## 17 Abstract

18 **Background:** Hypertension is a significant global health problem, particularly in Sub-Saharan 19 Africa (SSA). Despite the effectiveness of medications and lifestyle interventions in reducing 20 blood pressure, shortfalls across health systems continue to impede progress in achieving optimal 21 hypertension control rates. The current review explores health system factors contributing to 22 hypertension outcomes in SSA. 23 **Methods:** The World Health Organization health systems framework guided the literature search 24 and discussion of findings. We searched PubMed, CINAHL, and Embase databases for studies 25 published between January 2010 and June 2022 and followed the Preferred Reporting Items for 26 Systematic Reviews and Meta-Analyses guidelines. We assessed studies for risk of bias using the

27 tools from Joanna Briggs Institute.

28 **Results:** Thirty-nine studies clustered in 10 SSA countries met inclusion criteria. Health system 29 determinants included human resource factors such as providers' knowledge and adherence to 30 hypertension treatment guidelines (n=21) and task sharing and shifting strategies (n=10). The 31 second health system factors explored in service delivery were the health facility type and 32 capacity (n=7) and hypertension service accessibility by cost, place, and time of services (n=15). 33 A quarter of the included studies explored supply chain management for access to essential 34 equipment and medicines. An additional set of studies addressed quality improvement strategies 35 involving cross-integration of services (n=7) and various strategies of gauging the systems for 36 better hypertension outcomes (n=8).

37 Conclusion: A combination of multiple rather than solo system interventions may yield
38 significant improvements in blood pressure outcomes. Health information management and
39 leadership involvement were less explored. Additional research on health system determinants of

- 40 hypertension is needed to drive global improvements in hypertension outcomes. Future research
- 41 would benefit from more rigorous implementation type interventional studies comprehensively
- 42 assessing health system factors that contribute to better hypertension outcomes.

## 48 Introduction

49 Hypertension remains a global health challenge, especially for low- and middle-income countries 50 (LMICs) in Sub-Saharan Africa (SSA) [1]. Hypertension is a significant risk factor for stroke 51 and ischemic heart disease, the world's deadliest maladies [2]. It is estimated that 30% of the 52 SSA population have hypertension [3–5], 27% are aware of their hypertensive status, and only 53 7% have their hypertension under control [3]. The prevalence of hypertension in SSA will likely 54 continue to rise due to the rapid shift to sedentary lifestyles, growing urbanization, and a higher 55 number of people living longer [6, 7]. The level of preparedness of health systems for managing 56 hypertension and related sequelae is poor and requires urgent attention [8, 9]. 57 Several strategies have been implemented to manage hypertension in SSA. Population-based 58 interventions such as educational campaigns to improve dietary practices by reducing salt 59 consumption have proven cost-effective in lowering blood pressure among hypertensive patients 60 [10–13]. Alternative interventions implemented to reduce dietary salt include increasing the 61 availability and affordability of healthy foods and reformulation of processed foods with the help 62 of government policies [10]. Other strategies including technology and non-technology based 63 reminders targeted the hypertensive patients to improve their adherence to the prescribed 64 pharmacologic and non-pharmacologic treatments [13, 14]. Despite the numerous, effective 65 interventions targeting the patients with hypertension, the health systems are not equipped to provide the best quality care, yet, the health system is the current epicenter in the population-66 67 based hypertension [8, 9]. 68 Multiple guidelines exist for screening, diagnosing, and treating hypertension [2, 15, 16]. The 69 Pan-African Society of Cardiology task force convened in 2014 laid the roadmap to achieving

70 25% blood pressure control in Africa by 2025[17]. In 2021, the World Heart Federation laid an

71 updated roadmap that identified the major roadblocks in hypertension diagnosis and management 72 and recommended solutions for reducing uncontrolled hypertension by 30% by 2030 [18]. The 73 lack of local hypertension treatment guidelines, protocols, and policies on the procurement and 74 distribution of anti-hypertensives are some of the multiple identified government and health 75 system roadblocks to achieving hypertension control goals [17, 18]. These roadblocks likely 76 result in the lack of community sensitization on hypertension and service inaccessibility through 77 high-cost and centralized hypertension care [19, 20]. According to the Chronic Care Model, the 78 health systems' role in hypertension management should be to support patients for self-79 management at home, set up systems to ensure patients follow up after clinical encounters, and 80 decentralize hypertension care closest to patients [20, 21]. Health systems should provide access 81 to specialists if needed, ensure providers are trained and have access to the latest guidelines and 82 decision support, and document care to improve the quality of care [20, 21]. 83 The World Health Organization (WHO) health systems framework highlights six critical 84 elements to target while working to improve the quality of health services. These are the service 85 delivery; health workforce; access to equipment, consumables, and technology; information 86 systems; financing; and leadership and governance. In 2013, the WHO developed the Service 87 Availability and Readiness Assessment (SARA) to map the progress in the six elements of the 88 health systems[22]. The SARA tool has been extensively utilized in maternal and reproductive 89 health and on a minimal basis in cardiovascular health care [23, 24]. The evidence on the health 90 system determinants of hypertension care and outcomes is limited. The current review 91 synthesizes the literature on the health system factors of hypertension care in SSA and identifies 92 the gaps and opportunities for improving the quality of hypertension care.

## 93 Methods

## 94 Search Strategy:

- 95 Collaborating with a scientific library informationist, we defined the search terms for
- 96 hypertension service availability and delivery guided by the WHO health systems' framework
- 97 [25]. We Identified Medical Subject Headings (MeSH) terms ("Health Facilities," "Health
- 98 Services Accessibility," "Health Care Delivery"); and hypertension ("hypertension" or "elevated
- 99 blood pressure" or "raised blood pressure" or anti-hypertensive) in SSA. We searched PubMed,
- 100 Cumulated Index to Nursing and Allied Health Literature (CINAHL), and Embase. The detailed
- 101 list of search terms is in Supplementary File 1 (S-File 1).

## 103 Study selection and eligibility

104 The Preferred Reporting Items for Systematic Reviews and Meta-Analyses (PRISMA) [26]

105 guided this systematic review (S-File 2). We imported articles from the literature search into

106 Covidence, and three investigators (SB, KA, and OO) conducted the title and abstract screening,

107 full-text review, and final extraction. Two investigators appraised each article independently at

108 each step, and the third investigator resolved any conflicts. Occasionally, the investigators

109 discussed with the supervising faculty (YCM and CRH) to resolve disputes.

110 In the article search and screening, we included studies (1) published between January 2010 –

111 June 2022; (2) conducted in health facility settings (hospitals, clinics, community health

112 facilities) in SSA; (3) with randomized controlled trials, quasi-experimental, cohort study, case-

- 113 control study, cross-sectional study designs, and quality improvement projects; (5) which
- 114 explored the association between healthcare system factors and hypertension awareness,
- treatment initiation and adherence, and control. The delineation of the search to 2010 was

influenced by another systematic review conducted in 2013 exploring the influence of the healthsystem on hypertension awareness, treatment, and control in LMICs [27].

118 We excluded studies (1) merely describing the prevalence of hypertension and associated

119 patient-level factors, (2) which investigated the health system interventions without exploring

120 association with any of the listed hypertension outcomes, and (3) which explored hypertension

121 care interventions conducted solely in the community setting without describing collaboration

122 with health facilities, or (3) examining patient-level behavioral change interventions for

123 hypertension management. Additionally, we excluded gray literature (books, cases, etc.).

124 The investigators tracked the rationale for excluding any study during the entire process

125 following the article search as reported in the PRISMA flowchart (Figure 1).

#### 127 **Risk of Bias Assessment**

128 We used the Joanna Briggs Institute (JBI) tools to assess the quality aspects of the methods and 129 conduct of the studies included in the review [28]. We evaluated the quality improvement study 130 using the Standards for Quality Improvement Reporting Excellence 2.0 (SQUIRES) guideline 131 [29]. SQUIRES uses a checklist of standard elements for reports of system-level projects to 132 improve healthcare quality. Two investigators independently assessed the risk of bias for each 133 study and the third resolved conflicts. The JBI tool uses "Yes," "No," and "Unclear or Not 134 applicable" to assess the different features of study design and the overall appraisal as include 135 study, exclude study, or seek more information. We replaced "Yes," "No," and "Unclear" with 136 "Low risk of bias," high risk of bias," and "Some concerns," respectively. We assigned the 137 overall quality appraisal of each study as "good," "fair," and "poor" and studies with poor quality 138 were excluded. We used the robvis [30] online tool to create risk-of-bias plots where the overall

appraisal was also converted to "low risk of bias" for the study of good quality, "some concerns"
for studies of fair quality and "high risk of bias" for studies of poor quality.

## 141 Analysis and synthesis of findings

After the data extraction, we identified relevant themes of health system factors and interventions for hypertension care. We classified the outcomes of each study in the appropriate group: hypertension awareness, systolic and diastolic blood pressure (BP), treatment initiation and adherence, and BP control. We tracked which factors/interventions are likely to lead to better hypertension outcomes and compared findings across the different countries of SSA. We discussed the results against the other potential areas of health systems crucial to improving the quality of hypertension care as delineated in the WHO health systems framework [25].

## 149 **Results**

150 We identified 7,494 studies, yet 3,121 were duplicates (Figure 1). We conducted title and 151 abstract screening for 4,373 studies yielding 205 for full-text review. The latter led to 39 studies 152 for inclusion in this systematic review (Table 1). The quality assessment demonstrated a low risk 153 of bias in 62% (24/39) of the included studies (S-File 3). Given the nature and complexity of 154 health system interventions, the compliance to all requirements of the study design raised some 155 concerns in 38% (15/39) of the included studies. Among randomized controlled trials, the most 156 common issues were the lack of concealed intervention allocation, the similarity of groups at 157 baseline, and blinding participants and those delivering the intervention of the group 158 assignments. The most common concern among cohort studies was the lack of identification and 159 management of confounding factors and strategies to address participants' loss to follow-up. The 160 identification and management of confounding factors was the most common reason for concern 161 among cross-sectional studies.

### 169 **Country and design of included studies**

170	Of the 39 included studies, six were randomized controlled trials conducted in South Africa
171	(n=2) [31, 32], Cameroon (n=1) [33], Ghana (n=1) [34], Kenya and Uganda (n=1) [35], and
172	Zambia (n=1) [36]. Five quasi-experimental studies were conducted in Nigeria (n=2)[37, 38],
173	Cameroon (n=1) [39], Kenya (n=1) [40], and Sierra Leone (n=1) [41]. Eight cohort studies were
174	conducted in Ethiopia (n=1) [42], Uganda and Tanzania (n=1) [43], Tanzania (n=1) [44], South
175	Africa (n=1) [45], Sierra Leone (n=1) [46], Ghana and Kenya (n=1) [47], Kenya (n=1) [48], The
176	Democratic Republic of the Congo (n=1) [49].
177	Nineteen cross-sectional studies were conducted in Ethiopia (n=3) [50–52], Nigeria (n=2) [53,
178	54], Botswana (n=1) [55], Democratic Republic of Congo (n=1) [56], Swaziland now called
179	Eswatini (n=2) [57, 58], Namibia (1) [59], South Africa (n=3) [60–62], Ghana (n=4) [63–66],
180	Kenya (n=2) [67, 68]. We additionally identified one quality improvement report from Botswana
181	[69]. The geographic representation of included studies by country is demonstrated in Figure 2.

185 186	Health system factors and interventions explored
187	The most studied health system factors were human resource factors $-(1)$ healthcare providers'
188	knowledge and adherence to hypertension treatment guidelines and decision support systems;
189	and (2) the task-sharing/shifting of hypertension care tasks to unconventional health
190	professionals. Other health system factors related to service delivery included (3) the health
191	facility type and capacity and (4) service accessibility in terms of cost, place, and time of care
192	(Table 2). Additionally, studies explored (5) supply chain management for access to essential
193	equipment and anti-hypertensive medicines. Finally, studies explored the revision of the patient

- 194 care process at the health facility through (6) the cross-integration of services and (7) the
- 195 different quality improvement strategies for improving hypertension care.

# (1) Healthcare providers' knowledge and adherence to hypertension treatment guidelines and decision support system

202 Half of the studies (21/39) [32–36, 38–41, 43, 46–49, 53, 55, 57–59, 61] across 13 countries

203 explored the impact of healthcare provider knowledge of or adherence to hypertension treatment

204 guidelines and decision support system on hypertension outcomes (Table 3). Generally, higher

- 205 provider knowledge of or better adherence to guidelines and availability of decision-making
- support systems correlated with better hypertension care outcomes. For instance, the lack of
- 207 physician knowledge in prescribing anti-hypertensives at a University College Hospital in
- 208 Nigeria demonstrated 76% higher or lower blood level doses (as measured in urine) of anti-

- 209 hypertensives than recommended and contributed to 35% lower BP control [53]. Adherence to
- the Eighth Joint National Committee guidelines contributed to 46% of additional patients
- 211 achieving BP control in Kenya [70]. An approximately similar pattern was observed in a study
- conducted in Botswana [55].

217 Improvement in the healthcare providers' skills and knowledge of the correct blood pressure 218 measurement techniques and hypertension diagnosis, respectively, were effective in managing 219 hypertension in Kenya [40]. In its first year, the program helped screen 532 527 individuals, 220 diagnose almost 10% of them with hypertension, and initiate 72% of those diagnosed on 221 treatment [40]. The provider skills in BP measurement were assessed in Eswatini by comparing 222 the pragmatic measurements with standard sphygmomanometer measurements [57]. The two 223 measurements showed a good agreement of 0.7 Kappa score and an 84% concurrence in 224 hypertension treatment decisions (continuing, changing, adjusting, stopping treatment). 225 (2) Task-sharing/shifting strategy 226 A quarter of studies (10/39) [32, 34–36, 38, 39, 41, 47, 48, 58] conducted in 9 countries explored 227 the impact of delegating some hypertension care tasks to non-physician providers (task-shifting) 228 or community health workers. The task-shifting consisted of training and giving roles to lay 229 community health workers in South Africa [32] and Zambia [36] to conduct and record the BP 230 measurements, to nurses in Cameroon [39] and Ghana [34] to treat hypertension (including 231 prescribing drugs), and to pharmacists in Nigeria [38] to treat hypertension (prescribe 232 medications) and dispense medications after diagnosis at the health facility. 233 The impact of task-shifting varied across studies but bent towards positive BP outcomes. In 234 Ghana [34] and Cameroon [39], task-shifting contributed to the significant decline in systolic and 235 diastolic BP but not in the achievement of controlled BP [34, 39]. On the other hand, in the two 236 quasi-experimental studies conducted in Nigeria and Zambia, respectively, the task-shifting 237 contributed to the achievement of controlled BP in Nigeria (AOR 2.27, p: 0.049) from baseline 238 to end line and in Zambia from 13% at baseline to 25% (no p-value reported) among patients 239 who attended at least 2 follow up visits [36, 38]. In a cluster randomized controlled trial

conducted in South Africa, the task-shifting to lay community health workers in BP
measurement and documentation contributed to higher adherence to appointments (75% vs. 56%
patients attending their assigned appointments) but no statistically significant improvements in

achieving BP control comparing the intervention to the control group [32].

#### (3) Health facility type and capacity

245 Eighteen percent (7/39) of the included studies [42, 49, 55, 56, 62, 65, 68] explored the impact of 246 health facility type and capacity on hypertension care and outcomes. The studies highlighted the 247 significant yet inconsistent differences in hypertension outcomes associated with receiving care 248 at either community health post (closer to the community - offering one or very few primary 249 healthcare services), community health center (serving a slightly bigger size of the community -250 offers the whole package of primary care services), general referral hospital, or specialized 251 clinics. In Botswana, community health posts were three times better than community health 252 clinics in helping patients achieve BP control [55]. In Ethiopia, general referral clinics were 253 almost two times better than specialized clinics [42] in patients' achievement of BP control. In 254 the Democratic Republic of Congo, there were no significant differences in BP outcomes 255 between general referral hospitals and community health centers [56]. Additionally, the presence 256 of the doctor on a daily basis (OR:1.64; 95% CI:1.17-2.31; p=0.004) and a higher mean number 257 of nurses in the clinic (OR: 1.15; 95% CI:1.08-1.23; p=0.001) were significantly associated with 258 BP control at the baseline of a randomized controlled trial conducted in South Africa [71]. 259 (4) Accessibility of hypertension care (cost, geographic, temporality of service delivery) 260 The effect of patients' access to hypertension care on hypertension outcomes was explored in

261 38% (15/39) of the included studies within seven SSA countries [34, 35, 37, 38, 47, 48, 50–52,

262 54, 58, 63, 64, 66, 67]. The general trend was that the lower cost of care was significantly

263 associated with better hypertension outcomes. The two quasi-experimental studies conducted in 264 Nigeria and Ghana provided health insurance coverage to the intervention group and to both 265 study arms, respectively [34, 37]. In both studies, the systolic and diastolic BP declined in both 266 study arms with a significant and sharper decline in the intervention arms even though the 267 achievement of BP control was not significantly different in the intervention versus control arms. 268 Two cross-sectional studies in Ethiopia reported that patients' payment of user fees was 269 associated with 50 times higher odds of uncontrolled BP while paying less than 50 Ethiopian 270 Birr (approximately 1 USD) was associated with two-fold higher odds of achieving BP control 271 [50, 52]. 272 Four studies reported the factors related to the spatial and temporality accessibility of 273 hypertension care services in achieving BP control. The shorter distance to the health facilities 274 [51] and time flexibility at the hypertension care clinics were associated with better hypertension 275 care outcomes [67]. Yet, such patterns were not true in South Africa, where rural dwellers 276 (where people are likely to travel longer to health facilities) were better responders to treatment 277 intensification by achieving BP control compared to urban dwellers (OR: 0.66; 95% CI: 0.45-278 0.97; p:0.034) [71]. In Ethiopia, traveling less than 30 minutes to the hospital had 2.02 times 279 higher odds of medication adherence compared to traveling 30 minutes or more [51]. Similarly, 280 the flexibility in location (other than at the health facility) and time of day of dispensing 281 medications were associated with better health outcomes, as reported in Kenya [67] and Nigeria. 282 [38] In Kenya, the extension of hypertension service hours to include evening hours led to a two 283 times likelihood of patients' adherence to anti-hypertensive medications even though patients 284 scheduled to attend weekend clinics had 76% fewer odds of medication adherence [67].

#### 285 (5) Supply chain management for the availability of essential equipment and

#### 286 consumables

287 A quarter (10/39) of the studies [36, 39–41, 48, 49, 55, 66, 67, 69] across eight countries 288 explored the availability of equipment and consumables involved in hypertension management 289 and impact on BP outcomes. The procurement of drugs and consumables and improvement in 290 the supply chain implemented in the experimental studies and quality improvement project was 291 in combination with other interventions such as providers' training in Cameroon, Kenya, and 292 Zambia [36, 39, 40], and better data management in Botswana [69]. In these studies, the impact 293 of the equipment and supply chain was not necessarily isolated but undoubtedly contributed to 294 the overall improvements in BP outcomes. 295 The cross-sectional study conducted in Botswana reported that the medication errors contributed 296 to three times higher odds (Odds Ratio: 3.23; 95% CI 1.75-6.06 p<0.001) of uncontrolled BP. 297 Almost one-third of the errors were dispenser errors caused mainly by the stock out of the 298 medication and reluctance to refer the patients back to the prescriber to provide an alternative 299 medicine [55]. The interventions that showed significant improvement in BP improved not only 300 the availability of the equipment but also the essential anti-hypertensive drugs, as is the case in 301 Kenya [40].

#### (6) Cross-integration of services

303 The integration of hypertension and other non-communicable diseases services into the well-304 established health services was explored in 18% (7/39) of the studies in 6 different countries [35, 305 43, 45, 46, 49, 60, 61]. The most frequent form of cross-integration was the provision of non-306 communicable diseases services in the Human Immunodeficiency Virus (HIV) and Sexually

307 Transmitted Diseases clinics and the use of existing patient follow-up mechanisms in managing308 non-communicable diseases.

309 Predominantly, the cross-integration of services has shown significant improvements in 310 hypertension control. A cohort of patients in South Africa increased in controlled BP from 43% 311 before integration of services to 49% one year after integration [45]. Another cohort of patients 312 in Uganda and Tanzania had a 10% decline in the risk of uncontrolled BP [43]. In Uganda and 313 Kenya, the care for hypertension, diabetes, and HIV were integrated, and additional features of 314 care improved, leading to a 26% higher likelihood of initiating patients on hypertension 315 treatment and a 29% higher likelihood of BP control. In the Democratic Republic of the Congo, 316 hypertension services were integrated into Emergency Primary Clinic. While there was a high 317 rate of new hypertension diagnoses in 97% of the included sample, only 34% remained in care in 318 one year, and other those who remained in care, 71% achieved a systolic BP below 140 mmHg, 319 which is the cut-off used in the country for desired systolic BP [49]. 320 In one instance, the hypertension clinic was built from scratch in Sierra Leone [46]. A cohort of 321 patients followed in that new rural hypertension clinic had BP control go from 6% at baseline to 322 31% at one year-follow-up [46].

323 (7) Deliberate improvement in the quality of hypertension care

Eight studies [31, 33, 36, 39, 40, 60, 61, 69] conducted in 5 countries explored the additional
value of deliberately gauging and improving systems for a better quality of hypertension care.
The quality improvement projects included an improved data recording process in Zambia and
Botswana [36, 69] and better monitoring through supervision in Cameroon [33] and South Africa
[31]. In South Africa, a quality improvement project on improving data recording and adherence
to treatment guidelines by providers was implemented through the introduction of a folded

guidelines sheet inside the patient file [31]. The project did not contribute to an increase in
patients with BP control, and providers reported that the project was overwhelming because of
staff shortage [31]. Where quality improvement was implemented jointly with other system
components such as improving the supply chain of equipment and consumables in Botswana
[69]; providers' training on hypertension care and task-shifting in Cameroon [33, 39]; supply
chain, training, and task-shifting in Zambia [36]; there were better blood pressure outcomes.

## 336 **Discussion**

337 This systematic review aimed to assess the health system factors and interventions for 338 hypertension awareness, initiation and adherence to hypertension treatment, and achievement of 339 controlled blood pressure in SSA. A 2013 systematic review in LMICs [27] and a 2015 narrative 340 synthesis in SSA [72] explored the health system determinants of hypertension care and reported 341 consistent findings of factors of hypertension outcomes: cost of care, human resources factors 342 such as adherence to protocols, physical resources factors such as lack of functioning equipment, 343 and lack of treatment guidelines. Our review identified the above and additional health system 344 interventions and factors, including the accessibility factors of care such as place and time of 345 care, the health facility type and capacity, the use of quality improvement strategies, and the 346 cross integration of services.

The healthcare provider's knowledge and adherence to hypertension treatment guidelines stood out as one of the most studied health system interventions [40, 73, 74]. The capacity building among healthcare providers and the task sharing and shifting of hypertension management roles to vital professionals like nurses, pharmacists, and community health workers align with scientific evidence from developing and developed countries [75, 76]. For instance, the nurses'

352	role in managing hypertension has evolved from merely measuring and monitoring blood
353	pressure to collaboratively detecting, diagnosing, and referring patients with hypertension and its
354	complications [77, 78]. In many countries and settings, nurses prescribe or dispense anti-

360	their hypertension [79]. Neupane and colleagues recommend shifting some hypertension
361	management tasks to non-physician clinicians to bridge that gap [79]. Interdisciplinary
362	collaboration is the way forward for SSA to provide quality hypertension care to patients;
363	however, regional and national policies must align with and support best practices.

The current review 382 did not find studies exploring patient registries to prevent loss to follow-up in hypertension 383 management.

384 The hypertension clinics model consists of managing patients with hypertension in their own 385 outpatient unit and was experimented and proved effective in Sierra-Leone [46] and Eswatini 386 [58]. The premise of this strategy is to have well trained healthcare providers and good systems 387 of data management, in some instances to decentralize of hypertension care, and improvement in 388 patient follow-up. The lessons from the management of HIV and Tuberculosis could be applied 389 in those services. It is crucial to ensure that the detachment of hypertension care from the general 390 outpatient department or from the well-equipped hospital does not hamper the patients' initiation 391 on hypertension treatment through the internal transfer processes and that patients with 392 hypertension continue to receive holistic care for other health problems they might have in 393 addition to hypertension.

While the decentralization of care might address geographic barriers to hypertension care access, other factors of accessibility such as cost of care and time of services require additional and potentially different interventions. Extensively, the current and previous literature have shown that the high direct and indirect costs of care hamper patients' use of health services and lead to

398 poor health outcomes and among patients with hypertension, poor blood pressure control [54, 66, 399 90]. The time of operation of clinics, though limited evidence exists, has an impact on the 400 staffing hence the long queues of patients at the in- and outpatient departments which 401 discourages patients' attendance to their appointments and encourages loss to follow-up [67, 91, 402 92]. Universal health coverage through government-subsidized insurance premiums has been 403 advocated as a solution to prevent catastrophic spending on healthcare services and associated 404 poor health outcomes [93-95], and the 24/7 hypertension clinic operation could be explored as a 405 potential intervention to the long waiting queues at the clinics. The financing of universal health 406 coverage and the 24/7 open clinics, however, require political buy-in and collaboration across 407 sectors, local and international [94].

408 While leadership and governance are central to the success of any endeavor to improve the 409 quality of care, their role and impact in advancing hypertension care in SSA are not widely 410 researched, and the few existing studies are predominantly of poor quality [96]. Thornton 411 highlighted the critical values of leadership commitment, willingness to fund care, strategic and 412 creative local and foreign partnerships, and evidence-based guidelines as the key reasons why 413 Botswana surpassed the United Nations' HIV management goals of 95% awareness, 95% on 414 treatment, and 95% [81]. A 3-year campaign mobilization on the role of clinical leaders in 415 hypertension management at various health systems in the United States achieved the goal of 416 80% blood pressure control within seven months [97]. A scoping review of interventions to 417 strengthen the health professionals' leadership in SSA found that the opportunities for leadership 418 development in SSA are scarce and those available are of poor quality and lacking a consistent 419 evaluation framework [98]. There is a need for more studies on strengthening leadership in 420 healthcare and exploring its impact on health outcomes, including hypertension in SSA.

421 As the burden of hypertension increases globally, the investment required of health systems to 422 manage hypertension is rising. Hypertension is significantly associated with adverse outcomes of 423 Coronavirus Disease 2019 (COVID-19), the ongoing pandemic ravaging the entire world's health 424 systems [99, 100]. Studies reported that hypertensive patients had almost three times the odds of 425 mortality compared to people without hypertension [99]. The long-term post-COVID symptoms 426 haunt the patients with hypertension who survive COVID-19 more than the general population 427 [101]. For instance, patients with hypertension are twice as likely to have migraine-like 428 headaches and 68% higher odds of poor sleep than people without hypertension [101]. Apart 429 from the COVID-19 rationale, under the Sustainable Development Goal (SDG) 3 (Ensure 430 healthy lives and promote well-being for all at all ages), target 3.4 aims to reduce by one-third 431 the premature mortality from non-communicable diseases [102]. The management of 432 hypertension, a significant risk factor for cardiovascular diseases, is a step closer to achieving 433 target 3.4 of SDG 3.

434 Standard tools for exploring the health system determinants for specific diseases are scarce in the 435 realm of hypertension care in Africa. There is a dire need for psychometric tools to explore 436 health system readiness to provide quality hypertension care. The availability of those tools 437 would open doors to researchers interested in hypertension care to gather quality data on health 438 system determinants and render the evidence to policymakers to develop policies directed at 439 shortfalls in care delivery to improve the health outcomes of patients with hypertension.

440 Future studies are recommended to explore the roles of leadership and governance and

441 information systems at the health facilities levels as well as multi-level approaches (ie,

442 individual, community, provider, health system) in the improvement of hypertension care [27,

443 72]. Additionally, while the current review explored studies conducted in SSA, most of the

444 studies were conducted in three countries (Ethiopia, South Africa, and Ghana). Future studies 445 should explore hypertension service readiness in other countries of SSA. The expansion of 446 studies exploring health system factors of hypertension care could be a way to highlight the areas 447 of need to advocate for support from local and international health agencies. 448 **Strengths and Limitations** 449 The strengths of the current review are the holistic view of health system factors and 450 interventions that affect the quality of hypertension service delivery, stringent critique of the 451 quality of the studies, and the overall derivation conclusion against the WHO framework [25]. 452 Nevertheless, the current review included only studies published in English and did not include 453 the gray literature, which could consist of unpublished reports, and quality improvement projects 454 on the health system interventions to improve hypertension service delivery. While the review 455 attempted to isolate the effect of the individual health system factors, many system interventions 456 were delivered in a bundled approach which rendered the isolation impossible.

## 457 Conclusion

The literature exploring health system factors of hypertension outcomes in SSA is limited in volume and quality. The combination of multiple health system interventions was likely to result in better hypertension outcomes. More rigorously designed studies about the different aspects of the health systems and their impact on hypertension outcomes, especially the health information management and leadership and management are needed in SSA to inform effective hypertension control efforts.
