### **ABSTRACT**

Background: Immunocompromised (IC) persons are at increased risk for severe COVID-19 outcomes and are less protected by 1-2 COVID-19 vaccine doses than are immunocompetent (non-IC) persons. We compared vaccine effectiveness (VE) against medically attended COVID-19 of 2-3 mRNA and 1-2 viralvector vaccine doses between IC and non-IC adults. Methods: Using a test-negative design among eight VISION Network sites, VE against laboratoryconfirmed COVID-19-associated emergency department (ED) or urgent care (UC) events and hospitalizations from 26 August-25 December 2021 was estimated separately among IC and non-IC adults and among specific IC condition subgroups. Vaccination status was defined using number and timing of doses. VE for each status (versus unvaccinated) was adjusted for age, geography, time, prior positive test result, and local SARS-CoV-2 circulation. Results: We analyzed 8,848 ED/UC events and 18,843 hospitalizations among IC patients and 200,071 ED/UC events and 70,882 hospitalizations among non-IC patients. Among IC patients, 3-dose mRNA VE against ED/UC (73% [95% CI: 64-80]) and hospitalization (81% [95% CI: 76-86]) was lower than that among non-IC patients (ED/UC: 94% [95% CI: 93-94]; hospitalization: 96% [95% CI: 95-97]). Similar patterns were observed for viral-vector vaccines. Transplant recipients had lower VE than other IC subgroups. Conclusions: During B.1.617.2 (Delta) variant predominance, IC adults received moderate protection against COVID-19—associated medical events from three mRNA doses, or one viral-vector dose plus a second dose of any product. However, protection was lower in IC versus non-IC patients, especially among transplant recipients, underscoring the need for additional protection among IC adults.

### **INTRODUCTION**

Immunocompromised (IC) persons, or those with suppressed humoral or cellular immunity resulting from health conditions or medication use, comprise approximately 3% of the U.S. adult population [1, 2]. IC adults are at increased risk for severe COVID-19 outcomes such as hospitalization and death [3-6] and acquire less protection from two COVID-19 mRNA vaccine doses as do immunocompetent (non-IC) persons [7]. Analyses of real-world data have also demonstrated differential vaccine effectiveness (VE) across subgroups of patients with a range of IC conditions [7]. While a third COVID-19 mRNA vaccine dose has been recommended as part of the primary series for IC persons since August 2021 [8], limited evidence exists regarding VE of three mRNA doses for preventing severe outcomes such as COVID-19—associated emergency department (ED) and urgent care (UC) events or hospitalizations among adults with different types of IC conditions [9, 10].

The objective of this study was to estimate, using electronic health record (EHR)-derived data during a period of B.1.617.2 (Delta) variant predominance, the relative VE against laboratory-confirmed COVID-19-associated ED/UC events and hospitalization of 3 versus 2 mRNA vaccine doses and 2 versus 1 viral-vector vaccine dose(s). Estimates also include absolute VE of each vaccinated group compared with unvaccinated status. VE was calculated separately and compared between IC and non-IC adults and among different subgroups with specific types of IC conditions. Determining the real-world effectiveness of 3 mRNA doses and 2 viral-vector doses will inform recommendations for IC patients. They will also provide a basis for future analyses during periods when other variants predominate and when sufficient data have accrued to examine four- and five-dose regimens among IC patients [8].

## **METHODS**

### **Study Setting and Data Source**

The VISION Network is a collaboration between the Centers for Disease Control and Prevention (CDC) and eight U.S. health care systems and research centers in 10 states, with integrated medical, laboratory, and vaccination records: Baylor Scott & White Health (Texas), Columbia University Irving Medical Center (New York), HealthPartners Institute (Minnesota, Wisconsin), Intermountain Healthcare (Utah), Kaiser Permanente Northern California, Kaiser Permanente Northwest (Oregon, Washington), Regenstrief Institute (Indiana), and the University of Colorado [7, 11-15].

Within the framework of a test-negative design [16-19], encounters among persons admitted to one of 391 ED/UC facilities and persons hospitalized (>24 hours) at one of 261 hospitals were eligible if patients were aged ≥18 years with ≥1 discharge diagnosis among a previously published list of qualifying COVID-19–like illness (CLI) diagnoses [11]. CLI was defined as a clinical diagnosis (from the International Classification of Diseases [ICD], 9th and 10th Revisions) of acute respiratory illness (e.g., respiratory failure or pneumonia) or signs or symptoms (e.g., cough, fever, dyspnea, vomiting, or diarrhea) that are associated with COVID-19 [20-22]. CLI encounters included ED/UC events and hospitalizations between August 26, 2021 (14 days after the first U.S. recommendation for a third mRNA COVID-19 vaccine dose as part of the primary series for IC individuals [23]) and December 15–25, 2021 (last date during which the Delta variant accounted for >50% of sequenced viruses at each study site [13]). Repeat ED visits and repeat UC clinic visits (within 24 hours) and or hospital readmissions within 30 days post-discharge were combined and analyzed as single medical visits. This study was reviewed and approved by the institutional review board at Westat, Inc.

# Measures

IC status was defined by the presence (presumed IC) or absence (presumed non-IC) of ≥1 discharge diagnosis for immunocompromising conditions, as previously published [7]. Diagnoses across five categories of conditions were derived from previous studies of large hospital-based or

administrative databases: 1) solid malignancies, 2) hematologic malignancies, 3) rheumatologic or inflammatory disorders, 4) other intrinsic immune conditions or immunodeficiencies, and 5) organ or stem cell transplants [24-26] (**Supplementary Table 1**). Data on immunosuppressive medications were not available.

Vaccination status was documented in EHRs or state or local immunization registries [11] and was defined as of the medical event index, or the date of specimen collection associated with the most recent SARS-CoV-2 test result before the ED/UC event or hospitalization (or, if testing only occurred after admission, the date of admission). Primary analyses included recipients of Moderna (mRNA-1273) and/or Pfizer-BioNTech (BNT162b2) products. Patients were classified as unvaccinated, 2-dose mRNA-vaccinated (≥14 days earlier), or 3-dose mRNA-vaccinated (≥7 days earlier). Patients with two doses were further subdivided as <150 and ≥150 days earlier. We excluded mRNA vaccine recipients who received 1) only 1 dose, 2) second dose 1−13 days earlier, 3) third dose 1−6 days earlier, or 4) ≥4 doses. Secondary analyses included Janssen (Johnson & Johnson [Ad26.COV2]) vaccine recipients, with patients classified as 1-dose Janssen-vaccinated (≥14 earlier) or 2-dose vaccinated (≥7 days earlier). Due to sample size constraints, any product was used to define second dose (i.e., mRNA or Janssen). Among Janssen recipients, we excluded those who received 1) first dose 1−13 days earlier, 2) second dose (any product) 1−6 days earlier, or 3) ≥3 doses.

SARS-CoV-2 infection was confirmed by molecular assays (e.g., real-time reverse-transcriptase—polymerase-chain-reaction [RT-PCR] assays) obtained within 14 days before to <72 hours after an ED/UC clinic visit or hospital admission. We only included events with an available SARS-CoV-2 molecular test result during this window. To minimize confounding related to recent infection, patients with a positive SARS-CoV-2 result 15–89 days earlier were excluded. Demographics and underlying medical conditions (defined by ICD codes assigned at medical event) were extracted from EHRs.

### **Statistical Analysis**

A test-negative design was used to assess VE with respect to an ED/UC event or hospitalization associated with laboratory-confirmed SARS-CoV-2 infection and CLI. VE was estimated by comparing odds of a positive SARS-CoV-2 test result between vaccinated and unvaccinated patients using multivariable logistic regression models [7, 11, 13]. VE was adjusted for age (spline), geographic region, calendar time (spline), prior documented positive SARS-CoV-2 test result (none, 90–364 days ago, ≥365 days ago), and local SARS-CoV-2 circulation (7-day moving average of percentage of RT-PCR tests that were SARS-CoV-2—positive within the medical facility's geographic region; spline). VE was also weighted for patients' inverse propensity to be vaccinated (if vaccinated) or unvaccinated (if not vaccinated). Generalized boosted regression trees were used to estimate the propensity to be vaccinated based on sociodemographics, underlying medical conditions, known prior SARS-CoV-2 infection (pre-vaccination, if vaccinated), and facility characteristics. Separate weights were calculated for each VE model and were truncated at the 99<sup>th</sup> percentile of the distribution of weights. Any covariates with an absolute standardized mean or proportion difference (SMD) ≥0.20 after weighting were also included in the model for the respective VE estimate(s) to minimize residual confounding.

VE estimates were stratified by IC status, vaccine product received, age group (18–64, ≥65 years), and race/ethnicity (non-Hispanic white, non-Hispanic Black, Hispanic). Among IC patients, VE was also calculated separately among five mutually exclusive subgroups of patients with each type of immunocompromising diagnosis (patients with multiple types were excluded) and separately among recipients and non-recipients of organ/stem cell transplants (no patients excluded). To directly compare the 3-dose versus 2-dose mRNA vaccine series, relative VE was calculated using a similar methodology with 2 doses serving as the referent group. Effect modification by IC status (IC vs. non-IC) and type of IC condition (transplant recipient vs. non-transplant recipient) was assessed using interaction terms with vaccination status in regression models. To evaluate mRNA product differences, a contrast was used to

test differences in regression coefficients between Moderna and Pfizer-BioNTech. P-values <0.05 were considered statistically significant. Analyses were performed using SAS version 9.4 (SAS Institute) or R software, version 4.1.2 (R Foundation for Statistical Computing).

### **RESULTS**

### **Descriptive Characteristics**

A total of 208,919 ED/UC medical events and 89,725 hospitalizations were identified during August 26-December 25, 2021, among adults with CLI and SARS-CoV-2 testing who were either unvaccinated or had received 2-3 mRNA vaccine doses. Characteristics of non-IC and IC patients overall and by vaccination status are provided in Table 1 for ED/UC events and Table 2 for hospitalizations. The proportions of all ED/UC events and hospitalizations that were among IC persons were 4% and 21%, respectively. Median age was 47 years (interquartile range [IQR]: 31–66) and 65 years (IQR: 48–77) among non-IC patients in ED/UC and hospital settings, respectively, and 66 years (IQR: 54-75) and 68 years (IQR: 58–77) among IC patients in those settings (data not shown). Overall, proportions of ED/UC events among non-Hispanic Black and Hispanic patients were 9% and 15%, respectively, and 11% and 12% for hospitalizations. Overall, a smaller proportion of ED/UC (19%) than hospitalized (64%) patients had a discharge diagnosis for a chronic respiratory condition. Proportions of ED/UC events and hospitalizations among patients with a historical positive SARS-CoV-2 test result ≥90 days earlier was 6-7%. There were differences by network site, age, and race/ethnicity between 2-/3-doses mRNAvaccinated and unvaccinated patients. The application of inverse propensity-to-be-vaccinated weighting reduced differences between vaccinated and unvaccinated patients with respect to these and other factors (Supplementary Tables 2-3).

Among 8,848 ED/UC events and 18,843 hospitalizations for IC patients, 36% and 42%, respectively, had a discharge diagnosis for solid malignancy, compared with diagnoses for hematologic

malignancy (11%/13%), rheumatologic/inflammatory disorder (27%/25%), another intrinsic immune condition or underlying immunodeficiency (34%/35%), and organ/stem cell transplant (9%/8%) (data not shown). The majority of ED/UC visits (84%) and hospitalizations (79%) had only one of these five types, whereas 14% and 18%, respectively, had exactly two, 1%/2% had three, and <0.1%/0.3% had four or five.

In both settings, a smaller proportion of non-IC patients were vaccinated with two (45% in both settings) or three (8%/9%) mRNA vaccine doses compared with IC patients (two doses: 48%/51%; three doses: 16%/18%) (**Tables 1-2**). Overall, 38% and 41% of vaccinated non-IC patients in ED/UC and hospital settings, received the Moderna vaccine, compared with 61%/58% with the Pfizer-BioNTech vaccine and 1%/1% with a combination of both products. Among vaccinated IC patients, 38% and 40% in ED/UC and hospital settings received the Moderna vaccine, compared with 61%/59% with the Pfizer-BioNTech vaccine and 1%/1% with a combination.

In ED/UC settings, the median time since 2-dose mRNA-vaccinated patients' second dose was 189 days among non-IC patients (IQR: 146–225) and 196 days among IC patients (IQR: 160–230); median durations in hospitals were 199 days (IQR: 161–233) and 198 days (IQR: 163–231), respectively (data not shown). In ED/UC settings, the median time since 3-dose mRNA-vaccinated patients' third dose was 35 days among non-IC patients (IQR: 17–49) and 45 days among IC patients (IQR: 26–72); median time in hospitals was 34 days (IQR: 19–54) among non-IC and 43 days (IQR: 24–66) among IC patients.

### mRNA COVID-19 VE by Immunocompromised Status

Among 200,071 ED/UC events for non-IC patients, 21% had laboratory-confirmed SARS-CoV-2 infection (35% infected among unvaccinated; 10% among 2-dose vaccinated; 3% among 3-dose vaccinated), compared with 13% among 8,848 ED/UC events for IC patients (21% infected among

unvaccinated; 9% among 2-dose vaccinated; 5% among 3-dose vaccinated). Among IC adults, 2-dose mRNA VE was 67% (95% confidence interval [CI]: 62–72) and 3-dose mRNA VE was 73% (95% CI: 64–80) against SARS-CoV-2 infection at an ED/UC event, compared with 81% (95% CI: 81–82) and 94% (95% CI: 93–94) among non-IC adults (**Table 3**). VE against ED/UC events for 2 and 3 doses was significantly lower among IC versus non-IC patients (tests of interaction, both p<0.05).

Among 70,882 hospitalizations for non-IC patients, 22% had SARS-CoV-2 infection (41% infected among unvaccinated; 8% among 2-dose vaccinated; 2% among 3-dose vaccinated), compared with 11% among 18,843 hospitalizations for IC patients (22% infected among unvaccinated; 7% among 2-dose vaccinated; 3% among 3-dose vaccinated). Among IC adults, 2-dose mRNA VE was 72% (95% CI: 69-75) and 3-dose mRNA VE was 81% (95% CI: 76-86) against SARS-CoV-2 infection at hospitalization, compared with 87% (95% CI: 86-87) and 96% (95% CI: 95-97), respectively, among non-IC adults. VE against hospitalization for 2 and 3 doses was significantly lower among IC versus non-IC patients (tests of interaction, both p<0.05). VE point estimates were similarly lower among IC versus non-IC patients in analyses stratified by age group and race/ethnicity (Supplementary Tables 4-5).

In ED/UC and hospital settings, point estimates for 2-dose mRNA VE were lower among patients with ≥150 versus <150 days elapsed since second dose (Table 3). Further, among IC patients in both settings, 2-dose VE was higher for Moderna than Pfizer-BioNTech products (both p<0.05). Similarly, among IC patients, 3-dose VE was higher for Moderna than Pfizer-BioNTech products in hospital settings (p<0.05), but no significant difference was observed in ED/UC settings (p=0.61). In relative VE analyses among IC patients, three mRNA doses were significantly more effective than two mRNA doses in ED/UC settings (44%; 95% CI: 24–58) and hospital settings (48%; 95% CI: 34–59); results were similar for both Moderna and Pfizer-BioNTech products (Table 4).

### mRNA COVID-19 VE by Type of Immunocompromising Condition

Among patients with only one type of immunocompromising condition, VE against COVID-19—associated ED/UC events after 2-dose mRNA vaccination for IC patient groups ranged from 11% (95% CI: -102-61) among organ/stem cell transplant recipients to 82% (95% CI: 66-90) among patients with hematologic malignancy. 3-dose VE ranged from 50% (95% CI: -36-81) among patients with hematologic malignancy to 87% (95% CI: 70-95) among patients with solid malignancy (**Table 5**). VE against COVID-19—associated hospitalizations of patients with 2-dose mRNA vaccination ranged from 73% (95% CI: 49-86) among organ/stem cell transplant recipients to 83% (95% CI: 77-87) among patients with another intrinsic immune condition or underlying immunodeficiency. VE of 3-dose mRNA vaccination ranged from 39% (95% CI: -69-78) among organ/stem cell transplant recipients to 92% (95% CI: 84-96) among patients with solid malignancy.

VE of 2-dose and 3-dose mRNA vaccination (each versus unvaccinated status) was lower among transplant recipients than among non-transplant recipients with other immunocompromising condition(s) in ED/UC and inpatient settings (tests of interaction between organ/stem cell transplant status and vaccination status, all p<0.05) (Table 5). Among transplant recipients, two or three doses of Moderna were more effective than two or three doses of Pfizer-BioNTech against COVID-19 hospitalization (both p<0.05), but no product difference was detected with respect to VE against COVID-19 ED/UC events (both p>0.25).

### Janssen (Johnson & Johnson) COVID-19 VE

A total of 10,329 ED/UC events (5% IC) and 4,202 hospitalizations (23% IC) were among Janssen vaccine recipients. Characteristics of non-IC and IC Janssen vaccine recipients in ED/UC and hospital settings are provided in **Supplementary Tables 6-7**. Among Janssen vaccine recipients, 7% of non-IC patients and 6% of IC patients in ED/UC settings, and 6% and 5%, respectively, in hospital settings, had received a second dose (any product). Among those who received a second dose, 67% and 63% of non-

IC patients in ED/UC and hospital settings, respectively, and 77% and 69% of IC patients in those settings had a heterologous dosing pattern (i.e., mRNA product as second dose).

In ED/UC settings, median duration since 1-dose Janssen-vaccinated patients' first dose was 182 days among non-IC patients (IQR: 139–219) and 190 days among IC patients (IQR: 148–227); median durations in hospitals were 179 days (IQR: 134–215) and 185 days (IQR: 147–218), respectively. In ED/UC settings, median duration since 2-dose Janssen-vaccinated patients' second dose (any product) was 26 days among non-IC patients (IQR: 16-40) and 20 days among IC patients (IQR: 12–37); median durations in hospitals were 26 days (IQR: 15–38) and 29 days (IQR: 17–40), respectively.

Among IC adults, VE of one Janssen dose was 7% (95% CI: -26–31) and VE of two doses (any product for second dose) was 71% (95% CI: 6–91) against COVID-19 ED/UC events, compared with 64% (95% CI: 61–66) and 90% (95% CI: 86–93), respectively, among non-IC adults (see Supplementary Table 8). VE for 1 Janssen dose was significantly lower among IC versus non-IC patients (test of interaction, p<0.05); there was no statistical difference for 2 doses. Among IC adults, VE of one Janssen dose was 45% (CI: 29–57) and VE of two doses was 70% (95% CI: 25–88) against COVID-19 hospitalization, compared with 72% (95% CI: 69–76) and 93% (95% CI: 86–96), respectively, among non-IC adults (tests of interaction between IC status and vaccination status, p<0.05 for 1 dose and 2 doses).

### **DISCUSSION**

In a multistate analysis of real-world EHR-derived data from nearly 209,000 ED/UC events and 90,000 hospitalizations during Delta variant predominance, 3 doses among mRNA COVID-19 vaccine recipients and 2 doses among viral-vector vaccine recipients (any product for second dose) were more effective at preventing laboratory-confirmed COVID-19 medical events in IC and non-IC patients compared with receipt of 2 mRNA vaccine doses, one viral-vector vaccine dose, or being unvaccinated. While this additional primary series dose offers further protection to IC patients, VE estimates among IC

patients who received 3 doses of mRNA vaccines or 2 doses of a viral-vector containing series were significantly lower than VE among non-IC patients. These findings indicate that, as a group, IC patients receive less protection from vaccination, compared with the protection received by non-IC patients. These findings are consistent with other studies suggesting that certain IC populations experience attenuated immune responses to COVID-19 vaccines and that VE is reduced among IC patients overall [3, 27]. To our knowledge, this study is among the first to report different estimates for 3-dose mRNA VE across groups with different IC conditions, with point estimates ranging from 50–87% (ED/UC) and 39–92% (hospital). Specifically, and consistent with our previous study of 2-dose vaccination, VE was again found to be especially low for patients with organ or stem cell transplants, confirming that this population is at particular risk of lower protection from severe COVID-19 outcomes even when vaccinated [7].

Our results highlight the need for extra protection against COVID-19 among IC adults. Therefore, they support the recommendation that all eligible persons should receive multiple vaccine doses, and that IC persons should receive more than non-IC persons, to enhance protection against severe COVID-19. They also add to evidence suggesting that, compared with non-IC persons, IC populations may have a greater need for additional measures (masking, physical distancing, pre-exposure prophylaxis) to prevent COVID-19.

To our knowledge, this study is also among the first to show a statistically significant difference in VE between mRNA products among IC patients. Our network's previous study demonstrated a trend toward a greater protective effect of the Moderna versus Pfizer-BioNTech mRNA vaccine, and this study provides more rigorous statistical evidence of this difference [7]. Therefore, while this is an observational study with some inherent limitations noted below, and while either mRNA vaccine provides good VE for IC patients, this finding is notable and deserving of further study and

consideration. It should also be noted that we did not have sufficient power to directly compare relative VE between viral-vector and mRNA vaccine products.

This study has several strengths, including its large and diverse sample, but it is also subject to several limitations. First, the use of selected discharge diagnoses as surrogates for presumed IC status and the absence of medication and other relevant data might have led to classification of persons as IC who were not; the opposite is also possible but less likely. Second, despite each network partner's data linkage with state or local immunization registries, misclassification of vaccination status is possible. Third, although inverse weights balanced unvaccinated and vaccinated patients on sociodemographic and health characteristics, and further adjustments were made, unmeasured and residual confounding (e.g., mask-wearing, waning immunity) in this observational study might have influenced estimates. For example, prior SARS-CoV-2 infection could only be controlled for if it was documented in the EHR. Fourth, this study was limited to the period of Delta variant predominance and findings may differ during the subsequent period of Omicron variant predominance, a matter that will be the focus of future analyses. Finally, although additional mRNA doses are currently recommended for IC patients, current data availability did not yet allow for such analyses, and will also be the focus of future studies.

This study has implications for public health and clinical practice. While further analyses should evaluate the effectiveness of four mRNA vaccine doses, patients will benefit from receiving booster COVID-19 vaccine doses. Consistent with current CDC recommendations, booster doses confer greater protection than the primary series alone [8]. However, this study also reinforces the reality that vaccinated IC patients remain less protected than vaccinated non-IC patients and may benefit more from additional precautions, including the use of nonpharmaceutical prevention strategies such as mask-wearing to prevent SARS-CoV-2 infection. Also, if infected with SARS-CoV-2, IC patients would benefit from being monitored closely and considered early for proven therapies that might prevent progression to severe illness. Additional studies are needed to determine the degree of VE improvement

conferred by additional COVID-19 vaccine doses in IC populations, evaluate whether different approaches to vaccine administration might improve VE (e.g., dosage timing, temporarily withholding immunosuppressants), and further evaluate VE differences between vaccines products.
