Barriers and enablers to blood culture sampling: a systematic review and theoretical domains framework survey in Indonesia, Thailand and Vietnam

2 Background

3 Blood culture (BC) sampling is recommended for all suspected sepsis patients prior to antibiotic

4 administration. Here, we aimed to identify barriers and enablers to BC sampling in three

5 Southeast Asian countries.

6 Methods

7 We conducted a systematic review of studies evaluating barriers/enablers to BC sampling from

8 1900 to 2020 globally (PROSPERO, CRD42020206557). Using the findings of the systematic

9 review, we developed and conducted a Theoretical Domains Framework (TDF)-based survey

10 with a case scenario question among doctors and final-year medical students in Indonesia,

11 Thailand and Vietnam.

12 Findings

13 In the systematic review, we identified 6,175 unique records from the databases, of which 25 met the eligibility criteria. Studies were conducted in 37 high-income countries (HICs) and 41 low-14 15 and middle-income countries (LMICs). Of 14 TDF domains, three and seven were not assessed in HICs and LMICs by the studies included in the systematic review, respectively. 1,070 medical 16 17 doctors and 238 final-year medical students completed the survey. The proportion of respondents who would definitely take BC in the case scenario was 89.8% for Thai, 50.5% for Vietnamese 18 and 31.3% for Indonesians (p<0.001). Eight TDF domains were considered key in influencing 19 BC sampling, including 'no awareness of guideline [TDF-knowledge]', 'low priority of BC 20 21 [TDF-goals]', 'no intention to follow guidelines [TDF-intention]', 'level of doctors who can 22 order or initiate an order for BC [TDF-social professional role and identity]', 'no norms of BC 23 sampling [TDF-social influence]', 'perceived cost-effectiveness of BC [TDF-environmental

- substantial heterogeneity between the countries across most domains.

27 Conclusions

- 28 Evidence on barriers and enablers to BC sampling is limited globally. We identified individual,
- 29 socio-cultural and environmental barriers/enablers to BC sampling across different countries,
- 30 which represent potential targets for interventions. Context-specific multifaceted interventions at
- both hospital and policy levels are required to improve diagnostic stewardship practices.

Blood culture (BC) is a crucial diagnostic, which can guide antibiotic treatment decisions of
severe bacterial infections, and may improve patient outcomes.^{1,2} The cumulative results of BC
are also crucial to inform antimicrobial resistance (AMR) surveillance, at the hospital, country
and global levels.³ International guidelines on sepsis management have been stressing the
importance of obtaining BC before or, when not possible, within 24 hours after administration of
antibiotics.^{1,4}

- Lastly, we mapped identified TDF domains to the COM-B ('capability', 'opportunity',
- ¹⁵⁴ 'motivation' and 'behaviour') model.¹⁶⁻¹⁸ COM-B forms the hub of the Behaviour Change Wheel
- 155 (BCW), a framework which signposts to potentially relevant intervention strategies. This
- allowed us to list all intervention types and policy options that were likely to be effective in

- 166 Systematic review

167 We identified 6,175 unique records from the databases (Figure 1, Appendix S5). After title and

abstract screening, 884 articles were selected for full-text review. 859 articles were excluded

- because they did not meet the eligibility criteria and 25 original studies were included (Appendix
- 170 S6). Those studies were conducted in or included participants from 37 HICs and 41 LMICs
- 171 (Figure 2, Appendix S7), and comprised 15 (60%) quantitative studies, six (24%) quantitative
- 172 non-randomized interventional studies, two (8%) qualitative studies, one mixed-method study,
- and one quantitative randomized controlled trial (4% each). Of 25 studies, eight (32%) were

| 177 | The systematic review identified barriers/enablers of BC sampling across 11 of 14 TDF domains. |
| 178 | The most common domain reported was 'knowledge', followed by 'behavioural regulation', |
| 179 | 'environmental context and resources', 'memory, attention and decision processes', 'beliefs |
| 180 | about consequences' and 'social influence' (Table 1). Of 14 TDF domains, three and seven were |
| 181 | not assessed in HICs and LMICs by the studies included in the systematic review, respectively |

| 185 | From 1 December 2021 to 30 April 2022, 1,070 medical doctors and 238 final-year medical |
| 186 | students in Indonesia, Thailand and Vietnam completed the online TDF survey covering all 14 |
| 187 | TDF domains. Half of respondents were female (n=680, 52%) and most worked in governmental |
| 188 | hospitals (n=980, 75.4%) (Table 2). The most common department was internal medicine |

189 (n=450, 34.4%), followed by emergency (n=175, 13.4%) and pediatrics (n=153, 11.7%).

190 Respondents were from 24 of 34 provinces in Indonesia, 39 of 77 provinces in Thailand, and 25

191 of 63 provinces in Vietnam.

Based on the sepsis case scenario (Table 2), half of respondents (52.3%, 682/1,304) answered

- 194 that they would definitely take BC. However, the responses were significantly different between
- the three countries (p<0.001). Most Thai respondents (89.8%, 273/304) answered that they

199 Thematic synthesis for domains identified as having high importance

We combined the results obtained from the systematic review and the TDF survey (Table 1 and Appendix S10), and present content themes, in rank order, within each of the eight domains that were considered very important (i.e. key) in the three countries in SEA in the section below, with example references and quotes (Table 3).

205 Knowledge

Theme. Awareness of guidelines. In the review, "lack of knowledge of existing guidelines" was 206 reported as a key barrier to BC sampling.¹³ In our survey, 59.0% (756/1,282) of respondents 207 208 answered that they know of guidelines for BC sampling being used in their hospitals, while 209 29.3% (376/1,282) answered that they do not know if their hospitals use any guidelines, and 210 11.7% (150/1,282) answered that their hospitals do not use any guidelines (Appendix S11). Among those who answered that they know of local guidelines, 81.0% (612/756) stated that their 211 local guidelines recommend BC sampling in all patients presenting with sepsis. About half 212 213 (47.8%, 596/1,248) answered that they know of international guidelines, and most of those (95.0%, 566/596) stated that the international guidelines recommend BC sampling in all patients 214 215 presenting with sepsis. Respondents who answered that they know of local guidelines (odds ratio [OR] 2.55, 95% confidence interval [CI] 1.93-3.38, p<0.001) or international guidelines (OR 216 217 1.97, 95% CI 1.50-2.57, p<0.001) were more likely to answer with "definitely take BC" in the 218 case scenario (Appendix S12).

220 *Theme: BC-related knowledge.* In the review, previous studies reported deficiencies in BC-

related knowledge, i.e. the number of BC bottles to be collected, amount of blood volume needed

be collected, temperature of BC incubation, necessity of aseptic techniques and impact of

antibiotics prior to BC collection.^{12,15,30} Our survey did not assess BC-related knowledge as this

study did not focus on quality of BC practice.

226 *Theme: Training.* In the review 'lack of training' on BC was commonly reported as a

227 barrier.^{15,31,32} In our survey, 37.8% (153/407) of Indonesian respondents, 24.9% (64/257) of Thai

respondents and 12.4% (52/421) of Vietnamese respondents responded that there were no

training, lectures, classes or meetings that provide knowledge about local/national/international

230 guidelines for BC sampling in their hospitals (p<0.001). Respondents who answered that there

are training, lectures, classes or meetings that provide knowledge about guidelines for BC

sampling were more likely to answer with "definitely take BC" in the case scenario (OR 1.68;

233 95% CI 1.18-2.38, p=0.004).

235 *Goals*

Theme: Priority of BC. In the review, "low priority attributed to BC" was reported as a key
barrier to BC sampling. However, "lack of time" or "time constraints" is commonly used to
represent "low priority to BC" in the working environment with similar work density in
hospitals.^{13,32} In many settings, ordering or initiating an order for BC can take only few seconds
by writing "blood culture" in the doctor order form. In our survey, we used a question asking
about the priority of BC compared to that of empirical antibiotics. 91.3% (274/300) of Thai
respondents answered that they obtain BC prior to receiving empirical antibiotics in patients

presenting with sepsis all the time or often, while 80.0% (380/475) of Vietnamese respondents
and 54.2% (251/463) of Indonesian respondents answered likewise (p<0.001). Respondents who
gave priority to BC were more likely to answer with "definitely take BC" in the case scenario
(OR 4.25, 95% CI 3.04-5.94, p<0.001).

Theme: Intention to follow guidelines. In the review, "low intrinsic motivation"¹³ and "general reluctance to draw large volumes of blood"³³ were reported as barriers to BC sampling. In our survey, among those who answered that they know of local guidelines, 92.9% (157/169) of Thai respondents answered that they plan to follow local guidelines all the time or often, while 82.0% (283/345) of Vietnamese respondents and 74.1% (172/232) of Indonesian respondents answered likewise. Those respondents were more likely to answer with "definitely take BC" in the case scenario (OR 2.92, 95% CI 1.88-4.53, p<0.001).

257 Social professional role and identity

Theme: Level of doctors who can order or initiate an order for BC. In the review, a survey 258 evaluated the role of nurses to decide on BC testing in HICs,³² but none of the studies included 259 260 evaluated the role of different levels of doctors on BC sampling. In our survey, >75% of Thai respondents answered that all levels of medical doctors (consultants, physicians, residents and 261 262 interns) can order or initiate an order for BC in their hospitals. Most Indonesian and Vietnamese 263 respondents (87.9%, 870/990) answered that consultants can, but fewer answered that physicians (61.8%, 612/990), residents (59.1%, 585/990) and interns (20.3%, 201/990) can (p<0.001). A 264 265 quarter of Thai respondents (28.7%, 87/303) answered that final-year medical students can order

| 271 | perceived responsibility' was reported as a barrier from final-year medical students, but not from |
| 272 | medical doctors. ¹³ In our survey, most medical doctors (86.5%, 905/1,046) answered that it is |
| 273 | very appropriate or appropriate for them to order BC or initiate an order for BC, while only about |

278 Theme: perception about their role to draw blood for BC. In our survey, most respondents 279 (72.8%, 949/1,303) answered that registered nurses are tasked to draw blood from patients for 280 BC, followed by microbiology laboratory team (36.0%, 469/1,303), specialized blood draw team (27.4%, 357/1,303), residents (25.4%, 331/1,303), physicians (23.5%, 306/1,303), consultants 281 282 (23.2%, 302/1,303), interns (17.8%, 229/1,303) and final-year medical students (11.6%, 283 151/1,303). Of respondents who answered that they are tasked to draw blood from patients for 284 BC, 69.1% (248/359) responded that it is very appropriate or appropriate for their role to draw 285 blood for BC. Those respondents were more likely to answer with "definitely take BC" in the case scenario (OR 1.94, 95%CI 1.04-3.64, p=0.04). 286

328 Behavioural regulation

Theme: Regulation of cost reimbursement. 404 'Low priority to BC [TDF-goals]', 'no intention to follow guidelines [TDF-intention]', 'lack of 405 perception about their role to order or initiate an order for BC [TDF-social professional role and 406 identity]' and 'lack of norms of BC sampling [TDF-social influence]' are likely key barriers to 407 BC sampling in both HICs^{13,36,44} and other LMICs³³ where resources for BC sampling are 408 available to some extent.

To our knowledge, 'level of doctors who can order or initiate an order for BC [TDF-social professional role and identity]' and 'influence from healthcare workers, patients and families of patients [TDF-social influence]' have never been systematically evaluated and reported as a barrier to BC sampling. Those are important barriers as, in many hospitals in both HICs and LMICs, final-year medical students and interns are responsible for most BC ordering and acquisition³⁰ and influences from other parties can discourage BC sampling.

417 Remarkably, the cost of BC seems to have influence on executive level doctors, patients, 418 families of patients, or those who set regulations on cost reimbursement of BC. announcing to all levels of healthcare workers that negative consequences that discourage BC
sampling per local guidelines will not be tolerated [enablement] for cost-related barriers), and
develop intervention content in details based on local context for the changes of BC practice to

This study also has several limitations. First, the systematic review was limited in scope and 432 433 quality due to limitation and heterogeneity of studies included. The TDF survey included a convenient sample of hospitals and practitioners, which might have led to selection bias. This 434 435 limited our ability to draw firm conclusions on the contemporary situation on barriers and 436 enablers to BC sampling globally and in the SEA region. Therefore, the data should be interpreted cautiously. Second, the exclusion of non-peer-reviewed and non-English literature 437 438 meant that we might not have included local publications and documents from local government 439 and/or non-government institutions. However, their exclusion likely improved the quality of the 440 evidence as those literature may not always follow gold-standard or recommended guidelines for 441 evaluation. Third, the survey could not reach the target sample size in Thailand despite 442 substantial efforts. Nonetheless, the study had enough power to estimate the prevalence of barriers and enablers in Thailand, and compare that with those observed in Indonesia and 443 Vietnam. 444

In conclusion, among three LMICs in SEA barriers to BC sampling were varied and
heterogeneous. This comprehensive analysis using TDF gives information across the entire
spectrum of behavioral influences of BC sampling. These results can help local healthcare


