| 16 | Abstract |
| 17 | Background |
| 18 | Women of reproductive age (WIFA, 15-49 years) in Ghana are experiencing an |
| | |

19 upsurge in excess body mass index (BMI) and anemia (low hemoglobin concentration 20 (Hb of ≤ 10.9 g/dl)). Regions of Southern Ghana (Central, Eastern, and Volta) are 21 recognized to have high rates of adolescent pregnancies, and is known to be associated 22 with high risk of anemia. However, little is known for pregnant South Ghanaian women. 23 This study aimed to examine anthropometry - maternal stature and early pregnancy BMI 24 - and socio-demographic measures as independent risk factors for anemia in antenatal 25 women in Southern Ghana.

Methodology 27

Baseline data on anemia from healthy pregnant women (15-49 years; n = 1278) 28 29 collected through antenatal attendance in an observational cohort study was included in 30 the descriptive and logistic regression analysis using STATA (Stata Corp LLC [US]). 31 Anemia (dependent) and the independent variables: high parity (≥ 5 children/woman); 32 short stature (145≤155cm); underweight (BMI <18.5kg/m²), normal (BMI 18.5-24.9kg/m²), overweight (BMI 25-29.9kg/m²), and obesity (BMI >30 kg/m²) assessed with 33 weight (kg) before the 20th week of gestation divided by height (m²) were defined 34 35 following standards. Wealth status was constructed using Principal Component Analysis 36 of durable assets, housing characteristics, water/sanitation, and toilets facilities. All 37 estimates were evaluated at the 5% significance level (p < 0.05).

Results 39

40 Of the sample, 45.85% had moderate/severe anemia with $9.67(\pm 0.04)$ average hemoglobin (g/dl) concentration. Overweight/obesity was approximately (47%; 41 overweight 29% vs obesity 18%), short stature (4.77%), and underweight (4.61%) in the 42 43 1278 women interviewed. Obesity was highest in the highest income women (26.24% (69/263)) in whom anemia decreased (34.78%, 80/230)) compared to highest prevalence 44 45 of anemia in short stature (59.01%, 36/61), underweight (57.62%, 34/59), and overweight (44.68%, 164/367) women. 46

The risk of anemia increased with high parity (adjusted odds ratio; aOR 3.91; 48 49 95%CI: 1.79-8.52; p = 0.001); lowest income quintile (aOR:2.10; 95%CI: 1.35-3.26; p = 0.001); second income quintile (aOR:1.52; 95%CI: 1.01-2.30 p = 0.045); being Ewe 50

ethnicity (aOR:2.09; 95%CI: 1.35-3.24; p = 0.001); and Akan (aOR:1.79; 95%CI: 1.162.74; p = 0.008); while obesity reduced the risk (aOR:0.70; 95%CI: 0.50-0.99; p = 0.045).

54 **Conclusion**

55 Anemia in pregnancy and overweight, and obesity as double burden of 56 malnutrition remain significantly high in pregnant South Ghanaian women. The AIP 57 exceeded the WHO defined threshold and was particularly highest in women having high parity, short stature, and underweight. While high parity and income status increased 58 59 overweight/obesity, obese women were more likely to have a reduced risk of anemia. However, across the ethnicity, high parity and low-income status posed significant risk 60 61 of anemia in women. Further research examining the nexus between underweight or short stature versus high rates of anemia or overweight/obesity and income and anemia to better 62 63 explain, and prevent the increasing trend of anemia in pregnant Ghanaian women is 64 recommended.

Introduction 67

68 Malnutrition in all its forms is affecting humanity worldwide. Women in fertility age (WIFA, 15-49 years) are particularly vulnerable to 69 70 overweight and obesity (excess BMI of $\leq 25 \text{kg/m}^2$) and anemia (low hemoglobin 71 concentration, Hb of $\leq 10.9/dl$) in pregnancy (AIP). This is widely recognized as the overlooked paradox of triple burden of malnutrition [1-3]. Researchers posit that because 72 73 societies have evolved embracing unhealthy lifestyles in addition to multiple childbearing 74 practices or short inter-pregnancy intervals, nutritional stores of women often deplete 75 alongside postpartum weight retention, thereby increasing the chances of 76 overweight/obesity and AIP [1,4–6]. This often results in bleeding during delivery and 77 other serious obstetric complications including low birth weight (less than 2.5kg) which 78 in turn predicts many adult diseases [78].

80 Anemia in pregnancy and excess BMI varies by ethnicity and geographical 81 locations and is endemic (more than 40%) in most Lower-Middle Income Countries 82 (LMICs) [3,8–10]. Data from 46 LMICs indicates 40.4% of WIFA is anemic with pregnant women having 14% increased risk than non-pregnant women whilst those in the 83 84 third trimester have 55% increased risk of anemia [3]. This is consistent with the World Health Organization (WHO) global statistics of anemia in WIFA (40%) and 42% in 85 86 children less than 5 years [3]. In contrast, some LMICs such as Ethiopia and Tanzania 87 reported a moderate level of anemia [11–13].

88

Anemia affects up to 42% of WIFA in Ghana more than the WHO defined 40% 89 90 threshold at which mass iron supplementation is recommended in anemia endemic

91 country. This record of anemia prevalence is also more than the global record and is been 92 consistently high among WIFA across Northern, Middle and Southern zones of Ghana 93 [3,14,15]. Also in Ghana, this prevalence is much more higher (48%) among adolescents, 94 whose pregnancy represents 22.1%, 21.1%, and 17% in Southern Ghana (Volta, Central, 95 and Eastern, the study regions respectively) compared to 14% known nationally, and 96 pregnant women (45%) [14,15]. Overweight/obesity continues to soar in pregnant women 97 (nearly 41 to 52% in 2008 and 2014 respectively) and among WIFA, 6% are estimated to 98 be underweight, and 50% are overweight/obese [9,16,17]. Being overweight or obese potentially increases risk of iron deficiency (ID) due to low-grade inflammation which in 99 100 turn elevates hepcidin production and subsequently, decreases iron efflux into circulation 101 [2,18]. This reason was not linked to hemoglobin concentration and excess BMI. 102 Likewise, underweight (BMI of < 18.5kg/m²) and short maternal stature have been shown 103 to increase risk of anemia in pregnancy [2,19,20].

Anemia in pregnancy is associated with nutritional deficiencies, with ID 105 106 accounting for 60% of severe and nearly 50% of moderate anemia cases worldwide.² Similarly, in Ghana, ID underlies half of the anemia cases occurring in WIFA [14,16]. 107 108 AIP is also common when women do not use birth control measures and have high parity, 109 having life children of 5 or more alongside low-income and educational levels 110 [5,6,11,15,21–24]. Women with high parity/fertility are most often poor due to the fact 111 that they have more children to care for and cannot afford higher education with 112 consequences for unemployment and a higher dependency ratio [11,15,21,23,25]. Thus, 113 having more children increases household and family size with less opportunity for 114 education, employment, income, and eventual poor maternal health [11,21,23,24].

Frequent childbearing or short interpregnancy intervals increase nutrient depletion, and this is particularly worse when nutrient inadequacy prolongs in the reproductive cycle, from conception through pregnancy and parturition [56]. Women have higher chances of experiencing hemorrhage during childbirth and depleting nutritional stores over time. Pregnancies result in an increased ID and anemia. Contrarily, others have retained postpartum weight [26,27].

122 Antenatal clinics (ANC) provide a system by which anemia and excess gestational 123 weight gain as nutritional and birthing problems are addressed [22]. In Ghana, despite 124 87% of ANC attendees having attended at least four times during pregnancy, addressing 125 anemia and preventing unhealthy weight gain during pregnancy lag behind ANC 126 appointments [14–16]. Additionally, women empowerment programs and improvement 127 in education have had little or no significant impact on childbearing age and parity or fertility rate. Total fertility in Ghana assessed as number of children per woman shows a 128 129 medium-fertility level of 3.82 children per woman. This is a 1.72 increase above the 130 required replacement-level fertility (2.1 children/woman) alongside a rising teen 131 pregnancy rate [14,21,28]. Furthermore, a United Nations population statistics on birth 132 control measures indicate Ghana is among African countries with low contraceptive use; 133 median coverage of any method (22.2%), modern method (20.3%), and unmet need 134 (34%) whilst only 36.2% had demand met [29]. These data are scary as it presupposed 135 that a higher fertility/parity or a population increase, and associated risks of anemia in the 136 WIFA population is eminent in Ghana.

A high parity to high BMI of $\geq 25 \text{kg/m}^2$ association is common and further 138 139 enhances risk of anemia in pregnant women. Such evidence is not well documented in Ghana where the double burden of malnutrition in pregnant women is reportedly high 140 141 [9,14,17]. Further, it is unclear whether socioeconomic status, and anthropometric 142 measures of above or below normal BMI and small maternal stature influences high levels of anemia in Ghanaian women. This study examined anthropometry – early pregnancy 143 144 BMI and maternal stature - and socio-demographic measures as predisposition factors of 145 AIP in women attending routine antenatal care in Southern Ghana (Central, Eastern, and 146 Volta regions). This study is vital to know the current trend of AIP from these regions 147 where the most available National representative data revealed a higher rates of 148 adolescent pregnancy, a putative risk factor for anemia [14].

150 Methodology

151 Study design, population and sampling technique, sample size

Baseline data involving healthy pregnant women collected through antenatal attendance from an observational cohort study design conducted between October 2018 and May 2019 was included in this secondary data analysis. Women recruited were aged 155 15 to 49 years and were between 6 and 42 weeks of gestation. The gestational age was confirmed based on the reported last menstrual period cum ultrasound scan date [30].

157

Women with underlying conditions like Human Immune Deficiency Syndrome (HIV) or tuberculosis (TB) with potential to compromise nutritional status were excluded from the study. This was assessed through a review of their ANC booklet and through direct reported data from physician-diagnosed health conditions that could affect

162 nutritional health. Participants who did not meet this defined criterion were excluded from163 the study.

| 165 | A multi-stage sampling method was deployed to recruit the participants. The three |

| 166 | regions as well as health facilities - a teaching hospital, three municipal hospitals, and |
| 167 | two polyclinics - were purposely selected based on the documented evidence of |
| 168 | adolescent pregnancy (Volta 22%, Central 21%, and Eastern 17%) [14,15]. This sampling |
| 169 | method is vital to study a lager sample of women in LMICs for the explanation of the |
| 170 | relationship between overweight/obesity and anemia [31]. The present study purposely |
| 171 | included the health institutions for participants recruitment due to the fact that ANC |
| 172 | attendance was high and the availability of medical doctor(s) or midwives with either |
| 173 | basic essential obstetric or comprehensive care (BEmOC/EmOC), or both. This avoided |
| 174 | loss to follow up (in the original study) as women were not referred elsewhere for |
| 175 | delivery, as essential services that would be needed in the time of delivery were available. |

176

177 The eligible participants were randomly recruited. Women were asked to pick a 178 folded piece of paper upon entering the facility with 'yes' or 'no' written on. Those who 179 picked 'yes' were interviewed after having understood the study procedures and willingly 180 consented.

181

182 Sample size

A sample size of 1278 was estimated using STATA (Stata Corp LLC [US]) power
analysis command. The study was powered (80%) to detect 1.4 odds of association

between maternal MUAC (of less than 23 cm) assuming prevalence (28%) of LBW
infants [32]. There was a 10% adjustment to offset the effect of non-response rate, and as
the minimum obstetric complication to be detected. The baseline data from the study was
re-examined in this analysis to explain the influence of BMI, stature, and sociodemographic on AIP.

191 Data collection

192 Trained nutrition officers and nurses employed face-to-face interviews and 193 medical record review (ANC record booklet and attendance registers) to obtain data using 194 a pre-tested semi-structured questionnaire. The questionnaire was adapted from a 195 published document and piloted for necessary amendments before field implementation 196 [14]. This ensured validity and reliability of the data analyzed. This process of data 197 collection was performed whilst the participants were waiting to attend appointments with 198 providers/midwives.

199

200 Primary data collected at baseline included economic status, and Hb (g/dl) 201 concentration measured with a calibrated Hb meter (URIT Medical Electronic Co. Ltd, 202 D-7, High-tech zone, China) through a standard procedure by laboratory technicians. The 203 economic status assessment data was consistent with that used by national health surveys 204 in Ghana and included a) *durable assets*: color television, radio set, refrigerator, mobile 205 phone, car, or motorbike, gas, or electric stove, washing machine, electricity, computer, cabinet, internet access, and bed; b) housing characteristics: natural floor, cement floor, 206 207 tiles, woolen carpet, rubber carpet, and roofing system; c) water and sanitation: pipe

water, tube well, or borehole, surface water, sachet, or bottled water; and d) *toilet facility:*flush toilet, pit latrine, no toilet facility, and open defecation [14].

Retrospective data extracted from maternal and laboratory record books included
maternal age, civil status, education, occupation, ethnicity, gravida, defined as the number
times that a woman has been pregnant, parity, and sickling status. Anthropometric data
of height and weight (kg) before the 20th week of gestation was extracted from the records.

Training and monitoring of data collectors in addition to a field guide developed following standard protocol all of which allowed quality assurance of data collection and compliance to specified standards.

Exposure and outcome variables

AIP was defined as low Hb (≤ 10.9 g/dl) concentration including severe, moderate, and mild regardless of the gestation age. Those with adequate Hb concentrations of ≥ 11 g/dl were classified as non-anemic [33].

224

Wealth index was estimated from asset data using Principal Components Analysis (PCA) method. This index measures inequalities in household characteristics as a proxy of women's health services usage and eventual outcomes [14]. The binary ('1' as having the asset and '0' not having the asset) data analyses gave a household wealth index score. Each household score was ranked into five equal groups, each reflecting 20% of the population. The resultant wealth quintiles were defined from the lowest to the highest quintile [14].

High parity/fertility level was defined as pregnant women having at least 5 lifechildren at the time of the interview [23,28].

234

Anthropometry data included in this study were maternal stature and early 235 236 pregnancy BMI. Maternal stature variable was grouped following standard as very short 237 (<145 cm), short (145 to <150 cm), average (150 to <155 cm), and standard (\geq 155 cm) 238 [19]. Early pregnancy BMI was computed using maternal weight (kg) before the 20th 239 week of gestation as the baseline weight divided by height in meters square (m^2) . The 240 resultant BMI was further categorized into underweight (BMI of <18.5 kg/m²), normal 241 (BMI of 18.5 to 24.9kg/m²), overweight (BMI of 25 to 29.9 kg/m²), and obese (BMI of 242 $> 30 \text{ kg/m}^2$) [34].

243

244 Data management, descriptive and outcome statistics

Data was collated in hard copy, cleaned, and double entered into Epidata software (version 4.6.0, <u>http://www.epidata.dk/download.php</u>, December 3, 2018). This was exported into STATA (Stata Corp LLC [US]) for analysis. Analyzed data was safely kept in locked facilities as hard copies and soft copies were password protected.

249

Descriptive analysis explored the prevalence of anemia in association with socioeconomic, maternal stature, and early pregnancy BMI variables as independent risk factors for AIP. The results were presented as percent distributions of Hb (g/dl) prevalence, socio-demographic factors, maternal stature, and BMI. The outcome analysis explored the relationship between the dependent and independent variables. Hb (g/dl) level was grouped into a binary variable, coded as '1' if the respondent had anemia and

256 '0' if otherwise. Similarly, regarding wealth quintiles, the highest quintile was held as the 257 reference group and primiparous as reference for the parity level.

258

259 Unadjusted univariable analysis between independent (socio-demographic and 260 parity characteristics, maternal stature, and BMI) and the outcome/dependent (Hb status) 261 variable were examined. Logistic regression with a backward selection procedure was 262 implemented to develop the best fit multivariable model of associations between 263 independent and the outcome variables. Variables were included in the multivariable 264 model if loglikelihood ratio test (LRT) p-values were <0.05. Robust standard errors were 265 calculated, using STATA 'vce(robust)' sub-command, to adjust for any correlation of the 266 model errors due to the sampling procedure, assuming women who visited selected 267 facilities shared similar covariates. Potential covariates retained in the final model 268 included age, education, ethnicity, wealth status, gravid, parity, BMI, and Hb (g/dl).

Ethics consideration

271 The study was approved by the Research Ethics Committee of the University of 272 Health and Allied Science, Ghana, with the reference number; UHAS-REC A.2 [7], 18-273 19. Each selected health facility granted written permission for use of the study site. Each eligible woman who willingly volunteered to be involved provided written informed 274 275 consent for enrollment after understanding the study details including potential benefits 276 and harm, data collection procedures, data storage and protection, and anonymity as spelt 277 out in the participants information sheet.

Results 278

Socioeconomic characteristics and anemia status 279

280 Table 1 describes the background characteristics and anemia status of the 281 respondents. Participants were 28.07 ± 6.37 years, on average and teenage mothers (15-282 19 years) had the highest level of anemia (60.74% (82/135)). However, this consistently 283 decreased for women aged to 41.82% (87/208) in the 35 and above age group with evidence of differences within group. Overall, the prevalence of AIP ((Hb ≤ 10.9 g/dl) 284 was 45.85% (586/1278) with an average Hb (g/dl) level of 9.67 (±0.04) in anemic women, 285 an indication of moderate anemia. Women in the 2nd trimester constituted more than half 286 287 (55.39% (708/1278)) of the study participants in whom 47.31% (335/708) were anemic.

288

289 The greatest proportions of the women were recruited from the municipal and 290 teaching hospitals in Volta region (44.91% (574/1278)) with the least being from the municipal hospital in the Eastern region (14.63% (187/1278)). Anemia was 291 292 disproportionally higher in Central (51.45% (266/517)) followed by Volta (46.16% (265/574)), and Eastern (29.41% (55/187)). Anemia was highest in Akan ethnicity 293 294 (47.32% (283/598)), followed by Ewes (46.37% (256/522)) while Ga-Dangme and Northerners together had the least (36.71 % (47/128)). This was consistent with the study 295 296 population pattern; Akan (46.79% (598/1278%), Ewes (43.19% (552/1278)), and the 297 minority were Ga-Dangme and Northerners (10.01% (128/1278)).

298

299 Low income and primary/no formal educational levels were associated with increased prevalence of AIP. Of the 1278 women Hb(g/dl) data included in the analyses, 300 301 60.40% (151/250) and 49.59% (123/248) of those in the lowest and second income

More than half (54.38% (695/1278)) of the respondents were primiparous (having a child for the first time) with around 4% (51/1278) of them in the high parity (having at least five children) among whom a highest proportion (70.58% (36/51)) were anemic.

314

Data on maternal stature shows that those with normal height and anemic were fewer, meanwhile, the number increased in short stature women (59.01% (36/61)), though this cohort forms just about 5% (61/1278) of the study population. This dropped by nearly 8% in those within the average height (51.03% (99/194) while declining further by 15% in those attaining a normal height (44.01% (445/1011)).

320

Early pregnancy BMI assessment indicate high levels of overweight/obesity ((46.7%; 597/1278; overweight (28.71% (367/1278)) *vs* obesity (17.99% (230/1278)). Anemia was highest in underweight (57.62% (34/59)) though this cohort represented only about 5% (59/1278) of the study population. This consistently decreased by 8% in the normal BMI category (49.51% (308/622) even though this group forms the highest

341 Figure 2 reveals that early pregnancy BMI category varied by women's income level. Healthy weight gain was highest (63.6% (159/250)) in the lowest income women, 342 343 but this decreased by nearly 24% to 39.92% (105/263) in the highest income women in 344 whom obesity was highest (26.24% (69/263)). Obesity was lowest (9.20%, 23/250)) in 345 the lowest income women. So, the wealthier the women were the higher the rates of 346 excess BMI and vice-versa. 347 Fig 2: Percent distribution of early pregnancy BMI by mother's income level* 348 (*Lowest, n = 250; Second, n = 248; Middle, n = 256; Fourth, n = 261; Highest, n = 263) 349 350 351 **Results of anemia in pregnancy and associated risk factors** 352 353 Table 2 outlines the odds ratio (OR) and adjusted odds ratio (aOR) of factors 354 associated with AIP. Being from an Ewe ethnicity was associated with high risk of anemia (OR = 1.49; 95% CI: 1.00 to 2.21; p = 0.048) and (aOR = 2.09; 95% CI: 1.35 to 3.24; p 355 356 = 0.001), and (OR = 1.54, 95% CI: 1.04 to 2.29; p = 0.029), and (aOR = 1.79; 95% CI: 357 1.16 to 2.74; p = 0.008) if an Akan ethnicity. 358 359 The risk of anemia was highest in the high parity (5 children/women) (OR = 2.66; 360 95% CI: 1.43 to 4.96; p = 0.002) and (aOR = 3.91; 95% CI: 1.79 to 8.52; p = 0.001). 361 Surprisingly, being obese was associated with 46% reduced risk of anemia (OR = 0.54; 95% CI: 0.39 to 0.74; p < 0.001) and 30% reduced risk (aOR = 0.70; 95% CI: 0.50 to 362 363 0.99; p = 0.045).364 365 Whereas, neither gravida, education, or occupation showed no impact on AIP, the

379 **Discussion**

High proportion of pregnant women interviewed at routine antenatal care in the selected 380 regions of Southern Ghana were anemic and overweight, and obese reflecting the growing 381 double burden of malnutrition in this population group. Statistics across the world indicate 382 pregnant women or WIFA (15-49 years) are either anemic or overweight and obese, or both 383 [1]. Most significantly, the anemia recorded was higher, than the WHO defined 40% threshold 384 [8,14,15]. The present findings uniquely identified anemia as a micronutrient deficiency 385 386 increasingly trending on a par with macronutrient malnutrition [4,15]. This is consistent with National surveys. In particular, the Ghana Demographic Health Survey data revealed a higher 387 burden of maternal malnutrition, varying substantially by individual nutritional status, 388 389 economic status, parity, and ethnicity [14,35,36]. These are paradoxically linked predisposition factors of malnutrition common to LMICs [1,4,37]. 390

391

392 Anemia was significantly more common in high parity and low (lowest and second quintile) income women groups in whom close to two-third and more than half respectively 393 had healthy weight (BMI of 18.5 to 24.9kg/m²) than highest income women among whom 394 395 obesity increased. While overweight and obesity increased positively with increasing parity and high-income level, there was an inverse relationship between obesity and the rate of 396 anemia. The high parity being proportionate to high level of anemia and overweight/obesity 397 398 enhances the fact that child bearing practices increase nutrient depletion as well as promote 399 blood loses and postpartum weight retention [5,6,11,23,26,27,38]. Though statistically insignificant, AIP was highest in short stature (145≤155cm) and underweight (BMI 400 <18.5kg/m²) women than their counterparts of healthy weight (BMI of 18.5 to 24.9kg/m²) and 401 402 compares with evidence, especially from rural India and the Maldives [2,20,39].

404 Despite the fact that the present analysis not including 405 dietary habits as a determinant of malnutrition, it is possible the poor and undernourished (short 406 and underweight) pregnant women were more anemic because of nutritional inadequacies in 407 the diet whilst the high economic classified women indulged in high caloric diets with little or no physical activity resulting in higher levels of overweight/obesity [4]. This lifestyle lays 408 409 the foundation for malnutrition to occur, a phenomenon commonly associated with nutrition 410 transition where urbanization and modernization accompanies income and economic growth 411 [4]. This further suggests perchance, women in poor income quintile consumed less caloric 412 dense diets (which may be of a poorer nutritional quality but may not be nutrition secured and

adequately utilize nutrients) and or undertook hard physical work compared to the higher

414 income ladies thus are less likely to be overweight or obese, but were anemic.

Studies expound the excess BMI and iron deficiency (ID) and iron deficiency anemia 416 (IDA) relationships [2,18,37]. Overweight/obesity prior to and during pregnancy imposed a 417 418 higher ID and IDA burden on infant-mother-pair, and nearly doubles the risk of postpartum anemia in women [2,18,37,40]. A woman who is overweight or obese has increased risks of 419 420 ID due to natural process avoiding human and pathogen competition for iron discussed earlier 421 [2]. In contrast, there are inconclusive evidence about overweight/obesity and Hb (g/dl) 422 concentration in women. The obese women in this study had 30% reduced risk of AIP 423 consistent with other studies including one study involving obese Chinese women who had improved Hb(g/dl) concentration level [2,37,40–42]. The present study findings reasonably 424 suggest that obesity protects against AIP in contrast to high parity which significantly underpin 425 426 increased obesity level as well as increased anemia risk.

427

428 Evidently, having at least 5 children/women increase overweight/obesity risk and 429 independently, predisposed women to nearly four-fold risk of anemia in this study. Though the 430 number of women in this cohort was small (about 4%), the finding is similar to that of a study 431 in Oman where approximately half of the women studied had high parity with a significantly higher incidence of AIP [23]. The same risk was not evident when analyzed according to the 432 number of pregnancies, not live births in this study. Short interpregnancy interval, or high 433 434 parity/fertility depletes nutrition reserves and thus, predisposes women to a higher risk of 435 anemia [5.6,11]. Of note, while age at pregnancy had no significant relation with AIP in this 436 study, the findings support evidence that increase childbearing influences nutrient depletions, 437 a putative risk factor for anemia in the reproductive cycle [5,6,23].

438

439 The result also exemplified anemia as a condition of the poor and overweight/obesity as conditions of the affluents. Whereas, poverty was inversely associated with 440 overweight/obesity in women, poverty and high parity were positively associated with 441 442 increased risk of anemia. Evidently, when women's economic status improved, the risk of anemia being more likely decreases while overweight and obesity increased. In other words, 443 444 women in the lowest and second quintiles were more likely to have anemia than their 445 counterparts in the highest income quintiles, but not overweight/obesity. It could be speculated 446 that poorer women are more likely to have many children, which may push them into poverty 447 and thereby they may be unable to afford healthy diets to prevent AIP. Indeed, having 5 or more children predisposed women to low income (poverty) and anemia, but not overweight 448 and obesity in this study. Studies in part of Asia and Eastern Africa demonstrated that a lower 449 450 average monthly income and high parity were vital modifiable risk factors for rising levels of AIP [12,43,44]. Conversely, birth control strategies and education reduced the risk of AIP 451 [44,45]. These results underscore the significance of improving individuals or household 452

income status whilst maintaining a replacement-fertility level, particularly among the poor, asrecommended in other studies [8,10,11,21,44,45].

455

456 The direct association between high parity, poverty, and increased likelihood of AIP found in the present study was associated with frequent birthing experiences in other literatures 457 458 [45]. For instance, whereas Oman reported a higher incidence of AIP in high parity women, analysis of Myanmar's first Demographic and Health Survey data revealed elevated risks of 459 460 AIP prevalence [46]. Understandably, high parity women have higher chances of experiencing 461 hemorrhage during childbirth due to malnourishment associated with frequent pregnancies or short interpregnancy intervals [5,6,23]. Another plausible reason could be that having more 462 463 children increases household/family size, which may result in women being unable to get 464 adequate nutrition, thus explaining the apparent different risk for anemia in relation to the 465 number of pregnancies, compared to live births and also the low income suggested in the 466 present study.

467

A larger proportion of pregnant adolescents were anemic compared to the adults 468 however the results were not statistically significant. This finding seems to contrast the findings 469 470 that high parity, a factor associated with age, increases the risk of AIP [5,6,23,46]. Indeed, the result demonstrated that high parity resulted in an increased odd of AIP, but not in association 471 472 with adulthood. The higher proportion of AIP in the adolescents could be attributed to their inability to meet daily nutrient requirements prior to pregnancy and thereby unable to meet the 473 increased nutritional demand in pregnancy [15]. This may be due to the inability to sustain iron 474 475 and hemoglobin levels during menstruation in adolescence.

Ethnicity was an unmodifiable risk factor for overweight/obesity and anemia in 477 pregnant women across the study regions. The residents of the Central region, most of whom 478 were of the Akan ethnic origin, had the highest proportion of AIP consistent with a recent study 479 in the region [47]. The Ewes who are predominantly domiciled in the Volta region came second 480 following Central regional record of anemia. However, women from Volta had the highest 481 odds – twice the risk – of AIP among the ethnics compared to Akans who had about 1.8 times 482 483 risk. However, obesity was higher (nearly one-fifth) in Central and Eastern respectively 484 compared with about one-sixth in Volta (figure not shown). These levels of obesity and anemia 485 in Volta region cast doubt that obesity reduces anemia risk. Nonetheless, elsewhere, in Saudi Arabia obese pregnant women, about three-fifths were anemic [48], whereas analysis of a 486 487 National data from Ghana indicated below 10% co-occurrence of overweight/obesity and 488 anemia in WIFA, [36] but more than half were shown to have co-occurrence of overweight and 489 anemia [35].

490

The regional and ethnic variations in anemia and overweight/obesity found in Southern
Ghana corroborate previous studies in the Middle and Northern parts of the country [8–10].
Elsewhere, secondary analysis of the Colombian National Nutrition Survey (ENSIN) 2010 data
elucidated similar associations of high levels of AIP across geographic groups/ethnicities [49].
However, developing country like Ethiopia and Tanzania reported a moderate level of anemia
in women whilst some high-income countries such as New Zealand, Australia, England, and
Ireland, reported below three percent prevalence [11–13].

498

The established burden of anemia and overweight, and obesity in pregnant South Ghanaian women enhances the WHO recommendation for increase ANC attendance where women anthropometry, dietary counselling, and socioeconomic measurements are assessed

502 before delivery [22]. And whereas obesity seems protective against AIP in this study in support 503 of other studies, but contrarily to many other findings, it is important to deploy alternative diagnostic methods to further explain the rising trend of overweight/obesity and anemia and 504 505 the causes in Ghanaian women [2,18,50]. For instance, measuring ID including detecting inflammation is supported in a WHO guideline where ferritin concentration is recommended 506 507 for iron status assessment [50]. A review of overweight/obesity and risk of ID/anemia by Wawer et al. corroborates the WHO's guideline [2]. Mwangi and colleagues have, however, 508 509 cited uncertainties in the use of zinc protoporphyrin (ZPP) in addition to Hb concentration to 510 define AIP [51]. Regardless of the findings, a further review has advocated for its use [51]. 511

512 Limitations and strengths

513 Cause and effect relationships are hard to determine since the data were drawn from an observational cohort study baseline data. Dietary habits and preventive services like iron 514 515 supplementation, helminths, and infection prevention during pregnancy which are important 516 risk factors were not studied, hence misclassification bias is likely. Further, the analysis also included baseline data of Hb(g/dl) concentration measurement that has several limitations in 517 518 anemia estimation than iron status (for example, serum ferritin) assessment [50]. Additionally, 519 the regions and the health facilities were conveniently selected and no urban-rural segregation 520 could potentially bias the results. However, the method was recommended as necessary for 521 LMICs [31].

522

523 Consequently, the researcher has made cautious interpretations of the results and deployed 524 anthropometry data to determine nutritional effect on maternal anemia. The study also 525 enhanced the reliability of data through the use of a validated tool by skilled professionals who 526 had training on the study method and were provided with standard references for data

527 collection. In addition, field investigators had assigned supervisors knowledgeable in528 nutritional and health surveys.

529

530 Conclusion

Anemia in pregnancy and overweight, and obesity as a double burden of malnutrition 531 remains significantly high in pregnant South Ghanaian women. The AIP exceeded the WHO 532 533 defined threshold as a significant public health threat and was particularly highest in women having high parity, short stature, and underweight. While high parity and income status 534 535 increased overweight/obesity, obese women were more likely to have a reduced risk of anemia. 536 However, across the ethnicity, high parity and low-income status posed significant risk of 537 anemia in women. As women with an improved income status were more likely at risk of overweight/obesity but less anemic, public health nutrition recommendations should focus on 538 targeting these higher income women to ensure they focus on more healthy diets and physical 539 activity to reduce excess BMI. 540




