Determinants of wasting, stunting, and undernutrition among children under five years: Cross-sectional study in southern Punjab, Pakistan

1 Abstract

Background: Malnutrition is a serious concern globally and may lead to early death if it remains
untreated. Prevalence of malnutrition is high in South Asian countries. Therefore, this study aims
to evaluate the determinants of wasting, stunting, and undernutrition in under-five children of
southern Punjab, Pakistan.

Methods: We conducted a cross-sectional study among 185 children. Anthropometric measures
 were done by nutritional experts and pediatricians. Data were analyzed with SPSS version 25.0. A
 p-value <0.05 was considered statistically significant.

9 *Results:* Significant determinants of wasting (weight-for-height) were family monthly earnings 10 (β =-0.14; 95% CI: -0.89 to -0.04; p=0.03) and complementary feeding practices (β =-0.21; 95% 11 CI: -1.14 to 0.19; p<0.001). For stunting (length/height-for-age), the significant determinants were 12 tuberculosis (TB) contact history (β =-0.15; 95% CI: -0.97 to -0.03; p=0.03) and non-use of 13 exclusive breastfeeding practices (β =-0.19; 95% CI: -1.40 to 0.16; p=0.01). For undernutrition, 14 significant determinants were monthly income (β =0.28; 95% CI: 0.11 to 0.62; p=0.02) and 15 exclusive breastfeeding practices (β =0.22; 95% CI: 0.17 to 0.39; p=0.02).

16 Conclusion: Social determinants such as family earnings, family food security, practices of 17 exclusive breastfeeding and proper complementary feeding, number of under-five siblings, and 18 history of TB contact have a strong association with malnutrition and undernutrition. Concerted 19 and comprehensive strategies are needed for the improvement of associated factors to combat 20 malnutrition as well as undernutrition among children.



23 Introduction

Malnutrition with all its types, especially undernutrition, wasting (height-for-weight), and stunting 24 (height-for-age) are usually characterized by abnormal or inadequate food intake (1). Owing to 25 undernutrition, children are more susceptible to diseases or even death. The risk of death increases 26 27 in moderate to severely wasted children. According to the World Health Organization (WHO), 28 stunting is also present among children with low socioeconomic status, poor feeding practices, poor nutrition and health of the mother, and child illness in the early stages of life [1]. 29 Globally, the situation of malnutrition is critical: In 2019, 47.0 million children under the age of 30 31 five years were wasted and 144.0 million children were stunted. South Asia has the highest number of wasted (25.2 million; 14.3% of children under five in South Asia) and stunted (55.9 million; 32 31.7% of children under five in South Asia) children under five [2]. Overall, families with higher 33 income and education levels had lower rates of underweight children [3]. 34 The death rate associated with undernutrition is higher in low- to middle-income countries. Almost 35 45% of deaths of children below the age of five years were associated with undernutrition [1]. 36 Wasted children are more prone to experience several infections, delays in cognitive development, 37 and reduced productivity in adulthood [4]. The economic, medical, social as well as developmental 38 impacts of malnutrition cause decreased growth and development potential of children. It is a very 39 serious issue not only for individuals and families, but also for economic productivity of already 40 resource scare countries [1]. 41

According to the National Nutrition Survey 2018, Pakistan has a 40.2% stunting prevalence, 17.7%
wasting rate, and 28.9% of children below the age of five years are underweight. Overall, 48.4%
of infants received exclusive breastfeeding and 45.8% of mothers started early initiation of
breastfeeding. Boys are slightly more stunted, wasted, and underweight (40.9%, 18.4%, and

29.3%, respectively) as compared to girls (39.4%, 17.0%, and 28.4%, respectively) [5]. Although a growing body of research on child nutritional status is available in Pakistan, studies are still lacking which investigate the effect of different determinants of malnutrition. Therefore, the purpose of the current study was to understand the determinants of wasting, stunting, and undernutrition to identify new targets for intervention to prevent malnutrition of children under five years of age in southern Punjab, Pakistan.

53 Methods

54 Study design

A multicenter cross-sectional study was conducted at Community Management of Acute Malnutrition (CMAM) centers in four villages of southern Punjab, running under the supervision of the health department of the government of Pakistan. These were government-designated centers for the management of malnutrition in under five children. Study participants enrolled from these centers visit CMAM centers to receive their nutritional treatment. Southern Punjab is a highly populated and socio-economically deprived area with the worst indicators of illiteracy, malnutrition, infant and under-five child mortality in Pakistan [5,6].

63 Sample

The sample size was calculated by using the cross-sectional study formula taking severe malnutrition prevalence (p) as 11% and error term (d) as 0.05. The calculated sample size was n=151. This number was further enhanced to 185 for study precision, strength and accuracy.

A total of 185 children aged 6–59 months without gender specification were enrolled. Eligibility
 criteria were having severe wasting or stunting identified by anthropometric indices of WHO

classification, which are having height-for-weight (wasting) < -3 standard deviations (SD) and
height-for-age (stunting) < -2 SD [7,8]. All children were from the same ethnic and language
background. Written consent was obtained from parents after introducing them to the purpose of
the study. A flow chart for eligibility criteria is presented in Figure 1.

74 Baseline assessments

Interviews with parents were conducted at CMAM centers. An extensively pretested structured 75 questionnaire was used for collection of information from parents/caregivers regarding family 76 77 sociodemographic characteristics (income, parental education, profession, household size, and family structure), child nutrition (breastfeeding and complementary feeding practices), biological 78 and healthcare characteristics (child medical history, immunization record, and access to health 79 80 care). Family monthly earning was assessed by income from all sources in Pakistani rupees (PKR). Exclusive breastfeeding and complementary feeding practices (quantity, variety, and frequency) 81 of semisolid diet were judged according to WHO recommendations [9]. For immunization status, 82 the Expanded Program of Immunization (EPI) schedule was followed [10]. The immunization 83 status was verified by the vaccination card. Child medical history was assessed by previous 84 hospital records and prescriptions. A brief history was acquired from parents/caregivers to identify 85 the child for any seizure disorder and neurological deficit. Children sick with these conditions were 86 not enrolled in the study. All of these determinants of wasting, stunting, and underweight were 87 88 included in the study after an extensive literature search.

In case of hospital delivery, child gestational age was calculated from previous antenatal hospital
documentation and in case of delivery at home, information based on a maternal report was noted.
For children who were delivered before 37 weeks of gestation and at the date of data colletion

were ≤24 months of age, their age was adjusted by deducting the entire weeks of missed gestation
from the current age.

95 Anthropometric assessments

Anthropometric assessments were taken by the qualified nutritional supervisors. Their competency 96 97 in assessing weight and height was approved by the first author. Double anthropometric values were recorded by a study team. If both values were different from each other, then further 98 measurements were conducted until an exact value was measured. The replicated value was then 99 100 documented. Children's weight (approximated to 10 g) was assessed without clothing or in very light outfit through a UNISCALE, which was fixed by a standard weight and adjusted to zero 101 102 before each evaluation. First, UNISCALE was used to record only the weight of the mother if 103 infants and children were not able to stand. Afterwards, the undressed baby or child was given to the mother as she stood on the scale, and the cumulative weight of the mother and infant was 104 evaluated [8,11]. Infant/child weights were calculated as the difference between these two 105 106 measures.

107 The recumbent length of kids ≤ 87 cm in height was measured to the nearest 0.1 cm with a length-108 measuring board with a fixed headrest and an adjustable foot piece ("SECA GmbH & Co. KG, 109 Hamburg, Germany"). Children over 87 cm tall were evaluated by standing with their bare feet 110 and heels together on a flat horizontal plate attached to the measurement board. Weight-for-height 111 Z-scores and height-for-age Z-scores were calculated using the WHO Child Growth Standards 112 [8,11]. Nutrition status classification was done with "WHO ANTHRO, version 3.2.2".

114 Dependent and independent variables

In this study analysis, the dependent variables were wasting (weight-for-height Z-score) as a measure of acute malnutrition, stunting (height-for-age Z-score) as a measure of chronic malnutrition, and undernutrition (weight-for-age Z-score). All sociodemographic, medical, and dietary factors described above have been included as independent variables.

120 Data analysis

121 Data was analyzed using SPSS 25.0. An independent t-test was used to compare the Z-score mean 122 differences between independent variables for wasting, stunting, and undernutrition. A 123 multivariate analysis was performed to identify the significant determinants causing wasting, 124 stunting, and undernutrition among children under five years. Based on continuous dependent 125 variables, Linear regression models were applied for multivariate analyses. The results were 126 reported as β coefficients with 95% confidence intervals (CI). p-values of 0.05 and less were 127 considered as statistically significant.

129 *Ethical approval*

Permission to conduct the study was obtained from the provincial and district health department of Punjab, Pakistan. This study was conducted according to the guidelines laid down in the Declaration of Helsinki and all procedures involving human subjectss were approved by the Ethical Review and Advanced Study Research Board of the University of Punjab, Pakistan (ref-9/2352-ACAD). Written informed consent from parents was obtained from all subjects.

136 Results

A total of 185 children aged 15.36 months (SD \pm 10.23) participated in this study. They had a midupper arm circumference of 10.19 cm (SD \pm 0.96). The majority were females (n=104; 56.2%), had a family income of \leq 15000 PKR (n=128; 69.2%) and at least two siblings (n=144; 77.8%). Overall 100 children (54.1%) had one to seven previous episodes of illness, 149 (80.5%) had no exclusive breastfeeding, and poor complementary feeding practices were seen in 165 children (89.2%) children as shown in Table 1.

144 Determinants of wasting (acute malnutrition: weight-for-height Z-score)

In the bivariate analysis, wasting was significantly associated with family monthly earning with a mean difference of 0.43 (95% CI: 0.01 to 0.85; p=0.04) and complementary feeding practices with a mean difference of 0.51 (95% CI: 0.05 to 0.96; p=0.03). Applying linear regression for the multivariate analysis, family monthly income (β =-0.14; 95% CI: -0.89 to -0.04; p=0.03) and complementary feeding practices (β =-0.21; 95% CI: -1.14 to 0.19; p<0.001) were again significant determinants (Table 2).

152 Determinants of stunting (chronic malnutrition: height-for-age Z-score)

In bivariate analysis of stunting, tuberculosis (TB) contact history and the practices of exclusive breastfeeding with a mean difference of 0.41 (95% CI: -0.53 to 0.86; p=0.04) and 0.75 (95% CI: 0.18 to 1.31; p=0.01), respectively, were statistically significant. The linear regression showed a significant association of stunting with TB contact history (β =-0.15; 95% CI: -0.97 to 0.03; p=0.03) and exclusive breastfeeding practices (β =-0.19; 95% CI: -1.40 to 0.16; p=0.01) (Table 3).

159 Determinants of undernutrition (weight-for-age Z-score)

The results for undernutrition are shown in Table 4. In the bivariate analysis, monthly income with a mean difference of 0.32 (95% CI: 0.03 to 0.61; p=0.03) and the practices of exclusive breastfeeding with a mean difference of 0.39 (95% CI: 0.05 to 0.73; p=0.03) were significantly associated with undernutrition. Application of linear regression in the multivariate analysis showed a statistically significant association between undernutrition and monthly income (β =0.28; 95% CI: 0.11 to 0.62; p=0.02) and exclusive breastfeeding practices (β =0.22; 95% CI: 0.17 to 0.39; p=0.02).

168 Discussion

Malnutrition and undernutrition are detrimental for the future generation. Our study highlighted 169 170 several determinants of wasting, stunting, and undernutrition. If addressed carefully, it could result in lower rates of children suffering from these conditions. Among others, the results show that 171 children from low socio-economic status (monthly income less than 15,000 PKR) had a higher 172 risk of wasting as compared to those children who belonged to relatively higher income (15,000 173 to 35,000 PKR monthly). Income level is an obvious factor that affects food intake. Families with 174 low income are not able to feed their children properly due to limited resources. Some other studies 175 also claim the effect of income on malnutrition [12,13]. 176

In our study, the majority of the children were severely acute malnourished. In addition, chronic malnourishment owed to poor complementary feeding practices. Because weaning practices have a crucial role in the development of children and prevention of malnutrition, proper eating habits or good complementary feeding practices are key factors to improve the nutritional status of children. When children receive an adequate amount of food or a complementary diet, they have

a positive trend towards healthy growth and development. Poor weaning practices negatively affect
the nutritional status leading to malnutrition [2,9]. Complementary feeding along with
breastfeeding up to 24 months of age provides an adequate amount of nutrients and also provides
balanced nutrition that is essential not only for the development of children but also for the
prevention of malnutrition [9].

Breastfeeding should start from birth and continue till the second birthday of the child along with complementary feeding that prevents acute and chronic malnutrition, as mother's milk alone cannot fulfill the requirement of growing children [9,14,15]. Breastfeeding without complementary feeding after six months of age might be a risk factor for malnutrition due to the lack of essential nutrients that are necessary for the normal growth and development of children [9].

193 Improper and non-exclusive breastfeeding can lead to acute and chronic malnutrition. According to a study conducted in Pakistan, 48.4% of children were exclusively breastfed and 45.8% of 194 mothers started early initiation of breastfeeding right after the birth of a baby [5]. Exclusive 195 breastfeeding should start in the first hour after the birth, because mother's milk has a balanced 196 amount of nutrients necessary for the newborn [9,12]. Some infectious diseases have an impact on 197 the degree of malnutrition as well as on the growth and development of children. Previous research 198 has shown that children frequently having infections were more undernourished [16-18]. Children 199 having a history of TB were more likely to be stunted and malnourished because of inflammation 200 201 [16].

Children with three or more siblings are more likely to be stunted than those children who have one or two siblings. The point is that with more children in a household, lower amounts of food might be available per person. In this way, health and nutritional status may be compromised and

children are more likely to be wasted or stunted [2,14,15]. Children born at birth intervals less than
two years are more likely to develop acute or chronic malnutrition [11,14]. The higher the number
of children under five in a family, the more scarce are the resources to properly feed all children
[2,17,18]. A large household size also has been shown to negatively affect children's health,
nutritional status, and development [12,17].

Mother's education has an important part in the healthy growth and development of infants and young children. In the current, the study majority of mothers were uneducated and their children showed more nutritional problems. An educated mother may be better aware of the nutritional needs of her child and, thereby, may prevent stunting and wasting [19].

There are some limitations to this study due to its cross-sectional design. Anthropometric measures have been conducted by qualified personell which promote data quality. By observing children's nutritional state with greater insight, the dynamic nature of child's growth and development could be better understood.

219 Conclusion

Children under the age of five years are prone to malnutrition as well as undernutrition. Almost all 220 developing countries are suffering from the public health issues of malnutrition as well as 221 undernutrition among children. The findings of the current study indicate that wasting and stunting 222 along with undernutrition are associated with exclusive breastfeeding and complementary feeding 223 224 practices, household size, family earning, and history of infections. Concerted efforts will be needed from all sectors of society to tackle the problem of child malnutrition in Pakistan. Alertness 225 regarding a child's dietary needs and other factors leading to child growth must be incorporated in 226 227 the child nutrition program.
