

1 **Are We Seeing the Unseen of Human Trafficking? A Retrospective Secondary**
2 **Analysis of the CTDC K-Anonymized Global Victim of Trafficking Data Pool**
3 **in the Period 2010-2020**

ABSTRACT

Background: Human trafficking is considered a hidden global threat with unsubstantiated numbers despite the estimation of the presence of around 40.3 million victims worldwide. Human trafficking results in severe detrimental impacts on both mental and physical health. Given the sensitivity and negative consequences of human trafficking on the global system and victims, and considering the scarce research in this area, our current study aimed at describing the (i) Sociodemographic profiles of anonymized victims, (ii) Means of control, and (iii) Purpose of trafficking, utilizing the largest anonymized and publicly available dataset on victims of human trafficking.

Methods: This is a retrospective secondary analysis of the Counter-Trafficking Data Collaborative (CTDC) data pool in the period from 2010 to 2020. The utilized dataset is called the k-anonymized global victim of trafficking dataset, and it is considered the largest global dataset on victims of human trafficking. Data from the k-anonymized data pool were extracted and exported to Statistical Package for Social Sciences, SPSS® version 27.0 for Windows (IBM Corp. Version 27.0. Armonk, NY) for quality check and analysis using descriptive statistics.

Results: A total of 87003 victims of human trafficking were identified in the period from 2010 to 2020. The most age category encountered among victims was 9-17 years with around 10326 victims (11.9%), followed by 30-38 years with 8562 victims (9.8%). Females comprised 70% of the sample with 60938 victims. The United States (n=51611), Russia (n=4570), and the Philippines (n=1988) comprised the most countries of exploitation/trafficking. Additionally, the year 2019 witnessed the greatest number of victims registered for assistance by anti-trafficking agencies with around 21312 victims (24.5%). Concerning means of control, threats, psychological abuse,

48 restriction of the victim’s movement, taking the victim’s earnings, and physical abuse were the
49 most reported means. Around 42685 victims (49.1%) reported sexual exploitation as the purpose
50 of their trafficking, followed by forced labor with 18176 victims (20.9%).

51 **Conclusion:** Various means and methods can be used by traffickers to control the victims to be
52 trafficked for many purposes, with sexual exploitation and forced labor being the most common
53 ones. Global anti-trafficking efforts should be brought together in solidarity through utilizing the
54 paradigm of protection of victims, prosecution of traffickers, prevention of trafficking, and inter-
55 sectoral partnerships. Despite being a global concern with various reports that tried to capture the
56 number of trafficked victims worldwide, human trafficking still has many unseen aspects that
57 impose a significant challenge and adds to the global burden in combatting this threat.

69 **1. BACKGROUND**

70 Generally, migration is defined as changing the place of habitual residence for a variety of
71 reasons, and this can be temporarily or permanently, within the same country or through moving
72 to another country (1,2). For simplification, migration can be classified into internal migration
73 (within the same country), or external migration (moving to another country). Also, various
74 geopolitical, technological, and environmental factors are shaping global migration (2). People
75 migrate for a variety of reasons, some of which are man-made hazards (e.g., wars and armed
76 conflicts, violation of human rights), natural/environmental disasters (earthquakes, floods,
77 Tornados, epidemics, droughts), or other peaceful reasons such as studying, or looking for job
78 opportunities (i.e., labor migration) (3). Statistically, around 3.6% of the world’s population are
79 migrants in 2020 (i.e., people who migrated) and this corresponds to 281 million according to the
80 most recent world migration report 2022 released by the International Organization for Migration
81 (IOM) (2). Of the global 281 million migrants as of 2020, 135 million are female, and 146 are
82 males, with around 169 million people migrating due to labor reasons (i.e., Labour migrants).

83 From a legal perspective, migration can be categorized into regular migration which is
84 considered an authorized movement managed by various official authorities around the world, or
85 irregular migration which corresponds to unauthorized movement through illegal ways such as
86 smuggling and human trafficking (4). The term human trafficking is also known in the literature
87 as trafficking in person (TIP) or modern-day slavery (5). The United Nations (UN) defines human
88 trafficking as “*the recruitment, transportation, transfer, harbouring or receipt of persons, by*
89 *means of the threat or use of force or other forms of coercion, of abduction, of fraud, of deception,*
90 *of the abuse of power or of a position of vulnerability or of the giving or receiving of payments or*
91 *benefits to achieve the consent of a person having control over another person, for the purpose of*

92 *exploitation*” (6,7). Also, the US National Human Trafficking Resource Centre (NHTRC) defines
93 human trafficking as “*Human trafficking involves the use of force, fraud, or coercion to compel a*
94 *person into commercial sex acts or labour or services against his or her will*” (8). Human
95 trafficking is considered a crime and a severe multidimensional violation of human rights as well
96 (9).

97 A model called the Actions - Means - Purpose model (The A-M-P model) describes how
98 human trafficking occurs (9). Actions that may be taken by the perpetrator/trafficker include
99 recruiting, harboring, obtaining, patronizing, soliciting, or transporting, while the means include
100 force, coercion or fraud, and the purpose of trafficking is usually sex trafficking (commercial sex)
101 or labor/service trafficking (8). Concerning the dimensional aspects of the means in the A-M-P
102 model, the force could be through physical assault, confinement, or drugging the victim, fraud
103 could be through false promises, fake travel documents, or false advertising, while coercion could
104 be either physical (e.g., threatening to hurt someone, threatening by a weapon) or psychological
105 (e.g., threats against the victim or the family, threats to be sent to jail) (9). Also, human trafficking
106 as a concept differs from human smuggling as they are considered two distinct terms and crimes.
107 While human smuggling requires the movement of victims across borders, human trafficking can
108 occur without leaving the country (10). Although both concepts differ, smuggled humans have a
109 high vulnerability for being victims of human trafficking too (10).

110 Trafficking of humans results in significant negative impacts on both mental and physical
111 health due to the accompanying physical and psychological violence, in addition to poor living
112 conditions (11). Various psychological responses have been reported by victims including
113 posttraumatic stress symptomology, depression, anxiety, aggression, irritability, poor sleep,
114 insomnia, avoidance and isolation, phobias and panic attacks, substance abuse, hopelessness,

115 distrust and fear of strangers, loss of interest in things, inability to plan for the future, fear of being
116 permanently damaged, and fear of rejection (12).

117 In addition to the mental health impacts, human trafficking imposes detrimental
118 consequences on victims' physical well-being too. Victims of human trafficking do not have
119 sufficient access to quality medical care due to various reasons, with financial constraints and the
120 victim's illegal status being the most common barriers (11). Moreover, victims are more prone to
121 food deprivation and poor nutrition, memory loss, chronic pain, infectious diseases including viral,
122 parasitic, and bacterial diseases (e.g., hepatitis, tuberculosis, sexually transmitted infections,
123 contagious skin infestations), and occupational injuries (12).

124 Human trafficking is considered a hidden global problem with unsubstantiated numbers
125 despite the presence of some global estimates and reports (13). In 2017, the International Labour
126 Organization (ILO) estimated the presence of approximately 40.3 million victims of human
127 trafficking, of whom 29.4 million were identified as victims of forced labor trafficking (6). Given
128 the sensitivity, and negative consequences of human trafficking on the global system and victims,
129 and considering the scarce research in this area, our current study aimed at analyzing part of the
130 largest anonymized dataset on victims of human trafficking in the period 2010-2020. More
131 specifically, we aimed at describing the following: (i) Sociodemographic profiles of anonymized
132 victims, (ii) Means of control, and (iii) Purpose of trafficking. More details about the dataset and
133 the analysed variables are described in the methods section of this paper.

137 2. METHODS

138

139 2.1 Study Design

140 This is a retrospective secondary analysis of a publicly available dataset on global victims
141 of human trafficking.

142

143 2.2 An Overview of the Dataset and Data Contributors

144 The dataset used in our analysis is based on the Counter-Trafficking Data Collaborative
145 (CTDC) which is a collaborative hub on human trafficking that provides data through collaboration
146 between various counter-trafficking agencies including the IOM, Polaris, Recollectiv (formerly:
147 the Liberty Shared), The Portuguese Observatory on Trafficking in Human Beings (OTSH), and
148 the A21 (14). Additionally, Microsoft® and Tech Against Trafficking are the technology
149 contributors. The CTDC initiative's donors are the U.S. Department of State Bureau of Population,
150 Refugees, and Migration (PRM); the U.S. Department of Labour (DOL) through the International
151 Labour Organization (ILO)'s Research to Action (RTA) project; the Global Fund to End Modern
152 Slavery (GFEMS) under a cooperative agreement with the U.S. Department of State (DOS); the
153 IOM Development Fund; and the Ministry of Foreign Affairs of the Netherlands (BZ) (14).

154 The created dataset by the CTDC initiative is called *the global victim of trafficking dataset*.
155 It is considered the largest global dataset on victims of human trafficking. The required data are
156 collected and updated by the contributing agencies and through the case management system (15).
157 Due to the sensitivity of human trafficking data, individual-level data were protected at two stages,
158 the first stage is through the elimination of all personal identifiers from the dataset, and the second
159 stage which corresponds to a more advanced level of protection is through a mathematical

160 approach called k-anonymization (15). The global K-Anonymized dataset that has been used in
161 our analysis comprises data on more than 156,000 victims of human trafficking from around 189
162 countries from 2002 to 2021. This dataset used in our analysis is dated 15 July 2021, and it is
163 publicly available to researchers and policymakers through the CTDC website (
164 <https://www.ctdatacollaborative.org/dataset/global-k-anonymized-data-and-resources>).

165

166 **2.3 Study Population in the Analysed Period**

167 The authors of the present paper have decided to analyze the data for the period 2010 to 2020
168 using the k-Anonymized global victim of trafficking dataset. In the mentioned period, 87003
169 victims of human trafficking were identified.

170

171 **2.4 Description of the Analysed Variables**

172 2.4.1 *Sociodemographic Information:* This part comprised variables that are related to the year
173 of registration (reflects the year in which the victim was identified and assisted by the
174 counter-trafficking agency), data source (reflects the data collection method, whether
175 through case management system or hotline service), gender (female, male, or
176 transgender), age category in years (0-8, 9-17, 18-20, 21-23, 24-26, 27-29, 30-38, 39-47,
177 48+), majority status at registration (reflects whether the victim was above 18 years or
178 under 18 years of age at the time of registration and assistance by the concerned counter-
179 trafficking agency; thus, categorized as adult or minor), majority Status at
180 exploitation/trafficking (reflects whether the victim was above 18 years or under 18 years
181 of age at the time of trafficking or exploitation; thus, categorized as adult or minor), the

182 victim's nationality or the country of origin, and country of trafficking/exploitation (the
183 country where a victim is first identified and assisted). Concerning gender classifications,
184 the IOM started to include gender (not sex at birth) including the transgender/non-
185 Conforming category in the survey questionnaire starting in 2017.

186 2.4.2 *Means of Control:* In this part, the means of controlling human trafficking victims are
187 collected, and it includes control by debt bondage, control by taking the
188 remunerations/earnings of the victims, control through restrictions of victim's capability to
189 access the needed daily living funds, control through threats, control through psychological
190 abuse, control through physical abuse, control through sexual abuse, control through false
191 promises, control through psychoactive substances, control through restriction of victim's
192 freedom of movement, control through restriction of access to medical care, control
193 through excessive working hours, control through restricting the victims' access to their
194 children, control through threats of law enforcement and imprisonment, control through
195 withholding necessities such as access to basic daily needs, and control through
196 withholding or destroying official documents such as passports, work permits, or other
197 legal or governmental documents. It is important to note that traffickers may use a
198 combination of these means of control to exploit and enslave their victims.

199 2.4.3 *Purpose of Trafficking:* This part reflects the purpose of trafficking of the victims, and it
200 includes, forced labor, sexual exploitation and services, combined sex and labor services,
201 forced marriage (a marriage that was imposed on the individual under the threat of a
202 penalty), forced military service (military service that was imposed on the individual under
203 the threat of a penalty), organ removal, as well as slavery and similar practices. Regarding

204 sex services, this included prostitution, pornography, remote interactive services, and
205 private sexual services.

206

207 **2.5 Data Analyses**

208 Data from the k-anonymized global victim of trafficking dataset were extracted and exported
209 to Statistical Package for Social Sciences, SPSS® version 27.0 for Windows (IBM Corp. Version
210 27.0. Armonk, NY) for quality check and analysis. Descriptive statistics were performed for
211 categorical and numerical data. The age was presented in categories that were described in section
212 2.4.1. Other categorical variables were presented as frequency counts and percentages. The dataset
213 has many missing values in various parts which represent data that were not collected/missed/could
214 not be retrieved. Missing values were reported where appropriate.

215

216 **2.6 Ethical Considerations**

217 The utilized dataset was already anonymized by the CTDC's technological support
218 agencies using a two-step anonymization. Additionally, there was no required ethical approval
219 for the utilization of the dataset as it is freely and publicly available to researchers and
220 policymakers through the CTDC initiative website
221 (<https://www.ctdatacollaborative.org/dataset/global-k-anonymized-data-and-resources>).

225 **3. RESULTS**

226

227 **3.1 Sociodemographic Profile of Victims**

228 A total of 87003 victims of human trafficking were identified in the period from 2010 to
229 2020 within the utilized dataset. The most age category encountered among victims was 9-17 years
230 with around 10326 victims (11.9%), followed by 30-38 years with 8562 victims (9.8%). 43656
231 victims (50.2%) were identified as adults (aged 18 years and above) at the time of registration for
232 assistance by anti-trafficking agencies, whereas 6675 victims (7.7%) were identified as adults at
233 the time of trafficking or exploitation. Females comprised 70% of the sample with 60938 victims.
234 Approximately, 60.5% of the trafficking data were obtained through hotline services. **Table 1**
235 presents more details about the sociodemographic characteristics of the victims.

248 Concerning nationality or country of origin of victims, the top 10 countries -in descending

249 order- were the Philippines (n=11454), Ukraine (n=7478), U.S (n=6366), Moldova (n=4984),

250 Mexico (n=2382), Cambodia (n=2130), Indonesia (n=1513), Myanmar (n=1371), Nigeria

251 (n=1040), and Belarus (n=884). 43101 victims (49.5%) had an unknown country of origin (missing

252 value). On the other hand, the top 10 countries of exploitation/trafficking -in descending order-

253 were the U.S. (n=51611), Russia (n=4570), the Philippines (n=1988), Indonesia (n=1784),

254 Cambodia (n=1029), Mali (n=550), Thailand (n=505), Malaysia (n=501), Poland (n=485), and

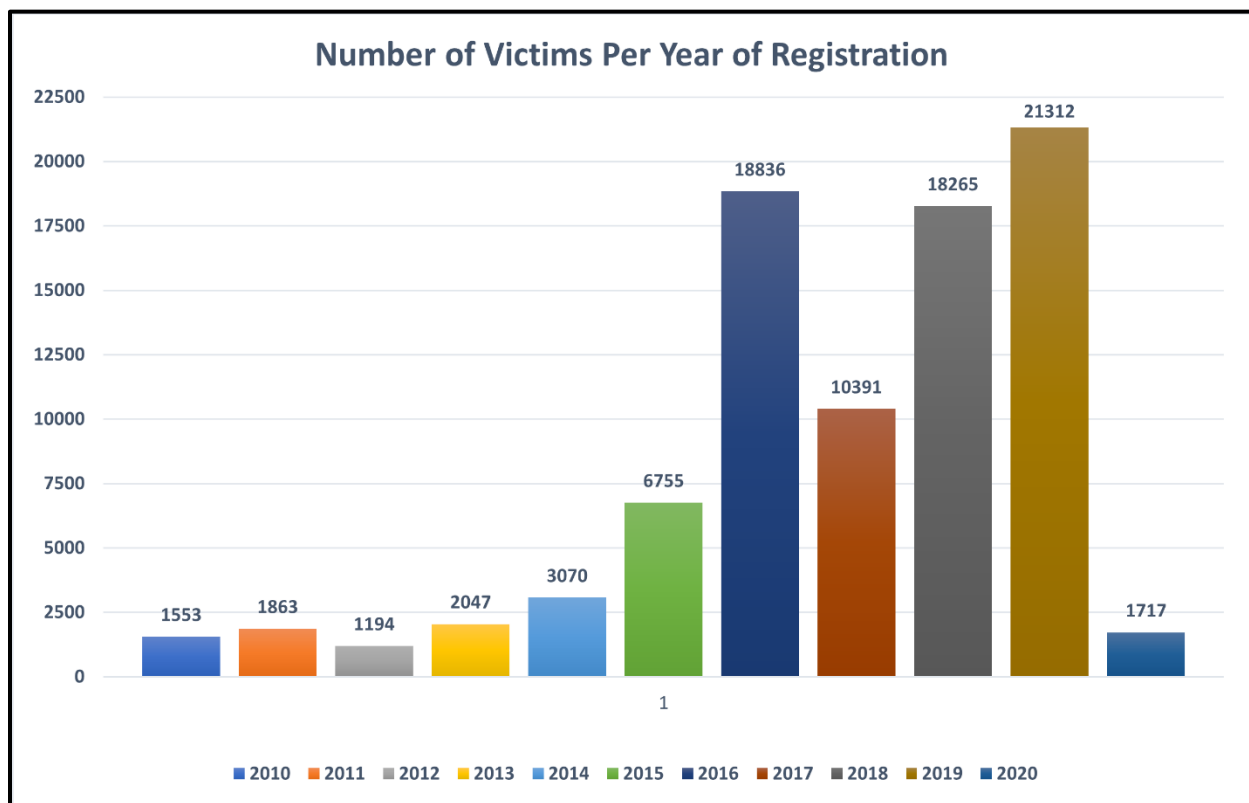
255 Saudi Arabia (n=355). Missing values related to the country of exploitation were (19072; 21.9%).

256 The year 2019 witnessed the greatest number of victims registered for assistance with around

257 21312 victims (24.5%), followed by 2016 (n= 18836; 21.6%), and 2018 (n= 18265; 21.0%). See

266 **3.2 Means of Control**

267 The most reported means of control were threats (n=12343), psychological abuse
268 (n=11980), restriction of the victim’s freedom of movement (n=11059), taking the victim’s
269 remunerations/earnings (n=8588), physical abuse (n=8187), whereas the lowest reported means of
270 control was restricting victims’ access to their children (n=360). **Table 2** shows more details about
271 the reported means of control.

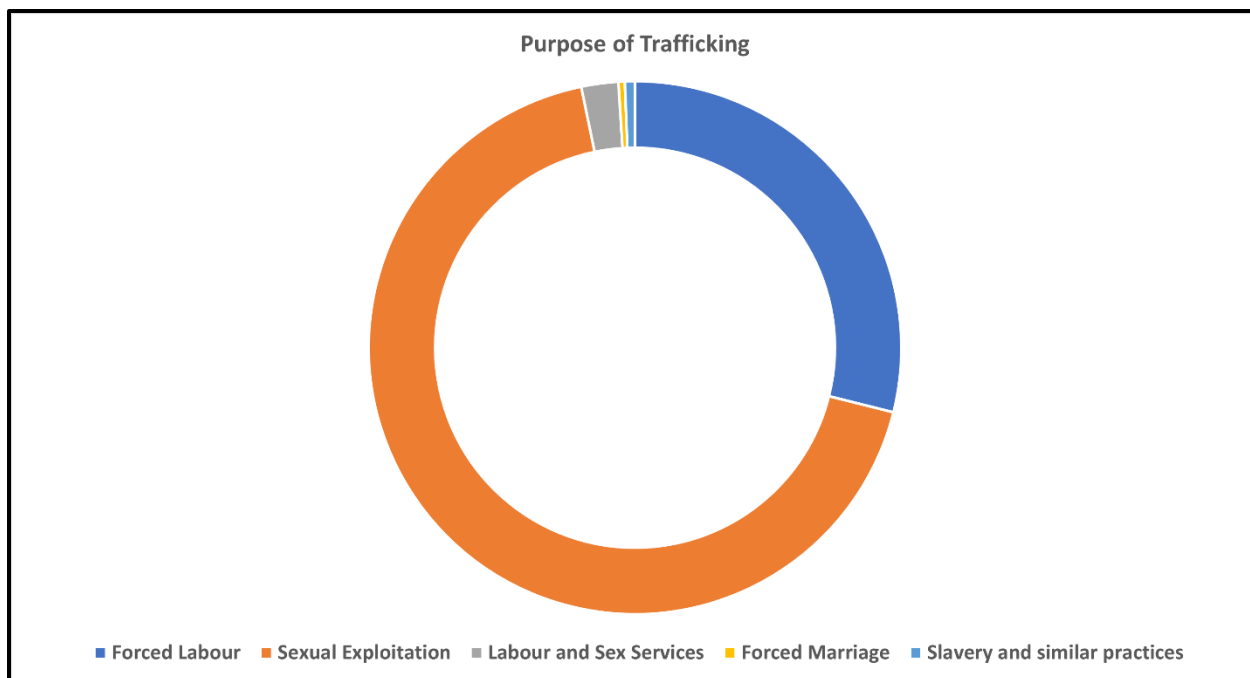

276 **3.3 Purpose of Trafficking**

277 Around 42685 victims (49.1%) reported sexual exploitation as the purpose of their
278 trafficking, followed by forced labor with 18176 victims (20.9%). See **Figure 2** for more details.

279 Concerning types of sex work for those who experienced sexual exploitation as a purpose of
280 trafficking were prostitution (n=13287; 15.3%), followed by pornography (n=1866; 2.1%), private
281 sexual services (n=487; 0.6%), and remote interactive sex services (n=118; 0.1%).

287 **4. DISCUSSION**

288 To the best of the authors' knowledge, this is the first scholarly attempt to analyze the
289 largest publicly available data pool on human trafficking in the period 2010-2020, utilizing the K-
290 Anonymized CTDC global victim of human trafficking dataset. The current analysis aimed to
291 describe the anonymized sociodemographic profile of victims, means of control, and the purpose
292 of trafficking. Our paper provides a brief and initial insight into a very sensitive and complicated
293 topic that is of global concern. As mentioned earlier, global migration is affected and shaped by
294 many geopolitical and socioeconomic factors (3,16). These factors may have a negative impact on
295 regular migration (i.e., migration through a legal process) leading to an increased level of irregular
296 migration (i.e., migration through illegal ways). Human trafficking or trafficking in person has
297 been a global concern as it attracted public attention for the past 20 years due to its detrimental

298 and harmful impact on both the mental and physical well-being of victims, its violation of the
299 victims' dignity, freedom and human rights, as well as its impact on global security (17,18). There
300 are many hazards associated with human trafficking that can be linked to exploitation-related risks
301 (e.g., abuse, occupational hazards, unsafe living conditions, and poor nutrition), or global health
302 (vulnerability to infectious and non-communicable diseases, occupational injuries, financial
303 insecurity, mental health burden, and hazardous labor cycles) (6).

304 To combat human trafficking, governments and organizations around the world have
305 implemented a range of measures and strategies to prevent trafficking, protect victims, and
306 prosecute traffickers (19). These efforts may include (i) legal frameworks through laws and
307 regulations to criminalize human trafficking and provide protections for victims, (ii) prevention
308 efforts through awareness campaigns, education programs, and efforts to disrupt the demand for
309 exploitation, (iii) protection and support for victims through providing safe and secure housing,
310 medical and mental health care, and legal assistance to victims of trafficking, (iii) prosecution of
311 traffickers through law enforcement and efforts to strengthen the criminal justice system to better
312 respond to trafficking, and (iv) international cooperation through working together and sharing
313 information and resources (20,21). This may involve collaboration across borders and between
314 different sectors, such as the law sector, social services, and non-governmental organizations
315 (NGOs). Additionally, global anti-trafficking efforts may include intelligence and information
316 sharing through gathering and sharing information about human trafficking cases, trends, and
317 networks, as well as using this information to inform law enforcement and victim services efforts
318 (20).

319

320 Some examples of global anti-trafficking initiatives and laws are, a collaboration between
321 the IOM, the European Union (EU), the United Nations Office on Drugs and Crime (UNODC)
322 was established to counteract human trafficking through The Global Action against Trafficking in
323 Persons and the Smuggling of Migrants - Asia and the Middle East (GLO.ACT Asia and the
324 Middle East) in the period 2015-2019 (22). Additionally, the UNODC has set a Global Initiative
325 to Fight Human Trafficking (UN.GIFT) which was implemented in 2007 with the main objective
326 of fighting human trafficking through raising public awareness, strengthening preventive
327 measures, supporting and protecting victims, anti-trafficking law enforcement, implementing
328 international commitment, strengthening partnerships, and providing funds for necessary services
329 and initiatives (23). Moreover, various anti-trafficking laws were established in various regions
330 such as the 2006 Ouagadougou Action Plan to Combat Trafficking in Human Beings in the African
331 Union, the Plan of Action Against Trafficking in Persons especially Women and Children - 2015,
332 the Convention Against Trafficking in Persons, Especially Women and Children - 2015, and the
333 Declaration Against Trafficking in Persons, Particularly Women and Children - 2004 which were
334 established by the association of southeast Asian nations (24). The EU has been also active in
335 implementing various measures to fight human trafficking through the 2012-2016 EU Strategy
336 towards the Eradication of Trafficking in Human Beings, and 2011 Directive 2011/36/EU on
337 Combating and Preventing Trafficking in Human Beings and Protecting its Victims. Furthermore,
338 Arab states have joined the global anti-trafficking efforts through the 2012 Comprehensive Arab
339 Strategy for Combating Trafficking in Human Beings, the 2010 Arab Initiative to Combat
340 Trafficking in Persons, and the 2008 Arab Framework Act on Combating Trafficking in Persons
341 (24). The Americas as well have paid tremendous attention to the issue of human trafficking
342 through the 2018 Hemispheric Efforts against Trafficking in Persons “Declaration of Mexico”, the

343 2014 Inter-American Declaration against Trafficking in Persons, and the 2010-2014 Working Plan
344 to Combat Trafficking in Persons in the Western Hemisphere (24).

345 Looking at how various countries and nations are standing against human trafficking
346 through various laws and initiatives, it is important to stress the point that anti-trafficking efforts
347 are challenging due to the many complexities surrounding this issue. The UN has classified human
348 trafficking as the third most profitable crime globally (25). Also, human trafficking does not only
349 have economic perspectives but also a public health one. The economic, social, and health impacts
350 of human trafficking are still not thoroughly looked at and researched. According to recent
351 statistics, human trafficking was estimated to be a \$150 billion industry (26). As mentioned
352 previously, the ILO revealed that around 40 million people were victimized through trafficking in
353 persons (6). Additionally, the same ILO statistics reported that most victims are females, which is
354 also similar to what was found in our analysis. Also, the findings of our present study are consistent
355 with the 2016 UNODC report which revealed that the majority of trafficked victims were women,
356 girls, and younger children and accounted for 71% (27). Human trafficking is affecting various
357 populations regardless of age, gender, and nationality. Children/minors are also in danger of this
358 crime as they can be trafficked for forced labor, forced military service, and sex trafficking (28).
359 In addition, certain populations have high vulnerability to being victimized through human
360 trafficking such as minors, victims of child sexual abuse, foreign nationals, persons with extreme
361 poverty, and lesbian, gay, bisexual, transgender, queer, and others (LGBTQ+) individuals (28).

362 To successfully combat human trafficking, anti-trafficking efforts should be brought
363 together in solidarity through inter-governmental and intersectoral partnerships involving
364 governmental organizations, NGOs, the private sector, and communities (29). Tackling a global
365 threat like human trafficking does not have a smooth pathway. Therefore, a multi-faceted approach

366 is required such as the 4Ps paradigm which includes: Protection, Prosecution, Prevention, and
367 Partnerships is considered an essential approach to combat human trafficking (30).

368 Our study has limitations that should be taken into consideration while interpreting the
369 findings. The CTDC K-Anonymized dataset has many missing values which may change some
370 statistical figures if these missing values were collected. Additionally, there is a possibility of recall
371 bias that impacted the collected data and may have led to the missing values as victims of human
372 trafficking might suffer from psychological traumas that negatively affect their ability to recall
373 events. Another limitation to this study could be that the numbers of those exposed to human
374 trafficking are underestimated and underreported so we cannot assume that the results are
375 generalizable to the population of global victims or international migrants. Nevertheless, our
376 findings provide an initial insight into some statistics related to human trafficking utilizing the
377 CTDC collaborative hub, and we encourage further research in this field with the involvement of
378 a longer period of analysis and utilizing more variables as well.

380 **5. CONCLUSION**

381 Human trafficking has detrimental consequences on the physical and psychological health
382 of victims. Various means and methods can be used by traffickers to control the victims to be
383 trafficked for many purposes with sexual exploitation and forced labor being the most common
384 ones. Global anti-trafficking efforts should be brought together in solidarity through utilizing the
385 paradigm of protection of victims, prosecution of traffickers, prevention of trafficking, and inter-
386 sectoral partnerships. Despite being a global concern with various reports that tried to estimate the

387 number of trafficked victims globally, human trafficking still has many unseen aspects that impose
388 a significant challenge and adds to the global burden in combatting this worldwide threat.
