## 13 Abstract

14	Background: Coronavirus disease 2019 (COVID-19), caused by severe acute respiratory							
15	syndrome coronavirus 2 (SARS-CoV-2), has created enormous medical and economic							
16	burdens on human society. However, the co-existence of COVID-19 and diseases in tropical							
17	regions is not taken seriously. To improve the understanding of the current status and trends							
18	on crosstalk of COVID-19 and tropical diseases, this paper provided an analysis, from a							
19	bibliometric perspective, of the COVID-19-related publications in 'Tropical							
20	Medicine'-entitled journals.							
21	Methods: We used Clarivate Analytics and VOSviewer to analyze 783 publications in							
22	seven 'Tropical Medicine'-entitled journals. Document overview, basic bibliometric							
23	characteristics, citation performance, co-authorship, co-citation, bibliographic coupling, and							
24	co-occurrence of keywords and terms were summarized in this article.

#### 44 1 Introduction

45 Coronavirus Disease 2019 (COVID-19), induced by Severe Acute Respiratory Syndrome Coronavirus 2 (SARS-CoV-2)<sup>[1]</sup>, has become a severe worldwide epidemic. As an 46 47 indispensable part of the world, the tropical region (defined by the region between Tropic of Capricorn and Tropic of Cancer) is inevitably impacted by the COVID-19 epidemic<sup>[2]</sup>. 48 49 According to the data of World Health Organization COVID-19 dashboard 50 (https://covid19.who.int/), there are 9138808 cumulative confirmed cases and 173674 cumulative death cases by 6:19 pm (CEST), July 6<sup>th</sup>, 2022. Besides, the co-existence of 51 52 COVID-19 and diseases in tropical regions, especially neglected tropical diseases, makes the 53 pandemic even more threatening and complicated<sup>[3]</sup>.

54 In this scenario, scientific journals within the scope of tropical medicine have paid great

55	attention to the evolving state of the COVID-19 pandemic. Seven 'Tropical
56	Medicine'-entitled journals indexed by Science Citation Index Expanded in Web of Science
57	Core Collection, i.e., Journal of Tropical Medicine, Southeast Asian Journal of Tropical
58	Medicine and Public Health, Tropical Medicine & International Health, Tropical Medicine
59	and Infectious Disease, Transactions of the Royal Society of Tropical Medicine and Hygiene,
60	Asian Pacific Journal of Tropical Medicine and American Journal of Tropical Medicine and
61	Hygiene, must be mentioned. A considerable number of valuable contributions regarding
62	COVID-19 have been published by the seven journals. The detailed information about these
63	journals can be found in Table 1.



66	A question raises 'what are the current status and emerging trends about the relevant
67	studies?' To address this issue, bibliometric analysis should be performed <sup>[4]</sup> . Although some
68	general bibliometric research upon COVID-19 has been accomplished <sup>[5-9]</sup> , by far, no specific
69	bibliometric study on the COVID-19-related publications in 'Tropical Medicine'-entitled
70	journals, which impedes the understanding of the current status and emerging trends.
71	In this work, a comprehensive bibliometric study was carried out. Using Clarivate
72	Analytics and VOSviewer as tools, document overview, basic bibliometric characteristics,
73	citation performance, co-authorship, co-citation, bibliographic coupling, and co-occurrence of
74	keywords and terms were analyzed thoroughly. The current status and emerging trends were
75	further summarized based on the results. We hoped this piece of work could help to master the
76	status quo of COVID-19-related studies in important 'Tropical Medicine'-entitled journals
77	and trigger the upcoming contributions.

## 78 2 Methods

79 The bibliometric methodology of this work is summarized in **Scheme 1**.

## 82 2.1 Document survey

83 The COVID-19-related publications in seven 'Tropical Medicine'-entitled journals, viz. 84 Journal of Tropical Medicine, Southeast Asian Journal of Tropical Medicine and Public 85 Health, Tropical Medicine & International Health, Tropical Medicine and Infectious Disease, 86 Transactions of the Royal Society of Tropical Medicine and Hygiene, Asian Pacific Journal of 87 Tropical Medicine, and American Journal of Tropical Medicine and Hygiene were retrieved 88 from Web of Science Core Collection database, accessed through Jinan University. Document survey was performed at 2 pm, on June  $30^{th}$ , 2022 (time zone: UST + 8). The 89 full query set was as follows. Definitions of codes: SO-journal title, TS-topic. 'OR' and 'AND' 90 91 were Boolean operators. 92 #1: (SO = Journal of Tropical Medicine) OR (SO = Southeast Asian Journal of Tropical 93 Medicine and Public Health) OR (SO = Tropical Medicine & International Health) OR (SO = 94 Tropical Medicine and Infectious Disease) OR (SO = Transactions of the Royal Society of

- 95 Tropical Medicine and Hygiene) OR (SO = Asian Pacific Journal of Tropical Medicine) OR
- 96 (SO = American Journal of Tropical Medicine and Hygiene).
- 97 #2: (TS = COVID) OR (TS = COVID 19) OR (TS = COVID-19) OR (TS = COVID
- 98 2019) OR (TS = Coronavirus Disease 2019) OR (TS = COVID-2019) OR (TS = SARS CoV

102 Further, considering the outbreak time of COVID-19, the publication time was refrained

- to 2019~2022, by 2 pm, June 30<sup>th</sup>, 2022 (time zone: UST + 8). The retrieved documents were
- 104 exported as plain text and tab-delimitated files for subsequent analyses.

## 105 2.2 Bibliometric analysis

- 106 The documents were analyzed by the analytical module of Clarivate Analytics
- 107 (associated with Web of Science) <sup>[10]</sup>, and VOSviewer (version 1.6.17, Leiden University,
- 108 Leiden, Netherlands)<sup>[11]</sup>, to showcase the knowledge domain and emerging trends.

109 Clarivate Analytics: Information about language, open access modes, publication years,

- 110 journal titles, research areas, publication types, geographic distribution, organizations, authors,
- 111 and funding agencies was analyzed. Moreover, citation performance was demonstrated by
- total citing articles, citing articles without self-citations, average citing articles per item, total
- 113 times cited, times cited without self-citations, average times cited per item, and Hirsch index
- 114 (*H*-index). The top-20 cited publications were extracted.
- 115 VOSviewer: Networks about co-authorship (regions, organizations and authors),

116	co-citation, bibliographic coupling and co-occurrence (author keywords + keywords plus and							
117	title/abstract terms) were created. The full counting method was utilized to fabricate the							
118	clustered or time-overlay networks. Threshold values for network preparation: co-authorship,							
119	regions-15; co-authorship, organizations-10; co-authorship, authors-5; co-citation-20;							
120	bibliographic coupling-30; co-occurrence, author keywords + keywords plus-5; co-occurrence,							
121	title/abstract terms-50.							

122 **3 Results** 


## 123 **3.1 Document overview**

A literature survey returned 783 documents in total. All (783, 100%) of these documents were written in English, which favored global communications<sup>[12]</sup>. A large proportion (596, 76.12%) of them were published in open access (OA) mode, which demonstrated a relatively high level in a research field compared to previous studies<sup>[13-15]</sup>. The OA mode made it free to download and read the published COVID-19-related works, increasing the accessibility and visibility<sup>[16]</sup>, which might be especially beneficial to developing regions.

## 130 **3.2 Basic bibliometric characteristics**

The distribution of publication years of the 783 documents is depicted in **Figure 1(a)**. There were 223 (28.48%), 463 (59.13%) and 97 (12.39%) documents published in 2020, 2021 and 2022, respectively. 'Tropical Medicine'-entitled journals showed their concerns about COVID-19 in an early stage of the epidemic (the year 2020), and the first five papers were published in March 2020<sup>[17-21]</sup>. The year 2021 witnessed a 107.62% increase in publication

#### 136 numbers to 2020, suggesting the raising concerns.




138 Figure 1 Distribution of publication years (a), journals (b) and publication types (c) of the retrieved documents. 139 Figure 1(b) shows the distribution of journals. All seven journals of interest had 140 published relevant works, but the publication number varied. American Journal of Tropical 141 Medicine and Hygiene published most papers (514, 65.65%), followed by Asian Pacific 142 Journal of Tropical Medicine (75, 9.58%), Transactions of the Royal Society of Tropical 143 Medicine and Hygiene (67, 8.56%) and Tropical Medicine and Infectious Disease (67, 8.56%). 144 The other journals published less than 50 related works: Tropical Medicine & International 145 Health (47, 6.00%), Southeast Asian Journal of Tropical Medicine and Public Health (12, 146 1.53%) and Journal of Tropical Medicine (1, 0.13%). It should be noted that the varied 147 numbers only partly reflexed the emphases laid on COVID-19 research, but were not 148 indicators of the journal's scientific standard.


The distribution of publication types is summarized in **Figure 1(c)**. Articles (456, 58.24%) were the major publication type. Interestingly, meeting abstracts accounted for a considerable proportion of 20.69%. It was inferred that some important conferences were held to review the *status quo* of the epidemic and the state-of-the-art of therapeutic strategies, and the accepted abstracts of these meetings might provide meaningful cutting-edge information. The percentage of reviews was relatively low (5.62%), which was lower than editorial materials (10.35%) and close to letters (4.73%). It was anticipated that more reviews could be

written to summarize the current status of this field, which would help to figure out the future
directions<sup>[22]</sup>.

Figure 2(a) depicts the top geographical distribution of the retrieved documents. Twelve regions contributed at least 30 publications. The USA was the main contributor, with 281 publications, followed by England with 117 publications. The other regions (India, Nigeria, Brazil, Thailand, Netherlands, China, Pakistan, Bangladesh, Ethiopia and Switzerland) contributed less than 100 publications. It was shown that both topical and non-tropical, developed, and developing regions participated in the contribution. Hence, it was a global trend to publish COVID-19-related works in 'Tropical Medicine'-entitled journals.

documents. Of note, 'Ministry of Health' in (b) included Ministry of Health of Guinea (1), Bhutan (1), Vietnam (1),

169	Malawi (1), Nicaragua (1), Somalia (1), Rwanda (1) and Israel (1).


170	According to Figure 2(b), 11 organizations contributed $\geq$ 20 publications; 'Ministry of
171	Health' ranking the 9 <sup>th</sup> was not an individual organization, but a combination of the ministries
172	in different regions (Guinea, Bhutan, Vietnam, Brazil, Kenya, Brunei, Saudi Arabia, Uganda,
173	Italy, Sri Lanka, Dem Rep Congo, Malawi, Nicaragua, Somalia, Rwanda and Israel, most of
174	them were tropical regions). As institutes in tropical regions, Mahidol University (Thailand),
175	Mahidol-Oxford Tropical Medicine Research Unit (Thailand), and University of Ibadan
176	(Nigeria) appeared on the list of top contributors. University of London (England) and
177	London School of Hygiene & Tropical Medicine (England) acted as the top organizations, and
178	the University of Oxford (England), University of Amsterdam (Netherlands), etc. also
179	contributed a large number of publications, revealing that institutions in non-tropical regions
180	were concerned about the crosstalk of COVID-19 and tropical diseases as well. World Health
181	Organization to improve the health level of all humankind ranked as top $5^{[23]}$ , which
182	elaborated its concerns about the impact of COVID-19 in tropical regions. Additionally, the
183	geographical distribution of the top organizations was basically in parallel with Figure 2(a).
184	The most fruitful authors (31 with over 5 publications) in this field are listed in Figure
185	2(c). Schultz MJ (primary affiliation: Mahidol University, Thailand), Lucero-prisno DE
186	(primary affiliation: London School of Hygiene & Tropical Medicine, England), and Papali A
187	(Atrium Health, USA) with 19, 12 and 10 papers were the top-3 authors, who were all from
188	the top contributing regions in Figure $2(a)$ . The other authors published 6~8 papers. For
189	newly emerging investigators, it would be advisable to seek collaboration with these fruitful

authors.

191	The basic bibliometric characteristics of 783 documents were described above. A peak
192	number of publications occurred in the year 2021, the documents were distributed unevenly in
193	the seven journals and 'article' was the major publication type. The top contributing regions,
194	organizations and authors were summarized, and the results showed that global discussion
195	was included in the seven journals. Some peripheral data can be found in Supplementary
196	Material Tab. S1 and S2.

#### 197 **3.3 Citation performance**

198 The citation performance of the 783 documents was scrutinized, and the results are 199 displayed in Figure 3. The numbers of total citing articles, citing articles without 200 self-citations, total times cited and times cited without self-citations were 5372, 5195, 6015 201 and 5747, respectively. It was then calculated that the self-citation only occupied a proportion of approximately 4%, which was a quite low rate compared to published literature <sup>[24-26]</sup>. It 202 203 was considered that with a lower self-citation rate, the citation performance would be more 204 significant and convincing<sup>[27]</sup>. The average number of citing articles and times cited per item 205 were 6.86 and 7.68, respectively. Furthermore, the H-index was 34, meaning that 34 206 publications were cited at least 34 times. Compared with some bibliometric studies of COVID-19<sup>[28-30]</sup>, this *H*-index was moderate. Therefore, the citation performance could be 207 208 further improved, and more attention from the science community was needed. It was 209 anticipated that the COVID-19-related research published in 'Tropical Medicine'-entitled 210 journals could provide more insights into the COVID-19 management during the 211 post-COVID-19 era, by serving as valuable references.

214 The top-20 most cited papers were extracted, listed in **Table 2**. Documents published in 215 Tropical Medicine & International Health, American Journal of Tropical Medicine and 216 Hygiene, Asian Pacific Journal of Tropical Medicine, Transactions of the Royal Society of 217 Tropical Medicine and Hygiene, and Tropical Medicine and Infectious Disease (5 out of 7 218 journals) were involved in the list. Correspondingly, 1, 14, 2, 1, 1 and 1 papers were 219 published in the above journals. The journal American Journal of Tropical Medicine and 220 Hygiene with most entrances was also the top 1 publishing journal in Figure 1(b). It was 221 perceived that this journal might be one of the flagship journals in its area. No entrance in 222 Table 2 was published in Southeast Asian Journal of Tropical Medicine and Public Health 223 and Journal of Tropical Medicine, probably owing to the small number of relevant 224 publications in these journals. All entrances were published in 2020 and could be regarded as 225 pioneer research. The distribution types were to some degree interesting: 3 were editorial 226 materials, 3 were reviews and 14 were articles. The ratio was similar to that of Figure 1(c). 227 Editorial materials accounted for a certain proportion, and even the top 1 paper was an editorial material<sup>[18]</sup>. The appearance of editorial materials in the most cited papers was a rare 228 case in bibliometric analyses<sup>[31-33]</sup>. It should be explained by that the editorial members of the 229 230 related journals were highly concerned about the COVID-19 epidemic, and they offered

- useful insights that deserved widespread attention (especially regarding the evolving status of
- 232 the epidemic<sup>[18, 34]</sup>, and the administration of potential SARS-CoV-2 inhibitors)<sup>[35]</sup>. In addition,</sup>
- the total citations per paper varied between 52 and 930, 7~132-fold higher than the average
- times cited obtained in **Figure 3** (~7).

The citation performance analysis elucidated that the documents of interest were frequently cited, while more reuse of them should be expected. To master the topics discussed in this field, the most cited papers shown in **Table 2** were recommended to be referred to.

### 240 3.4 Co-authorship

The co-authorship of the 783 documents was assessed on the level of regions, organizations, and authors, from 'macroscopic' to 'microscopic'. The VOSviewer software widely used in knowledge domain visualization was employed henceforth<sup>[36-38]</sup>. In the visualized networks, the diameter of an item represented the strength (publication number) and the boldness of a connecting line was proportional to the link strength (frequency of co-authorship of co-occurrence). Item colors indicated different categories and mean publication times for cluster networking and time-overlay networking, respectively<sup>[39]</sup>.







Figure 4 Co-authorship, regions time-overlay visualization.

248 The visualization of co-authorship, regions is provided in **Figure 4**. With the threshold of 249 15, 29 regions were displayed on the network. The dense network suggested that the 250 cooperation between regions was quite active. USA, England, India, Switzerland and Italy are 251 located at the center of the network, acting as the collaborative pivots, with 28, 27, 25, 18 and 252 16 links built, respectively. Among them, the USA, England, and India were the top 3 253 contributing regions in Figure 2(a), possessing a total link strength of 304, 251 and 103, 254 respectively. The most intense co-authorship tiles included USA-England (link strength = 44), 255 USA-Nigeria (link strength = 29), England-Netherlands (link strength = 21) and 256 England-Switzerland (link strength = 20). It was indicated that the collaboration between 257 developed regions was prevailing and that between tropical and non-tropical regions also

## 258 played an important part.

Figure 4 also presents the information about mean publication time, as a time-overlay visualization. China, Italy, South Africa, *etc.*, marked in purple, launched cooperative research in an early stage (mean publication time ~2020.7). Marked in green, regions like the USA, England, Nigeria, and Thailand also joined the conversation in an early phase (mean publication time ~2020.8). The regions like India, Bangladesh, and Pakistan were colored in red (mean publication time ~2021.0), exhibiting a recent active role in international cooperation.

The visualization of the full data set of co-authorship, organizations are displayed in the upper panel of **Figure 5**. With the threshold of 10, 20 organizations were involved. However, this panel could not introduce much valuable information due to the condensed layout, expect that Hamad Medical Corporation (Qatar) did not cooperate with other organizations. To achieve a better interpretation, the condensed items in the pink box were magnified as the lower panel.

University of Pittsburgh (USA), John Hopkins University (USA), and the University of 278 California at San Francisco (USA) were cooperative pivots, establishing 13, 12 and 12 links, 279 respectively. As for the total link strength, Mahidol University (Thailand, 48), University of 280 Oxford (England, 45) and University of Amsterdam (the Netherlands, 41) stood out. 281 University of Oxford-Mahidol University (England-Thailand, 17), Mahidol 282 University-University of Amsterdam (Thailand-Netherlands, 15), and University of 283 Oxford-University of Amsterdam (England-Netherlands, 15) were the most intense 284 cooperative tiles, indicating that collaboration was widely established between non-tropical 285 and topical/non-tropical organizations. However, the collaborative relationship between 286 topical organizations was not evidently exhibited herein.

Johns Hopkins Bloomberg School of Public Health (USA), Stellenbosch University (South Africa), University of Pittsburgh, University College of London (England, UCL), and Universidad Peruana Cayetano Heredia (Peru) participated in the cooperation in a relatively

early period (mean publication time ~2020.6). Organizations like the University of Oxford
(England), John Hopkins University (USA), and Atrium Health (USA) were more recent
collaborators, with a mean publication time of about 2020.9.






Figure 6 Co-authorship, authors time-overlay visualization.

293 Subsequently, the co-authorship profile of authors is illustrated in Figure 6. With a 294 threshold of 5, 62 authors were included in the visualization. Overall, the pattern of this 295 profile was very different from Figure 4 and Figure 5. There were a number of individual 296 author groups. To be specific, 16 author groups did not share co-authorship. The seven author 297 groups of John Woodford et al. (primary affiliation: National Institute of Allergy and 298 Infectious Diseases, USA), Alimuddin Zumla et al. (primary affiliation: University College of 299 London, England), Wafaie W. Fawzi et al. (primary affiliation: Harvard University, USA), 300 Anthony D. Harries et al. (primary affiliation: International Union Against Tuberculosis and 301 Lung Disease, France), Marcus J. Schultz et al. (primary affiliation: Mahidol University, 302 Thailand), Don Eliseo (III) Lucero-prisno et al. (primary affiliation: London School of 303 Hygiene & Tropical Medicine, England), and Amber Castillo *et al.* (primary affiliation: The 304 University of New Mexico, USA) were representative large groups.

Seen from the ~2020.6 mean publication time, the three author groups of Mouhand F.H. Mohamed (primary affiliation: Hamad Medical Corporation, Qatar), Alimuddin Zumla *et al.* (primary affiliation: University College of London, England), and Dimie Ogoina (primary affiliation: Niger Delta University Teaching Hospital, Nigeria) involved in this field in an early stage. More than half of (9/16) author groups in Figure 5 possessed the mean publication time of ~2021.0, demonstrating that a large proportion of fruitful authors were still active in academic cooperation.

By far, the co-authorship profile of the retrieved documents was analyzed. From regions, organizations to authors, or macroscopic to microscopic, the cooperation network seemed to become looser. It was conjectured that less fruitful organizations or authors that were not involved in **Figure 5** and **Figure 6** had built cooperation relationships, adding to the dense macroscopic (geographical) network. These results also inspired us not to neglect yet to value the contributions from non-top organizations or authors<sup>[40]</sup>.

## 320 3.5 Co-citation and bibliographic coupling

321	To describe the state-of-the-art knowledge domain, co-citation and bibliographic
322	coupling analyses were conducted. The definition of co-citation and bibliographic coupling
323	was as follows. Co-citation: Two references not limited to the current set were mutually cited
324	by a publication in the current set; Bibliographic coupling: Two publications in the current
325	sets mutually cited a reference not limited to the current set <sup>[41]</sup> . According to the above
326	definition, the items in co-citation might be older documents published before the COVID-19
327	epidemic or irrelevant documents published after the epidemic onset, while those in
328	bibliographic coupling belonged to the 783 documents.




Figure 7 Co-citation cluster network visualization (a) and bibliographic coupling network visualization: partial set

329	Figure 7(a) illustrates the co-citation cluster network. The threshold 20 resulted in 11
330	qualified items. As these papers were frequently referenced by the retrieved documents, it was
331	regarded that they constructed the knowledge base for this field <sup>[42]</sup> . Three clusters colored red,
332	green and blue were shown, representing different elements of the knowledge base.

336 (1) Red cluster, 5 items: Literature (Zhu N, 2020)<sup>[43]</sup>, (Dhama K, 2020)<sup>[44]</sup>, (Wu ZY,

2020)<sup>[45]</sup>, (Zhao JJ, 2020)<sup>[46]</sup>, and (Lee K, 2009). The last item was irrelevant to the
COVID-19 pandemic and thus was omitted for analysis. This cluster was mainly about the
early knowledge about the characteristics of COVID-19 and the evolving tendency.

340 (2) Green cluster, 4 items: Literature (Zhou F, 2020)<sup>[47]</sup>, (Huang CL, 2020)<sup>[48]</sup>, (Chen NS,

341 2020)<sup>[49]</sup>, and (Wang DW, 2020)<sup>[50]</sup>. Papers in this cluster mainly dealt with the clinical and

342 epidemiological investigations of COVID-19 in China.

333

343 (3) Blue cluster, 2 items: Literature (Horby P, 2020)<sup>[51]</sup>, and (Guan Wei-jie, 2020)<sup>[52]</sup>. The
344 former item was a clinical study on the drug dexamethasone administrated to hospitalized
345 COVID-19 patients, while the latter item discussed clinical characteristics of COVID-19 in

## 346 China, both published in *New England Journal of Medicine*.

347	The bibliographic coupling network visualization of a full set of items (42) is shown in
348	Figure S1. As the seven documents on the right part did not couple with the others, they
349	added no significance to the analysis. Under this circumstance, the condensed cluster on the
350	left part (35 items) was magnified as Figure 7(b), to mine meaningful information. The
351	coupled items, especially in the same cluster, share a high similarity of references, implying
352	that they had similar research intention, protocol or outcome <sup>[53]</sup> . The typical papers in each
353	cluster might be viewed as the classic research paradigm <sup>[54]</sup> . Seven clusters colored in red,
354	green, blue, yellow, purple, cyan and orange were obtained in Figure 7(b).
355	(1) Red cluster, 7 items. Representative literature (Velavan, 2020) <sup>[18]</sup> , and (Huynh Giao,
356	2020) <sup>[55]</sup> : General knowledge toward COVID-19.
357	(2) Green cluster, 6 items. Representative literature (Chakraborty, 2020) <sup>[56]</sup> , and (Morens,
358	2020) <sup>[57]</sup> : The origin of COVID-19 from a zoonotic perspective.
359	(3) Blue cluster, 6 items. Representative literature (Nachega, 2020) <sup>[58]</sup> , and (Abena,
360	2020) <sup>[59]</sup> : Treatment of COVID-19 and its outcome, especially in Africa.
361	(4) Yellow cluster, 6 items. Representative literature (Islam, 2020) <sup>[60]</sup> , and (Alvarez-risco,
362	2020) <sup>[61]</sup> : The strategies to combat COVID-19 infodemic.
363	(5) Purple cluster, 5 items. Representative literature (Quincho-lopez, 2020) <sup>[62]</sup> , and (Jiang,
364	2020) <sup>[63]</sup> : The complications of COVID-19.
365	(6) Cyan cluster, 3 items. Representative literature (Faico-Filho, 2020) <sup>[64]</sup> , and (Kwon,
366	2020) <sup>[65]</sup> : The impact of viral load on the severity of COVID-19.

367 (7) Orange cluster, 2 items. Representative literature (Oyelade, 2020)<sup>[66]</sup>, and (Rocha,


368	2021) <sup>[67]</sup> : The health threat of COVID-19 combined with other diseases. It was noteworthy
369	that the latter item possessed the newest publication time, representing the burgeoning topics.
370	Accordingly, the papers reporting the clinical and epidemiological features of COVID-19
371	(particularly in China) constructed the knowledge base of this aspect. The current research
372	foci included general knowledge, origin, treatment, infodemic, complication and severity
373	determinant of COVID-19, and the consequence of COVID-19 combined with other diseases
374	was also a vital topic. General knowledge of COVID-19 was the overlap of co-citation and
375	bibliographic coupling behavior.

## 376 **3.6 Co-occurrence of keywords and terms**

Last but not least, the co-occurrence of keywords and terms was visualized to figure out
the hotspots in COVID-19-related studies published in 'Tropical Medicine'-entitled journals.
In this study, all keywords (keywords defined by authors and added by Web of Science) and
terms in the title and abstract were analyzed.
The network visualization of 55 keywords' co-occurrence is shown in Figure 8. Figure
8(a) depicts the cluster network, where six clusters were obtained. Except for the search
themes (COVID-19, SARS-Cov-2, *etc.*), the typical keywords of each cluster were as follows.

387 (1) Red cluster, 13 items: About the epidemiology and public health aspect, characterized
388 by 'epidemiology', 'public health' and 'surveillance', *etc*.

389 (2) Green cluster, 13 items: About the aftermath of insufficient vaccination level,

390 characterized by 'vaccines', 'vaccination' and 'risk', etc.

391 (3) Blue cluster, 9 items: About the clinical feature, characterized by 'clinical
392 characteristics', 'pneumonia' and 'patient', *etc*.

393 (4) Yellow cluster, 8 items. About the risk in combination with acute infectious diseases,

394 characterized by 'mortality', 'Ebola' and 'Dengue', etc.

395 (5) Purple cluster, 6 items. About the risk in combination with chronic infectious
396 diseases, characterized by 'pandemic', 'Human immunodeficiency virus (HIV)' and
397 'tuberculosis', *etc.*


398 (6) Cyan cluster, 6 items. About the comparison with the SARS epidemic, characterized

399 by 'SARS', 'transmission' and 'outbreak', *etc*.

Taking mean publication time into consideration (~2020.6), 'Wuhan' and 'pneumonia' were 'old' keywords. This was because in the early stage of the epidemic, the disease had not been officially named, and it was initially considered a type of pneumonia that originated

403 from Wuhan, China (so-called 'Wuhan Pneumonia'). However, after the knowledge

404	accumulated about the disease, the inappropriate code with suspicion of stigmatization was
405	prohibited <sup>[68]</sup> . In addition, the epidemic rapidly spread outside the Wuhan region. As a result,
406	the heat of 'Wuhan' and 'pneumonia' dropped in a later period. With the mean publication
407	time ~2021.2, the keywords like 'clinical characteristics', 'diagnosis', 'vaccines',
408	'vaccination', 'hesitancy', 'HIV', and 'neglected tropical diseases' were the recent hot
409	keywords. The diagnosis and clinical characteristics of COVID-19 were still emphasized, and
410	the vaccination hesitancy and the combination with other diseases were newly burgeoning
411	issues.
412	Terms co-occurrence are considered non-keyword terms in publications and might be
413	critical addenda to the keywords co-occurrence analysis <sup>[69]</sup> . The results (54 terms) are
414	visualized in Figure 9, where predominant terms were identical to or derived from keywords
415	in Figure 8. For example, 'COVID', 'SARS CoV', 'pandemic', 'infection', 'patient', 'Africa',
416	'mortality', 'outcome', 'diagnosis', 'transmission', 'pneumonia', and so forth. Some
417	protocol-related new terms emerged, like 'participant', 'treatment', 'day' and 'year', which
418	probably stemmed from clinical reports. It was worth mentioning that 'vaccine' and
419	'vaccination' were also hot terms in Figure 9 (b), mirroring the heated discussion about
420	COVID-19 vaccines.

423	The co-occurrence analysis basically revealed the current and emerging hotspots in this
424	field. Nevertheless, to ensure the readability and resolution of the figure, a certain threshold
425	was set for visualization. It should be admitted that some extremely new trends introduced by
426	a small number of papers would have been ignored. The authors will attempt to analyze these
427	new tendencies in their future work, with the help of other tools like Python <sup>[70]</sup> .

## 428 4 Discussion

Having scrutinized the document overview, basic bibliometric characteristics, citation
performance, co-authorship, co-citation, bibliographic coupling, and co-occurrence of keywords
and terms, the current status and emerging trends of this field were unveiled.

#### 432 4.1 Current status

433 (1) Bibliometric perspective: The topic had turned into a global concern, and 434 investigators outside topical regions made great contributions. Article, meeting abstract and 435 editorial material were the predominant publication type, while review only accounted for a 436 small part. More reviews should be contributed to claim the progress on COVID-19 437 knowledge. Some 'Tropical Medicine'-entitled journals publish a small number of relevant 438 papers, and they were suggested to attract more related submissions. Besides, the citation 439 performance could be improved, and attention from other research areas was demanded. 440 (2) Research topics: The clinical features of COVID-19 patients were the mainstream

441 topic. The origin, treatment, infodemic, complication and severity determinants of COVID-19

<sup>442</sup> also provoked intensive discussions.

#### 443 4.2 Emerging trends

444	(1) Bibliometric perspective: Revealed by the co-authorship profile, regions like India,
445	Bangladesh and Pakistan, organizations like the University of Oxford, John Hopkins
446	University and Atrium Health and authors like Wafaie W. Fawzi, John Woodford, and Don
447	Eliseo (III) Lucero-prisno were the recently active contributors. To seek collaboration with
448	them was a beneficial choice for emerging investigators in this field.
449	(2) Research topics: The hesitancy in making vaccines against SARS-CoV-2 and the
450	circumstance where COVID-19 coexisted with other tropical diseases were two recent
451	research hotspots. From the authors' point of view, more efforts should be made to investigate
452	these two issues, to achieve better epidemic management in tropical regions.

## 453 **5** Conclusion

454 In this work, the current status and emerging trends of COVID-19-related studies in 455 seven 'Tropical Medicine'-entitled journals were analyzed from a bibliometric perspective. 456 First, the result of the document overview demonstrates a relatively high level of OA 457 publication. The basic bibliometric characteristics were then evaluated. The results show that 458 to publish COVID-19-related works in 'Tropical Medicine'-entitled journals was a global 459 trend and studies on this topic have provoked international concern and discussion. The 460 citation performance analysis revealed that more reuse of publications should be expected. 461 The collaboration between developed regions was prevailing, and that between tropical and 462 non-tropical regions also played an important part. The results of co-citation and 463 bibliographic coupling analyses showed that studies on the general knowledge, origin,

464	treatment, infodemic, complication, and severity determinant of COVID-19 served as the
465	current research foci for this field and that the consequence of COVID-19 combined with
466	other diseases was also a vital topic. Hotspot mining was achieved through the analysis of
467	keyword co-occurrence and terms. It was revealed that the keywords like 'clinical
468	characteristics', 'diagnosis', 'vaccines', 'vaccination', 'hesitancy', 'HIV', and 'neglected
469	tropical diseases' were the current hot words, and the vaccination hesitancy and the
470	combination with other diseases were newly burgeoning issues. Overall, this work described a
471	whole bibliometric picture of COVID-19-related studies in seven 'Tropical Medicine'-entitled
472	journals.
