1 Title: Time series analysis of routine immunisation coverage during the COVID-19 pandemic in 2021

2 shows continued global decline and increases in Zero Dose children

- 5 Abstract
- 6 Whilst it is now widely recognised that routine immunisation (RI) was disrupted by the COVID-19
- 7 pandemic in 2020 compared to previous immunisation performance, the extent of continued
- 8 interruptions in 2021 and/or rebounds to previous trends remains unclear, with sporadic surveys
- 9 reporting signs of immunisation system recovery at the end of 2020.
- 10 We modelled country-specific RI trends using validated estimates of national coverage from the World
- 11 Health Organisation and United Nation Children's Fund for over 160 countries, to project expected
- 12 diphtheria, tetanus, and pertussis-containing vaccine first-dose (DTP1), third-dose (DTP3) and measles-
- 13 containing vaccine first-dose (MCV1) coverage for 2021 based on pre-pandemic trends (from 2000-

14 2019).

15 We estimated a 3.6% (95%CI: [2.6%; 4.6%]) decline in global DTP3 coverage in 2021 compared to 2000-16 2019 trends, from an expected 90 1% to a reported 86 5% across 164 reporting countries, and similar 17 results for DTP1 (2.8% decline; 95%CI: [2.0%; 3.6%]), and for MCV1 (3.8% decline; 95%CI: [4.8%; 2.7%]). 18 86.5% global coverage in 2021 represents a further decrease from that reported in 2020 and 2019, and 19 translates to a 16-year setback in RI coverage, i.e., 2005 levels. Hypothesised and early signals of 20 rebounds to pre-pandemic coverage were not seen in most countries. The Americas, Africa, and Asia 21 were the most impacted regions, with low- and middle-income countries the most affected income 22 groups.

23	The number of Zero Dose children also continued to increase in 2021. DTP1 coverage declined
24	worldwide from an expected 93·7% to a reported 90·9% (2·8% decline; 95%CI: [2·0%; 3·6%]) which
25	translates into an additional 3.4 million Zero Dose children on top of an expected 11.0 million (30.9%
26	increase) at the global level.
27	We hope this work will provide an objective baseline to inform future interventions and prioritisation
28	aiming to facilitate rebounds in coverage to previous levels and catch-up of growing populations of
29	under- and un-immunised children.

31 Introduction

32 It is now widely recognised that routine immunisation (RI) was disrupted globally during the start of the 33 COVID-19 pandemic and throughout 2020 [1–4]. Single-country studies, and literature reviews have 34 reported delays and interruptions in service delivery, decreases in attendance, and/or full suspension of 35 services during the pandemic, e.g., during periods of quarantine or implementation other non-36 pharmaceutical interventions. Observational and modelling studies have evaluated the impact of 37 disruptions at the country-, regional-, and global-level in terms of coverage reduction, with estimates 38 ranging from 2% [5] to over 7% globally in 2020 [6]. We previously published an estimated 2.9% decline 39 for diphtheria, tetanus, and pertussis-containing vaccine third-dose (DTP3; 95% CI: 2.2%; 3.6%) and 40 similar declines for other key vaccine indicators [7]. Prior research has established associations between 41 lower vaccination coverage and outbreaks of vaccine preventable diseases (e.g., Measles outbreaks in 42 Zambia [8] and the United States of America [9]), highlighting the potential health implications of the 43 knock-on effects of the pandemic.

Whilst the evidence of RI disruptions in 2020 is now well documented, it remains unclear whether such
disruptions continued in 2021. Few papers have been published on 2021 coverage, with some

46 exceptions largely focussing on single countries (e.g., Brazil - [10]), and the grey literature hinting at a 47 potential decline in global coverage between 2020 and 2021 [11,12].

48 Here, we build on previously published methods to test and quantify the extent of RI disruption in 2021 49 compared to pre-pandemic trends. Reaching Zero Dose children (those that receive no vaccinations) is 50 crucial to reduce the most acute vaccine-preventable morbidity and mortality in infants. Therefore, we 51 translate modelled coverage disruptions into quantification of under- and un-immunised (i.e., Zero 52 Dose) children. We also investigate year-on-year trends within countries to identify rebounds and 53 continued declines, with the aim to facilitate future investigations of the key factors underpinning these 54 dynamics and focus efforts and resources to aid recovery.

56 Materials and methods

57 Data collection

58 Building on our previously published methodology to identify deviations from temporal trends in RI [7], 59 we investigated changes in RI coverage using three key indicators: diphtheria, tetanus, and pertussis-60 containing vaccine first-dose (DTP1) and third-dose (DTP3) coverage, and measles-containing vaccine 61 first-dose (MCV1). To recap – DTP1 is typically administered at around six-weeks of age and is used as a 62 proxy for inequity to quantify Zero Dose children [13]; DTP3 is delivered to children of approximately 63 fourteen-weeks old and serves as a general marker for immunisation system performance, used by 64 national and global immunisation stakeholders; and MCV1 is recommended to be delivered at nine-65 months of age and is often used as an additional indicator of health system performance. 66 We used coverage data published by the World Health Organisation and United Nation Children's Fund 67

(UNICEF) Estimates of National Immunisation Coverage (WUENIC [14,15]) from 2000-2021 inclusive,

68	using the latest (July 2022) WUENIC data release [16]. It is noted that included within the latest WUENIC
69	release are retrospective revisions to previous-year (<i>i.e.</i> , pre-2021) coverage estimates for the
70	Democratic Republic of the Congo, Samoa, Tunisia, Guatemala, Philippines, and Cote d'Ivoire [16]. Such
71	revisions typically represent validation of population-level coverage surveys that replace previously
72	reported coverage levels for the current and some recent years. For this reason, we have updated
73	predictive modelling for expected coverage in 2020 using the latest WUENIC data rather than leveraging
74	previous results [7].
75	Population data was sourced from the United Nations World Population Prospects 2022 [17] release
76	(UNWPP 2022, including retrospective updates of 2021 populations). Income group classification was
77	taken from the World Bank's 2021 categorisation of countries [18].
78	Statistical analysis
79	We used Auto Regressive Integrated Moving Average (ARIMA) modelling [19] to capture temporal
80	trends in coverage for each country from 2000-2019 to forecast expected coverage in 2020 and 2021.
81	The inclusion of 2020 in the ARIMA model fitting to forecast coverage in 2021 was ruled out as many
82	countries showed sharp changes in point estimates of coverage that year. While this may result in wider
83	confidence intervals (CIs) for 2021 than 2020, results were essentially unchanged when also including
84	2020 in the model-fitting stage for countries which did not show sharp changes in 2020.
85	Prior to investigating global, regional, income group, and year-on-year differences between expected
86	and observed coverage, historic (pre-2020) and predicted time series were assessed, and countries were
87	removed from analyses for one of two reasons:
88	• Prior knowledge : Countries lacking recent WUENIC coverage updates: For 7 countries
89	(Cambodia, the Central African Republic, Haiti, Guinea, Lesotho, Somalia, and South Sudan),
90	WUENIC report an inability to update coverage estimates for successive years due to the

91	absence of additional information meeting their criteria, resulting in WUENIC coverage
92	estimates appearing as constant. In addition, countries with large geopolitical events known to
93	have affected immunisation were removed. This applied to Myanmar and the Democratic
94	People's Republic of Korea, where immunisation coverage reportedly fell over 60%between
95	2020 and 2021. Whilst some of these coverage declines may have been associated with the
96	pandemic, to be conservative we removed these countries for aggregate analyses.
97	• Poor model fit : Poor model fit was identified in countries where projected coverage in 2020 fell
98	outside either two standard deviations or six percentage points from WUENIC-reported 2019
99	coverage. Both of these scenarios were deemed to indicate programmatically unlikely changes
100	in coverage (either infeasible programmatic improvements or major disruptions). These
101	countries were removed to be conservative and not overly associate changes in coverage with
102	pandemic impact, where the explanation may be driven by poor model fitting (e.g., due to prior
103	year volatility, or skew from anomalous data points).
104	The list of countries, per vaccine dose, that were removed due to lack of reliability in assessing temporal
105	trends, are detailed in the Appendix (Section S4). We conducted a sensitivity analysis on aggregate,
106	regional and income group level analyses with no countries excluded – these are detailed in the
107	Appendix (Section S7).
108	Changes in coverage were measured as the difference between the reported and expected coverage for
109	a given year. Values are reported as percentages and these refer to percentage point changes. The
110	following analyses were completed for each vaccine dose:
111	• Comparing expected versus reported coverage for 2021 : We conducted <i>t</i> - <i>tests</i> of reported
112	vaccination coverage against the null hypothesis of the absence of change in trends from prior

114	of RI impact in 2021.	We then investigate regional and	income group-level heterogeneities,

- 115 using linear models with coverage changes as a response variable and ANOVA using the
- 116 corresponding categorisation of countries. Differences between individual countries were
- assessed by comparing the 95% CIs of the linear models' coefficients.
- Calculating additional missed immunisations: We calculated the additional number of missed
- immunisations by combining the estimated changes in coverage (including estimates of low- and
- 120 high-bounds using 95% Cls) with surviving infant population estimates reported in the UNWPP
- 121 2022 dataset. These results indicate the number of additional unvaccinated children per country
- 122 that would have been reached based on previous immunisation trends.
- Trends in coverage from 2020 to 2021: We investigated absolute changes in coverage between
- 124 2020 and 2021 per country to quantify the extent of recovery and continued coverage declines.
- 125 We tested whether trends in 2020 were associated with trends in 2021, by conducting Fisher's
- 126 Exact tests on the relevant contingency table.
- 127 All analyses were conducted using R, version 4.1.2 [20] and can be reproduced using a publicly available
- 128 *reportfactory* including required data (all publicly available) and scripts [21].

- 130 Results

131 <u>2021 coverage</u>

After removing countries further analyses were conducted on: 164 countries for DTP3, 168 countries for

- DTP1, and 160 countries for MCV1. Examples of coverage trends for the largest countries included are
- shown in **Figure 1** for each vaccine dose. Similar trends can be seen within countries across different
- vaccine doses (with DTP1 and DTP3 being more similar than MCV1 coverage trends), and large
- 136 differences between countries.

138 Figure 1 – Expected and reported 2020 and 2021 vaccine coverage for DTP1, DTP3, and MCV1: example of five countries with 139 largest populations in completed datasets. These graphs show WUENIC-reported coverage data (black dots) from 2000 to 2021 140 inclusive, and the corresponding ARIMA predictions and the associated 95% CIs (red bars) for 2020 and 2021. 141 The exact magnitude of coverage change remained hard to assess for two-thirds of countries due to 142 uncertainties in model predictions (Figure 2) – however global trends remained clearly apparent. In 143 2021, eight more countries showed statistical evidence (p < 0.05) of changes in coverage compared to 144 2020 (for DTP3: n = 39 in 2021 and n = 31 in 2020. In 2020 all 39 countries had coverage declines below 145 Cls and in 2021 30/31 countries had coverage declines below Cls, and 1 – Namibia - increased coverage 146 above expected CIs). Conducting a *t-test* on within-country differences in coverage between years 147 further confirmed that coverage declines were greater in 2021 than in 2020 (df = 160, t = -3.31, p = 148 0.0011).

Figure 2 – Comparison between 2021 WUENIC-reported DTP3 coverage and expectations derived from historical trends: This
 scatterplot shows country coverage (WUENIC-reported actuals and ARIMA-predicted expectations) as dots. Lines around
 individual points illustrate the 95% CIs of ARIMA predictions. Countries showing significant departure from expected values, i.e.,
 for which actual coverage is outside the 95% CI of predictions, are indicated in red; countries without such significant departure
 from expected results are shown in black.

Our analysis indicates an average global decline in DTP3 coverage of 3.6% (95%_{Cl}: [2.6%; 4.6%]), from an expected 90.1% to a reported 86.5% across 164 reporting countries. Global average coverage in 2021 for this set of countries was last reported in 2005, continuing to validate our previously reported results that the pandemic is associated with a 16-year setback in performance of immunisation programmes globally. Similar trends were observed for DTP1 (global decline of 2.8%; 95%_{Cl}: [2.0%; 3.6%] from an expected 93.7% to a reported 90.9%), and for MCV1 (global decline of 3.8%; 95%_{Cl}: [4.8%; 2.7%]) in

161 2021. Full results by country and vaccine dose can be seen in the Appendix (Sections S5, S6, and

- 162 Supplementary Tables). Sensitivity analyses also showed similar results (Appendix, Section S7).
- 163 Reported 2021 coverage represents a continued 0.8% decline from 2020 reported levels (DTP3: 87.3% in
- 164 2020 and 86.5% in 2021). Given the inclusion of historical updates to prior year coverage estimates for
- some countries, we re-evaluated our previously published analysis of 2020 coverage declines (we also
- 166 updated inclusion and exclusion criteria, for consistency). Our re-analysis aligned with our previously
- reported results DTP3 global decline of coverage of 2.7% (95%_{cl}: [1.9%; 3.5%]), from an expected
- 168 90.0% to a reported 87.3%. Reproduced results are in the Appendix (Section S8).

170 Figure 3 – Differences between expected and reported DTP3 vaccine coverage in 2021 across (A) UN regions and (B) income

171 groups. Points represent individual countries, grouped, and coloured according to (A) UN region classification and (B) World

Bank income groups. Country coordinates on the X-axis were jittered for visibility. Values on the y-axis are indicated as absolute

173 differences between reported and expected vaccine coverage, in percentages. Violin plots show the density of the data within

each group: wider lines indicate more datapoints. The black dashed horizontal lines indicate no change in coverage. LIC: Low-

- 175 income Country. LMIC: Lower-middle-income Country. UMIC: Upper-middle-income Country. HIC: High-income Country.
- 176 At a regional level, there was evidence that coverage declined compared to previous trends in Africa,
- 177 the Americas and Asia and that coverage in the Americas declined furthest (Americas: 6.7% decline,
- 178 95%_{CI}: [4·8%; 9·3%]). Similar trends were seen across all vaccines modelled.
- All income groups except for high-income countries exhibited statistical evidence of declines in coverage
 at the 95% confidence level in 2021 for DTP1, DTP3, and MCV1, with the great divergence in expected
 versus reported coverage consistently seen in lower-middle income countries (DTP3 LMICs; 5.5%, 95%_{Cl}:
 [3.6%; 7.3%]).

Heterogeneities due to one variable (regions or income groups) remained after accounting for the effect of the other one (regional after accounting for differences in income group: for DTP3, ANOVA – F = 5.22, df = 156, $p < 5.63 \times 10^{-4}$; income group after accounting for differences in regions: ANOVA – F = 5.75, df = 156, $p < 9.33 \times 10^{-4}$). Evidence of heterogeneities remaining after accounting for order effects were also seen for DTP1 (p = 0.018 for region after income, and $p = 2.68 \times 10^{-4}$ for income after region) and MCV1 (p = 0.003 for both ANOVAs).

189 Additional missed immunisations and Zero Dose children in 2021

190 Zero Dose children are estimated using DTP1 data. These results on 168 countries for DTP1 represent

191 93% of the global surviving infant population in 2021. Based on point estimates of the total infant

192 populations across these countries, there were 1.61 million (M) Zero Dose children in 2021, of which

193 504.9 k (31.4%) were associated with unexpected coverage declines in 2021. This point estimate is

higher than the estimated additional 1.51 M ZD children in 2020, of which 358.3 k (23.8%) were

associated with coverage declines in 2020 vs. prior trends.

Table 1 details the number of missed immunisations for the 10 countries with the absolute number of

additional missed immunisations compared to expectations for 2020 and 2021 combined. Of note, these

198 countries are all in Asia, Africa, or the Americas. This list of countries is very similar to the list of

199 countries with largest increases in missed immunisations in 2021 alone.

205 <u>Year-on-year trends in point estimates of coverage</u>

206 Absolute reported coverage indicates the proportion of children immunised in a given year per country, 207 and can be compared to previous coverage levels to understand if more or less children are being 208 reached each year. In terms of absolute reported coverage from 2019 to 2021, for DTP3, 40 countries 209 (24.4%) reported continued coverage declines for both consecutive years whereas just six countries 210 (3.7%) reported sustained coverage improvements year-on-year. The majority of countries either 211 exhibited coverage stagnation (39 countries, 23.8%) or a decline follow-up by stagnation (or stagnation 212 followed by a decline) - 24 countries (14.6%). The remaining 48 countries (29.3%) had coverage oscillate 213 (e.g., lower then higher, or higher then lower) over years. **Table 2** for a full breakdown for DTP3; similar 214 trends were seen for DTP1 and MCV1. 215 Table 2. At a country level the year-on-year reported changes in coverage can be seen in **Figure 4**, with Panel A providing colour-coding by region and panel B by income group. Only six countries are in the top right segment (consistent year-on-year coverage improvement for DTP3 during the first two years of the pandemic) and all other countries reported some declines and/or static coverage levels during the pandemic.

Figure 4 – Year-on-year DTP3 trends: Comparison between 2021 WUENIC-reported DTP3 coverage and expectations derived from historical trends. reported coverage was within Cls of modelled projections or not. All figures show percentage point differences.

232 <u>Year-on-year trends compared to forecasts</u>

- 233 Comparing reported coverage to forecasted levels provides an indication of whether, and to what
- extent, coverage deviated from country-specific previous trends during each year of the pandemic. For
- the majority of countries (118, 72.0%) reported coverage fell within 95% CI forecasts for both 2020 and
- 236 2021. No countries had higher coverage in 2021 than forecasted confidence intervals, however 24
- countries (14.6%) had lower coverage than expected in both years. A Fisher's Exact test confirmed that
- trends observed in 2020 and in 2021 were correlated (DTP3: $p < 2 \times 10^{-13}$), largely due to an access of
- countries exhibiting declines in 2020 which continued in 2021 (Table 3)

243 Discussion

244 <u>Global routine immunisation continues decline</u>

245 Our results suggest that the global decline in RI coverage observed in 2020 has continued in 2021. In 246 contrast with previous indications in the latter half of 2020 that services and coverage was returning to 247 pre-pandemic levels [22], we found virtually no indication of rebounds in RI coverage, and many 248 instances of countries where decline continued further in 2021 (n = 40, 24.4% of countries), where 249 declines occurred following stagnation in the first year of the pandemic (n = 11, 6.7% of countries), or 250 coverage continues to stagnate at 2019 levels (n = 39, 23.8% of countries). Immunisation performance 251 has not reverted to pre-pandemic levels during the continuation of the pandemic and has instead 252 declined further from the previously achieved improvement trajectory. Global WUENIC-reported

coverage across the 164 included countries for DTP3 declined continuously from 89.8% in 2019 to 87.3%

- in 2020 to 86.5% in 2021. This compares to an expected 90.1% coverage in 2021 (i.e., decline of 3.6%,
- 255 95%_{CI}: [2·6%; 4·6%]). See **Figure 5** for an overview of DTP1, DTP3, and MCV1 coverage actuals and
- expectations from 2000 to 2021.

261 Between 2019 and 2021, two-thirds of countries exhibited either continuous declines year-on-year, or

262 declines followed by stagnation (or vice versa) during the pandemic. These findings confirm qualitative

263 reports from the World Health Organisation (WHO) that immunisation services have been continuously

interrupted throughout the pandemic (56% of countries reported disruptions in Q3 2020, 42% in Q1

265 2021, and 53% in Q4 2021 [23]).

266 The trend in declines in RI coverage during the pandemic period is largest in the Americas, Africa, and

Asia; and for low- and middle-income countries (with region and income group both having independent

explanatory power). This trend is also consistent across vaccines, delivered at different schedules (DTP1

typically delivered at 6-weeks, DTP3 at 14-weeks, and MCV1 at 9-months old).

270 Our results cover over 90% of the surviving infant population in 2021 – over 119 M infants. However,

our results are limited to annual trends reported at a national level. Publicly available data on globally

272 recognised estimates of coverage at a monthly level would enable more granular time series modelling

273 on the impact of the pandemic on RI, ideally with shorter time lags between events and reporting.

274 Missed immunisations

275 The compounded impact of two years with RI coverage at lower levels (or coverage declines then 276 stagnation or vice versa) in many countries will place an increasing toll on RI vaccine requirements and 277 increase complexity of service delivery. In 2023, there will be an increasing number of unvaccinated one-278 and two-year-olds in many countries. Vaccine programmes typically plan vaccine supply requirements 279 and procurement based on surviving infant populations. This approach may need to evolve to actively 280 include quantification of missed immunisation in older populations to ensure sufficient vaccines for 281 catch-up through RI touchpoints. Furthermore, reaching children over one-years old is not "typical" (in 282 most countries) for RI, and infants of this age do not necessarily routinely engage with the health system 283 at appropriate times and places to be reached through ad-hoc catch-up. Resultingly, catch-up campaigns 284 - targeted at sub-populations where coverage has declined the most - may be required. More data and 285 research at the sub-national level is required in order to determine the most appropriate catch-up 286 routes and supplementary immunisation activities (SIAs). WUENIC data is published at national level, 287 therefore alternative coverage data sources, e.g., administration data (which has some known caveats – 288 see Appendix Section S1) or other sub-national level surveys would be required.

289 Zero Dose

290 Notably, the number of Zero Dose children also continued to grow: DTP1 coverage across the modelled 291 countries fell from a reported 91.6% to 90.9% between 2020 and 2021, compared to an expected 93.7% 292 coverage in 2021 (i.e., decline of 2.8%, $95\%_{CI}$: [2.0%; 3.6%]) - see **Figure 5** for visual depiction. This 293 translates to an additional 3.4 million Zero Dose children on top of an expected 11.0 million (30.9% 294 increase). These figures for both 2020 and 2021 are updated using the most recent UN WPP estimates, 295 based on the medium variant surviving infant population estimates. Population estimates, particularly in 296 fragile states where a national census may not have been conducted for years or decades, are known to 297 sometimes have wide confidence intervals (see UN WPP 2022 projections) - therefore the number of 298 Zero Dose children could be larger still.

299	The decline in DTP1 coverage was 77% of the size of the decline in DTP3 coverage (2.8% vs. 3.6%). This
300	suggests that of the additional 4.3 M infants not receiving DTP3 globally in 2021 associated with
301	pandemic declines, 3.3 M of these were additional Zero Dose children versus expectations, and 1 M
302	resulted from increased drop out between vaccine doses. On the one hand, this is particularly
303	concerning given the tight linkage between Zero Dose children and adverse health outcomes (e.g.,
304	disease outbreaks and vaccine preventable deaths). However, recognition that declines in coverage
305	appear to be primarily driven by increases in ZD, rather than greater dropout between vaccine doses,
306	provide insights on where to target limited resources for catch-up on health system strengthening. This
307	places heightened importance on the increasing focus on channeling resources to identify and reach
308	Zero Dose children.
309	Additionally, several individual countries with large birth cohorts reported coverage below the expected
240	
310	95% Cls, indicating strong evidence in large increases in Zero Dose children during the continued
311	pandemic. These countries include: India, Indonesia, Philippines and Mozambique (see Table 1 above) -

324 Factors for pandemic resilience

325 Whilst income group and regional factors (independently) explain some of the global declines in 326 coverage (adjusted $R^2 = 0.14$ for the linear model including income group and region), further 327 understanding of explanatory factors is required to guide recovery and build resilience globally for 328 future pandemics. Understanding the impact of Non-Pharmaceutical Interventions (NPIs) and COVID-19 329 rollout on health service access and delivery may be valuable starting points. Countries deployed a wide 330 variety of NPIs over time, which influenced mobility and societal behaviours [27], and influenced 331 immunisation services [28]. These interventions have been captured and codified in global datasets, 332 such as the COVID-19 Government Response Tracker [29]. Exploring the relationship between NPI 333 implementation and immunisation system performance over the last two years may indicate policy 334 areas with beneficial and deleterious effects on health systems. Additionally, approximately 50% of 335 countries surveyed by the WHO reported direct trade-offs between COVID-19 vaccination programme 336 rollout and RI service delivery for infants and school-aged children [23]. Further quantification of the 337 trade-off between continued COVID-19 vaccination efforts and RI, in terms of morbidity and mortality 338 implications, could be valuable in guiding immunisation strategies at the country- and global- level in the 339 coming years (as efforts to integrate COVID-19 in immunisation programmes continue). 340 Finally, a select few examples of countries achieving coverage improvements year-on-year and/or 341 reported coverage higher than forecasts in 2020, despite the backdrop of the pandemic. These countries

may provide case studies to explore for translational learnings. For example, Chad's reported DTP3

coverage increased from 50% in 2019 to 52% in 2020 and 58% in 2021 (although it is noted that

- coverage was within 95% forecasted Cls for both years); and Namibia's 2020 reported DTP3 coverage of
- 93% was higher than forecasted (point estimate: 87% ($95\%_{C}$: [81.4%; 92.6%]).

347 Conclusion

This research builds on our previously published, transparent, and replicable approach for estimating gaps in RI coverage across countries, providing an objective measure for missed immunisations and coverage disruptions in 2021. It is clear that immunisation services continued to be disrupted in many low- and middle-income countries, particularly in the Americas, Africa, and Asia, and we hope this work can inform future research to identify effective interventions to facilitate rebounds in coverage to previous levels and catch-up of growing populations of under- and un-immunised children.
