# Determinants associated with infant mortality in Ethiopia: Using the recent 2019 Ethiopia mini demographic and health survey

Abstract

**Background:** Infant mortality is the number of deaths under the age of one year and it is one of the most essential and sensitive indicators of the health status of the country. This study aims to identify the determinants that affect infant deaths in Ethiopia using the 2019 EMDHS.

**Methods:** This study used the 2019 Ethiopia mini demographic and health survey and 1,397 infants born from mothers who had been interviewed about births in the five years before the survey. The data were first analyzed with a chi-square test of association, and then potential factors were evaluated with binary logistic regression models. An adjusted odds ratio (AOR) along with a 95 % confidence interval (CI) of parameters was used to interpret the result

**Results:** The prevalence of infant death was 21% .The study also showed that age at first birth (16-32) infant (AOR = 0.541, 95%CI: 0.353, 0.827), mothers who had breastfed (AOR = 0.022, 95% CI: 0.014,), preceding birth interval less than 24 months (AOR = 0.183, 95% CI 0.117, 0.287), mothers who born their child in the health sector (AOR = AOR = 0.442, 95% CI: 0.304, 0.802) statistically related with a lower risk of infant mortality. Although mothers age group 35-49 (AOR = 2.682 1.446 4.974), mothers who had no ANC visits (AOR = 5.029, 95% CI: 2.923, 8.64), multiple births (AOR = 6.094, 95% CI: 2.684, 13.837, P=0.000) were statistically associated with a higher risk of infant mortality.

**Conclusions:** It is greatly suggested that maternal and child health care services (ANC visits) are strengthened. Preceding birth interval of fewer than 24 months, multiple births, and please of delivery at home needs special attention. We recommend also health institutions play a great roll to give awareness to mothers about family planning to reduce infant mortality.

## Introduction

Mortality is very responsive to social, economic, and psychological factors. Historically, mortality has often been used as a barometer of welfare [1] .Under-five mortality is the most sensitive indicator of the health status of the community in the world. Despite their having been a significant reduction in under-five mortality, its rate is still high in Sub-Saharan African countries [2]. Infant mortality is the number of deaths under the age of one year and it is one of the most essential and sensitive indicators of the health status of the country [3]. Infant mortality is a useful and inexpensive indicator of population health. It represents not only the health of newborns but also the general well-being of society [4]. Neonatal time is the highest risk for infant mortality because of pre-term birth (28 %), severe infections (26%), and asphyxia (23%) [5]. In Ethiopia, infant and child mortality is still high. According to the 2019 EMDHS report in Ethiopia 1 in every 30 children dies within the first month, 1 in every 22 children dies before celebrating their first birthday, and 1 in every 17 children dies before reaching their fifth birthday. The report also showed that infant mortality also declined from 59 deaths per1, 000 live births in 2011 to 48 deaths per1, 000 live births in 2016 and declined from 48 deaths per1, 000 live births in 2016 to 47 deaths per 1,000 live births in 2019 [6-8]. There has been a slight increase in neonatal mortality since 2016, from 29 to 33 deaths per 1,000 live births [8]. Infant mortality was still high in Africa including Ethiopia and it can be reduced by increasing the mother's age at first birth, duration of breastfeeding, and birth interval [9]. The study carried out in different parts of the world [10-12] revealed that the combined effect of Maternal age, maternal age at birth, breastfeeding status, type of birth, preceding birth interval, the breastfeeding status, ANC visits, type of birth, and place of delivery, were significant factor for infant death. These studies contributed to our understanding of many features of determinants of

infant and child mortality in the world especially, in Ethiopia. This study studied in different ways, child and mother's demographic and socio-economic variables. This study aimed to identify determinants associated with infant mortality in Ethiopia. However, In Ethiopia as far as our knowledge there is no study done on infant mortality using EMDHS2019 by application of the binary logistic regression model. Moreover, the previous study in Ethiopia was limited to regional survey data. Therefore, this study focuses on identifying the determinants related to infant mortality in Ethiopia using the EMDHS 2019.

## **Material and Methods**

## Study area and data source

The data used in this study was obtained from the 2019 Ethiopia Mini Demographic and Health Survey (EMDHS 2019), which was implemented by the Central Statistical Agency (CSA) at the request of the Federal Ministry of Health (FMoH). This community-based cross-sectional study was carried out from March 21, 2019, to June 28, 2019, based on a nationally representative sample that provided estimates at the national and regional levels and for urban and rural areas. The survey interviewed 8,855 women of reproductive age (age 15-49) from a nationally representative sample of 8,663 households. This survey was conducted at the national level and for Ethiopia's nine regional states and two city administrations. The data used for infant mortality estimation were collected in the birth history section of the woman's questionnaire which is included in the survey. A detailed methodology has been presented in the 2019 EMDHS final report **[13]**.

**Inclusion and exclusion criteria.** In this study, a child with an age of less than one year was included. Children older than 1 year are not included in this study. Moreover, our analysis excludes infants whose events (alive or dead) were missing.

**Variables in the study.** Outcome variable of this study was infant death in months. Infant mortality is the number of deaths under the age of one. The response variable is coded as (1=alive and 0=death)

Independent variables. The Predictable independent variables that were considered in this study

were shown (Table 1).

We extracted the dependent variable infant mortality rate by using SPSS version 23. After extracting data, Statistical analysis was performed using STAT version 14. To describe the study participants, descriptive statistics were used. This study also used a combination of the chi-square test to determine whether the response variable was associated with different independent variables. Additionally, the multivariable binary logistic regression model performs a response variable with two categories (infant mortality with two categories of yes or no). A binary logistic regression model was used to determine the factors related to infant mortality. A p-value < 5% is used to test the presence of a significant association between the response variable and predictors.

## Result

A total of 1,397 infant mortality took part in this study and infant death occurred in 21 %(293). Rural residents had the highest infant mortality (16.5%).Moreover most women (39.7%) are economically poor. Mother's age at first birth between 33 and 49 had the lowest rate of infant death (0.8%). The proportion of female and male infant death was (39.4% and 39.6%) respectively. The majority of (38.7%) infant death was attributed to women who didn't have education Furthermore; all covariates are presented in (**Table 2**).

## **Results of the binary logistic regression model**

Binary logistic regression model were performed utilization of categorical independent variables that were found to be significant in the bivariate analysis, **Table 4** summarizes the findings. Maternal age, maternal age at birth, breastfeeding status, type of birth, preceding birth interval, breastfeeding status, ANC visits, type of birth, and place of delivery, were statistically significant related with infant death. When compared to maternal age at first birth infants whose age at first birth were (16-32) than whose age less than 16 to infant age, the odds of infant death were 0.541 times (AOR = 0.541, 95%CI: 0.353, 0.827) lower. Those who had breastfed a 0.022 (AOR = 0.022, 95% CI: 0.014, 0.034, P<0.000) times less risk of infant death compared to other infants. The odds of infant death among multiple births were 6.094 (AOR = 6.094, 95% CI: 2.684, 13.837, P=0.000) times higher as compared to single births. Furthermore, Children born greater than 24 months of the previous birth interval had 0.183 times (AOR = 0.183, 95% CI 0.117, 0.287) less risk of infant death than those born less than 24 months.

Compared to mothers who had ANC visits, the risk of infant mortality was 5.029 times higher (AOR = 5.029, 95% CI: 2.923, 8.649, P=0.000). Please of delivery was also a significant predictor of Infant death. Mothers who birth their child in the health sector had a 0.494 (AOR = AOR = 0.442, 95% CI: 0.304, 0.802) times lower risk of infant death than mothers who birth their children at home (**Table 3**).

## Assessment of goodness of fit of the model

After fitting the binary logistic regression model to categorical data, it is necessary to assess the adequacy of the model. To deal with this, we used Hosmer and Lemeshow's Goodness of Fit tests. Based on the results in (Table 4), the null hypothesis that there is no difference between the model with just a constant and the model with predictors has been rejected. The statistical values (Table 5) of Cox & Snell (Pseudo R-square = 0.529) and Nagelkerke (Pseudo R-square = 0.839) were reasonable in this investigation, indicating that the model explained part of the variation (Table 6). Table 7 reflects that the Hosmer-Lemeshow goodness of fit test is an insignificant result. As a result, the model well fits the data.

## Discussion

This study aims to identify the determinants of infant deaths using EMDHS 2019. To examine factors that affect infant mortality, this study used both descriptive and logistic regression models. The descriptive statistics showed that the prevalence of infant death was 21%. The binary logistic regression model shows that maternal age, age of mothers at birth, breastfeeding status, type of birth, preceding birth interval, breastfeeding status, ANC visits, type of birth, and place of delivery, were statistically significantly related to infant deaths. Mother's age at first birth is a significant predictor of infant death. Infant death was higher in mother's birth their child at young stage than in the older mother. This outcome is consistent with study [9,14-16]. This finding was consistent with a study from the year before [28]. This study finding has important policy implications, particularly in determining the program needs for a sustainable decline in infant mortality rate, and in monitoring public health interventions. The mother's age was found to be a significant predictor of infant death. Infant death was higher in the younger

mother than in the older mother. This study is consistent with findings [17-18]. The findings also revealed that type of birth was a significant risk factor for infant mortality. The risk of infant death was greater in multiple births than in single birth infant. This is because single newborns get enough breast milk [19-21]. These studies [17,22] . also agree with the previous study Breastfeeding is a child's first line of defense against death and disease, protecting them from respiratory infections, gastrointestinal illnesses, and other negative health consequences [9] .Short birth intervals had high risk of infant death than long birth intervals, and the risk of infant death decreased as the prior birth interval grew. The risk of obstetric complications is lower in mothers with long birth intervals than in mothers with shorter birth intervals [21-23]. Furthermore, statistically, place of delivery was also a significant predictor of infant death. Mothers who birth their child in the health sector had a lower risk of infant death than mothers who birth their children at home. This is because newborns health sector have greater access to health care and other key health-related amenities that are required for infant survival [24-27]. It is important to look beyond identifying determinates with infant death .Reducing motherhood in younger ages and increasing the spacing between births and also specified that an increase in mothers' age at first birth, improve health care services which should in turn raise child survival and should decrease infant death in Ethiopia. Interventions and strategies should be targeted focusing on these characteristics to improve child health outcomes as well as the future betterment of Ethiopia.

#### Conclusion

The result of this study revealed that maternal age, mothers' age at birth, breastfeeding, type of birth, preceding birth interval, breastfeeding status, ANC visits, type of birth, and place of delivery, were statistically significantly related to infant mortality. Preceding birth interval of fewer than 24 months, multiple births, and please delivery at home needs special care. We

recommend also health institutions play a great roll to give awareness to mothers about family planning and breastfeeding to reduce infant mortality.
