22	Objective
23	This study aimed to assess whether continuous anesthetic wound infusion (CAWI) increases postoperative
24	activity in patients who undergo midline laparotomy for gynecological diseases.
25	
26	Methods
27	This was an unplanned secondary analysis of a randomized controlled trial examining the effect of an activity
28	tracker with feedback on postoperative activity in patients who underwent midline laparotomy for gynecological
29	diseases (NCT02025387). Of the 53 patients included in the trial (12 patients used CAWI and 41 patients did
30	not), 11 patients with CAWI (case group) and 11 without CAWI (control group) were selected by matching the
31	duration of surgery. We compared the postoperative activity and other endpoints between the case and control
32	groups.

48 Introduction

50 Postoperative activity is associated with complications and recovery. For example, one systemic review showed 51 that the amount of postoperative activity is negatively correlated with the length of hospital stay [1]. Bed rest 52 after surgery increases the chances of pulmonary embolism and deep vein thrombosis [2, 3] 53 It has been suggested that increasing postoperative activity is beneficial. For example, early ambulation after 54 open abdominal surgery prevents postoperative complications and reduces the length of stay [1]. In patients who 55 started walking within 3 days after surgery, the time to independent standing and walking was significantly 56 shortened [4]. Early ambulation also prevents venous thromboembolism [5-7]. 57 Postoperative pain is one of the main hurdles in increasing postoperative activity. A negative correlation 58 between pain and activity after cesarean section was previously reported [8]. Another study reported that 59 postoperative daytime steps increased as postoperative pain was relieved [9]. Similarly, postoperative pain relief 60 in hip fracture patients was shown to promote early functional gait recovery [10]. Such a positive correlation 61 was also seen in patients undergoing knee arthroplasty, where postoperative pain management was associated 62 with better range of motion, better performance in daily activities, and faster gait speed [11]. 63 Continuous anesthetic wound infusion (CAWI) is a device that continuously releases a local anesthetic into the 64 surgical site. The CAWI has been reported to effectively relieve postoperative pain. According to a meta-65 analysis that included 121 randomized controlled trials, CAWI was reported to reduce pain during laparotomy 66 and sternotomy [12]. In another study, CAWI reduced additive opioid consumption [13]. We also reported that 67 CAWI reduced pain in patients with gynecologic cancer [14]. 68 We hypothesized that CAWI might increase postoperative activity through pain relief. This study therefore

aimed to assess whether CAWI increases postoperative activity in patients who underwent midline laparotomy

70 for gynecological diseases.

71 Materials and methods

72

73 Study information and population

74 This is an unplanned secondary analysis of a randomized controlled trial examining the effect of an activity 75 tracker with feedback on postoperative activity in patients who underwent midline laparotomy for gynecological 76 diseases [15]. The recovery rate of activity was measured by comparing the number of steps taken before and 77 after midline laparotomy. The secondary analysis was approved, and the requirement for informed consent was 78 waived by the Institutional Review Board of our institute (IRB No. B-2108-700-106). 79 The medical records of the 53 patients who participated in the randomized controlled trial were reviewed. 80 Twelve patients received both CAWI and intravenous patient-controlled analgesia (PCA), but 41 patients 81 received only intravenous PCA. By considering the duration of surgery as a factor to match patients receiving 82 CAWI with those receiving PCA alone (nearest matching duration within \pm 30 min), 11 patients with CAWI 83 (case group) and 11 patients without CAWI (control group) were selected (Figure 1). 84 85 **Objectives** 86 The primary objective was to compare the recovery rate on postoperative day 4 (step counts on postoperative 87 day 4 divided by the daily step counts at preoperative baseline) between groups. The secondary objectives were 88 to compare the recovery rate over time, pain measured using the Brief Pain Index (BPI), fatigue measured with a 89 brief fatigue index (BFI), gas out day, soft blend diet initiation, ileus rate, and length of stay. 90 91 Statistical methods 92 The Mann-Whitney test or independent t-test was used to compare continuous variables. Chi-square tests were 93 used to compare the categorical variables. After conversion to the log scale, a linear mixed model was used to

94 analyze the recovery rate over time.

95 *P*-value of < 0.05 was considered statistically significant. All analyses were performed using SPSS 25.0 (IBM,

96 Armonk, NY, USA).

97	Results
98	
99	Patient characteristics
100	The patient characteristics were similar between the case and control groups (Table 1). Specifically, the mean
101	age was in the mid-50s in both the case and control groups. Height and weight of the case group were similar to
102	those of the control group. The distribution of the American Society of Anesthesiologists (ASA) score was also
103	similar between the groups. The duration of surgery was > 3 h, and the incision length was > 20 cm in both
104	groups. The distribution of the arms in the randomized controlled trial was similar between the case and control
105	groups.
106	
107	Postoperative outcomes
108	A comparison of the postoperative outcomes is summarized in Table 2. Step counts at the preoperative baseline
109	and postoperative day 4 were similar between groups. The recovery rate on postoperative day 4 in the case
110	group was numerically higher but not significantly different from that of the control group (58% vs. 44%;
111	p=0.450).
112	Least, average, and present pain measured with BPI on postoperative day 2 was lower in the case group than in
113	the control group. However, the BPI scores on postoperative day 5 were similar between groups. Fatigue, gas
114	out days, soft blend diet initiation days, ileus, and length of stay were all similar between groups.
115	
116	Recovery rate over time
117	The recovery rate over the postoperative day showed a gradual increase in the case group, but a fluctuation in
118	the control group (Figure 2). Linear predictions of the log-transformed recovery rate over the postoperative day

119 were also similar between the case and control groups (p = 0.584, Figure 3).

120 Discussion

121

122 Main findings of our study

123 A previous study reported that one of the major reasons for a quick postoperative recovery is controlling acute

124 postoperative pain [11]. In one study, postoperative activity increased, whereas the pain decreased over time,

- 125 after laparotomy surgery. Therefore, we hypothesized that CAWI might increase postoperative activity through
- 126 pain relief. However, in this study, the CAWI was not associated with increased postoperative activity. Although
- 127 not statistically significant, the recovery rate on postoperative day 4 was higher in the case group than in the
- 128 control group. The small sample size could be a reason for the negative results.

130 CAWI reduces pain

131 In this study, CAWI was associated with reduced pain on postoperative day 2, but not on day 5. Similar results 132 have been reported in previous studies. For example, a study reported that acute-phase pain control was 133 effective in the CAWI group, especially for laparotomy surgery [12]. Previous studies also have shown earlier 134 retention of bowel function and a shorter hospital stay with CAWI [1, 13], but there were no significant 135 differences observed in our study.

137 Advantages of our study

The strength of our study was that the amount of postoperative activity and degree of postoperative pain could be quantitatively assessed using an objective number. There have been only a few studies investigating the relationship between postoperative pain and activity. In our study, activity accuracy was assessed using an activity tracker and pain through the BPI score. The basal activity was quantified using an activity tracker to assess the recovery rate.

144 Limitations of our study

A limitation of our study was the possibility of selection bias. Specifically, the CAWI tended to be applied to longer and major surgeries, which led to differences in characteristics between the two groups. We attempted to negate the selection bias using duration of surgery as a factor for matching. In addition, the number of patients included in our study was insufficient to achieve significant results. In future studies, enrolling higher number of

- 151 Conclusion
- 152 In this exploratory analysis, CAWI was not associated with increased postoperative activity in patients who
- 153 underwent midline laparotomy for gynecological diseases.
