39 Abstract

- 40 OBJECTIVE:
- 41 Precision medicine is a rapidly progressing avenue to providing the right care to the
- 42 right patient at the right time and spans all medical fields and specialties. However,
- 43 given its reliance on computation and timely, accurate information, actualizing precision
- 44 medicine within the emergency department and its "anyone, anywhere, anytime"
- 45 approach presents unique challenges which could exacerbate disparities rather than
- 46 improve care.
- 47

48 METHODS:

49 We performed a qualitative, nominal group technique study of emergency physicians

50 with prior knowledge of precision medicine concepts to identify high priority ethical

- 51 concerns facing the implementation of precision medicine in the emergency department.
- 52

53 RESULTS:

Twelve emergency physicians identified 91 ethical concerns which were organized into
a framework with three major themes: values, privacy, and justice. The framework
identified the need to address these themes across three time points of the precision

57 medicine process: acquisition of data, actualization in the care setting, and after effects 58 of its use.

60 CONCLUSIONS:

- 61 Precision medicine may help to improve the quality of care provided in the emergency
- 62 department, but significant hurdles exist. Our framework helps to identify high-yield
- 63 ethical concerns that could serve as focus areas for future research and policy in order
- 64 to guide the effective implementation of precision medicine in the emergency
- 65 department.

66 Introduction

67

Historically, medical treatments have been tailored to the average patient. However, few 68 69 individuals look or feel like the average patient-each has their own risk factors, needs, and ideal outcomes. Precision medicine aims to address this problem by moving from a 70 71 one-size-fits-all model toward one of providing the "right care to the right person at the right time" through the use of big data like genetics and wearable technologies.^{1–5} 72 73 However, even the most advanced, targeted therapies are limited by biases that already exist in the US healthcare system.^{6,7} Differential care, even when "evidence based", can 74 75 result in worsened gaps between the haves and the have-nots, disproportionately burdening already marginalized communities.⁸ For emergency physicians, who serve in 76 77 the safety net for American healthcare, precision medicine's "right care, right patient, 78 right time" must be balanced with our "anyone, anywhere, any time" mantra and the practical and ethical challenges that this setting presents. 79

80

81 To date, most precision medicine initiatives have focused on the utilization of genetics 82 to better understand or treat diseases. Much has been made of determining the right 83 medication for the right person (e.g., warfarin dosing for those with a CYP mutation) or when to start cancer screening based on genetic profiles (e.g., colorectal screening for 84 CHD1).⁹ It has become clear, however, that genetics alone cannot explain much of the 85 variation in outcomes across the population.^{2,10} The effect of behavioral factors like diet 86 87 and exercise have been well-established, and studies have also begun to illuminate the effect of social and environmental determinants of health like access to healthcare 88 resources or housing, which may be responsible for over half of health outcomes.^{11,12} 89

As such, there has been a broadening approach to precision medicine that does not rely solely on genetics, but also home monitoring, social media and social networks, as well as patient-generated data like diet, daily steps, exercise, or heart rate variability.^{13,14}

While useful when available, not all patients can afford these tools and services. 94 Furthermore, "precise" treatments rely on the accuracy of this data, which must be built 95 into data sets and shared. Few comprehensive data sets that incorporate all of these 96 97 data exist, and even fewer have been carefully evaluated for missing or inaccurate data which could bias results.¹⁵ Current data sets suffer from a lack of representation from 98 99 some populations while simultaneously over-representating chronically-ill patients or those presenting to research institutions.¹⁶ Data that were collected where patients are 100 provided differential care might inadvertently support antiquated practices^{17–21} due to 101 102 the association of outcomes with variables like the ability to pay for a higher level of 103 care. Though precision approaches aim to limit guality gaps and provide more equitable 104 care, decisions that are made without the full picture of their context might inadvertently exacerbate systemic biases.⁷ 105

The emergency department setting offers additional unique hurdles for the growth of precision medicine. Little patient-generated data are readily available at the point of care. Highly important features like code status are haphazardly available among the sickest patients. Nevertheless, emergency care providers strive to provide better care, and to actualize the benefits of a truly learning healthcare system. How can this safety net, responsible for a growing and significant portion of acute care in America,^{22,23} begin

- to approach the problems that inherent to the implementation of precision medicine so
- 114 that it might offer real-time, equitable care for patients with the widest spectrum of
- 115 disease in medicine and a microcosm of the healthcare system?
- 116
- 117 Given the continued growth yet limited scope of precision medicine in the emergency
- department, our primary goal was to identify themes and gaps in current research by
- 119 using a rigorous consensus technique to identify ethical questions and concerns of
- 120 precision medicine relevant to emergency medicine practice. This manuscript presents
- 121 the resulting consensus framework.

122 Methods

123

- 124 Study Design and Setting: We employed a modified nominal group technique (NGT), a
- 125 consensus methodology widely used in emergency medicine, to identify high priority
- 126 research questions relevant to the implementation of precision medicine in the
- 127 emergency medicine setting and arrive at a consensus framework.^{24–31}

128

- 129 NGT is a four-step process in which stakeholders generate and then prioritize research
- 130 ideas (Figure 1). NGT was well-suited for our research question as our aim was to
- 131 generate a comprehensive set of ethical questions and concerns which could then be
- 132 organized and ordered. This is in contrast to other frequently used consensus
- 133 techniques such as the Delphi technique, which are designed instead to reach a
- 134 consensus opinion on one particular question.²⁴ NGT has previously been used
- 135 successfully to identify research priorities in the field of Emergency Medicine.^{25,27,32–35}

141 Selection and Participants: The ideal NGT session group size is greater than six - with the ideal between nine and twelve - participants,³² with the ideal between nine and 142 twelve.³² Participants were recruited via email to the Society of Academic Medicine 143 144 Ethics Committee listsery; the email invitation also asked recipients for referral and 145 sharing to others who may be interested. A convenience sample of the first fourteen 146 respondents to the email were registered as potential participants in the NGT group to 147 meet the ideal group size and allow for scheduling conflicts. Ultimately, twelve 148 emergency medicine physicians with working knowledge of precision medicine topics 149 joined our NGT session. Participants represented a spectrum of sub-specialties 150 (education, ethics, pediatrics, diversity, equity, and inclusion, and informatics) across 151 various stages of training (resident, early-, mid- and late-career) and practice settings (county hospital, community hospital, academic center, and integrated managed care 152 153 consortium) (Appendix 1) in order to provide a range of emergency medicine practice 154 perspectives.

Participants took part in the NGT session during the American College of Emergency
Physicians annual conference in Boston, October of 2021. The process was moderated
by the lead researcher of the group (CR), and notes were taken by two separate
researchers (ES and MG).

162 NGT Process

163

164 Phase 1: Silent idea generation.

165 The first step of NGT is a round of silent idea generation. In this phase, after being

166 given an initial prompt, participants silently write down what they believe to be high

167 priority topics or concerns. It is imperative that this phase is silent, as this allows each

168 member of the group to write their initial thoughts without influence from other members.

169 Our prompt asked participants to identify what they thought were priority research topics

170 for the implementation of precision medicine initiatives in the emergency medicine

171 setting.

172

173 Phase 2: Round-robin.

After individual idea generation, participants then shared their ideas with the group in a round-robin format. NGT has the advantage of not allowing any one particular voice to outweigh others, by asking each participant to share their complete list of ideas in-turn during the round robin phase, rather than ad-hoc discussion, thus minimizing potential bias.^{36,37}

179

180 Phase 3: Discussion and clarification.

After the round-robin format, participants undertook a 30-minute discussion and
clarification of topics. In this phase, participants were encouraged to ask other members

183 for clarification of topics generated as needed. Cross-cutting themes were identified,

- and duplicate topics consolidated. Key topics were then placed on moveable cards for
- 185 prioritization and further thematic grouping.
- 186
- 187 Phase 4: Finalization of research priorities.
- 188 Lastly, participants finalized the topics they believed represented priority areas for
- research. In traditional NGT, this is the ranking phase, where members are allocated
- 190 votes to generate a ranked list of research priorities. Instead, participants categorized
- 191 concerns by overarching themes and came to consensus on those distinctions.

192 **Results**

- 193 During phases one and two of the NGT process, 82 questions were generated
- 194 (Complete list in Appendix 2) with the average participant contributing 6.8 (+/- 2.9)
- 195 questions. After refinement and separation of cross-cutting themes and consolidation of
- 196 duplicate topics in phase three, a list of 68 final questions were retained.
- 197 In phase four, those questions were mapped into common thematic realms based on
- the nature of the ethical issue and where in the precision medicine process the issue
- 199 was likely to occur (Tables 1-3). The result of this mapping was a 3 by 3 matrix
- 200 consisting of ethical concerns grouped into the domains of values, privacy and justice
- as related to their temporal relationship to the precision medicine process, specifically in
- the acquisition of data, the actualization of precision medicine in practice, and the after-
- 203 effects of the process (Figure 2). This matrix represents the product of our expert panel
- 204 consensus.

218 Discussion

219

220	Precision medicine research and practice in the emergency medicine context requires
221	attention to the specific ethical concerns of those working in this space in order to avoid
222	potential pitfalls and promote inclusion and equity. Working with a diverse group of
223	emergency physicians, we used a modified NGT approach to identify critical areas in
224	need of research at the intersection of emergency medicine, precision medicine, and
225	ethics. The resulting consensus framework highlights critical areas of focus for precision
226	medicine research in emergency medicine that are cognizant of the limits and
227	challenges of data acquisition, the actualization of precision medicine in practice, and
228	the potential after-effects of this pursuit for our patients and communities. Three major
229	themes emerged from the modified NGT: values, privacy, and justice.
230	

231 Shared Ethical Concerns: Values, Privacy, Justice

A recurring theme in discussion was "whose values are we accounting for?" Participants 232 233 acknowledged the sometimes conflicting needs of the individual versus those of the 234 system. Providers may recommend medications which prolong survival, but side effects may be undesirable or the cost prohibitive for some patients.³⁸ The definition of high 235 quality care envisioned by precision medicine may not align with the individual goals of 236 237 patients. There were many questions raised regarding challenges to patient autonomy 238 and to the ambiguity of who is the ultimate decision maker in precision medicine-and 239 how that might change over time, as the needs of the many may be at odds with the needs of a few. The ethical principle of autonomy is considered perhaps the most 240 important principle in medical ethics.³⁹ Respect for autonomy requires that patients are 241

able to make their own decisions, incorporating their own values, but the limits of patient
 autonomy remain under debate.⁴⁰

244

245 Ensuring that patient autonomy is maintained can be particularly challenging in the 246 emergency care context. In the emergency department, providers make decisions with 247 patients in a time-constrained setting, particularly compared to those historical clinical 248 environments of precision medicine, such as oncology. Not only does this limit time for discussion, it may also create a sense of external pressure to make a decision.⁴¹ Might 249 other competing factors in this clinical setting also ultimately limit patient and physician 250 251 choice given precision medicine's reliance on optimizing measurable and scalable 252 outcomes? The idea of autonomy becomes less clear when it comes to data at the 253 population level: whose value system will be used to make decisions once data has 254 moved from the individual care setting to community responsibilities? Will patient values 255 (e.g., best outcome) align with broader system values (e.g., cost-effectiveness) when considering precision medicine research and recommendations? To what extent might 256 patients ultimately lose elements of individual autonomy once their data is incorporated 257 into communal data? 258

259

260 This latter concept underscores the importance of privacy in precision medicine.

261 Confidentiality, a core ethical principle of emergency medicine,⁴² requires providers 262 ensure their patient's privacy. The practice of precision medicine in the emergency 263 department will likely require massive amounts of data transiting across institutions and 264 from personal devices. Ensuring the safety and security of this protected information is

265	a major hurdle for precision medicine initiatives, and the above-mentioned time-
266	sensitive nature of the emergency department encounter makes it necessary to share
267	this data in real-time, which is unique from other medical specialties. ^{43–46} Additionally,
268	when patients know that the information they provide to the system will be used to make
269	recommendations for themselves or others, it may have several effects. First, patients
270	may not accurately disclose their values and personal concerns if they do not have trust
271	in the safety of their information and its use. For example, alcohol use and history for
272	the allotment of liver transplant is one area which may leave patients in a moral
273	quandary, unsure whether to be open with their behavior but fearing the effects of those
274	disclosures.47,48 Furthermore, patients may be concerned that their personal choices
275	may have adverse effects on people like them, providing another ethical dilemma for
276	how and what to disclose. Privacy includes not only the protection of one's identity and
277	personal information, but also the ability to make choices without interference.49
278	Perceptions of trustworthiness will impact the success of any scientific or research
279	endeavor, particularly among historically disadvantaged populations. ⁵⁰
280	

But perhaps nowhere is the complex tension between values and privacy felt more than in the realm of justice. A commitment to justice is in the historical roots of emergency medicine and it is no surprise that our consensus framework includes this as a key area for research in precision medicine as it grows in the emergency department and in the prehospital setting.^{51–53} Emergency physicians carry the distinct duty under federal law to provide care to anyone who presents for emergency care.⁵⁴ This duty is widely recognized to rest on a fundamental moral responsibility to provide care "promptly and

288	expertly, without prejudice or partiality". ⁴² At first it may seem that precision medicine
289	would help to limit personal biases which might affect care, using data as opposed to
290	gestalt or local practice variation. But structural biases may encode results and
291	outcomes on patients that might inadvertently limit the benefits of the precision medicine
292	model. Obvious examples include the use of race-adjusted creatinine to allocate critical
293	resources which has occurred for years and affects the validity of results used to make
294	targeted recommendations.55

295

296 Justice, or more specifically with respect to medical ethics, distributive justice,

emphasizes that resources are to be distributed fairly, equitably, and appropriately. This 297 298 can be heavily hindered if providers rely on precision models to make recommendations 299 without a critical appraisal of how well the results fit the patient in front of them. Even if done well, the outputs of precision medicine may not be available to all.⁵⁶ Precision 300 301 medicine which is ultimately only accessible to a few but built on the data of many, 302 would violate the principle of justice and would be an affront to the growing field of social emergency medicine. In oncology, an area with a much longer history of precision 303 304 medicine, 78% of patients and providers reported concerns regarding the accessibility of precision medicine.⁵⁷ 305

308 Cross-Cutting Themes & the Process of Precision Medicine

309 Participant discussion emphasized the need to investigate concerns of justice, privacy,

310 and values from a longitudinal perspective: data acquisition, actualization, and

311 application after-effects. In doing so, additional cross cutting themes emerged

312 (Supplemental Table 1), many of which are shared with other applications of precision

313 medicine.

314

315 Data Availability and Acquisition

316 Ultimately, the trust patients and providers have in the recommendations of precision 317 medicine begins with the data that are used and collected. In emergency medicine, we, 318 as providers, stand prepared to address a range of conditions for any patient, at any 319 time. However, we often cannot rely on complete patient histories (e.g., due to the 320 severity of illness or mental status changes frequently encountered in emergency 321 medicine) or access to prior medical records (e.g., our patients may be uninsured, underinsured, and without access to routine primary care providers.⁵⁸ Precision 322 323 medicine approaches will thus need to be deployable in a timely manner and require 324 only what limited patient-specific information is available to emergency physicians. 325

326 Furthermore, even when data are available, precision medicine approaches may serve only to perpetuate systemic flaws in the healthcare system if the data used is 327 inaccurate, biased, or exclusionary from the start.^{7,59} Data may reflect bias with respect 328 to inclusion⁶⁰ as well as bias stemming from structural racism. A 12-year review of the 329 330 National Hospital Ambulatory Medical Survey (NHAMCS) showed that Black patients in 331 the emergency department were 10% less likely to receive immediate or emergent Emergency Severity Index (ESI) scores compared to white patients, 10% less likely 332 333 than white patients to be admitted, but 1.26 more likely to die in the emergency

department or the hospital than white patients.⁵⁸ If these data were used to make
recommendations about who and where to direct resources, it may serve only to further
amplify the pre-existing failures to address and reduce bias that are present in the data
and its acquisition.

- 339 Choice

340 Beyond the issue of timing, there are additional logistic concerns for the actualization of 341 precision medicine in emergency departments, including costs, legal issues and patient 342 education. Efforts made to collate data from emergency care settings to be used in 343 precision medicine research may result in products or treatment pathways unaffordable to these patients.^{61–63} This may be mitigated through insurers.⁶⁴ but the emergency 344 345 department is a safety net, and as such this approach may not benefit the most 346 vulnerable patients while those who are insured may find that their plans have little incentive to offer this option.⁶⁵ Research has shown that the cost of precision medicine 347 is a concern shared by patients and providers alike.^{56,57} 348

349

350 Informed Decision Making

Even when payment is not an issue, a data- and machine-supported approach may not be conducive to truly informed consent given the limitations of adequately educating emergency department patients regarding how precision medicine and its associated research works.^{56,66} Beyond the challenge of consenting in the emergency context, providers must also consider issues regarding disclosing incidental information and the potential changes associated with the use of data over time which interconnected to

- 357 other growing datasets. Stewardship of these data, defined as "the responsible
- 358 management of something entrusted to one's care",⁶⁷ will be critical to maintaining trust
- 359 of patients and communities as this science evolves.⁵⁰
- 360

361 Avoiding Reductionism

362 Despite the promise of precision medicine to deliver individually tailored care, it, like

363 traditional approaches, requires that patients be categorized into discrete groups by

364 some shared characteristics. The choice of categories and the act of assigning patients

to these groups has its own meaning and implications.⁴

366

Discussion in this NGT process highlighted the need to actively maintain a holistic view of the patient without being overly reductive to these categories.
