19 **Preterm Birth and Neonatal Mortality in Selected Slums in** 20 **and around Dhaka City of Bangladesh: A Cohort Study**

21 **Abstract:**

22 **Background:**

23 Although under-five mortality declined appreciably in Bangladesh over the last few decades,
24 neonatal mortality still remains high. The objective of the study is to assess the level and
25 determinants of preterm birth and the contribution of preterm birth to neonatal mortality.

26 **Methods:**

27 Data for this study came from selected slums in and around Dhaka city, where; since 2015, icddr,b
28 has been maintaining the Health and Demographic Surveillance System (HDSS). The HDSS data
29 were collected by female Field Workers by visiting each household every three months; however,
30 during the visit, data on Last Menstrual Period (LMP) were also collected by asking each eligible
31 woman to ascertain the date of conception. Gestational age was estimated in complete weeks by
32 subtracting LMP from the date of pregnancy outcome. In this study, 6,989 livebirths were recorded
33 by HDSS during 2016-2018, and these births were followed for neonatal survival; both bivariate
34 and multivariate analyses were performed.

35 **Results:**

36 Out of total births, 21.7% were born preterm (before 37 weeks of gestation), and sub-categories
37 were: 2.19% for very preterm (28 to 31 weeks), 3.81% for moderate preterm (32 to 33 weeks), and
38 15.71% for late preterm (34 to 36 weeks). The study revealed that preterm babies contributed to

39 39.6% of neonatal deaths; however, the probability of death was very high on the 1st day of birth
40 (0.124 for very preterm, 0.048 for moderate preterm, 0.024 for late preterm, and 0.013 for term
41 birth), and continued until the 3rd day. In the regression analysis, compared to the term neonates,
42 the odds of neonatal mortality were 8.74 (CI: 5.68, 13.45, $p < 0.01$), 4.05 (CI: 2.64, 6.22, $p < 0.01$)
43 and 1.48 (CI: 1.05, 2.08, $p < 0.05$) respectively for very, moderate, and late preterm birth categories.
44 The population attributable fraction for neonatal mortality was 23%, and sub-categories were 14%
45 for very preterm, 10% for moderate preterm, and 6% for late preterm.

46 **Conclusions:**

47 Although urban slums are in proximity to many health facilities, a substantial proportion of
48 preterm birth contributed to neonatal deaths. So, pregnant women should be targeted, to ensure
49 timely care during pregnancy, delivery, and post-partum periods to improve the survival of new-
50 borns in general and preterm birth in particular.

53 **Introduction:**

54 Globally, under-five mortality rates although are improving, neonatal mortality rates have shown
55 much less progress. In Bangladesh, neonatal mortality accounts for 69% deaths of infants and 66%
56 deaths of under-five children [1]. To improve the situation, the Sustainable Development Goal 3
57 (SDG3) has proposed to reduce under-five death further, and each country should target to reduce
58 the neonatal mortality rate to at least 12 per 1,000 livebirths by 2030 [2].

59 The survival chance of a baby depends on gestation age. In fact, preterm is defined as babies born
60 before 37 completed weeks of gestation, while categories of preterm births are: a) very preterm
61 (28 to 31 weeks); b) moderate preterm (32 to 33 weeks); and c) late preterm (34 to 36 weeks); those
62 born at 37 or more weeks of gestation was classified as term birth. Globally, an estimated 15 million
63 babies are born preterm each year (more than one in 10 babies); two-fifth of these birth were in
64 south Asia and sub-Saharan Africa [3, 4]. At the national level, preterm birth is about 5% in the
65 developed countries, while it is 25% in the low-medium income countries [5]; however, the
66 preterm birth rate is increasing in some developed countries [6].

67 Preterm birth complications are estimated to be responsible for 35% of the world's 3.1 million
68 annual neonatal deaths, and are now the second most common cause of death after the economic
69 cost of preterm birth is high in terms of neonate. The risk of death of premature babies is at a
70 higher level during the neonatal period than those born at term, especially in developing countries,
71 where about half of all mothers give birth at home without a skilled birth attendant [7].
72 Complications of preterm births are the leading direct cause of neonatal mortality, accounting for
73 approximately 1 million of almost 4 million neonatal deaths every year, and act as a risk factor for
74 many neonatal deaths due to other causes, particularly infections [8]. Preterm babies who survive
75 are at a higher risk for short-term and long-term morbidities [9-11]. In Bangladesh, 17.2% of

76 newborn deaths are due to complications of premature births [12]. Preterm neonates also
77 contribute significant costs to health systems, and families of preterm newborns often experience
78 considerable psychological and financial hardships [13, 14].

79 The decrease in neonatal mortality of preterm birth in developed countries is primarily due to
80 better management than changes in the percentage of preterm births [15-17]; postnatal care for
81 preterm babies in developed countries uses specialized equipment and trained doctors. Low cost
82 and effective services appropriate to home births in low-income countries are rare [18, 19].
83 However, some studies from high-mortality settings have demonstrated that interventions
84 targeting home care service by a skilled community health worker for providing service to pregnant
85 women during antenatal, delivery and postnatal period reduced neonatal mortality significantly [20-
86 26].

87 According to the last slum census in 2014, a total of 13,938 slums were counted covering 2,227,754
88 residents all cities and other urban areas of Bangladesh (for details, BBS 2015 [27]). Out of those,
89 33.6% were counted in Dhaka North (11.8%), Dhaka South (12.6%) and Gazipur city corporation
90 (9.2%). Bangladesh Urban Health Survey reported that neonatal mortality is higher in the slum
91 areas (43.7 per 1000 livebirths) than non-slum areas (20.1 per 1000 live births). Reports also
92 indicates the inequality of the neonatal deaths regarding the location and size of the slums as well
93 as sex of the child [28, 29].

94 Studies of preterm birth and neonatal mortality were few, particularly among slum dwellers in
95 developing countries, and it is due to scarcity of data. The urban HDSS has been in operation in
96 selected slums in around Dhaka city to monitor and impact evaluation of the comprehensive
97 primary health care services those are being provided by the Aalo clinics (model clinics). The study
98 took advantage of using high quality HDSS data of the slum area, those at great risk of experience
99 of preterm birth; the study slums cover about one-third of slum population of Bangladesh. The

100 objective of the study is to assess the level and determinants of preterm birth and the contribution
101 of preterm birth to neonatal mortality using data from selected slums in and around Dhaka city.

102 **Methodology:**

103 **Setting:**

104 The study used data from urban Health and Demographic Surveillance System (urban HDSS)
105 which operates on some purposively selected *slums* from Dhaka (North & South) and Gazipur City
106 Corporations, where icddr,b has been maintaining the HDSS since 2015 (for detail see *Slum Health*
107 *in Bangladesh* [29]). *Slums* are defined as a cluster of compact settlements of 5 or more households
108 which generally grow very unsystematically and haphazardly on government and private vacant
109 land, are prone to adverse environmental hazards and exposures [27]. Whereas the *households* are
110 consisting of one or more people who live together and share meals from a common cooking pot,
111 and can identify one member as head of the household. The slums were selected for the urban
112 HDSS regarding the larger in size (>100 households per slum area), sustainable and convenient
113 for longitudinal data collections by female Field Workers. All the inhabitants of those selected
114 slums were interviewed for baseline census in 2015 covering 118,238 population (3.8 persons per
115 households). After the baseline census data collections, all the households are followed in every 3
116 months of interval. These data cover registration of conception, pregnancy outcomes (livebirths,
117 stillbirths, induced miscarriage, and spontaneous miscarriage), deaths, marriage/divorce,
118 migrations (in-, out-, and internal movement), changes in household composition/headship, safe
119 motherhood practices.

120 In these slums, the under-five mortality rate is about 70% higher than those recorded in rural
121 Matlab HDSS government-service area. In these slums, most households had one bedroom (82%)
122 with a small dwelling area (119 sq ft). Construction materials are usually brick/cement floors

123 (88%), tin walls (70%), and tin roofs (94%). About 95% of households used pipe water for
124 drinking, while only one-third had sanitary latrine flush to sewerage/septic tank. Sharing facilities
125 are common in the slums, 92% shared water sources, 90% latrines, and 60% cooking places; use
126 of electricity as a source of light is universal. Most households have electric fans (96%) and mobile
127 phones (85%); only 60% had television and *khat*. The mean household expenditure was BDT
128 11,981 per month (US\$ 145) and 72% of households did not have any savings [30].

129 **Data and measurements:**

130 During the follow-up visits, each married woman (15-49 years) was asked privately by the female
131 Field Worker to know whether they had been menstruating or not; if not, then asked about their
132 Last Menstrual Period (LMP) to ascertain the conception status. Once the conception was
133 confirmed, the woman was followed for subsequent pregnancy outcomes (livebirth, stillbirth,
134 induce miscarriage, and spontaneous miscarriage). For each livebirth, data were collected on the
135 date of delivery, place of delivery, details on maternity care (antenatal, delivery, and postnatal
136 practice). Gestation age was estimated by subtracting the date of delivery and the date of LMP.

137 In this study, all the livebirths in the selected slum areas (HDSS areas) for the period 2016-2018
138 were followed for survival up to the neonatal period. During these periods, there were 6,989
139 livebirths were registered in the HDSS area and all of them were selected, and of them, 265 died
140 during the neonatal period. Refusal is rare and the community is always been supportive of icddr,b
141 activities, as they get free treatment for diarrhoea from Dhaka hospital. Preterm birth was defined
142 as a livebirth; those born between 28 and 36 weeks of gestation, and sub-categories were very
143 preterm (28 to 31 weeks), moderate preterm (32 to 33 weeks), and late preterm (34 to 36 weeks);
144 those born at 37 or more weeks of gestation were classified as term birth. Deliveries below 28

145 weeks of gestation age were considered either miscarriages or stillbirth, and not included in this
146 analysis.

147 **Data analysis:**

148 First, neonatal mortality was calculated for each week of gestation and for gestation age categories.
149 The relative risk of neonatal death and a 95% confidence interval were calculated using gestational
150 week, while ‘40 weeks’ was used as reference; while for categories of gestation age, term births (37
151 to 42 weeks) used as a reference category. The daily death rate up to the neonatal period was
152 calculated with the number of deaths on a given day for the number of new-borns surviving on
153 that day.

154 The population attributable fraction (percent of deaths that could be prevented if the
155 complications of prematurity could be eliminated) was calculated for neonatal mortality and a 95%
156 confidence interval was calculated by categories of preterm births [31]. The formula for population
157 attributable fraction is-

158 $PAF = P_i(1 - \frac{1}{RR_i})$ P_i is number of deaths per births and RR is the risk ration of i th group.

159 The dependent variables used in this study is neonatal mortality – the probability of dying after
160 birth and before 28 days of life (died or alive). Both bivariate (percent/rate) and multivariable
161 (logistic regression) analyses were performed. The following variables were included in the model:
162 age of women, sex of child, education of women, mother’s working status, number of antenatal
163 checks, complication during delivery, mode of delivery, delivery attended by, and place of delivery
164 as independent variables. Multicollinearity has been tested using the multiple linear regression
165 methods incorporating the variance inflation factor (VIF) and acceptable range (VIF<5.0) included
166 in the final logistic model. SPSS version 20 was used for all analyses.

167 **Results:**

168 A total of 6,989 livebirths were followed for this study 346 livebirths were died during the study
 169 period (Table 1). Among them, most of the mother gave birth at 18-24 years of age (54.6%)
 170 followed by the 25 or more years (36.7%) and only 8.7% women gave birth at their adolescence.
 171 Most of the mother completed 5 or more years of schooling (50.3%) and 28% of mother had no
 172 formal education. During the study, nearly one-fourth of the women had worked outside (26.3%).
 173 Most of the mother gave birth normally (71.3%) and using the unskilled birth attendants (63.7%),
 174 though the hospital delivery is higher than the home delivery (51.4% vs 48.6%). Most of the
 175 mother received 1-3 antenatal care (ANC) visits (47.2%), followed by 4 or more ANC vists
 176 (36.8%) and 16% of the women had not received any ANC visits. Most of the births are term
 177 births (78.3%) and rest of them are preterm births in different categories.

180 Both the numbers of births (0.20% to 1.32%) and the number of deaths (1.51% to 4.91%) were
 181 very low between 28 and 32 weeks of gestation (Table 2). From gestation age 34 weeks, the number
 182 of births started to increase gradually and reached from 255 (3.22%) to 671 (9.60%) at gestation
 183 age 37 and to 1513 (21.65%) at gestation age 39. Then the number of births declined gradually to
 184 385 (5.51%) at gestation age 42. On the other hand, the number of deaths was 12 (4.53%) at
 185 gestation age 34 and increased to 20 (7.55%) at gestation age 37, and to 39 (14.72%) at gestation
 186 age 39, then declined to 12 (4.53%) at gestation age 42 with a peak of 45 (16.98%) at gestation age
 187 40. The relative risks of neonatal mortality were very high at gestation age 31 (4.02 times); however,
 188 with exceptionally high risk at gestation age 28 (9.92 times), followed by gestation age 30 (7.21
 189 times). For gestation age categories 36 to 39 weeks and for categories 41 to 42 weeks, relative risks
 190 were lower than 1.00, which means that mortalities were lower at these ages than those recorded
 191 for gestation age 40 weeks.

197 Table 3 shows the number of births, number of deaths, neonatal death rates, relative risks, and
 198 population attributable fractions by gestation age categories. Both the numbers of births (2.19%
 199 and 3.81%) and deaths (12.08% and 10.57%) were low for gestation age categories of 28-31 and
 200 32-33 weeks, but the number of births (15.71%) and the number of deaths (16.98%) increased
 201 from gestation age category 34-36 weeks, while both the numbers of births (78.29%) and deaths
 202 (60.38%) reached to peak at gestation age category 37-42 weeks. The relative risks showed a similar
 203 pattern, higher at lower gestation age categories and lowest at gestation age category 37-42 weeks.
 204 In fact, the mortality risk of very preterm births was 7.15 times, 3.60 times for moderate preterm
 205 birth, 1.40 times for late preterm birth compared to term birth; for overall preterm birth (less than
 206 37 weeks), the mortality risk was 2.37 times. The population attributable fraction for neonatal
 207 mortality was 14% for very preterm birth, 10% for moderate preterm birth, and reduced to 6%
 208 for late preterm birth. For overall preterm birth, the population attributable fraction was 23%.

216 The probability of death for each category of preterm birth as well as those of term births was very
217 high on the day of birth (Figure 1). For very preterm birth, the probability of death on the day of
218 birth was 0.124, 0.048 for moderate preterm, and 0.024 for late preterm; the probability of death
219 was 0.013 for term birth. However, by the 3rd day of life, the probability of death reduced by 70%-
220 95% for these categories of birth. During 7-28 days of life, the probability of death for term birth
221 was 0.002, 0.016 for very preterm birth, 0.020 for moderate preterm birth, and 0.001 for late
222 preterm birth; however, the number of cases for very preterm and late preterm birth were very
223 few.

226 Table 4 shows regression estimates of neonatal mortality by preterm birth categories. Model-I
 227 included only preterm birth categories, while Model-II included preterm birth categories along
 228 with the selected socio-demographic variables as independent variables. For neonatal mortality,
 229 Model-I shows that the odds of death was 8.90 (CI: 5.84, 13.57; $p < 0.01$) for very preterm birth,
 230 3.98 (CI: 2.60, 6.07; $p < 0.01$) for moderate preterm birth, and 1.42 (CI: 1.01, 1.99; $p < 0.05$) for
 231 late preterm birth compared to term birth. In fact, Model-II improved significantly, the odds of
 232 death changed slightly, 8.66 (CI: 5.63, 13.32; $p < 0.01$), 4.13 (CI: 2.69, 6.34; $p < 0.01$) and 1.48 (CI:
 233 1.05, 2.08; $p < 0.05$) respectively. Among the independent variables considered here, only sex of
 234 child (odds of death was 0.76 for girl (CI: 0.59, 0.99; $p < 0.04$) and mode of delivery (odds of
 235 death was 2.80 for normal delivery (CI: 1.69, 4.64; $p < 0.001$) were found significant in this model.

241 Discussion

242 This study analysed the prospective cohort data for estimating the effects of preterm birth on
243 neonatal mortality in the urban poor (slum) area in Bangladesh. We used two models, where
244 model-I showed the unadjusted effect of preterm birth on neonatal mortality and the model-II
245 reflects it after adjusting other sociodemographic and reproductive factors. We found that every
246 one out of five livebirths were preterm which contributed to 39.% of neonatal deaths. The neonatal
247 mortality rate was high 37.9 per 1000 livebirths in the slum and it varied considerably by different
248 gestational ages. The probability of death for each category of preterm birth (very=0.124,
249 moderate=0.048, and late=0.024) and those of term birth (0.013) were very high on the day of
250 birth; however, by 3rd day of life, the probability of death reduced substantially. Compared to the
251 term neonates, the odds of neonatal mortality were much higher as the gestational age reduces,
252 and the population attributable fraction reduces, respectively.

253 Estimation of gestational age based on reported LMP is usually criticised for inaccurate recall. In
254 our study, the LMP data were collected by female Field Workers who visited each household every
255 three months to collect HDSS routine data, while each eligible woman was asked about their
256 menstruation status secretly. Once conception was confirmed, LMP was recorded and the woman
257 was followed prospectively for pregnancy outcome. Rahman et al. (2019)[32] estimated the
258 gestational age based on LMP of ultrasound-based and LMP collected by female Field Workers of
259 Matlab HDSS, and found that both estimates were close (Cronbach's alpha=0.89). As conception
260 data of urban HDSS is collected following a similar procedure as those of Matlab HDSS, so the
261 urban HDSS data is believed to be of the same quality.

262 Our study found that 21.7% of births were preterm which was close to that recorded (19.4%) by
263 Baqui et al. (2013)[33], and the one recorded (22%) by Mamun et al. (2006)[34] from two different

264 rural areas of Bangladesh. On the other hand, Rahman et al. (2019) [32] recorded a slightly higher
265 level of preterm birth (29%) in Matlab HDSS data than our study for an earlier period (1990-1994),
266 but for the recent period (2010-2014), the level of preterm birth has declined to almost half (11%).
267 Our study has made an important contribution by proving community-based preterm birth data
268 from the slum dwellers.

269 Although a large number of studies have examined socio-demographic differentials of infant and
270 under-five mortality in Bangladesh [35-37], none of these studies have specifically examined
271 mortality differentials among slum dwellers. Recently Razzaque et al. (2022) examined under-five
272 mortality using the same data (HDSS) and found that it varied by the mother's working status, sex
273 of the child, size of the baby, delivery type, presence of complication (s) during delivery, and birth
274 interval [38]. Our current study found almost similar results while pre-term birth was included in
275 the model. Our study indicates that the adolescent women who gave birth to a baby boy by normal
276 delivery had higher risks of neonatal mortality compared to preterm birth. Therefore, raising
277 awareness about late pregnancy and caesarean delivery reduces the risk of neonatal deaths in
278 preterm births. These findings reinforce the importance of awareness and access to reproductive
279 and maternal health care to address the infant mortality in poor urban settlements. Kannaujiya and
280 other found that the having a girl child and c-section had less likely to die in the early neonatal
281 period in India [39].

282 The neonatal mortality rate found in our study was about 80% higher (37.9 vs. 20.7 per 1000
283 livebirths) than that recorded in the Matlab HDSS government area [40]. In our study area, non-
284 use of antenatal care was higher than those in the Matlab HDSS government area (12.0% vs. 6.3%),
285 and a higher level of home delivery (49.0% vs. 37.6%) with large proportion of pregnancy was
286 attended by unskilled birth attendants (24.5% vs. 20.0%) [40, 41]. This has been occurring in the
287 slum although the study area is in proximity to many types of health facilities (public, private, and

288 NGOs). In this regard, WHO and UNICEF jointly proposed that promotion for universal access
289 to antenatal care, skilled birth attendance, and early postnatal care, would contribute to a sustained
290 reduction in maternal and neonatal mortality [42].

291 Our study found that one in five births are preterm (21.7%), while two in five preterm births died
292 (39.6%) during the neonatal period. The neonatal mortality rate was 209.1 (per 1,000 livebirths)
293 for very preterm birth, 105.2 for moderate preterm birth, and 41.0 for late preterm birth. The study
294 also found that the population attributable fraction for neonatal mortality was 23%; which states
295 that if excess deaths of preterm births could be prevented, there would be an almost one-quarter
296 reduction of mortality at the population-level. The population attributable fraction found in our
297 study was slightly lower (23% vs. 33%) than that recorded in another study from a rural area of
298 Bangladesh [33]. The higher attributable fraction documented by Baqui et al. (2008) [22] could be
299 due to that their study area was under the intervention programme to reduce neonatal mortality,
300 where home-based delivery was much higher than our study (91% vs. 48%).

301 The neonatal mortality rate by gestational age gives us insights into the mortality burden for
302 preterm and term births. For very preterm birth, the neonatal mortality was high, but the
303 proportion of death was low; while for moderate and late preterm birth, the neonatal mortalities
304 were low, but the proportion of birth was high. Studies have reported that to improve the survival
305 of the preterm neonates, the need for very preterm birth is quite different from those of moderate
306 and late preterm births [7, 21, 33]. In this connection, Baqui et al. (2008) [22] reported that
307 community-based strategies to manage newborn complications should focus on strengthening
308 referral systems and reducing barriers to care-seeking to reach facilities quickly; however, these
309 authors also mentioned that very little can be done for very preterm birth by community health
310 workers in a rural community setting [7, 33]. In the HDSS neonatal mortality was very high,
311 although slums are in proximity to many health facilities. So, intervention programme could be

312 slightly different than those tested in rural settings. In the slum population, future intervention
313 study can be tested by targeting the pregnant women along with strong referral linkage to facility
314 to ensure care during pregnancy, delivery, and post-partum periods; this might improve survival
315 of the new-borns in general and preterm birth in particular.

316 The strength of the study that data came from HDSS area that maintain high quality data visiting
317 prospectively each households every three months and data collected interviewing the respective
318 women (for conception, delivery, and information of newborn). So, date of occurrence of the
319 event is believed to be fairly accurate. The major limitation is the data of conception based on
320 LMP which is criticised for inaccurate recall; however, our record conception may not be a big issue
321 as sufficient probing is done during the data collection and during following visit it is rechecked.

322 **Conclusions**

323 Although urban slums are in proximity to many health facilities, neonatal mortality is still high in
324 these slums, while a substantial proportion of preterm birth contributed to neonatal deaths. So,
325 pregnant women especially adolescent mother and vaginally delivered in the slum should be
326 targeted, along with strong referral linkage to facility, to ensure care during pregnancy, delivery,
327 and post-partum periods to improve the survival of new-borns in general and preterm birth in
328 particular, in achieving the Sustainable Development Goal 3 for Bangladesh.

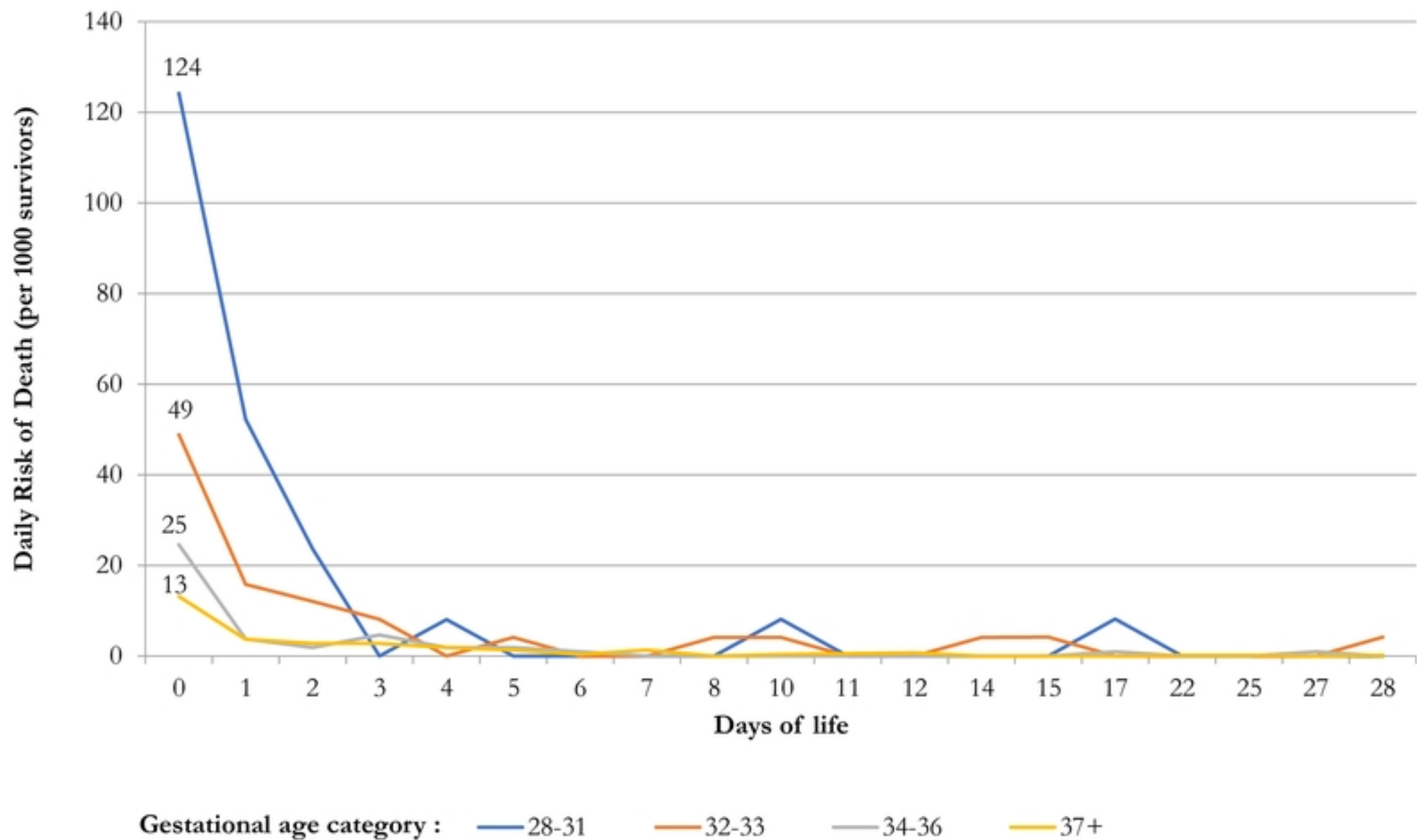
