

Study of the Effect of Intestinal Microbes on Obesity: A Bibliometric Analysis

8 Abstract

9 **Background:** Obesity is a serious public health problem. According to statistics, there are millions
10 obese people worldwide. The intestinal microbiota is the microbiota that lives in the gastrointestinal
11 tract of the human body and can interact with the external environment through diet. Probing and
12 summarizing the relationship between intestinal microbes and obesity has important guiding
13 significance for the accurate control of the research direction and expanding the choice of obesity
14 treatment methods. We aimed to use bibliometrics to qualitatively and quantitatively analyze the
15 published literature and to reveal the research hotspots and development trends in the effects of
16 intestinal microbes on obesity research.

17 **Methods:** We obtained documents from the core collection of Web of Science (WoSCC) from 2013–
18 2022 on February 2nd, 2023. Microsoft Excel, Biblioshiny R language software packages and
19 CiteSpace were employed to collect publication data, analyze publication trends, and visualize relevant
20 results.

21 **Results:** We identified 8888 original research articles on the effects of intestinal microbes on obesity
22 published between 2013 and 2022. China made the highest number of publications on the topic, with
23 3036 publications (34.16%), and the United States with 87065 citations made the greatest contribution.
24 University of Copenhagen was the most prolific institution (209 publications). Patrice D. Cani
25 published the most related articles (97 publications), whereas Peter J. Turnbaugh was cited the most
26 frequently (3307 citations). Nutrients was the journal with the most studies (399 publications, 4.49%),
27 and Nature was the most commonly co-cited journal (6446 citations). The burst keywords “obese
28 patient” and “serum” recently appeared as research frontiers.

29 **Conclusion:** Although China has the largest number of publications, the United States, depending on
30 its largest citations, has become the leader in the effects of intestinal microbes on obesity research.
31 Current research hotspots focus on related mechanisms of the effects of intestinal microbes on obesity
32 and therapeutic methods for obesity with intestinal microbes. Through diet, probiotic preparations and
33 regulation of the intestinal flora, fecal microbe transplantation may have a significant impact on
34 reducing the obesity epidemic. Considering the great potential and application prospects, intestinal
35 microbe applications in obesity therapy will remain a research hotspot in the future.

36 1 Introduction

37 Obesity is a serious public health problem. According to statistics, there are approximately 600
38 million obese people and 1.9 billion overweight individuals worldwide (El-Sayed Moustafa and
39 Froguel, 2013). It is predicted that the number of obese people in the world will reach 1.12 billion by
40 2030 (KellyYang et al., 2008). As far as we know, obesity is not only a change in appearance but also
41 associated with disorders of lipid and glucose metabolism, chronic inflammation, oxidative stress and
42 increased risk of a variety of diseases. According to research, obesity is one of the nonnegligible
43 reasons for cardiovascular disease, diabetes and malignant tumors (BoccellinoDi Domenico et al., 2018;
44 Scherer and Hill, 2016), and it is estimated that more than 80% of the global burden of diabetes and
45 cardiovascular disease will occur in developing countries such as China and India in 2025
46 (MohanGupta et al., 2016). However, the etiology of obesity is not yet completely clear. The increasing
47 prevalence of obesity will not be explained by changes in energy balance alone. Therefore, it is vital
48 for the whole world to determine the formation mechanism of obesity and then explore effective
49 methods to treat it and reduce the incidence and mortality of obesity-related diseases.

50 The intestinal microbiota is a microbiota that lives in the gastrointestinal tract of the human body
51 and can interact with the external environment through diet (AlessandroMarcello et al., 2017). These
52 microbes colonize the intestinal tract through mother-to-child transmission from the prenatal period.
53 The colonization of human intestinal microbes continues after birth and is regulated by factors
54 including gestational age, mode of delivery (natural delivery or cesarean section), diet (breastfeeding
55 or baby food), hygiene and antibiotics. The environment and diet of the first three years of life are
56 essential for the acquisition of adult-like microbiota and the establishment of bacteria-host symbiosis
57 that affect immune and nervous system development. At the age from 2 to 5, the intestinal microbiota
58 will gradually stabilize, and there is no significant difference with intestinal microbiota in adults
59 (RodríguezMurphy et al., 2015). Under normal circumstances, the intestinal microbiota maintains a
60 symbiotic relationship with the human body, and a good symbiotic relationship between them is very
61 important for the maintenance of human health (JandhyalaTalukdar et al., 2015), but instantaneous
62 changes in the intestinal ecosystem can lead to the destruction of the symbiotic relationship between
63 microorganisms and hosts, such as aging, obesity, sedentary lifestyles, and dietary patterns, and the
64 effects of antibiotics can change the intestinal microbiota (NazliYang et al., 2004). Because of the
65 important role of the intestinal ecosystem in maintaining host physiology, its changes can also cause a
66 variety of physiological disorders in the human body, including low-grade inflammation, metabolic
67 disorders, excessive lipid accumulation and loss of insulin sensitivity, in turn leading to changes in the
68 composition of the intestinal microbiota and decreasing the diversity of flora and metabolic pathways
69 (Halmos and Suba, 2016; Sidhu and van der Poorten, 2017), thus increasing the risk of metabolic
70 diseases such as obesity and diabetes (TangKitai et al., 2017). Probing and summarizing the
71 relationship between intestinal microbes and obesity has important guiding significance for the
72 accurate control of the research direction and expanding the choice of obesity treatment methods.

73 Bibliometrics is a discipline that uses mathematics and statistics to quantitatively analyze literature
74 and information. Through quantitative analysis of the subject literature, we can construct its knowledge
75 structure and explore its development trend. At present, it has been widely used in many research fields
76 (GaoDou et al., 2021; LiuGao et al., 2022; WangMa et al., 2020). Overall, this analysis method and
77 the traditional literature review are both based on previous research, summarize the current situation
78 and shortcomings of the research, and finally guide further research. Literature review emphasizes the
79 content of the article, that is, to summarize the aspects and shortcomings of the existing research, and
80 most of them quote the representative papers in the literature according to a preset research context.

81 On the other hand, bibliometric analysis places more emphasis on the analysis of “quantity”. There is
82 no need to analyze the research content of each document in detail but to analyze the number of
83 published documents, the distribution of authors and the relationship of citations in the target field.
84 Most of the included documents are highly quoted. Compared with the traditional literature review,
85 bibliometric analysis can make a more intuitive systematic analysis of all the literature in this field in
86 a visual way, which is helpful for researchers entering a new field to grasp the overall trend of the field.
87 There have been many review articles in the field of intestinal microbes and obesity, but the quantitative
88 analysis in the field is insufficient. Therefore, in addition to briefly summarizing the hotspots in review
89 articles, we use bibliometrics to qualitatively and quantitatively analyze the published literature and
90 intends to reveal the research hotspots and development trends in this field.

91 **2 Materials and methods**

92 **2.1 Data sources and search strategies**

93 Data were obtained from the core collection of Web of Science (WoSCC), a database of Clarivate
94 Analytics. The following search strategies were presented: ((overweight OR obesity OR obes* OR
95 over\$weight) AND (gastrointestin* OR gastro-intestin* OR gut OR intestin*) AND (bacteria OR
96 prebiotic OR probiotic OR microbiot* OR microbiome* OR flora OR microflora)). In the end, a total
97 of 8888 original articles in English were retrieved. All the documents were downloaded as “Full Record
98 and Cited References” and saved as “Bibtex” and “plain text file”. The above data were obtained on
99 2nd February 2023.

100 **2.2 Data analysis and graph acquisition**

101 The corresponding files retrieved from WoSCC were imported into Microsoft Excel (16.66.1),
102 Biblioshiny and CiteSpace (6.1. R6) to perform a bibliometric and visual analysis. Annual publications,
103 country annual publications, and publisher annual publications were analyzed with Microsoft Excel.
104 The Biblioshiny platform provides a web-based graphical interface in the Bibliometrix package, which
105 was used to conduct total citation, average article cited, publications of journal and country
106 collaboration map. CiteSpace is interactive visualization analysis software developed by Professor
107 Chen Chaomei to conduct different types of network analyses, such as country collaboration networks,
108 institution collaboration networks, author collaboration networks, co-cited author collaboration
109 networks, co-cited journal collaboration networks, and keyword co-occurrence, which aid in visually
110 analyzing the knowledge domain and emerging trends. A dual-map overlay was constructed for
111 journals. The parameters of CiteSpace were as follows: time slicing (2013 to 2022), years per slice (1),
112 links (strength: cosine, scope: within slices), selection criteria (g-index: k=5 in country, institution,
113 author collaboration network analysis and keyword co-occurrence), pruning (pathfinder, pruning sliced
114 networks). Cluster labels used keywords by log likelihood ratio (LLR). To identify emerging topics,
115 we detected keywords and references with a strong citation burst.

116 Ethical approval was waived by the local ethical board because the data came from public databases,
117 and no human or animal subjects were involved.

118 **3 Results**

119 **3.1 An overview of the annual growth trend**

120 As shown in Figure 1A, from 2013 to 2022, a total of 8888 English-language articles met our
121 inclusion criteria. The number of annual publications began to exceed 500 in 2016, and only after 3

122 years did the annual publications exceed 1000. The annual number of publications increased from 267
123 in 2013 to 1768 in 2022, with an amazing increase of over sixfold. We further analyzed the annual
124 national output of the 10 most productive countries and regions (Figure 1B). The different colors
125 represent different countries, and the slope represents the speed of annual publication number increase.
126 China ranked first in the number of annual publications, followed by the United States and Spain. The
127 top 10 publishers according to their contribution to the total number of articles about the effect of
128 intestinal microbes on obesity are shown in Figure 1C. The different colors represent different years'
129 publications. Regarding the number of publications, Elsevier (1685) and Springer Nature (1388) far
130 surpassed other publishers, confirming their unsurpassable international position in the publishing
131 industry.

132 **3.2 Country influence and collaboration**

133 In the ten years from 2013-2022, 124 countries or regions participated in the domain of intestinal
134 microbes and obesity. China ranked first with 3036 publications, accounting for 34.16% of all
135 publications, followed by the United States (2356, 26.51%) and Spain (480, 5.40%) (Figure 2A, Table
136 1). Nevertheless, the United States tops the ranking of the most cited countries with a frequency
137 (number of documents) of 87065, followed by China (65250), France (13809), and Canada (13496)
138 (Supplementary Table S1). The country collaboration map shows the overall perspective of countries'
139 and regions' academic cooperation (Supplementary Figure S1). The shade of blue represents the
140 number of articles published, dark blue indicates more publications, and as the color becomes lighter,
141 the publications decreased. The red line represents that there is academic collaboration between the
142 linked two countries. The thicker the line is, the more cooperation two countries have. The United
143 States had the broadest academic associations with other countries or regions, while its collaboration
144 with China was the tightest, followed by Canada. The United States and China both had a frequent
145 connection with European countries. Moreover, among European countries, there was also tight
146 collaboration, but communication among the other countries or regions still needs to be strengthened.

147 There were 179 institutions included in the results of institution analysis. The top 10 institutions
148 mostly came from China (5) and the USA (2), followed by Denmark (1), Belgium (1), and Spain (1).
149 Chinese academic of sciences, the University of Copenhagen and Shanghai Jiao Tong University had
150 the highest total link strength, revealing close cooperation with other institutions (Figure 2B, Table 2).

151 **3.3 Distribution and co-authorship of authors**

152 In this analysis, 16 authors had published at least 21 publications. The 10 most productive authors
153 are listed in Table 3. Most of the authors were from Europe, with Belgium (n=3), followed by China
154 (n=3), Canada (n=2), Sweden (n=1), and France (n=1). Patrice D. Cani (97 publications) and Nathalie
155 M. Delzenne (73 publications), both from Université catholique de Louvain, contributed the top two
156 most publications, followed by Reimer, Raylene A (51 publications) from the University of Calgary.
157 The top two authors maintained the most contact with other research labs, and the cooperation between
158 Patrice D. Cani and Nathalie M. Delzenne was close (Figure 3A). Co-cited authors are shown in Figure
159 3B and Table 4. Peter J. Turnbaugh, and Patrice D. Cani rank the top two, which manifests their
160 centrality in the research field.

161 **3.4 Analysis of journals and co-cited academic journals**

162 As shown in Table 5, the top 10 most productive journals published 2155 publications, accounting
163 for 24.25% of all publications. *Nutrients* (impact factor (IF) 2021, 6.706) published the most articles
164 (399 publications, 4.49%), followed by *Scientific Reports* (IF 2021, 4.997; 339 publications, 3.81%)
165 and *Food & Function* (IF 2021, 6.317; 281 publications, 3.16%). The top three highest co-cited journals
166 were *Nature* (IF 2021, 69.504; 6446 citations), *PLOS ONE* (IF 2021, 3.752; 6247 citations), and
167 *Proceedings of the National Academy of Sciences of the United States of America* (IF 2021, 12.779;
168 5329 citations). The co-citation relationship among different journals was visualized in a co-citation
169 network (Figure 4, Table 6). *Nature* had the highest centrality (0.18), followed by *PLOS ONE* (0.17),
170 which means that the published articles in the two journals were widely recognized and cited by
171 researchers.

172 Supplementary Figure S2 shows the dual-map overlay of journals. The yellow, green, and orange
173 spline waves represent citations made by the source articles. Each spline curve starts with the citing
174 map on the left and points to the cited map on the right. The label represents the subject covered by the
175 journal. The dual-map overlay shows seven main citation paths. The published articles were mostly
176 focused on journals in the fields of medicine, medical, clinical, molecular, biology, and immunology
177 and partly focused on veterinary, animal and science. Cited articles were mostly published in journals
178 in the fields of molecular biology and genetics, and many articles were published in journals in the
179 fields of health, nursing, medicine, environmental, toxicology and nutrition.

180 **3.5 Analysis of keywords**

181 **3.5.1 Co-occurrence analysis**

182 Keywords could accurately reflect the main research point of an article, which has a high
183 condensation in a research field and can directly point to the center of the text. Therefore, a high
184 frequency of keywords represents hot issues in a research field and research hotspots. The keyword co-
185 occurrence graph for the effects of intestinal microbes on obesity is shown in Figure 5. The density
186 value was 0.0457. The ten most frequent keywords were gut microbiota, obesity, inflammation, insulin
187 resistance, intestinal microbiota, health, metabolism, diet, gut microbiome, and metabolic syndrome
188 (Table 7).

189 **3.5.2 Cluster analysis**

190 The clustering analysis of the keywords yielded 288 nodes and 1083 links, with a Q value of 0.4123
191 (>0.3) and an S value of 0.7178 (>0.5), which are two important indicators to evaluate the significance
192 of the clustering effect. There were 8 clusters, including diversity, insulin resistance, short-chain fatty
193 acids, activation, food intake, bariatric surgery, body composition, and nonalcoholic fatty liver disease
194 (Figure 6). “diversity” # 0 was the largest cluster, followed by “insulin resistance” # 1 and “short-chain
195 fatty acids” # 2. Timeline View analysis was conducted to further analyze the keywords of the effects
196 of intestinal microbes on obesity (Supplementary Figure S3).

197 **3.5.3 Burst detection.**

198 CiteSpace was further used to perform burst detection with high frequency and therefore revealed
199 research frontiers and hotspot trends over a period. As shown in Supplementary Table S2, the first 25
200 keywords were sorted by strengths of burst to discover the research hotspots about the effects of
201 intestinal microbes on obesity. Keywords such as “ecology” (strength 28.33), “human gut microbiota”
202 (strength 27.34), “microbiota” (strength 23.44), “diet induced obesity” (strength 21.12), and “irritable

203 bowel disease” (strength 16) were the strongest keywords leading the research boom from 2013-2018.
204 Keywords such as “obese” (strength 9.3) and “serum” (9.69) were the most recent trending keywords.
205 Supplementary Table S3 shows the top 25 references with the strongest citation bursts, which were
206 recognized as a critical milestone and led the development direction of the field for a while.

207 4 Discussion

208 In this study, we performed a bibliometric analysis of the effects of intestinal microbes on obesity-
209 related studies from 2013 to 2022 using the core collection of WoSCC to comprehensively understand
210 global research trends and hotspots and provide references for researchers in this field or those who
211 want to become involved in the field. Based on the above analysis, it is certain that obesity is closely
212 influenced by intestinal microbes.

213 4.1 Global trends in effects of intestinal microbes on obesity

214 The amount of annual scientific production is an important indicator of development in an academic
215 field. In our study, a total of 8888 original articles from 1392 journals met the inclusion criteria. The
216 article annual growth rate reached 22.93%, and the annual growth rate from 2019 to 2020 was the
217 highest. An article published by Lawrence A. David et al., which was the most co-cited, found that an
218 altered diet could lead to a rapid gut microbiome response. The results showed that short-term
219 consumption of diets composed entirely of animal or plant products alters microbial community
220 structure and overwhelms interindividual differences in microbial gene expression (DavidMaurice et
221 al., 2014). The second most cited article was published by Amandine Everard et al. They isolated a
222 mucin-degrading bacterium that resides in the mucus layer, named *Akkermansia muciniphila*. The
223 results showed that the abundance of *A. muciniphila* decreased in obese and type 2 diabetic mice, but
224 prebiotic feeding could normalize *A. muciniphila* abundance. Moreover, high-fat diet-induced
225 metabolic disorders, including fat-mass gain, metabolic endotoxemia, adipose tissue inflammation, and
226 insulin resistance, could be reversed by *A. muciniphila* treatment (EverardBelzer et al., 2013). Although
227 these two articles are about different research, they both proved the correlations between intestinal
228 microbes and the host, which have greatly driven the development of the field.

229 Among the 10 most influential journals in effects of intestinal microbes on obesity research, four
230 were also among the top 10 co-cited journals (Nature, Proceedings of the national academy of sciences
231 (PNAS), Gut, Science). Among these, the IF value of Nature was 69.504 (2021), followed by Science
232 (63.832), Gut (31.795) and PNAS (12.779), indicating their outstanding contributions in the field of
233 effects of intestinal microbes on obesity research. The most frequently co-cited journals were Nature,
234 PLOS ONE, PNAS, and Gut. Notably, three of the top 10 co-cited references were published in Nature,
235 one of them was published in PNAS, and one of them was published in Gut. The main research hotspots
236 were about the mechanism of dietary intervention or human genetics to intestinal microbes. Moreover,
237 richness or kinds of intestinal microbes can also modulate the host’s metabolism, such as obesity or
238 type 2 diabetes. These findings have laid the foundation for a deeper understanding of the regulatory
239 relationship between intestinal microbes and obesity or type 2 diabetes.

240 4.2 Co-authorship networks in effects of intestinal microbes on obesity research

241 The closeness of collaboration between countries/regions, institutions, and authors was assessed,
242 which can help find the laws of scientific research cooperation, guiding more effective scientific

243 research activities, and promoting potential collaborative opportunities for other groups. According to
244 Table 1, China, with 3036 articles, ranks first among the top 10 total publication countries, followed
245 by the United States, with 2356 publications. Notably, the total number of publications in the USA
246 (87065) was greater than that in China (65250) and far greater than that in France (13809), Canada
247 (13496) and the other top 10 most cited countries. The total citations of the United States and China
248 are far more than several other top 10 most cited countries citations combined. Without doubt, the
249 United States and China demonstrate their position as leaders in the field. Notably, Israel with 49
250 publications was the most cited country per article (average article citations, 124.18), suggesting that
251 the quality of research on effects of intestinal microbes on obesity in Israel is very high, the similar
252 story is unfolding in many European countries such as Belgium (average article citations, 107.85),
253 Sweden (average article citations, 103.95), etc., which sets a model for other countries/regions in this
254 research field (Supplementary Table S1, S4). To improve the quality of articles, the reliability of the
255 data source and the rigor of the experimental design may be the first factors affecting the quality of
256 publications, and more attention should be given to these aspects in future studies. According to Figure
257 2B, the bottom right is most dominated by universities from China, while the upper left is most
258 dominated by schools in North America or Europe. Nevertheless, more cooperation between the two
259 clusters could be conducted to catalyze breakthrough progress in research on the effects of intestinal
260 microbes on obesity.

261 Four of the top 10 institutions are based in China, followed by the United States with three, which
262 are thereby maximizing regional advantages and demonstrating the dominance of the United States
263 and China in the field. This may partly explain why China and the United States consistently maintain
264 a high quantity of publications. University of Copenhagen in Denmark was the most productive
265 institution worldwide, followed by Chinese academic of sciences in China, indicating that these two
266 institutions participated in the most collaborations with other institutions worldwide. Although Spain
267 and Canada ranked third and fourth in terms of total publications, only one of the Spanish research
268 institutions ranked in the top 10, indicating a lack of institutions with professional and research stature
269 in terms of the effects of intestinal microbes on obesity research (Table 1-2). The most effective
270 organizations and groups are leading the trends in the effects of intestinal microbes on obesity research;
271 thus, further study at these institutions will ensure continuous future development in this field.

272 **4.3 Basic knowledge and hotspots in effects of intestinal microbes on obesity research**

273 **4.3.1 Basic knowledge**

274 The most frequently cited references possess pivotal academic position in the field. Either positive
275 or negative conclusions from the documents influence others' research direction. In our study, the top
276 co-cited references were used to investigate the knowledge base for the effects of intestinal microbes
277 on obesity research. Among the top 10 co-cited references, we found that second-generation
278 sequencing was a vital technology that relies on its high-throughput characteristic, making it easy to
279 sequence the transcriptome or genome of a species (Schuster, 2008). With the development of
280 sequencing technology, a large amount of data is generated. To make more accurate and full use of
281 sequencing data, software and data analysis platforms have also been developed. An open-source
282 software package named DADA2 is used for modeling and correcting Illumina-sequenced amplicon
283 errors. With the help of this software, researchers could accurately reconstruct amplicon-sequenced
284 communities at the highest resolution, which ensured the accuracy of the research to the greatest extent
285 (CallahanMcMurdie et al., 2016). Another utility tool named QIIME 2 could serve not only as a
286 marker-gene analysis tool but also as a multidimensional and powerful data science platform that can
287 be rapidly adapted to analyze diverse microbiome features (BolyenRideout et al., 2019). These tools
288 help drive rapid development in microbiome research. With the help of sequencing, recent research

289 found that the richness of the human gut microbiome correlated with human metabolic markers.
290 Individuals with a low bacterial richness were characterized by more marked overall adiposity, insulin
291 resistance and dyslipidemia and a more pronounced inflammatory phenotype when compared with
292 high bacterial richness individuals (Le ChatelierNielsen et al., 2013). Correspondingly, with higher gut
293 microbiome gene richness and *A. muciniphila* abundance could exhibit the healthiest metabolic status,
294 particularly in fasting plasma glucose, plasma triglycerides and body fat distribution (DaoEverard et
295 al., 2016). The obesity-associated gut microbial species *Bacteroides thetaiotaomicron*, a glutamate-
296 fermenting commensal, is linked to changes in circulating metabolites, and the abundance of
297 *Bacteroides thetaiotaomicron* is markedly decreased in obese individuals and inversely correlated with
298 serum glutamate concentration (LiuHong et al., 2017). Human obesity is a heterogeneous condition in
299 the context of pathogenesis, pathophysiology and therapeutic responsiveness. Studies of alterations in
300 the genome—the microbial gut metagenome—may define subsets of adult individuals with different
301 metabolic risk profiles, which could contribute to resolving some of the heterogeneity associated with
302 adiposity-related phenotypes (Le ChatelierNielsen et al., 2013). All these findings suggest that gut
303 microbiome richness is a key factor in maintaining the homeostasis of human health.

304 The gut microbiome can rapidly respond to an altered diet, and a dynamic balance can be achieved
305 between intestinal microbes and diet immediately, indicating that not only a long-term diet but also a
306 short-term diet can influence the gut microbiome (DavidMaurice et al., 2014). Weight-loss intervention
307 by bariatric surgery partially reversed obesity-associated microbial and metabolic alterations in obese
308 individuals (LiuHong et al., 2017). This means that external interventions can affect intestinal microbes.
309 Research also proved that transmissible and modifiable interactions between diet and microbiota
310 influence host biology. The transformation correlated with invasion of members of *Bacteroidales* from
311 Ln into Ob microbiota that prevented development of increased adiposity and body mass in Ob cage
312 mates and transformed their microbiota's metabolic profile to a leanlike state. Therefore, it may be
313 possible to intervene in obesity by targeting the gut microbiota (RidauraFaith et al., 2013), and there is
314 already evidence proving this speculation. *Akkermansia muciniphila* is a mucin-degrading bacterium
315 that resides in the mucus layer. Research found that *A. muciniphila* decreased in obese and type 2
316 diabetic mice, and *A. muciniphila* treatment reversed high-fat diet-induced metabolic disorders,
317 including fat-mass gain, metabolic endotoxemia, adipose tissue inflammation, and insulin resistance
318 (EverardBelzer et al., 2013). Pasteurized *A. muciniphila* could enhance its capacity to reduce fat mass
319 development, insulin resistance and dyslipidemia. Moreover, Amuc_1100, a purified membrane
320 protein from *Akkermansia muciniphila*, could improve the gut barrier and partly recapitulate the
321 beneficial effects of the bacterium (PlovierEverard et al., 2017). All these findings are of great driving
322 significance, indicating that it is feasible to use microbes to treat obesity, but more research is needed
323 to support this hypothesis.

324 In addition to the underlying effect of intestinal microbes on obesity, substantial evidence has
325 suggested that intestinal microbes also have an effect on type 2 diabetes, which is also a major public
326 health issue throughout the world. A metagenome-wide association study (MGWAS) was used to
327 identify and validate type-2-diabetes-associated markers and to establish the concept of a metagenomic
328 linkage group, which enabled taxonomic species-level analyses. Type 2 diabetes is accompanied by a
329 decrease in the abundance of some universal butyrate-producing bacteria and an increase in various
330 opportunistic pathogens (QinLi et al., 2012). Conversely, high bacterial richness was related to a
331 reduction in insulin resistance (Le ChatelierNielsen et al., 2013), and *A. muciniphila* treatment could
332 also reverse insulin resistance (EverardBelzer et al., 2013) (Table 8).

333 4.3.2 Research hotspots

334 Keywords with high frequency are usually used to accurately reveal the main research interests and
335 hotspots in the field within a certain period, which help researchers to precisely catch up to the research
336 trends from numerous studies. By analyzing the co-occurrence keywords, “gut microbiota” and
337 “obesity” had the highest frequency and centrality ranking the top two, indicating that the main research
338 interests focused on the relationship between “gut microbiota” and “obesity”. The effects of intestinal
339 microbes on obesity have been supported by several trials, which have all shown that intestinal
340 microbes modulate the metabolism of obesity (EverardBelzer et al., 2013; Le ChatelierNielsen et al.,
341 2013; RidauraFaith et al., 2013). The clustering function was used to show the whole network map.
342 The 8 clusters of keywords presented in this paper illustrate 8 research topics, which to some extent
343 represent 8 significant aspects of the research. Studies in the same cluster might have similar research
344 themes. As shown in Figure 6, the top two largest clusters, “diversity” # 0 and “insulin resistance” # 1,
345 showed that the two topics were still the main themes in the effect of intestinal microbes on obesity
346 research. Simultaneously, a timeline view analysis was conducted to further observe the evolution pace
347 of each cluster and recognize the pivotal research direction through a microperspective. We can clearly
348 observe in Supplementary Figure S3 that the research focus has shifted with time; by 2020, the research
349 on several topics was more balanced. After 2020, the research in the “shot-chain fatty acids” #2 and
350 “activation” #3 directions gradually weakened. The results indicated that gut microbiome research and
351 the treatment of obesity and obesity-related diseases have become the main themes.

352 Furthermore, burst detection was an analytic tool that could effectively capture the dramatic
353 increases in references or keywords in one research field within a specified period; therefore, it served
354 as an important indicator of research hotspots or research frontiers over time. The evolution of the burst
355 keywords over the last 10 years is shown in Supplementary Table S2. According to the ranking by
356 burstiness strength, we observed that the top 15 keywords started to burst in 2013, and “ecology”
357 remained the longest with an end time in 2018. More importantly, the “obese patient” and “serum”
358 burst separately in 2019 and 2020 and continue to burst until now, which indicated that the two topics
359 have received continuous attention in recent years and might be the main trends of research on the
360 effect of intestinal microbes on obesity. Notably, there was a sudden and rapid growth in the number
361 of articles in the field, which might be related to the term “serum”, which was only a new burst in that
362 year.

363 Bariatric surgery is considered the only effective and sustainable weight loss method for obese
364 patients. There is a 50–70% decrease in body weight and fat mass after surgical procedures such as
365 Roux-Y gastric bypass (RYGB) and sleeve gastrectomy (SG) (PaganelliLuyer et al., 2019).
366 Nevertheless, obese patients undergoing bariatric surgery may experience overgrowth of small
367 intestinal bacteria (SabateCoupaye et al., 2017), a condition that snags with weight loss and increases
368 the risk of micronutrient deficiency that appears to be harmful for the configuration and composition
369 of intestinal microbiota (HibberdWu et al., 2017; Mach and Clark, 2017). To maintain the effect of
370 surgery and avoid weight rebound, it is important for obese patients to correct the microbial balance
371 and improve microbiota-host interactions with specific interventions (Aron-WisnewsyPrifti et al.,
372 2019). Research has also shown that the elevated pH resulting from RYGB could ensure the survival
373 of probiotic bacteria, making it possible for surgical patients to receive probiotic therapy (80).
374 Probiotics are a kind of active microorganism beneficial to the host that colonizes the human intestinal
375 tract and reproductive system, and they can improve the host microecological balance and play a
376 beneficial role. Bariatric surgery is often followed by an increase in *Streptococcaceae* and a decline in
377 *Bifidobacteriaceae* (PaganelliLuyer et al., 2019). Proper supplementation with probiotics can
378 compensate for the intestinal microbial imbalance caused by surgery. Moreover, recent research
379 showed that probiotic intervention could increase the levels of peptide YY and GLP-1 in mice (TianLi
380 et al., 2016), reduce the level of intestinal inflammation (TsaiLin et al., 2019), and induce the

381 production of anti-inflammatory cytokines (FolignéParayre et al., 2016). Meanwhile, intestinal peptide
382 signals activate the gut-brain axis, which, in turn, exerts endocrine effects on other organ systems,
383 especially the brain, regulating appetite, metabolism, and other dietary behaviors(Bliss and Whiteside,
384 2018; Hussain and Bloom, 2013; NeyrinckVan Hée et al., 2012; RastelliVan Hul et al., 2020).
385 Consequently, weight loss and reduced insulin resistance occur. However, due to the heterogeneity of
386 experimental techniques, methods and objects, the effectiveness and safety of microbial product
387 intervention in improving obesity against intestinal microbiota need to be further verified, and the
388 mechanism is not clear. Few studies have focused on the development of new functional
389 microbiological products, and most of them have been carried out in mice. Before microbial products
390 are reasonably and effectively treated for obesity, a large number of studies are needed, especially
391 randomized controlled clinical trials.

392 Serum samples are a less invasive biomatrix that reflects the dynamic changes in the metabolome
393 of the whole organism (DunnBroadhurst et al., 2011). The serum metabolome has emerged as a
394 technique that focuses on defining the functional status of host-microbial relationships in biological
395 specimens, which can reflect the dynamic changes in metabolites and explore disease-related
396 metabolites or dysregulated metabolic pathways (metabolome analysis for investigating host-gut
397 microbiota interactions). A top 10 co-cited reference showed the gut microbiome and serum
398 metabolome alterations in obesity that patients after bariatric surgery not only appeared partially
399 reversed obesity-associated microbial but also accompanied by metabolic alterations, including the
400 decreased abundance of *B. thetaiotaomicron* and the elevated serum glutamate concentration,
401 suggesting that it may be possible to intervene in obesity by targeting the gut microbiota (LiuHong et
402 al., 2017). There are complex interactions between the host and intestinal microbes in carbohydrate,
403 amino acid, lipid and nucleic acid metabolism. Intestinal microbes can use their respective metabolites
404 to maintain intestinal viability while affecting the development, homeostasis and function of the host
405 immune system through nutrition- and metabolite-dependent mechanisms (Brestoff and Artis, 2013).
406 Small molecules, such as vitamins, fatty acids, amino acids, and bile acids, regulate host-intestinal
407 metabolic homeostasis by binding to specific host membranes or nuclear receptors (HustedTrauelsen
408 et al., 2017; PutignaniDel Chierico et al., 2016). The references with the highest citation bursts are
409 unique contributions to the field of study. We found that articles related to bile acids have become the
410 most cited articles in recent years (KohDe Vadder et al., 2016; WangLiao et al., 2019). Bile acids
411 directly and rapidly affect the metabolism of bacteria, including membrane damage and disruption of
412 amino acid, nucleotide and carbohydrate metabolism, and short-term exposure to bile acids
413 significantly affects host metabolism by altering the bacterial community structure (TianGui et al.,
414 2020). Another study showed that the gut microbiota also produced many other metabolites with
415 important functions, such as short-chain fatty acids (SCFAs) and bile acids (KrishnanDing et al., 2018).
416 Short-chain fatty acids can directly activate G-coupled receptors, inhibit histone deacetylases, and
417 serve as energy substrates (KohDe Vadder et al., 2016). They thus affect various physiological
418 processes and may contribute to health and disease. According to the above analysis, although notable
419 advances in the effects of intestinal microbes on obesity have been made, our understanding of the
420 interrelationships between them remains descriptive, and we still have numerous gaps to fill.

421 4.4 Strengths and Limitations

422 The bibliometric study conducted a systematic analysis of the basic situation, research hotspots,
423 and trends in effects of intestinal microbes on obesity from a visualization perspective. The results of
424 the bibliometric study were objective and accurate, which could provide a comprehensive guide for

425 academics who are already or wish to work in this field. Nevertheless, there are still some limitations
426 in our study. First, owing to the nature of the CiteSpace software, our data are filtered only from the
427 WoSCC database, which is not sufficiently comprehensive and may lead to data omission. Second, our
428 results were processed by CiteSpace software with certain algorithms, which could lead to bias in some
429 of the results. Finally, only English articles were included from the database and analysis, potentially
430 leading to a source bias.

431 **5 Conclusion**

432 Intestinal microbes possess essential research value and application prospects in obesity therapy.
433 Compared with other review articles, the contribution of the study is evident in its visualized ways to
434 reveal the effect of intestinal microbes on obesity. Research on the effects of intestinal microbes on
435 obesity is increasing rapidly, highlighted by the outstanding contributions of China, the United States
436 and Spain to the development of this field. Current research hotspots focus on related mechanisms of
437 the effects of intestinal microbes on obesity and therapeutic methods for obesity with intestinal
438 microbes. Diet, probiotic preparations and regulation of the intestinal flora, fecal microbe
439 transplantation may have significant impacts on reducing the obesity epidemic. “Obese patient” and
440 “serum” have become the latest burst that have attracted attention in recent years and will serve as the
441 focus of future research. More cooperation and communication between countries and institutions
442 should be strengthened to promote development in this field and benefit more patients with
443 obesity. Data availability statement

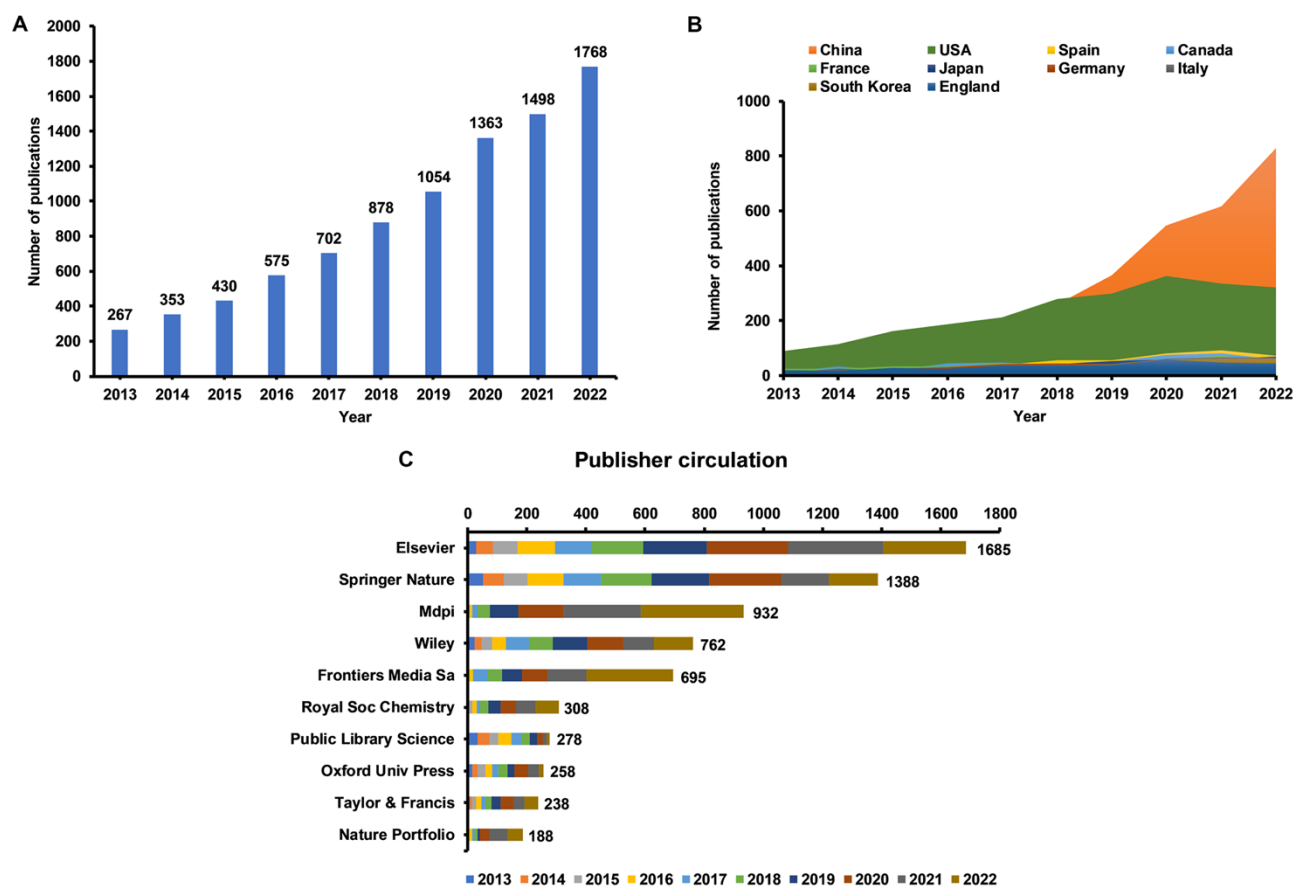

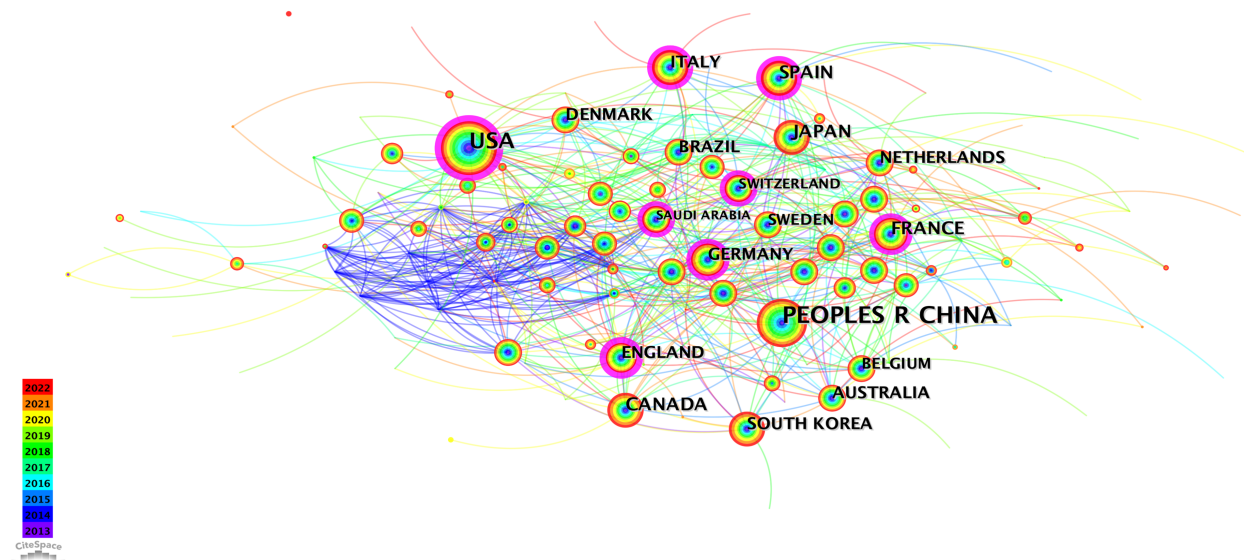

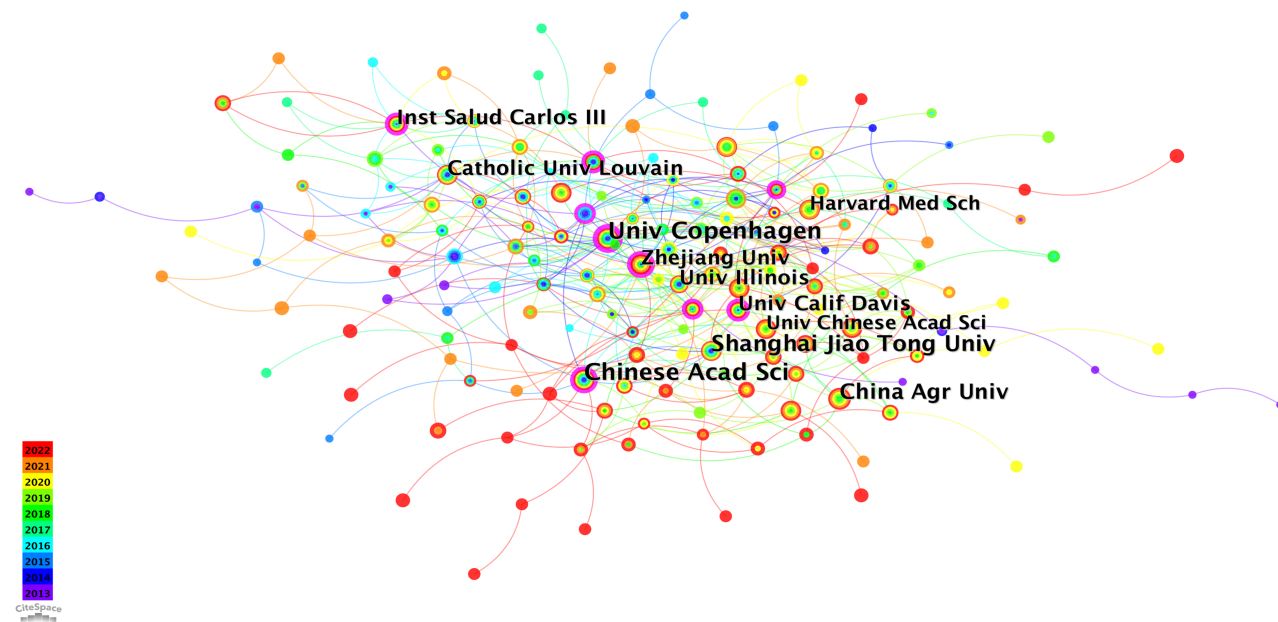


577 FIGURE 1 Global publication trend and country or region analysis for the effect of intestinal microbes on obesity

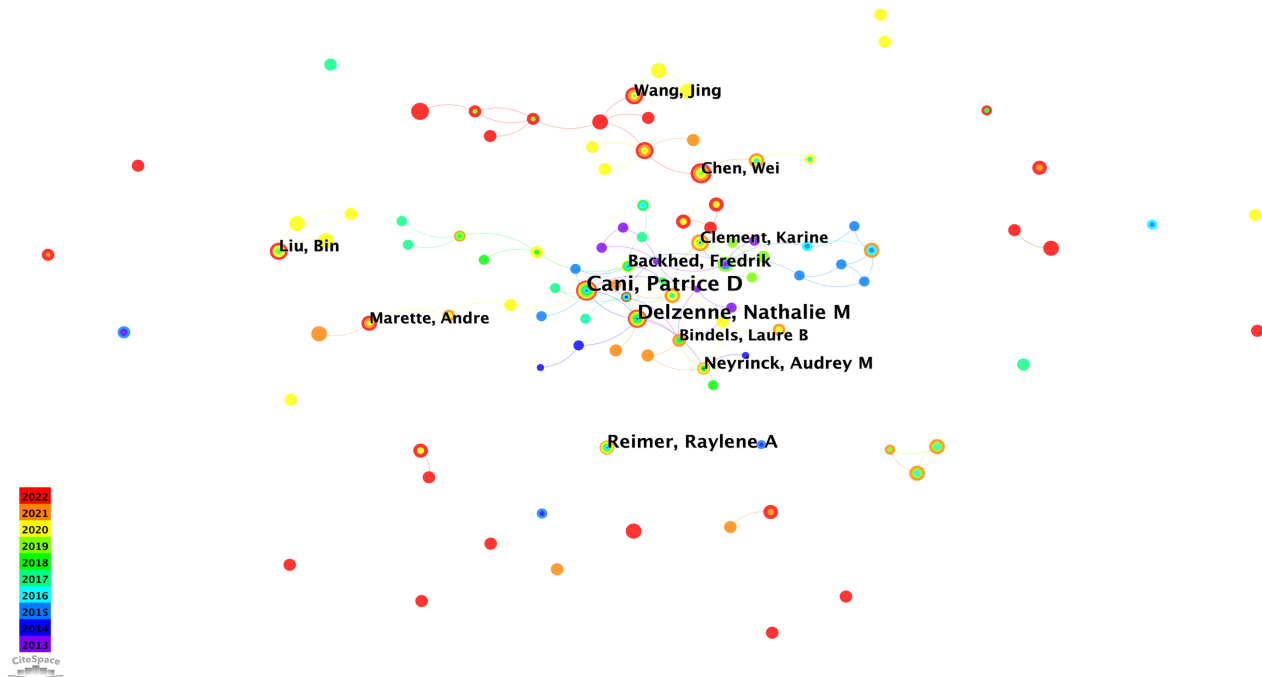

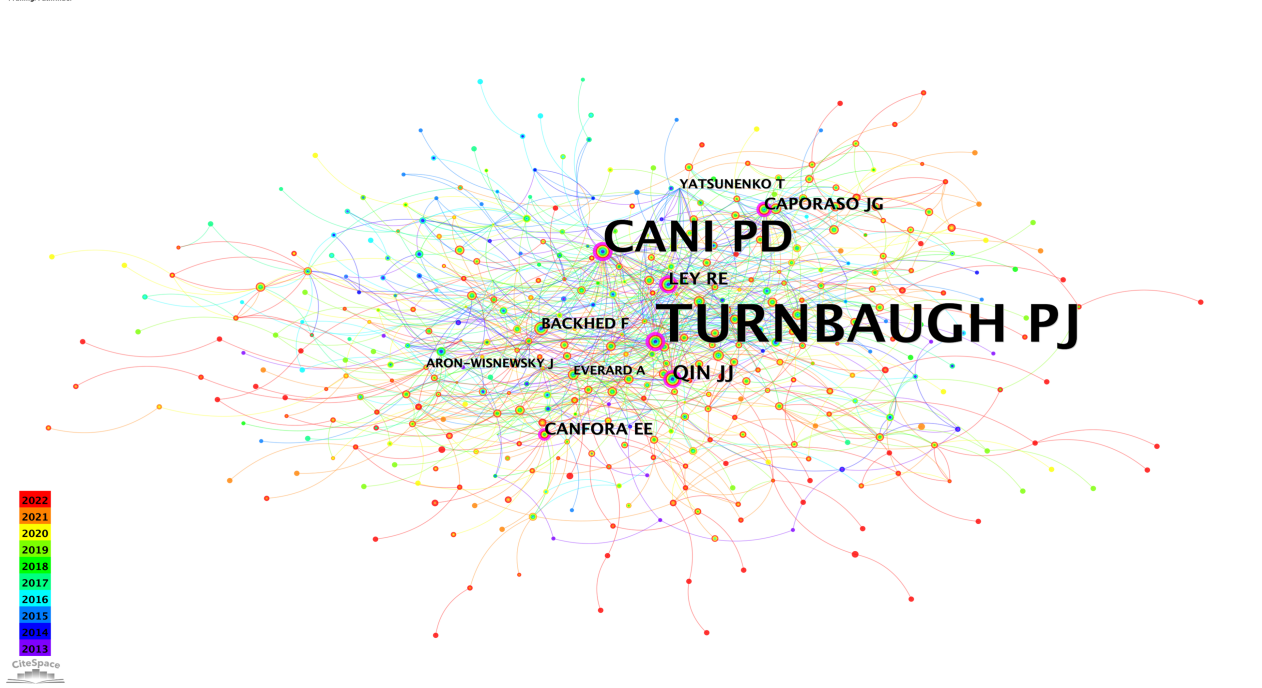


581 FIGURE 2 CiteSpace network visualization map of countries/regions and institutions. (A) CiteSpace network

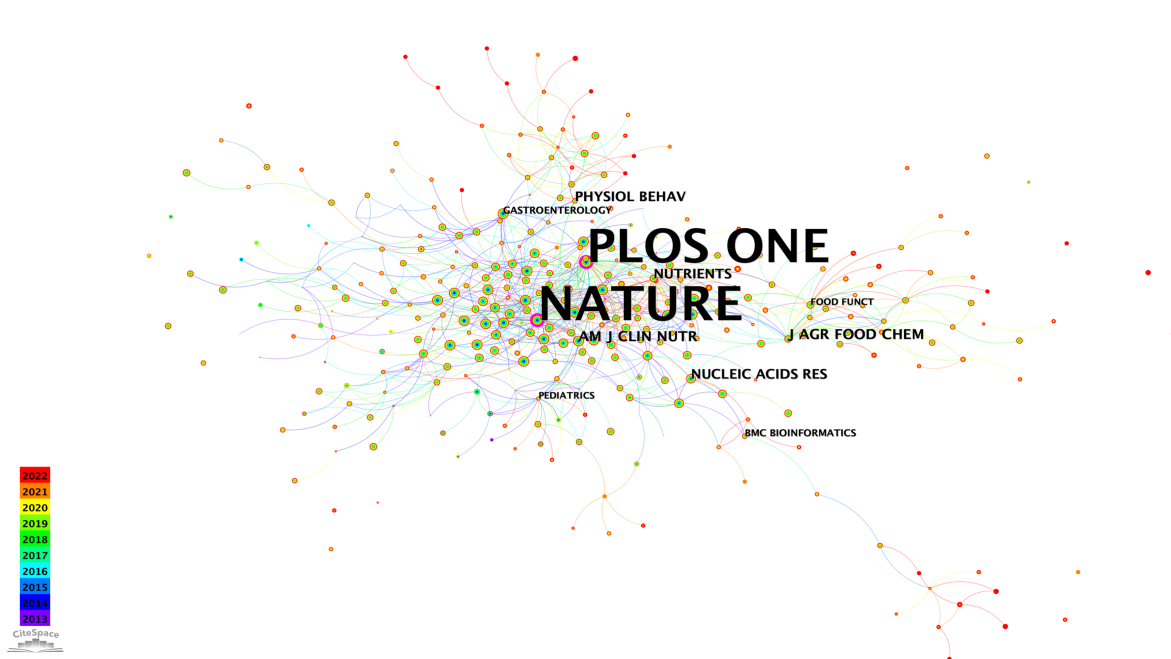

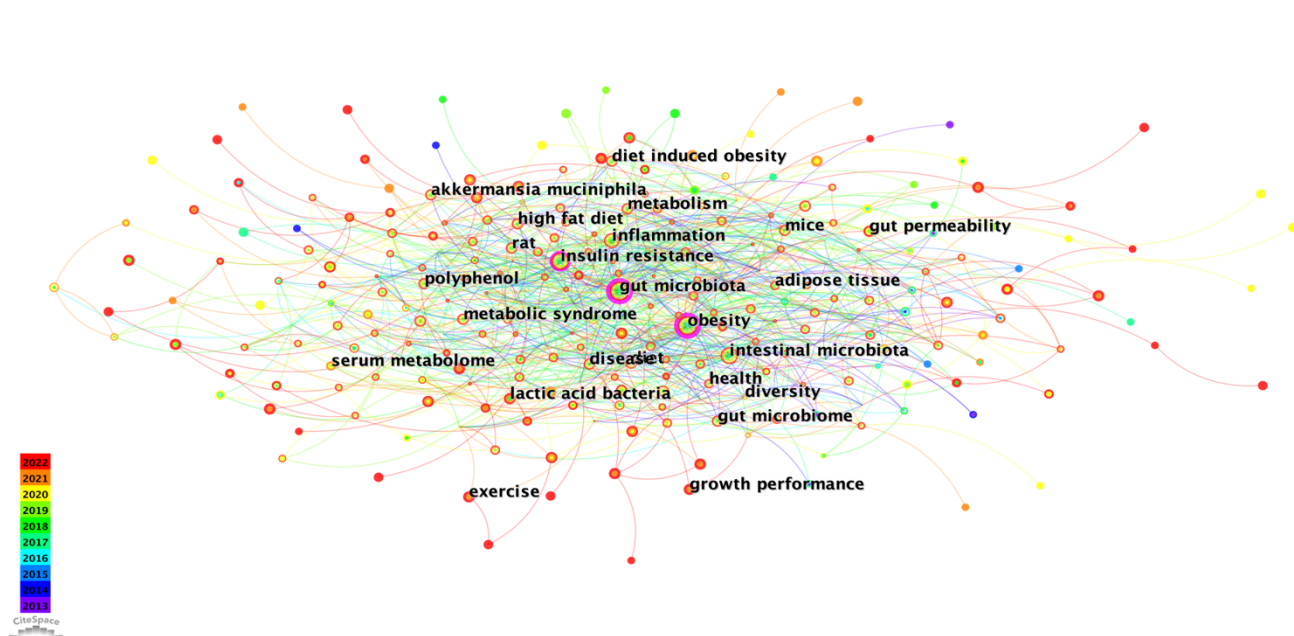
585 FIGURE 3 CiteSpace network visualization map of authors and co-cited authors. (A) CiteSpace network visualization

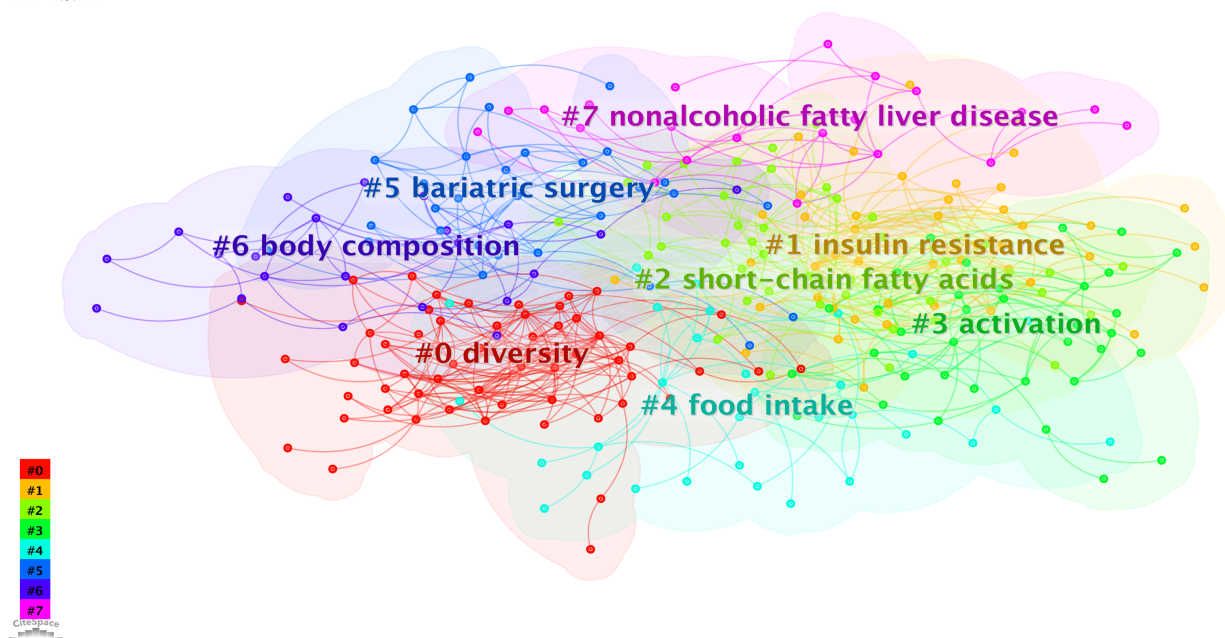
589 FIGURE 4 CiteSpace network visualization map of co-cited journals involved in the effect of intestinal microbes on
