27 Abstract

28 Background

Ethiopia has one of the highest maternal mortality ratios in Africa. Few have examined the quality of labour and delivery (L&D) care in the country. This study evaluated the quality of routine L&D care and identified patient-and hospital-level factors associated with the quality of care in a subset of government hospitals.

33 Materials and methods

34 This was a facility-based, cross-sectional study using direct non-participant observation 35 carried out in 2016. All mothers who received routine L&D care services at government hospitals (n=20) in one of the populous regions of Ethiopia, Southern Nations Nationalities 36 and People's Region (SNNPR), were included. Mixed effects multilevel linear regression 37 modeling was employed in two stages using hospital as a random effect, with quality of L&D 38 39 care as the outcome and selected patient and hospital characteristics as independent variables. Patient characteristics included woman's age, number of previous births, number of skilled 40 41 attendants involved in care process, and presence of any danger sign in current pregnancy. 42 Hospital characteristics included teaching hospital status, mean number of attended births in 43 the previous year, number of fulltime skilled attendants in the L&D ward, whether the 44 hospital had offered refresher training on L&D care in the previous 12 months, and the extent of resources available (measured on a 0-100% scale) to provide quality L&D care as defined 45 46 by the Ethiopian Ministry of Health in 2014. The outcome was measured with a quality of 47 L&D care score (scale 0 to 100) based on adherence to L&D care standards, which had been 48 introduced by the Ethiopian Ministry of Health in 2014.

49 **Results**

50	On average, the hospitals met two-thirds of the standards for L&D care quality, with
51	substantial variation between hospitals (standard deviation 10.9 percentage points). While the
52	highest performing hospital met 91.3% of standards, the lowest performing hospital met only
53	35.8% of the standards. Hospitals had the highest adherence to standards in the domain of
54	immediate and essential newborn care practices (86.8%), followed by the domain of care
55	during the second and third stages of labour (77.9%). Hospitals scored substantially lower in
56	the domains of active management of third stage of labour (AMTSL) (42.2%), interpersonal
57	communication (47.2%), and initial assessment of the woman in labour (59.6%). We found
58	the quality of L&D care score was significantly higher for women who had a history of any
59	danger sign (β = 5.66; p-value = 0.001) and for women who were cared for at a teaching
60	hospital (β = 12.10; p-value = 0.005). Additionally, hospitals with lower volume and more
61	resources available for L&D care (P-values < 0.01) had higher L&D quality scores.

62 Conclusions

Overall, the quality of L&D care provided to labouring mothers at government hospitals in SNNPR was limited. Lack of adherence to standards in the areas of the critical tasks of initial assessment, AMTSL, interpersonal communication during L&D, and respect for women's preferences are especially concerning. Without greater attention to the quality of L&D care, regardless of how accessible hospital L&D care becomes, maternal and neonatal mortality rates are unlikely to decrease substantially.

74 Background

75	Globally, more than 300,000 mothers die annually due to preventable pregnancy and
76	childbirth related problems (1). Almost all (99%) of these deaths occur in low-and
77	middle-income countries (LMICs) (2), of which more than two thirds were in sub-
78	Saharan Africa (SSA). Ethiopia has one of the highest maternal mortality ratios
79	(MMR) in SSA, 412 per 100,000 live births (3). While countries in SSA have
80	experienced substantial reductions in MMR largely due to increased access to skilled
81	birth attendance (4) in the last thirty year, MMR in SSA continues to lag far behind.
82	Ethiopia is not on track to meet Sustainable Development Goals of reducing MMR to
83	less than 70 per 100,000 live births and ending preventable deaths of newborns to at
84	least as low as 12 per 1,000 live births by 2030 (5, 6).
85	
86	While access to skilled birth attendance is essential, newer evidence is emerging on
87	the importance of enhancing the quality of labour and delivery (L&D) care in order to
88	reduce MMR. Half of all maternal deaths and one million newborn deaths can be
89	prevented annually by providing high-quality care before, during, and after childbirth
90	(7-11). Furthermore, qualitative data from Ethiopia (12) have suggested that
91	perceptions of poor quality of hospital-based L&D care can be a major barrier in
92	scaling up the use of available skilled birth attendants, limiting their impact on MMR.
93	
94	Although researchers and policymakers have underscored the importance of quality of
95	L&D care (7), few empirical studies in SSA have examined the quality of L&D
96	services, and those that have (13-15) generally described overall quality without
97	examining the patient- and hospital-level factors that were associated with poor
98	quality of L&D services. The one study we found that used a substantial sample of

99	hospitals to examine factors associated with L&D quality was from Rwanda (12) and
100	is also more than a decade old; this study (12) found no significant patterns in quality
101	of L&D care by hospital-level factors. Thus, the contemporary level of quality of
102	hospital-based L&D care as well as the patient- and hospital-level factors associated
103	with higher L&D care quality in SSA in general and in Ethiopia, specifically, remain
104	largely unknown.

105

106 Accordingly, we sought to describe the quality of hospital-based L&D care as

107 measured by adherence to L&D quality of care standards set forth by the Ethiopian

108 Ministry of Health (16) and to identify patient- and hospital-factors associated with

109 higher quality L&D hospital care in Ethiopia. We used a non-participant observation

study conducted in 20 government hospital in the most populous region of Ethiopia,

111 Southern Nations Nationalities and People's Region (SNNPR). Findings may be useful

112 for designing and targeting intervention to improve quality of care and hence reduce

113 MMR.

Materials and methods

115 Study design

We undertook a non-participant observation study conducted with all normal vaginal deliveries of women 18 years and older occurring in government hospitals (n=20) in the Ethiopian region of SNNPR from November 11 to December 10, 2016. Births were excluded (n=16 births) if the birthing woman had any high-risk factors (e.g., preeclampsia or previous scar), if the neonate was not alive at birth, or if the birthing woman developed complications during the during the first hour following the birth.

122 **Data collection**

123 In each hospital, non-participant observation was undertaken by two experienced,

- 124 professional midwives identified as outside assessors and previously not known to the
- hospital staff. The birthing process for women who were attended between 8:30am
- and 12:30pm and between 1:30pm and 5:30pm and between 6:30pm and 9:30pm were
- 127 observed until one hour postpartum. In high volume hospitals, data collectors
- 128 observed the maximum number of births possible without compromising data quality.
- 129 If only one woman was in active labour, both data collectors observed. If two women
- 130 who were in active labour were being attended simultaneously, the data collectors
- 131 observed one each, and if more than two were occurring simultaneously, the data
- 132 collectors selected two women using a lottery method and observed one each.

133

- 134 Using an observation checklist, data collectors assigned score of '1' if the activity
- 135 were observed and performed according to the recommended standard of care and '0'
- otherwise. At the end of a completed observation and before starting a new one, data

137 collectors reviewed the clinical record of the woman to gather data about her initial

assessments based on the history and physical examination completed before the

admission observation began.

140 Measures

141 **Dependent variable**

The outcome was calculated for each birth as the percentage of all relevant standards fulfilled, with possible values from 0%-100%. The percentage fulfilled was reported for the relevant standards overall as well as within 7 domains. For each hospital, the

145	quality of L&D care score was determined as the mean percentage across all observed
146	births in that hospital, reported for the standards overall and within each of 7 domains.
147	

148 Independent variables

149 Patient-level independent variables included the woman's age, number of previous

births, number of skilled attendants involved in care process, presence of any danger

sign in current pregnancy. Hospital-level independent variables included teaching

152 hospital status, mean number of births in the hospital in the previous year, number of

153 fulltime skilled attendants in the L&D ward on the assessment day, whether the

hospital had offered refresher training on L&D care in the previous 12 months, and

the extent of resources available (measured on a 0-100% scale) to provide quality

L&D care as defined by the Ethiopian Ministry of Health (16). Details on the measure

157 of resources available have been previously described (17).

159 **Data analysis**

160 We used descriptive statistics to summarize both the outcome (overall and for 7

domains) and the patient- and hospitals-level independent variables. We examined the

162 unadjusted associations between the outcome and each independent variable using t-

tests for binary and categorical independent variables and Pearson correlation

164 coefficients for continuous independent variables. Results available from first author.

166 Multivariable regression was employed to estimate adjusted associations between

167 hospital quality of L&D care scores and the independent variables. Mixed effects

168 multilevel linear regression was fitted in two stages to achieve a parsimonious

169	predictive model. The first stage, or null model, was fitted with no explanatory
170	variables using hospital as a random effect. This model was used to determine how
171	being attended in a particular hospital may explain differences in the outcome. The
172	second stage, or the full model, included the patient-and hospital-level independent
173	variables.
174	Intra-class correlation coefficients (ICCs) were also calculated for both the null and
175	full models to explore the amount of variance in the outcome attributable to
176	differences within versus between hospitals. Because of the centering of all
177	continuous independent variables on the grand means, the random term of the
178	intercept at hospital level adjusted for the variance in outcome attributable to the
179	hospital, and appropriately controlled for the clustering of observations by hospital.
180	Interaction terms were created, and their effects tested. Cases with missing data for
181	key variables were excluded from further analysis. P-value <0.05 was used to
182	determine statistical significance of the associations. Data analysis was accomplished
183	using the Advanced Statistics Module of SPSS IBM Statistics.
184	Ethics approval was obtained from the Institutional Review Boards (IRBs) of Jimma
185	University (Ethiopia) and The University of Edinburgh (UK). All participants
186	provided informed consent following the procedure approved by the IRBs before
187	being observed. The authors did not have access to information that could identify
188	individual participants during or after data collection.

189 **Results**

190 Characteristics of the study participants and hospitals

191 A total of 1,351 labouring mothers were approached and gave consent to participate in

the study; 16 were later excluded due to non-normal progression of labour resulting in

an analytic sample of 1,335 women (98.8% of those approached for the study).

194

195 The mean age of women in the study was 25.7 years (standard deviation (SD) = 4.8

196 years), and about two thirds were aged 21-30 years (Table 1). Nearly three quarters

197 (74.2%) had previously given birth to one or two children. More than three quarters

198 (77.1%) of the women had had 3 or 4 antenatal care (ANC) visits for the present

199 pregnancy. Of the 1,335 women in the analytic sample, 38 women (2.8%)

200 encountered one or more danger signs in the present pregnancy. Just more than half

201 (57.8%) of the women were attended at a non-teaching type of hospital. The baby was

alive and in good condition (with no complication) until the end of observation in

203 95.6% (n = 1,275) of the cases, while the rest (n = 58) were alive with complication

204 (Table 1).

deliveries (SD 1293.3) in a hospital. Hospitals had on average 440 fulltime skilled

attendants in the L&D ward, with an average of 22 (SD 9.7) per hospital. A total of

45% of the hospitals had offered refresher training on management of L&D in the past

213 12 months. The average score (17) assessing the extent of resources available to

provide quality of L&D care was 68.2%, with a SD of 15.9 percentage points.

217 Outcome

218 Summary score for quality of L&D care

219 The mean percentage of standards fulfilled across all hospitals was 66.6% (standard

deviation [SD] 10.9 percentage points) (Fig 1). The highest performing hospitals met

221 91.3% of standards; the lowest performing hospital met 35.8% of the standards.

222 Hospitals achieved the highest mean percentage score in the domain of immediate and

essential newborn care practices (86.8%, SD 11.8 percentage points), followed by the

domain of second and third stages of labour 77.9% (SD 20.6 percentage points). The

domain with the lowest mean percentage score was in complying with AMTSL

standards (42.2%, SD 12.2 percentage points), followed by the domains of

interpersonal communication (47.2%, SD 38.4 percentage points) and initial

assessment of the woman in labour (59.6%, SD 15.6 percentage points).

Domain 1: Initial assessment

- substantially across hospitals with the highest fulfilling 74.8% of the standards (SD
- 12.7) and the lowest fulfilling 30.6% of the standards (SD 15.1). The most commonly
- documented aspects of the initial assessment were vaginal examination findings,
- 239 (95.3%), which included checking and recording cervical dilatation, foetal
- 240 presentation, and membrane status and pulse rate (93.8%). In contrast, documentation
- of findings from the general examination was generally less common (58.4%). The
- woman's temperature was recorded for about half (52.5%) of the women. The
- 243 previous obstetric history of complication during previous pregnancies was recorded
- for 6% of the women. Similarly, providers recorded whether the woman had any

245 danger sign in the present pregnancy in only 2.8% of the cases.

Domain 2: Second and third stages of labour

247 In this domain, providers adhered to an average 77.9% of the recommended

standards, SD 20.6 percentage points. The mean percentage scores were as high as

- 249 99.1% (SD 4.1 percentage points) in one hospital and as low as percentage
- 250 points54.0% (SD 21.2 percentage points) for another hospital. Scores were highest
- 251 (92.1%–95.1%) for several tasks including examination of the placenta and
- membranes for completeness, palpation of the uterus every 15 minutes after the
- 253 placenta is delivered to confirm uterine contraction, and examination of the vulval-
- 254 perineal region for possible lacerations. In contrast, scores were far lower for other
- tasks. For example, checking for vaginal bleeding and taking blood pressure and pulse
- rate every 15 minutes after birth were performed in just about half (52.8%) and less

263 **Domain 3: Immediate and essential newborn care**

264 Overall, provides complied to an average 86.8% of the standards for immediate and

- essential newborn care practices, SD 11.8 percentage points (Table 2). Providers
- performed the recommended tasks in 87.6% to 98.7% of the deliveries, and the

267	performance was less variable across hospitals relative to other domains with most
268	hospitals having a mean percentage score above 80%. The vast majority (98.7%) of
269	newborns were weighed and classified and 96.6% were dried with a towel
270	immediately after birth; however, immediate post-partum care was often lacking. For
271	instance, providers helped the mother initiate breastfeeding within the first hour post-
272	partum in 37.6% of the cases, checked the newborn's temperature every 15 minutes in
273	only 21.9% of the cases, and explained the importance of delayed bathing for the first
274	24 hours after birth to just more than half (52.3%) of the women.

Domain 4: Infection prevention (IP) practice

276 Providers adhered to an average 71.8% of the recommended IP standards, SD 16.6

277 percentage points. The scores varied across hospitals, ranging between 90.5% (SD 7.9

percentage points) to 41.3% (SD 11.8 percentage points). Providers correctly wore

279 gloves, disposed sharps and decontaminated instruments and surfaces after procedure

most of the time (96.7%, 91.8% and 96.5%, respectively); however, providers rarely

wore other protective clothing other than gloves (14.4%), and hand hygiene before

examination during labour occurred in only 38.8% of the cases (for more information

from this domain, see **Table 3**).

Domain 5: Use of partograph to monitor labour

288	The overall mean percentage score for correct use of partograph was 76.4%, SD 23.9
289	percentage points. Hospitals varied substantially in this area of practice with providers
290	at one hospital correctly used partograph all the time (100%), while those at another
291	doing so in about half (52.1%, SD 19.4 percentage points) of the cases. In cases for
292	which providers used a partograph to monitor the progress of labour (n=1073), they
293	plotted cervical dilatation on the partograph at least every 4 hours in 91.2% of the
294	cases, but providers recorded temperature at least every 2 hours in only 36.6% of the
295	cases (for more information from this domain, see Table 3).

296 Domain 6: Active management of third stage of labour (AMTSL)

297	Providers met an average 42.4% of the AMTSL standards, SD 12.2 percentage points.
298	Three hospitals performed the highest in this area, scoring 50.5% in this domain (SD
299	0-0.2 percentage points), while the lowest performing hospital scored 24.5% (SD
300	10.9 percentage points). Although 97.2% of the women received a uterotonic, i.e.,
301	oxytocin or ergometrine, and almost all of them received it within three minutes of
302	delivery, and 90.8% within one minute of delivery, controlled cord traction was
303	performed in only 74.1% of cases, and uterine massage was performed in only 42.4%
304	of the observed deliveries.

Domain 7: Interpersonal communication during L&D

- 306 Providers adhered to an average 47.2% of the recommended practices of interpersonal
- 307 communication during L&D, SD 38.4 percentage points. Three hospitals scored
- above 82% (SD ranging between 10.7 and 32.8 percentage points), while another
- three scored below 15% (SD 13.2 34.2 percentage points). Providers gave
- 310 explanations of procedures and what would happen during labour in about two thirds
- 311 (63.1%) of the labours observed, but providers encouraged only about a third (31.4%)

of the women to have a support person present throughout L&D.

Factors associated with quality of L&D care process

In the fully adjusted model with hospital as a random effect (ICC in null model 0.59),

both patient and hospital characteristics were significantly associated with quality of

L&D care (Table 4). Among the patient characteristics examined, the presence of a

317 danger sign in the current pregnancy was significantly (and positively) associated

with quality of L&D care ($\beta = 5.66$; P-value = 0.001). None of the other patient

- 319 characteristics examined—age of the woman, number of previous births, or the
- number of skilled attendants involved in care processes—was significantly associated

321	with quality of L&D care. Among hospital characteristics examined, type of hospital
322	(teaching versus non-teaching), lower hospital volume of births in the previous year,
323	and having more resources available for L&D care were each associated with higher
324	quality of L&D care (P-values < 0.01). Neither the number of fulltime skilled health
325	professionals working in the maternity ward nor provision of refresher training on
326	management of L&D in the past 12 months were significantly associated with quality
327	of L&D care (P-values > 0.05).

341 **Discussion**

342 We found that on average hospitals met only two-thirds of the standards for quality of L&D care, with particularly poor performance in three domains of care: initial 343 assessment of the woman in labour, AMTSL, and interpersonal communication. 344 Importantly, although quality of care was limited overall, one hospital achieved more 345 than 90% of standards met, providing an example of "positive deviance" (18) that 346 could yield information and inspiration for future quality improvement efforts among 347 hospitals in SNNPR. The high-performance levels on examination of the 358 placenta, membranes and vulval-perineal region, and uterine massage yet low 359 performance on monitoring the condition of a mother with vaginal bleeding are 360 findings that are consistent with other studies conducted in SSA (20). Lack of 361 monitoring of vaginal bleeding signifies the potential risk of developing immediate 362 post-partum complications endangering the mother's life. 363


