

1 **Florida Doulas' Perspectives on their Role in Reducing Maternal Morbidity and Health**
2 **Disparities**

23 ***Abstract***

24
25 *Introduction:* Maternal mortality rates continue to rise in the United States. Considerable racial
26 disparities exist, as Black women are 2-3 times more likely to die from pregnancy-related
27 complications than White women. Doulas have been associated with improved maternal
28 outcomes. This study aimed to 1) investigate Florida doulas' perspectives on severe maternal
29 morbidity/mortality, related inequities, and their influence on these areas as well as 2) identify
30 opportunities for actionable change.

31 *Methods:* This qualitative study included seven online, in-depth interviews and seven focus
32 groups with doulas ($n = 31$) in the state of Florida. Interview and focus group guides aimed to
33 investigate how doulas perceive their role in the context of a) maternal morbidity and b) health
34 disparities/inequities.

35 *Results:* Doulas associated maternal morbidity and health disparities with Black pregnant people,
36 attributing racism as a major contributor. Doulas identified their role in mitigating this problem
37 as one that involves: providing positive social surveillance and emotional support, equipping
38 clients with access to education and resources, and championing for advocacy in healthcare
39 settings. Actionable steps utilizing the social ecological model and reproductive justice
40 framework are provided.

41 *Discussion and Health Equity Implications:* Doulas perceived their role as integral to mitigating
42 maternal morbidity and maternal health disparities, particularly in the context of race. Equitable
43 access to doulas for low-income and or minoritized populations may be one key strategy to
44 improve maternal health equity.

45 **Introduction**

46 Pregnant people in the US have not reaped the benefits of the decline in worldwide
47 maternal mortality (MM) rates.¹ The national MM rate rose to 32.9 deaths per 100,000 live births
48 in 2021, compared to a rate of 23.8 in 2020.² Even after controlling for education and
49 socioeconomic status, Black birthing people remain at the highest risk for MM and severe
50 maternal morbidity (SMM), with a MM rate 2.6 times the rate of non-Hispanic White birthing
51 people.²⁻⁵ Comparable trends persist in Florida.^{6,7} Many multilevel factors may explain
52 worsening US maternal outcomes. A systematic review⁸ on social determinants of health
53 reported that insurance status (i.e., covered by Medicaid or not at all), income level, and lower
54 education are associated with higher risk of maternal morbidity and mortality, in addition to
55 demographic characteristics such as Black race and Hispanic ethnicity.

56 Doula support has been associated with improved birth outcomes including fewer
57 cesareans, shorter labors, less birth complications, higher breastfeeding rates, higher rates of
58 birth experience satisfaction.⁹⁻¹² Furthermore, the inclusion of community-based, culturally
59 competent doula support has been associated with fewer maternal complications among
60 marginalized women facing higher rates of MM/SMM.¹¹⁻¹⁵ Historically, doulas were utilized in
61 White, middle/higher class spheres,¹⁶ and low income, as well as other marginalized, populations
62 had limited access to these services.

63 Despite popular discourse on how doula services may mitigate MM/SMM and related
64 inequities,¹⁷⁻²⁰ there are limited data assessing the perspectives of doulas on their perceived role
65 in these areas. Our study aims to 1) investigate Florida doulas' perspectives of MM/SMM and
66 health inequities and their influence on these areas and 2) identify opportunities for actionable
67 change in the context of maternal morbidity and maternal health disparities.

68 **Methods**

69 Online, in-depth interviews and focus groups were conducted with 31 doulas serving
70 Florida families to gather rich data related to their lived experiences in the profession. Interviews
71 and focus groups were chosen for purposes of data triangulation, as focus groups can lead to
72 conformity of one opinion. Therefore, interviews served as a form of data checking to ensure that
73 thematic representations were sound and not being led by focus group dynamics. Seven
74 interviews and seven focus groups were conducted.

75 Interview and focus group guides were developed by all team members and were
76 informed by the social ecological model (SEM; Figure 1). The SEM is based on the theory that
77 an individual's behavior is integrated in a dynamic network of intrapersonal characteristics,
78 interpersonal processes, institutional factors, community features and public policy.²¹
79 Secondly, these guides were developed with the acknowledgement that multiple factors
80 influence health inequities, which is one of the tenets of reproductive justice. Reproductive
81 justice advocates for listening to birthing persons, recognizing autonomy, amplifying their voices
82 to oppose oppression and to regain reproductive control.^{22,23} For this study, we focused on how
83 doulas interpret their role within the context of the SEM.

84 The study was approved as exempt by the University of South Florida and the University
85 of Florida Institutional Review Boards. Convenience and snowball sampling practices were used
86 to recruit doula participants. Flyers advertising the study were shared with community partners
87 and distributed within their networks. The time interval for recruitment and data collection was
88 approximately four months (April-July 2022). Interested participants completed an online pre-
89 screening questionnaire which was used to determine eligibility (e.g., labor and delivery doula
90 experience in Florida, served at least two families in the past year). After providing consent,

91 doula participants participated in an interview or focus group lasting approximately 60 minutes.
92 Participants were compensated for their time with a \$40 digital gift card of their choice to Target,
93 Amazon, or Wal-Mart. Interviews and focus groups were recorded via Zoom and auto-
94 transcribed via artificial intelligence technology.

95 During interviews and focus groups, doulas were asked to provide the first word that
96 came to mind upon hearing the phrase 'maternal morbidity,' to discuss health disparities, and
97 were asked how they felt their skill sets may help to reduce such disparities. The subject of race
98 or racism was not raised by the interviewer. To identify actionable steps for solutions, doulas
99 were asked how they would address the problems they were articulating in their sessions.

100 Team members cleaned transcripts to ensure accuracy. All team members reviewed
101 transcripts for an inductive approach toward codebook generation, following Campbell et al.'s
102 method for coding interview data.²⁴ All team members performed open coding of all transcripts,
103 where a close line-by-line reading of all data occurred, allowing for meaningful words, units, and
104 contexts to emerge.²⁵ Axial coding was performed next, all team members met to combine initial
105 open codes into broader themes, where relevant attributes could be further explored.²⁶ Themes
106 generated reached theoretical saturation (each thematic category became operationalized with no
107 novel information presented in subsequent interviews or focus groups), which is a significant
108 component of qualitative research.²⁷ The first author unitized 10% of the sample of transcripts,
109 and following Campbell et al.'s ²⁴ approach for achieving intercoder agreement, the first and
110 third authors independently coded these data.²⁴ According to Miles and Huberman's accepted
111 levels for reliability,²⁸ the overall intercoder agreement was "very good" at a level of 92.2%. All
112 data were then coded by the first author in NVivo, a qualitative data analysis software, to assess
113 thematic patterns.

114 **Results**

115 *Demographics*

116 Most doulas interviewed identified as female. Most participants identified as birth, post-
117 partum, and full spectrum doulas. Most (69%) of the doulas who participated were between 35
118 and 54 years of age. Three-quarters (75.9%) self-reported their race as White, 17.2% self-
119 reported their race as Black, and 6.9% self-reported their race as other. One-quarter of
120 participants (27.6%) self-reported as Hispanic/Latina. While more than half (58.6%) of the doula
121 participants reported an income greater than \$50,000 per year, nearly all (93.1%) reported
122 serving families who may qualify for government assistance due to economically disadvantaged
123 circumstances. These families may be eligible for Medicaid, WIC, or free/reduced lunch.

124 To provide depth and breadth while privileging doula responses, summaries of thematic
125 findings, relevant SEM level, and relevant participant quotes are provided in Table 1. The names
126 of the doulas that are quoted in Table 1 have been changed to pseudonyms to protect their
127 privacy. In response to the first prompt, **theme one** found that doulas overwhelmingly (98%)
128 associated *maternal morbidity* with *Black or African American pregnant people* without the
129 interviewer prompting for racial disparities. A word cloud was created to visually represent the
130 saturation of responses, with phrases provided most often appearing in larger font (Figure 2).

131 Frustration and sadness were expressed in the conversations surrounding this subject, and
132 as dialogue continued, important conversations began to occur surrounding the race of doulas
133 and their clients. A few doulas reported hearing that Black doulas preferred working with Black
134 clients. Positive sentiment regarding this idea featured the thought that members of a community
135 could connect with their clients, understand them, and educate them in more powerful ways.
136 Other ideas posed by a few White doulas included the assumption that they had been hired by

137 Black clients in the past because their clients felt it gave them greater authority in the hospital
138 setting to have a White doula present in the room.

139 These points led doulas back to conversations surrounding the importance of the doula’s
140 role, which generated **theme two**, with 100% of doulas reporting the importance of championing
141 for *self-advocacy* while providing *advocacy* in the context of health disparities. Doulas reflected
142 on prior instances of systemic racism they had witnessed their clients experience and commented
143 on having to balance their role in these situations as an advocate while still needing to ensure
144 access (particularly in the delivery room). They discussed the importance of educating about
145 self-advocacy above simply providing *their own* advocacy. By teaching clients how to ask their
146 own questions, represent their interests, and convey the needs and rights of their body and their
147 child’s, doulas reported providing a skill set that could be passed on beyond the pregnancy.
148 However, doulas did concede that self-advocacy is a skill that takes practice - and is “easier said
149 than done.” Notably, the importance of advocacy was highlighted around labor and delivery.
150 Doulas did mention White doulas needing to avoid a savior mentality with Black clients. Doulas
151 reported the hospital setting as especially challenging (both for themselves and their Black
152 clients), as many healthcare providers may not accept their presence, leading to complexities in
153 being able to fulfill their role to their utmost potential in these settings.

154 Considering themes one and two, doula responses revealed multiple action steps for
155 implementation. Proposed action steps (with quotes) in Table 3 are also linked to a coordinated
156 SEM level for further exploration. First, doulas addressed (1) their personal responsibilities in
157 being informed on racial disparities regarding maternal health disparities. Beyond “knowing the
158 statistics,” discussions of having a responsibility to be aware of systemic racism were addressed.
159 Some doulas discussed the importance of (2) having doula certification programs tie more

160 systemic racism and implicit bias education into certification curricula so that this information is
161 provided to more doula communities. Some doulas reported smaller organizations as being more
162 inclusive of racial and ethnic diversity efforts. Therefore, some reported that larger organizations
163 may not be as in tune with community needs or outreach, but that these organizations provide the
164 pathway for helping more clients in-need. Many participants reflected diversity of doulas in their
165 communities as an issue. Doulas reported a need for (3) greater public health funding to provide
166 increased support for doula compensation and recruitment of diverse doulas to ensure clients
167 have options. Finally, (4) some doulas recommended that the doula-provider communicative
168 relationship be improved upon by partnering with local hospitals in substantive ways.

169 When doulas were asked about how they perceived their role in helping to reduce
170 maternal morbidity and maternal health disparities, two final themes strongly emerged. **Theme**
171 **three** was classified as *education and resources*, where 92% of doulas described providing
172 access to resources, information, and education. Often, these resources were discussed as relating
173 to childbirth, with the doula helping the birthing person prepare for what to expect during labor.
174 Provision of resources were deemed a necessity for the postpartum period. Additionally, many
175 doulas discussed the importance of resources specific to a client's individual needs and
176 geographic area. A few doulas discussed the significant effort required to put together different
177 versions of targeted resource packets for different client situations, but they did not
178 underestimate the importance of these resources in helping their clients feel more informed.

179 Regarding *education and resources*, doulas reported that it was important that each doula
180 was well-informed on their community and its providers and services (e.g., lactation
181 consultation, mental health services, etc.) for a variety of client profiles (e.g., insured vs.
182 Medicaid recipient). Therefore, a viable action step would be (5) the creation of customizable

183 resources for various client situations, complete with culturally inclusive messaging. Partnering
184 with existing local community organizations is vital. Some doulas commented that (6) a tailoring
185 of resources in hospital settings may be necessary not only to ensure that clients from all
186 populations, especially marginalized groups, are being represented, but to ensure they are being
187 *meaningfully represented*, not featured in a tokenistic way.²⁹

188 Finally, **theme four** revealed that 82% of doulas tied the importance of their role back to
189 the act of consistent, open communication with their clients, classified as *positive social*
190 *surveillance*. Such encounters involved doulas making themselves available for their clients via
191 phone, text, or email and providing greater access than a healthcare provider might be able to. By
192 checking in, listening, and having someone check-in on them after an appointment, doulas
193 reported that the relationship can become stronger over time. Many doulas extended this theme
194 by noting what or was not within their scope of practice, indicating that when a client asks a
195 medical question, they refer to the healthcare provider. Therefore, they identified their role as
196 one with the ability to effectively monitor for social situations and inequities that other members
197 of the healthcare team may not be privy to due to their time constraints or lack of access to the
198 client.

199 Action steps suggested for theme four include helping clients set reminders for
200 appointment times, providing referrals for clients who may need greater levels of assistance
201 based on various social determinants of health (particularly focusing on partnerships with
202 racially and ethnically based community organizations when able), and in instances where
203 implicit bias is perceived (via the act of positive social surveillance), reminding the client of their
204 self-advocacy skills and acting as an advocate when necessary.

206 Discussion

207 Our research found that participants overwhelmingly associated MM and SMM with
208 Black or African American birthing people. Described racial disparities were attributed to
209 systemic racism and implicit bias.^{30,31} In addition to providing education, resources and
210 emotional support, our participants discussed the importance of their role in assisting birthing
211 persons and families by teaching self-advocacy and providing advocacy in the healthcare setting
212 (SEM interpersonal/institutional level). Doulas assist birthing people in navigating their
213 healthcare journeys, processing the healthcare field, overcoming obstacles, and providing
214 valuable information. Where physicians can detect “high risk” situations in ways that doulas
215 cannot, doulas may be able to detect “social high risk” in ways that physicians cannot, due to
216 such acts of *positive social surveillance*. They appreciate their ability to assist birthing people
217 with navigation of a complex healthcare delivery system that may hamper access to care (e.g.,
218 institutionalized formalities and protocols) (SEM institutional level).

219 Doula support during pregnancy, labor, and delivery has been associated with improved
220 outcomes among women facing disproportionately high rates of maternal morbidity³². Doula
221 clients report higher rates of satisfaction with their birth experience and an increased belief in
222 their own ability to influence birth outcomes through behavior change³³. Our previous work
223 demonstrates Black women who are supported by doulas during pregnancy and postpartum
224 report enhanced communication and information sharing as well as improved emotional support
225³⁴. These findings align with results of the current study which indicate that doulas feel their
226 primary role is to support birthing persons during pregnancy, birth, and postpartum (SEM
227 interpersonal level). Conversations focused on doulas having a responsibility to their
228 communities by being aware of systemic racism and implicit bias, utilizing culturally

229 representative educational efforts, and continuing to engage in positive surveillance by paying
230 attention on behalf of their clients while not going outside their scope of practice.

231 Doula responses revealed multiple action steps for implementation (Table 3) including
232 doula certification programs include more on systemic racism and implicit bias education and
233 awareness (e.g., one suggestion for how to begin a foundation for this is Royce et al.'s Special
234 Report on addressing implicit bias in obstetrics and gynecology education).³¹ Regarding need for
235 improved doula-provider communicative relationship, we suggest working toward a “cycle of
236 doula communication,” where there is a clearly defined goals and roles for all stakeholders from
237 the beginning to avoid what may have been a historically adversarial relationship. Health
238 communication experts could provide training programs, scripts, and suggestions for events
239 ranging from monthly webinars/meet-and-greets and brown bag lunches between healthcare
240 providers and doulas.

241 *Limitations*

242 We acknowledge that a limitation of our study is our sample structure. While racially
243 representative of the larger doula profession, it is important that our future work focus on
244 purposive sampling that explore doulas' perspectives from minoritized communities on their
245 ability to provide support for clients, particularly in the context of medical racism. Considering
246 our findings regarding a need for more Black doulas, it is necessary to understand how Black
247 doulas feel they may influence MM/SMM or related disparities.

248 Additionally, an advantage that doulas may have over healthcare providers is their ability
249 to engage with multiple facets of a patient's behavior (e.g., diet, exercise, appointment
250 compliance, testing, etc.), referenced earlier as positive surveillance. When discussing an issue as
251 complex as SMM, doula support for each of these areas certainly play a role and were addressed

252 in our interviews and focus groups but were beyond the scope of this study due to space
253 limitations.

254

255 **Health Equity Implications**

256 Overall, our results revealed that doulas feel they serve an important role in helping to
257 address health inequities in the perinatal period. Many of their goals entail building their
258 professional identity around ways to dismantle these preventable occurrences for socially
259 disadvantaged clients. Notably, our study and its findings align with the Commonwealth Fund's
260 Advancing Health Equity Program. This study supports the foundation's evidence-based
261 approaches for equity-centered maternity care which included the importance of doulas.²⁰

262 Our findings and proposed action steps also have important policy implications. President
263 Biden's 2023 budget includes \$470 million toward investments (e.g., the Healthy Start Initiative)
264 to expand maternal health initiatives aimed at improving access to care to address the crisis of
265 Black maternal morbidity and mortality in the United States.³⁵ Specifically, proposed calls to
266 action from the Health Resources and Services Administration include the implementation of
267 bias training for providers and the hiring, training, certifying, and compensation of community-
268 based doulas in areas with higher rates of disproportionate health outcomes,³⁶ which apply to the
269 findings and recommendations of our study. As the state of Florida ranked 36 out of 50 in 2022
270 for the Commonwealth Fund's scorecard for healthcare, we are at a crucial juncture where
271 support services for families must be championed to help families survive, and ultimately, have
272 the chance to thrive.

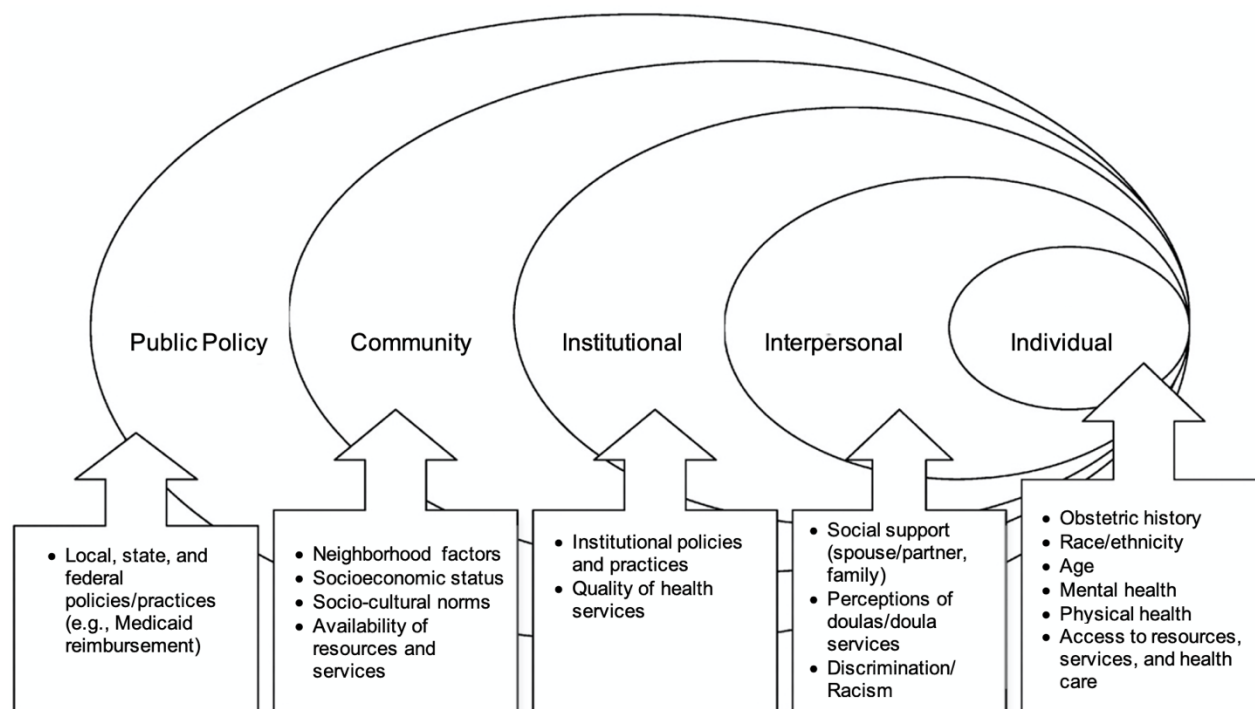

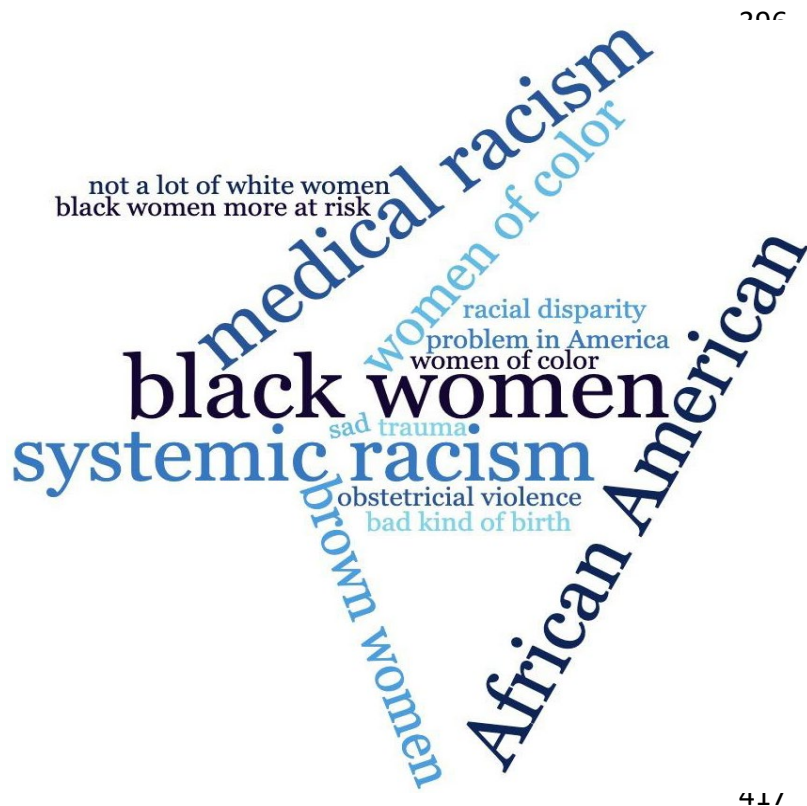
