1	Contribution of central hemodynamics and end-tidal $CO_2$ to cerebrovascular dynamics

## 36 Abstract

37 During aerobic exercise, central hemodynamics and CO2 partial pressure are central to middle cerebral artery blood velocity (MCAv) response. Still, the extent of their contribution is unknown. 38 39 The purpose of this study was to characterize and utilize statistical modeling to determine the contribution of heart rate (HR), mean arterial pressure (MAP), and end-tidal CO<sub>2</sub> (P<sub>ET</sub>CO<sub>2</sub>) 40 dynamics to MCAv dynamics. Three randomized exercise bouts were completed on a 41 42 recumbent stepper at 30-40% (Low), 45-55% (Mod1), and 60-70% (Mod2) of estimated HRmax. A 90-s resting period was followed by 6-min of continuous exercise within the estimated HR 43 ranges. HR, MAP, P<sub>ET</sub>CO<sub>2</sub>, and MCAv exercise dynamics were modeled with a 44 45 monoexponential curve. From this modeling, the baseline ( $_{BI}$ ), time delay ( $_{TD}$ ), time constant (T), and steady-state (ss) responses were determined. Backward AIC linear regression models 46 47 determined contributing dynamics. Seventeen healthy adults completed all exercise bouts (28 ± 6 yrs, 8 females). The time from initiation of exercise to an exponential increase in HR (HR<sub>TD</sub>) 48 49 was significantly longer for Low than Mod2 (p=0.047). The time constant for the rise in HR (HRT) was significantly shorter for Low than Mod1 and Mod2 (p=0.01). The absolute change in HR 50 from baseline to steady-state (HRss) was significantly lower for Low than Mod1 and Mod2 51 52 (p<0.001), and Mod1 was significantly lower than Mod2 (p<0.001). MAP<sub>ss</sub> was significantly 53 lower for Low than Mod1 (p=0.01) and Mod2 (p<0.001). Exercise intensity, HR<sub>TD</sub>, and MAP<sub>TD</sub> 54 accounted for 17% of variation for MCAv<sub>TD</sub> (p=0.01). HR<sub>TD</sub>, P<sub>ET</sub>CO<sub>2TD</sub>, and MCAv<sub>TD</sub> accounted for 21% of variation MCAvt (p<0.01). MCAvt, MAP<sub>SS</sub>, and P<sub>ET</sub>CO<sub>2SS</sub> accounted for 60% of 55 variation for MCAv<sub>SS</sub> (p<0.001). Throughout the MCAv dynamic response pathway central 56 57 hemodynamics and end-tidal CO<sub>2</sub> do not account for most MCAv response until the steady-state 58 phase. Thus, other physiological factors should be considered with assessing cerebrovascular function during aerobic exercise. 59

### 61 Introduction

62 It has been established that aerobic exercise is good for brain health through adaptations of the vascular system [1, 2]. The recent application of a dynamic cerebrovascular 63 modeling technique can determine the response pathway during aerobic exercise [3] and may 64 65 be valuable for understanding the underlying mechanisms contributing to cerebrovascular 66 health. This modeling technique is attainable because of utilizing beat-by-beat and breath-by-67 breath physiological measures during exercise [4]. In addition to middle cerebral blood velocity (MCAv), the dynamic modeling can be applied to heart rate, mean arterial pressure, and end-68 69 tidal CO<sub>2</sub> partial pressure.

70 Previous investigations have established the MCAv dynamic response during aerobic 71 exercise in healthy adults across the aging spectrum [5-7] and in clinical populations, such as 72 stroke [8, 9]. This technique has revealed that MCAv increases exponentially following the onset of exercise and is a method for identifying unique age- and disease-specific profiles. Evidence 73 74 suggests MCAv increases from rest during low to moderate-intensity exercise, with the amplitude greatest during moderate-intensity exercise [5]. Additionally, MCAv amplitude is 75 negatively associated with age and positively correlated with estimated VO<sub>2</sub>max [5]. Within older 76 77 adults, the time delay is significantly longer (i.e., slower) than in young adults [6], and elevated 78 cerebral resistance in older adults attenuates the MCAv response compared to older adults with 79 normal cerebral resistance [7]. Lastly, compared to healthy older adults, individuals post-stroke 80 have a significantly lower MCAv amplitude in both hemispheres [8].

Central hemodynamics and end-tidal CO<sub>2</sub> partial pressure are central to the middle
cerebral artery blood velocity (MCAv) dynamic response during acute aerobic exercise.
However, there is still a lack of understanding of the central hemodynamic and end-tidal CO<sub>2</sub>
partial pressure dynamics and how their responses contribute to MCAv dynamics during aerobic
exercise.

86	This investigation aimed to characterize and assess the contribution of exercise
87	intensity, central hemodynamics (i.e., heart rate and mean arterial pressure), and end-tidal $CO_2$
88	partial pressure dynamics to MCAv dynamics during acute bouts of aerobic exercise in young,
89	healthy adults. We hypothesize that heart rate will significantly contribute to the initiation of
90	exercise, but that mean arterial pressure and end-tidal $CO_2$ will be significant contributors during
91	the steady-state phase. Additionally, we explored exercise dynamics within males and females.

93 Materials and methods

### 94 Study design

The experimental protocol consisted of three separate, 6-min bouts of exercise. The order of the exercise bouts was randomized using a random number generator. All data were collected during a single visit to the laboratory. Data were collected between October 2016 and September 2021, and data were assessed for this investigation in March 2022.

### 100 Participant criteria

Participants were screened using our established inclusion/exclusion criteria [3]. Inclusion criteria were: 1) the ability to perform repeated bouts of exercise and 2) the ability to travel to the University of Kansas Medical Center for testing. Exclusion criteria were: 1) inability to acquire a middle cerebral artery transcranial Doppler ultrasound (TCD) signal, 2) inability to perform the alternating leg movements on the seated recumbent stepper, 3) diagnosis of any neurological conditions such as multiple sclerosis, 4) pulmonary disease, or 5) diagnosis of myocardial infarction or heart failure.

108 Participants were asked to abstain from food for two hours [10], caffeine for a minimum 109 of 6 hours [11], and vigorous exercise for 12 hours [6] before testing. Female participants were verbally questioned regarding menstrual status. We did not directly assess hormone levels, but
females exercised during their menstrual cycle's early follicular phase (Days 1-7) [6].
The research was conducted following the principles embodied in the Declaration of
Helsinki and following local statutory requirements. The University of Kansas Medical Center
Human Subjects Committee approved all experimental procedures (IRB number
STUDY00003176). Institutionally approved written informed consent was obtained before
participation.

### **118** Recumbent stepper familiarization

The Karvonen method was used to determine the appropriate heart rate range for each 119 exercise intensity (HR range = [% exercise intensity (age-predicted HRmax - HRrest)] + HRrest) 120 [3, 12]. Participants were familiarized with the prescribed rate of 120 steps per minute. The 121 122 target work rate was determined by setting the initial resistance to 40 watts and then increasing 10 watts every 30 seconds. Once the target heart rate was achieved for the first intensity and 123 124 maintained for one minute, watts were increased progressively until the target heart rate for the second intensity was achieved and maintained, and then again until the target heart rate for the 125 126 third intensity was achieved.

### 128 Instrumentation

After familiarization, participants were instrumented with (1) a standard 5-lead ECG (Cardiocard, Nasiff Associates, Central Square, NY, USA) with lead II continuously recorded, (2) a finger hemodynamic monitoring system (Finometer, Finapres Medical System, Netherlands), used to measure beat-by-beat arterial pressure, (3) a brachial oscillometric blood pressure cuff (Tango M2 Stress Test Monitor, SunTech Medical, Inc., Morrisville, NC, USA) placed on the contralateral arm to the Finapres and used for comparison to ensure accuracy, and (4) expired

135 CO<sub>2</sub> was continuously measured by a nasal cannula connected to a CO<sub>2</sub> capnograph (BCI

136 Capnocheck Sleep 9004 Smiths Medical, Dublin, OH, USA) [3].

Transcranial Doppler ultrasound (TCD, 2 MHz probes; Multigon Industries Inc., Yonkers,
NY, USA) measured MCAv with probes on the right and left trans-temporal windows. A MuellerMoll probe fixation device held the ultrasound probes in place. The TCD signal was optimized
by adjusting the probe angle and depth settings [3].

### 142 **Exercise bouts**

The exercise consisted of three different intensities: 30-40% (Low), 45-55% (Mod1), and 60-70% (Mod2) of age-predicted heart rate max (HRmax) [12]. The intensities of the three exercise bouts were kept below the ventilatory threshold (i.e., anaerobic threshold) [12]. It has been previously established that during vigorous-intensity exercise above the ventilatory threshold, CO<sub>2</sub> plays a greater role than the hemodynamic responses and decreases MCAv [13, 14].

The baseline recording lasted 90-s, followed by 6-min of continuous exercise within the target HR range. The Borg Scale was used to measure the participants' rating of perceived effort or exertion (RPE) during the exercise bout [15]. Participants were asked to rate their perceived exertion on a scale of 6 to 20 immediately following the exercise. To ensure participants returned to a rested state, participants remained seated for a minimum of 10 minutes or until heart rate, blood pressure, and end-tidal CO<sub>2</sub> partial pressure returned to resting values before the next bout started [3].

### 157 Data acquisition

All variables were sampled at 500 Hz and interpolated to 2.0 Hz. Data with R-to-R intervals greater than 5 Hz or changes in peak MCAv greater than 10 cm s<sup>-1</sup> in a single cardiac

- 160 cycle were considered an artifact and censored. Three-second averages were calculated and
- smoothed with a 9-second sliding window average [3].

### **163 Dynamic modeling**

- 164 Heart rate (HR), mean arterial pressure (MAP), end-tidal CO<sub>2</sub> (P<sub>ET</sub>CO<sub>2</sub>), and MCAv
- 165 dynamics were modeled with a monoexponential curve [16]. A custom-written script within R
- version 4.1.0 and the nls function package (R Core Team, Vienna, Austria) was used to model
- the exercise response [16]. R scripts and data related to this manuscript are available from the
- 168 corresponding author upon reasonable request.
- 169 From this modeling, we were able to determine baseline  $(_{BL})$ , time delay  $(_{TD})$ , time
- 170 constant (T), and steady-state (SS) responses (Table 1). BL is the average of 90-s before the
- 171 onset of exercise. TD is the time delay preceding the exponential increase in the variable of
- 172 interest.  $\tau$  is the time constant or time-to-63% of the peak. <sub>SS</sub> is the absolute change from <sub>BL</sub> to
- the 90-s average of steady-state exercise (3 to 4.5 minutes) [3].

### **177 Statistical Analysis**

178 Parametric (one-way ANOVA) or non-parametric (Kruskal-Wallis) tests were completed 179 to compare variables following a visual inspection of Q-Q plots and the Shapiro-Wilk test. For

180 post-hoc comparisons, Bonferroni correction was used for parametric comparisons, and the

- 181 Dunn test was used for non-parametric comparisons.
- 182 For evaluation of the contribution of central hemodynamics and P<sub>ET</sub>CO<sub>2</sub> to MCAv
- dynamics, a backward stepwise Akaike Information Criterion (AIC) linear regression model
- 184 selection was completed. The models included exercise intensity, the preceding dynamic
- factors, and the equivalent dynamic factors. For example, the model for  $MCAv_{TD}$  had exercise

intensity,  $HR_{BL}$ ,  $MAP_{BL}$ ,  $P_{ET}CO_{2BL}$ , and  $MCAv_{BL}$ , along with  $HR_{TD}$ ,  $MAP_{TD}$ , and  $P_{ET}CO_{2TD}$ . The

187 same modeling technique was used within sex as well.

188 Data analyses were performed with R version 4.1.0 (R Core Team, Vienna, Austria).

189 Data are presented as mean ± standard deviation unless otherwise noted, and statistical

190 significance was evaluated at  $\alpha$  < 0.05.

### 192 **Results**

### **193** Participant and exercise characteristics

194 Seventeen adults completed all three bouts of exercise (28 ± 6 years of age, 8 females,

195 174  $\pm$  10 cm, 69  $\pm$  12 kg, and body mass index 22.7  $\pm$  3 kg m<sup>-2</sup>).

196 Acquired heart rates during the steady-state phase were all within the estimated HR

197 range (Table 2). Post-hoc comparisons between exercise bouts for HR<sub>SS</sub> were all significantly

different within the total sample (all comparisons p<0.001). Within males, Low HR<sub>ss</sub> was

significantly lower than Mod2 (p<0.001), and Mod1 was significantly lower than Mod2 (p=0.01).

200 There was not a significant difference between Low and Mod1 (p=0.06). Within females,

201 comparisons between exercise bouts for HR<sub>SS</sub> were all different, with HR significantly increasing

between exercise bouts (Low vs. Mod1, p<0.001; Low vs. Mod2, p<0.001; Mod1 vs. Mod2,

203 p<0.01).

204	Watts for Low was significantly lower than Mod2 (p<0.001) for the total sample, but
205	Mod1 was not significantly different than Low (p=0.19) or Mod2 (p=0.25). Within males, Low
206	was significantly lower than Mod2 (p=0.02), but Mod1 was not significantly different than Low
207	(p=0.51) or Mod2 (p=0.35). Similarly, within females, Low was significantly lower than Mod2
208	(p<0.001), but Mod1 was not significantly different than Low (p=0.18) or Mod2 (p=0.08).
209	For RPE, all comparisons were all significantly different, with RPE increasing with bout
210	intensity (Low vs. Mod1, p<0.001; Low vs. Mod2, p<0.001; Mod1 vs. Mod2, p<0.01). Within
211	males, RPE was significantly lower for Low than Mod1 (p=0.03) and Mod2 (p<0.001), but
212	participants did not perceive Mod1 to be significantly easier than Mod2 (p=0.09). Similarly,
213	within females, RPE was significantly lower for Low than Mod1 (p=0.03) and Mod2 (p<0.001),
214	but participants did not perceive Mod1 to be significantly easier than Mod2 (p=0.16).

### 223 Comparison of dynamic factors across exercise bouts

Within the total sample, resting HR (HR<sub>BL</sub>) was not significantly different between exercise bouts. The time to an exponential increase in HR after the initiation of exercise (HR<sub>TD</sub>) for Low was significantly earlier than Mod2 (p=0.047), but no difference between Low and Mod1 (p=0.93) or Mod1 and Mod2 (p=0.07; Table 3). The time to 63%-of-peak (HRT) for Low was significantly slower than Mod1 and Mod2 (p=0.01, p=0.01), but there was no difference in time between Mod1 and Mod2 (p=0.82). The absolute change in response from baseline to steady-state (HR<sub>ss</sub>) for Low was significantly less than Mod1 and Mod2, and Mod1 was significantly lower than Mod2 (all post-hoc comparisons, p<0.0001). MAP<sub>SS</sub> for Low was significantly less than Mod1 (p=0.01) and Mod2 (p<0.0001), but no difference in absolute change between Mod1 and Mod2 (p=0.06). For  $P_{FT}CO_2$  and MCAv, dynamic factors were not significantly different across exercise intensities.

251 Tau (τ), time constant. Low = 30-40%, Mod1 = 45-55%, and Mod2 = 60-70% of estimated

255	Within males, $HR_{BL}$ , $HR_{TD}$ , and $HR_{T}$ were not significantly different across exercise
256	bouts. However, $HR_{SS}$ for Low was significantly lower than Mod1 and Mod2 (p<0.01 and
257	p<0.001), but Mod1 was not significantly lower than Mod2 (p=0.18). Additionally, $MAP_{SS}$ for Low
258	was significantly lower than Mod2 (p<0.01), but no difference in absolute change between Low
259	and Mod1 (p=0.08) or Mod1 and Mod2 (p=0.42). For $P_{ET}CO_2$ and MCAv, dynamic factors were
260	not significantly different across exercise bouts.

271	Similarly, within females, $HR_{BL}$ , $HR_{TD}$ , and $HR\tau$ were not significantly different across
272	exercise bouts. However, $HR_{SS}$ for Low was significantly lower than Mod1 and Mod2 (p<0.01
273	and p<0.001), and Mod1 was significantly lower than Mod2 (p<0.01). Additionally, $MAP_{SS}$ for
274	Low was significantly lower than Mod1 and Mod2 (p=0.04 and p<0.001), and Mod1 was
275	significantly lower than Mod2 (pp=0.04). For $P_{ET}CO_2$ and MCAv, dynamic factors were not
276	significantly different across exercise bouts.

### 300 MCAv dynamics

301	For MCAv <sub>TD</sub> , all baseline and $P_{ET}CO_{2TD}$ factors dropped from the model (Table 4).
302	Exercise intensity remained in the model, but its contribution was not significant. $HR_{TD}$ and
303	$MAP_{TD}$ significantly contributed to $MCAv_{TD}$ , such that the longer $HR_{TD}$ and $MAP_{TD}$ were to their
304	exponential increase after initiation of exercise, the longer the exponential increase in $MCAv_{TD}$ .
305	Exercise intensity, $HR_{TD}$ , and $MAP_{TD}$ accounted for 17% of the adjusted shared variation.
306	Within males, exercise intensity and MAP <sub>BL</sub> , HR <sub>TD</sub> , and $P_{ET}CO_{2TD}$ dropped from the
307	model. Only MCAv_{BL} and MAP_{TD} were significant contributors, with HRBL and $P_{\text{ET}}\text{CO}_{\text{2BL}}$
308	contributing non-significantly. Of the significant contributing factors, a higher MCAv at baseline
309	(MCAv <sub>BL</sub> ) and the longer MAP <sub>TD</sub> was to the exponential increase after initiation of exercise, the
310	longer the exponential increase in MCAv <sub>TD</sub> . $HR_{BL}$ , $P_{ET}CO_{2BL}$ , $MCAv_{BL}$ , and $MAP_{TD}$ accounted for
311	27% of the adjusted shared variation.
312	Within females, MAP <sub>BL</sub> , MCAv <sub>BL</sub> , and $P_{ET}CO_{2TD}$ dropped from the model. HR <sub>TD</sub> and
313	MAP <sub>TD</sub> significantly contributed to MCAv <sub>TD</sub> , such that the longer $HR_{TD}$ and $MAP_{TD}$ were to their
314	exponential increase after initiation of exercise, the longer the exponential increase in $MCAv_{TD}$ .
315	Exercise intensity, $HR_{BL}$ , $P_{ET}CO_{2BL}$ , $HR_{TD}$ , and $MAP_{TD}$ accounted for 37% of the adjusted shared
316	variation.

334 For MCAvt, only TD dynamic factors were included in the model because HRT, MAPT, and PETCO2T all occurred after MCAvt (Table 7). Exercise intensity and MAPTD dropped from the 335 model. HR<sub>TD</sub> remained in the model, but its contribution was not significant. P<sub>ET</sub>CO<sub>2TD</sub> and 336 MCAV<sub>TD</sub> significantly contributed to MCAvT, such that the longer P<sub>FT</sub>CO<sub>2TD</sub> was to the 337 338 exponential increase after initiation of exercise, the longer the time to 63-of-peak (MCAvt). Additionally, the longer MCAv<sub>TD</sub> was to the exponential increase after the initiation of exercise, 339 the less time to MCAvt. HR<sub>TD</sub>, P<sub>ET</sub>CO<sub>2TD</sub>, and MCAv<sub>TD</sub> accounted for 21% of the adjusted shared 340 variation. 341 342 For males, exercise intensity,  $P_{FT}CO_{2TD}$ , and  $MCAv_{TD}$  dropped from the model.  $HR_{TD}$ remained in the model, but its contribution was not significant. MAP<sub>TD</sub> significantly contributed to 343 MCAvt, such that the longer MAP<sub>TD</sub> was to the exponential increase after initiation of exercise, 344 the less time to MCAvt. HR<sub>TD</sub> and MAP<sub>TD</sub> accounted for 48% of the adjusted shared variation. 345

For females, exercise intensity and  $P_{ET}CO_{2TD}$  dropped from the model. HR<sub>TD</sub> remained in the model, but its contribution was not significant. MAP<sub>TD</sub> significantly contributed to MCAvT, such that the longer MAP<sub>TD</sub> was to the exponential increase after initiation of exercise, the longer the time to MCAvT. Additionally, the longer MCAv<sub>TD</sub> was to the exponential increase after the initiation of exercise, the less time to MCAvT. HR<sub>TD</sub>, P<sub>ET</sub>CO<sub>2TD</sub>, and MCAv<sub>TD</sub> accounted for 21% of the adjusted shared variation. HR<sub>TD</sub>, MAP<sub>TD</sub>, and MCAv<sub>TD</sub> accounted for 61% of the adjusted shared variation.

For MCAv<sub>SS</sub>, exercise intensity, all  $\tau$  dynamic factors (except MCAv $\tau$ ), and HR<sub>SS</sub> dropped from the model. All remaining dynamic factors significantly contributed to MCAv<sub>SS</sub>. The longer the time to 63-of-peak (MCAv $\tau$ ), the greater the absolute change in MAP<sub>SS</sub> and PETCO2<sub>SS</sub>; the larger the absolute change in MCAv<sub>SS</sub>. MCAv $\tau$ , MAP<sub>SS</sub>, and PETCO2<sub>SS</sub> accounted for 60% of the

adjusted shared variation.

372	For males, exercise intensity, all $\tau$ dynamic factors, and HR <sub>SS</sub> dropped from the model.
373	All remaining dynamic factors significantly contributed to $MCAv_{SS}$ , such that the greater the
374	absolute change in MAP <sub>SS</sub> and $P_{ET}CO_{2SS}$ , the larger the absolute change in MCAv <sub>SS</sub> . MAP <sub>SS</sub> and
375	P <sub>ET</sub> CO <sub>2SS</sub> accounted for 43% of the adjusted shared variation.
376	For females, HRT, MAPT, and HR $_{\rm SS}$ dropped from the model. Exercise intensity and
377	P <sub>ET</sub> CO <sub>2SS</sub> remained in the model but did not significantly contribute. Like the total sample,
378	MCAvt, MAP <sub>SS</sub> , and $P_{ET}CO_{2SS}$ were all significant contributors. Thus, the longer the time to 63-
379	of-peak (MCAvt), the greater the absolute change in MAP $_{\rm SS}$ and $P_{\rm ET}CO_{\rm 2SS}$ ; the larger the
380	absolute change in MCAv <sub>SS</sub> . MCAv <sub>T</sub> , MAP <sub>SS</sub> , and $P_{ET}CO_{2SS}$ accounted for 78% of the adjusted
381	shared variation.

### 411 **Discussion**

412 This investigation suggests that HR, MAP, and  $P_{FT}CO_2$  contribution varies throughout 413 the MCAv dynamic response pathways during aerobic exercise, and contribution differs within males and females. Time to the exponential increase in HR and MAP are significant contributing 414 factors during the initial response to exercise, but 83% of the variation is still unexplained. 415 416 Continuing into the  $\tau$  phase, MAP is no longer a contributor, but the time to the exponential 417 increase in  $P_{ET}CO_2$  and MCAv is, but 79% of the variation is still unexplained. It is not until the 418 steady-state phase that the MCAv time-to-63% of peak ( $\tau$ ) and the absolute changes in MAP 419 and  $P_{FT}CO2$  contribute most to MCAv<sub>SS</sub> phase, explaining 60% of the variation. This evidence 420 suggests that at the initiation of exercise, other factors beyond these central physiological components play significant roles across the dynamic pathway that explain the dynamic 421 response of MCAv. 422

423 Cardiac regulation, directly and indirectly, affects cerebral vasculature [17-19]. Previous 424 research has reported that changes in cardiac output influence cerebral blood velocity during 425 exercise in healthy young adults [19]. At the onset of dynamic exercise, oxygen consumption 426 increases and continues to increase over the first minute of steady-state exercise and then plateaus as the oxygen uptake and transport match the demand of the tissues. The increase in 427 428 cardiac output is due to an initial increase in stroke volume and heart rate, with both variables plateauing within two minutes of steady-state exercise. Concerning our findings, cardiac output, 429 specifically stroke volume, may significantly contribute to MCAv during exercise initiation [13]. 430 Once cardiac output plateaus in the steady-state phase of the exercise, its contribution may 431

432 lessen, and other factors such as MAP and  $P_{ET}CO_{2TD}$  may contribute more, as seen in our 433 findings of 60% for MCAv<sub>SS</sub>.

Our findings suggest that sexes may differ in central hemodynamic adjustments and 434 adaptations to dynamic exercise [20]. Regarding the sex-related difference in hemodynamic 435 436 response during exercise, it has been found that males have higher systolic blood pressure 437 during exercise than females, probably due to females' blunted sympathetic response and higher vasodilatory state of females [21]. One potentially confounding factor is the fluctuation in 438 estrogens throughout the menstrual cycle, which can impact blood volume, systemic vascular 439 440 resistance, and ventricular functions [22]. As all the females were in the early follicular phase (Days 1-7), we do not believe hormonal factors played a significant role in the variability within 441 females, but it is unclear if this resulted in differences between sexes. The potential role played 442 by autonomic activity and hormone fluctuations should be investigated. Furthermore, the 443 444 potential gender-related hemodynamic difference is the lower maximum level of stroke volume 445 reached during dynamic exercise by women compared to men. The smaller cardiac size due to smaller body may be responsible for the reduced stroke volume and cardiac output often 446 447 reported in females [23, 24]. Central command has been almost completely overlooked by 448 scientists within the cerebrovascular function field, and such considerations of their effects on 449 MCAv should included in future exercise investigations and may explain some of the variation.

Aerobic exercise is commonly used to stress the cardiovascular system, which allows for 450 451 the quantification and evaluation of cardiovascular disease severity. However, this modeling 452 technique could assess cerebrovascular function and disease during aerobic exercise. Declines 453 in cerebral blood velocity are often observed with advancing age and disease. The decline in 454 cerebral blood velocity may be observed at rest but is often enhanced in response to various 455 challenges. They are thought to reflect a deterioration in cerebrovascular reserve, or "the ability 456 of cerebral blood vessels to respond to increased metabolic demand and chemical, mechanical, or neural stimuli." [25] Understanding the dynamic response of associated physiological 457

variables within young adults will allow us to understand responses within aging populations. Because aging and pathology may affect the hemodynamic and  $CO_2$  reactions to exercise, this may also be reflected in the association with the MCAv response. Furthermore, we will be able to investigate how exercise interventions affect the dynamic response of hemodynamics and  $P_{ET}CO_2$  and how their relationship to MCAv changes as a result of training.

We recognize limitations to the present investigation. Although TCD can directly 463 measure cerebral blood velocity, it cannot measure the diameter of a vessel. The current 464 evidence of whether exercise induces changes in MCA diameter is conflicting [26, 27]. Our 465 466 methodology assumes a constant MCA diameter during the exercise transition. However, if the 467 diameter does change, a change is likely to be very slight in larger basal arteries, such as the MCA, and it would not affect blood velocity to a great extent [28]. Within our protocol, we 468 469 increase the watts systematically over the first 30-s of the exercise. Exercise intensity was a 470 non-significant factor at the initiation of exercise, and it may be explained by how we set watts. 471 Despite this finding, we believe this methodology is essential and should be implemented to reduce the participant from eliciting a Valsalva maneuver and altering the hemodynamic 472 473 responses at the initiation of exercise. Lastly, the sample was small, especially within sex 474 groups, and limited to young, healthy adults, and future study comparisons should consider this. These findings provide characterization and novel insight into central hemodynamics 475 and PETCO2's contribution to MCAv dynamics during aerobic exercise. Heart rate, mean 476 477 arterial pressure and end-tidal CO<sub>2</sub> partial pressure contribute little at the initiation of exercise 478 but mean arterial pressure and end-tidal CO<sub>2</sub> partial pressure contribute to most of the MCAv 479 response during steady-state exercise. Further work is necessary to support these findings by 480 investigating other factors, such as cardiac output and sex differences, that help explain the 481 variation in the MCAv response. Furthermore, as we have characterized the contribution of 482 hemodynamics and end-tidal CO<sub>2</sub> partial pressure to MCAv dynamics, an investigation into exercise intervention effects on dynamics is underway. 483
