1 Emerging viruses are an underestimated cause of undiagnosed febrile illness in Uganda

20 SUMMARY

- 21 Background: Viruses that cause acute febrile illness (AFI) in sub-Saharan Africa cause a spectrum
- of disease from mild to life-threatening. Viral infection is often undiagnosed, as routine

23 diagnostics are insufficient to capture the diversity of circulating pathogens.

24

25 **Methods**: 1281 patients with fever of 2-7 days were prospectively recruited from three sites in

26 Uganda as part of the CDC-UVRI AFI Study and screened with enhanced diagnostics. Plasma from

27 233 undiagnosed patients was analysed using metagenomic next-generation sequencing (mNGS).

28 Confirmatory testing was carried out by PCR and serology.

29

30 Findings: Thirty-eight viral pathogens were identified by mNGS in 35/233 (15%) undiagnosed

31 patients including Measles, Hepatitis A/B/E viruses, Human immunodeficiency virus-1,

32 Rhinovirus, Rotavirus-like virus, Human herpesvirus 6B, Human parainfluenza virus 3 and

33 Enteroviruses. Four high-consequence arboviruses were found in six patients; Crimean-Congo

34 haemorrhagic fever virus, Rift Valley fever virus, dengue virus and yellow fever virus. Le Dantec

virus, last reported in 1969, was detected and confirmed by serology in one patient (and a

contact of that patient). The majority of patients (23/30; 76%) diagnosed with an acute viral

37 infection were treated with antibiotics and/or (12/30; 40%) antimalarials.

Interpretation: AFI in Uganda is commonly associated with undiagnosed viral infection, including high-consequence and rarely reported viruses. This highlights an ongoing risk to public health and the need for improved vigilance. MNGS alongside diagnostic serology is a powerful method for clinical surveillance to investigate circulating viral pathogens. Cost-effective diagnostic assays should be adapted according to regional needs for testing.

48 INTRODUCTION

East Africa is a biodiverse region and a hotspot for viral zoonoses. In the last decade, Uganda has 49 reported outbreaks of haemorrhagic fever caused by Ebola (EBOV), Sudan (SUDV), Marburg 50 (MARV), Rift Valley fever (RVFV), yellow fever (YFV) and Crimean-Congo haemorrhagic fever 51 (CCHFV) viruses¹. Many vector-borne viral infections are prevalent in Uganda, and several were 52 described here for the first time, including Zika virus (ZIKV), Semliki Forest virus (SFV), 53 chikungunya virus (CHIKV), O'Nyong Nyong virus (ONNV) and West Nile virus (WNV)². 54 Anthropogenic change, as a result of frequent travel, increasing commerce, and shifting global 55 climate patterns raises the risk of spread within and outside zoonotic hotspots³. Many infections 56 are likely missed due to the scarcity of diagnostic tests, increasing the risk of spread of high 57 58 consequence viruses. Further, they may be misattributed to malaria or bacterial infection, increasing the risk of antimicrobial resistance. In this study, we investigated the occurrence of 59 undiagnosed viral infections as a cause of acute febrile illness (AFI). 60 61 62 AFI is a common cause of presentation to healthcare centres (HC) across sub-Saharan Africa (SSA), despite a significant reduction in malaria prevalence following successful intervention 63 64 campaigns⁴. Communicable diseases are estimated to account for up to 36% productivity losses in SSA⁵. The contribution of viral infection to AFI in Africa is at least 8-60%, likely an under-65 estimate as population studies have relied on traditional diagnostic tests which are limited to 66 selected pathogens^{6–9}. A thorough understanding of the burden of viral disease is essential for 67 implementing prevention strategies by limiting vector-borne transmission, introducing 68 69 vaccination where needed and available, rapid cost-effective diagnostics and treatments. 70 Metagenomic next-generation sequencing (mNGS) allows for unbiased identification of viral 71 genomes in clinical samples, including known and novel pathogens. In this study, we used mNGS 72 to identify viral infections in patients in Uganda presenting with AFI that remained undiagnosed

73 after routine serological and PCR-based assays.

74 METHODS

75 Patients and sampling

1281 patients were recruited prospectively with informed consent into the AFI study from three 76 study sites in Uganda and assigned an anonymized study number, not known to anyone outside the 77 recruitment team at each healthcare provision site; Ndejje HC IV (Wakiso), St. Paul's HC IV (Kasese), 78 79 and Adumi HC IV (Arua) between April 2011 and January 2013 (Figure 1a). Inclusion criteria were >2 years age with (a) a reported fever lasting 2-7 days or \geq 38°C temperature on admission, or (b) 80 symptoms consistent with brucellosis or typhoid fever. Cases with clinical evidence of an alternative 81 diagnoses such as otitis media were excluded. Samples were obtained at presentation (acute sample) 82 83 and 14-21 days later (convalescent sample). Diagnostic assays including serology, blood culture and blood films were carried out to identify and exclude active or recent infection with malaria, typhoid, 84 leptospirosis, rickettsiae, CHIKV, dengue (DENV), WNV, YFV and ONNV. 210 patients remained 85 undiagnosed and acute plasma were retrospectively tested using mNGS. In addition, 23 samples 86 87 were obtained from two outbreaks of febrile illness that occurred within the time period of the 88 study.

89 **Ethics statement**

90 Ethical approval for the AFI study was granted by the Uganda Virus Research Institute (UVRI)

- 91 Research Ethics Committee (GC/127/10/02/19) and the Uganda National Council for Science and
- 92 Technology (HS767).

94 Sample processing and mNGS

95 RNA was extracted from 200μl of plasma using the Agencourt RNAdvance Blood Kit (Beckman

96 Coulter), according to manufacturer's instructions, including DNase treatment at 37°C for 15min.

87 RNA was reverse transcribed using Superscript III (Invitrogen) followed by dsDNA synthesis with

98 NEBNext Enzyme (New England Biolabs). DNA libraries were prepared using LTP low-input Library

99 preparation kit (KAPA Biosystems) as previously described¹⁰. Resulting libraries were quantified

100 with the Qubit 3.0 fluorometer (Invitrogen) and their size determined using a 4200 TapeStation

101 (Agilent). Libraries were pooled in an equimolar ratio and sequenced on the Illumina MiSeq and

102 NextSeq platforms.

104 **Bioinformatic analysis**

105 Raw Fastq files were searched directly for evidence of viral sequences using Diamond BLASTX (Figure S1a)¹¹. *De novo* assembly was carried out using dipspades and contigs were identified 106 using Diamond BLASTX against the nr database¹². Viral hits detected with blastx were confirmed 107 with blastn and mapped to the closest reference genome using *Tanoti*, a mapper developed for 108 109 use with highly diverse viral genomes (github.com/vbsreenu/Tanoti). A diagnosis threshold of 28 nucleotides was estimated as a reliable cut-off following an analysis of all common human viral 110 pathogens and removal of genomic repeat regions, well under the minimum sequence length in 111 our samples (Figure S1b). Maximum-likelihood phylogenetic analysis was carried out using 112 IQTREE and 1000 ultra-fast bootstrap replicates using relevant reference sequences¹³. 113 Uncorrected pairwise-distances were estimated using MEGA 10.0¹⁴. 114

116 Capture ELISA

Rhabdovirus (Le Dantec; LDV and Adumi virus) glycoprotein genes (synthesized by Eurofins 117 118 Genomics) excluding the transmembrane regions (identified using TMHMM and TMpred) were amplified and cloned into the secretory mammalian expression vector pHLSec containing a C-119 terminal 6xHistidine tag^{15,16}. Human embryonic kidney cells (HEK 293T) were maintained in 120 Dulbecco's modified Eagle's medium (DMEM) supplemented with 100IU/ml penicillin, 100µg/ml 121 122 streptomycin, 2mM glutamine and 10% foetal bovine serum. Cells were transfected (Fugene 6, 123 Promega) and cell supernatant containing secreted recombinant glycoproteins was harvested at 124 48-hours and expression confirmed by Western Blotting against 6xHis. ELISA plates (ImmulonHB) 125 were coated with rabbit anti-His antibody overnight and blocked with 2.5% BSA/PBS at 37°C for 1 hour. Cell supernatant containing glycoprotein was added to the wells followed by patient 126 serum, both for 1 hour at 37°C. This was followed by HRP-conjugated goat anti-human IgG at 127 128 room temperature for 1 hour. Wells were washed after each step with 0.1% Tween-20/PBS. Reactions were developed using TMB substrate, stopped with 0.16M sulphuric acid and read on 129 130 a spectrophotometer (Pherastar).

132 **Pseudotype neutralization assay**

The use of Vesicular Stomatitis Virus (VSV) in which the glycoprotein sequence has been replaced
 (VSVΔG*luc*) to generate pseudotyped viruses has been described previously¹⁷. Glycoprotein
 genes were cloned into the eukaryotic expression vector and transfected into HEK-293T cells
 using polyethylenimine followed by infection with VSVΔG*luc*-VSV-G at a multiplicity of infection

- 137 of 0.02. Cells were incubated for one hour at 37°C, washed with PBS and re-incubated in DMEM.
- 138 Supernatants were harvested 72-hours post infection. Pseudoparticle activity was assessed on
- 139 HEK-293T cells by measuring luciferase activity at 72-hours on a Microbeta 1450 Jet luminometer

140 (Perkin Elmer).

- 141 For neutralisation assays, 1×10⁴ HEK-293T cells were plated in a white 96-well plate and
- incubated at 37°C for one hour. Four-fold serum dilutions were prepared in DMEM ranging from
- 143 1:8 to 1:131072. Serum was mixed with either VSVΔG*luc*-VSV-G or VSVΔG*luc*-LDV-G at a
- 144 concentration expected to generate a luciferase reading of 1×10^6 counts per second and
- incubated for 1 hour at 37°C. 50µl per well of the pseudotype/serum mixture was added to the
- 146 cells and incubated for 24 hours. Luciferase substrate was added to each well (Steadylite plus[™],
- 147 Perkin Elmer) and luminescence measured on a Chameleon V plate scintillation counter (Hidex
- 148 Oy).

149 **RESULTS**

150 Demographics and clinical analysis

- 151 15% of patients with undiagnosed AFI (35/233) had evidence of acute viral infection by mNGS
- 152 (Figure 1b). Demographic and clinical data was available for 30/35 patients with AFI. The median
- age at clinical presentation was 7.5 years (range 2-40). 80% of cases occurred in children under
- the age of 16. Males were more commonly represented than females (20/30; 67% versus 10/30;
- 155 33%). The majority had been recently bitten by mosquitoes (22/30; 73%) and/or other
- 156 arthropod vectors, including biting flies (3/30; 10%), ticks (3/30; 10%), fleas (2/30; 7%) and lice
- 157 (1/30; 3%). Ten percent reported haemorrhagic symptoms but none of these had evidence of a
- viral haemorrhagic fever (VHF) virus by mNGS. At presentation, the median temperature was
- 159 38.2°C. Other clinical symptoms are described in **Table 1**. Common presumptive diagnoses
- included malaria, respiratory tract infection, typhoid fever and unknown. The majority 23/30
- 161 (77%) of patients were presumptively treated with antibiotics, 12 (40%) were treated with
- antimalarials and 5 (17%) with antihelminth therapy.
- 163 Of the 35 patients diagnosed by mNGS, 6 (17%) had a virus associated with VHF (CCHFV, RVFV,
- 164 YFV and DENV), 9 (25%) with viruses associated with respiratory infection (human parainfluenza
- 165 3, rhinovirus C and measles virus), 8 (22%) with hepatitis causing viruses (HAV, HBV, HEV), and 5
- 166 (14%) with gastroenteritis associated viruses (Table 2, Supplementary Table S1). Six patients
- 167 (17%) were infected with human immunodeficiency virus-1 (HIV-1). One patient was infected
- 168 with the rhabdovirus LDV. Two of these cases, one each of yellow fever and RVF were correctly
- 169 identified in the context of a known outbreak.

171 Viruses associated with VHF

172 Genomes from four VHF-associated viruses were detected in six febrile patients; CCHFV (patient

173 138-2), RVFV (patients 117-3, RVF58), DENV (patient ARB248) and YFV (patients YFV685,

174 ARB176).

175

176 The CCHF patient (138-2) was a male in his 30s from Kasese district. He presented with fever

177 (37.9°C), headache, nausea and joint pain. He had been bitten by mosquitoes but had not been

- aware of tick bites and had not recently slaughtered animals. He was treated with vitamins and
- 179 paracetamol and recovered. Partial (10-25% coverage) CCHFV sequences across all three
- 180 segments; large (L), medium (M) and small (S) were detected by mNGS (Figure 2a). The L and S

segments had >90% nucleotide identity to previously identified genomes from Uganda and
Democratic Republic of the Congo, respectively (Table 2, S1). The M segment had 81%
nucleotide identity to a genome from Uganda, suggestive of higher divergence or possible
reassortment (Figure 2d). Convalescent serology was not available from the patient, who
recovered and had moved abroad.
Two cases of RVF (117-3, RVF58) were detected. RVF58 was suspected due to occupational risk

188 (contact with slaughtered animals) and suggestive symptoms during an outbreak, and was confirmed by serology. 117-3 was a woman in her 30s from a rural part of Arua district who 189 gave a 3-day history of fever but whose temperature was recorded as 36.3°C on admission. She 190 described chills, headache, eye, neck and joint pain, nausea, diarrhoea and jaundice. She had 191 192 been bitten by mosquitoes and fleas. She was given paracetamol and attended a traditional healer for further treatment. Convalescent serology was not available for this patient. Viral reads 193 194 most closely matched the L segment of a Ugandan strain in case 1 (RVF58) and the M segment of 195 a Kenyan strain in case 2 (117-3).

196

197 Two cases of YFV infection and one DENV infection (genotype 3) were detected during suspected
198 YFV outbreaks and confirmed by convalescent serology. All genomes identified by mNGS were

related to East/Central Africa lineages (Table 2, S1; Figure 2 b,c,e,f).

200

201 While haemorrhagic symptoms were recorded for 3/30 (10%) AFI study cohort patients, none of 202 the these had a known VHF virus detected. The study patients described above with CCHFV and 203 RVFV did not report classical haemorrhagic symptoms.

204

205 Le Dantec virus

Patient 220-2 was a male aged between 5 and 10 years from Kasese district. He presented to hospital
with a 38.5 °C fever of 4 days, with headache, abdominal pain, vomiting and joint pains. He reported having
been bitten by mosquitoes. He was treated with ciprofloxacin and paracetamol for suspected
typhoid fever and made a full recovery. By mNGS, we detected the full genomic sequence of a
previously rarely reported rhabdovirus; Le Dantec virus (LDV; Figure 3a). This was confirmed by
direct RT-PCR from patient plasma and Sanger sequencing. The LDV genome had 94% nucleotide
identity to the RefSeg LDV genome (NC 034443.1), isolated for the first time in 1965 in Senegal

- and sequenced from an archival sample in 2015¹⁸ (Figure 3d). In keeping with an active infection,
- we demonstrated immunological response to LDV glycoprotein by ELISA and pseudotype
- neutralisation assay, in both the patient and in a contact of the patient who had been unwell at
- the same time, using convalescent serum (Figure 3b,c).
- 217

218 Viruses associated with acute hepatitis

- Hepatitis A (HAV) and hepatitis E (HEV) viruses were detected in 5 (patients ARB169, 218-1, 169-
- 1, 184-2, 145-3) and 2 (patients 20-2, 60-1) patients respectively. Clinical data was available for
- four of the HAV cases. The age of infection ranged from 2 to 15 years. All were febrile at
- 222 presentation. Three of four patients presented with vomiting, one had diarrhoea and one had
- jaundice. All HAV genomes were genotype IB and related to previously reported sequences from
- Uganda (Figure 4a, S3e). The HEV patients were aged between 0 and 5 years, and febrile at
- presentation. One had diarrhoea and vomiting and the other had undifferentiated fever.
- The two HEV isolates were genotype 1e and closely related to a Nigerian sequence (Figure 4b, S3d).
- 227

228 Viruses associated with gastroenteritis

- 229 Gastrointestinal viruses were detected in plasma from 5 patients, including 4 enteroviruses (the
- echoviruses E3, E4 and E9 and Coxsackie B3 virus from patients 212-1, 316-3, 165-1, 195-1
- respectively) and a fragment of a highly divergent rotavirus H-like virus in one patient (96-1)
- 232 (Figure 4c, S3f).
- 233

234 Viruses associated with respiratory infection

- Respiratory viruses were detected in plasma from 9 patients and included six cases of measles
- 236 morbillivirus (patients 215-1, 217-1, 242-1, 223-1, 113-1, 203-1), two cases of human
- parainfluenza virus 3 (patients 88-1, 114-1) and one case of rhinovirus C (patient 40-2) (Figure
- 4c,d and S3b,c). The measles virus sequences closely matched recently reported Ugandan B3
- genomes. The rhinovirus C clustered with subtypes RV-C12 and RV-C44.

241 Bloodborne viruses

- The bloodborne viruses HBV (patient 192-1) and HIV-1 (patients RVF58, ARB176, 143-2, 390-1,
- 243 199-2, 214-1) may have occurred as acute or chronic infections, detected in a population with a
- high seroprevalence of both viruses. HBV was detected in a teenage patient (192-1)

- 245 presenting with headache, anorexia and abdominal pain. It was most closely related to a
- sequence from Rwanda. HIV was identified as a co-infection in two patients, one with RVFV
- 247 (RVF58) and another with YFV (ARB176) (Figure 4e, S3a); suggesting chronic infection. Patient
- 248 214-1 was infected with HIV-1 subtype A1, clustering with another Ugandan sequence. All other
- 249 HIV-1 sequences were subtype D.
- 250

251 Herpesviruses

- Three patient samples (082-2, 185-2 and 143-2) contained human herpesvirus-6B (HHV6B)
- 253 genome, the cause of roseola infantum, related to strains from USA, Uganda and DRC. Seven
- 254 patients (187-2, 189-2, ARB244, ARB265, ARB454, ARB688 and HEV2) had evidence of
- cytomegalovirus (HHV5) in the bloodstream; this may have been acute or chronic infection. No
- varicella zoster virus (VZV) infections were detected.
- 257

258 Viruses detected that are not known to be associated with disease

- 259 MNGS also detected viruses often found in human populations that have not been definitively
- associated with disease. These included the annelloviruses: Torque Teno virus (TTV), Torque
- 261 Teno mini virus (TTMV), Torque Teno midi virus (TTMdV); and human pegiviruses (HPgV) (Table
- 262 **S2**).
- 263 We also detected a second and novel rhabdovirus sequence in several AFI samples by *de novo*
- assembly (Adumi virus). This virus was likely to be a contaminant of blood collection tubes, as
- 265 discussed in Supplementary Information.

266 DISCUSSION

267 In this prospective cohort study of AFI in Uganda, we used mNGS to identify viral causes of acute 268 undiagnosed fever in 210/1281 (16.4%) patients who tested negative after extensive screening for well-characterised pathogens, and an additional 23 samples obtained from outbreaks during 269 270 the same time period. The cohort was prospectively recruited from patients presenting to three HCs in rural and urban Uganda. We detected viral pathogens in 35/233 (15.5%) patients, 271 including 6/233 (2.6%) associated with VHF. Lack of clinical diagnosis of such viruses means that 272 appropriate public health measures may not be taken to prevent onward transmission and 273 274 appropriate treatment may not be given. The most commonly detected viruses reflected acute 275 gastrointestinal or respiratory infection. The detection of active blood-borne virus infection 276 reflects a chronic burden of disease and a need to widen treatment in the Ugandan population. 277 Importantly, acute viral infection was invariably misdiagnosed as bacterial or malaria and treated with antibiotics or antimalarials. This carries an associated risk of antimicrobial drug resistance. 278 279 We also noted vaccine-preventable infections in children (HAV, HBV, measles, Rotavirus) 280 indicating the need for a more comprehensive vaccination schedule. 281 282 AFI is widespread in SSA and in the absence of specialised point-of-care diagnostics; clinical 283 symptoms associated with different viruses may be indistinguishable. Even high-consequence VHFs such as Lassa fever and Ebola virus disease present with haemorrhage in less than 20% of 284 cases ^{19,20}. We identified CCHFV in a patient with undifferentiated fever who did not report 285 contact with ticks or slaughtered animals, highlighting the limitations of current risk algorithms in 286 identifying such patients in an endemic area. A high CCHFV seroprevalence has recently been 287

reported in farming communities and domesticated animals in Uganda, suggesting that
 unrecognised infection may be common²¹.

290

We also detected the mosquito-borne infections RVFV, DENV and YFV; of which RVF can also be
caused by contact with infected livestock. RVF is widespread across Africa and may cause a
spectrum of illness from mild to severe. It is associated with haemorrhage and encephalitis in
around 1% of human cases²². DENV is transmitted by *Aedes* mosquitoes and is endemic in Asia,
South America and sub-Saharan Africa. It is relatively less well reported from the African
continent, although studies suggest high seroprevalence^{23,24}. Worldwide, there are an estimated
100 million clinical cases per year, of which around 5% progress to dengue shock syndrome or

dengue haemorrhagic fever. We detected DENV-3 in this study, in keeping with previous reports
of genotypes 1-3 on the African continent. YFV is endemic in Africa and South America and is
transmitted by *Aedes* and *Haemagogus* mosquitoes. Severe disease with haemorrhage occurs in
up to 12% of those infected²⁵. An effective live vaccine exists for YFV and has recently been used
to control outbreaks in Brazil and DRC. It is required for travellers to Uganda and other endemic
regions, but the local unvaccinated population may remain vulnerable to infection.

305 We detected two rhabdoviruses in this study; LDV, a potential pathogen and Adumi virus, a likely contaminant. Rhabdoviruses are highly divergent and ubiquitous in host range, infecting plants, 306 307 invertebrates and vertebrates. Human disease is well-described; rabies lyssavirus causes fatal neurological infection and Chandipura virus causes acute neurological disease. Other, less well 308 309 described members have also been suggested as human pathogens, including Bas Congo virus 310 that was associated with a single outbreak of haemorrhagic disease in the DRC. Additionally, studies have also identified rhabdoviruses in blood from healthy asymptomatic individuals^{26,27}. 311 312 LDV is an emerging pathogen and has only two historical documentations; in a child with 313 hepatosplenomegaly and fever in Senegal in 1965 (sequenced in 2015) and in a middle-aged 314 shipyard worker with fever and severe neurological symptoms in Wales in 1969, who had 315 offloaded a ship inbound from Nigeria. LDV belongs to the genus Ledantevirus and closely related species have been found in rodents and bats. Neurological pathology has been described in 316 rodents infected experimentally with the virus²⁸. In our study, we demonstrated an immune 317 response and the development of neutralising antibodies in the infected individual and a 318 household contact who had similar symptoms at the time. 319

320

Vaccine-preventable diseases remain common in Uganda, even for viruses covered under routine immunisation, indicating insufficient coverage to generate herd immunity. Uganda has an active Expanded Programme of Immunization (EPI) against measles, HBV and rotavirus. YFV vaccination was introduced in October 2022. Vaccine coverage is lower in some neighbouring countries and this may increase the risk of imported infection. Measles vaccine in Uganda is often given as a single dose and booster vaccines during outbreaks. Such an approach may limit severe illness but has lower efficacy than the two-dose regimen used in other countries²⁹.

We detected a viral pathogen in 15.5% of undiagnosed cases, however, the high detection of viruses associated with respiratory and gastrointestinal infection in plasma highlights the high burden that these diseases carry in Uganda. The inclusion of respiratory and stool samples (not available in this study) in future studies will likely reveal a much higher prevalence of infection. Additionally, the inclusion of serological assays would increase detection of infections outside the viraemic phase. We have likely under-estimated the burden of viral disease in this study for these reasons.

Viral metagenomics, although a powerful and sensitive method for unbiased genomic discovery 337 338 is prone to limitations. Caution must be practiced when interpreting NGS data to exclude artefacts, which can arise from cross-contamination from the environment, within sequencing 339 340 reagents and from other samples processed or sequenced together. In several studies, viral reads 341 have subsequently been related to contamination within kits or from the environment. For 342 example, Nextera XT reagents have been associated with detection of Merkel cell polvomavirus³⁰. In this study, we found a novel rhabdovirus in several patient samples, most 343 344 likely as a result of contaminated blood tubes with a virus of mosquito origin. This highlights the need for careful interpretation of mNGS data, confirmation by other methods and the 345 development of standards and validation methods to interpret experimental information. 346 347

348 CONCLUSIONS

349 Febrile illness is widespread in Uganda and a significant proportion of undiagnosed disease can

be attributed to viral infections, several of which have pandemic potential and can cause high

351 mortality and morbidity. Metagenomic next generation sequencing is a powerful tool to

investigate the viral aetiology of AFI in high-risk populations and can be applied to develop low-

353 cost clinical diagnostics. The finding of multiple highly pathogenic and poorly-described viruses in

a single multi-site study in Uganda highlights the depth of the unknown with regard to circulating

human viruses and the risk for onward transmission in a rapidly changing world.
