1 Prevalence of cardiometabolic risk factors according to urbanization level,

2 gender and age, in apparently healthy adults living in Gabon, Central Africa

24 Abstract

The prevalence of cardiometabolic risk factors (CMRFs) is increasing in sub-Saharan Africa and represents a serious health issue. Specific and accurate data are required to implement prevention programs and healthcare strategies. Thus, the aim of this study was to estimate the prevalence rates of CMRFs according to the level of urbanization, age and gender in Gabon.

A cross-sectional study was conducted using the World Health Organization's (WHO) stepwise approach for the surveillance of chronic disease risk factors. Participants over 18 years of age, without known underlying disease, from rural and urban areas of Gabon were included. Biological and behavioral data were collected using an adapted version of the standardized WHO survey questionnaire.

The median age was 38[28-50] years. Tobacco consumption was more frequent in rural areas than 34 in urban areas (26.1% vs 6.2%; p < 0.01). Men were more likely to be smokers than women, in 35 both settings (aOR: 8.0[4.9-13.5], p < 0.01). Excessive alcohol consumption (19.4% vs 9.6%; p < 0.01). 36 0.01) predominated in rural than in urban areas. Urban dwellers were less physically active than 37 rural people (29.5% vs 16.3%; p < 0.01). In total, 79.9% of participants aged under 54 years had a 38 high blood pressure (HBP) while 10.6% of the younger participants had pre-hypertension. 39 Metabolic syndrome was higher in women (21.7% vs 10.0%; p < 0.01) than in men. Furthermore, 40 6.4% of men and 2.5% of women had a high risk of developing coronary heart diseases in the next 41 10 years (p = 0.03). Finally, 54.0% of the study population had three or four risk factors. 42

The prevalence rates of CMRFs were high in the study population. Disparities were observedaccording to urban and rural areas, gender and age groups. National prevention and healthcare

45 strategies for cardiometabolic diseases in Gabon should take into account these observed46 differences.

48 Introduction

Cardiovascular diseases (CVD) are the most common non-communicable disease (NCD). 49 In 2019, CVD were responsible for an estimated 17.9 million deaths worldwide, of which more 50 than three guarters occurred in low- and middle-income countries [1]. The increasing rate of deaths 51 due to CVD remains a serious health concern. By 2030, 23 million people are expected to die from 52 CVD, stroke and coronary heart diseases being the leading factors of these deaths. In sub-Saharan 53 Africa (SSA), an increased prevalence rate of NCD, especially CVD, has been observed in the past 54 30 years. Ischemic heart diseases have now become a major leading cause of death in SSA, 55 surpassing other major infectious diseases (malaria, tuberculosis and intestinal infections) [2]. 56

Cardiometabolic diseases (CMD) are related to modifiable and non-modifiable risk factors 57 (RF). Indeed, risk factors such as age, hypertension, diabetes, dyslipidemia, tobacco smoking, 58 59 physical inactivity, high alcohol consumption, insufficient fruit/vegetable consumption and high fat intake are considered to be directly linked to the occurrence of CMD. High blood pressure 60 (HBP) levels accelerate the risk of stroke and coronary heart disease. Likewise, people with 61 62 diabetes are twice as likely to develop CVD. Physical inactivity is one of the lifestyle factors which 63 promotes the onset of obesity, HBP, diabetes mellitus and an abnormal lipid profile. In SSA, HBP, type 2 diabetes, overweight and obesity were shown to be the most prevalent cardiometabolic risk 64 factors (CMRF) [3]. 65

Moreover, there has been a rapid increase of urbanization in SSA as well as significant population growth and aging in the past decades. Rapid and unplanned urbanization has been shown to contribute to the increase of CMD prevalence due to the increase of risk factors [4]. Indeed, unplanned urbanization is always characterized by the absence of spaces dedicated to physical activity. Furthermore, the urban environment provides an abundant market for the consumption of tobacco, alcohol and unhealthy food [5, 6].

Previous studies performed in high- and low-income countries highlighted disparities in the prevalence and types of CMRF in urban versus rural settings. For instance, in Cameroon, a higher prevalence of obesity (17.1%) and hyperglycemia (10.4%) has been reported in urban areas compared to rural areas [7]. In a study carried out in Burkina Faso, HBP was found in 24.8% and 15.4% of individuals living in urban and rural areas, respectively [8]. Furthermore, differences in the rates of risk factors according to gender have been described as well. Obesity and abdominal obesity are more often observed in women while men have a higher tobacco consumption [9, 10].

In Gabon, data on the burden of CMD and CMRF are scarce. Nevertheless, previous studies 79 80 reported a non-negligible incidence of CVD (13.3%) and the prevalence of diabetes was estimated at 19.6% [11, 12]. Furthermore, according to the WHO global health statistics, one in five people 81 is considered obese and in 2018, 17% of deaths were related to CVD [13]. In the same way, a high 82 prevalence of HBP was described in young students [14]. It was recently shown that in SSA, the 83 increased morbidity and mortality rates of CMD are a consequence of inefficient prevention 84 85 programs and healthcare strategies [15]. The lack of data on CMD and their risk factors are key impediments to implement efficient control efforts. Recent data are required to develop awareness 86 programs, to prioritize preventive measures and to adapt healthcare strategies according to urban 87 88 and rural areas. As such, in order to better contextualize future prevention and healthcare strategies,

it is important to characterize the burden of CMRF according to sociodemographic factors (age,

90 gender) and urbanization levels in Gabon.

91 Thus, the aim of this study was to estimate the prevalence rates of CMRF in urban and rural areas92 of Gabon.

93 Material and methods

94 Study sites

A prospective, cross-sectional and observational study was carried out from September 95 2020 to November 2021 in two urban areas (Melen and Libreville) and two rural areas (Bitam and 96 Koula-Moutou) in Gabon. Melen is located in the fifth district of Libreville, the capital city. This 97 district has 148,129 inhabitants. Koula-Moutou is located 586.9 km southeast from the capital, in 98 the Ogooué-Lolo province. Bitam is located in the north of Gabon, 592 km from Libreville, in the 99 Woleu-Ntem province. The Ogooué-Lolo and Woleu-Ntem provinces are the fourth and seventh 100 most populated provinces in Gabon with 65,771 and 154,986 inhabitants, respectively. In these 101 102 rural areas, the main activities of the population are agriculture, fishing and hunting.

103 The study was performed in Melen at the Centre de Recherche Biomédicale en Pathogènes 104 Infectieux et Pathologies Associées (CREIPA), in Libreville at the Centre Hospitalier Universitaire 105 de Libreville (CHUL), in Koula-Moutou at the Centre Hospitalier Régional Paul Moukambi 106 (CHRPM), and in Bitam at the Centre Médical de Bifolossi.

109 Study population

The study population was recruited through awareness campaigns in healthcare centers and in the community. Volunteers aged more than 18 years old, with negative malaria, HIV, hepatitis, tuberculosis tests, without known underlying disease, who had been residing in the four study sites for at least two years, and who gave their consent to participate were included. Pregnant women were not included.

115 Sample size calculation

116 The sample size was calculated with the formula used to estimate a sample proportion:

And the reported prevalence of cardiovascular disease in Gabon of 17%, in the absence of previous
data on CMDRF [12]. The significance level was 5%. Considering a non-response rate of 10%, the
minimum sample size was 239 included participants for rural and urban areas.

121 Data collection and physical examination

Data were collected using an adapted version of the standardized WHO survey 122 questionnaire by a team composed of experienced medical doctors, nurses and biologists [16]. The 123 first phase of the study included a face to face interview with participants, during which they were 124 asked about their socio-demographic data and their lifestyle characteristics such as tobacco and 125 alcohol consumption, dietary habits (fruit, vegetable and salt consumption), physical activity. In 126 addition, information on their past or current medication for HBP or diabetes was also recorded. In 127 128 the second phase of the study, anthropometric measurements such as height, weight and waist circumference were taken. Height and weight were measured using a height gauge and an electronic 129

scale, respectively. Participants were weighed without shoes and wearing only light clothing. 130 131 Measurements were recorded to the nearest 0.5 centimeter for height and 0.1 kg for weight. Body mass index (BMI) was calculated according to the following formula: weight (kg)/ height squared 132 (m^2) . Waist circumference was measured (in cm) in a standing position, by measuring the midpoint 133 between the lower margin of the last palpable rib and the top of the iliac crest, according to the 134 WHO recommendations [16]. Blood pressure (BP) and heart rate were measured in the sitting 135 136 position, on the left arm of each participant using an automatic blood pressure monitor (OMRON M3 Comfort, Kyoto, Japon) after 3 minutes of rest. Three measurements were performed 3 minutes 137 apart and the average values of the two closest values of BP and heart beats were recorded. 138

Biological analysis

After completing the questionnaire form and the physical examination, blood samples were collected in the morning from participants who had fasted for 12 hours. Blood glucose, total cholesterol (Total-C), HDL cholesterol (HDL-C), then LDL cholesterol (LDL-C) and triglyceride (TG) concentrations were measured using the PentraC200 analyzer (HORIBA ABX SAS, France).

144 Quality procedure

Throughout the study, measurements were performed by two independent technicians. Participants with HBP and high fasting glucose levels, detected during screening, were seen 15 days later by the study team. If the same trends were observed, they were classified as having HBP or hyperglycemia. In the case of diagnosis confirmation, they were referred to the physician of the nearest health centre or case management. Data obtained were all comparable. Double data entry was carried out to minimize the risk of data entry errors.

151 **Definition of variables**

The variables were defined based on WHO criteria [16]. Smokers were distributed into 152 three groups: the first group included all tobacco users: the second group consisted of daily smokers 153 (i.e. individuals who smoked at least one cigarette per day); the third group consisted of occasional 154 smokers (i.e. people who smoke between 1 to 3 cigarettes per week). Passive smokers were people 155 156 who had experienced passive smoking at home or at work during the 30 days prior to the day of the screening. Two groups were created for alcohol consumption: people who had consumed at 157 least one alcoholic drink during the 12 last months, and those with excessive alcohol consumption, 158 i.e. with more than 4 alcoholic drinks (12 g of ethanol) consumed per week. Different kinds of 159 bottles or boxes were presented to the volunteers to allow the team to estimate the amount of 160 drinking. After each volunteer reported the number of bottles or boxes he consumed, the physician 161 estimated the standard quantity of drink which corresponded to 12 g of ethanol according to the 162 most frequent type of drink available in the country (unpublished data). The number of fruit and/or 163 164 vegetable intake per day was also assessed: an intake of less than 5 fruits or vegetables per day was considered as insufficient. Salt consumption was also evaluated and individuals were ranked 165 according to their habits: occasional or excessive salting when cooking, adding salt before eating 166 or usual consumption of salty additives with food. 167

Physical activity was estimated depending on the volunteers' occupation, household activities, walking and physical activities during their free time. A physical activity <150 minutes per week was considered insufficient and a sedentary lifestyle was characterized by the fact of spending 12 hours of time sitting or lying down over the course of a day.

172	A metabolic syndrome was diagnosed according to the definition established by the
173	International Diabetes Federation in 2005 [17]. The diagnosis was based on the combination of at
174	least three of the five following RF: elevated triglycerides (>1.7 mmol/L); abdominal obesity (waist
175	circumference \geq 94 cm in men; \geq 80 cm in women); systolic blood pressure \geq 130 mmHg and/or
176	diastolic blood pressure \geq 85 mmHg or treated hypertension, fasting blood glucose \geq 5.56 mmol/L
177	or treated diabetes mellitus; low HDL cholesterol (HDL-C <1.03 mmol/L men, HDL-C <1.29
178	mmol/L women). Abnormal lipid levels were classified according to the Adult Treatment Panel III
179	criteria as follows: high total cholesterol (Total-C \geq 6.2 mmol/L), low HDL cholesterol (HDL-C
180	<1 mmol/L); high LDL cholesterol (LDL-C \geq 4.1 mmol/L) and high triglyceride levels (TG >2.26
181	mmol/L) [18].

182 HBP was defined as systolic blood pressure \geq 130 mmHg and diastolic blood pressure \geq 80 mmHg 183 or when participants followed a treatment for HBP. Pre-hypertension was defined as systolic blood 184 pressure between 120-129 mmHg and diastolic blood pressure between 70-79 mmHg [14]. An 185 elevated heart rate amounted to >80 beat/min. High fasting blood glucose levels were defined by 186 venous blood glucose levels \geq 5.6 mmol/L after at least 12-hour fasting. Diabetes was defined when 187 individuals followed treatment for diabetes mellitus. A BMI between 25 kg/m² and 29 kg/m² was considered as overweight, and obesity was defined as a BMI over 30 kg/m². Abdominal obesity 188 189 was defined for a waist circumference ≥ 94 cm in men and ≥ 80 cm in women.

The Framingham risk score for coronary heart disease was used to estimate the 10-year cardiovascular risk of the volunteers. The factors used in the calculation included age, gender, diabetes, smoking, SBP, DBP, Total-C and HDL-C. The cardiovascular risk score was categorized as low (<10%), intermediate (10%-19%), and high ($\geq 20\%$) as recommended [19].

The following eleven biological and behavioral RF were used to assess the number of CMD risk factors in the age groups of the study population: HBP, hyperglycemia, diabetes, obesity, overweight, abdominal obesity, dyslipidemia, tobacco use, excessive alcohol consumption, low fruit/vegetable consumption, insufficient physical activity. Metabolic syndrome was considered as a group of RF.

Ethical considerations

200 Ethical clearance and approval were obtained from the National Ethics Committee under the reference PROT N°002/2020/PR/SG/CNE. The study also received administrative 201 202 authorization from the Ministry of Health (which is the national regulatory authority), as well as 203 from the local administrators of each the study areas. All persons approached, including the 204 authorities, were informed about the objectives of the study, the procedures, what was expected of the potential participants, the possible risks and benefits for them. For the illiterate participants, a 205 206 local community member, previously trained by the research team, gave them information in the local language. Written and signed informed consent was obtained from each participant. A 207 fingerprint was used as a signature for the illiterates who were accompanied by a witness who also 208 signed the consent form. According to the National Ethics Committee requirement, the participants, 209 aged below 21 years old, who agreed to participate signed a written assent form of consent and 210 211 their parents or legal guardians provided a signed informed consent, after verification of their 212 parental relationship. All participants and guardians were clearly informed about the study procedures, interest, potential risks and benefits, and their rights. Participants with abnormal 213 214 clinical or biological data were conducted to the site health facility for appropriate investigation 215 and management.

216 Statistical analysis

Data were analyzed using Statistical Package for the Social Sciences (SPSS version 20) and 217 Epi info (version 6). The data was further categorized according to areas, age group and gender. 218 The normality of the data was checked by the Shapiro's and Kolmogorov-Smirnov test for 219 quantitative variables. Since the variables did not follow a normal distribution, medians were 220 compared between groups using the Mann-Whitney U test and proportions were compared using a 221 chi-squared test. Univariate logistic regression was performed to assess the unadjusted association 222 between the studied variable and the presence of CMRF. All variables that were associated with 223 the presence of at least one CMRF with a p<0.2 in the univariate analysis were included in the 224 respective multivariable analysis. A multivariate multinomial logistic regression was used to 225 226 determine the independent predictors of CMRF; we adjusted models for gender, areas of residence and age. Adjusted odds ratio (aOR) and cOR were reported at a 95% confidence interval (CI). All 227 p-values are two-tailed, and $p \le 0.05$ was considered statistically significant. 228

229 **Results**

230 Sociodemographic characteristics of the study population

In all, 1098 volunteers were approached and 978 were interviewed, 499 in urban areas and 479 in rural areas (Figure 1; Table 1). The results of the lipid measurements were available for 705 participants, 458 volunteers (154 men; 304 women) in urban areas and 247 volunteers (100 men; 147 women) in rural areas.

236	Women represented almost 60.0% of the study population. The majority of the participants
237	were aged less than 54 years old (83.5%) and the median age was 38 years [28-50]. More than half
238	(55.6%) and almost two thirds (66.9%) of the participants were in a relationship (married or living
239	with a partner) and had at least a secondary school level education level (Table 1). Volunteers from
240	urban areas were younger (37 \pm 13.4 vs 41 \pm 11.6 years), more likely to be unmarried (50.7% vs
241	26.3%), and had a higher education level (40.5% vs 4.4%) than rural participants ($p < 0.01$) (Table
242	1).

Prevalence of behavioral characteristics associated with cardiometabolic disease risk factors according to gender and area of residence

Overall, 156 (16.0%) participants smoked. Men were more likely to be smokers than women, both in rural (aOR: 8.0[4.9-13.5], p < 0.01) or urban settings (aOR : 4.0[1.8-8.4], p < 0.01) (Tables 2 and 4). Participants from rural areas were more frequently smokers (Table 2). Indeed, daily smokers (29.4% vs 19.8%, p < 0.01) were more frequent in rural areas than in urban areas. Overall, 24.7 % of the study population was exposed to passive smoking at work or at home.

Alcohol consumption was more prevalent than smoking in the general population, men being the most frequent users, whatever the study area (Table 2). Less than 15% of the study participants had excessive consumption, rural inhabitants and men were two-fold and 4-fold, respectively, at a higher risk of being excessive alcohol consumers (Tables 2 and 4).

Rural residents were more likely to eat food with additional salty additives than urban residents (41.5% vs 24.2%; p < 0.01) (Table 2). The same trend was observed for women living in urban cities (Table 2).

The mean fruit and vegetable consumption was 2.8 ± 2.3 /day. Only 12.2 % (n = 119/978) of volunteers consumed the recommended five or more fruits and/or vegetables per day (Table 2). Neither age nor area statistically influenced the quantity of fruit and vegetable intake, although women from urban settings had a higher fruit and vegetable consumption compared to men (Table 2). The rate of low physical activity was higher in urban areas (29.5% vs 16.3%; *p* < 0.01), and in women (26.0%, n=149/573 vs 18.8%, n=76/405; *p* <0.01) (Table 2).

275 Prevalence of anthropometrics and biological cardiometabolic 276 disease risk factors according to gender and area of residence

Almost, half of the study population had HBP (49.7%) (Table 3). HBP, diabetes,
abdominal obesity, obesity, high LDL-C level, high Total-C level and metabolic syndrome were
significantly more common in urban areas than in rural areas (Table 3).

289	The prevalence of HBP, including participants on medication for hypertension and pre-
290	hypertension was 59.8% (Table 3). Among the respondents considered with HBP, 97(20%) were
291	on medication. Men were more likely to have HBP or pre-hypertension than women ($p < 0.01$).
292	However, while rural inhabitants had a lower prevalence of HBP, they were 1.5 times more at risk
293	of having pre-hypertension (Table 4). Volunteers aged less than 36 years old were more likely to
294	have pre-hypertension (10.6%) than older participants (3.9%) ($p < 0.01$). However, 36.5% of
295	participants aged less than 36 years had HBP, compared to 62.2% of participants aged between 36
296	and 53 years old and 79.9% of participants who were older than 53 years old.

315 The mean waist circumference and BMI were, respectively, 84.82 ± 15.53 cm and $26.50 \pm$ 316 6.64 kg/m^2 in the overall study population. Abdominal obesity was found in more than 20% of the participants, while the overall prevalence of overweight and obesity was 50.0% (Table 3). Living 317 in urban areas (aOR: 1.89, 95%CI [1.31-2.63], p < 0.01) and female gender (aOR: 4.2, 95%CI 318 319 [3.54 - 7.14], p < 0.01) were associated with obesity (Table 4). According to age, a higher prevalence of obesity was seen in adults aged 36-53 years old (34.5%) compared to the oldest 320 (29.8%) and the youngest (16.4%; p < 0.01). The prevalence rate of overweight was comparable 321 between the three age groups, ranging from 25.0% to 29.1%. 322

The mean (±SD) of Total-C, LDL-c, HDL-C, TG levels were 4.89 (±1.29) mmol/L, 2.43 (±1.07) mmol/L, 1.36 (± 0.52) mmol/L and 0.82 (± 0.52) mmol/L, respectively. Low HDL-C (23.1%) was the most prevalent dyslipidemia, while the rates of other markers were below 7.0% (Table 3). There was higher rate of low HDL-C in rural areas. High LDL-C and hypercholesterolemia were more frequent in inhabitants from urban sites. However, no difference was observed between men and women for high Total-C levels (5.5% in men vs 6.3% in women; p = 0.47), and for high LDL-C (6.7% in men vs 6.2% in women; p = 0.92) (Table 3).

Our results show a higher trend towards hypertriglyceridemia (3.2% in men vs 1.3% in women; p = 0.10) and low HDL-C (26.8% in men vs 21.1% in women; p = 0.09) in men compared to women. The mean Total-c rate was 6.9 (± 0.7) mmol/L in the group of volunteers with a high Total-C, the mean HDL-C rate was 0.69 (± 0.23) mmol/L in participants with low HDL-C, the mean LDL-C rate was 4.91 (± 0.93) mmol/L in participants with high LDL-C, and finally, the mean TG was 3.26 (± 0.49) mmol/L in the group of volunteers with hypertriglyceridemia.

The overall prevalence of diabetes was 5.4% and the prevalence rate of high fasting blood glucose levels was almost 4-fold higher (Table 3). The hyperglycemia prevalence rate was

comparable in urban and rural areas, while 51 out of the 53 volunteers on diabetes medication lived in urban sites (p < 0.01). The burden of both abnormalities was not statistically different according to gender. The overall prevalence of metabolic syndrome was higher in women (21.7%) than in men (10.0%; p < 0.01) (Table 3).

Framingham cardiovascular risk score according to urban and rural areas

The Framingham risk score for coronary heart disease was assessed only in the group of the 505 participants aged over 30 years old (296 in urban areas and 209 in rural areas). Overall, 30 (3.4%) participants had a high score, and among these 18 (6.1%) lived in urban settings while only 2 (1.0) resided in rural areas (p < 0.01). The rates of people with a moderate score were comparable in the two areas (12.5% in urban area vs 11.0% in rural area, p = 0,61). The prevalence of a high risk score was significantly lower in men (6.4% in women vs 2.5% in men; p=0.03), and in older participants (13.7% vs 1.4% in those aged between 36-53 years old; p < 0.01).

353 age group and area of residence

Overall, 972 (99.4%) participants had at least one modifiable CMD risk factor. Participants frequently had three or four RF (54.0%) and those with the highest number of risk factors resided in urban areas (Table 3).

The number of CMRF per individual significantly varied according to age (p < 0.01) (Fig 1). The majority of healthy volunteers aged under 36 years old (70.9%; n = 299/422) had three RF or less; two thirds of the oldest participants (60.3%, n = 97/161) had four RF or more, while the middle-aged volunteers had more frequently (60.0%, n = 237/395) three to four CMRF (Fig 2).

363 **Discussion**

The burden of NCD is rapidly growing worldwide, including in SSA where populations 364 also suffer from the burden of infectious diseases. Public health efforts mainly focus on reducing 365 the burden of the three main infectious diseases (malaria, HIV/AIDS and tuberculosis) and 366 neglected tropical diseases (NTDs). However, reports on the increasing death rate associated with 367 368 CVD are on the rise for SSA [12, 20]. In addition, data from Central Africa are scarce, although the living conditions of local populations are not significantly different from other low-middle-369 income-countries in SSA. This lack of reliable data is an obstacle for (i) the consideration of NCD 370 371 as serious public health issue, and (ii) for the design and planning of efficient preventive strategies tailored to the population, in order to reduce the silent and neglected impact of NCD. 372

This study shows a considerable high prevalence of individual NCD risk factors in peopleliving in urban and rural settings in Gabon.

To date, there was no recorded data on the prevalence of daily tobacco use and harmful alcohol consumption in Gabon, although these behaviors are noticed among young adults. The prevalence of daily tobacco use was higher than that observed in young Gabonese students (19.2%

378 vs 14%), in Kenvan adults (13.5%) and in global reports from SSA [14, 21, 22]. The fact that men 379 are more likely to be smokers than women is currently reported worldwide [9, 23]. However, an unusual higher prevalence of daily tobacco users in rural areas (19.2%) compared to urban settings 380 (2.8%) was observed. In SSA countries, the smoking prevalence rate was found to be 40% in urban 381 areas versus 20% in rural areas [24]. Approximatively, 25% of the study population were exposed 382 to passive smoking at work or home. Although Gabon has adopted and designed preventive 383 384 strategies after implementing the anti-smoking law in 2013, it seems that awareness campaigns are insufficient in the country and have difficulty reaching rural communities with lower school 385 attendance. This study emphasizes the need to continue data collection and to consider gender and 386 387 sociodemographic factors, in order to tailor preventive strategies to target populations. Rural communities must be better informed and included in the preventive programs for NCD. 388

389 Smoking and alcohol consumption are two RF for CMD which often occur together. 390 Excessive alcohol consumption was more prevalent in men and in rural settings as observed 391 elsewhere [9, 10]. Alcohol and tobacco consumption in women is traditionally considered as 392 abnormal or incorrect (immoral) in Gabon, while it is more accepted for men, this could explain 393 the difference highlighted according to gender. It is important to note that this gender difference is only observed for the excessive consumption of tobacco or alcohol, whatever the level of 394 395 urbanization. Surprisingly, smoking and alcohol consumption were more often reported by rural 396 inhabitants. Alcohol shops are easily accessible in urban settings, but local production is frequent 397 in rural settings. Each family can have its own palm plantation and sugar cane fields as well as 398 homemade stills, and therefore have the possibility of producing its own palm wine or cane sugar liqueur whose alcohol level can exceed 30%. The two drinks, which are very popular in local 399 400 communities, are very often consumed without moderation.

An unhealthy diet and insufficient physical activity are common in the study population, 401 with prevalence rates comparable to findings from other African countries. Indeed, the prevalence 402 of low fruit and vegetable intake is in line with reports from Tanzania (82%) and Ethiopia (95%) 403 [25, 26]. There was no difference according to gender or the geographic location. This could be 404 due to the population's dietary habits and their similar access to various fruits and vegetables. Most 405 participants in this study (74%) did not have a sufficient and regular income which would allow 406 them to buy and consume several fruits and vegetables on a daily basis. In addition, the eating 407 habits of the population depend on the seasonal availability of foods and also on the geographic 408 area. Although agriculture is the main activity in rural areas and these are the main supplier of local 409 410 fruits and vegetables, the availability of these is seasonal and there is only very little variety and quantity: certain fruits are found in a region at a given time, and not necessarily in another. In 411 addition, the average Gabonese meal consists of a starchy food and meat or fish for lunch, which 412 is the main meal of the day. The consumption of fruit for snacks or dessert is only possible for 413 people who have sufficient income to buy expensive imported fruits and vegetables every day. The 414 questionnaire used during the interviews did not take into account the local context to gather data 415 on the availability and specificities of local foods; future studies should adapt the questions 416 accordingly. Gabonese government policies should promote healthy eating habits, for example by 417 418 making healthy foods available at reduced prices in urban areas and by providing agricultural land and mechanical tools dedicated to agriculture in rural areas. 419

The prevalence rate of high salt intake in cooking and dietary habits was not negligible. It reached 42% in total when the consumption of processed food with salt was combined with the addition of salt during meals. The higher prevalence observed in rural areas could be explained by the absence of preventive information about the risk of CVD when eating more than 5g of salt per

day, but also by the fact that cardiologists, who usually provide such education and counselling,are lacking in rural areas.

The overall prevalence of low physical activity is 22% in SSA, which is in line with the results in our present study (23%). The higher proportion of women and urban participants with insufficient physical activity seems to be common in low- and middle-income countries [27]. The sedentary lifestyle (at home and at work) in urban cities and the fact that men do more physical work compared to women might partly be in cause.

The prevalence rate of overweight and obesity in the study population is cause for concern 431 as it amounts to 50%. This is very high compared to reports from other SSA countries such as 432 Mozambique (30%) and Zambia (24.4%) [28, 29]. The prevalence of central obesity (29%) was 433 however comparable to data from these countries. Obesity is the consequence of energy imbalance 434 435 between the type and quantity of food consumed and insufficient physical activity. The predominance of both CMRF among women and the urban population of this study justify the 436 observed higher predominance of overweight/obesity and central obesity in these two groups. Our 437 438 results are in accordance with other data in African countries where the prevalence rate of overweight/obesity has doubled within the last two decades, with the highest burden found in 439 women and urban inhabitants [30, 31]. The westernized and sedentary lifestyle of urban 440 populations of low-middle-income-countries results in infrequent physical inactivity during free 441 time, more time spent in offices in front of computers, increased use of public transportation, and 442 443 the increased consumption of processed foods and junk foods, which are all causal factors for overweight/obesity. In Libreville, the work is carried out in a continuous day with a break of less 444 than an hour. Workers therefore do not have the possibility of returning home to have a balanced 445 446 lunch, the majority having lunch in fast food outlets where fried foods and meals rich in oil and

salt are most frequently available. This poor lifestyle may explain the higher prevalence of obesity
in the group of patients aged 35 to 53 years old, which is the most professionally active in our study
population.

450 Hypertension is the leading CMRF in Africa, its prevalence is the highest in the world, ranging from 17% to 70% [32]. Almost half (49.7%) of the interviewed persons in our study had a 451 high blood pressure, which is consistent with a previous report from the main hospital in Libreville, 452 but considerably higher compared to studies from Oman (33) [33, 34]. Although the differences 453 454 could be due to the cross-sectional study design and other parameters such as the stress of the participants during the physical examination, these findings are a matter of grave concern for 455 physicians, health workers, and policy makers. Indeed, the prevalence of participants on medication 456 457 is still high (20%). Our findings also suggest that more than 25% of the population were not aware 458 of their health status or were undiagnosed, and thus would remain untreated, increasing the risk of 459 ischemic attack. There is an urgent need for preventive efforts, better diagnostics, high treatment 460 coverage, and awareness campaigns on the causes and consequences hypertension. The prevalence 461 of HBP was lower in rural settings in this study, it reached 39% in areas where it is known that 462 awareness campaign and annual systematic screening and treatment are not often accessible. A recent study conducted in Libreville revealed an HBP prevalence rate of nearly 20% among 463 464 adolescents [14]. Altogether, these results suggest that HBP is a major public health problem in Gabon and that there is an urgent need to implement control and prevention strategies. These 465 findings also highlight the need for an integrated approach of NCD for prevention in urban and 466 remote rural areas. 467

The risk of developing a CVD increases with high fasting blood glucose levels; more than
20 million African individuals live with diabetes [35]. Data on the prevalence of diabetes in Central

470 Africa are sparse. The prevalence rate of diabetes was 5.4% in this study, which is in line with 471 studies from Cameroon (5.6%), Burkina Faso (5.2%) [36, 37]. However, not surprisingly 97% of the diabetic participants lived in urban areas, and as such the prevalence rate was higher (10.2%) 472 than in rural areas. The prevalence of hyperglycemia was much higher than that of diabetes, and it 473 was comparable in urban and rural settings. Beyond the deaths directly attributable to diabetes, 474 hyperglycemia is responsible for a heavy burden of mortality [38]. It is therefore urgent to 475 implement a strategy to treat patients in the pre-diabetes stage in order to avoid a progression of 476 the disease to diabetes and its medical and economic consequences. 477

Effective detection and treatment of dyslipidemia are recommended to reduce 478 cardiovascular diseases in Africa. The burden of these biological risk factors is increasing in SSA 479 480 [20]. Low HDL-C level was the most frequent detected dyslipidemia (23.1%), which is consistent with data from SSA (20-40%) [39]. High Total-C (6.4%) and hypertriglyceridemia (6.3%) 481 prevalence rates were lower than the majority reported data from other SSA countries [39, 40]. 482 483 However, the concerning prevalence rate of the metabolic syndrome (12.5%), which is a precursor 484 of CVD and diabetes, is in line with rates from SSA (16%) [41]. Women and urban populations are the most concerned. This is not surprising because related behavioral risk factors were also 485 found to predominate in these groups. Pre-HBP (14.4% vs 6.0%), elevated heart rate (45.9% vs 486 487 25.1%) and low HDL-C (42.5% vs 12.7%) levels were predominant in rural areas. These results could reflect an ongoing epidemiologic transition, in rural areas. 488

Less than 1% of the apparently healthy study participants had no CMRF. More than 80% had at least two NCD risk factors, although persons living in urban sites (18.8%) were more likely to have more than three RF than rural inhabitants (11.5%). In Kenya, the majority (75%) of adults

492 screened had at least four RF [42]. As observed elsewhere, increasing age and urban residence
493 were associated with a higher number of CMRF [28].

According to the Framingham risk score, people at a high risk of suffering from a cardiovascular event in next 10 years were more likely to live in urban areas than in rural areas (6.08% vs 0.95%), as reported in Myanmar [9]. These results are not surprising as the variables considered in the calculation of the Framingham risk score were found in high prevalence rates in urban sites.

Urban inhabitants had the most risk factors and older people had a higher number of RF. It has been suggested that the risk of cardiovascular events increase with particular combinations of risk factors as well as their total number [43, 44]. As an example, hypertension associated with the elderly may be combined with several others RF. Thus, strategies to reduce RF in the population should be adapted to target the population according to the areas.

This is the first study which assessed CMRF both in urban and rural areas of Gabon, were 503 no data were previously recorded. A standardized approach was used, making the generated data 504 505 comparable to other countries. Data was collected by well-trained team members, and the presence 506 of a field worker living in each of the study area and speaking the native language, facilitated exchanges with the populations in rural localities. However, although the Framingham risk 507 508 equation was used to assess the 10-year risk score of cardiovascular events, it has not been validated 509 in African populations. The development and validation of a region-specific risk estimation 510 equation is much needed. The recorded data were self-reported through face-to face interviews on 511 personal lifestyle. Thus, the participants may tend to say what is acceptable or correct instead of being honest. As a consequence, alcohol and tobacco consumption could be under-reported. 512 513 Moreover, the measurement of salt in urine was not performed to assess the reliability of the volunteers estimates of their salting habits. Lastly, this study was cross-sectional and did not assess 514

environmental and genetic risk factors. Despite these limitations, the data in this study provide
useful baseline information on the burden of CMRF and could be used by policy makers and control
programs.

518 Conclusion

This study provides essential information on CND indicators in Gabon. The prevalence of modifiable CMD risk factors was high both in urban and rural study sites. Gender differences in risk factor prevalence was observed. The high prevalence of multiple RF per individual indicates the urgent need to implement effective preventive programs as well as the detection, treatment and prevention of related cardiovascular and metabolic diseases. Other surveys with larger sample populations and specific groups such as youth, elderly, pregnant women and HIV-infected persons should also be performed.
