# SARS-CoV-2 introductions to the island of Ireland

# Abstract

Severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) has had an unprecedented impact on the people of Ireland as waves of infection spread across the island during the global coronavirus disease 2019 (COVID-19) pandemic. Viral whole-genome sequencing (WGS) has provided insights into SARS-CoV-2 molecular mechanisms of pathogenicity and evolution and contributed to the development of anti-virals and vaccines. High levels of WGS have enabled effective SARS-CoV-2 genomic surveillance on the island of Ireland, leading to the generation of a sizeable data set with potential to provide additional insights into viral epidemiology. Because Ireland is an island, accurate documentation of travel rates to and from other regions, both by air and by sea, are available. Furthermore, the two distinct political jurisdictions on the island allow comparison of the impact of varying public health responses on viral dynamics, including SARS-CoV-2 introduction events.

Using phylogenomic analysis incorporating sample collection date and location metadata, we describe multiple introduction and spreading events for all major viral lineages to the island of Ireland during the period studied (March 2020–June 2022). The majority of SARS-CoV-2 introductions originated from England, with frequent introductions from USA and northwestern Europe. The clusters of sequences predicted to derive from discrete introduction events ("introduction clusters") vary greatly in size, with some involving only one or two cases and others comprising thousands of samples. When introduction cluster samples are mapped sequentially by collection date, they appear predominantly in previously affected or adjacent areas. This mirroring of the phylogenetic relationships by the geospatiotemporal propagation of SARS-CoV-2 validates our analytic approach. By downsampling, we estimate the power to detect introductions to Ireland as a function of sequencing levels. Per capita normalisation of both sequencing levels and detected introductions accounts for biases due to differing sequencing efforts and total populations. This approach showed similar rates of introductions for all major lineages into Northern Ireland (NI) and Republic of Ireland (RoI) with the exception of Delta, which was higher in NI which is likely attributable to higher travel per capita. However, there were similar rates of Delta infection within NI and RoI, suggesting that although travel restrictions will reduce risk of introducing novel variants to the region, they may not substantially decrease total incidence.

Our generalisable methodology to study introduction dynamics and optimal sequencing levels will assist public health authorities to select the most appropriate control measures and viral sequencing strategy.

# **Introduction**

Severe acute respiratory syndrome coronavirus 2 (SARS-CoV-2) is a non-segmented, single-stranded <sup>2</sup> positive-sense RNA virus in the family *Coronaviridae*, which was first detected in Wuhan (武汉), Hubei 3<br>(湖北) province. China (中华人民共和国) in December 2019, with an initial draft genome posted in early (湖北) province, China (中华人民共和国) in December 2019, with an initial draft genome posted in early <sup>4</sup> January 2020 (Andersen et al. [2020;](#page-28-0) Virological [2020\)](#page-32-0). The virus is characterised by having an unusually 5 large genome (∼30 kbp) for an RNA virus, but is typical of coronaviruses (Brian and Baric [2005\)](#page-28-1). <sup>6</sup>

Despite the presence of an error-correcting RNA-dependent RNA replicase (Pachetti et al. [2020\)](#page-31-0), which reduces the overall mutation rate (e.g., compared to human immunodeficiency virus or influenza 8 viruses), SARS-CoV-2 still mutates with an estimated rate of about  $1 \times 10^{-6}$  to  $2 \times 10^{-6}$  mutations 9 per nucleotide per replication cycle (Amicone et al. [2022;](#page-28-2) González-Vázquez and Arenas [2023;](#page-29-0) Markov 10 et al. [2023\)](#page-30-0). RNA editing carried out by host proteins such as members of the ADAR gene family  $\mu$ deaminating adenosine to inosine and APOBEC gene family deaminating cytosine to uracil result in <sup>12</sup> pervasive A→G and C→U mutations (Di Giorgio et al. [2020;](#page-28-3) Simmonds [2020\)](#page-31-1). This accumulation of viral <sup>13</sup> mutations leads to an estimated substitution rate of about two novel single-nucleotide polymorphisms <sup>14</sup> (SNPs) appearing each month (Duchene et al. [2020;](#page-28-4) Castillo-Morales et al. [2021;](#page-28-5) Markov et al. [2023\)](#page-30-0). <sup>15</sup> The continuous evolution of SARS-CoV-2 results in the sporadic emergence of new viral lineages, which 16 can evade naturally acquired immunity and diminish the effectiveness of existing vaccines (Wang et al. 17 [2022\)](#page-32-1). New lineages are often characterised by many novel mutations that have accumulated rapidly prior 18 to detection (Harvey et al. [2021\)](#page-29-1) or, more rarely, by RNA recombination events (Li et al. [2020;](#page-30-1) Turakhia, <sup>19</sup> Thornlow, A. Hinrichs, et al. [2022\)](#page-32-2).

Whole-genome sequencing (WGS) facilitates the identification of viral variants, enabling viral transmission to be tracked in epidemics and pandemics (Baillie et al. [2012;](#page-28-6) Dudas et al. [2017;](#page-28-7) Grubaugh, <sup>22</sup> Ladner, Kraemer, et al. [2017\)](#page-29-2). Knowledge of circulating SARS-CoV-2 variants informs public health 23 policies and responses (Talic et al. [2021\)](#page-31-2). In response to the pandemic, the COVID-19 Genomics UK  $_{24}$ (COG-UK) consortium was established in April 2020 to provide high-throughput WGS of SARS-CoV-2 <sup>25</sup>

RNA extracted from positive cases in the nations of the United Kingdom (UK) (The COVID-19 Genomics  $_{26}$ UK (COG-UK) Consortium [2020\)](#page-31-3). As a COG-UK member, we were responsible for sequencing the 27 majority of Northern Irish SARS-CoV-2 samples (Fuchs et al. [2022\)](#page-29-3) and also, in collaboration with <sup>28</sup> members of the Sanger Institute, developed a dashboard for visualising dispersion of SARS-CoV-2 lineages <sup>29</sup> across Northern Ireland (<http://go.qub.ac.uk/covid19>). 30

In the Republic of Ireland, SARS-CoV-2 WGS was predominantly performed by the National Virus <sup>31</sup> Reference Laboratory in University College Dublin on behalf of the National SARS-CoV-2 Surveillance  $\frac{32}{2}$ & WGS programme. The high per-capita SARS-CoV-2 WGS programmes within the island of Ireland <sup>33</sup> provide an opportunity to study viral introductions into and spread between its two most populous urban <sup>34</sup> centres (Belfast and Dublin) and the remainder of the island.  $\frac{35}{35}$ 

The island of Ireland (Irish: Eire, referred to hereafter as Ireland) is located on the periphery  $\frac{36}{10}$ of northwestern Europe and offers a unique perspective to the study of viral transmission. Ireland  $\frac{37}{27}$ has a significant amount of travel, not only with other European countries (O'Connor and Lyons 38 [2003\)](#page-30-2), but also with North America due to historical population migrations (Kenny [2014\)](#page-29-4). Also, <sup>39</sup> within Ireland there are two countries with a combined population of almost 7 million: Northern  $\frac{40}{40}$ Ireland (NI) with a population of ∼1.9 million (Northern Ireland Statistics and Research Agency <sup>41</sup> (NISRA; Irish: Gníomhaireacht Thuaisceart Éireann um Staitisticí agus Taighde), Census 2021 main  $\frac{42}{4}$ [s](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1)tatistics for Northern Ireland (phase 1), [https://www.nisra.gov.uk/publications/census-2021](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1) [main-statistics-for-northern-ireland-phase-1](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1)), which is one of the nations of the United Kingdom <sup>44</sup> (UK), and Ireland (referred to hereafter as the Republic of Ireland (RoI)) with a population of  $\sim 5.1$ <sub>45</sub> [m](https://data.cso.ie/table/FP001)illion (Central Statistics Office (CSO, Irish: An Phríomh-Oifig Staidrimh), [https://data.cso.ie/](https://data.cso.ie/table/FP001) 46 [table/FP001](https://data.cso.ie/table/FP001)). This geopolitical structure provides an opportunity to examine the effect of independent  $\frac{47}{47}$ pandemic response measures on SARS-CoV-2 introductions and onward transmission over the course of <sup>48</sup> the pandemic thus far on otherwise similar geographic regions. Note that the designation "Irish" is used <sup>49</sup> to describe all samples collected in Ireland.  $\frac{50}{20}$ 

The transmission and severity of SARS-CoV-2 have been shown to be influenced by various human  $51$ factors, including population density and regional deprivation. Studies have identified population density  $52$ as a potential factor in the transmission of the virus, with variations observed across different regions of  $\frac{53}{10}$ NI (McKinley et al. [2021\)](#page-30-3). Moreover, the risk of dying due to SARS-CoV-2 infection has been found to  $\frac{54}{54}$ be associated with regional deprivation (Public Health England [2020\)](#page-31-4).

Research has demonstrated that deprivation is a primary risk factor for SARS-CoV-2 deaths among  $_{56}$ care home residents in England (Bach-Mortensen and Degli Esposti [2021\)](#page-28-8). Furthermore, the mortality 57 rate for deaths involving SARS-CoV-2 has also been shown to be significantly higher in the most deprived <sup>58</sup> areas of England (Office for National Statistics [2020\)](#page-31-5). Additionally, socioeconomic deprivation was linked <sup>59</sup> to a higher rate of critical cases and mortality due to  $SARS-CoV-2$  in Scotland (Lone et al. [2021\)](#page-30-4). These  $\omega$ findings suggest that regional deprivation is a key factor that must be considered when assessing the 61 impact of the pandemic within Ireland.  $\epsilon$ 

In NI, there is already evidence linking SARS-CoV-2 incidence rate to deprivation data (McKinley  $63$ et al. [2021\)](#page-30-3). The identification of SARS-CoV-2 introductions and monitoring of viral spread allows us <sup>64</sup> the opportunity to investigate their links with deprivation. Such an approach may help in identifying 65 areas in Ireland that are at higher risk of transmission and mortality, and inform targeted public health 66 interventions. By identifying areas that are most vulnerable to the virus, policymakers and healthcare  $\sigma$ professionals can develop targeted interventions and allocate resources more effectively, ultimately reducing 68 pandemic harm.

Multifarious studies have characterised the initial introduction of SARS-CoV-2 to specific regions  $\pi$ (Gonzalez-Reiche et al. [2020;](#page-29-6) Díez-Fuertes et al. 2020; Deng et al. 2020; Gámbaro et al. 2020; Bedford  $\pi$ 1 et al. [2020;](#page-31-6) Moreno et al. 2020; Maurano et al. 2020; Paiva et al. 2020; Komissarov et al. [2021;](#page-29-7) Muenchhoff  $\tau$ et al. [2021;](#page-30-9) da Silva Filipe et al. 2021; Lobiuc et al. 2021; Murall et al. 2021; Juscamayta-López et al. [2021;](#page-29-8) Githinji et al. [2021;](#page-29-9) du Plessis et al. [2021;](#page-28-13) Tordoff et al. [2021;](#page-32-3) Mallon et al. [2021;](#page-30-10) Lemieux et al. <sup>74</sup> [2021;](#page-30-11) McBroome et al. [2022;](#page-30-12) Borges et al. [2022\)](#page-28-14), or variants of SARS-CoV-2 to regions (Stefanelli et al. <sup>75</sup> [2020;](#page-31-7) Tang et al. [2021;](#page-31-8) Toovey et al. [2021;](#page-31-9) Alpert et al. [2021;](#page-28-15) Elliott et al. [2022;](#page-28-16) Michaelsen et al. [2022;](#page-30-13) <sup>76</sup> Fonager et al. [2022;](#page-30-14) Nasir et al. 2022; Bukhari et al. [2023\)](#page-28-17). A previous phylogenetic analysis of 225 Irish  $\pi$ genomes from two pandemic waves suggested that multiple introductions of SARS-CoV-2 to Ireland from <sup>78</sup> outside had taken place (Mallon et al. [2021\)](#page-30-10). However, the extent and originating locations of these and  $\tau_{2}$ other introductions to Ireland remain to be elucidated. <sup>80</sup>

Here, we leveraged a global SARS-CoV-2 phylogeny of more than seven million sequences to identify 81 such introductory events. During six key time periods throughout the pandemic, we quantified introductions ascribed to the following major viral lineages as designated by the World Health Organization <sup>83</sup>

(WHO) and Pango nomenclature (O'Toole et al. [2022\)](#page-30-15) as assigned by the pangolin tool (O'Toole et al.  $\mu$ [2021\)](#page-31-10): early initial variants, Pango B.1.177, Alpha (Pango B.1.1.7), Delta (Pango B.1.617.2/AY), as well  $\epsilon$ as two major Omicron lineages (i.e., Pango B.1.1.529/BA.1 and Pango BA.2). The results yield insights <sup>86</sup> into SARS-CoV-2 epidemiology within Ireland during each analysed time period, including SARS-CoV-2 <sup>87</sup> importation frequencies as well as the subsequent geographic spread of infections. The workflow presented <sup>88</sup> here is generalisable (i.e., it can be applied to any geographic region and virus of interest given sufficient <sup>89</sup> sequencing data is available) and therefore can inform and improve global public health responses to both  $\sim$ present and future viral and other pathogens.

# Materials and Methods 92

#### $\mathbf{Data}$  and  $\mathbf{Data}$

**SARS-CoV-2 phylogenetic tree** A global SARS-CoV-2 phylogeny (Lanfear [2020\)](#page-30-16) dated  $20^{th}$  May 94 2022 was downloaded from GISAID EpiCoV<sup>™</sup> (Khare et al. [\(2021\)](#page-29-11), <https://www.gisaid.org>) on 24<sup>th</sup> 95 May 2022. This phylogenetic tree is based on the masked alignment of 7,603,547 high quality SARS-CoV-2  $\frac{96}{100}$ genome sequences (Figure S1).  $\frac{97}{200}$ 

Introductions SARS-CoV-2 sequence metadata Metadata including the date and country of 98 sample collection for all GISAID sequences was downloaded on  $4<sup>th</sup>$  June 2022. We have employed the  $\frac{99}{2}$ GISAID nomenclature to attribute samples to countries.

SARS-CoV-2 confirmed cases The number of daily confirmed SARS-CoV-2 cases for NI and RoI 101 [w](https://coronavirus.data.gov.uk)ere downloaded from the Coronavirus (COVID-19) in the UK dashboard ([https://coronavirus.data.](https://coronavirus.data.gov.uk) 102 [gov.uk](https://coronavirus.data.gov.uk)) and Ireland's COVID-19 Data Hub (<https://covid-19.geohive.ie>) respectively. <sup>103</sup>

Passengers arriving to Ireland by air Our study analyzed aviation data pertaining to passengers 104 [t](https://www.nisra.gov.uk/statistics/tourism/northern-ireland-air-passenger-flow-statistics)raveling to Ireland between March 2020 and June 2022 as sourced from NISRA ([https://www.nisra.](https://www.nisra.gov.uk/statistics/tourism/northern-ireland-air-passenger-flow-statistics) 105 [gov.uk/statistics/tourism/northern-ireland-air-passenger-flow-statistics](https://www.nisra.gov.uk/statistics/tourism/northern-ireland-air-passenger-flow-statistics)) for NI and CSO <sup>106</sup> (<https://data.cso.ie/table/TAM05>) for RoI. While CSO data for RoI was directionally-resolved, <sup>107</sup> allowing raw use of arriving passenger numbers, monthly arrival passenger populations for NI were 108 estimated by halving the published passenger flow values (i.e., monthly arrivals  $=\frac{\text{ monthly passengers}}{2}$ ).

Passengers arriving to Ireland by sea To monitor the arrival of short sea ferry passengers traveling 110 from Great Britain (GB) to the island of Ireland, we considered routes originating from Cairnryan <sup>111</sup> (Scotland), Fishguard (Wales), Holyhead (Wales), Liverpool (England), or Pembroke (Wales) and <sup>112</sup> terminating at Belfast (NI), Dublin (RoI), Larne (NI), or Rosslare (RoI). We also compiled data on <sup>113</sup> international sea passenger routes to Ireland, which included routes departing from Bilbao (Spain), <sup>114</sup> Cherbourg (France), and Rosscoff (France). These routes led to Cork, Dublin, and Rosslare in RoI. <sup>115</sup> To obtain the sea passenger numbers for RoI, we used data from the Central Statistics Office (CSO). <sup>116</sup> [S](https://data.cso.ie/table/ASM03)pecifically, we utilised the sum of the air and sea monthly directionally-resolved passenger data ([https:](https://data.cso.ie/table/ASM03) 117 [//data.cso.ie/table/ASM03](https://data.cso.ie/table/ASM03)) and then subtracted the corresponding figures for air travel ([https:](https://data.cso.ie/table/TAM05) <sup>118</sup> [//data.cso.ie/table/TAM05](https://data.cso.ie/table/TAM05)). 119

Population density for government districts in Ireland Population data within RoI and NI were 120 [o](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1)btained from CSO (<https://data.cso.ie/table/FP001>) and NISRA ([https://www.nisra.gov.uk/](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1) <sup>121</sup> [publications/census-2021-main-statistics-for-northern-ireland-phase-1](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1)), respectively. To 122 compute the population densities, the population within each government district was divided by 123 the corresponding geographic area of the district, as sourced by Ordnance Survey of Northern Ire- <sup>124</sup> [l](https://www.opendatani.gov.uk/dataset/osni-open-data-largescale-boundaries-local-government-districts-20121)and (OSNI, [https://www.opendatani.gov.uk/dataset/osni-open-data-largescale-boundaries-](https://www.opendatani.gov.uk/dataset/osni-open-data-largescale-boundaries-local-government-districts-20121) 125 [local-government-districts-20121](https://www.opendatani.gov.uk/dataset/osni-open-data-largescale-boundaries-local-government-districts-20121)) for NI and Ordnance Survey Ireland (OSI; Irish: Suirbhéireacht 126 Ordanáis Eireann, <https://data-osi.opendata.arcgis.com>) for RoI. See Table S1 for the values used 127 in the computation of population density.

Deprivation for government districts in Ireland The population data of subgroups in NI are <sup>129</sup> primarily available at the level of Super Output Areas (SOAs). These areas were developed by the <sup>130</sup> Northern Ireland Statistics and Research Agency (NISRA) with the aim of improving small-area statistics, <sup>131</sup>

and they were first produced for the 2011 census outputs (Northern Ireland Statistics and Research 132 Agency [2013\)](#page-30-17). Multiple deprivation measures in SOAs are presented as rankings, with SOAs in NI ranked 133 from 1 (most deprived) to 890 (least deprived) (Northern Ireland Statistics and Research Agency [2017\)](#page-30-18). <sup>134</sup> Ranked-based data is deemed unsuitable for measurements, thus an indirect calculation of the level of 135 deprivation is necessary using alternative data such as income level. <sup>136</sup>

SOA data can be disaggregated into grid cells using the dasymetric technique (Firoozi Nejad [2016\)](#page-29-12). As 137 such, this method can be applied to disaggregate deprivation data (e.g., income level) from the SOA level 138 into grid cells, generating grid-based deprivation data across NI. These outcomes can be subsequently <sup>139</sup> merged with administrative areas to estimate the level of deprivation within those regions. <sup>140</sup>

In NI, The proportion of the population residing in households with equivalised income below 60% of the NI median (Northern Ireland Statistics and Research Agency [2017\)](#page-30-18) at the SOA level is utilised as a metric for measuring deprivation  $(\%)$ . For this analysis, WorldPop data for the entirety of NI in 2020 is also utilised. The dataset is obtainable at a granular level of grid cells (100m cell at the Earth's equator) for both the UK and Ireland, with the units representing the number of individuals per cell (Bondarenko et al. [2020\)](#page-28-18). To determine the number of individuals inhabiting each SOA (2020), population grid cells are utilised. Subsequently, the % of individuals living in deprivation is converted into the "number of deprived individuals in SOA", and a straightforward algebraic expression is employed to devise a weighted overlay technique for disaggregating the number of deprived individuals into grid cells:

Population value in grids<br>Total population within  $SOA$  × number of deprived individuals in SOA

The results, which represent the number of deprived individuals in grid cells, are superimposed onto  $_{141}$ administrative boundaries to estimate the number of deprived individuals within each area. Subsequently, <sup>142</sup> these figures are transformed into a percentage of deprived individuals within administrative areas, <sup>143</sup> utilising total population data in each SOA. <sup>144</sup>

Deprivation data (deprivation score) for the RoI is accessible at the administrative level of county <sup>145</sup> councils (Teljeur et al. [2019\)](#page-31-11). Irish SARS-CoV-2 genomes and metadata for substitution rate estimation The entire GISAID 161 FASTA and metadata databases were downloaded on 18th February 2023 to analyse population-wide SARS- <sup>162</sup> CoV-2 genomics in Ireland. These data were then filtered to extract Irish samples (i.e., country='Ireland' 163 or country='NorthernIreland') using augur filter  $v21.0.1$  (Hadfield et al. [2018\)](#page-29-13).

## Identifying and removing tree outliers 176

To identify samples that potentially have incorrect collection dates in their associated metadata or <sup>177</sup> deviate substantially from their expected position in the tree under a molecular clock, the GISAID <sup>178</sup> phylogenetic tree and sample collection dates were input to Chronumental v0.0.50 (Sanderson [\(2022\)](#page-31-12), <sup>179</sup> <https://github.com/theosanderson/chronumental>) to estimate a time-tree from the phylogeny. The <sup>180</sup> difference between sample collection dates and the date predicted by Chronumental was calculated and 181 a Z-score was calculated for each sample. Samples with a Z score greater than  $+3$  or less than  $-3$  were 182 excluded from further analysis. These Z scores equate to roughly  $a \pm 60$  days difference in date. This 183 step excluded  $0.6\%$   $(46,278/7,603,547)$  of samples in the tree (Figure S2).

## $\blacksquare$  Creating subtrees the state of  $\blacksquare$

GoTree v0.4.3 (Lemoine and Gascuel [\(2021\)](#page-30-19), <https://github.com/evolbioinfo/gotree>) was used to 186 prune the GISAID phylogenetic tree to subtrees used in subsequent analyses. Some NI samples were <sup>187</sup> suspected to be erroneously labelled as being from NI. These "NI samples" with IDs other than 'NIRE-' <sup>188</sup> were excluded when subtrees were created. Non-NIRE samples account for 5,427 NI samples.

## $\alpha$  Reconstructing ancestral location of lineages  $190$

To infer ancestral locations of samples, a phylogenetic tree and the country of each sample in the <sup>191</sup> tree was provided to PastML. Locations, at the level of countries, was inferred for each ancestral 192 node of the phylogenetic tree (internal points between tips and the root of the tree that represent an  $_{193}$ ancestral state) using the DELTRAN (delayed transformation) method (Swofford and Maddison [1987\)](#page-31-13) in <sup>194</sup> PastML v1.9.34 (Ishikawa et al. [\(2019\)](#page-29-14), <https://github.com/evolbioinfo/pastml>). Additionally, the 195 -resolve\_polytomies PastML option was enabled. 196

## Clustering of sequences to identify independent introductions to Ireland 197

DendroPy v4.5.2 (Sukumaran and Holder [\(2010\)](#page-31-14), <https://dendropy.org>) was used to traverse the <sup>198</sup> output trees from PastML to identify Irish tips of the tree that were descended from ancestral nodes with <sup>199</sup> a non-Irish country label assigned by PastML. We define all Irish tips linked to an importation event to <sup>200</sup> comprise an introduction cluster.

The following periods were selected to span from prior to the first detected sequence of each major 202 lineage in Ireland until they reached dominance. <sup>203</sup>

**Period A - Initial introductions** To identify initial introductions to Ireland, the tree was pruned 204 to include only sequences from the start of the pandemic up to the end of May 2020 and rooted using  $_{205}$ Wuhan-Hu-1 (GISAID: EPI ISL 402125) as an outgroup. Rooting a tree is the process of deciding which  $_{206}$ part of the tree is the oldest point and gives the direction of evolution moving from the root to the tips of 207 the tree (Figure S3). An outgroup, a tip or lineage outside the group of tips of interest yet related to the <sup>208</sup> the group, allows the root to be determined. Here, we use one of the earliest SARS-CoV-2 sequences  $_{209}$ as the outgroup to the rest of sequences in the tree. This tree included 103,316 tips of which 714 are  $_{210}$ from the RoI and 633 are from NI (Figure S4). Ancestral location of lineages was inferred by PastML as <sup>211</sup> above. Location could not be resolved for 64 nodes  $(0.05\%)$  and 2,053 new internal nodes were created by  $_{212}$ resolving polytomies.

Period B - B.1.177 To identify Pango (O'Toole et al. [2022\)](#page-30-15) lineage B.1.177 introductions to Ireland, <sup>214</sup> the tree was pruned to include only B.1.177.\* sequences (and renamed sublineages of B.1.177.\*: AA.1, <sup>215</sup> AA.2, AA.3, AA.4, AA.5, AA.6, AA.7, AA.8, Z.1, Y.1, W.1, W.2, W.3, W.4, V.1, V.2, U.1, U.2, U.3) <sup>216</sup> from the first non-outlier occurrence of B.1.177 to the end of October 2020, and rooted using Wuhan-Hu-1 <sup>217</sup> (GISAID: EPI ISL 402125) as an outgroup (Figure S5). This tree included 31,869 tips of which  $215$  218 are from RoI and 235 are from NI. Ancestral location of lineages was inferred by PastML as above. <sup>219</sup>

Location could not be resolved for 4 nodes  $(0.01\%)$  and 364 new internal nodes were created by resolving  $_{220}$ polytomies. 221

**Period C - B.1.1.7 - Alpha** To identify Pango lineage B.1.1.7 introductions to Ireland, the tree was  $_{222}$ pruned to include only B.1.1.7 sequences (and renamed sublineages of B.1.1.7.\*: Q.1, Q.2, Q.3, Q.4, Q.5, <sup>223</sup> Q.6, Q.7, Q.8) from the first non-outlier occurrence of B.1.1.7 to the end of February 2021, and rooted <sup>224</sup> using Wuhan-Hu-1 (GISAID: EPI ISL 402125) as an outgroup (Figure S6). This tree included 183,092 <sub>225</sub> tips of which 2,850 are from RoI and 461 are from NI. Ancestral location of lineages was inferred by 226 PastML as above. Location could not be resolved for 45 nodes  $(0.02\%)$  and 2,181 new internal nodes  $_{227}$ were created by resolving polytomies. 228

**Period D - B.1.617.2/AY - Delta** To identify Delta introductions to Ireland, the tree was pruned to  $_{229}$ include only B.1.617.2/AY sequences from the first non-outlier occurrence to the end of July 2021, and <sup>230</sup> rooted using Wuhan-Hu-1 (GISAID: EPI ISL 402125) as an outgroup (Figure S7). This tree included  $_{231}$ 512,420 tips of which 4,923 are from RoI and 1,613 are from NI. Ancestral location of lineages was inferred <sup>232</sup> by PastML as above. Location could not be resolved for 287 nodes (0.05%) and 6,363 new internal nodes <sup>233</sup> were created by resolving polytomies.

Period E - B.1.1.529/BA.1 - Omicron To identify Omicron introductions to Ireland, the tree was 235 pruned to include only B.1.1.529/BA.1 sequences from the first non-outlier occurrence to the end of <sup>236</sup> January 2022, and rooted using Wuhan-Hu-1 (GISAID: EPI\_ISL\_402125) as an outgroup (Figure S8). 237 This tree included 1,313,634 tips of which 7,888 are from the RoI and 3,615 are from NI. Ancestral <sup>238</sup> location of lineages was inferred by PastML as above. Location could not be resolved for 497 nodes <sup>239</sup>  $(0.03\%)$  and  $22.546$  new internal nodes were created by resolving polytomies.

**Period F - BA.2 - Omicron** To identify BA.2 introductions to Ireland, the tree was pruned to include <sub>241</sub> only B.2 sequences from the first non-outlier occurrence to the end of March 2022, and rooted using <sup>242</sup> Wuhan-Hu-1 (GISAID: EPI ISL 402125) as an outgroup (Figure S9). This tree included 644,494 tips of 243 which 1,235 are from RoI and 5,136 are from NI. Ancestral location of lineages was inferred by PastML as  $_{244}$ above. Location could not be resolved for 338 nodes  $(0.05\%)$  and 12,722 new internal nodes were created  $_{245}$ by resolving polytomies. <sup>246</sup>

## Downsampling tips from England 247

To determine the effect of the relative over-representation of English samples in the tree on the high <sup>248</sup> level of English introductions identified to Ireland, we randomly downsampled tips from England in the <sup>249</sup> tree. Between  $10\%$ -90% of English samples were randomly removed from the tree in  $10\%$  increments, 250 with three replicates at each increment. Downstream analysis to identify introductions to Ireland was  $_{251}$ conducted as before.

# Downsampling tips from Ireland 253

To determine the effect of the level of sequencing in Ireland on the number and size of Irish introductions <sup>254</sup> for the island as a whole and for each jurisdiction, we randomly downsampled tips from NI, RoI, and  $_{255}$ Ireland in the tree. Between  $10\%$ -90% of samples from Ireland were randomly removed from the tree in  $_{256}$ 10% increments, with one replicate at each increment. Downstream analysis to identify introductions to <sup>257</sup> Ireland and clusters size was conducted as before.

# $Estimation of total vs. identified introductions$  259

A goal of this study was to evaluate the number of genetic sequences that would be required to identify <sup>260</sup> all SARS-CoV-2 introductions to Ireland. To determine the additional number of introductions  $(I)$  that  $_{261}$ could be identified by analysing more sequences  $(S)$ , we utilised ordinary least-squares (OLS) linear  $_{262}$ regression function scipy.stats.linregress from the Python library SciPy (Virtanen et al. [2020\)](#page-32-4). <sup>263</sup>

For each period, let S be the total number of available sequences and  $\mathbb{I}$  be the corresponding number of introductions to Ireland identified. During downsampling, it is appropriate to select  $N$  (e.g., 10)

evenly-spaced downsampled sequencing values  $s_i$  such that

$$
s_i = i \bullet \frac{\mathbb{S}}{N} \quad \text{for } i = 1, 2, \dots, N,
$$

which yields an equivalent array

$$
S = \boxed{s_1 \mid s_2 \mid \ldots \mid \mathbb{S}} = \boxed{\frac{\mathbb{S}}{N} \mid \frac{2\mathbb{S}}{N} \mid \ldots \mid \mathbb{S}} = \boxed{\frac{\mathbb{S}}{N} \mid \frac{\mathbb{S}}{N} + \Delta S \mid \ldots \mid \mathbb{S}},
$$

where  $\Delta S \equiv \frac{S}{\Delta}$ N

Through performing randomised downsampling of Irish tips in the phylogeny to each of the levels in array  $S$  and detecting introductions for each, a corresponding array for introductions,  $I$ , will be obtained:

$$
I = \begin{array}{|c|c|c|c|c|} \hline I_1 & I_2 & \ldots & \mathbb{I} \end{array},
$$

where  $I_1$  is the introductions predicted by downsampling to level  $s_1$ , etc.

A numerical difference array (with size of  $N-1$ ) can be calculated from I:

$$
\Delta I = \begin{array}{|c|c|c|c|c|} \hline I_2 - I_1 & I_3 - I_2 & \dots & \mathbb{I} - I_{N-1} \end{array}
$$

which enumerates the successively decreasing additional introductions identified upon increasing sequencing  $_{266}$ by  $\Delta S$ . 267

We suppose that these diminishing returns of increased sequencing will continue to hold, such that at a sequencing saturation point  $\mathbb{S}_{all}$ , all predicted introductions,  $\mathbb{I}_{all}$ , would be identified and there would  $\mathbb{I}_{269}$ be limited additional value to increasing sequencing levels. <sup>270</sup>

To estimate Sall, the sequencing level required to predict all introductions, we perform OLS linear regression to assess the relationship:

$$
\Delta I = m \bullet S + c,
$$

where m represents the slope of the linear regression line and c represents the intercept of the linear  $_{271}$ regression line. Note that as S has one element fewer than  $\Delta I$ , we must prepend an element to  $\Delta I$ , such 272 that the first element contains the value  $I_1$ , as the number of additional introductions identified from  $273$ zero sequencing to the level of  $s_1$  is  $I_1$ .

To apply the regression equation for extrapolation, values for S greater than the number of sequences obtained (S) may be input to compute new values for  $\Delta I$ . Therefore, increased sequencing will provide additional introductions until  $\Delta I = 0$ , where  $S = S_{all}$ , which is the intersection of the regression line with the S axis:  $\mathbb{S}_{\text{all}} = \frac{-c}{m}$ :

$$
\Delta I = 0 = m \bullet \mathbb{S}_{\text{all}} + c \to \mathbb{S}_{\text{all}} = \frac{-c}{m},
$$

thereby creating an upper bound for the extrapolation of S. 275

To calculate  $\mathbb{I}_{\text{all}}$ , extrapolated S values (S<sub>extrapolation</sub>) are firstly generated in an array from  $\mathbb{S} + \Delta S$ to  $\mathbb{S}_{\text{all}}$ :

$$
S_{\text{extrapolation}} = \boxed{\mathbb{S} + \Delta S \mid \mathbb{S} + 2\Delta S \mid \dots \mid \mathbb{S}_{\text{all}}}
$$

Inputting these ( $S_{\text{extrapolation}}$ ) values into the regression equation, we similarly obtain  $\Delta I_{\text{extrapolation}}$ :

$$
\Delta I_{\text{extrapolation}} = m \bullet S_{\text{extrapolation}} + c.
$$

Each extrapolated  $\Delta I$  value within  $\Delta I_{\text{extrapolation}}$  is summed with I to predict I<sub>all</sub>, the total number of 276 introductions to Ireland within the period. 277

Note that our analysis assumes that the number of additional introductions is directly proportional  $_{278}$ to the total number of sequences. However, this assumption may not hold true, and future research in <sup>279</sup> this area will need to be undertaken to determine the ideal functional form with which to perform such <sup>280</sup> extrapolations. 281

#### $Geospatial mapping$  282

GeoPandas v0.11.1 (Jordahl et al. [\(2022\)](#page-29-15), <https://geopandas.org>) was used to facilitate geospatial 283 visualisations of SARS-CoV-2 introductions to Ireland. As source data, two geospatial vector data files (i.e., <sup>284</sup> [s](https://gadm.org)hapefiles) were downloaded from the GADM Database of Global Administrative Areas ([https://gadm.](https://gadm.org) 285 [org](https://gadm.org)), which aims to provide high-quality maps of the administrative areas of all countries, at all recognised <sup>286</sup> levels of sub-division to be utilised freely for non-commercial use. The shapefile gadm41\_IRL\_1.shp as  $_{287}$

The geographic resolution of RoI 292 county and NI LGD is identical to the metadata fields accessible in GISAID or COG-UK metadata, <sup>293</sup> allowing each sample to be associated to a distinct geographic region within Ireland. To create a map <sup>294</sup> for the entire island of Ireland, NI was extracted from the shapefile containing the entirety of the UK <sup>295</sup> and was merged with the shapefile containing RoI. Due to limited fine-detail information, sequenced <sup>296</sup> samples were estimated to originate from the most populous settlement of each district as determined by 297 Northern Ireland Statistics and Research Agency (NISRA; Irish: Gníomhaireacht Thuaisceart Eireann um <sub>298</sub> [S](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1)taitisticí agus Taighde, [https://www.nisra.gov.uk/publications/census-2021-main-statistics-](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1) 299 [for-northern-ireland-phase-1](https://www.nisra.gov.uk/publications/census-2021-main-statistics-for-northern-ireland-phase-1)) for NI cities or Central Statistics Office (CSO; Irish: An Phríomh- 300 Oifig Staidrimh, <https://data.cso.ie/table/FP001>) for RoI cities. Latitudes and longitudes of these 301 representative cities were obtained from Microsoft Bing Maps (<https://www.bing.com/maps>). To <sup>302</sup> annotate the maps, Troendle–Simpson–Skvortsov 2-letter abbreviation codes were devised for each local <sup>303</sup> government district as indicated in Table S1.  $304$ 

#### Spatial statistical analysis of Geographic Information System (GIS) data

Spatial statistical analyses of Geographic Information System (GIS) data were automated by the Spatial <sup>306</sup> [S](https://www.esri.com/en-us/arcgis/products/arcgis-pro/overview)tatistics toolbox in the ArcGIS Pro v3.0.2 (Build 3.0.2.36056) software developed by Esri ([https:](https://www.esri.com/en-us/arcgis/products/arcgis-pro/overview) 307 [//www.esri.com/en-us/arcgis/products/arcgis-pro/overview](https://www.esri.com/en-us/arcgis/products/arcgis-pro/overview)). Geospatial data was input to the <sup>308</sup> Spatial Statistics toolbox in ArcGIS Pro in the form of shapefiles, geodatabases, or feature classes, <sub>309</sub> containing both the attribute and location data of the features being analysed. <sup>310</sup>

The Ordinary Least Squares (OLS) functionalities used within the ArcGIS Pro Spatial Statistics <sup>311</sup> toolbox provide the results of bivariate regression of two independent variables: population density, and  $\frac{312}{2}$ deprivation in correlation with the dependent variable: the proportion of Irish tips sequenced in the region <sup>313</sup> linked to introduction and spreading events within the periods studied. The specific statistical measures  $\frac{314}{2}$ revealed by the OLS functionalities are p-values, robust p-values, adjusted  $R^2$ s, variance inflation factors  $\frac{1}{315}$ (VIFs), and Koenker (BP) statistic (i.e., Koenker's studentised Bruesch-Pagan statistic) probabilities. <sup>316</sup>

## $SARS-CoV-2$  genomic trends in Ireland  $317$

We separately aligned each Irish genomic sequence from GISAID with Pango lineages corresponding to those of the six periods studied  $(N=140.121)$  to the Wuhan-Hu-1 reference genome (GISAID:  $\frac{319}{200}$ EPI ISL 402125) using MAFFT v7.453 (Katoh et al. [2002\)](#page-29-16). The number of substitutions in each Irish 320 genome compared to the Wuhan-Hu-1 reference genome was determined by calculating the Hamming  $_{321}$ distance (Hamming [1950\)](#page-29-17), which tallies the minimum number of substitutions required to change the  $\frac{322}{2}$ reference sequence into a subject sequence of equal length, while excluding the contributions of insertions,  $\frac{323}{2}$ deletions, and Ns in the subject sequence.

To analyse substitution rates per period, we conducted ordinary least squares (OLS) linear regression <sup>325</sup> [u](https://scikit-learn.org)sing the LinearRegression model from scikit-learn v1.1.3 (Pedregosa et al. [\(2011\)](#page-31-15), [https://scikit-](https://scikit-learn.org) <sup>326</sup> [learn.org](https://scikit-learn.org)). The data in Table S8 includes error estimates and p-values from regressions that were nearly 327 identical, but conducted using the OLS functionality in statsmodels v0.13.5 (Seabold and Perktold [\(2010\)](#page-31-16), <sup>328</sup> <https://www.statsmodels.org>). 329

# $\textbf{Results}$  and  $\textbf{330}$

Confirmed SARS-CoV-2 cases followed similar trends in NI and RoI, with some differences including  $\frac{331}{2}$ more cases in NI in autumn 2021 and Feb 2022 and more in RoI in Jan 2022 (Figure [1A](#page-10-0)), which may 332 reflect disparities in viral epidemiology and/or pandemic response measures between the two jurisdictions. 333 The number of samples sequenced per month was mirrored between NI and RoI, with the per capita rate <sup>334</sup> being higher in NI (Figure [1B](#page-10-0)). Successive waves of dominant SARS-CoV-2 Pango (O'Toole et al. [2022\)](#page-30-15) 335 lineages were very similar, with a few other lineages persisting in RoI after the introduction of Alpha and <sup>336</sup> a delayed rise in Omicron BA.2 in NI (Figure [1C](#page-10-0)). The introduction of these lineages to the island of  $\frac{337}{2}$ Ireland will be our focus here. 338

To estimate the number of SARS-CoV-2 introductions to the island of Ireland, we used a phylogenetic <sup>339</sup> tree from May 2022 available from GISAID  $EpiCoV''$  (Lanfear [2020\)](#page-30-16). This tree was based on the masked  $\frac{340}{2}$ alignment of 7,603,547 high quality SARS-CoV-2 genome sequences. To identify sequenced samples that <sup>341</sup> have incorrect metadata collection dates or deviate substantially from their expected position in the tree  $\frac{342}{4}$ under a molecular clock, a time-tree was estimated from the phylogeny. Outliers, equating to roughly a  $\frac{343}{2}$  $\pm$  60 days difference between metadata date and predicted date, were excluded from further analysis 344 (Figure S2). This step excluded 0.6% (46,278/7,603,547) of sequences. A number of analysis periods, A to <sup>345</sup> F, were chosen as critical periods during the SARS-CoV-2 pandemic when important viral importations <sup>346</sup>  $\alpha$  occurred (Figure [1D](#page-10-0)).  $\frac{347}{2}$ 

Due to inconsistencies between country and fine-grain location metadata, some NI samples were 348 suspected to be erroneously labelled as being from NI. This could overestimate the number of identified <sup>349</sup> introductions. Samples with an NIRE prefix ID (e.g. NIRE-000107) should all be collected and sequenced <sup>350</sup> in NI and correctly attributed a country location of NI. Samples with NIRE prefix IDs comprise  $84.3\%$  <sup>351</sup> of NI samples in the phylogenetic tree, while RAND IDs comprise 8.2%, NORT IDs 2.7%, and 15 <sup>352</sup> other prefixes total 4.8% of NI samples. Therefore, identified NI introductions were filtered to consider <sup>353</sup> introductions that consisted of NIRE IDs only. This excluded 5,427 NI samples. <sup>354</sup>

#### SARS-CoV-2 introductions from Europe and USA seeded early pandemic  $\frac{355}{355}$

Despite the relatively low numbers of sequenced samples in both RoI and NI from 2020 (Figure [1B](#page-10-0)), some  $\frac{356}{2}$ insights can be gleaned about the nature of these early importations. The first analysis period (Period  $\frac{357}{257}$ A) is the beginning of the pandemic and aims to quantify the initial introductions of SARS-CoV-2 to  $\frac{358}{100}$ the island of Ireland (Figure [1C](#page-10-0)&D). The tree was pruned to include only sequences from the start of  $\frac{359}{100}$ the pandemic up to the end of May 2020. This tree included 103,316 tips of which 714 are from RoI  $_{360}$ and 633 are from NI. A country was estimated for each ancestral lineage of the phylogenetic tree using  $\frac{361}{100}$ the DELTRAN (delayed transformation) method. SARS-CoV-2 introductions to Ireland could then be  $\frac{362}{100}$ inferred by Irish sequences that are descendants of a non-Irish ancestral node in the tree.

This method estimates that at least 170 independent introductions of SARS-CoV-2 took place in the <sup>364</sup> time period up to the end of May 2020, 103 to RoI and 67 to NI, with three intra-Irish introductions, two <sub>365</sub> from RoI to NI and one from NI to RoI. The majority of introductions originated from Europe, with  $\frac{366}{1000}$ 59.5% of introductions from England, 10.1% from the United States of America, and 4.8% from Scotland 367 (Figure [2](#page-12-0) Period A left, Table S2). There was a significant positive correlation between the number of <sup>368</sup> introductions from a country and the number of tips in the tree from a country ( $\rho = 0.75$ ,  $P = 0.002$ ,  $\frac{369}{256}$ Spearman's rank correlation; Figure [2](#page-12-0) Period A centre). There was no correlation between the number  $\frac{370}{20}$ of introductions from a country and its distance from Ireland ( $\rho = -0.47$ ,  $P = 0.45$ , Spearman's rank  $\sigma_{31}$ correlation; Figure [2](#page-12-0) Period A right).  $372$

## B.1.177 and Alpha introductions originated predominantly from England  $\frac{373}{373}$

The second analysis period (Period B) focuses on the emergence of Pango lineage B.1.177 over summer 374 2020 until the end of October 2020 by which time B.1.177 had become dominant in Ireland (Figure [1C](#page-10-0)&D).  $\frac{375}{2}$ The phylogenetic tree was pruned to contain B.1.177 sequences from this time and included 31,869 tips, of  $\sigma$ which 215 were from RoI and 235 were from NI. There were 41 introductions identified, of which 23 were  $\frac{377}{27}$ into NI and 18 into RoI (Table S3). Almost all introductions originated from Great Britain, with 85% of  $\frac{378}{278}$ introductions from England (Figure [2](#page-12-0) Period B left). With only four unambiguous countries (England, <sup>379</sup> Scotland, Wales, & Spain) for all importations in this period (Table S4), no meaningful correlation with <sup>380</sup> number of tips in the phylogenetic tree and distance from Ireland could be performed (Figure [2](#page-12-0) Period B 381

centre and right).  $\frac{382}{20}$ 

Period C focuses on introductions of B.1.1.7 Alpha lineage until the end of February 2021 (Figure [1C](#page-10-0)&D). 383 The phylogenetic tree was pruned to 183,092 tips of which 2,850 were from RoI and 461 were from NI. There  $\frac{384}{100}$ were 173 introductions into the RoI from outside Ireland, and 45 into NI (Table S4). Additionally, there  $\frac{385}{100}$ were 25 introductions between RoI and NI (14 from NI and 11 from RoI). The majority of introductions  $\frac{386}{100}$ originated from England  $(81.1\%)$ , followed by Germany  $(4.1\%)$ , and USA  $(2.3\%$ ; Figure [2](#page-12-0) Period C left).  $\frac{387}{2}$ While there was no correlation between the number of introductions and the distance from Ireland, there <sub>388</sub> was a significant positive correlation between the number of introductions from a country and the number  $\frac{389}{100}$ of tips in the tree from a country ( $\rho = 0.85$ ,  $P = 0.0003$ , Spearman's rank correlation; Figure [2](#page-12-0) Period C 390 right and centre, respectively).

#### Delta lineage imported from England, Europe, and India

Period D focuses on introductions of Delta lineages (Pango lineages B.1.617.2/AY) until the end of July 393  $2021$  (Figure [1C](#page-10-0)&D).  $394$ 

The phylogenetic tree was pruned to 512,420 tips of which 4,923 are from RoI and 1,613 are from NI. 395 There were 454 introductions into RoI from outside Ireland, 273 into NI, and one introduction to either 396 RoI/NI (Table S5). Additionally, there were 73 introductions between RoI and NI (31 from NI and 42 <sub>397</sub> from RoI). The majority of introductions originated from England  $(66.1\%)$ , followed by Scotland  $(6.1\%)$ ,  $\frac{398}{2}$ India  $(5.3\%)$ , and Spain  $(3.4\%;$  Figure [3](#page-14-0) Period D left). Interestingly, these are not balanced between  $\frac{399}{2}$ NI and RoI. There were 228 introductions from England to NI (83.5% of NI introductions) yet only 224  $_{400}$ introductions to RoI (49.3% of RoI introductions). Conversely, there were 33 introductions from India to <sup>401</sup> RoI (7.2% of RoI introductions), and 23 from Spain  $(5.1\%)$  yet only 5 introductions from India to NI  $_{402}$  $(1.8\% \text{ of NI introductions})$  and 1 from Spain  $(0.4\%)$ .

For Period D, we found a significant positive correlation between the number of introductions from a  $_{404}$ country and the number of tips in the tree from that country ( $\rho = 0.77$ ,  $P = 1.4 \times 10^{-6}$ , Spearman's  $405$ rank correlation; Figure [3](#page-14-0) Period D centre). There was also a significant correlation between the number  $406$ of introductions from a country and the distance of each country from Ireland ( $\rho = -0.65$ ,  $P = 0.0004$ ,  $\omega$ Spearman's rank correlation; Figure [3](#page-14-0) Period D right).

#### England and USA account for majority of BA.1 introductions  $\frac{409}{409}$

Period E focuses on introductions of the Omicron (BA.1) lineage (Figure [1C](#page-10-0)&D).

The phylogenetic tree was pruned to include 1,313,634 tips of which 7,888 were from RoI and 3,615  $_{411}$ were from NI. There were 1,937 introductions to Ireland (1,329 introductions into RoI and 608 into  $_{412}$ NI) and 69 introductions between RoI and NI (31 from NI and 38 from RoI; Table S5). About half of  $\frac{413}{100}$ introductions were from England (50.8%), followed by USA (26.7%), and France (6.3%; Figure [3E](#page-14-0) left).  $_{414}$ 

We found a significant positive correlation between the number of introductions from a country and  $\frac{415}{415}$ the number of tips in the tree from that country for Period E ( $\rho = 0.79$ ,  $P = 5.3 \times 10^{-10}$ , Spearman's 416 rank correlation; Figure [3](#page-14-0) Period E centre). There was also a significant correlation between the number  $417$ 

of introductions from a country and the distance of each country from Ireland ( $\rho = -0.51$ ,  $P = 0.003$ ,  $\mu$ 18 Spearman's rank correlation; Figure [3](#page-14-0) Period E right).

#### BA.2 introductions predominantly from Northern Europe  $420$

Period F focuses on introductions of the Omicron  $(BA.2)$  lineage (Figure [1C](#page-10-0)&D).

The phylogenetic tree was pruned to include  $644.494$  tips of which 1,235 were from the RoI and 5,136  $_{422}$ were from NI. There were 1,309 introductions to Ireland (428 introductions into the RoI and 881 into  $423$ NI) and 34 introductions between RoI and NI (29 from NI and 5 from the RoI; Table S6). England  $424$  $(60.6\%)$ , Denmark  $(10.7\%)$ , Scotland  $(8.6\%)$ , and Germany  $(6.1\%)$  were the most frequently observed  $_{425}$ origin countries for importations (Figure [3](#page-14-0) Period F left). <sup>426</sup>

For Period F, we found a significant positive correlation between the number of introductions from a  $_{427}$ country and the number of tips in the tree from that country ( $\rho = 0.91$ ,  $P = 6.8 \times 10^{-11}$ , Spearman's 428 rank correlation; Figure [3](#page-14-0) Period F centre). There was also a significant correlation between the number  $_{429}$ of introductions from a country and the distance of each country from Ireland ( $\rho = -0.60$ ,  $P = 0.006$ , 430 Spearman's rank correlation; Figure [3](#page-14-0) Period F right).

#### Clusters comprising multiple Irish sequences vary greatly in size  $\frac{432}{432}$

A cluster of multiple Irish sequences that arise from a single introduction event can be informative about <sup>433</sup> virus spreading and epidemiology when combined with geographic or other information. However, 63.2% <sup>434</sup>  $(2,782/4,403)$  of introductions across all six periods resulted in detection of only a single Irish descendant  $435$ (Figure [4\)](#page-15-0), with the percentage at specific periods varying from  $38.1\%$  (Period C) to  $68.9\%$  (Period E)  $_{436}$ between periods studied. The largest cluster in each period ranged from 124 sequences in Period B to <sup>437</sup> 2,228 sequences in Period F. The large number of clusters having few samples implies that despite the <sup>438</sup> globally high per capita sequencing rate in Ireland, the level of WGS sequencing may be insufficient <sup>439</sup> to detect most cases spreading from each introduction and the number of importations will have been <sup>440</sup> underestimated. Any conclusions regarding geographic spread must be tempered by this limitation and <sup>441</sup> also take into account the variable proportion of positive cases sequenced as a result of changing case <sup>442</sup> numbers and sequencing effort.  $\frac{443}{4}$

## Introductions from England exceed predictions based on sample numbers in  $\frac{444}{444}$ the global phylogeny and the global phylogeny

Countries with an open, high-throughput variant surveillance program will feature more frequently in <sup>446</sup> the phylogenetic tree than other countries that have made few sequences publicly available. There is a  $_{447}$ strong relationship between the number of tips in the tree from a specific country and the number of <sup>448</sup> introductions from the same country (Figures [2](#page-12-0) and [3\)](#page-14-0). England is the most frequent origin country of <sup>449</sup> importations to Ireland for all periods analysed. However, these high levels of importations observed <sup>450</sup>

could be due to England being a global leader in the SARS-CoV-2 sequencing effort by making many  $\frac{451}{120}$ genome sequences available, rather than due to factors like the country being geographically close to <sup>452</sup> Ireland with high connectivity.  $\frac{453}{453}$ 

To investigate the effect of sampling bias on the number of Irish importations attributed to England, <sup>454</sup> we randomly downsampled tips from England in the tree to levels retaining between 90% and 10% of the original number and then counted importations to Ireland as before. If the proportion of importations <sup>456</sup> from England to Ireland was due solely to the amount of English samples in the tree, we could expect  $_{457}$ a linear relationship when downsampling, i.e., reducing the number of English samples in the tree by <sup>458</sup> 50% would reduce the proportion of introductions attributed to England by 50%. Instead, as samples are <sup>459</sup> removed, we observe that the proportion of introductions from England remains higher than expected  $_{460}$ (Figure [5A](#page-16-0)). This is significant for all six periods when compared to the linear expectation ( $P$  between  $_{461}$  $8.9\times10^{-8}$  and  $3.6\times10^{-5}$  for each period; paired Wilcoxon signed-rank test). Additionally, the proportion  $462$ of introductions from England to Ireland is always greater than the proportion of English samples in the <sup>463</sup> tree for all downsampled replicates (Figure [5B](#page-16-0)).

#### Optimal Irish sequencing rates vary between periods  $465$

Different levels of sequencing impact the ability to detect introduction events throughout the pandemic. <sup>466</sup> Increased SARS-CoV-2 sequencing in both RoI and NI in 2021 (Figure [1B](#page-10-0)) yielded more rapid and  $_{467}$ informed surveillance of variants. <sup>468</sup>

Sequencing at a very low level will miss whole clusters resulting from importations and so when  $\frac{469}{469}$ sequencing is low, the number of importations will be underestimated. At the other end of the spectrum,  $470$ sequencing every SARS-CoV-2 case will detect all members belonging to each cluster, resulting in the  $_{471}$ best possible estimate of the number of importations. However, as the level of sequencing increases, the <sup>472</sup> returns are diminishing because different members of the same cluster would be sampled, in which case  $473$ 

the number of importations remains much the same.

To determine the effect of different levels of sequencing on the number of Irish importations detected, <sup>475</sup> we randomly downsampled Irish sequences in the tree, similar to above, retaining between 90% and 10%  $476$ and then counted importations to Ireland as before. For Periods A–C, removing 90% of Irish samples,  $477$ reduces the number of introductions detected to between  $31\%$  and  $44\%$  of the introductions observed  $478$ (Figure [6A](#page-18-0)). This is greater than the 10% expectation if introductions decreased linearly. For Periods <sup>479</sup>  $D-F$ , a more steep decline is observed as samples are removed and when only  $10\%$  remain, we detect  $\frac{480}{480}$ between 22% to 27% of the original observed number of introductions. When average cluster size is  $_{481}$ considered, a steeper decline is instead observed for Periods A–C compared to D–F (Figure [6B](#page-18-0)). Therefore, <sup>482</sup> we hypothesise that if sampling was increased in Ireland beyond the level conducted for Periods A–C, few  $\frac{483}{483}$ additional introductions would be detected, but instead most new samples would be added to existing  $_{484}$ introduction clusters and increase cluster size. For Periods D–F, an increasing in sampling would continue  $\frac{485}{485}$ to detect many new introductions and increase cluster size of existing introductions.

It is a challenge for public health officials to assess the effectiveness of a given level of sequencing.  $_{487}$ To assist in this evaluation, we have developed a methodological framework involving the extrapolation <sup>488</sup> of downsampled data to determine the proportion of total predicted introductions that were detected <sup>489</sup> using the available sequencing. The extrapolation results (see Table [1](#page-19-0) and Figure  $6C\&D$ ) also reveal  $490$ the estimated number of sequences required to identify all introductions to Ireland. For Periods A–F, <sup>491</sup> the number of introductions detected vs. predicted via extrapolation for these periods were 170/186, <sup>492</sup> 41/42, 218/224, 728/867, 1937/2258, and 1309/1383, respectively. Similarly the proportions of sequences <sup>493</sup> available to the number estimated to detect all introductions were  $1347/2044$ ,  $450/570$ ,  $3311/4303$ ,  $494$ 

6536/11815, 11503/19538, and 6371/8751, respectively. Such extrapolations could provide a reliable <sup>495</sup> approach for predicting the total number of introductions and required sequencing levels in comparable <sup>496</sup> epidemiological scenarios (i.e., subject virus or geographic location). <sup>497</sup>

In contrast to Figure [6C](#page-18-0)&D which refer to the whole island, Figure [6E](#page-18-0) shows the number of introductions  $498$ to NI and RoI during Periods A–F. Normalising both introductions and sequences acquired per capita <sup>499</sup> accounts for biases in total population and disparities in sequencing efforts. This reveals that introduction <sup>500</sup> rates per capita were similar between NI (circles) and RoI (squares) with the exception of Period D 501 during which they were higher in NI. This approach also allows comparison of sequencing levels per capita <sub>502</sub> achieved during each period (rightmost points).

## Population density and deprivation significantly impact SARS-CoV-2 intro- $\frac{1}{205}$  ductions and spread in Ireland  $\frac{1}{205}$

We examined the effect of population density and deprivation on the spread of the virus within NI  $_{506}$ and RoI using six ordinary least-squares (OLS) regression models and Geographic Information Systems 507 (GIS). Considering all regression models (see Table [2\)](#page-19-1), variance inflation factors (VIFs) were below 3, <sup>508</sup> indicating that there is no significant multicollinearity among the independent variables. Furthermore,  $_{509}$ The Koenker (BP) statistics are all above the 0.05 threshold, which suggests that the models do not <sup>510</sup> suffer from heteroskedasticity, and indicate that applying geographically-weighted regression (GWR)  $_{511}$ would not yield much additional clarity. Analysis of Periods D–F, which had the highest sequencing rates,  $\frac{512}{2}$ revealed that both population density and deprivation had some statistically significant correlations with <sup>513</sup> the introduction and spread of the virus.  $514$ 

Our GIS analysis indicated that the introduction and spread of SARS-CoV-2 infections was not <sup>515</sup> randomly distributed across Ireland. Population density displayed statistically significant positive  $\frac{1}{516}$ correlations with SARS-CoV-2 introductions and spread in Period D ( $p < 0.05$ ) in NI and in RoI ( $p_{\text{517}}$  $< 10^{-4}$ ) during all three periods (D–F). More SARS-CoV-2 sequences were produced in more deprived  $\frac{518}{518}$ areas of NI in Periods D & E (p < 0.05). However, a significant inverse relationship was observed with  $\frac{519}{2}$ deprivation during Period F ( $p < 0.05$ ) in RoI. This unexpected result may reflect differing sequencing  $\frac{520}{20}$ strategies between NI and RoI. ## The localised SARS-CoV-2 spreading revealed by geospatiotemporal analysis  $\frac{525}{255}$ of introduction clusters confirms the validity of our phylogenomic analysis  $\frac{526}{266}$

We conducted geospatiotemporal analyses of introduction clusters by tracking the geographic appearance  $\frac{527}{22}$ of phylogenetically-descendent samples linked to each introduction event over time. Samples with <sup>528</sup> incomplete or ambiguous geographic metadata were excluded from geospatial mapping, resulting in 95% <sub>529</sub> (31,529/33,131) of the Irish sequences being retained for analysis. Figure [8A](#page-22-0) depicts Ireland with local <sup>530</sup> government districts of NI and RoI, while Figure [8B](#page-22-0) and Figure [8C](#page-22-0) illustrate the spreading patterns <sup>531</sup> of the third and second-largest detected introduction clusters, respectively. An introduction cluster of <sup>532</sup> 960 Irish Delta SARS-CoV-2 sequences originating from Scotland via Causeway Coast and Glens in <sup>533</sup> NI during Period D (2<sup>nd</sup> June–31<sup>st</sup> July 2021) showed intra- and neighbouring-region spread, with a 534 transmission hop from NI to County Roscommon and County Dublin (Figure [8B](#page-22-0)ii to Figure 8Biii). An 535 even larger introduction cluster of 1,274 Irish Omicron BA.1 SARS-CoV-2 sequences during Period E 536  $(30<sup>th</sup>$  November 2021–31<sup>st</sup> January 2022) spread similarly, originating from England via County Dublin  $\frac{537}{2}$ and County Kildare (Figure  $8C(i-vi)$ ).

These geospatiotemporal patterns of viral spread are derived solely from phylogenetic trees and <sup>539</sup> associated sample metadata. The fact that they conform to the expected scenario of predominantly local <sup>540</sup> transmission events supports our analytic approach.  $541$ 

Additional regional metadata, including 2-letter abbreviations for local government districts in Figure [8](#page-22-0)  $\frac{542}{542}$ and information regarding population centres in each district, is provided in Table S1. #### Nucleotide substitution rates in Ireland are consistent with global trends  $574$

We have assessed SARS-CoV-2 substitution rate over time between the introduced lineages in comparison to  $575$ reports of others, given the unique geographic and cultural position of Ireland. Our analysis demonstrated <sup>576</sup> that the substitution rates of Irish SARS-CoV-2 were consistent with those earlier reported (Markov 577 et al. [2023;](#page-30-0) González-Vázquez and Arenas [2023\)](#page-29-0) and were similar to the substitution rates estimated by  $\frac{578}{578}$ Nextstrain (Hadfield et al. [\(2018\)](#page-29-13), <https://nextstrain.org>). 579

Figure [9A](#page-24-0) shows all (as of 18<sup>th</sup> Feb 2023) Irish sequences with  $\geq 99.9\%$  genome coverage as obtained <sup>580</sup> from GISAID corresponding to lineages introduced in Periods  $A-F$ , with the mean observed substitutions  $\frac{581}{100}$ tracked for NI and RoI as solid lines. We observe increases at transition periods due to the appearance of  $\frac{582}{2}$ new lineages alongside the existing circulating variant (see Markov et al. [\(2023\)](#page-30-0) for a detailed explanation  $\frac{583}{100}$ of this phenomenon). To investigate substitution characteristics of each lineage we separately analysed <sup>584</sup> the apparent substitution rates corresponding to lineages introduced in each period (see Figure S11). <sup>585</sup> Estimated substitution rates for NI and RoI for each lineage group are presented in Figure [9B](#page-24-0). From this <sup>586</sup> analysis we can see that overall there do not appear to be significant differences between the apparent  $\frac{587}{100}$ substitution rates of SARS-CoV-2 in NI compared to RoI. However, Period B, which is a time period  $\frac{588}{588}$ with the lowest sequencing rates both locally and globally (see Figure S12), and Period F, which saw  $\frac{589}{100}$ significantly more importations to NI than RoI may be significant.

Furthermore, Figure [9C](#page-24-0)&D show that the decrease in genome cytosine (C) content (Figure 9C) is  $_{591}$ generally compensated by an increase in genome thymine  $(T)$  content (Figure [9D](#page-24-0)), which is characteristic  $\frac{592}{2}$ of SARS-CoV-2 evolutionary behaviour reported previously (Di Giorgio et al. [2020;](#page-28-3) Simmonds [2020\)](#page-31-1). <sup>593</sup>

## Discussion 594

The unprecedented global effort to rapidly sequence millions of SARS-CoV-2 samples and share the results <sup>595</sup> openly has created a rich resource that provides the opportunity to address previously intractable research <sup>596</sup> questions. While the scale of the dataset is its strength, it has posed problems to existing software, tools 597 and methods that had not previously encountered such computational challenges. However, the work of  $\frac{598}{2}$ many other research groups to optimise multiple sequence alignment and phylogenetic analysis of millions <sup>599</sup> of SARS-CoV-2 sequences has enabled us to identify introduction events to the island of Ireland during  $\frac{600}{200}$  $\chi$  key periods of the pandemic.  $\frac{601}{601}$ 

The  $4.403$  independent SARS-CoV-2 introductions to Ireland detected during the six time periods  $\frac{602}{602}$ studied should be treated as a conservative lower bound estimate for several reasons. Firstly, the genome 603 sequencing data available is limited by sparseness and a variable sampling rate. In 2020, the rate of  $\frac{604}{604}$ sequencing in both NI and RoI was low — with less than three thousand sequences from each, compared to  $\frac{605}{605}$ approximately fifty thousand each in 2021. This restricts how informative earlier time periods, specifically <sup>606</sup> A, B and much of C, are for gleaning insights into Irish introductions. Key periods of importation that  $\omega$ involve increased international travel and gatherings, such as Christmas, are also periods of reduced  $\frac{608}{608}$ sampling. This has the double effect of increasing the rate of successful introductions taking place while  $\omega$ also reducing the opportunity for these events to be captured. These factors within the Irish sequencing  $610$ programmes directly affect the number of introductions observed and cause the extent of underestimation <sup>611</sup> to vary.  $\frac{612}{20}$ 

Secondly, a global inequality in SARS-CoV-2 genomic surveillance has been reported (Brito et al. 613 [2022\)](#page-28-19). The sampling rate in other countries can affect the number of introductions identified in Ireland. <sup>614</sup> Consider a scenario in which a lineage with a unique set of mutations, lineage L, is circulating in another 615 country, country A. An introduction event from country A to Ireland takes place and if sequenced in <sup>616</sup>

Ireland, the unique set of mutations allows us to easily attribute country A as the origin. If a subsequent  $\epsilon_{617}$ mutation, mutation M, occurs in country A and this mutated lineage L is again introduced, it will be  $\epsilon_{618}$ identified as a second introduction event if sequenced in both countries. If, however, there is a low 619 sequencing rate in country A, mutation M might only be sequenced among Irish samples. Therefore,  $\infty$ mutation M would appear as an Ireland-specific mutation occurring within the original introduction  $\epsilon_{21}$ cluster of lineage L. While rare, this scenario would result in missed introductions and merged clusters 622 that should be independent from each other. The high rate of sequencing in nearby Great Britain should  $623$ reduce the occurrence of such scenarios affecting our introduction counts for Ireland.

A low sampling rate in other countries can affect more than just the number of introductions; it can  $\epsilon_{25}$ result in introductions being wrongly attributed. For example, scenarios can arise whereby a cryptic  $\epsilon_{\text{ee}}$ lineage circulates in a country, country B, with a low rate of sequencing and is therefore not sampled and  $\frac{627}{627}$ attributed as originating in country B. Introductions from country B to other countries than Ireland can <sup>628</sup> also occur, some of which may have robust variant detection programmes, potentially leading to some 629 introductions to Ireland from country B being wrongly attributed to one of these other countries. <sup>630</sup>

Thirdly, to identify independent introductions it is necessary to distinguish them from each other. <sup>631</sup> Genetic diversity enables the tracking of viral infection and onward transmission events for the purposes of 632 genomic surveillance (Grubaugh, Ladner, Lemey, et al. [2018;](#page-29-19) Rockett et al. [2020\)](#page-31-17). Novel shared mutations 633 reveal a history of infection and transmission events. Similarly, we can only differentiate between separate  $\frac{634}{634}$ introduction events if they are genetically distinct. Sequences that are identical but result from multiple 635 introduction events will be grouped in the same introduction cluster because they are indistinguishable. <sup>636</sup> They are therefore counted as a single introduction. The relatively low mutation rate of SARS-CoV-2 637 compared to other viruses, and subsequently the low level of genetic diversity, will increase the likelihood  $\frac{1}{638}$ of this occurring, resulting in an underestimate of independent introduction events. <sup>639</sup>

Notwithstanding the caveats discussed above, we were able to identify patterns of introductions <sup>640</sup> that are not explained by the influence of different national sequencing levels. As expected, for some  $\frac{641}{641}$ time periods there is a negative correlation between number of introductions and distance, presumably  $\frac{642}{642}$ reflecting less travel from distant countries.

The ability to link many sequences with geospatial and temporal metadata attributable to specific 644 introduction and spreading events enabled us to conduct a range of geospatial analyses. Such analyses 645 provide an opportunity to use geospatiotemporal data to develop epidemiological models and better <sup>646</sup> understand pandemic dynamics. We further hypothesise that, given a sufficiently high level of accurate  $\frac{647}{647}$ viral genome sequencing, spatiotemporal clusters of virus spread can be used to predict the presence of  $\frac{648}{648}$ undetected introduction events.

The correlations observed between population density, deprivation, and introductions and spread <sup>650</sup> of SARS-CoV-2 suggest roles for these factors in enhancing viral introductions and spread and cor- <sup>651</sup> roborate previous associations of SARS-CoV-2 incidence with deprivation in Ireland (Madden et al. <sup>652</sup> [2021\)](#page-30-20), particularly in NI (McKinley et al. [2021\)](#page-30-3). Targeted interventions in areas of high popula- <sup>653</sup> tion density and deprivation may therefore be warranted to reduce the introductions and spread of  $\frac{654}{654}$ SARS-CoV-2 and other future transmissable diseases. However, the relationship between deprivation  $\frac{655}{655}$ and geographic location is complex; not all individuals experiencing deprivation live in areas typically associated with deprivation, and not all individuals living in such areas experience deprivation.  $\frac{657}{6560}$ [T](https://www.nisra.gov.uk/support/output-geography-census-2011/super-output-areas)hus, incorporating high-resolution geospatial data such as the 890 Super Output Areas ([https://www.](https://www.nisra.gov.uk/support/output-geography-census-2011/super-output-areas) <sup>658</sup> [nisra.gov.uk/support/output-geography-census-2011/super-output-areas](https://www.nisra.gov.uk/support/output-geography-census-2011/super-output-areas)) or 3,780 Data Zones 659 (<https://www.nisra.gov.uk/support/geography/data-zones-census-2021>) in NI compared to the <sup>660</sup> 11 LGDs used in this study, due to the limited resolution of GISAID metadata, could enhance the <sup>661</sup> accuracy of analyses and provide a more nuanced understanding of the distribution of population density 662 and deprivation.  $\frac{633}{663}$ 

Because multiple factors can influence the number of introductions observed it can be difficult to  $\frac{664}{664}$ attribute the cause for differences between time periods. For example, the relative scarcity of introductions 665 observed in Period B is likely due to very limited travel, but is also exacerbated by the low levels of <sup>666</sup> sequencing in Ireland and globally. This raises the salient question: what level of sequencing is required 667 to provide adequate genomic surveillance? Sequencing every single positive case will provide the most complete representation of variants circulating in a community, however, this would be too costly and 669 largely unnecessary as in many cases the same variants would be sampled repeatedly. On the other  $\epsilon_{\rm 670}$ hand, if too few cases are sequenced, this risks missing variants of concern. These could be imported  $\sigma_{11}$ from elsewhere or arise de novo and both would likely not be detected until well established in the  $\frac{672}{672}$ community. The optimum number of samples to sequence will vary depending on total number of cases  $\frac{673}{673}$ and international sequencing levels. Nonetheless, we have developed a methodology with which to estimate  $674$ 

both the total number of importations that are likely to have occurred as well as the minimal number  $\frac{675}{675}$ of sequences required to detect all importations for a given time period (see Figure [5\)](#page-16-0). We find that  $\sigma$ relatively few sequences are required to accurately estimate the total number of introductions (although 677 more are needed as introduction rates increase). However, higher sequencing levels will always help to  $\sigma$ <sup>88</sup> elucidate infection dynamics and enhance the detection of emerging variants. These factors should be  $\sigma$ <sub>079</sub> considered when setting sequencing targets.  $\frac{680}{680}$ 

The higher per capita introduction rate into NI during Period D (Delta) is likely due to higher travel  $\epsilon_{0.81}$ into NI than RoI at this time (Figure [1E](#page-10-0)). The similar incidence in both jurisdictions during Period D  $_{682}$ (Figure [1A](#page-10-0)) suggests that most cases arise due to internal spread and the benefit of travel restrictions is <sup>683</sup> largely limited to reducing the risk of importing novel variants.

To investigate the relationships between viral characteristics (e.g., genetic identity and load) and <sup>685</sup> clinical outcomes (e.g., symptoms, complications, disease severity, duration of illness, and treatment <sup>686</sup> responses), it is necessary to perform viral sequencing of infected individuals. When multiple individual 687 sequences from a sufficiently large proportion of the population are available, this approach enables 688 tracking of viral dynamics through phylogenetic reconstructions, which can identify outbreaks and chains 689 of transmission events. Phylogeographic techniques used in this study allow: 1) estimation of the origin <sup>690</sup> and source of introductions, 2) mapping of subsequent spreading events and propagation, 3) estimation of  $\frac{691}{691}$ substitution rates within introduction clusters, and 4) provision of insights into the effects of mutations on  $\frac{692}{1000}$ viral characteristics. An alternative approach to study population-level variant dynamics is the monitoring 693 of viruses within wastewater using molecular methods. This provides unbiased aggregate sampling of <sup>694</sup> entire communities and its effectiveness has already been demonstrated in Ireland (Wade et al. [2022;](#page-32-5) 695) Reynolds et al. [2022\)](#page-31-18). Despite the challenges of genome sequencing from wastewater it has been shown 696 to be an effective complementary approach for genomic surveillance of SARS-CoV-2 (Karthikeyan et al. 697 [2022\)](#page-29-20), although without the information that can be gained from the reconstruction of a molecular 698 phylogeny. In the context of infectious disease surveillance and outbreak response, phylogenetic analyses have shown  $\sim$ to be a valuable tool (Attwood et al. [2022\)](#page-28-20) for identifying emerging strains (Tang et al. [2021\)](#page-31-8), tracking the  $_{701}$ spread of disease (Moreno et al. [2020;](#page-30-5) Borges et al. [2022\)](#page-28-14), and strategising targeted interventions (Kwon  $\pi$ <sup>02</sup> et al. [2021\)](#page-29-21). Incorporating phylogenetic analyses into real-time advisory workflows (Hadfield et al. [2018;](#page-29-13)  $\frac{703}{100}$ Turakhia, Thornlow, A. S. Hinrichs, et al. [2021\)](#page-32-6) requires a robust system for collecting, storing, and <sup>704</sup> analyzing genetic sequence data, as well as trained personnel who are skilled in bioinformatics and  $\tau_{05}$ phylogenetic analyses (Smith [2018\)](#page-31-19). By leveraging the power of genetic sequencing and analysis, public <sup>706</sup> health agencies and other stakeholders can better understand the evolution and transmission of pathogens,  $\frac{707}{100}$ identify at-risk populations, and develop effective strategies to prevent and control outbreaks. Increased  $\tau_{08}$ use of phylogenetic analyses in real-time advisory workflows has the potential to significantly improve our  $\frac{709}{100}$ ability to respond to infectious disease threats, ultimately leading to better public health outcomes.  $\frac{710}{200}$ 

# $Conclusions$   $\blacksquare$

Despite the high level of SARS-CoV-2 WGS, particularly in the UK, sampling was relatively sparse  $\pi$ 12 and variable. Nonetheless, the potential of genomic epidemiology is well-recognised (Stockdale, Liu,  $_{713}$ ) and Colijn [2022;](#page-30-12) Hill et al. [2021;](#page-29-22) McBroome et al. 2022; Killough et al. [2023\)](#page-29-23) and this analysis further  $\tau_{14}$ demonstrates the additional value of WGS beyond surveillance of emerging variants. Although our  $_{715}$ conclusions must be tempered by fluctuations in local and international sequencing, the estimates of  $\tau_{16}$ numbers of introductions and geospatial tracking of specific clusters could be used to inform public health  $\eta$ agencies how to limit the spread of health risks to neighbouring countries and to prevent unwarranted  $\pi$ 18 travel and trade restrictions. These data could also assist vaccine deployment strategies and implicitly <sup>719</sup> estimate herd immunity thresholds (Stockdale, Liu, and Colijn [2022\)](#page-31-20). The goal of the International  $_{720}$ Health Regulations is to avoid disruption to global travel and trade. Performing this analysis closer to  $\tau_{21}$ real time and on an international scale could inform policy about the effectiveness of border measures. 722

The opportunity provided by the continually decreasing cost of WGS should be used to adopt WGS  $\frac{723}{223}$ more widely to monitor and geospatiotemporally investigate future infectious conditions. Sequencing  $\frac{724}{124}$ all infected individuals is not presently feasible nor is this necessary to predict the total number of  $\tau_{25}$ introductions. Our findings demonstrate the extensive variation in sequencing requirements across the <sup>726</sup> SARS-CoV-2 pandemic. We therefore recommend a flexible strategy for surveillance with the capability  $\frac{727}{272}$ to surge sequencing above baseline rates as required by the contemporaneous conditions.
