Correlation between life satisfaction and symptoms of attention deficit hyperactivity disorder (ADHD) in dental students: The mediation of

resilience

Abstract

The aim of the study was to examine the morbidity of Attention Deficit Hyperactivity

Disorder (ADHD) symptoms in dental students, explore the correlation between life

satisfaction and ADHD symptoms. It also discusses whether resilience mediates the

correlation between ADHD symptoms and life satisfaction. Self-report questionnaires

consist of the Wender Utah Rating Scale (WURS), the Adult ADHD Self-Report Scale

(ASRS), the Satisfaction With Life Scale (SWLS), the Conner-Davidson Resilience Scale

(CD-RISC), and sociodemographic characteristics. The analyses with Hierarchical

linear regression were operated to investigate the effect of ADHD symptoms on life

satisfaction. The study used resampling and asymptotic strategies to discuss the

mediation of resilience. 291 dental students became final objects. Twenty students

(6.87%) may have ADHD. There were differences in ADHD prevalence among objects

of diverse ages and with varying levels of paternal education. The ADHD

asymptomatic group had distinctly higher resilience and life satisfaction degrees than

the symptomatic group. Inattention and hyperactivity were both correlated

negatively with life satisfaction and resilience. Life satisfaction was observably

positively associated with resilience. Resilience serves as a mediating role between

life satisfaction and the two symptoms of ADHD. Detecting ADHD symptoms earlier is

helping improve mental health of future dentists. Resilience intervention programs

can enhance life satisfaction of dental students.

Introduction

A global study pointed out that mental disorders' burden increased from 1990 to 2019 [1]. Attention deficit hyperactivity disorder (ADHD) is a sort of the most familiar mental disorders affecting nonage and adults, which leads to an enormous economic burden worldwide [2]. The main features of ADHD incorporate inattention, hyperactivity, and impulsivity [3]. With the progress of many cohort studies, more and more scholars have recognized that ADHD symptoms usually appear in childhood, and a significant proportion persists into adolescence or adulthood. The prevalence in children is about 5% and is twice as high in boys as in girls [4]. The World Mental Health Survey published by the World Health Organization(WHO) points out that the prevalence of adults is about 2.8% [5]. Chronic symptoms of ADHD have invariably been shown to be related to impairment in many fields of life, like occupational achievement, social correlations, substance use, academic record, and other psychiatric comorbidities [6-10]. Nevertheless, few studies have statistically analyzed the prevalence of ADHD in dental students by searching mainstream databases such as PubMed and Web of Science. With the continuous development of Psychiatry, Psychology, and Education, more and more people began concentrating on ADHD in college students. However, studies on medical students have mainly focused on the adverse effects, including suicidal behaviour and Internet addiction, accompanying ADHD[11-13]. At the same time, the study on the association between ADHD and positive outcomes, including quality of life and life satisfaction, is minimal. In

scientific efforts, clinical practice, and teaching practice, the dimensional approach of ADHD can allow people to obtain more information than the traditional classification method [14]. A study of middle-aged and older Australians showed that inattention was more relevant than hyperactivity in ADHD symptoms in social, academic, occupational functioning, and psychological outcomes, which include life satisfaction [15]. Until now, however, no study has examined this issue among dental students. Although ADHD symptoms may generate impairment in some related functions, they do not significantly impact some people's lives. According to our conjecture, this group may have positive psychological resources to cope with adversity better. Since positive psychology was proposed to prevent and treat mental health problems and improve people's overall subjective well-being, positive psychology has been increasingly applied to many people, including children, doctors, and soldiers [16-18]. As one of the positive psychological resources, resilience can reduce the negative impact of psychiatric symptoms in ADHD patients and improve their life satisfaction [19,20]. Generally speaking, resilience is how people understand, manage, and control themselves after a significant stressful or traumatic event [21]. It can be inferred from the transaction model of coping and stress[22] that resilience, as a psychological resource, can quadratically affect the evaluation process of stressors and thus moderate the relationship between stressors and their outcomes. Still, there are few studies related to the potential effects of resilience in the correlation between life satisfaction and ADHD symptoms. Given the increasing socioeconomic burden of ADHD, existing studies on ADHD symptoms are significantly

underrepresented in dental students. We conducted the research to 1) analyze the morbidity of ADHD symptoms in dental students of China; 2) explore the relationship between life satisfaction and two segments of ADHD symptoms among dental students; 3) explore the mediation between life satisfaction and ADHD symptoms.

Materials and Methods

Subjects and Study design

The research was a cross-sectional investigation. It was carried out in May 2023 at a medical university in China. "Wenjuanxing" (www.wjx.cn), a famous professional online survey platform, was used to conduct questionnaires and collect data. During or after data capture, authors can access information that identifies individual participants. A stratified cluster sampling method was operated to recruit dental students based on academic years. All students participated voluntarily and were informed of the study's purpose before answering the questionnaire. At the beginning of the questionnaire, we designed an informed consent link. The subjects who answered the questionnaire were considered to have signed a written informed consent agreement before answering the questionnaire. Medical Ethics Committee of China Medical University authorized the study.

Assessment of ADHD symptoms in adults

The study adopted the Chinese edition of the Adult ADHD Self-Report Scale(ASRS) to measure adult ADHD symptoms in subjects. [23]. This scale has two subdivisions named inattention and hyperactivity. Both have nine entries. (e.g., "How often do you fidget or squirm with your hands or feet when you have to sit down for a long

time?" and "How often do you misplace or have difficulty finding things at home or work?".) Each article is ranked on a Likert scale with five points from zero ("never") to four ("very often"). The respondents were requested to score each article owing to their affairs in the last six months Subjects who scored more than 24 would have ADHD in all probability, those who scored 17-23 were sorted into possibly having ADHD, and those who scored 0-16 were almost not likely to have ADHD [24]. Owing to previous studies, the Chinese edition of ASRS has decent credibility and validity. [23–25]. Cronbach's alpha for the inattention segment was 0.78 and the hyperactivity dimension was 0.85.

Assessment of ADHD symptoms in nonage

The Wender Utah Rating Scale (WURS) was operated to measure ADHD symptoms in nonage among the objects. The scale with twenty-five items was used primarily to review individual ADHD symptoms during adolescence. Sample items include "When I was a child, I had trouble seeing things from someone else's point of view" and "As a child, I was sad or blue, depressed, unhappy". Each article is ranked on a Likert scale with five points from zero ("not at all or very slightly") to four ("very much"). The researchers used an aggregate score of 46 as the cut-off point for childhood ADHD [26]. Scholars believe WURS has decent credibility and validity. Cronbach's alpha in the research was 0.94.

Classification criteria of ADHD symptomatic set and asymptomatic set

In clinical practice, only individuals with both overt childhood ADHD symptoms and current ADHD symptoms are diagnosed as adult ADHD. Therefore, subjects with WURS scores ≥46 and at a minimum one section of ASRS scores ≥17 were divided into a symptomatic set in this study, and the remaining were classified as asymptomatic.

Measurement of life satisfaction

The Satisfaction With Life Scale (SWLS) estimates the worldwide aspect of life satisfaction [27]. The scale owns five items (e.g., "So far, I have gotten the influential things I want in life" and "I am satisfied with my life"). Each article is responded to on a Likert scale with seven points from one ("strongly disagree") to seven ("strongly agree"). The lower the ranking scored, the less satisfied the subjects were with their lives. Past researches have demonstrated convincing credibility and predictive validity among diverse age groups [27–29]. Cronbach's alpha for the scale was 0.91

Assessment of resilience

The Connor—Davidson Resilience Scale (CD-RISC) was developed to estimate the capacity to deal with pressure and adverse circumstances [30]. CD-RISC, possessing twenty-five items, has a higher psychometric property rating than most scales that measure resilience [31]. Sample items include "As things look hopeless, I do not give up condition" and "Past success gives me confidence for new challenges." Each article is ranked on a Likert scale with five points from zero ("not true at all") to four ("accurate nearly all the time"). The subjects with lower scores have a lower standard of resilience. In China, owing to the positive validity and credibility of

CD-RISC, it has been made widely use of [30,31]. Cronbach's alpha for CD-RISC was 0.94.

Demographic characteristics

Demographic information for the study incorporated gender, age, race, place of residence, academic year, whether the only child and parental educational level.

Statistical analysis

SPSS 26.0 was operated to analyze all the data. The statistical examinations we used were completely two-sided, and results with P < 0.05 were marked as remarkable. The study used T-tests and chi-squared tests to examine the distinctions in psychological and categorical variables between ADHD symptomatic set and the asymptomatic set. Pearson's correlation analysis was conducted to check associations among life satisfaction, resilience, inattention and hyperactivity. The researchers investigate the influence of independent variables on life satisfaction using hierarchical regression analysis. F, R2, R2-changes (AR2) and Standardized estimates (β) were supplied for each step. Resampling and asymptotic strategies, which were developed by Hayes and Preacher [29], were operated to check the mediation of resilience (a*b) on the correlations of hyperactivity and inattention with life satisfaction. The researchers labeled 95% confidence interval (BCa 95%CI) and calculated bias-corrected for each a*b product. An obvious mediation was indicated by the BCa 95%Cl excluding 0. To avoid multicollinearity, all the continuous variables were coped with standards before the regression analyses.

Results

Demographic features of the objects

In total,297 questionnaires were distributed, and 291 copies were collected. Table

1 showed the demographic features of the issues and the allocations of life satisfaction. There were 120 male subjects and 171 subjects

Features of the objects between the attention deficit hyperactivity disorder (ADHD) symptomatic set and asymptomatic set

In WURS, 91 students scored \geq 46 among 291 subjects. Then, the 91 people were statistically analyzed by ASRS scale, and the screening method was as follows: if the scores of 1-3 questions in Part A (namely the first six questions) were \geq 3, and the scores of 4-5 questions were \geq 4, and more than four of the six questions met the

above standards. A total of 20 people correspond to the above conditions. These 20 subjects were divided into the ADHD symptomatic set. Table 2 presented the features of the students in the ADHD symptomatic and asymptomatic set. The female set had a lower percentage of ADHD symptoms than the male set (p = 0.025). Observe distinctions have existed between the three sets in Paternal educational level (p = 0.046). Observe distinctions weren't existed between the two sets in age (p = 0.794), Race (p = 0.216), Place of residence (p = 0.830), Academic year (p = 0.652), The only child (p = 0.865), and Maternal education level (p = 0.520). The asymptomatic set had remarkably higher ranks of life satisfaction (p < 0.05) and resilience (p < 0.05) than the symptomatic set

Table 3 demonstrated the means, standard deviations (SD), and correlated results in life satisfaction, resilience, inattention and hyperactivity. The table indicated that both hyperactivity and inattention were negatively linked to life satisfaction (hyperactivity: r = -0.190, p < 0.05; inattention: r = -0.121, p < 0.05) and resilience (hyperactivity: r = -0.258, p < 0.05; inattention: r = -0.177, p < 0.05). Life satisfaction was observably positively correlated with resilience (r = 0.752, p < 0.05).

The consequences of Hierarchical linear regression

Table 4 indicated the consequences of the hierarchical regression concerning life satisfaction. Hyperactivity and inattention explained 4% of the differences in life satisfaction. It was revealed that a significant negative correlation between hyperactivity and life satisfaction after controlling age and gender, (β = -0.26, p < 0.05). A quite positive consequence of resilience was indicated in life satisfaction. (β = 0.75, p < 0.05), explaining 53% of the variable of life satisfaction

The mediation of resilience in the correlations between life satisfaction and ADHD symptoms

Table 5 revealed the magnitude of the mediation (a*b), BCa 95%CI and the path coefficients. Resilience has a significant mediating effect between life satisfaction and inattention of students. (a*b=-0.199,P < 0.05) Resilience significantly moderated the correlation between life satisfaction and hyperactivity in the subjects. (a*b=-0.159,P < 0.05).

Discussion

UP till now, there has been little investigation into ADHD among dental students.

Existing studies have explored the awareness and knowledge of dental students about ADHD but have not focused on ADHD in the group itself [32]. This study focuses on ADHD symptoms among dental students. It is also the first to explore the correlation between life satisfaction and ADHD symptoms of dental students, as well as to verify the mediation of mental resilience in these relationships. On one hand, the outcomes of this study indicate that 6.87% of dental students have symptomatic ADHD. The relevant data of Chinese dental students was lower than the morbidity rate of ADHD (8.45%) among Chinese medical students [33]. Several studies have demonstrated a correlation between ADHD and learning disabilities, particularly in verbal reasoning, visual-auditory memory, and cognitive traits [34,35]. It can be inferred that some individuals with ADHD will be slightly worse than ordinary people in learning ability. Chinese undergraduates must take a national exam before being admitted and choose their prospective colleges and majors based on their scores. In most Chinese medical universities, the average score of students admitted to the stomatology program is higher than that of undergraduates. majoring in clinical medicine in the same institution. Therefore, among high school graduates with ADHD symptoms who want to apply for stomatology, compared with graduates who want to use it for clinical medicine, most of them cannot study oral medication due to the entrance examination scores. On the other hand, based on the data from WHO, the result is higher than the worldwide prevalence of ADHD (2.8%) among adults [5]. This data may indicate that, compared with the mental disorders which are easily recognized and detected, dental students facing heavy academic and life pressure

often underestimate or ignore ADHD symptoms. Early detection and diagnosis of dental students with ADHD symptoms are necessary to treat them as early as possible. The research reveals that the morbidity of ADHD significantly differs in students whose fathers have different levels of education. The probable reason is that Chinese fathers teach their children more harshly, while fathers with less education often cannot control their emotions and often criticize their children. These may make a difference on the recovery of ADHD symptoms in nonage. This suggests that the relevant department should improve the education level of residents. A review of three decades of research shows that, in the long run, people with untreated ADHD are impaired in social functioning, self-esteem, and occupation compared to ordinary people [36]. The resilience level of the symptomatic set is observably lower than that of the asymptomatic group, which is consistent with the study of medical students [33]. The rational interpretation is that people with ADHD often have other mental disorders, including mood disorders, learning disabilities, and so on [34,37], and many have experienced significant adverse events [38]. These are all inversely related to resilience [33].

One of the principal findings of this research was that life satisfaction had significant correlations with hyperactivity among people who major in dentistry. In contrast, there was no correlation between life satisfaction and inattention after controlling the distracting factors. This is different from existing research. In the past literature, some show that inattention is correlated with life satisfaction[33], while others believe that there is no apparent difference between diverse subtypes of ADHD[39]. There are two reasons for this result: First, ADHD is more general in men

than women, and it is more common for men to show hyperactivity than inattention. Second, the survey uses recall scales. Hyperactivity is more likely to attract the attention of others, such as teachers and parents. These individuals mentioned hyperactivity around subjects more often than inattention, which may make issues memorize hyperactivity more clearly than inattention.

Another important finding of the research is that resilience significantly mediates between life satisfaction and the two ADHD symptoms in people who major in dentistry. Besides being directly related to satisfaction in life, the two ADHD symptoms are also indirectly associated with life satisfaction through the mediation of resilience. Students with more obvious ADHD symptoms had worse resilient standards. It was associated with worse life satisfaction in turn. And vice versa. Unlike traditional psychology, which focuses on negative and pathological psychology, positive psychology uses human motivation as its basic tenet. Since positive psychology was proposed, it has been increasingly widely used to prevent and treat psychological disorders in the past 20 years. Resilience is an essential component of positive psychology, which refers to the excellent adaptability of individuals encountering adversity, scar and other remarkable pressures in life [40]. A meta-analysis in different populations showed that multiple training programs and interventions had a specific effect [41]. Previous studies have shown that appropriate interventions to improve resilience are feasible among university faculty military personnel [42,43]. Interventions based on mindfulness and cognitive-behavioural have been used more frequently in the psychological treatment of ADHD. This suggests that such interventions are effective in improving ADHD symptoms in adults [44,45]. Therefore, on an evidence-based basis, the School

of Stomatology can design a targeted resilience intervention program to enhance the satisfaction in the life of students with ADHD. It can improve the enthusiasm of these students for study and life, which is conducive to cultivating more excellent future dentists. The consequences of this research explained 57% of the differences in students' life satisfaction. The model didn't cover some potential variables, such as other social and psychological factors, which may affect students' satisfaction with life.

This study chose dental students as the subject group and obtained a large sample size and a highly effective response rate. This paper explored the correlation between life satisfaction and the two sub-symptoms of ADHD and analyzed the related mechanism between the two sub-symptoms and resilience. Admittedly, the research exists some boundedness. First, the studies all used self-report questionnaires, and data collected on these questionnaires can introduce errors. However, self-report questionnaires are often used in psychiatric clinical practice and large-scale epidemiological studies [46]. Second, as a cross-sectional investigation, it is incapable of exploring the causal relationship between the variables, and it is difficult to follow up on the subjects. Relevant prospective cohort studies can be carried out to supplement it. Third, limited by resource allocation, multi-centre research among multi-national, multi-regional, and multi-level medical schools should be carried out in the future.

Conclusions

Studies have shown that the morbidity of ADHD in general adults is lower than

Chinese dental students. It was revealed that paternal education level was relevant

to the morbidity. Of the two ADHD symptoms, only hyperactivity was significantly

associated with life satisfaction. Distinct mediation of resilience was found between

life satisfaction and ADHD symptoms. The consequences of the study can ensure the

early detection of ADHD symptoms in dental students to enhance the mental health

level of future dentists to a certain extent. Resilience intervention programs can

improve dental students' life satisfaction, especially for students with ADHD

symptoms.
