- 42 Psychiatric hospital admissions in the Western Cape are increasing, driven by poverty and substance

- To assess the trend of psychiatric admissions from 2015-2022 and factors associated with repeat psychiatric admissions and linkage to ambulatory services post-discharge.

- 49 Methods

50 Using electronic data from the Provincial Health Data Centre, a consolidated routine service database, 51 all psychiatric hospital admissions in the Western Cape were analyzed, stratified by hospital level. Mixed 52 effects logistic regression was used to determine factors associated with successful linkage to 53 ambulatory services within 30 days following hospital discharge, and repeat psychiatric admission within 54 30 and 90 days.

55 Results

Psychiatric hospital admissions, particularly at the district/acute level, were increasing prior to 2020 and an increasing proportion were substance related. 40% of admissions at the district level had not been seen at a primary health care facility in the year prior to admission. Males and those with substance use disorders were less likely to be successfully linked to outpatient services post-discharge. Successful

60	linkage was most protective against readmission within 90 days with an adjusted odds ratio of 0.76
61	(95%CI 0.73-0.79) and 0.45 (95%CI 0.42-0.49) at district/acute and specialized hospitals respectively.
62	Conclusion
63	Improving linkage to ambulatory services for mental health patients post-discharge is likely to avert
64	hospital readmissions.

67	This research highlights how often mental health patients requiring admissions are not seen at the
68	primary health care level and quantifies the risk for readmission of not following up psychiatric

77 Background

78 Prior to the COVID-19 pandemic, and consistent with international trends, there was already a high and 79 increasing prevalence of mental health conditions in the Western Cape Province of South Africa (1). 80 Recent surveys in the Western Cape have found that 31.8% of respondents had depression, and that the 81 lifetime prevalence for a substance use disorder was 20.6% (2,3). Nationally, neuropsychiatric disorders 82 are the third highest contributors to disability-adjusted life-years, after HIV/AIDS and other infectious 83 diseases, surpassing other non-communicable diseases (4). Factors such as poverty, food insecurity, 84 experiences of trauma and violence, substance use and comorbid illnesses are all known drivers of this 85 mental health burden (1,3,5–7).

Into this setting, the COVID-19 pandemic occurred, simultaneously exacerbating the burden of mental health disorders, while diverting resources away from mental health care towards COVID-19 services (8– 10). The economic crises and resultant job losses precipitated by COVID-19 also resulted in an increase in depressive symptoms in South Africa (11). High rates of depression, anxiety and post-traumatic stress disorder were also documented in South African healthcare workers during the pandemic (12). In addition, SARS-CoV-2 infection itself can have neuropsychiatric manifestations, including index-episode psychosis (13).

This increase in mental health disorders has particularly impacted in-patient services, where hospital managers have reported struggling to cope with high admission numbers. And while the majority of patients with mental health conditions do not require inpatient care, inpatient expenditure represented 86% of total mental health expenditure in the public health services in South Africa, with specialized psychiatric hospital admissions alone requiring 46% (14). In an increasingly financially constrained environmental, it is crucial to understand how admissions can be reduced and what factors influence this.

100 This study therefore aimed to describe and interrogate trends in psychiatric hospital admissions from 101 2015-2022, with a particular focus on the possible impact of substance use and COVID-19. This study 102 will also take into account ambulatory visits before and after admissions, as possible opportunities for 103 interventions.

- 105 Methods
- 106 Setting

The Western Cape Province of South Africa has a population of 7.1 million individuals, 74.9% of whom are reliant on public health services (15). For psychiatric services, the adult population has 33 district hospitals, four regional hospitals and two central hospitals (which we grouped together as "district/acute hospitals" for this analysis), all of whom refer to the three specialised psychiatric hospitals of Lentegeur, Stikland and Valkenberg. In the public sector in South Africa, the inpatient services treatment gap is high at 89%, with only 0.31 psychiatrists and 0.97 psychologists available per 100 000 population (16).

115 Data sources

The Provincial Health Data Centre (PHDC) collates all available patient-level electronic health data captured into routine health information systems within public health facilities in the Western Cape province (17). This includes admissions to psychiatric wards, derived from Clinicom, a patient administration database used at all public hospitals in the province, as well as eCCR (electronic Continuity of Care Record), the electronic discharge summary that includes information on discharge diagnoses using ICD-10 coding. Using a unique patient identifier, the admissions are linked to the

122	patients' interactions with the provincial health system at hospital and primary care levels prior to

125	Study population and inclusion/exclusion criteria
126	Individuals of all ages with a psychiatric hospital admission start date from 1 January 2015 to 31
127	December 2022 in a Western Cape public health facility were included. As ICD-10 diagnostic coding was
128	not always reliable enough to identify psychiatric patients, admitting specialty was used instead. A
129	psychiatric hospital admission was defined as:
130	An admission to a specialized psychiatric hospital OR
131	• An admission to any other hospital in the province, where patients were admitted to the
132	specialty of "Psychiatry" on Clinicom
133	Patients with psychiatric conditions seen only in the Emergency Centres or those admitted to other
134	specialties (e.g., suicidal patients admitted to the General Medicine Department following an overdose)
135	were not included.

137	Data analysis
138	Firstly, descriptive data looking at trends in admission numbers, diagnoses and outcomes after discharge
139	are presented. First contacts with the public health system, following hospital discharge are also

explored. While this is not limited to mental health ambulatory services only, as these can be difficult to distinguish electronically at the primary health care (PHC) level, the assumption is that as all patients are given a follow-up date after discharge, a visit directly after discharge was assumed to be most likely related to the preceding admission. PHC visits in the year preceding a psychiatric admission to an

district/acute hospital are also assessed. PHC visits within 24 hours of a hospital admission were excluded here, i.e., those PHC visits where the patient could have been referred on for hospital care were not included, but those PHC visits where the patient went home after and were unrelated to the current hospital admission were. Where appropriate trends are highlighted using Microsoft PowerBI (Version: 2.116).

The second analytical section is restricted to adult general psychiatry patients, as they are the patient population putting the most pressure on services, discharged home from either a district/acute hospital or a specialized hospital, i.e., admissions that result in transfers from a district/acute hospital to a specialized hospital are excluded. Elective therapeutic admissions to specialized hospitals were also excluded. Any individuals who were known to be deceased (in-facility deaths of individuals with a previous psychiatric admission) were also excluded. Stata (13.1, StataCorp. LLC, College Station, TX) was used for the analysis. The outcomes assessed were:

- Successful linkage to care post-discharge, defined as an ambulatory visit (PHC clinic or hospital
 out-patient) within 30 days of hospital discharge.
- Repeat psychiatric hospital admission, at any hospital level, within 30 and 90 days from the date
 of discharge

All admissions discharged by 31 December 2022 were included in this analysis (the data set was pulled on 15 March 2023, allowing sufficient time for the outcomes to have occurred and been captured electronically), except for the outcome of readmissions within 90 days, where only admissions discharged by 30 November 2022 be included.

Mixed effects logistic regression is used, as individuals often have repeated admissions over time and there is non-independence of observations. An alternative approach of using standard logistic regression, but including only the latest admission for an individual, was also performed. All analyses are stratified by hospital level (district/acute and specialized) and adjusted for:

• Age and sex

- Broad diagnosis category based on primary discharge diagnosis ICD-10 coding: mood
 disorders, including both uni- and bipolar depression (F30-F39); schizophrenia and other
 psychotic disorders (F20-F29); substance related disorders (F10-F19); and other diagnoses

- 195 Results
- 196 General trends in increasing admission numbers

Psychiatric admissions in the province have increased markedly over the last eight years (Figure 1a). In 2015 there were 6 013 admissions in specialized hospitals and 10 991 admissions in district/acute hospitals. This increased to 6 697 and 19 880 admissions respectively in 2022. Admissions in district/acute level hospitals almost doubled during this period, while specialized hospitals only increased slightly.

202 2020 was the only year where an increase in admissions was not seen. For district/acute admissions 203 (Figures 1b), we can see a large decrease in admission numbers coinciding with the first wave of COVID-204 19 infections in the province in mid-2020, followed by smaller decreases with the second (December 205 2020 – January 2021) and third waves (mid-2021).

Figure 2b illustrates the primary discharge diagnosis in specialized hospitals for general acute psychiatry, where schizophrenia and other psychotic disorders make up more than half the primary diagnoses, with mood disorders contributing to less than 20% of admissions. Substance related disorders as the primary discharge diagnosis has increased as a proportion from 15.96% in 2018 to 22.47% in 2022. When looking

at all diagnosis codes listed (i.e., not just the primary diagnosis code) (Figure 2d), substance related
 diagnoses also increased proportionately with time, accounting for 45.84% of all admissions in 2022.

213 Diagnostic coding is not as detailed or complete at district/acute hospitals, although this has improved 214 with time – as illustrated by the initially large number of diagnoses that fell into the "Other" category. 215 But a similar trend can be seen at these hospitals (Figures 2a and 2c), where substance related disorders 216 now make up 22.74% of all primary diagnoses in 2022, and 29.21% of all admissions have a substance 217 related diagnosis listed in 2022. While the proportion that were substance related increased over time, 218 so did the total absolute number of patients too, meaning that the 12.71% of patients with any 219 substance related diagnosis code in 2015 corresponded to 1 396 individuals and the 29.21% of patients 220 in 2022 corresponded to 5 613 individuals.

The readmission rate has, however, remained relatively stable, with around 10% of admissions, resulting in a psychiatric readmission in the next 30 days (Figure 3), and this increases to around 18-19% at 90 days. But with the absolute number of psychiatric hospital admissions increasing, so too have the absolute number of readmissions putting the limited beds available under pressure. Currently only 47.5% of admissions acute/district hospitals and 28.68% of admissions to specialised hospitals are first known psychiatric admissions. Amongst those known with to have a previous psychiatric admission, the median number of days between admissions decreased between 2018 to 2022, for both hospital levels.

230 Profile of admitted patients and outcomes after discharge

231 Male patients account for 62.15% of all psychiatric admissions in the province. Male patients and those 232 with a primary substance related disorder tended to be younger (Supplementary Figure 1).

233 In 2022, the median length of stay in district/acute hospitals was 7 days and for specialized hospitals 34 234 days. In district/acute hospitals, those awaiting referral required an additional week of admission 235 (Supplementary Figure 2a). With increasing numbers of admissions at the district/acute level, a 236 decreasing proportion were referred on for specialist care. In 2015, 37.54% were referred on, while in 237 2022 only 27.08% were referred on. Length of stay at specialised hospitals was related to discharge 238 diagnosis (Supplementary Figure 2b). Schizophrenia and other psychotic disorders had the highest 239 lengths of stay, followed by mood disorders and then substance related disorders. All diagnosis 240 categories showed a decrease in length of stay for 2022.

241

242 A median of 12 and 16 days were taken to first contact with the health system after discharge from 243 district/acute hospitals and specialized hospitals, respectively. For those discharged directly from a 244 district/acute hospital in 2022, 53.2% of individuals had an clinic/out-patient visit within 30 days, a 245 number which has been increasing slowly over the last few years (Figure 4a). An additional 10.43% do 246 make contact with out-patient services but take >30 days after discharge. 8.37% of discharges only make 247 contact with the health system again with their next admission and 28.0% have had no further contact 248 with the health system (as of March 2023, when this dataset was extracted). A similar trend is seen at 249 specialized hospitals, although a higher proportion are followed up at ambulatory services within 30 250 days – 65.4% in 2022 (Figure 4b). But around 20% of patients discharged from specialized psychiatric 251 service have no further contact with the health system.

253 PHC visits before a psychiatric admission

In 2022, 39.4% of admitted patients had not been seen at a PHC facility in the year preceding their admission, and this increased to 72.35% if one looked at the 30 days preceding an admission (Supplementary Figure 3). Since 2015 there has been a general trend of increasing PHC visits in the period before an admission. 2020, however, was the exception with the proportion of admissions with a PHC visit in the 30 days prior to admission decreasing in May to July. Despite this general increase, the median days between the last PHC visit and the psychiatric admission has remained relatively stable between 35 and 42 days (37 days in 2022).

262 Successful linkage to care

74 728 admissions at district/acute hospitals and 30 750 admissions at specialized hospitals were
 included in these analyses, the detailed characteristics of which are described in Table 1.

267 At district/acute hospitals (Table 2), those with a PHC visit in the preceding year were more likely to be 268 successfully linked to ambulatory services (adjusted Odds ratio [aOR] of 2.67 [95% confidence interval 269 {95%Cl} 2.58-2.77]). Women were also more likely to be successfully linked to care, as were older 270 patients and those without a primary substance related disorder. At specialized hospitals (Table 3) 271 similar trends were seen, bearing in mind the slightly different categorization of diagnoses and lengths 272 of stay. Those with a PHC visit in the year prior to admission (aOR 2.07 [95%Cl 1.93-2.22]) and women 273 (aOR 1.14 [95%Cl 1.05-1.23]) were more likely to be successfully linked to care, but increasing age and 274 previous psychiatric admissions were not associated with improved linkage to care.

275

276 Risk factors for readmission

At district/acute hospitals, female sex, older ages, being admitted to a rural hospital and a primary substance related diagnosis were associated with a lower risk of readmission. An increasing length of stay (but only up until 28 days), previous psychiatric admissions and a PHC visit in the year preceding an admission were risk factors for readmission. While the aORs for admission years decreased with time, a relative increase was seen in 2021, although 2022 has seen a return to aORs of pre-pandemic years. Successful linkage to care decreased the risk of readmission by 31% (aOR = 0.69 [95%CI 0.65-0.72]) and 24% (aOR = 0.76 [0.73-0.79]) for readmissions within 30 and 90 days respectively.

At specialized hospitals, successful linkage to care within 30 days of discharge was the most protective 284 285 factor against readmission within 30 and 90 days, with an aOR of 0.37 (95%CI 0.32-0.43) and 0.49 (0.44-286 0.55) respectively. Sex was not associated with readmission but a primary diagnosis that was substance 287 related had the lowest association with readmission. Previous admissions were strongly associated with 288 readmissions, as well as a PHC visit in the preceding year and being a direct admission to a specialized 289 hospital (i.e., patients not transferred from a district/acute hospital), although the latter two factors only 290 to a lesser degree. Longer lengths of stay were also protective of readmission, although the aOR for 60-291 90 days and \geq 90 days similar. There was no clear trend for admission years.

The alternative approach of using standard logistic regression on only the latest hospital admission for an individual found similar results (Supplementary Table 1 and 2).

294

295 Discussion

The main finding of this study is that a high proportion individuals who require psychiatric hospital admission, are not routinely attending at ambulatory services, both before and after the admission,

suggesting that opportunities to avert psychiatric hospital admissions and readmissions are being missed. Substance related disorders are contributing to not only the increase in admission numbers being seen, but once an individual is discharged home, those with a substance related disorder are less likely to successfully link to ambulatory services.

303 While COVID-19 and its after effects are likely contributing to the current increase in psychiatric 304 admissions, it must be highlighted that the trend of increasing admissions, particularly at the 305 district/acute level, was already established prior to 2020, implying that other factors, such as 306 increasing poverty, inequality, substance use and trauma/violence, could be driving this increase (18). 307 Food insecurity and neighborhood level deprivation were found to be associated with depression, 308 suggesting that structural poverty was contributing to the burden of mental illness in the South Africa 309 (5,6). A study conducted in Lentegeur Hospital in 2016 found that 62% of patients, and 73% of male 310 patients, used substances prior to their admission, with cannabis and methamphetamine being most 311 commonly used (7). While the substance rates we found were lower, they were dependent on clinician 312 ICD-10 coding, which is often not detailed enough, especially at the district/acute hospital level.

313 Increased admission numbers can also be related to increased access to in-patient health services, 314 particularly in settings where out-patient services are limited. The district/acute hospitals with the 315 highest number of psychiatric admissions in 2022 were the new large district hospitals of Mitchells Plain 316 and Khayelitsha, which opened in 2013 and 2012 respectively. And the increasing size of the general 317 population over time should also not be forgotten (18). Admission numbers at specialized hospitals, 318 however, showed only a muted increase in numbers, in line with provincial policy which preferentially 319 funded the expansion of beds at the district/acute level (Circular H18/2015). According to a Provincial 320 Database, the number of official psychiatry beds in the Cape Town Metro was 417 in 2022 (a 136%

increase from 2015), while the three specialized hospitals only increased by 11% in the same time
 period, to 1 527 beds in 2022.

323 24% of mental health inpatients nationally are being readmitted to hospital within three months of 324 being discharged (14). Our study found slightly lower rates of 18-19% within 3 months, and no increase 325 in the readmission rate, except for the relative increase in district/acute hospitals in 2021, although with 326 rising absolute numbers of admissions this might still change. Scarcity of in-patient psychiatric beds can 327 result in premature discharge policies, where patients are discharged home before full recovery, leading 328 to an increased risk of readmission (19). Our analysis showed that shorter lengths of stay were 329 associated with an increased risk of readmission at specialized hospitals, but up to a certain point only, 330 with lengths of stay above 90 days not decreasing the risk of readmission. Interestingly longer lengths of 331 stay at district/acute hospitals were associated with an increased risk of readmission, possibly 332 suggesting that these patients might benefit from specialized care. At the same time direct admissions 333 to specialized hospitals had higher aORs for readmission, highlighting the importance of patients being 334 managed at the appropriate level of care.

335

In 2022, 40% of admitted psychiatric patients had not been seen at PHC facility in the preceding year (a small proportion of these patients might still be in care, if they are being followed up by private facilities, hospital out-patient departments, or community health workers). The assumption that if these patients were regularly being followed up at the PHC level a hospital admission could be averted might not always be true, but by not following these patients up, we are potentially missing an opportunity to intervene. The relatively stable median days between PHC visit and psychiatric hospital admission of 35 to 42 days, despite the increasing proportion of individuals visiting a PHC in the year prior to admission,

reiterates this. Presumably patients receive their medication for 28 days, but do not return after, resulting in an exacerbation of symptoms and admission soon after.

And while out-patient services were impacted by COVID-19, particularly in early 2020, a finding which is supported by data from the South African private sector (20), the overall trend was of increasing, albeit slowly, PHC use prior to admission. However, it is important to note that digitized PHC headcount data became mandatory for provincial PHC facilities in April 2020, and so at least some of the increase we are seeing is related to better electronic data capture rather than an actual change in PHC usage.

350 With regards to linkage post-discharge, male patients and those with substance related diagnoses were 351 less likely be linked after discharge, at both hospital levels. This is in line with data from a study in 352 patients with schizophrenia in Cape Town that found that substance use disorders were most strongly 353 associated with non-adherence (21). Ongoing psychotic symptoms, impaired insight and involvement 354 with the criminal justice system have been found to be barriers to engagement with ambulatory services 355 (22). Those with longer hospital admissions were also more likely to be successfully linked to care, 356 possibly reflecting that those individuals have more severe disease and/or that during the longer 357 hospital stay more time was put into preparing post-discharge care. Later admission years were 358 associated with more successful linkage to care, although improving electronic PHC headcount data 359 might be biasing this as well.

360

Successful linkage to care after discharge was one of the most protective factors against readmission within 30 and 90 days, at both hospital levels. All the other covariates in these analyses are relatively fixed, with the health system having limited control over them, the exception being length of hospital stay - although with limited bed capacity this ability is also constrained. PHC visits in the year prior to admission were associated with an increased risk of readmission, possibly indicating the chronicity of

the underlying disease more than the subsequent health seeking behaviour. Linkage to ambulatory psychiatric services remains a challenge globally (23). And in the Western Cape, this challenge is not limited to psychiatry services only. Patients diagnosed with tuberculosis in hospital, for instance, are more likely to be lost to follow up and have higher mortality than those diagnosed at clinics (24). Effective clinical bridging strategies proposed have included communicating discharge plans to outpatient clinicians, family involvement during the hospital stay and starting outpatient programs before discharge (23).

373 Limitations

By using routinely collected electronic data, a limitation of this study is firstly that we were restricted to 374 375 admitted patients only, and secondly, that we were dependent on diagnostic coding that was not always 376 accurate or sufficiently detailed. Also because of the challenges with diagnostic coding, we could only 377 identify patients by the admitting specialty of psychiatry, excluding psychiatric patients in Emergency 378 Centres and those admitted to other specialties. While this will underestimate the total number of 379 psychiatric patients in hospital, particularly for suicidal patients, the trends are still important, and the 380 absolute numbers of patients admitted to psychiatric wards remain crucial to those services. In addition, 381 with the expansion of electronic data use at PHC level during the study period, it is impossible to 382 determine how much of the increase in PHC use that is related to better data capturing. Further detailed 383 studies assessing the mental health burden at PHCs and Emergency Centres are needed.

For the readmission analyses, data on out-of-facility deaths and migration out of the province is not currently available at the PHDC. If after hospital discharge, an individual moves back to the family home in another province and relapses there, they will not be counted as a readmission, artificially lowering the readmission rate. And if there is differential out-migration by hospital drainage area, this would contribute to the varying facility readmission rates. Private patients also access psychiatric services in

389	the public sector, but billing information was too incomplete to be adjusted for. While the stratification
390	of these analyses by hospital level is reasonable, it does not consider the fact that patients often move
391	between the two levels over many years, and more comprehensive longitudinal analyses taking into
392	account the individual patient journeys through the health system are needed.
393	
394	Conclusion
395	Driven by poverty and substance use, psychiatric admissions have increased markedly, particularly at the
396	district/acute hospital level, and have been exacerbated further by the COVID-19 pandemic. While
397	ambulatory service use before and after a psychiatric hospital admission is slowly increasing with time,
398	more can possibly be done at that level to avert hospital admissions. Successful linkage to ambulatory
399	services following hospital discharge is one of the most protective factors against readmission, and
400	stronger measures need to be put in place to ensure that all individuals discharged home receive
401	appropriate follow-up.

















Median days since last psychiatric admission
