31 Abstract

32	Introduction: Taiwan introduced a two-dose inactivated Japanese encephalitis (JE) mouse brain-
33	derived (JE-MB) vaccine into routine childhood immunization in 1968, with booster vaccination
34	implemented in 1974 and 1983. In 2017, JE-MB vaccine was replaced by a two-dose live-attenuated
35	chimeric vaccine (JE-CV). After implementation of JE vaccination programs, JE cases have shifted
36	from children to adults. In this study, we described the JE epidemiology and identify high-risk
37	groups to further inform vaccine policy.
38	Methodology/Principal Findings: We extracted data from Taiwan's notifiable disease surveillance
39	database, vital statistics, and employment statistics from 2010 to 2022. Diagnosis of JE was
40	confirmed by JE seroconversion, a four-fold increase in virus-specific antibodies, a positive JE viral
41	nucleic-acid test, or JE virus isolation. From 2010 to 2022, a total of 313 cases of JE were diagnosed,
42	resulting in an overall incidence rate of 0.10 cases per 100,000 person-years and a mortality rate of
43	0.006 per 100,000 population. Among these patients, 64% were male, and the median age was 51
44	years (range 0-82). Compared with people born in or after 1976 (vaccinated with four doses of JE-
45	MB vaccine or two doses of JE-CV), those born in or before 1962 (unvaccinated) and those born
46	during 1963–1975 (vaccinated with two or three doses of JE-MB vaccine) had a 4.2-fold (95%
47	confidence interval [CI] 3.0–5.7) and 5.9-fold (95% CI 4.3–8.1) higher risk of JE, respectively. The
48	relative risk of working in agriculture, forestry, fishing, or animal husbandry, compared to other
49	occupations, was 5.0 (95% CI 3.5-7.0).

- 50 **Conclusions/Significance:** In Taiwan, individuals born before 1976 and those employed in
- 51 agriculture, forestry, fishing, or animal husbandry had a higher risk of JE. We recommend JE
- 52 vaccination for people in these high-risk groups who have not been fully vaccinated or have an
- 53 unknown vaccination history.

56 Author Summary

57	The Japanese encephalitis (JE) virus is primarily transmitted through infected mosquito bites
58	between animals such as pigs and birds, with humans being the dead-end hosts. JE can lead to death
59	or long-term neurological or psychiatric complications. Vaccination is the most effective preventive
60	measure against JE. With the implementation of comprehensive immunization programs against JE
61	since 1960s, Taiwan has experienced a significant decline in the incidence and mortality rates of the
62	disease. This retrospective observational cohort study utilized Taiwan's national databases from 2010
63	to 2022 to investigate the epidemiology of JE and identify high-risk populations, thereby to inform
64	vaccine policy. A total of 313 JE cases were diagnosed among Taiwanese citizens with an incidence
65	rate of 0.10 cases per 100,000 person-years and a mortality rate of 0.006 per 100,000 population,
66	indicating consistently low incidence and mortality rates. Several factors were statistically
67	significantly associated with the occurrence of JE, including male gender, individuals born before
68	1976, residing outside the northern region, and working in occupations related to agriculture,
69	forestry, fishing, or animal husbandry. To prevent JE, it is recommended to offer vaccination to high-
70	risk populations who have not completed their immunization.

73 Introduction

74	Japanese encephalitis virus (JEV) is primarily transmitted among various animals, including
75	pigs and birds, through the bites of infected mosquitoes, particularly Culex tritaeniorhynchus [1, 2].
76	Humans, as the dead-end host, may become infected incidentally through the bites of infected
77	mosquitoes [1, 2]. Symptoms of JEV infection can vary from mild flu-like symptoms to encephalitis,
78	the latter being characterized by high fever, headache, neck stiffness, disorientation, coma, seizures,
79	and paralysis. About 20% of the patients with Japanese encephalitis (JE) died, and up to 50% of the
80	survivors suffered from long-term neurological or psychiatric sequelae [3, 4]. There is still no
81	specific antiviral treatment available for JE. Given that herd immunity may not necessarily work, the
82	most effective approach to preventing JE is personal vaccination or adopting measures to avoid
83	mosquito bites [5].

92	2000s in Taiwan, the majority of JE patients were individuals who had not received the vaccine
93	previously [5]. However, since 2010, JEV genotype I has replaced genotype III as the dominant viral
94	strain in Taiwan [10], and the effectiveness of JE-MB vaccine against this different strain after more
95	than 30 years of vaccination has not been evaluated.
96	The risk of JE is also influenced by various other factors. Mosquitoes play a critical role in
97	exposing humans to JEV [11]. The abundance of mosquitoes and the spread of JEV are significantly
98	affected by multiple factors, including temperature, humidity, precipitation, altitude, land use,
99	agricultural practices, livestock and bird densities, and socioeconomic status [12-16]. In Taiwan, the
100	primary vector species for JEV transmission is C. tritaeniorhynchus [10], and the risk of JE is
101	associated with rising temperatures and specific humidity levels [13]. The eastern region of Taiwan
102	has reported a higher incidence of JE, but the underlying cause remains unknown [17, 18]. Pig farms
103	may pose a higher JE risk than wetlands due to the significantly higher rates of JEV infection in
104	mosquitoes from pig farms [10]. While mosquito-borne diseases have been recognized as
105	occupational diseases for individuals traveling to endemic areas [19], the knowledge may be lacking
106	in areas where they are prevalent. Studies examining JE in specific occupations have mainly relied
107	on questionnaire surveys [20] and descriptive epidemiology [21, 22], highlighting the need for more
108	analytical epidemiological studies.
109	Since there is currently no definitive method to control the vector, vaccination is considered an

110 effective approach to preventing JEV infection [23]. The objective of this study was to explore the

- 111 epidemiology of JE and identify the current high-risk groups, aiming to inform vaccination policies
- 112 in Taiwan.

114 Materials and Methods

115 Study population and setting

116	In Taiwan, JE has been categorized as a mandatory notifiable infectious disease since 1955, and
117	in 1965, the Centers for Disease Control (CDC) established laboratory testing methods to aid in the
118	diagnosis of JE. Clinicians were responsible for identifying patients suspected of having JE by
119	assessing symptoms such as fever, headache, neck stiffness, vomiting, acute psychosis (delirium,
120	confusion, etc.), disturbance of consciousness, abnormal muscle tone, focal neurological deficit, or
121	seizure. Subsequently, the medical staff at the hospital reported the patients' basic information and
122	clinical characteristics to the CDC, along with samples of blood, cerebrospinal fluid, or tissue to the
123	CDC for confirmation of the diagnosis. Upon the confirmation of a case, local health authorities
124	promptly initiated a comprehensive investigation into the affected individuals, including inquiries
125	into their residential and occupational environments. Furthermore, information was provided to
126	reinforce hygiene education among individuals at risk in the surrounding areas.
127	In order to further decrease the incidence and mortality rates of JE, Taiwan incorporated the JE
128	vaccine into its Expanded Program on Immunization for children in 1968. Initially, children aged 3
129	years or younger received two doses of JE-MB vaccine [8]. By 1974, the vaccination regimen was
130	expanded to three doses, with a booster dose of JE-MB vaccine administered one year after the initial
131	two doses [8]. Additionally, starting in 1983, children in their first year of elementary school
132	received an extra booster dose of JE-MB vaccine [8, 24]. Since 2017, traditional vaccines have been

133	replaced by a live-attenuated chimeric vaccine (JE-CV), which is administered in two doses with a 1-
134	year interval. This vaccine implementation has effectively prevented JE and resulted in a shift of JE
135	occurrences from children to adults. Between 1968 and 2012, the incidence rate of JE has declined
136	significantly from 2.05 to 0.12 cases per 100,000 person-years [8, 17]. Prior to 1966, over 95% of JE
137	patients were aged 20 years or younger, whereas after 1998, over 90% were aged more than 20 years
138	[8, 25]. Moreover, the mortality rate has also been decreasing year by year [17].
139	
140	Study procedure
141	This retrospective observational cohort study was conducted in Taiwan utilizing nationwide

142 databases from January 2010 to December 2022. Our investigation involved the utilization of the

143 National Infectious Disease Reporting System (NIRDS) archive, which is maintained by the CDC.

144 This allowed us to gather comprehensive information pertaining to laboratory-confirmed JE cases,

145 including details such as sex, birth date, residence, environmental exposure, occupational category,

146 symptoms, signs, date of diagnosis, and, if applicable, death date. To facilitate the identification and

147 comparison of risk factors, we also obtained data on the sex, birth cohort, residence, and

148 occupational category of all Taiwanese citizens throughout the duration of the study. To obtain these

149 data, we utilized two reliable sources—the nationwide Population Data published by the Department

150 of Household Registration, the Ministry of the Interior, and the Employment and Unemployment

151 Statistics Enquiry System, managed by the Directorate General of Budget, Accounting, and

152 Statistics.

154 *Laboratory investigations*

155	The central laboratory of Taiwan CDC is well-equipped to conduct essential diagnostic tests for
156	JE, encompassing serological diagnosis, molecular diagnosis, and virus isolation using cell culture.
157	In the past, the hemagglutination inhibition assay was employed to identify a four-fold increase in
158	plasma antibodies against both JE and dengue fever, with dengue antibody test results serving as a
159	negative control to minimize the potential for cross-reactivity. However, a more specific diagnostic
160	method for JE was developed by the laboratory in 1998. This method utilized an envelope- and
161	membrane-specific capture IgM and IgG enzyme-linked immunosorbent assay (ELISA) to detect
162	seroconversion, which subsequently became the primary approach for serological diagnosis. Starting
163	in 2001, molecular diagnosis became another valuable tool for detecting JEV RNA in blood,
164	cerebrospinal fluid, or tissue through real-time polymerase chain reaction. Additionally, virus
165	isolation through cell culture was another diagnostic technique employed, which involved observing
166	characteristic cytopathic effects and detecting its antigen using an indirect immunofluorescence
167	assay. At least one of the three diagnostic methods (serological diagnosis, molecular diagnosis, and
168	virus isolation through cell culture) was necessary to confirm case of JEV infection.

170 Data collection and definitions

171	Between 2010 and 2022, laboratory-confirmed JE cases were recorded monthly, from January to
172	December. All patients and/or family members were thoroughly inquired about a range of symptoms,
173	including fever, headache, neck stiffness, vomiting, acute psychosis, disturbance of consciousness,
174	movement disorder, focal neurological deficit, seizures, and any other unlisted symptoms. Mortality
175	data were collected and linked to the NIDRS through mandatory reporting. The observation period
176	for mortality was extended to one year following the onset of symptoms or until May 29, 2023.
177	The laboratory-confirmed cases of JE, as well as the entire Taiwanese population, underwent a
178	grouping based on sex at birth and birth date. Males and females were distinguished, and age
179	categories were established to cover different age ranges: juveniles (<18 years), adults (18-64 years),
180	and the elderly (≥65 years). Furthermore, this study classified individuals into three groups based on
181	their birth year: those born in or before 1962, those born between 1963 and 1975, and those born in
182	or after 1976. These groups were identified as follows: Cohort 1, consisting of unvaccinated
183	individuals; Cohort 2, including those who received two or three doses of JE-MB vaccine; and
184	Cohort 3, comprising those who received either four doses of JE-MB vaccine or two doses of JE-CV
185	vaccine.
186	The residences were divided into four regions according to the National Development Council's
187	classification, based on cities or counties. The northern region consisted of Taipei, New Taipei,
188	Keelung, Taoyuan, Hsinchu, Yilan, Lianjiang, and Kinmen. The central region included Miaoli,
189	Taichung, Nantou, Changhua, and Yunlin. The southern region encompassed Chiayi, Tainan,

190	Kaohsiung, Pingtung, and Penghu. The eastern region comprised Hualien and Taitung (Fig S1).
191	Through the investigations, potential sources of exposure for JE patients, such as pig farms and
192	pigeon coops within a one to five-kilometer radius, as well as rice paddy fields, were identified [26,
193	27]. Individuals working in agriculture, forestry, fisheries, or animal husbandry were identified,
194	while those employed in other industries, such as manufacturing and services, were classified as
195	"other occupations."
196	
197	Statistical analysis
198	The incidence and mortality rates of JE were calculated as the total number of occurrences
199	divided by the total person-years of follow-up. For demographic and clinical characteristics,
200	quantitative variables were analyzed by calculating medians and ranges, while categorical variables
201	were examined by calculating numbers and percentages. To assess the relative risk (RR) for each
202	category of sex, age, birth cohort, residence, and occupation, the risk of each group was compared
203	with the risk of all the other groups. The 95% confidence interval was estimated using the Poisson
204	distribution. Statistical analyses were performed using Statistical Analysis Software version 9.4
205	(SAS Institute, Cary, NC, USA).
206	
207	Ethics Statement

208 This study was approved by the Institutional Review Board of Centers for Disease Control,

- 209 Ministry of Health and Welfare, Taiwan (No. TwCDCIRB112110). All information was anonymized
- and analyzed as secondary data. Informed consent was waived due to the retrospective design.

212 **Results**

213 Incidence and mortality rates

- From 2010 to 2022, a total of 313 Taiwanese citizens were diagnosed with JE through laboratory
- 215 confirmation. The median annual number of JE cases was 22, ranging from 15 to 35 cases. The
- 216 overall incidence rate was 0.10 cases per 100,000 person-years, which varied between 0.06 and 0.15
- 217 across the 13 study years. However, no significant change in the incidence rate was observed over
- the years (Fig 1A). The months of June (41%) and July (32%) had the highest occurrence of JE,
- followed by May (12%) and August (6%). Notably, there were no JE cases diagnosed during the
- 220 months of December, January, February, March, and April (Fig 1B).
- Among the 313 JE patients, fever (80%) and mental status changes (69%) were the most
- prevalent symptoms, followed by headaches (34%), acute psychosis (22%), and neck stiffness
- 223 (18%). Less common symptoms included vomiting, seizures, movement disorders, and focal
- neurological deficits. The overall mortality rate was low, with an estimated rate of 0.006 per 100,000
- population per year (Fig 1A). The case fatality rate was 5.4%, with 17 deaths occurring within one
- 226 year of diagnosis. Of the 17 fatal cases, 29% occurred within 30 days, while 76% and 88% occurred
- within 90 and 180 days of diagnosis, respectively.

229 Sex, age, and birth cohort

Among the 313 patients diagnosed with JE, males accounted for 64% of the cases, with females

231	comprising the remaining 36%. The overall incidence rate for males (0.13 per 100,000 person-years)
232	was higher than that for females (0.07 per 100,000 person-years) (Fig 2A). The median age of the JE
233	patients was 51 years (range, 0 to 82). Only 2%, were juveniles, while the majority were adults,
234	making up 87% of the cases, and the remaining 11% were elderly individuals. The overall incidence
235	rates for JE among juveniles, adults, and the elderly were 0.01, 0.13, and 0.08 per 100,000 person-
236	years, respectively (Fig 2B). Throughout the study period, the proportions of all JE patients
237	diagnosed in Cohorts 1, 2, and 3 were 41%, 41%, and 18%, respectively. Cohorts 1 and 2 had higher
238	overall incidence rates of 0.15 and 0.21 cases per 100,000 person-years, respectively, while Cohort 3
239	had the lowest rate of 0.04 cases per 100,000 person-years (Fig 2C).

252	these two groups were 0.59 and 0.12 per 100,000 person-years, respectively (Figure 2E).
253	
254	Risk factors of Japanese encephalitis
255	This study identified several significant factors associated with JE, including sex, age, birth
256	cohort, residence, and occupation (Table 2). Males had a higher risk compared to females (RR 1.8,
257	95% CI 1.4–2.3). Adults and elderly individuals were at significantly higher risk compared to
258	juveniles (RR 11.1, 95% CI 5.0–25.0 and RR 7.3, 95% CI 3.1–17.4, respectively). Cohorts 1 and 2
259	had higher risks compared to Cohort 3 (RR 4.2, 95% CI 3.0–5.7 and RR 5.9, 95% CI 4.3–8.1,
260	respectively). People residing in central, southern, and eastern Taiwan had higher risks compared to
261	those living in northern Taiwan (RR 2.4, 95% CI 1.7–3.3, RR 3.4, 95% CI 2.6–4.6, and RR 5.4, 95%
262	CI 3.3–9.0, respectively). Furthermore, workers in agriculture, forestry, fishing, or animal husbandry
263	had a higher risk compared to individuals in other occupations (RR 5.0, 95% CI 3.5–7.0).

265 **Discussion**

266	From 2010 to 2022, Taiwan experienced consistently low incidence rate of JE and its associated
267	mortality. However, certain factors were identified as being associated with a higher incidence of JE
268	in Taiwan, which included male gender, individuals born before 1976, residing outside the northern
269	region, and working in occupations related to agriculture, forestry, fishing, or animal husbandry.
270	Compared to other countries in the Asia-Pacific region, Taiwan has made significant strides in
271	combating JE [28]. Similar to South Korea and Japan, Taiwan has successfully reduced the
272	occurrence and death rates of JE [17, 28-30]. Various factors have contributed to this achievement,
273	including urbanization, reduced rice paddy field sizes, relocation of pig farms, and the use of
274	pesticides to control mosquito vectors. However, the most crucial factor has been the implementation
275	of comprehensive immunization programs against JE. Initially introduced in the 1960s, the program
276	administered two or three doses of the JE-MB vaccine, resulting in a vaccination rate of 80% or
277	higher. Subsequently, the policy was updated to administration of four doses, with an outstanding
278	vaccination rate of 95%. As a result, Taiwan has maintained a stable JE incidence rate of 0.10 cases
279	per 100,000 person-years over the past three decades [8], with a record-low death rate of 0.006 per
280	100,000 population per year in the past decade [17]. The success of the JE immunization program
281	has also highlighted the crucial role of vaccination in reducing fatalities [3], as evidenced by
282	Taiwan's one-year case fatality rate of 5.4%, which was lower than those in the previous records
283	[17]. However, it is important to acknowledge the potential for a slight increase in delayed deaths

resulting from long-term neurological or psychiatric sequelae [4].

285	In Taiwan, different numbers of vaccine doses may result in varying levels of protection. Cohort
286	1, with a higher likelihood of mosquito exposure during childhood, primarily acquired JEV infection
287	naturally. On the other hand, Cohorts 2 and 3 obtained antibodies through various vaccination
288	programs implemented following environmental changes. During the follow-up period, Cohorts 1
289	and 2 exhibited significantly higher incidence rates of JE compared to Cohort 3. This could be
290	attributed to lower antibody levels in Cohorts 1 and 2, unlike nearly all people of Cohort 3 who had
291	undergone complete vaccination against JE and might continue to have higher antibody levels [8].
292	Furthermore, Cohort 2 had a higher incidence rate than Cohort 1, potentially due to incomplete
293	vaccination that might fail to provide the same long-lasting immunity as natural infection. Another
294	factor to consider was the vaccines developed for JEV genotype III might have reduced effectiveness
295	against JEV genotype I [31]. Overall, this study suggested that individuals who had not received four
296	doses of JE-MB vaccine exhibited significantly higher incidence rates than those who had received
297	four doses of JE-MB vaccine or two doses of JE-CV. Our findings may provide additional insights
298	into previously limited information on vaccine effectiveness at the population level [4, 18].
299	There were several other factors that contributed to the occurrence of JE in Taiwan. Men were
300	found to have a higher risk than women, likely due to their involvement in outdoor activities.
301	Nationwide data between 2010 and 2022 revealed that men had an average labor force participation
302	rate of 67%, while women's rate was approximately 51%. JE was predominantly prevalent during

303	June and July, influenced not only by the favorable temperature and humidity for mosquito growth
304	but also by pig breeding [13, 17]. The agriculture, forestry, fishing, and animal husbandry industries
305	posed a higher risk of disease transmission, likely due to increased exposure to pigs, birds, and
306	farmland. However, in Taiwan, an endemic area for JEV infection, criteria for determining whether
307	JEV infections in individuals residing in such areas are qualified as occupational diseases have not
308	been established. This study revealed the link between JE and occupational factors by identifying a
309	notable number of JE patients in Taiwan over the past 13 years who were involved in specific
310	occupations.
311	The incidence of JE in Taiwan exhibited regional variations, with the eastern region having the
312	highest incidence, followed by the southern and central regions, while the northern region had the
313	lowest incidence. Previous research has indicated that the seropositive rate of Cohort 2 sampled in
314	eastern Taiwan was lower [32], suggesting a lower vaccination coverage during the early stages of
315	the vaccination program in that particular region. Moreover, the distribution of industries varied
316	across different regions, with 80% of agriculture and animal husbandry workers concentrated in the
317	central, southern, and eastern regions. In these regions, the proportion of such workers was 5-15
318	times higher than in the northern region, with the eastern region having the highest proportion. As a
319	result, individuals residing in the eastern region of Taiwan were likely at a higher risk of contracting
320	JEV infection due to a lower vaccine coverage and a greater proportion of agriculture and animal
321	husbandry workers.

322	The production of JE-MB vaccine was discontinued due to safety concerns and the requirement
323	for multiple doses, despite its immunogenicity. In contrast, JE-CV has been shown to be safe, highly
324	immunogenic, and capable of providing long-lasting immunity. Notably, a single dose of JE-CV is
325	sufficient to confer protective immunity, comparable to the effect of three doses of JE-MB vaccine in
326	adults [33]. In light of the unavailability of JE-MB vaccine, JE-CV could be considered as a
327	replacement or used as a booster or catch-up regimen [25]. However, it is important to note that,
328	similar to JE-MB vaccine, JE-CV is derived from the JEV genotype III strain (SA14-14-2). While
329	some partial cross-protection between genotype I and III strains has been observed in mice, the
330	effectiveness of JE-CV against the genotype I strain was lower than its effectiveness against the
331	genotype III strain, as demonstrated in both mice and swine [31, 34]. Further analysis of vaccine
332	effectiveness in humans would be necessary, and the development of a bivalent vaccine could be a
333	potential alternative strategy for vaccination against JE.
334	
335	Limitations
336	There were several limitations to this study. First, the incidence and mortality of JE may have
337	been underestimated as the awareness of JE and decision to notify suspected cases was at the
338	discretion of attending physicians. However, since notification for laboratory confirmation was
339	easily accessible and free of charge in Taiwan, the likelihood of missing to notify suspected cases

340 was relatively low. Second, there might be inaccuracies in the established databases. We did not have

341	vaccination records for all individuals, and our evaluation of vaccine effectiveness relied solely on
342	the risk of the birth cohort. Furthermore, the scope of investigation by local health authorities
343	regarding exposure to pigs, pigeons, and rice paddy fields might not have been extensive enough
344	given the long-distance migration ability of C. tritaeniorhynchus [35]. To address this, we assessed
345	the occupational risk of agriculture, forestry, fishing, and animal husbandry workers to evaluate the
346	exposure risk. Third, it is important to note that factors identified as high risk for JE do not
347	necessarily prove causation. Possible risk factors were not simultaneously evaluated in one model,
348	and future studies should consider adjusting for confounding factors. Finally, it should be
349	emphasized that the prevalent JEV strains in Taiwan after 2010 were genotype I. Therefore, the
350	findings of this study may not be generalizable to other countries, and policies should be adjusted
351	based on research results relevant to the specific region or country.
352	
353	Conclusions
354	JE is a life-threatening disease that should not be underestimated, despite its low incidence and
355	mortality rates in Taiwan. It poses a particular risk to individuals born before 1976 and those
356	employed in agriculture, forestry, fishing, or animal husbandry. To prevent JE, vaccination should be
357	offered to high-risk populations who have not received complete immunization.






Fig 1. (A) The incidence and mortality rates of Japanese encephalitis (n = 313). (B) The incidence rate of Japanese encephalitis by month (n = 313).









