### 22 Abstract

To assess the association between sleep and seroconversion after 23 receipt of two doses of inactivated severe acute respiratory 24 syndrome-coronavirus-2 (SARS-CoV-2) vaccines in pregnant women. 25 The serum level of immunoglobulin (Ig)G antibodies against the nucleic 26 acids of SARS-CoV-2 was measured. Logistic regression was used to 27 analyze the association between sleep and seroconversion. After two doses 28 of SARS-CoV-2 vaccine, 41.2% of the study cohort reached 29 seroconversion. Analysis revealed that pregnant women with poor quality 30 of sleep had a lower serum level of IgG antibodies (P = 0.008, 95%CI = 31 0.285–0.826) and that sleeping late at night (SLaN) may be a risk factor for 32 a low serum level of IgG antibodies (P = 0.025, 95%CI = 0.436-0.946). 33 Besides sleep, age and the time since vaccination were important 34 influences on seroconversion. A stratified analysis revealed that the effects 35 of sleep quality and SLaN on seroconversion occurred mainly in pregnant 36 women aged <35 years. Thus, sleep quality and SLaN can affect the serum 37 level of IgG antibodies in pregnant women after vaccination with 38 inactivated SARS-CoV-2. 39

### 41 Introduction

The coronavirus disease-2019 (COVID-19) pandemic was once an important public-health issue worldwide despite aggressive government

responses. Mass vaccination is a key measure to control the spread of this
outbreak. Dozens of severe acute respiratory syndrome-coronavirus
disease-2 (SARS-CoV-2) vaccines have been approved for use, with >1.2
billion doses administered worldwide as of August 2022<sup>[1]</sup>. Countries used
to adopt home-quarantine methods to control the spread of COVID-19, in
addition to large-scale vaccination.

The symptoms of COVID-19 infection and the side effects of 50 vaccination may lead to sleep problems, but whether it is also related to 51 other factors of the vaccine is unknown. Sleep is a state of total rest and 52 active neuromodulation of the central nervous system required by the body 53 to eliminate fatigue. Several studies have shown that sleep can be involved 54 (directly or indirectly) in regulation of the immune system through its 55 effects on the nervous system and neuroendocrine system<sup>[2,3]</sup>. Maintenance 56 of many immune functions is dependent on circadian rhythms and regular 57 sleep. Sleep can affect various components of the immune system, and 58 sleep disturbance can cause changes in the number and function of 59 immune cells. 60

Clinical findings have shown that sleep deprivation affects expression
of proinflammatory factors in central and peripheral systems in humans.
Five nights of sleep restriction has been shown to increase circulating
levels of the proinflammatory factors interleukin (IL)-1β, IL-6, and IL-17,
which remain at high levels even after 2 nights of sleep recovery<sup>[4]</sup>. In a

prospective cohort study from Greece, in which all enrolled participants
received two doses of a vaccine based on mRNA SARS-CoV-2, insomnia
was found to be associated with a lower serum level of immunoglobulin
(Ig)G antibodies, but that study did not involve pregnant women<sup>[5].</sup>

Physiological changes during pregnancy have significant effects on the immune system and respiratory system. The effect on the immune system after vaccination is influenced by various factors. However, few studies have investigated the effect of sleep on the immune system of pregnant women after administration of a vaccine based on inactivated SARS-CoV-2.

Here, we investigated the effect of sleep on the serum level of IgG
antibodies in pregnant women after receipt of two doses of inactivated
SARS-CoV-2 vaccine.

### 79 Methods

80 Study design

We collected information from the electronic medical records of pregnant women who gave birth in three hospitals in Guangzhou from December 2021 to March 2022. These women were given questionnaires to complete. All participants provided written informed consent. The study protocol complied with the Declaration of Helsinki 1964 and its later amendments. The data they provided included demographic information as well as information on basic behavioral lifestyle, including marital

status, educational level, occupation, age (stratified by the advanced
maternal age defined by the World Health Organization), body mass index,
time of last menstruation, sleep status (duration of nighttime sleep,
"napping", sleeping late at night (defined as go to bed past 11 p.m, SLaN),
sleep disturbance, sleep quality), tobacco smoking, alcohol consumption,
pregnancy, disease history, and the time since vaccination (defined as the
time interval between the last dose of vaccine and blood collection).

To exclude the effect of different doses of vaccine on the serum level of IgG antibodies, only pregnant women who received two doses of inactivated SARS-CoV-2 vaccine were included in this study. Pregnant women who had been infected or were infected with SARS-CoV-2 after enrollment and who received non-inactivated vaccine were excluded.

#### **Collection and analyses of samples**

After enrollment, 5 mL of venous blood was collected, centrifuged to separate the serum, and stored at  $-80^{\circ}$ C. IgG antibodies against the nucleic acids of SARS-CoV-2 were detected using a chemiluminescence kit (Bioscience, Chongqing, China). A serum level of IgG antibodies <1.00 signal/cutoff (S/CO) ratio was considered negative. A serum level of IgG antibodies  $\geq$ 1.00 S/CO was considered positive.

107 Statistical analyses

108 Descriptive analysis was used to denote demographic features. Factors 109 that may affect the serum level of IgG antibodies were identified using the

chi-squared test or rank-sum test. Logistic regression analysis was employed to analyze the relationship between sleep-related factors and antibody positivity. Statistical analyses were undertaken using SPSS 25.0 (IBM, Armonk, NY, USA). P < 0.05 (two-sided) was considered significant.

115 **Results** 

### **Demographic and clinical characteristics**

The study cohort comprised 650 pregnant women aged 18–43 years who had received two doses of inactivated SARS-CoV-2 vaccine before or during pregnancy. The number of pregnant women who had two doses of SARS-CoV-2 vaccine before and during pregnancy was 544 (83.7%) and 106 (16.3%), respectively.

A total of 440 (67.6%) pregnant women had suffered from a sleep disturbance in the previous year. These sleep disturbance included: difficulty in falling asleep (unable to fall asleep within 30 min); awakening readily or early at night; frequent visits to the toilet at night; nightmares; excessive dreaming. Seventy-nine pregnant women were aged >35 years (12.1%) (**Table 1**).

### 136 Relationship between the serum concentration of IgG

137 antibodies and sleep

"Seroconversion" is the development of specific antibodies in the blood 138 serum as a result of infection or immunization, including vaccination. We 139 discovered that, after vaccination, 41.2% of pregnant women had produced 140 IgG antibodies against the nucleic acids of SARS-CoV-2. Most of the 141 enrolled pregnant women had the habit of SLaN (73.8%) and taking a nap 142 (72.8%). The duration of nighttime sleep was  $8.51\pm1.14$  h and the duration 143 of a single nap was 0.81±0.81 h. Univariate analysis revealed a significant 144 difference between education level, occupation, and exercise status and 145 napping (P < 0.05). A significant difference between the prevalence of 146 SLaN and production of IgG antibodies was documented (P =147 0.043)(Table 1). 148

Logistic regression analysis revealed a significant difference between sleep quality, SLaN, and production of IgG antibodies (P < 0.05)(**Table 2**). We discovered that the prevalence of seroconversion was lower in pregnant women who had poor quality of sleep (P = 0.008, 95%CI 0.285–0.826) and that SLaN may be a risk factor for low production of IgG antibodies in pregnant women (P = 0.025, 95%CI 0.436–0.946), which

155	persisted even after adjustment for confounders. In addition to the
156	significant difference between sleep factors and production of IgG
157	antibodies, age ( $P = 0.016$ , 95%CI 0.307–0.885) and the time since
158	vaccination (defined as the time interval between the last dose of vaccine
159	and blood collection) ( $P$ < 0.001, 95%CI 0.912–0.967) were associated
160	with seroconversion.

For the further exploring the differences between SLaN, sleep quality, 168 and the serum level of IgG antibodies in pregnant women of different age 169 groups and at the time since vaccination, a stratified analysis was 170 conducted within two groups: pregnant women aged 35 years (Table 3); 171 24 weeks after vaccination (Table 4). The effects of sleep quality and 172 SLaN on the serum level of IgG antibodies in pregnant women were found 173 mainly in the group younger than 35 years. No relationship between sleep 174 quality, SLaN, and the serum level of IgG antibodies was found in the 175 group vaccinated <24 weeks previously. However, in the group vaccinated 176 >24 weeks previously, there was an association between SLaN and the 177 serum level of IgG antibodies, but not significantly so (P = 0.053). 178

#### Discussion 186

Vaccination using inactivated SARS-CoV-2 is an effective measure 187 to prevent SARS-CoV-2 infection. China, with its large population, 188 provides an opportune study site for assessing vaccination using 189 inactivated SARS-CoV-2 in pregnant women. To our knowledge, this is 190 the first study to investigate the association of sleep status and 191 seroconversion after vaccination using inactivated SARS-CoV-2 in 192 pregnant women. The present study found sleep status was found to be 193 associated with serum level of IgG antibodies. 194

To explore the impact of sleep status on antibody levels in pregnant 195 women after vaccination against SARS-CoV-2 is a rational approach. 196 Physical discomfort, anxiety, or hormonal changes caused by pregnancy 197

can lead to sleeping problems in pregnant women<sup>[17]</sup>. Studies have shown 198 that disruption of sleep patterns leads to endocrine disorders and changes 199 in the balance of the immune system, including changes in the number of 200 immune cells and cytokine levels in peripheral blood. This phenomenon 201 results in reduced immune defense against, and increased susceptibility to, 202 pathogens<sup>[6]</sup>, which increases the risk of SARS-CoV-2 infection in 203 pregnant women. Which was similar to our findings that pregnant women 204 with poor quality of sleep or SLaN had a lower serum level of IgG 205 antibodies. 206

The level of the immune response after vaccination is influenced by 207 different factors, including vaccine dose and age, which may have a 208 significant impact on the efficacy and duration of vaccine protection. 209 However, few studies have explored the effect of sleep on the immune 210 response after vaccination with inactivated SARS-CoV-2. In the present 211 study, poor sleep quality was found to be a risk factor for the serum level of 212 IgG antibodies, a finding consistent with that of other vaccine-related 213 studies. In a large-sample cohort study, all participants received two doses 214 of the mRNA SARS-CoV-2 vaccine, but pregnant women were excluded. 215 That study found that poor quality of sleep was associated negatively with 216 antibody levels<sup>[5]</sup>. 217

Observations on the immune response to vaccines and the relationship with sleep arose originally from animal studies. Brown and

colleagues found that clearance of the influenza virus was slowed in 220 sleep-deprived mice compared with that in mice with a normal sleeping 221 pattern<sup>[7]</sup>. Clinical research on sleep and the immune response to 222 vaccination has focused on vaccines against influenza, hepatitis, and 223 Salmonella Typhi. A study of a healthy population aged 40–60 years who 224 received three doses of hepatitis-B vaccine revealed that a short duration of 225 sleep was strongly associated with the likelihood of a reduced serum level 226 of antibodies to the hepatitis-B vaccine. Also, this negative effect of sleep 227 disturbance persisted even if triple doses of the vaccine were given, as well 228 as a 6-month adjuvant dose<sup>[8]</sup>. A study of the immune effect of influenza 229 vaccination in college students revealed that poor quality of sleep may be a 230 risk factor for reduced immunity to an influenza virus<sup>[13]</sup>. Appropriately 231 prolonged nighttime sleep after vaccination promotes host immune 232 responses<sup>[14,15]</sup>, and serum-specific antibody concentrations have been 233 found to be significantly lower in sleep-deprived men 5 days after 234 vaccination with the influenza A (HIN1) virus compared with those in a 235 group with a normal sleeping pattern<sup>[9]</sup>. Similarly, people who had a 236 regular sleeping pattern after Hepatitis A virus vaccination had higher 237 antibody titers after 4 weeks<sup>[10]</sup>. One study found that 10 days after 238 vaccination with a seasonal influenza virus, individuals who had 4 239 consecutive nights of sleep restricted to 4 h had IgG antibody titers less 240 than half that of individuals without this sleep deficit<sup>[16]</sup>. 241

The body has a "biological clock" to maintain the rhythm of sleep, 242 and SLaN can disrupt this rhythm and affect sleep quality. A recent study 243 showed that frequent SLaN greatly disrupted the ratio of immune cells, and 244 that this alteration contributed to a reduction in the function of immune 245 cells<sup>[18]</sup>. In the present study, SLaN was found to be an independent 246 influence on the serum level of IgG antibodies in pregnant women, with 247 those who SLaN habitually having a lower serum level of IgG antibodies. 248 In addition, the effect of poor sleep quality and SLaN on the serum level of 249 IgG antibodies was found mainly in women aged <35 years. This finding 250 may have been due to the fact that older pregnant women pay more 251 attention to the regularity of their work-and-rest schedule because their 252 body functions decline with age. Napping can reduce drowsiness and may 253 have some benefits for mood stability and cognitive function. An 254 association between napping and antibody levels has been documented, 255 but this finding did not hold after adjustment for confounding factors <sup>[5]</sup>, 256 which is similar to our findings. 257

We also identified significant differences between age, time since vaccination, and the serum level of IgG antibodies in pregnant women who received two doses of inactivated SARS-CoV-2 vaccine. Age was an important factor maybe to influencing the serum level of IgG antibodies, and that positivity to IgG antibodies was lower in older pregnant women. A phase-II clinical trial of the CoronaVac vaccine involving 600 healthy

adults (18-59 years) revealed that levels of neutralizing antibodies 264 decreased with increasing age<sup>[11]</sup>. Similarly, another study found that the 265 level of the immune response in pregnant women who received an mRNA 266 vaccine was correlated negatively with maternal age<sup>[12]</sup>. Antibody levels in 267 people decrease over time after completing vaccination. One study 268 revealed that antibody levels were correlated negatively with time, and 269 approached the threshold of seropositivity 6 months after receipt of two 270 doses of a vaccine <sup>[11]</sup>. 271

This was the first study to analyze the effect of sleep status on the 272 immune response of pregnant women after vaccination with inactivated 273 SARS-CoV-2 based on real-world data in three hospitals in China. 274 However, we declare some limitation in present study. This is a real-world 275 study, which cannot be designed as precisely as a clinical trial. Therefore, 276 data quality may vary widely. Future prospective cohorts with large 277 samples may be needed to further validate the relationship between sleep 278 and the effects of immunization using vaccines. 279

### Conclusions

Sleep quality and SLaN can affect the serum level of IgG antibodies
in pregnant women after vaccination with inactivated SARS-CoV-2.
