

1 ***Intersecting Vulnerabilities: Unraveling the Complex***
2 ***Relationship between Women, Climate Change, and Mental***
3 ***Health in Bangladeshi Communities***

1 Abstract

2
3 Climate change is one of the biggest challenges that humanity is facing in the 21st
4 century, and its impact is being felt all over the world. It is well documented that the impacts
5 of climate change have a significant effect on human health, including mental health. This
6 paper focuses on the gender effect of climate impacts on mental health based on qualitative
7 study conducted in two fragile communities in Bangladesh. This study was conducted using
8 qualitative methods, including participant observation, in-depth interviews, and focus group
9 discussions. The study was carried out in two fragile communities in Bangladesh, which were
10 selected based on their vulnerability to climate change impacts. The participants were selected
11 using snowball sampling. A total of 59 interviews and 3 Focus Group Discussions (FGDs)
12 were conducted. Climate change impacts have a significant effect on mental health in both
13 men and women. However, there are gender differences in the experience of climate change
14 impacts on mental health. Women are more vulnerable to climate change impacts on mental
15 health due to their gender roles and responsibilities. Responsible for taking care of their
16 families, they have to face additional challenges due to climate change impacts, such as
17 increased workload, water scarcity, and food insecurity, social insecurity as many of their
18 husband migrates to the cities for jobs. Women also face social and cultural barriers, which
19 exacerbates their vulnerability to climate change impacts on mental health. Men, on the other
20 hand, face challenges related to their livelihoods and economic security due to climate change
21 impacts. This study highlights the gender differences in the experience of climate change
22 impacts on mental health in two fragile communities in Bangladesh. Socioeconomic and
23 environmental determinants appear to be embedded and lead to psychological suffering in
24 relation to social roles and gender norms. Interventions should be designed to address the
25 specific needs and challenges faced by women in these communities. Policymakers should
26 take a gender-sensitive approach to address the mental health impacts of climate change in
27 these communities. This study contributes to the growing body of research on the gendered
28 impacts of climate change with a trajectory approach and provides insights for future research
29 in this area.

30 31 32 Introduction

33
34 Since the end of the 2000s, climate change (CC) effects on mental health are described
35 as a global emergency. Berry et al., described two main causal pathways between mental
36 health outcomes and climate impacts [1]. Direct consequences occur after acute events and
37 are described in terms of depression or psychological trauma [2]. Indirect consequences could
38 be caused by the changes in ecosystems through different determinants such as economy,
39 migration, or social structures [2]. For example, long-term changes such as chronic drought
40 increased the distress of the rural population [3]. Additionally, the cumulative effects of
41 multiple stressors associated with climate change can intensify existing mental health issues
42 or lead to the emergence of new ones. Such stressors may include food and water
43 insecurity[4–6], loss of livelihoods [7], displacement [8], and social networks [9]. Yet, a
44 knowledge gap remains to characterize the chronic effects of slow-onset events on mental
45 health issues [10]. Siegele defines the slow-onset events as phenomena with chronic changes
46 (increasing temperature, sea-level rise, salinization, ocean acidification, loss of biodiversity,
47 etc.) as opposed to acute events (storms, floods, acute drought, etc.) who are not permanent
48 and occurred in a short time frame [11]. As the slow-onsets and their chronic consequences
49 will keep rising, it is important to better understand the underlying mechanisms to provide

50 adequate actions. Moreover, the slow onset events are disproportionately affecting the
51 population living in the global South as they are more dependent on natural resources such as
52 water and crops. While women are considered at higher risk to suffer from post-traumatic
53 stress disorder after any natural disaster [12], how climate changes affect their mental health
54 remain underexplored in global South. Recent result show how climate change, and
55 specifically extreme weather events do affect the social structure. Women's vulnerabilities are
56 shaped by cultural and gender norms, as well as their lower socio-economic status in society,
57 which manifests itself in their domestic role, decision-making within the household, and it is
58 accentuated during climatic events [13] and in the context of a changing climate [14]. Indeed,
59 these events prompt men to leave their communities in search of income, while women are
60 trapped behind to shoulder caregiving responsibilities and additional duties [15]. But the
61 underlying mechanisms of action are not well-explained. Moreover, there is limited data
62 available from countries in the Global South, which are often the most vulnerable to the
63 impacts of climate change.

64 Bangladesh is one of the countries most exposed to climate events (cyclones, tidal surges,
65 floods, periods of drought) [16], and over the past decade, acute events have become
66 increasingly frequent and intense due to climate change [17]. Simultaneously, the nation faces
67 slow-onset events (acidification, increasing temperature, salinization, loss of biodiversity,
68 etc.) that have led to environmental disruptions [18,19]. More than 60% of the population
69 lives in rural areas and is significantly affected by slow-onset events [20]. The country is now
70 confronting a dual crisis with the emergence of a mental health crisis. Recent studies highlight
71 the substantial mental health burden in Bangladesh, with a 2019 average prevalence of mental
72 disorders in the population reaching 16.8% [21]. A 2020 study published showed that 20 % of
73 rural women were screened for a major depression disorder [22]. However, mental health
74 infrastructure is limited, and very few psychiatrists are available in the country, with an
75 estimated 260 psychiatrists for the 162 million people living in the area [23]. Moreover,
76 research in the mental health field is underfunded and women's mental health has been
77 identified as one of the scientific priorities [24].

78 Our objective is to understand how mental health's women are disproportionately affected by
79 climate change in the context of vulnerable communities in the global South.

82 **Methodology**

83
84

85 We conducted a qualitative research including participant observation, in-depth
86 interviews, and focus group discussions [25].

87 This study is nested within the Clim-HB project, a large public health research that focuses
88 on health system resilience and climate change [26]. Our research took place in two
89 vulnerable communities in Bangladesh, one in a rural area and the other in an urban area
90 chosen due to their vulnerability and exposure to climate change.

91 In the rural community, the local population relies on agriculture and aquaculture (fish and
92 shrimp culture) for their livelihoods. This community, located in the southwest region of the
93 country, is subject to both slow-onset and acute climatic events. Moreover, 20% of the
94 population experience a seasonal migration after the monsoon due to the lack of employment.
95 The second setting is a slum in the capital city. The investigation primarily focused on the

96 poorest households in the slum, who live in stilt houses built over a canal. This setting is
 97 particularly exposed to pollution and high temperatures. These field sites are part of a larger
 98 public health research project within the framework of the Clim HB project [26]. Both
 99 populations share a pattern of migration, as a large portion of the families encountered in the
 100 slum originated from coastal regions of Bangladesh and migrated for economic reasons, and
 101 sometimes environmental ones. Coastal regions are subject to significant environmental
 102 transformations as well as a scarcity of jobs, which is also related to the urbanization of the
 103 country [18,20].

104 The communities were selected using purposive sampling, and the participants were selected
 105 using snowball sampling. To reflect the seasonal variations that could influence mental health
 106 issues, data were collected during two period covering three months in total: in March and
 107 April during the hot season and in October 2022 after the monsoon. In each site,
 108 approximately fifteen households were followed throughout both data collection periods. We
 109 conducted interviews with various household members to triangulate the data, which helped
 110 improve the reliability and quality of the information gathered. This method proved to be
 111 essential in establishing the research relationship, allowing us to reconstruct social trajectories
 112 and assess the impact of specific environmental events on women's mental health. Table 1
 113 shows that the study comprised a total of 55 interviews and 6 focus group discussion (FGD).
 114 Only relevant data for the research question were retained for the analysis.

117 The majority of the interviews were conducted in Bengali with the presence of a Bengali-
118 English translator. During the second fieldwork, the researchers returned to the same
119 individuals to conduct a follow-up and refine the data obtained from the first fieldwork. In
120 each site, around fifteen families were interviewed. When possible, researchers conducted
121 interviews with different household members, to triangulate and gain a comprehensive
122 understanding of the family's situation.

123 A thematic analysis was then performed based on the social determinants framework from
124 WHO and Lund et al. [27,28]. To understand how power relations among gender are
125 constituted in a changing climate, it was combined to specific dimension (access to resources /
126 division of labour within and beyond the household) from the gender framework [29].
127 The authors had access to non-anonymized individual participant data, but it is important to
128 note that the data presented in this study have undergone a rigorous anonymization process
129 and have been maintained with strict confidentiality.

130

131 **Ethics declarations**

132

133 All participants provided signed consent to participate. Written consent was obtained from
134 both the parents and the individuals themselves for participants under the age of 18, ensuring
135 that both parties were informed and gave their consent to take part of this study. The study
136 protocol was reviewed and approved by the ethics committee from the Institutional Review
137 Board (IRB) of the BRAC James P Grant School of Public Health, BRAC University (ref:
138 IRB □ 19 November'20–050) in Bangladesh.

141 **Results**

142

143

144 Two main pathways of mental health outcomes impacted by climate change through
145 gender have been identified in these vulnerable communities. These pathways are
146 interconnected, depending on the social and environmental situation, and they often manifest
147 as cumulative effects that shape women's trajectories.

148

149

150 **The socioeconomic stressor as an intermediate factor**

151

152 This first pathway contributes to exacerbating pre-existing gender inequalities arising from
153 economic determinants. It leads to anxiety and depressive-like disorders by amplifying
154 individual vulnerabilities through the impact on livelihood.

155

156 **Impacts on mother responsibilities**

157

158 Climate change directly impacts the livelihoods of the most vulnerable populations.
159 Due to drought, peoples from rural setting are experiencing a decline in agricultural

160 production and shrimp yield. The immediate effect on market prices leads to food insecurity
161 that challenge mothers' responsibilities. It results in increased anxiety for them and potential
162 adverse effects on the physical health of their children. This affects all families in the studied
163 village, including those with a higher socio-economic status.

164

165 *I: There are some problems. Suppose we can now buy 1.5 kg when we could buy 2kg*
166 *in the past. It has become like this due to the price hike.*

167 *R: Any problems to feed for the children?*

168 *I: Even if we are starving, we have to feed them. We have to meet their need. (mother*
169 *1)*

170

171 This suffering is amplified in households that are already in economic difficulty with debt.

172

173 *I: You explained this year it did not rain much and it rained heavily for only 2 or 3*
174 *days. Do you think you have faced any problems with the lack of rainfall?*

175

176 *R: We have faced some problems with the lack of rainfall such as we had to irrigate*
177 *our land manually, and we have faced problems regarding jute retting. (...) We also*
178 *had problems with the money lender. So, we had to take money from our relatives as*
179 *well. It was very stressful (mother 2)*

180

181 Those that are in-debt experience the situation as one of the most difficult in their lives.
182 The situation seems worse for them due to a reduced ability to implement coping strategies.
183 Indeed, the mother 1, whose husband belongs to a higher social class and has attempted to
184 engage in local politics, holds significant social and symbolic capital in the village. The
185 family has better economic resources and greater diversification. They own a pond with fish,
186 a small vegetable garden, and a chicken coop. In the opposite, mother 2 and her husband have
187 a small land and a little grocery store that experienced the COVID crisis, and they both come
188 from impoverished families. Furthermore, mother 2 has two young children, one of whom she
189 is breastfeeding. When asked about her sleep quality, she expresses difficulties related to her
190 child's crying, who is not adequately nourished.

191

192 *I: The child annoys me a lot. I can't breastfeed her properly (...)*

193 *R: No, I could not sleep previously because of the financial crisis and now I cannot*
194 *sleep properly because my child cries at night.*

195 *I: Do you wake up a lot during the night?*

196 *R: He wakes up 2 or 3 times at night.(...) He does not like to eat rice. He always asks*
197 *for good food like fish, and eggs. (mother 3)*

198

199 Thus, the effects of climate change tend to follow the socio-economic gradient and the
200 preexistent social inequities. For mother 2, who belongs to a lower class and is heavily in
201 debt, food insecurity leads to disruptions in breastfeeding and undermines her mental health
202 as a caregiver. On the other hand, for mother 1, the psychological distress is less severe due to
203 her financial capacity to cope with the situation. Due to hampering in the breastfeeding leads
204 the nutrients lacking in her child also. The impacts are continuing in the cyclic pattern.

205

206 In each instance, these situations were described by the women who bear the responsibility of
207 caring for and feeding the children, while the interviewed men explained their strategies for
208 obtaining income without ever mentioning the mothers' and children's circumstances. This
209 indicates the overlooking tendencies of the women's burden also be discussable.

Similarly, their economic dependence on their husbands sometimes prevents them from leaving their marriage when they consider them unfit to fulfill their roles.

R: But after marriage, my husband once left his job and started pulling a rickshaw. He used to pull the rickshaw one day and sit at home for three days without earning any money. At that time, I got a feeling of leaving this family and staying separate from my husband. But I couldn't do that because of my children. I was worried for them. (mother3)

Income-generating activities in rural areas are not very popular. Due to their limited social capital and reduced agency, women often cannot leave their husbands to seek economic security for their children unless they can receive support from other family members, such as their own parents.

Coping strategies on the household rely on the daughters' & mothers' sacrifices

Coping strategies for the economic situations are dependent on social roles within families and based on a division of labor. Both are exacerbated in a changing climate. Mothers, who are often housewives to raise and educate the children, bear the responsibility of caregiving and thus have fewer options for economic survival strategies. This specifically impacts their mental health.

One of the economic survival strategies presented by a mother from the slum involved not bringing all her children with her. She took the youngest child who was breastfeeding and needed her, while she left her eldest daughter with her mother-in-law. She tries to visit her daughter every three months but describes this situation as very painful for her.

I: How is your sleep now? Are you tensed about something?

R: I am bound to be tensed about my son or my daughter. I can't do any work.

I: If you could tell us what are your thought about your children?

R: The mother has to suffer the pain of the son. Will anyone else suffer?

I: Can you sleep properly or you wake up from the sleep early?

R: I do wake up suddenly. I think what I did to deserve this. (mother 4)

She didn't want to move to the slum but had to as her husband has job there. They are both from the coastal area where it became hard to survive. Economic migration was thought as a survival strategy decided by the husband.

Furthermore, this economic migration desired by her husband isolates her. Being far from her mother and sister, makes it even more difficult for her to cope with the situation. Besides, her inability to work as she has to take care of her son reinforce her feeling of isolation.

R: I have to think about the rent, food and everything. But in village, i can share everything with my mother and my sister, which is very much better than this. (mother 4)

259 Additionally, she explains that she had to accept being married to financially relieve her
260 parents and could not pursue her studies.

261

262 *R: I have five siblings and I am the eldest among the sisters. I studied till class 6 and*
263 *then my parents married me off to reduce the burden (...). (mother 4)*

264

265 Economic strategies for these poor rural families are mainly decided by men so they can
266 provide for their families, even though this becomes increasingly complicated during times of
267 economic and environmental crisis.

268

269 In some cases, environmental events shape the economic strategies of the families.

270

271 Another respondent explained, that after an environmental event, her father decided to
272 married her.

273

274 *R: When I was a child, I observed a lot of cyclones and storms.*

275

276 *I: Did your house suffer damage during those cyclones?*
277 *R: We had 2 houses, one of the fell apart because of the Cyclone. It happened before*
278 *the river erosion. And we lost everything including houses in the river erosion.*

279

280 *I: When did this river erosion happen?*
281 *R: It happened around the mid-2000's. Before my marriage.*

282

283 *I: Did you got married for this reason or there were other problems in your family?*
284 *R: Before the river erosion, my family had the land and we were financially strong but*
285 *after the incident we got poor. And since we were so many siblings my father took the*
286 *decision about my marriage.*

287

288 *I: What type of land were those?*

289

290 *R: They were agricultural land and we used to grow rice and other crops on them.*

291

292 *I: Can you tell me the size of those lands?*

293

294 *R: It was a good amount of land. The whole area was gone by river erosion. (mother*
295 *5)*

296

297 In this case, the environmental event leads to a descendant social mobility of the family. Now
298 living in the slum, this mother face economic constrained that generate anxiety. She is
299 concerned about her children education and a broader vision of their future.

300

301 *R: It will be much more reliable for us to survive if my husband gets a new job. We*
302 *pay 4,000 takas as rent for one room and, my husband and my children live with me in*
303 *that one room.*

304

305 *I: Can you tell me about your food expenses?*

306

307 *R: Every month it costs about 10,000 to 12,000 taka for our food and children's*
308 *education combined. The house rent is separate. (...)*

309

310 *R: I'm having some stress about the future of my children and, also since my husband*
311 *has no job, I'm concerned about how we will finance the upcoming days. I'm having*
312 *headaches because of this stress. (mother 5)*

313

314

315 **Gender violence**

316

317

308 Although these situations have been documented outside the context of climate crises
309 [30], they appear to be more intense and recurrent when crises affect the household's
310 livelihood and reduce the opportunities for men to generate sufficient income to meet the
311 family's needs.

312
313 For example, the previous woman who was married after a river erosion and came in the slum
314 faced domestic violence because of the unemployed situation of her husband and his
315 addiction.

316
317 *R: I feel stressed now, but the reason is different. My husband has no work and he is*
318 *addicted, because of that we have conflicts in the house and also many other domestic*
319 *problems, that's why I have stress and tension all the time. (...) As he used to spend the*
320 *money on drugs and I tried to convince him, for that reason he used to beat me. (mother 5)*
321

322 Like other respondents, she is particularly isolated, which increases her stress. Her mother-in-
323 law is her close neighbor, support her son, and would report to him any of her complaints.
324 This exacerbates the situation and further contributes to the respondent's stress and feelings of
325 isolation.

326
327 *R: I'm trying to convince my mother-in-law as well, but every time they say that he will*
328 *quit his addiction soon but it's not happening and these types of conversations are*
329 *making conflicts between my husband and his mother and also me. because I'm*
330 *informing my mother-in-law about my husband's addiction and somehow, he is also*
331 *getting to know that I informed his mother. That's why there are conflicts between us*
332 *also. (mother 5)*
333

334
335 Several women explained to us that when they discuss household money management with
336 their husbands, particularly in situations of debt, the husbands reprimand them and may
337 physically abuse them.

338
339 *R: I used to have arguments with him, regarding the bazaar he used to take money*
340 *from people, and if I ask questions about it then he was beating me.*

341 *I: He is an alcoholic?*

342 *R: No. He used to gossip with his friends and spent money, this is his habit, but our*
343 *house condition is not good. That's the reason*

344 *I: When you used to say something that time he used to beat?*

345 *R: I said that, we have children, and they can't live without eating, he didn't do the*
346 *bazaar properly.*

347 *I: He used to take loans?*

348 *R: Yes.*

349 *I: He used to take loans from people but he didn't go to work, if I ask anything then he*
350 *used to beat me. (mother 6)*
351

352 In the rural area, a family facing over-indebtedness also experienced the negative effects of
353 climate change on their mental health. The woman explained that their financial situation was
354 already poor before, but it worsened this year due to a lack of rain. The combination of
355 financial stress and the impacts of climate change can create a challenging situation for
356 families, particularly for women, mothers, and widows who bear the responsibility of
357 caregiving.

R: We also had problems with the money lender. So, we had to take money from our relatives as well. It was very stressful.
I: Do you sleep well at night?
R: No, I could not sleep previously because of the financial crisis and now I cannot sleep properly because my child cries at night. (...)
I: How is your relationship with your husband?
R: The relationship is good but we get into fights for financial matters. People come over to ask for money and get into fights over it.
I: Does he physically abuse you along with verbal abuse?
R: He hits me at times.
Hasan: When was the last time he hit you?
R: It starts with an argument. I try to stay patient. People tend to pass judgment as I live in my father's house. People will talk, that is why I need to remain patient.
(mother 7)

This inescapable situation, which is often the result of norms and social pressures placed on women regarding the importance of religious marriage, can significantly impact their mental health and well-being. Women may feel trapped in their circumstances, unable to leave their marriages or seek help due to the expectations and obligations associated with their roles as wives, mothers, and caregivers.

R: Because my elder brother is very angry, if he listened to that, my husband is shouting at me or if he is misbehaving with me, then he will beat him. That's why I don't.
I: He doesn't know that he used to beat you?
R: Yes, he knows, he tried to get him arrested several times.
I: Okay.
R: But he couldn't do it because of me. I said how many times people get married, once so let it be, let me stay with one person. (mother 7)

Lack of coping strategy

The isolation experienced by many mothers and young girls is reinforced by the social norms that disregard discussions about psychological issues. This is a mechanism that is both self-controlled and encouraged by men due to the significance of reputation within these communities. Reputation is not only important for marrying off their children but also for matters of social dignity.

R: I always think if I'm able to do this then, it will be better but I don't have money, so how I'll do it? My children wanted to live in a good place and to have good food, but I am unable to do anything. No one will help me, I didn't share with anyone, my son asked me not to share because people will judge us, I am sharing with you guys as you're listening otherwise, I don't share with anyone, my son is different, he doesn't share his sadness with anyone. He has grown up. So, he doesn't like this. (mother 8)

Climate events as a triggering factor

410

The second mechanism highlighted by our data concerns the triggering effect of climate events, that affects young girls and mothers.

412

413

We had already encountered this issue with environmental event during our fieldwork in April 2022 following the COVID-19 pandemic. Some women had mentioned having suicidal thoughts during that period due to their perceived failure in fulfilling their caregiving responsibilities for their children.

416

417

418

R: During the covid situation, I and my two children were staying with my husband.

419

Whenever our children asked for food, we were not able to provide them with food.

420

That time I had a feeling of committing suicide.

421

I: Have you ever tried to commit suicide?

422

R: Yes, I tried to commit suicide once in the middle of the Corona situation. But with the poison bottle in my hand, I couldn't commit suicide anymore when I thought about my children because I was worried about who'll look after my children after I will be gone. (mother 9)

427

428 **Hot weather and children behavior**

429

430

431

During our first field in the hot season, indoor temperatures in the tin houses of the slum were very high and significantly higher than outdoor temperatures. Several women reported children's sleep problems resulting into behavioral issues during the day. They explained that they could not control their children's behavior, which led them into a negative spiral of increasing anxiety and stress, due to sleep deprivation, compounded by the children's difficult-to-regulate behavior.

439 **Environmental & specific setting**

440

441

442

The specificities of climate events are important to consider for the policy maker and in order to help the most vulnerable people. Usually the main characteristics retained are the duration, frequency, intensity of an event, geographical location such as coastal areas [31].

445

446

During our study, the cyclone Sitrang occurred and was considered by local authorities as having caused much damage due to its low intensity. However, the topography of the part of the slum involved in our study, whose houses are located on a canal, were highly affected. For the respondent, this cyclone that occurred in October 2022 was much more difficult than one of the last cyclones recognized as having caused the most damage in Bangladesh (Amphan in 2020), even if she was at this time living in the coastal area. Indeed, here she did not receive any assistance or rescue and was trapped in her room, although she took refuges during Amphan.

454

455

R: I think this cyclone was more dangerous. I stayed here the whole night. Yes, it was more dangerous for me (...) there we suffered from damage, one of our big trees was

456

457 *fallen into our house, our house was broken because of that, later we were unable to*
458 *fix it, the government helped us, and send some dry food. (mother 10)*

459
460 The inability to access shelters for these impoverished families has made them more
461 vulnerable, even though they have migrated from coastal areas that have been hit by multiple
462 cyclones, but where a refuge had been accessible.

463
464

465 **Housing vulnerability in the face of climate events**

466
467

468 This importance of housing was highlighted during the Cyclone Sitrang which
469 occurred in October 2022 and caused significant damage to families living in the slum.
470 Some of our respondents described the alarming situation for living in the tin houses located
471 on the part of the slum built on stilts above a canal. During the cyclone, the rainwater arrived
472 both from clouds and canal, whose water level began to rise suddenly in the evening.
473 While the majority of family took refuge in a public building, this one found trapped in her
474 room.

475

476 *R: During the cyclone, our house got flooded. The water level was very high because*
477 *our house was one of the low-level houses in this area. We lost many small household*
478 *things such as dishes and other belongings during that flood. The water level rose and*
479 *flooded our house at 11 pm night. The rain started early in the morning. We were*
480 *sleeping in the house when the water got into our house. We didn't expect that the*
481 *water level would rise that much because previously when it rained very little amount*
482 *of water used got into our house but that night the water level was very high. (mother*
483 *11).*

484

485 The situation was catastrophic as the family faced the prospect of death. While the mother
486 recounts the extreme tension, her children were traumatized, and her daughter remains in
487 shock several days after the event.

488

489 *R: When we were standing in bed, I was very tense. We were afraid that if the rain*
490 *continued, the water will increase, and we will be stuck here and die. One person*
491 *came during that time and he was asking if someone was stuck here in these houses.*
492 *We shouted yes and said that we were there. But I don't know whether he listened to us*
493 *or not because he didn't respond. Also, there were so many mosquitoes biting us*
494 *continuously, so we also asked that guy if he could bring us a mosquito coil. But he*
495 *didn't respond. And no one came to rescue us later on.*

496

497 *I: How were the babies doing during that time?*
498 *R: We removed the sewing machine from the table and placed the table on the bed.*
499 *Then we kept our children on top of that table. They sat there the whole night. My*
500 *daughter cried the whole night because she was very afraid of seeing the water. She is*
501 *still sick. My son also got sick and was afraid, so I took him to maulana (the religious*
502 *leader of the community), and now he's feeling good. But my daughter is still afraid*
503 *and sick. (mother 11)*

504

505 Housing is one of the most important factors in resilience or vulnerability to climate events
506 (heat waves, floods or cyclones). In both rural and urban sites, the houses that were less
exposed to flooding and more resilient to extreme weather conditions offered greater security

507 and protected mental health outcomes. Here too, gender plays a significant role in the
508 inheritance that is passed down to children, reflecting an inequality in the distribution of
509 material resources. The previous respondent, who is abused by her husband, lives in a tin
510 house, while her brother, who wants to help her, resides in their parents' hard-building house.
511 She is thus doubly vulnerable as she does not live in durable housing and she does not move
512 because her husband is not a decent enough person for him to live with his family.

513

514 *I: Why don't you stay there?*

515 *R: I don't stay there as my husband is not good. Maybe he can say a bad word, they*
516 *can hear that. It's not good to stay with the relative (mother 11)*

517

518

519 **A single mother with mental health preconditions**

520

521

522 One of the most pronounced vulnerabilities to climate events is being a single mother
523 raising her children. One of our respondents describes the alarming situation she experienced
524 when she was caught off guard by the rising waters. Her tin-roofed room is located on a part
525 of the slum built on stilts above a canal. The rainwater arrived both from the clouds and from
526 the canal, whose water level began to rise suddenly in the evening.

527

528 *R: Everyone went there in the shelter, in our area, there was so much water, only me,*
529 *my sister and my child were here, my sister told me that: "no one is here, do you want*
530 *to die?". Then somehow, I catch her and I started swimming, it was not the condition*
531 *of walking. I started swimming, carrying my child on my shoulder, then my sister even*
532 *got fallen due to the water pressure. So, I came back to this room. (mother 12)*

533

534 She didn't go in a shelter as others because she perceived it a risk as a single mother without
535 no other social support. Her brother also stayed in a tin house during the event.

536

537 *R: We were only sitting on the bed, but we were unable to sleep.*

538 *I: Only you and your son?*

539 *R: Yes. Many people went from here, but I didn't go as I don't have any place to go,*
540 *where I'll go.*

541 *I: During the night water level was increased, you did not do anything?*

542 *R: Where I will go along with a child, so I didn't go outside, I stayed here. I didn't feel*
543 *good to go any other place with my children, and it was hard for me to go anywhere to*
544 *take the shelter as a single mother, so that is why I didn't take the risk, I stay here on*
545 *the bed only. (mother 12)*

546

547 She was also afraid by the current situation of water in the road and her inability to protect her
548 son from the water.

549 *I: As everyone leaves here, no one asks you to go with them?*

550 *R: Yes, everyone was telling me to go from here, I said no, I'll not go, I had the*
551 *courage, and I said that, if my death is written here then I'll die here along with my*
552 *son, I'll not go anywhere.*

553 *I: Why you did not go anywhere?*

554 *R: I didn't go, because I didn't feel good, I had the courage in my mind that nothing*
555 *will happen, if my death is written here then I'll die here, if I go there, I can also die*
556 *there. I had the courage in my mind. (mother 12)*

Finally, she left her son with her uncle who stayed as the responsible person of the tong houses. Because her son was crying too much in her arms, as she was too stressed by the situation. Consequently, she stayed alone in the room, feeling very anxious, as she constantly thought about her son and found solers in her prayers.

R: I am million times thankful to Almighty Allah. Later on, the next day, the water level decreased and the rain almost stopped. So, as it was not raining, so I was less tensed. (...) I was so afraid when the water level was increasing, and I was thinking maybe it's going to be the end, but I performed special prayers, and I prayed to Almighty Allah, to save us and also, I was also remembering my Almighty Allah's name again and again, and then I saw in the morning the water level was decreasing. Around 3-4 AM it started less raining, at that time I was like the water level will not increase, and at that time I was having less stress. (mother 12)

Her initial decision to stay alone in the tin house with her son, awaiting death, is linked to her pre-existing mental condition. This woman has experienced several depressive episodes, including one a few months before the cyclone, which left her bedridden for a month, preventing her from working and taking care of her son, who stayed with his uncle. Her psychological difficulties began during childhood, without her recalling the reason, and then following her marriage and upon discovering that she was her husband's second wife. A few years later, her parents passed away, and her husband died accidentally, causing her pain from the memories of these lost loved ones and in relation to her own condition.

*R: Sometimes I think about my parents, so I feel restless, that time it feels like I'm not able to take a breath, it feels like I'm not breathing, once I got senseless, I was very sick, my sister got to know about it, and she came and she took me to the hospital
I: apart from your parent's incident, is there anything else that makes you feel restless?*

R: About my husband, the death of my husband, I think about it a lot, as we stayed together, now he is no more, I can also die, first my parents died, I was living with my parents, they died, then I was living with my husband, but he also died, I can also die. (...) Nowadays I am always thinking about my after-death situation. (mother 12)

Isolated woman

Another woman, widow who work as maid and live in the tin house explained how she was surprised how the water level raised suddenly and how stressed she was by the situation.

R: Yes, I was afraid, suddenly waterlogged inside the house and also inside the road, there was no one here, only 3-4 people were here whose stuff was here, I wasn't able to organize anything. (mother 13)

The respondent was very tensed with exacerbated symptoms due to rumors in the slum about the occurrence of a new cyclone following Sitrang.

I: Still, you're afraid because of this?

R: Yes, people are saying that another cyclone is coming

607 *I: So, you are feeling afraid?*

608 *R: Yes, I'm feeling afraid. I'm not going to work for 3-4 days. I can't sleep, my body*
609 *got wet, everything got wet. I got scared of seeing the water level, this is a problem!*
610 *(mother 13)*

611

612 Another respondent also exhibits symptoms of anxiety and has difficulty sleeping at night due
613 to the fear of new cyclones. This fear and anticipation of potential disasters can exacerbate
614 mental health issues, making it difficult for individuals to focus on their daily tasks and
615 responsibilities.

616

617 *R: Sometimes at midnight, like in the night-time, I feel scared, like maybe suddenly it*
618 *can come, because I'm staying in the tong house because nowadays people are saying*
619 *a new one is coming, so that's why I'm afraid if it happened again then what I'll do.*
620 *(mother 14).*

621

622

623 **Pathways of cumulative effects on mental health: a case study**

624

625

626 The following case is that of a woman who represents a typical example of the
627 cumulative effects of environmental, economic, and negative feedback loops when climate
628 events occur on the mental health. The negative feedback loop typically intertwines with
629 economic strategies related to the household size, such as migration and early marriage, or in
630 some cases, deciding which children will migrate to the city or stay in the village, and
631 eventually planning to return home.

632

633

634 **Trajectory of a woman from the coastal area and feeling trapped in the slum**

635

636 This woman was born in a coastal area of Bangladesh, exposed to risks associated with
637 climate events such as cyclones, river erosion, and slow-onset events. She belonged to a
638 family of farmers who owned multiple lands for rice crops and vegetables and had two
639 houses. During her childhood, she witnessed numerous cyclones and storms. In the early
640 2000s, a cyclone destroyed one of her family's houses, but no one was injured. She
641 occasionally suffered from nightmares involving storms destroying everything, especially
642 when her area was flooded and waterlogged. Since the road was reconstructed and reduced
643 waterlogging, she no longer suffers from nightmares.

644

645 In the mid-2000s, her family fell into poverty after river erosion destroyed their lands and
646 houses. With six children, her father decided, for economic reasons, to marry his two older
647 daughters to men from the capital, hoping for better living conditions. Her older sister moved
648 to Dhaka and married a man from the slum through her uncle's intervention. Later, her sister
649 brought her to Dhaka and married her to her husband.

650

651 After her marriage, she discovered that her husband was addicted to marijuana and alcohol,
652 spending significant amounts of money on drugs. Her husband worked as a rickshaw driver,
653 earning about 500-600 takas every day. However, he sold his rickshaw six days before our
654 visit. The couple has many expenses, including education fees for their two children in
655 primary school (300 takas every month). They live in a semi-built house in the slum near the

656 lake, paying an expensive rent of around 4,000 takas for one room. Food expenses for the
657 whole family amount to around 10-12,000 takas.

658
659 Her husband's drug addiction created conflicts within their marriage, and he often physically
660 abused her. Her mother-in-law, aware of the situation, protected her son, leaving the woman
661 feeling isolated. The Cyclone Sitrang exacerbated her stress, and she expressed "feeling very
662 stressed with tension all the time" about her children's future.

663
664 This case shows how the woman's trajectory has been influenced by climate events, her
665 family's economic problems, and the decisions made to cope with these challenges, such as
666 migration and early marriages. Moreover, it highlights how persistent issues, such as poverty,
667 addiction, and family conflicts, can worsen a woman's mental health situation, especially
668 when she feels trapped and isolated. This case also demonstrates that women are often the
669 most affected by the consequences of climate events and economic decisions made within
670 their households.

671
672
673 Other respondents mentioned after the cyclone Sitrang their sadness about leaving a child in
674 the village as a survival strategy in order to move to the city, only to realize they had fallen
675 into a dead-end trap. These climatic events reawaken past pains and impact mental health by
676 highlighting how their strategies have ultimately turned against them.

677
678 The lack of opportunity impacts all members of these communities, but it appears to be
679 especially pronounced among women who shoulder caregiving responsibility, have limited
680 access to education, and occupy the lowest positions within family hierarchies. Both acute and
681 slow-onset events distinctly affect the mental health of women, mothers, and widows, as it is
682 influenced by the interplay of socioeconomic factors, social networks, and environmental
683 conditions. These intersecting factors intensify the vulnerabilities these women experience,
684 making it even more difficult for them to cope with the consequences of climate-related
685 events.

686
687

688 Discussion

689
690

691 Our study presents original findings on how women are disproportionately affected
692 through two main mechanisms: socioeconomic stressors and acute environmental event.
693 socioeconomic stressors, particularly during slow-onset environmental transformations,
694 highlight the intersection between economic and environmental dimensions. Acute events
695 directly cause psychological distress. In both cases, gender-related social status and roles
696 shape individual trajectories. We specifically highlight that in these communities, economic
697 survival strategies are based on the involvement of women in serving the household, which
698 makes women's health even more vulnerable during climate and environmental events. This
699 exacerbates gender inequities and jeopardizes their mental health. Furthermore, our study
700 allows for an analysis of cumulative environmental, economic, and social events by
701 examining individual trajectories, opening up new perspectives for mental health research in
702 the Global South. This approach allows us to identify both the structural sociocultural factors
703 and the individual psychological factors that shape a person's mental health trajectory.

704

705 The specificities of climate events are important to consider for the policy maker and in order
706 to help the most vulnerable people. Usually the main characteristics retained are the duration,
707 frequency, intensity of an event, geographical location such as coastal areas [31]. Our results
708 showed the difference in perception and experiences lived by the most vulnerable for an event
709 considered as of small-scale by the general authorities. While not of importance for the
710 general population, it greatly affected both the living and economic conditions of a vulnerable
711 community and their mental health. It is crucial for decision-makers to anticipate the impacts
712 based on the topographic vulnerabilities of the sites and the individuals, in order to promote
713 the establishment of shelters and the provision of material aid, even during less intense events
714 such as Cyclone Sitrang. This situation is encountered by both men and women; however, it
715 adds to gender-specific vulnerabilities [32] and should be taken into account to grasp the
716 cumulative impact of vulnerabilities on individuals' life trajectories.

717
718 Understanding the gender-specific vulnerabilities related to climate events is important to
719 address the cumulative impact of vulnerabilities on individuals' life trajectories. Mental health
720 outcomes linked to SDGs will be difficult to achieve for women if the climate issue is not
721 taken into account as it disproportionately affects women by reinforcing their vulnerabilities
722 linked to social structures and producing new gender inequities.

723 More specific studies should be made in the global souths because the indirect impacts of
724 climate change on mental health are mostly uncovered as it happened mostly in the rural
725 setting. Yet, these countries are the more vulnerable to climate events even if they are from
726 far less responsible of the changing climate [33].

727
728 Our results highlight the importance for future research to consider psychological trajectories
729 while taking into account health determinants, social factors, as well as environmental factors.
730 This approach aims to better understand the mechanisms that affect populations and those
731 shaping their resilience when they face several challenges. Our analysis confirms some other
732 researcher based in Nigeria during floods in 2011. They found that this event impacted the
733 childcare of women's activities leading to increased anxiety about the health and safety of
734 their children [34]. We also find in accordance with the literature various determinants that
735 affect the link between mental health and climate change among women. Notably, one of the
736 key factors is the socioeconomic status of women [35], which can exacerbate their
737 vulnerability to the mental health impacts of climate change. Other determinants include
738 gender roles and expectations, gendered violence [36], limited access to resources [37] and
739 services after natural disaster [38], education, and the disproportionate burden of caregiving
740 responsibilities [36]. These factors can contribute to increased stress, anxiety, psychological
741 trauma and depression among women when faced with the challenges posed by climate
742 change [12]. We demonstrate how the combination of factors such as socioeconomic status,
743 gender roles, limited resources, and caregiving responsibilities can create a complex web of
744 vulnerabilities that disproportionately affect women's mental health in the face of climate
745 change. By examining these interconnected factors in detail, we provide a more
746 comprehensive understanding of the gendered impacts of climate change on mental health in
747 vulnerable communities, thereby offering valuable insights for future research and policy
748 interventions. Further research employing a trajectory-based approach is needed to better
749 understand the interplay of factors and their contributions to the impacts of climate change on
750 women's mental health in vulnerable communities.

751
752 Our study has limits. Our interviews were conducted in Bengali and transcribed so we might
753 have lost a part of the information. However, the analysis was performed with the translator to
754 overcome this risk. Our data were collected on a two-period basis, while this topic is a

755 sensitive one and might need iterative interviews to build a greater trust from the respondents.
756 We tried to overcome this limit by triangulating within the same household and meeting
757 multiple time with our respondents to build a trusting relationship.
758 We were perceived as foreigners and outsiders which might have had an impact on the quality
759 of data. In both setting we have been associated to their survival economical strategies and the
760 interviews could have been biased to meet the respondent needs. The tools from the reflexive
761 ethnography have help us to analyze our position in each situation and how it has shaped the
762 data.

763
764

765 **Conclusion**

766
767

768 It is crucial to consider the specific mental health impacts of climate change on
769 vulnerable groups, such as women, mothers, and widows, particularly in rural areas where
770 resources and support may be limited. Providing access to mental health care, financial
771 assistance, and climate-resilient livelihoods can help alleviate the strain on these individuals
772 and improve their overall well-being.

773 Addressing the specific needs and vulnerabilities of women in the context of climate change
774 requires a multi-faceted approach that includes promoting gender equality, empowering
775 women to make informed decisions about their lives, and providing access to resources and
776 support networks that can help them build resilience and cope with the challenges they face.
777 Additionally, it is crucial to engage communities and stakeholders in the process of
778 challenging and changing harmful gender norms and expectations that contribute to the
779 vulnerability of women in the face of climate change.
