Immunogenicity of a Two Dose Regimen of Moderna mRNA Beta/Omicron BA.1 Bivalent Variant Vaccine Boost in a Randomized Clinical Trial

Abstract

In this brief report, we compare the magnitude and durability of the serologic response of one versus two doses (separated by 56 days) of a variant vaccine (Moderna mRNA-1273 Beta/Omicron BA.1 bivalent vaccine) in adults.

Introduction

A single boost with currently authorized bivalent prototype/Omicron BA.4/5 vaccines leads to a serological advantage compared to ancestral vaccine boosting against Omicron subvariants.¹ Although additional doses of variant boosters are recommended for individuals at risk for severe disease², it is unclear whether two doses of variant vaccines further boosts humoral immunity to SARS-CoV-2 variants.

Methods

Adult participants were randomized 1:1 to receive one or two doses (separated by 56 days) of Moderna mRNA-1273 Beta/Omicron BA.1 bivalent vaccine (50 mcg) ≥ 16 weeks from last monovalent prototype vaccination. Beta/Omicron BA.1 was chosen to cover an antigenic space distant to D614G from which new variants may emerge. We assessed pseudovirus neutralization titers³ at 14, 28, 90 and 180 days after the last vaccination against D614G, Omicron BA.1, Omicron BA.4/5, B.1.351 and B.1.617.2. Participants were removed from analysis following self-reported infection, N-antibody positivity or receipt of an out-of-study booster.

Results

One hundred participants were enrolled in the one-dose and 102 in the two-dose arms. In previously uninfected participants, Day 29 ID₅₀ GMTs in the one-dose arm against D614G, BA.1, BA.4/5, B.1.351 and B.1.617.2 were 12,609, 2,824, 1,219, 7,075 and 7,024, respectively (Figure 1, Tables S1/S2). Corresponding ID₅₀ GMTs in the two-dose arm, 28 days after last dose, were 12,464, 2,891, 1,391, 7,507 and 7,708, respectively. To compare the degree of antibody waning, the Geometric Mean Fold Drop (GMFD) from Day 29 to 180 days after final boosting were calculated; for the one-dose/two-dose arms GMFD were 4.3/3.0 for D614G, 4.8/4.3 for BA.1, 4.6/3.3 for BA.4/5, 5.5/4.0 for B.1.351 and 4.5/3.5 for B.1.617. At enrollment, 18% and 21% of the one and two-dose arms, respectively, had a prior SARS-CoV-2 infection by self-report or N-antibody testing (Table S7). Titers were higher in these previously infected participants at all timepoints with similar findings following one or two doses (Tables S3 and S4).

Discussion

A two-dose boosting regimen with a variant vaccine, albeit given 2 months apart, did not increase serological responses compared to a single variant vaccine boost, contrary to what has been observed after AS03-adjuvanted H5N1 influenza virus immunization.⁴ However, durability

of the responses appears to be slightly improved with two doses. It is possible that a boost with more contemporary variant vaccines, or two doses given with a longer interval, could lead to different results. This study is the first in humans to show serological responses after a two-dose boost with a SARS-CoV-2 variant vaccine.

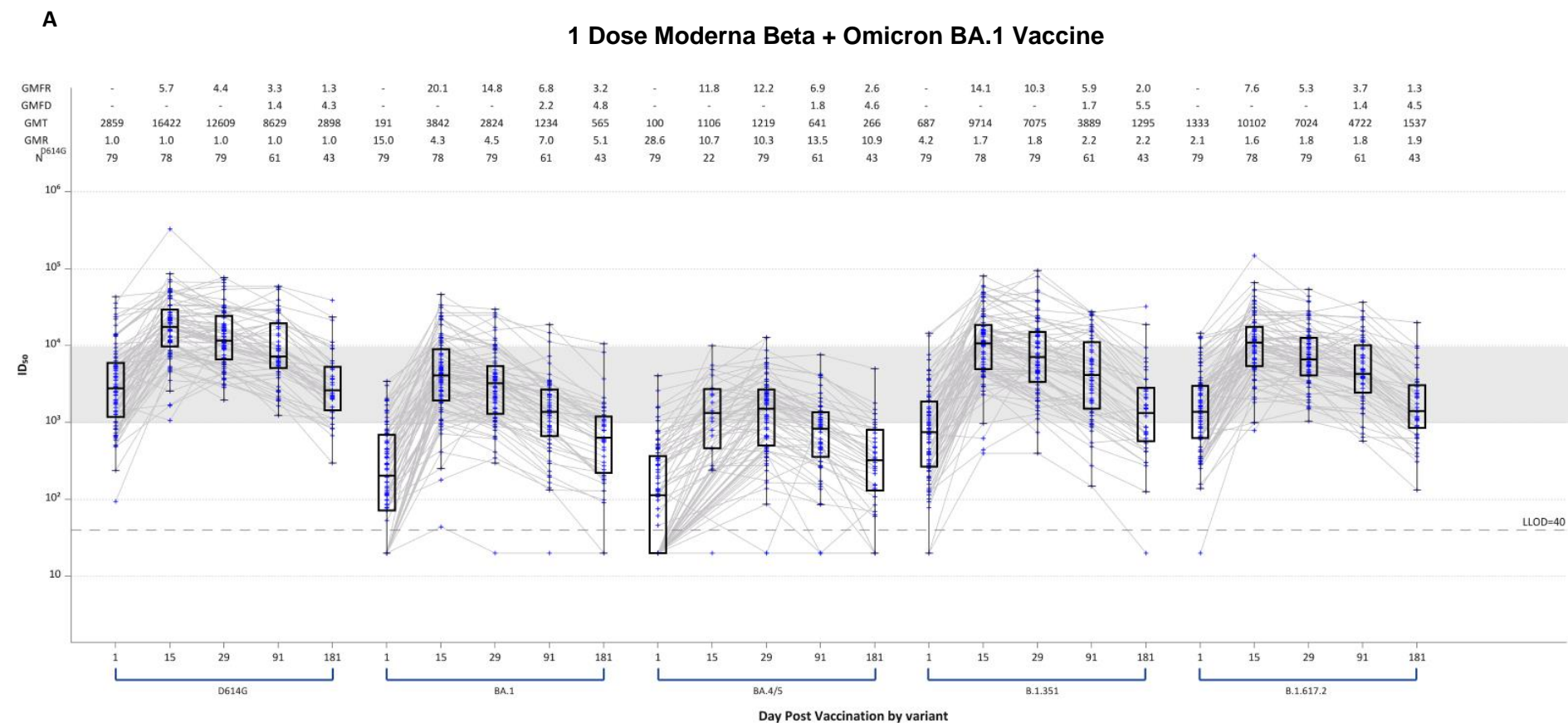

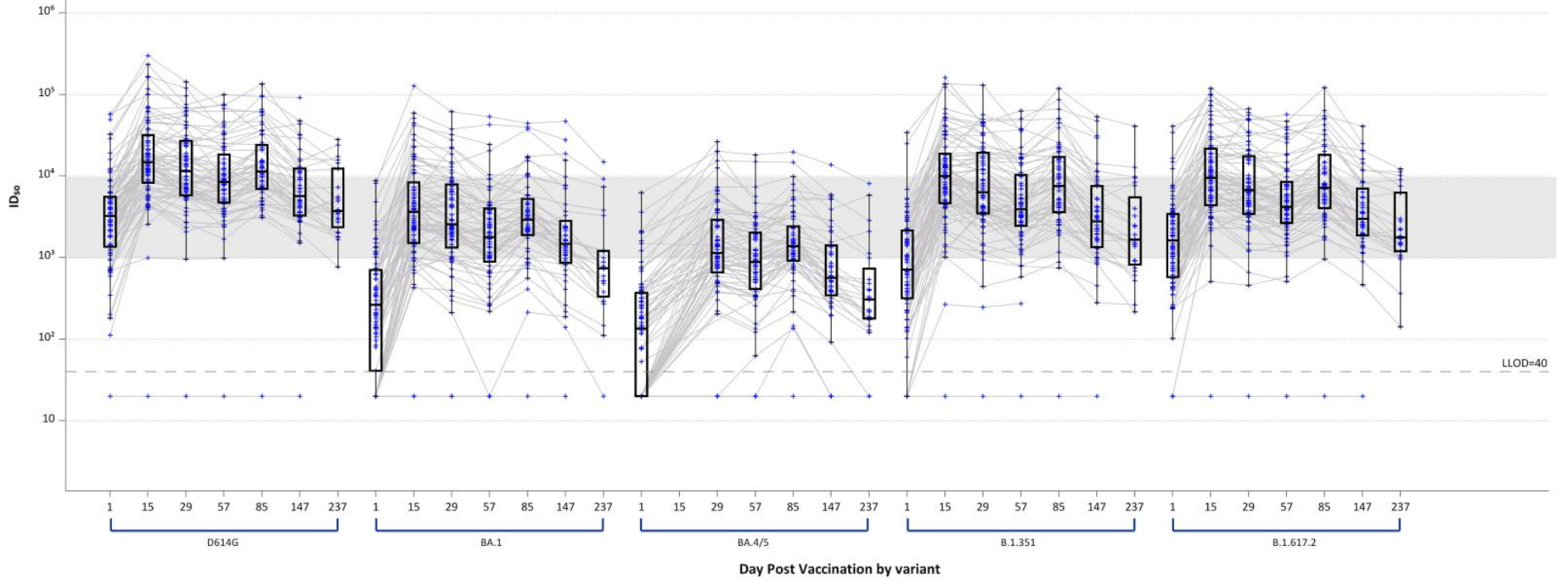
FIGURE 1. Pseudovirus Neutralization ID₅₀ Titers by Timepoint (baseline, Day 15 and 29 for both arms and 90 and 180 days after Vaccination for each arm, respectively and Day 85 for the 2 dose sample prior to receipt of second dose) and Variants, (D614G, Omicron BA.1 [B.1.1.529], BA.4/BA.5, Beta [B.1.351] and Delta [B.1.617.2]) before and after vaccination with 1 dose of 50 mcg of Moderna mRNA-1273 Beta/Omicron BA.1 (A) or 2 doses (given 56 days apart) of 50 mcg Moderna mRNA-1273 Beta/Omicron BA.4/5 (B) in participants previously uninfected at baseline. Boxes with horizontal bars denote interquartile range (IQR) and median ID₅₀, respectively. Whisker denotes 95% confidence interval. GMFR, geometric mean fold rise from baseline. GMFR, geometric mean fold rise from baseline. GMT, geometric mean titer. LLOD, lower limit of detection of the assay.

SUPPLEMENTAL MATERIALS

Study Design and Eligibility Criteria

This phase 2 open-label, randomized, clinical trial was performed at 22 sites in the US (Table S5) enrolling all participants from March to May 2022. Eligible participants were healthy adults (with or without a history of prior SARS-CoV-2 infection) who had received a primary series and a single homologous or heterologous boost with an approved or emergency use authorized prototype COVID-19 vaccine (Table S6). The most recent vaccine dose, and/or prior infection must have occurred at least 16 weeks prior to randomization. Full eligibility criteria are described at clinicaltrials.gov (NCT 05289037).

Two hundred and two eligible participants were stratified by history of confirmed SARS-CoV-2 infection, and randomly assigned for each arm in an equal ratio.

After informed consent, participants underwent screening, including confirmation of COVID-19 vaccination, medical history, a targeted physical examination, and a urine pregnancy test (if indicated). Samples were collected at Day 1, Days 15, 29, 57 (2-dose group only), and 85 (2-dose group only) and 3, 6, 9 and 12 months after last dose of vaccine. Immunologic data are currently available up to Day 181 for the 1-dose arm and through Day 237 (180 days after second dose) for the 2-dose arm.

The trial was reviewed and approved by a central institutional review board and overseen by an independent Data and Safety Monitoring Board. Participants provided written informed consent before undergoing trial-related activities. The trial was sponsored and funded by the National Institutes of Health (NIH). The National Institute of Allergy and Infectious Diseases NIAID SARS-CoV-2 Assessment of Viral Evolution (SAVE) program team was consulted to inform study arm design and variant vaccine selection.

Trial vaccine

The Beta/Omicron BA.1 bivalent trial vaccine was provided by Moderna (total amount of 50 mcg per vaccine; 25 mcg of each component). The vaccine candidates are manufactured similarly to their corresponding authorized or approved vaccines in the US or Europe.

Study outcomes

The primary objective was to evaluate humoral immune responses of candidate SARS-CoV-2 variant vaccines.

Immunogenicity assays

SARS-CoV-2 neutralization titers, expressed as the serum inhibitory dilution required for 50% neutralization (ID_{50}), were assessed using pseudotyped lentiviruses¹ presenting SARS-CoV-2 spike mutations tested in the Monogram laboratory (San Francisco, CA) lab for the following strains: D614G, Omicron BA.1, Omicron BA.4/5, B.1.351 and B.1.617.2.

Pre-specified immunogenicity endpoints

Statistical analysis

The primary objective of this study is to evaluate the magnitude and breadth of SARS-CoV-2 specific antibody titers in serum samples by estimating 95% confidence intervals (CI) for the geometric mean titer (GMT) at each timepoint when samples are collected. No formal hypothesis tests were planned.

The geometric mean fold rise (GMFR) is calculated as the geometric mean of titers at a timepoint divided by titers at Day 1. The geometric mean ratio to D614G (GMR_{D614G}) is the geometric mean of the ratio of titers for a variant of concern to titers against D614G.

The GMFD was calculated by dividing the result at Day 29 by the result at each day after Day 29 and then calculating the geometric mean. Seropositive rate is calculated as the proportion of participants with titers above the lower limit of detection (LLOD). 95% CI for GMT, GMFR, GMFD and GMR_{D614G} are calculated using the Student's t-distribution and 95% CI for seropositive rate is calculated using the Clopper-Pearson binomial method. For the purpose of analysis, participants were defined as previously infected by positive N antibody or self-report of a confirmed positive antigen or PCR testing. Participants were removed from analysis at timepoints following self-reported infection, N-antibody positivity or receipt of an out-of-study booster. Participants randomized to the 2-dose arm that did not receive the second dose were removed from the analysis after Day 29. This consisted of 11 participants who tested positive for COVID-19 prior to receiving the second dose, three participants who had adverse events and one participant who withdrew from the two-dose arm due to reactogenicity experienced after the first dose.
