

1 **Barriers and Facilitators to the Delivery of Age-friendly Health Services in Primary**  
2 **Health Care Centres in Southwest, Nigeria: A Qualitative Study**

31 **Abstract**

32 **Background:** With the rapid growth of Nigeria's older population, it has become important to  
33 establish age-friendly healthcare systems that support care for older people. This study aimed  
34 to explore the barriers and facilitators to the delivery of age-friendly health services from the  
35 perspectives of primary healthcare managers in Lagos State, Nigeria.

36 **Method:** We conducted 13 key informant interviews including medical officers of health,  
37 principal officers of the PHC Board and board members at the state level. Using a grounded  
38 theory approach, qualitative data analysis was initially done by rapid thematic analysis  
39 followed by constant comparative analysis using Dedoose software to create a codebook. Three  
40 teams of two coders each blind-coded the interviews, resolved coding discrepancies, and  
41 reviewed excerpts by code to extract themes.

42 **Results:** The main barriers to the delivery of age-friendly services included the lack of  
43 recognition of older adults as a priority population group; absence of PHC policies targeted to  
44 serve older adults specifically; limited training in care of older adults; lack of dedicated funding  
45 for care services for older adults and data disaggregated by age to drive decision-making. Key  
46 facilitators included an acknowledged mission of the PHCs to provide services for all ages;  
47 opportunities for the enhancement of older adult care; availability of a new building template  
48 that supports facility design which is more age-friendly; access to basic health care funds; and  
49 a positive attitude towards capacity building for existing workforce.

50 **Conclusion:** While we identified a number of challenges, these offer opportunities to  
51 strengthen and prioritize services for older adults in PHCs and build on existing facilitators.  
52 Work is needed to identify and test interventions to overcome these challenges and improve  
53 the responsiveness of the PHC system to older adults through the delivery of age-friendly  
54 health services in PHCs in Lagos, Nigeria.

## 55 **Introduction**

56 Age-friendly services are health services that address the unique needs and wants of older  
57 people so they can live healthy and active lives [1]. Presently, 14.8 million older persons live  
58 in Nigeria and at a growth rate of 3.2%, this number is expected to increase to 30 million by  
59 2050 [2]. Associated with the aging populations, non-communicable diseases (NCDs) have  
60 become a leading cause of morbidity, disability and mortality in all regions of the world,  
61 including in developing countries [3]. The burden of disease also includes age-related  
62 comorbidities including frailty, cognitive decline and multimorbidity [4]. In response, health  
63 care services need to be structured to be responsive to the needs of older adults to provide  
64 longitudinal primary care to prevent, diagnose and manage these comorbidities and improve  
65 the quality of life for this growing population [5, 6].

66

67 Primary Health Care centers (PHCs) are well positioned to provide person-centred and  
68 community-based care required to prevent or postpone morbidities associated with or more  
69 common with aging and reduce their impact on individuals, facilities and health systems [3,  
70 7]. However current PHC-related services in Nigeria prioritize maternal and child healthcare,  
71 resulting in gaps in the structure and delivery of services needed by older adults [8, 9]. For  
72 example, despite a national action plan for the control of NCDs, its prevention, care and  
73 treatment are not currently included in the minimum service package for primary health care  
74 in Nigeria [6]. According to the World Health Organization (WHO), PHCs that are age-friendly  
75 should address three areas in their care for older adults: 1) information, education,  
76 communication and training for providers; 2) health care management systems; and 3) the  
77 physical environment [10]. PHCs should focus on adapting health care to the preferences and  
78 needs of older people, health promotion and the prevention of chronic conditions that result  
79 from aging [11]. These adaptations in service provision can empower older adults, involving

80 them as partners in the care process, with goals to improve their quality of life, and ensure  
81 dignity in care [12].

82

83 Some studies have identified enablers and barriers to providing age-friendly services in both  
84 high and low and middle income countries. For example, in an Australian health system,  
85 stakeholders highlighted barriers in delivering hospitals-based education and skills training;  
86 governance structures and leadership and working in multidisciplinary teams [13]. Enablers  
87 included valuing care of older people and their families; skilled compassionate staff working  
88 in effective teams; and care models and environments supporting older people across the  
89 system. Focus group data from clinician stakeholders in Canada reflected organizational level  
90 barriers and facilitators in five categories namely; education, environment, staffing, policies  
91 and other research projects [14]. In Uganda, low readiness for public health facilities to provide  
92 age-friendly care services were due to gaps in all of the health system building blocks;  
93 leadership, financing, human resources and health management information systems (HMIS)  
94 [15].

95

96 In Nigeria, high staff workload, administrative challenges, and mismatch with the needs of the  
97 aging patient population and existing resources and priorities have been identified as common  
98 barriers to service provision for chronic conditions in the PHCs [16]. Minimizing barriers to  
99 accessing primary health care and improving care provided for older adults would both enhance  
100 health outcomes, and reduce public health spending substantially [12]. Our preliminary data in  
101 comprehensive PHCs across Lagos, southwest Nigeria, found health care workers to be  
102 inadequately trained for the care of older persons, sub-optimal screening for conditions  
103 common among this population, and infrastructural gaps in the physical environment that  
104 should allow older people to move around independently, actively, safely and securely while

105 receiving health care (personal communication). To gain further insight into our findings, we  
106 used qualitative methods to explore further the barriers and facilitators to the delivery of age-  
107 friendly health services from the perspectives of PHC managers. These finding are important  
108 to inform the designing and testing of interventions to increase accessibility, acceptability and  
109 appropriateness of age-friendly PHCs in Lagos and in the region.

110

## 111 **Materials and methods**

### 112 Study design

113 We conducted a descriptive qualitative study and used the Consolidated criteria for Reporting  
114 Qualitative research (COREQ) checklist to report on our methods and finding [17].

115

### 116 Study site and participants

117 Lagos State is the most populous city in Africa with over 15 million residents across 57 local  
118 districts and 376 wards[18, 19]. There are over 300 PHCs across the wards and 57 of such  
119 PHCs are referred to as “flagship PHCs” because they have a full complement of health  
120 workers including medical doctors and offer 24-hour services [19]. The Lagos State Primary  
121 Health Care Board (PHCB) is tasked with the overall responsibility of primary health care  
122 management in the state. The board acts as a strategic link between the state and local councils  
123 in matters relating to primary health service improvement and delivery [20]. It is headed by the  
124 permanent secretary and who provides oversight functions through the principal officers of  
125 several directorates and the medical officers of health (MOH). The MOH oversees all the PHCs  
126 within a local council and each PHC facility is headed by an officer-in-charge.

127

128 This study was conducted among key informants recruited between May and September 2022.

129 They included medical officers of health, principal officers of the PHC Board who are assistant

130 directors or directors and board members. Participants were purposively selected based on their  
131 experience and position in the PHC system. Seventeen individuals who had direct oversight in  
132 PHC management and delivery were contacted via invitation letters and phone calls and asked  
133 to participate in the study; four declined due to lack of interest and a total of 13 stakeholders  
134 were interviewed. However, saturation of themes was achieved in our sample. The  
135 demographic characteristics of participants are included in **Table 1**.

136

137 Interviewer team

138 Interviews were conducted by A.O. and M.B., who are both public health specialists with  
139 qualitative research experience. Most of the participants were known to the interviewers as a  
140 result of the meeting in other public health meetings and related activities in the state. The  
141 participants knew the researchers were faculty members at the University of Lagos and were  
142 involved in public health research.

143

144 Data collection

145 The interviews were done virtually at a time convenient to the participants, in a quiet place,  
146 using the Zoom platform (Zoom Video Communications, San Jose, CA, USA). At the start of  
147 the interview, the interviewer introduced herself, requested permission to record the session  
148 and informed verbal consent was obtained as part of the audio recording. Anonymity was  
149 ensured by not collecting and including data that could identify the participant during or after  
150 the interview. In addition, the participant was informed that a survey on the age-friendliness of  
151 services had been undertaken at selected PHCs. The interview began with defining ‘healthy  
152 aging’ according to WHO and asking the participants to express their thoughts on what it meant

153 to them. There were nine questions in all, and probing questions were used if required to elicit  
154 further information (Suppl. File 1). Interviews lasted about 45 minutes.

155 All interviews were digitally recorded using the recording feature on the Zoom platform. Once  
156 the recording was completed, a separate audio file was used for each participant and saved with  
157 a unique identifier in a computer secured by a password known only to the interviewer. Each  
158 audio file was transcribed verbatim by a transcription service provider, anonymized and  
159 crosschecked by A.O. The transcripts were uploaded to Dedoose (version 9.0.54) by A.O. and  
160 made accessible to six coders.

161

## 162 Data analysis

163 This study used a grounded theory approach to investigate the research [21]. We used the  
164 constant comparative method to analyze our data using an inductive approach.

### 165 Codebook creation

166 Six coders independently open-coded three transcripts (2 coders per transcript) assigning codes  
167 to all concepts identified in the interview data. Through a series of meetings, the coding team  
168 condensed the codes to combine similar codes. The resulting codes were discussed and  
169 finalized at an all-team meeting with the coders and the PIs. The final codebook (Suppl. File  
170 2) was uploaded into Dedoose.

171

### 172 Coding

173 Coders worked in teams of two to code 4-5 transcripts per pair. Teams individually identified  
174 and asynchronously discussed discordant code applications through a tracking spreadsheet.  
175 Consensus was reached between the pair of coders and the code was changed to reflect the

176 agreed-upon code and placement. If the coding team could not come to agreement, the code  
177 discrepancy was discussed by the entire team during a team meeting. Once initial coding was  
178 complete all excerpts were reviewed by code, summarized and organized into themes reflecting  
179 the barriers and facilitators to implementing age-friendly health services in PHCs. SW led this  
180 process through weekly discussions with the coding team.

181

## 182 Participant Feedback

183 Preliminary findings as well as emerging findings from a rapid analysis conducted by SW, LH  
184 and AO were presented to interviewed participants before the conclusion of analysis. After  
185 initial overview, participants were asked if they accurately represented their experience and  
186 understanding of the facilitators and barriers to implementing age-friendly health services in  
187 PHCs. Feedback from this meeting was used to check the themes developed in the final  
188 analysis. There were no additional themes which were identified based on the feedback.

189

## 190 Ethical Considerations

191 We obtained ethical approval from the Health Research and Ethics Committee (HREC) of the  
192 College of Medicine, University of Lagos (CMUL/HREC/10/21/954). Informed consent was  
193 obtained from each participant and confidentiality was ensured through de-identification of  
194 transcripts and use of identification codes.

195

## 196 **Results**



197 Three-quarters of the participants were female (76.9%) and doctors (76.9%) (Table 1). Almost  
 198 half (46.1%) were medical officers of health of the primary health care centers while 46.2%  
 199 belonged to the management category in the primary health care board.

204 We identified fifteen major themes (Table 2). Ten of these were barriers to the delivery of age-  
 205 friendly services while five were facilitators.

206

## 210 **Barriers**

### 211 **Older adults are not priority population for services provided by the PHCs**

212 There was acknowledgment by the participants that the responsibility of PHC was to provide  
213 care across the lifespan and all ages. However, it was noted that older adults were not always  
214 a priority population. One of the participants mentioned that Nigeria's low life expectancy  
215 indicates that the focus should be on the younger generation.

216

217 *“Life expectancy is between age 47 to 54 years in Nigeria, so we are more concerned*  
218 *about keeping the younger generation alive at the PHCs. Communicable diseases,*  
219 *treatments of malaria, HIV, TB, those are the bane of our existence in Africa, in Nigeria*  
220 *specifically, so more of the focus is on that.” P11*

221

222 *“We focus on antenatal, we focus on child welfare, we focus on maybe family planning*  
223 *more than the elderly, we focus on those aspects of health than the elderly.” – P13*

224

225 One participant noted that older adults should be given preference for receiving services, but it  
226 was not always the case.

227

228 *“When elderly people come to the PHCs, we need to give them some priority. We are*  
229 *supposed to give them some priority which we don't do” – P13*

230

### 231 **No policies or budget are set aside to specifically serve older adults**

232 Participants expressed that there were no policies that targeted the specific care of older people  
233 at the PHC level. In addition, there was no dedicated funding for older adults included in the  
234 budget for PHCs.

235           *“Unfortunately, I don't think there's any policy that is tailored to the aged, of course,*  
236           *there are policies where we talk about equity, and not in particular the aged but that*  
237           *bears in mind all human beings, whether you are young or old, a man or woman, and*  
238           *that's all encompassing but there's no policy focusing on the aged, there's no written*  
239           *policy.” – P2*

240

241           *“To the best of my knowledge there's no separate financial scheme for the service*  
242           *delivery to older people in the PHCs”- P6*

243

#### 244   **The staffing limitations in the PHCs affect the ability to serve older adults**

245   Staffing limitations was one of the reasons given as a barrier to the provision of dedicated  
246   services to older adults at the PHCs. These limitations were said to also impact negatively on  
247   providing care to other age groups and various programs, but even more so for older adults  
248   given the complexity of care.

249           *“Unfortunately, the health worker shortage is a general problem, the fact that we don't*  
250           *have enough health workers, it cuts across board not only for the elderly but including*  
251           *other age group, other programs..., I really don't see it feasible currently to have*  
252           *dedicated health workers to the elderly because even what we have is not enough.” - P2*

253

254   Knowledge and skill of health workers were considered important by the participants. Another  
255   challenge identified was the need for training in the care of older individuals as the health  
256   workers available were not trained to manage the needs of older adults resulting in a poor  
257   capacity to deliver age-friendly services.

258

259 *“Really, I think my own concern is that we need trained personnel ... let’s just do some*  
260 *orientation and reorientation. It’s not easy handling [older] people...you can't just*  
261 *jump in and do what you think is right, there has to be a structured kind of care or level*  
262 *of care to look after [older people] and minus having doctors occasionally.” – P3*

263

264 Participants also stated that there were limitations to services PHCs could offer older adults as  
265 some medical services required by them were outside their scope due to staffing expertise.

266 *“There is a limit to the services that we can offer. So, it is not a case of not making them*  
267 *a priority. Okay, an elderly that has a very bad diabetes, I am just using that as an*  
268 *instance or uncontrolled blood sugar, there is a limit to what we can do, we don’t have*  
269 *consultants.” – P12*

#### 270 **Insufficient programming and community-delivered services**

271 There was a general recognition of the need for community-delivered services such as home  
272 visits for older adults. One reason given included varying levels of physical or mental  
273 functionality in this age group.

274 *“Like I said, for them it will mainly be home visits.. and give them a kind of support,*  
275 *because most times, they are frail and there’s a lack of cognitive functionality, they rarely*  
276 *want to leave home so we need to have scheduled home visits for such older people,” –*

277 P11

278 Respondents also stressed the importance of community-delivered services to allow for prompt  
279 attention to older adults in emergencies and to prevent them from having further complications  
280 as well as improving accessibility.

281 *“So, these people should have a way of getting care even when it is needed at the*  
282 *community level including emergency... Linking their care right from the community to*

283 *the PHC and to the secondary level of care should be strengthened so that they can enjoy*  
284 *those services” – P10*

285

### 286 **Physical buildings are not designed and constructed to serve older adults**

287 Participants discussed challenges in the physical accessibility of the PHCs, for example, the  
288 entrances to many of the PHCs did not have ramps as they were not purpose-built.

289 *“We can't say we don't want this place, you just have to make use of what is being given,*  
290 *the way it's being built is not accessible or convenient for a frail person to climb the*  
291 *stairs or for a weak person to come in, some are built in places that's not accessible, bad*  
292 *road structure, no water access. .”- P2*

### 293 **PHCs do not access available resources**

294 The PHCs had not started accessing the Basic Health Care Provision Fund (BHCPF) provided  
295 by the federal government which could be helpful in funding the care of the older population.

296 *“.. the function of advocacy, reminding the Local Government Health Authorities and*  
297 *the Ward Health Committees that when the funds for Basic Health Care Provision Fund*  
298 *(BHCPF) comes they should prioritize the care of the older population, also there are*  
299 *funds coming in from the health insurance scheme in Lagos State (Ilera eko).”- P6*

300

### 301 **Data collected at the PHCs are not disaggregated by age for older adults**

302 While there was routine data collection at all the PHCs, there was no disaggregation of the data  
303 nor analysis for the purpose of monitoring older adults. As a result, the routine data set does  
304 not allow for the forecasting and planning needed to meet the needs of older people. The data  
305 collected were mainly used in determining the disease trends and deciding the types of drugs  
306 to purchase.

307           “...we can see that people are coming more for this and for that but not in particular  
308           having the elderly in mind unfortunately, but generally we look at those data and analyze  
309           it to find out if there's anything different from any trend or anything out of what we are  
310           expecting”. - P2

311

312   **Financial barrier: Many older adults don't have enough funds even for basic needs, low**  
313   **uptake of insurance**

314   Participants shared that older adults who had limited funds will have difficulty prioritizing their  
315   health or visiting the clinics. This is because certain payments had to be made to access care as  
316   well as the need to pay for food, habitation and so on. Some of this challenge is because of the  
317   low uptake of the Lagos State health insurance scheme.

318           “Of course, there's health insurance established in Lagos State but just few people are  
319           enrolled on the program, they still have to pay from pocket to get their healthcare and  
320           most of them because they are retired do not have funds to get the best services,  
321           sometimes they have limited funds and just prioritize the kind of drugs they can buy and  
322           these are the main challenges.” - P2

323

324           “The challenges will be, people are not taking up even the health insurance mandatory  
325           program, people are not taking, they are not buying the insurance” - P12

326

327   **Older adults have difficulty getting to the PHCs**

328   The participants noted that there were challenges in accessing the PHCs including the needed  
329   social support and transport to bring older adults to the PHCs.

330           “The only challenge I feel we have is if they don't have people around them to support  
331           them to the health facility”- P5

332 Geographic barriers including topography and distance to existing PHCs were among other  
333 reasons why older adults were not accessing some of the PHCs.

334

335 *“...some chairmen will just build PHCs even at places that are very difficult to reach*  
336 *and eventually nobody is ready to go maybe because of the topography of the area, you*  
337 *know the hill and the rest and some are not because of the road structure, some are very*  
338 *difficult to access because of these things we are talking about.” – P4*

### 339 **Facilitators**

340 We heard a number of facilitators from respondents on the capacity to provide age friendly  
341 care at the PHC.

### 342 **Primary Health Care mission is to provide services for all ages**

343 Many of the participants acknowledged that it was the role of the PHCs to provide affordable  
344 care across the lifespan and therefore it is open to all including older adults.

345 *“At the primary health care centre, .... we provide services that might not be targeted at*  
346 *ageing specifically but it’s a general service.... So even though it’s not targeted, it is*  
347 *open to people of all ages.” -P11*

348

### 349 **There are opportunities for the strengthening care for older adult**

350 The participants mentioned that there were opportunities within the PHC system to strengthen  
351 care for older adults. The Basic Health Care Provision Fund (BHCPF) by the federal  
352 government and the Lagos State Health Scheme (LSHS) are available to the PHCs, although  
353 as noted above, there was inadequate uptake by PHCs.

354 *“If more PHCs are set and enrolled in the program and we have people coming into the*  
355 *insurance program, then it will be easy, because this is a very good opportunity in the*



356 *state and there is a lot of money going into it, there's so much funding coming from the*  
357 *basic healthcare provision funds....” - P2*

358 Availability of Social and welfare services in some areas such as nutritional support, money,  
359 and prescriptions were also identified as important to help address the healthcare needs of older  
360 adults.

361 *“There are services that are good for elderly people but are not directed towards health,*  
362 *there are some local governments, who have nutrition services for elderly people, and*  
363 *some give financial transfers to support them”- P1*

364

### 365 **Positive attitude towards capacity building for existing workforce**

366 Some of the participants felt that capacity building of the existing workforce to expand and  
367 enhance the provision of age-friendly services could be done through training. An example  
368 given was the involvement of community mobilizers to encourage older adults who needed th  
369 care to access the PHCs and also in the provision of some home services.

370 *“We also have social mobilizers and these are people that have been recognized as*  
371 *people that have the voice within the community, they have been trained over the years,*  
372 *they go round talk to people and they'll share materials available like posters, fliers,*  
373 *handbills. Where and how to behave in the community and where they can ask questions,*  
374 *sometimes it's mostly in form of meetings” - P2*

375

### 376 **Community outreach programs for non-communicable chronic conditions in older adults**

377 PHCs already provide screening and treatment during community outreach programs for  
378 common chronic conditions such as hypertension and diabetes. Although they do not routinely  
379 manage these conditions in the PHCs, it can be built upon over time.

380           *“We’ve actually been doing several care for elderly, on mostly non communicable*  
381           *diseases like hypertension and diabetes, there are times when we have scheduled*  
382           *[community] programs like hypertension week, wellness week”- P2*

383

384   **State-developed structural template for PHCs supports facility design for accessibility for**  
385   **older adults**

386   The participants reported that Lagos State has a building template which reflects many of the  
387   WHO Age-Friendly guidelines and that all new PHC construction must follow this template.  
388   They also noted that it was possible for PHCs to use their quarterly funds to make the changes  
389   needed to their buildings. They expressed that with the political will, funds were available and  
390   the PHCs just needed to know what to do.

391           *“It’s not hard. So far there is a political will, you know political will, it will bring out*  
392           *the funds, the Medical Officer of Health (MOH) can only make recommendation that are*  
393           *okay for the elderly....., you need all these chairs with armrest, high chairs not the low*  
394           *ones with backrest and armrest and then we need a ramp both in front and at the back,*  
395           *the ramps for Ibeju is at the side which is meant to be the emergency entrance.” P9*

397   **Discussion**

398   Our qualitative work found supporting evidence of the earlier quantitative findings of gaps in  
399   training and infrastructure, as well as identified new barriers to providing healthy aging care  
400   for older people in Lagos state as well as the presence of some facilitators. Our respondents  
401   highlighted that older adults were not always a priority population for care at the PHCs but  
402   acknowledged the centrality of PHC's role to provide accessible and affordable care across the  
403   lifespan. While the need to strengthen accessibility as well as the availability of PHC focused  
404   on older adults was recognized there were a number of challenges that need to be addressed.

405  
406 One important gap noted by some of the respondents was the lack of the existence of policies  
407 targeted at serving older adults in PHCs in Lagos State. However, it was stated that there were  
408 aspects of the national policies that implied the inclusion of older adults for care based on care  
409 for all adults with the main goal of social welfare. For example, according to the 1999 Nigerian  
410 Constitution, Section 16, sub-section 2(d), old age care and pensions, as well as sick benefits,  
411 will be provided to all citizens [22]. Similarly, existing policy documents in Uganda focus only  
412 on addressing the social needs of older adults[15]. The federal government of Nigeria  
413 introduced new policies such as the National Senior Citizens Centre in 2017, an agency to cater  
414 to the needs of senior citizens; and related matters were enacted and in due course, the National  
415 Policy on Ageing for Older Persons in Nigeria was approved by the Federal Executive Council  
416 in February 2021[23, 24]. In addition to this, financial barriers from the PHC and limited  
417 financial resources among older adults were also identified. These barriers included low rates  
418 of uptake of programs designed to reduce these barriers. For example, the respondents also  
419 identified the poor coverage by the National Health Insurance Scheme (NHIS), reflections  
420 supported by data that only 5% of the population, mostly civil servants and younger individuals  
421 were enrolled in the program [25].

422 Another important barriers was the staffing limitations and specifically workforce  
423 trained in the care for older adults was another reason given as an implementation barrier for  
424 AFHS. These results reflect similar to findings from a quantitative survey in Benin City,  
425 Nigeria [26]. The lack of health manpower capacity is an issue of global public health concern  
426 and a major limitation to implementing important health policies across the lifespan [27]. In  
427 Nigeria, similar to in many countries in Africa, training in the care of older persons is still  
428 new. In Nigeria, it is not included in the undergraduate curriculum and only a few hospitals are  
429 accredited to offer training in geriatrics [28]. As a result, healthcare workers often do not have

430 the knowledge and competency to address the emerging challenges in delivering care for older  
431 adults living with complex needs and this threatens the quality of care as well as trust in the  
432 healthcare system [29].

433 Many participants also noted the importance of moving beyond facility-based care to  
434 providing home services in the community to support older adults but there are no such  
435 formalized services for this age group in Nigeria [30]. This work would be important for both  
436 practice outreach as well as prompt attention to identifying and responding to emergency  
437 situations, as well as active outreach to prevent delay in disease complications. Learning from  
438 existing approaches that work will be important as well as leveraging strengths in community  
439 care. For example, in parts of the United States, community-based supports and services are  
440 designed to help community-dwelling older adults remain safely in their homes and delay the  
441 need for placing them in institutions [31]. Respondents also noted that many older adults lacked  
442 the social support in bringing older adults to the facility was also identified as a challenge.  
443 Studies have suggested that some of this weakened social support and this has been largely  
444 attributed to the change in family dynamics and traditional family structure in Nigeria as well  
445 as the lack of community-based support noted above [32].

446 An important barrier reported was that many of the PHCs were not designed and  
447 constructed to serve older adults, especially as regards physical accessibility. For example,  
448 some of the buildings that serve as PHCs were put up by the local council chairmen for the  
449 purpose of providing care in the community, and health providers regarded this as a starting  
450 point. In our preliminary study that assessed the facility readiness of selected PHCs for AFHS,  
451 we found that two-fifths of the PHCs did not have ramps at their entrances, and a third did not  
452 have a reception area near the entrance. In addition, 86.7% of the public toilets in the PHCs did  
453 not have grab bars, and 33.3% were not served by public transportation. According to several  
454 of the participants, there was a current effort by the present state government to ensure donors

455 complied with the building template provided. Furthermore, the participants were optimistic  
456 that funds were not a barrier to making recommended changes to older buildings if given the  
457 necessary information and expanded use of the available funding sources including increasing  
458 enrollment in insurance and the BPHFC funds. Among the three principles proposed by WHO  
459 for AFHS, the physical environment has the most precise guidelines and is thought to be the  
460 least complex area of change [11].

461 While data are routinely recorded and reported at the PHCs, it was reported that they  
462 were not disaggregated for age for the older adult category, 60 years and above. One of our  
463 participants mentioned that the nationally designed reporting forms did not specify for those  
464 aged 60 years and above but classified adults as 18 years and above. This negatively affected  
465 the use of data to plan for the needs of older adults in the PHCs. However, routinely collected  
466 data is used to understand disease trends in the community and to restock drugs for facility use.  
467 On the contrary, outpatient department registers in Uganda had disaggregated data by age in  
468 all the selected health facilities in a study but geriatric data was not being used to improve  
469 service delivery [15]. A multi-country study on health data reporting in PHCs in five LMICs  
470 including Nigeria found that data was primarily collected in outpatient care, antenatal care,  
471 immunization, family planning, HIV and tuberculosis services only [33]. Although older adults  
472 vary greatly in terms of health status, the majority of them have at least one chronic condition  
473 and are prone to other age-related diseases such that the current data reporting system in the  
474 PHCs will exclude them from care [34, 35]. In comparison to high-income countries, data on  
475 aging and the well-being of older people in LMICs are insufficient and might not be fully  
476 representative of the aging populations in the countries flagging the need to prioritize research  
477 for informed decision-making [36].

478 One of the key facilitators for the implementation of AFHS mentioned by our  
479 respondents was the establishment of the Basic Healthcare Provision Fund (BHCPF), a

480 component of the National Health Act of 2014. It is predominantly funded by the Federal  
481 Government of not less than 1% of the Consolidated Revenue Fund (CRF), donor grants, and  
482 others [37]. Our respondents were positive that accessing the BHCPF would provide  
483 opportunities for investments in the PHCs but admitted that such funding may still not be  
484 targeted toward the care of older people. However this was also identified as missed  
485 opportunity identified was low use of the Basic Healthcare Provision Fund (BHCPF), PHCs  
486 which could support expanding and strengthening care for older adults. Our findings are  
487 supported by a study of the process of administration and disbursement of the BHCPF which  
488 highlighted some challenges such as poor accountability systems, high-level political  
489 interference, and lack of political commitment from the State to release funds for health  
490 activities[38].

491 Another facilitator mentioned by our participants while reflecting on the success of  
492 other PHC programs, is the existing PHC workforce that can be trained on the delivery of  
493 AFHS. This includes community health workers who can provide health awareness campaigns  
494 and home services for older adults while performing their routine duties in the community.  
495 Community health workers constitute the majority of the health workers in PHCs and their  
496 deployment to deliver essential health services has proven to be a well-established strategy to  
497 address the critical skilled health workforce [39, 40]. Several respondents also mentioned  
498 existing community outreach programs for non-communicable chronic conditions in older  
499 adults by the PHCs as a facilitator. Such care is offered during occasional outreaches  
500 comprising free screening and treatment of chronic conditions such as hypertension and  
501 diabetes. Recently, the Nigerian government focused on PHCs to tackle the rising non-  
502 communicable disease (NCD) burden by strengthening community health workers' skills and  
503 competencies for NCD care delivery [40]. However, it has been noted that such roles are

504 sometimes beyond the community health worker’s scope of practice and may be limited by  
505 access to adequate training and supervision [40].

506

507 To the best of our knowledge, this study is the first to explore barriers and facilitators  
508 to the delivery of age-friendly health services in Nigeria and one of few from Africa. We  
509 interviewed a multidisciplinary group of participants at high level of leadership in the PHC  
510 setting. Our studies had a number of limitations. Like all qualitative methods, results reflect  
511 the opinion and reflections of the respondents and their possible biases. We worked to limit  
512 bias by keeping questions open ended and ensuring anonymity throughout the process.  
513 Importantly we did not include older adults or their care givers in this study due to resource  
514 limitations, so their important perspectives and experiences of care were not captured. However  
515 we are planning to engage these groups in a follow-on study

## 517 **Conclusions**

518 In conclusion, this study among PHC stakeholders recognizes the role of PHCs in the  
519 promotion of healthy aging in general. While barriers were identified.. there were multiple  
520 many opportunities to strengthen and prioritize primary care services for older adults in Lagos  
521 state. Actions are needed to further engage stakeholders to prioritize actions and co-design and  
522 implement priority interventions that will directly address the barriers and build on existing  
523 strengths to improve the delivery of age-friendly health services in PHCs in Lagos, Nigeria.
