Characteristics of Cerebellar Cognitive Affective Syndrome (CCAS) in patients with acute cerebellar stroke and its impact on outcome

Abstract

Background: Recently, cerebellar cognitive affective syndrome-scale (CCAS-S) was

developed to assess CCAS—a syndrome in which cognitive impairment is caused by

cerebellar lesions. Literature regarding CCAS in patients with stroke is scarce, and its impact

on outcomes is unclear. This study aimed to evaluate CCAS in patients with acute cerebellar

stroke and examine its relationship with the outcomes.

Methods: Patients who experienced acute cerebellar stroke for the first time and were

hospitalized in Steel Memorial Yawata Hospital within 7 days of stroke onset between April

2021 and April 2023 were included in this observational study. CCAS-S, Mini-Mental State

Examination (MMSE), and Scale for the Assessment and Rating of Ataxia (SARA) scores

were measured 1 week after stroke onset, and Functional Independence measure (FIM)/Barthel

Index (BI) at discharge, physical function, activities of daily life (ADL), length of hospital stay,

and outcome (discharge destination) were evaluated. The Mann-Whitney U test was used to

compare CCAS-S scores and variables.

Results: Thirteen consecutive patients with acute cerebellar stroke (9 women) and age-and

sex-matched healthy controls (7 women) were included. The MMSE score was within the

normal range in all patients; however, patients with stroke had a lower total CCAS-S score

(median 72, interquartile range [IQR] 66-80) and a higher number of failed tests (median 4,

IQR 3–5) than those of healthy controls. Significant deficits were observed in semantic fluency

(p=0.008), category switching (p=0001), and similarity (p=009). Possible, probable, and

definite CCAS were diagnosed in 2, 1, and 10 patients, respectively. Patients discharged home

showed better SARA and FIM/BI scores but similar CCAS-S scores compared to those

discharged to rehabilitation hospitals.

Conclusion: CCAS along with impaired executive and language functions is frequently

observed in patients with acute cerebellar stroke; however, impaired motor function, and not

CCAS, influences the outcome.

### Introduction

The cerebellum influences motor functions, such as walk, balance, and coordinated movement; however, until recently, its function in language, cognition, and affect has not received much attention [1]. In the 1980s, Schmahmann [2] defined a new clinical symptom, cerebellar cognitive-affective syndrome (CCAS), a cognitive impairment as a result of damage to the cerebellum. CCAS is characterized by four domains: executive dysfunction, visuospatial cognitive impairment, language dysfunction, and affective disorders. The connection between the cerebellum and cognition has become clearer with advances in research related to anatomical aspects of CCAS, functional imaging of healthy individuals, neuropsychological aspects of patients with cerebellar lesions. In stroke patients, the incidences of cognitive impairment and personality disorders are high at 86% and 64%, respectively [3]. However, owing to the low awareness of CCAS in clinical practice, mild cognitive dysfunction is often overlooked [4]. This can be attributed to the absence of a strict definition or diagnostic model for CCAS, leaving the diagnosis at the clinician's discretion, usually based on a comprehensive neuropsychological examination. In addition, the wide variety of CCAS symptoms require extensive and time-consuming assessment. Many studies have identified efficient assessment methods, however, they vary across studies and are inconsistent [5–7]. In 2018, Hoche et al. [8] developed the CCAS Scale (CCAS-S), a screening test for CCAS, that consists of 10 neuropsychological items and requires 12-15 min for assessment. In recent years, the number of studies using the CCAS-S has increased, but most

have been conducted in patients with spinocerebellar ataxia or Friedreich's ataxia (FRDA) [9,

10]. In contrast, very few studies utilizing the CCAS-S in acute stroke patients have been

conducted, and only one has investigated the prevalence of CCAS and utility of CCAS-S in

stroke patients [11]. Therefore, this study aimed to investigate the characteristics of CCAS in

acute cerebellar stroke patients using the CCAS-S. In addition, we investigated relationship

between the CCAS-S and physical function, activities of daily living (ADL), length of hospital

stay, and outcome.

Methods

**Patients** 

In this study, acute stroke patients who were hospitalized at Steel Memorial Yawata Hospital,

Japan within seven days of stroke onset between April 2021 and April 2023 and met the

following criteria: (1) first-ever stroke; (2) computed tomography (CT) or magnetic resonance

imaging (MRI) showing cerebral infarction or hemorrhage confined to the cerebellum; and (3)

independent ADL without dementia before stroke onset were included. The exclusion criteria

were: (1) lesions other than those in the cerebellum and (2) a history of neurological disease or

mental disorder. Age-and sex-matched healthy patients with independent ADL and normal

cognitive function were recruited as controls.

**Ethical Approval** 

In accordance with the Declaration of Helsinki, this study was accepted by the Ethics Review

Committee of Steel Memorial Yawata Hospital (approval number 20-62-02), and careful

consideration was given to the handling of personal information. In addition, written informed

consent was obtained from all patients before their participation in the study.

**Statements and Declarations** 

The study report was organized according to the Strengthening the Reporting of Observational

Studies in Epidemiology (STROBE) statement [12].

**Assessment** 

The CCAS-S, Mini-Mental State Examination (MMSE), and Scale for the Assessment and

Rating of Ataxia (SARA) were measured a week after stroke onset. Additionally, Functional

Independence Measure (FIM) and Barthel Index (BI) at discharge, length of hospital stay, and

outcome (discharge destination: home or rehabilitation hospital) were evaluated.

The CCAS-S consists of 10 test items scored from 0 to 120 points, with a cutoff value of 82

points [8]. For each item, a cutoff value was established, and possible (sensitivity, 95%;

specificity, 78%), probable (sensitivity, 82%; specificity, 93%), and definite CCAS (sensitivity,

46%; specificity, 100%) were defined as one, two, and three or more failed items, respectively.

The SARA consists of eight items, ranging from 0 for no ataxia to 40 for severe ataxia [13] and

is useful for assessing the severity of stroke-related ataxia [14]. Each item was assessed as

previously described [8, 13].

**Statistical Analysis** 

Data are presented as median with interquartile range (IQR) or as frequencies and percentages.

The Mann–Whitney U test was used to compare CCAS-S scores and other variables between

with acute cerebellar stroke patients and healthy controls. For the analyses of respective

CCAS-S item, in addition to the original cutoff value, the first quartile of the healthy controls

was used as the cutoff value as our patients were older than those in the original CCAS-S study

[8]. Additionally, we compared these variables between patients discharged to their home and

those discharged to a rehabilitation entre. SPSS Statistics (version 23, IBM, Armonk, NY,

USA) was used for statistical analysis. A p<0.05 was considered statistically significant.

**Results** 

During the research period, 301 acute stroke patients were admitted to our hospital, 14 of

whom met the inclusion criteria. After excluding one patient as their assessment was impeded

due to comorbid acute myocardial infarction, thirteen cases were included in the final analysis.

All the patients underwent rehabilitation during hospitalization.

Patient characteristics of both the study groups are shown in Table 1. The median age was 75 years (IQR:73–79). Cerebellar lesions were ischemic in seven, hemorrhagic in six, left-sided in five, right-sided in seven, and bilateral in one patient. The affected vascular territories were the superior cerebellar artery (SCA) in 8 cases, the anterior inferior cerebellar artery (AICA) in 1 case, and the posterior inferior cerebellar artery (PICA) in 4 cases. A week after the onset, the median CCAS-S, MMSE, and SARA score was 72 (IQR: 66–80), 28 (IQR: 26–29), 6 (IQR: 2–15), respectively. At discharge, the median FIM and BI was 96 (IQR: 85–113) and 80 (IQR: 70–100), respectively. The median hospitalization days was 18 days (IQR: 13–21). Nine patients were directly discharged from the hospital and four were transferred to a rehabilitation centre.

CCAS in acute cerebellar stroke

Comparison of CCAS-S results with those of healthy controls is shown in Tables 1 and 2. All patients scored above the cutoff (23/24) on the MMSE; however, 11/13 (84.6%) scored below the cutoff (82 points) on the CCAS-S [8]. The median number of failed items per patient was four (IQR: 3–5). Consequently, 2, 1, and 10 patients were diagnosed with possible. probable, and definite CCAS, respectively. Frequently failed items were phonemic fluency (10 cases), verbal recall (nine cases), category switching (eight cases), semantic fluency (seven cases), and

similarity (six cases). In contrast, the digit span forward, cube drawing, and digit span

backward were less common (3, 2, and 1 case, respectively), and no patient was below the

cutoff for Go-No-Go and Affect.

A comparison of acute cerebellar stroke patients and healthy controls is shown in Table 2. In

terms of CCAS-S scores, acute cerebellar stroke patients showed significantly lower values for

total (p=0.004), semantic fluency (p=0.008), category switching (p=0.001), and similarities

(p=0.009) (Figure 1) than controls. However, there were no significant differences in phonemic

fluency (p=0.483) or verbal recall (p=0.756).

**CCAS** and lesion location

Table 3 shows the lesion location and CCAS-S results for each patient (failed items, left:

original cutoff; right: first quartile of controls as the cutoff). In four patients with total CCAS-S

scores above 80, one and three patients were affected in vascular regions of SCA and non-SCA,

respectively. Among the four patients with total CCAS-S scores between 70 and 80, three and

one patients were affected in SCA and non-SCA, respectively. Among the five patients with

total CCAS-S scores below 70, four and one patients were affected in SCA and non-SCA,

respectively. Patients with lower total CCAS-S scores were more likely to have SCA lesions. In

other words, SCA lesions tended to have lower total CCAS-S scores than the AICA/PICA

lesions. In terms of cerebellar segmentation, SCA territory stroke caused more damage to the

dentate nucleus (DN), whereas PICA territory stroke caused more damage to lobes VII and

VIII.

**CCAS** and outcome

Table 4 lists comparison of scores with the outcome. There were no significant differences in

age (p=0.35), CCAS-S score (p=0.67), MMSE score (p=0.85), and hospitalization days

(p=0.16) between the home discharge and transfer groups. However, the SARA (p=0.005),

discharge FIM (p=0.003), and discharge BI (p=0.002) scores were significantly lower in the

transfer group than in the home discharge group. There was no significant correlation between

CCAS-S and SARA scores (r=0.233) (Figure 2).

Discussion

This study investigated the characteristics of CCAS in patients experiencing their first acute

cerebellar infarction. Based on the CCAS-S, 11/13 patients (84.6%) showed cognitive

impairment due to cerebellar lesions; however, their MMSE score was within the normal range.

The most frequently failed items in the CCAS-S were semantic fluency, category switching,

and similarities compared with age-matched controls, and CCAS was more severe in SCA

territory stroke than in AICA/PICA stroke. Despite the high frequency of CCAS in acute

cerebellar stroke, it did not affect the outcome.

The CCAS-S is useful as a screening assessment for CCAS associated with cerebellar lesions

[8]; however very few studies have used CCAS-S in patients with stroke, and only one study

has reported the CCAS prevalence and used CCAS-S in acute stroke patients [11]. In a study

conducted by Abderrakib et al., 25 patients with acute cerebellar stroke were evaluated with

CCAS-S within one week of onset, and 1, 3, and 21 patients were classified as having possible,

probable, and definite CCAS, respectively. In our study, 10/13 (76.9%) patients had definite

CCAS, indicating that cognitive dysfunction is common in acute cerebellar stroke patients.

Considering that the MMSE scores were normal in all our patients, the CCAS-S was useful in

detecting CCAS.

Using the original cutoff value [8], the most frequently failed items were phonemic fluency

(77%), verbal recall (69%), category switching (62%), semantic fluency (54%), and

similarities (46%). However, this cutoff value has been criticized for not considering age and

education [15]. Therefore, in this study, we compared these results with those of age-matched

healthy controls. The CCAS-S items showing abnormalities included category switching,

semantic fluency, and similarity. Low scores on the phonemic fluency and verbal recall items

may be due to advanced age. In a previous study by Abderrakib et al. [11], category switching

and backward digit span were the most commonly failed items, followed by phonemic fluency

and verbal recall. The mean age was 64 years, which is younger than that in our study, and the

results were based on the original cutoff value.

The advantage of the CCAS-S is that the severity and extent of CCAS can be compared between studies. In a study on spinocerebellar ataxia type 3, 22 patients with age of  $51.9 \pm 10.0$ years were analyzed and the average total CCAS-S score was  $81.9 \pm 9.2$  [16]. Regarding spinocerebellar ataxia type 2, 64 patients with a mean age of  $48.77 \pm 12.02$  years showed a mean total CCAS-S score of 69.95 ± 13.48 [17]. Regarding chronic cerebellar stroke, 22 patients with age of  $47.27 \pm 13.10$  years showed a mean total CCAS-S score of  $88.18 \pm 2.88$ [18]. Considering the similar age of the patients in these three studies, CCAS might be most severe in spinocerebellar ataxia type 2 patients. This may be because the cerebellum and brainstem is affected in spinocerebellar ataxia type 2. Cognitive decline has been reported to occur even during the prodromal phase and is more pronounced in patients with severe motor activity in spinocerebellar ataxia type 2 [19]. The median total CCAS-S score for our patients was 72, which is similar to that of the spinocerebellar ataxia type 2 patients described above. Considering that the SARA score was higher in spinocerebellar ataxia type 2 patients than in our study, the similar total CCAS-S scores may be due to the advanced age of the patients. In the above three studies, age- and sex-matched healthy participants were independently examined and compared with a patient group to determine which CCAS-S items were impaired. The spinocerebellar ataxia type 3 study revealed five failed items, including affect [16], and the spinocerebellar ataxia type 2 study found 10 failed items, including affect [17]. The chronic cerebellar stroke study found abnormalities in nine items, excluding affect [18]. In congruence,

our study reported three failed items except for affect; degenerative diseases such as

spinocerebellar ataxia type 2 and type 3 are more likely impair the affect item than cerebellar

stroke. However, the use of independent healthy controls in each study may have introduced a

bias; therefore, it would be desirable to establish a worldwide reference value for each age

group.

The cerebellum is divided into 10 lobules based on the nomenclature introduced by Larsell [20],

with lobules I–V as the anterior lobe, lobules VI–IX as the posterior lobe, and lobule X as the

flocculonodular lobe. Lobule VII is further divided into lobules VIIa (crusts I and II) and VIIb.

Previous studies have shown that the foci of CCAS are located in the posterior lobe (lobules

VII and VIII, and mainly in the DN); specifically, in lobules VII and VIII for executive

function, in VIIa and right lobule VIII for visuospatial cognition, and in the right VIIa and

lobule IX for language function [21]. Other studies have indicated that the right posterolateral

region is responsible for CCAS [18]. In the present study, the DN and lobes VI, VII, and VIII

tended to be injured more frequently, supporting the results of previous studies.

The cerebrum and cerebellum are interconnected via neural networks. Strong connections have

been established between the cerebellum and various regions including the prefrontal cortex,

posterior parietal lobe, superior temporal lobe, and temporal lobe, indicating the cerebellar

involvement in higher cognitive networks [22, 23]. The association between the cerebellum

and brain can be categorized into motor and cognitive loop. In the context of CCAS, it is

believed that the condition arises from a disruption in the cognitive loop, specifically involving

the prefrontal cortex, bridge nucleus, cerebellar hemisphere/DN, and contralateral thalamus -

dorsomedial nucleus of prefrontal cortex [24, 25]. A study reported that cerebellar lesions

patients exhibited decreased cerebral blood flow and metabolism, particularly in premotor

areas contralateral to the lesion [26]. Furthermore, a SPECT study revealed that, in cases where

there was no damage to the brain regions under the tentorium, reduced blood flow in the

contralateral medial frontal lobe resulting from a cerebellar lesion could potentially account for

symptoms such as executive dysfunction, apathy, and impaired inhibition [27].

Although cognitive dysfunction and depression are known to affect outcomes after stroke

[28–31], whether CCAS affects the outcomes of acute cerebellar stroke has not been examined.

In our study, motor symptoms rather than CCAS were the factors affecting outcome; although

CCAS was detected by the CCAS-S, the MMSE was normal in all patients, reflecting that

cognitive impairment due to acute cerebellar stroke was not severe. In addition, studies of

spinocerebellar ataxia type 2 and FRDA have reported an inverse association between CCAS-S

and SARA. However, no significant correlation between CCAS-S and SARA was found in this

study. This may be partly because, unlike patients with degenerative diseases, patients with

cerebellar stroke experience only partial damage to the cerebellum.

There are a few limitations in this study. Firstly, the study was conducted at a single center and

the number of patients was small. Secondly, the CCAS-S was administered in Japanese; thus, it

could not be validated. Thirdly, the CCAS-S score of patients with acute cerebellar stroke was

compared with healthy controls, as in previous studies.

**Conclusions** 

Despite the high frequency of CCAS in acute cerebellar stroke patients, it did not affect the

outcome. In addition, the CCAS-S was useful in patients with acute cerebellar infarction, as

most patients with acute cerebellar infarction in the present study had clear CCAS. Future

studies should be conducted on a larger scale to examine the relationship with other

neuropsychological tests. And since this study was conducted during a short acute period, the

long-term prognosis of CCAS should also be investigated.
