

1 **Learning interventions and training methods in health emergencies: A**
2 **scoping review**

21 **Abstract**

22 **Background**

23 Keeping the health workforce and the public informed with the latest evolving
24 knowledge is critical to preventing, detecting and responding to infectious
25 disease outbreaks or other health emergencies. Having a well informed, ready,
26 willing, and skilled workforce and an informed public can help save lives, reduce
27 diseases and suffering, and minimize socio-economic loss in affected
28 communities and countries. Providing support and opportunities for learning in
29 health emergencies is much needed for capacity building. In this paper,
30 ‘learning intervention’ refers to the provision of ad-hoc, focused, or personalized
31 training sessions with the goal of preparing the health workers for emergencies
32 or filling specific knowledge or skill gaps. We refer to ‘training methods’ as
33 instructional design strategies used to teach someone the necessary
34 knowledge and skills to perform a task.

35

36 **Methods**

37 We conducted a scoping review to map and better understand what learning
38 interventions and training methods have been used in the different types of
39 health emergencies and with whom. Studies were identified by searching
40 Pubmed/Medline, Embase and consulting with experts.

41

42 **Results**

43 Of the 319 records that were included, contexts related to COVID-19, disasters
44 in general, Ebola and wars were most frequently covered. Four topic areas

45 were identified: Knowledge acquisition, Emergency Plans, Impact of the
46 learning intervention, and training methods. Much of the evidence was based
47 on observational methods with few trials, which likely reflects the unique context
48 of each health emergency. Evolution of methods was apparent, particularly in
49 virtual learning. Learning during health emergencies appeared to improve
50 knowledge, management, quality of life, satisfaction and clinical outcomes.

51

52 **Conclusion**

53 This is the first scoping review to map the evidence, which serves as a first step
54 to develop urgently needed global guidance to further improve the quality and
55 reach of learning interventions and training methods in this context.

56

57 **Introduction**

58 Learning in health emergencies can provide a foundation to build capacity for
59 emergency preparedness and response specific to different health
60 emergencies(1) (e.g., biological, environmental, armed conflicts, deliberate acts
61 of terrorism, industrial accidents), especially in low and middle income countries
62 where health systems need to be further strengthened(2). A ready, willing, and
63 able workforce is required that can be called upon in health emergencies to
64 help save lives, reduce diseases and suffering, and minimize socio-economic
65 loss in affected communities and countries. In today's interconnected
66 landscape, an educated public is also needed to champion measures for a
67 strong emergency preparedness and effective response(1). This can be
68 achieved by guiding, standardizing and facilitating the delivery of life-saving
69 knowledge, first to frontline workers in health emergencies and second to the

70 public. Learning paves the way for strengthened health literacy and
71 understanding of health communication which, in turn, bolsters awareness and
72 support for measures needed during health emergency events(3).

73

74 The World Health Organization (WHO) is developing guidance on *Learning in*
75 *Emergencies* to provide evidence-based interventions, training methods and
76 tools for professionals, communities and institutions to ensure quality learning
77 provision and knowledge dissemination during health emergencies. The primary
78 reason to develop the guidance was due to lessons learned from the COVID-19
79 pandemic The COVID-19 pandemic presented unique circumstances and
80 global challenges when it became clear that ‘just in time’ learning was required
81 to retrain and upskill large numbers of health professionals in order to launch
82 an effective response. For example, new methods and approaches for testing
83 and surveillance at scale were proven essential to operate at the national,
84 regional, and local level, which involved the need for rapid dissemination and
85 uptake of new learning so that the entire health, social care and education
86 workforce were equipped with relevant knowledge and skills to respond
87 effectively, especially in low and middle income countries(4, 5).

88

89 The COVID-19 pandemic also prompted the need to integrate effective risk
90 communication strategies to tackle the evolving information needs and
91 misinformation or infodemic (i.e., short for information epidemic) (6) and
92 potential spread of misinformation that could negatively impact on efforts to
93 develop and deliver learning interventions to professionals, communities and
94 institutions(7). From the onset of the COVID-19 pandemic, WHO committed to

95 knowledge dissemination to frontline health workers, governmental and non-
96 governmental actors, policy makers, capacity builders and trainers as well as
97 the public via its low-bandwidth adjusted online platform. In addition to regular
98 updates as more research emerged, WHO intended to regularly assess the
99 effectiveness of this initiative - that is knowledge dissemination through its
100 online platform (OpenWHO) on all the aspects of tackling the pandemic and
101 then including other health emergencies. Key findings indicated that employing
102 strategies to make learning more equitable and accessible can yield better
103 results in terms of outreach, and that learning production must be targeted for
104 real-time events in languages spoken in outbreak impacted areas(8).
105 Nonetheless, learning design based on inclusive pedagogy and learning
106 sciences, while being cognizant of barriers, such as poor internet connection or
107 limited digital literacy, to access learning can optimize learning experience(9).

108

109 The second rationale for developing the Learning in Emergencies guidance is
110 that various current guidelines tackled adult learning partially or in one
111 dimension. WHO itself has published several frameworks and
112 recommendations. However, none of these related guidelines covers Adult
113 Learning in Health Emergencies. The Learning in Emergencies guidance will
114 address a priority issue cited during the World Health Assembly (WHA), to help
115 WHO support governments in their health-related capacity building and to reach
116 health learning goals. The *Learning in Emergencies* guidance will encompass
117 the full scope of learning as preparedness, readiness, response and resilience
118 actions in capacitation for public health emergencies.

119 This scoping review of literature was undertaken to inform further
120 methodological choices and the commissioning of subsequent systematic
121 reviews to feed into the Guidance development process.

122 **Objectives**

123 The objective of this scoping review was to map the existing evidence (including
124 qualitative, quantitative and mixed-methods peer-reviewed publications, grey
125 literature studies, systematic and other types of literature reviews and
126 qualitative evidence synthesis) that has been published on the topic.

127 **Target population**

128 The target population included experts and individuals in need of health
129 information, such as health workforce, experts and volunteers, national
130 institutions and ministries (governmental and non-governmental actors),
131 policymakers, academia, capacity builders and trainers, citizens and affected
132 populations.

133 **Phenomenon of interest**

134 The phenomena of interest were classified as learning interventions as
135 specified below and health emergencies including the follow types: Biological,
136 Environmental, Armed conflicts, Deliberate acts of terrorism and Industrial
137 accidents.

138 **Intervention/Exposure**

139 Learning interventions included:

- 140 ● Continuous learning for professionals preparing for or acting in health
141 emergencies
- 142 ● Adult learning interventions and methods in emergency situations
- 143 ● Professional education, training and learning
- 144 ● Real time, just in time learning
- 145 ● Knowledge and learning transfer from an expert organization
- 146 ● Learning readiness in anticipation and preparedness for any health
147 hazard

148 **Methods**

149 The methodology was guided by Arksey and O'Malley's (8) five stage
150 framework for scoping reviews: identifying the research question(s), identifying
151 relevant studies, charting the data, collating, summarizing, and reporting the
152 results. In addition, principles of mixed-methods framework synthesis were used
153 to manage diverse study designs and help extract, map, chart, categorize and
154 summarize study findings(10). The review was reported using the relevant
155 domains of the Preferred Reporting items for Systematic Review and Meta-
156 Analysis for scoping reviews (PRISMA-ScR)(11).

157 A priori protocol was developed and published on the Open Science
158 Framework: <https://doi.org/10.17605/OSF.IO/5BK9R>.

159 **Selecting relevant studies**

160 Searches were carried out between February 2nd and February 28th 2023, and
161 covered sources from 2003 to the present. Key search terms were identified
162 within three PICO question components (Table 1 Supplementary material).
163 These terms were also used to identify relevant documents from which Medical
164 Subject Heading (MeSH) or other database-specific terms and keywords could
165 be extracted.

166 Key terms were searched using a free text strategy in the titles and abstracts.
167 This allowed having a broader, more sensitive approach and eliminated the
168 possibility of relevant items being missed. MeSH was applied to give more
169 specific results.

170 The following databases were searched: Pubmed/Medline and Embase, using
171 predefined combinations of key search terms. To prioritize LMICs, filters of the
172 selected databases were applied. The search strategy and search words are
173 annexed (Table 2 Supplementary material).

174 Search results were scanned for relevance and those meriting further
175 examination were imported into Rayyan for further consideration. The search
176 and initial screening were undertaken by GB and studies checked by other
177 authors were included. Citations were excluded if they focused exclusively on
178 academic settings (early education through medical school), did not have a
179 learning intervention (for example studies addressing knowledge in unprepared
180 professionals) or were not contextualized during or for a health emergency.
181 News (or announcements) as well as protocols of studies/reviews that had not
182 been completed, and other irrelevant document types were excluded, as well as
183 non-peer reviewed articles.

184 Titles and abstracts were screened against the following inclusion criteria: (1)
185 published between 2003 and 2023; (2) abstract and title written in English; and
186 (3) presenting data on research question (date, methodology, with focus on
187 geographical low and middle income context, type of learning/intervention and
188 for whom, type of emergency), (4) peer-reviewed sources only. Then, screening
189 of full texts of pre-selected citations against above-mentioned criteria was
190 performed. At this stage full texts written in other UN-languages and Portuguese
191 language were included as well. Processes were undertaken by GB and
192 crossed checked by co-authors. We did not undertake double blind processing.

193 **Charting the data**

194 All the included evidence was extracted into an Excel spreadsheet and included
195 citations were exported into Endnote. Data were extracted systematically using
196 a standardized form that included information on the period of study, location,
197 study population, design, research questions, key findings, and conclusions.

198 At the mapping stage we did not focus on the findings and conclusions as not
199 all studies were selected for inclusion in the systematic reviews that will
200 subsequently be commissioned.

201 **Collating, summarizing and reporting results**

202 The charted data (in the form of an evidence map) were then further analyzed,
203 grouped and sorted guided by the review aim and objectives. We specifically
204 focused on developing an understanding of the available literature on the
205 phenomena of interest and created visual displays and tables. We also
206 identified and described four major topic areas.

207

208 **Results**

209 A total of 6411 articles were imported into Rayyan, of which 1656 were
210 duplicates and 4317 were excluded based on a brief scan of titles and
211 abstracts. The remaining 446 documents were sorted by full-text access. One
212 hundred and thirteen articles were excluded for not being relevant and fourteen
213 did not have full text access. As shown in Fig 1, 319 articles met the inclusion
214 criteria and were included. Full description of included studies can be found in
215 Table 3 of the Supplementary material.

218 **Overview of study characteristics**

219 Most of the articles were descriptive studies on experiences in different
220 countries(12-176), followed by before-after studies(169, 173, 177-260). Also,
221 we found 19 randomized controlled trials(261-279), 14 cross-sectional
222 studies(280-293), 12 observational studies(294-305), 7 reviews(306-312), 5
223 qualitative studies(313-317) and 3 opinion pieces(318-320). (Table 4
224 Supplementary material)

225

226 **Emergency context**

227 COVID-19, Disasters in general, Ebola and wars were the most frequent topics.
228 This is related to the publication dates because most studies have been

229 published during these health emergencies (Ebola, 2015 and COVID-19 during
230 2020, 2021 and 2022) (Fig 2)

232

233 **Location**

234 Most studies were conducted in China (mainly due to COVID-19 and
235 Earthquakes), India and South Africa. A large number of the learning evidence
236 was also derived from several countries in Africa.

237

238 **Interventions, learning methods and tools**

239 Different types of learning interventions are described across the studies. The
240 majority of the studies used in-person training as an intervention(12, 14, 18-22,
241 30, 33, 34, 37-42, 46, 48-50, 52, 55, 61, 66, 67, 70, 72, 73, 75-78, 80-82, 87,
242 93, 97-100, 104, 108, 109, 111, 118, 120, 122-126, 128-131, 133, 135, 136,
243 138-141, 143, 144, 146-151, 153-159, 161, 165, 172, 174, 178-182, 184, 185,
244 187-189, 193, 195, 197, 198, 200, 206, 210, 212, 214-217, 220, 222, 223, 225,
245 228, 229, 232, 234, 237, 238, 243-245, 247-254, 257, 259, 261, 262, 264, 266,
246 268, 269, 271, 273, 275, 277, 279, 282, 288-290, 292, 294, 295, 298, 302, 313,
247 315, 317, 318, 320, 321), followed by virtual training.

248 Lectures, discussions, role playing, 'hands on' basic skills training, materials,
249 videos and simulations were used as in-person modalities. Additionally, 9
250 studies(26, 83, 85, 89, 117, 224, 263, 297, 307) suggested a professional
251 approach (such as Masters degrees and post graduate studies in universities)
252 as a way of preparing healthcare workers for health emergencies.

253 Within the virtual modalities, studies describe the use of Telemedicine(91, 92,
254 94, 96, 192, 283, 289), Massive Online Open Courses (MOOC)(28, 166, 208,
255 280, 296), Social Media(15, 265, 281, 284), Gamification(183, 274), Virtual
256 simulation(88, 272), Artificial Intelligence(86, 300) and Mobile devices(147,
257 202).

258 A few studies used blended format, usually workshops followed by virtual
259 training (in-person and virtual)(35, 44, 54, 63, 64, 101, 126, 127, 152, 191, 241,
260 270, 301, 318-320) (Fig 3)

263 **Learners**

264 Most of the learning interventions were directed at the health workforce such as
265 medical doctors, nurses, dentists, medical students, laboratory staff and
266 paramedical students. Some learning interventions were also aimed at military
267 personnel, citizens and affected population, volunteers, academia and national
268 institutions. (Table 5 Supplementary material)

269

270 **Learning content**

271 Curricula content was mostly focused on disease and disaster management.
272 Some content was about personal safety and security(48, 49, 54, 203-205, 207,
273 208), waste management(65, 211, 298), mental health(94, 104, 165, 171, 176,
274 212, 220, 234, 258, 276, 292), infection control and prevention(138, 167, 240,
275 263, 301), pest control(64, 65, 69, 211, 215, 298), triage(15, 61, 90, 93, 206,
276 270, 289) and stress management(30, 181, 269). A smaller number of curricula
277 included surgical training(97, 98, 164, 322), time management(222),

278 stigma(268), language and local culture(19), humanitarian law and
279 leadership(101), chemical incidents(213) and dealing with ethical dilemmas(71).
280

281 **Major topic areas**

282 By grouping the studies, four major topics were identified:

283 1) Knowledge acquisition: Articles that analyzed how much knowledge was
284 acquired during learning interventions as a way to assess effectiveness
285 of the intervention methods.

286 2) Emergency Plans: Learning recommendations focusing on how
287 governments and institutions should be prepared to face health
288 emergencies.

289 3) Impact of the learning intervention: Articles that analyzed how learning
290 and training during health emergencies had an impact on trainees and
291 affected populations.

292 4) Training method: Articles that focus on different learning methods and
293 tools that can be used for knowledge transfer during a health emergency.
294

295 The distribution of the major topics across the evidence is shown in Fig 4.

296 The largest number of articles found (n = 101) correspond to “Knowledge
297 evaluation”, followed by articles corresponding to “Emergency Plans” (n=84)
298 and “Training Method” (n=68). Finally, “Impact” was analyzed in 66 studies.

301 **Knowledge acquisition**

302 For knowledge evaluation, 101 studies(17, 18, 33, 41, 42, 48, 65, 79, 90, 94,
303 95, 97, 99, 100, 103, 107, 109, 111, 116, 155, 163, 168, 169, 172, 175, 177-
304 180, 182, 185-187, 189, 194-198, 200, 202, 205-207, 211, 212, 214, 216, 217,
305 219, 221, 223-228, 230-235, 237, 239, 243-245, 248, 249, 252, 253, 256, 258,
306 259, 264-266, 268, 270, 272, 273, 278, 279, 283, 284, 286, 288-290, 292, 294,
307 298, 300-302, 304, 305, 315, 317) provided information about how a learning
308 intervention during a health emergency can impact the knowledge of trainees.
309 According to the results of these studies, learning interventions were helpful for
310 improving knowledge, preparedness and confidence of trainees. On the other
311 hand, improved knowledge had a positive impact on diagnosis, and health
312 outcomes such as rate of infected patients.

313

314 **Emergency Plans**

315 84 studies(25, 35, 37-39, 43, 49-51, 53, 54, 56, 59, 60, 62, 63, 66, 68, 70, 72-
316 74, 77, 80-82, 85, 102, 106, 112, 113, 117, 118, 120, 121, 125-128, 130-134,
317 136, 141, 146, 148, 149, 151, 154, 156-158, 161, 162, 164, 165, 171, 173, 174,
318 176, 183, 190, 238, 247, 255, 262, 267, 274, 285, 287, 306-311, 316, 318, 319,
319 323-325) described the use of learning interventions as part of their emergency
320 plans from countries and health institutions: 65 are reports, 6 are reviews and
321 the rest of the evidence are randomized control trials, before and after studies,
322 opinions, cross-sectional and qualitative studies. The evidence described how
323 countries and hospitals should train healthcare workers, military, citizens and
324 students in environmental emergencies (earthquake, tsunami, typhoons and
325 disasters in general), biological emergencies (COVID-19, HIV, syphilis, Ebola,
326 Cholera and Zika) and armed conflicts (war and chemical emergencies). The

327 objective of this training was to prepare different populations for a future
328 emergency and this explains why these interventions were not offered during an
329 emergency.

330 As for the RCT, Ma et al(274) compared the use of a gaming technique versus
331 a disaster simulation and Lee et al(267) compared two video techniques: basic
332 response to a fire versus generic volcanic emergency. In both studies,
333 knowledge competence and response were statistically higher in the
334 intervention groups (gaming technique and video response to fire
335 emergencies).

336

337 **Training Methods**

338 On training methods, 68 studies(12-16, 19-24, 26-29, 31, 32, 36, 40, 44, 46, 47,
339 52, 57, 58, 61, 64, 67, 78, 83, 84, 86, 87, 89, 92, 96, 110, 122-124, 137, 140,
340 144, 145, 147, 152, 160, 166, 167, 169, 192, 203, 213, 215, 246, 250, 254, 260,
341 293, 296, 297, 299, 303, 312, 320, 321, 326) focused on describing different
342 training methods that can be used during a health emergency. 15 studies
343 described in-person training methods, and the rest of them used a virtual
344 training method such as simulation, telemedicine, MOOC, videos or artificial
345 intelligence.

346 MOOCs were used for cholera(28) and COVID-19(166, 296, 314), and all of
347 these studies showed that this method can be useful to disseminate trustworthy
348 information in low and middle-income countries and fill the gap of information
349 during health emergencies.

350 Artificial intelligence(86) was used during COVID-19 to help radiologists to
351 efficiently and timely diagnose the COVID-19 suspected patients.

352 Videos(203) were implemented in Burkina Faso during a dengue epidemic. This
353 study concluded that videos are effective for knowledge transfer and training
354 health professionals, however the narrative genre of the videos can influence
355 knowledge acquisition.

356

357 **Impact of learning interventions**

358 Two studies measured impact as satisfaction in citizens and affected
359 populations: One of them (261) trained parents of high-risk children about
360 malaria prevention using an in-person technique. Participant satisfaction was
361 assessed using a qualitative approach, however the main challenge reported
362 was adherence to the course. The other study(184) reported on in-person
363 training of Syrian refugee mothers of children with autism about overcoming
364 trauma by war. Satisfaction was analyzed and improvements were
365 recommended by the attendees, such as using online methods during the
366 course.

367 In the rest of the evidence that reported satisfaction as an outcome, it was
368 measured as self-perceived, as mental health status of healthcare workers,
369 well-being and preparedness.

370 27 studies analyzed how training during a health emergency impacted on the
371 quality of life of healthcare workers, citizens and volunteers. The endpoints
372 included: acceptability(295), anxiety(209), confidence(193), mental health (45,
373 199, 220, 222, 276, 313), preparedness(135, 139, 142, 143, 153, 159, 257,
374 269, 277, 327), satisfaction(30, 170, 198, 328-330), community cohesion(269)
375 and social adaptation(291). Most of the learning interventions were given after
376 health emergencies occurred. This would be related to the fact that quality of

377 life of the workers would be affected after the occurrence of these events. Two
378 studies(193, 209), however, analyzed how quality of life could be improved by
379 receiving prior training.

380

381 **Discussion**

382 We found 319 studies that analyzed different learning interventions and training
383 methods during health emergencies. Information about virtual training (including
384 online platforms, artificial intelligence, MOOC, the use of mobile devices, social
385 networks and telemedicine) arose mainly during the COVID-19 pandemic.
386 Before the pandemic, most of the studies focused on in-person training. This
387 change could be explained by technological advancements, the need for new
388 information that had to be updated quickly and also because of social
389 distancing recommendations. Of note, access to new technologies was scaled
390 up after 2020 as the pandemic accelerated this process.

391 Many studies analyzed the impact of training on clinical outcomes such as
392 patient survival (19, 215), rate of workers infection(33, 41, 87), number of
393 hospitalizations(99, 299) and number of correct diagnoses(86, 300). These
394 findings will be important when developing guidance since these outcomes can
395 be useful for decision making and selection of appropriate learning interventions
396 and methods. Finally, the importance of coordinated work between different
397 institutions(16, 25, 28, 38, 112, 238, 285), universities, governments and non-
398 governmental organizations emerges was noted in several studies. How best to
399 foster coordinated work between institutions may be of great interest for future
400 research.

401 We also found some potential evidence gaps that are worth investigating in
402 future research studies. First, there is limited evidence on the content of
403 learning interventions, especially regarding ethical dilemmas and how to solve
404 them (71). Also, we found a scarcity of evidence on end-of-life management
405 during emergencies such as end-of-life care and managing deceased people.
406 Subsequently, we identified other evidence gaps such as lack of robust
407 evaluation of the effect of learning transfer, as most studies rely on self-reports
408 (also referred as post-training 'smile-sheets') to evaluate transfer of
409 learning(331-333). These studies provide limited actionable data to determine
410 the effectiveness of training programs, as getting a favorable reaction from
411 learners does not guarantee that learning transfer has been achieved(334).
412 Further, too little research has examined the accountability of trainers for
413 transfer in terms of using transfer-enhancing strategies, and how trainers are
414 being evaluated(335)

415 In addition, most studies focused on information dissemination to build skills
416 rather than employing evidence-informed training methods for performance
417 improvement at the time of emergencies. Poor learning design and evaluation
418 methods can result in learning being wasted(331). Lastly, there was a lack of
419 evidence on managing emergencies through teamwork, effective
420 communication, and stress management. After all, factors such as stress, poor
421 team dynamic due to hierarchical issues, and poor communication can lead to
422 morbidity or mortality.

423

424 **Limitations and strengths**

425 This scoping review has potential limitations and strengths. One such limitation
426 was the time constraint to deliver the scoping review quickly. Despite following
427 standard scoping review processes, the search was not as robust as when
428 performing a systematic review. However, once the *Learning in Emergencies*
429 guidance is under way and new systematic reviews on the subject are
430 commissioned, new evidence may arise to complement these findings. Scoping
431 reviews are limited in purpose, but often fulfill a vital first step in establishing the
432 amount and type of evidence from which subsequent systematic reviews can be
433 commissioned with greater certainty of feasibility. The scoping review followed
434 an a priori protocol and was undertaken by a diverse team with varied expertise
435 in the topic and scoping review methods.

436

437 **Conclusion**

438 Research on learning and learning dissemination during health emergencies
439 has revealed considerable advancements, particularly in virtual learning.
440 Overall, it is evident that learning during health emergencies appears to improve
441 knowledge, management, quality of life, satisfaction and clinical outcomes. All
442 the information provided by this review can give decision makers tools to select
443 different types of learning interventions and methods for healthcare workers,
444 volunteers, military, civilians and governments. This scoping review may also be
445 useful for future research to address the identified evidence gaps.

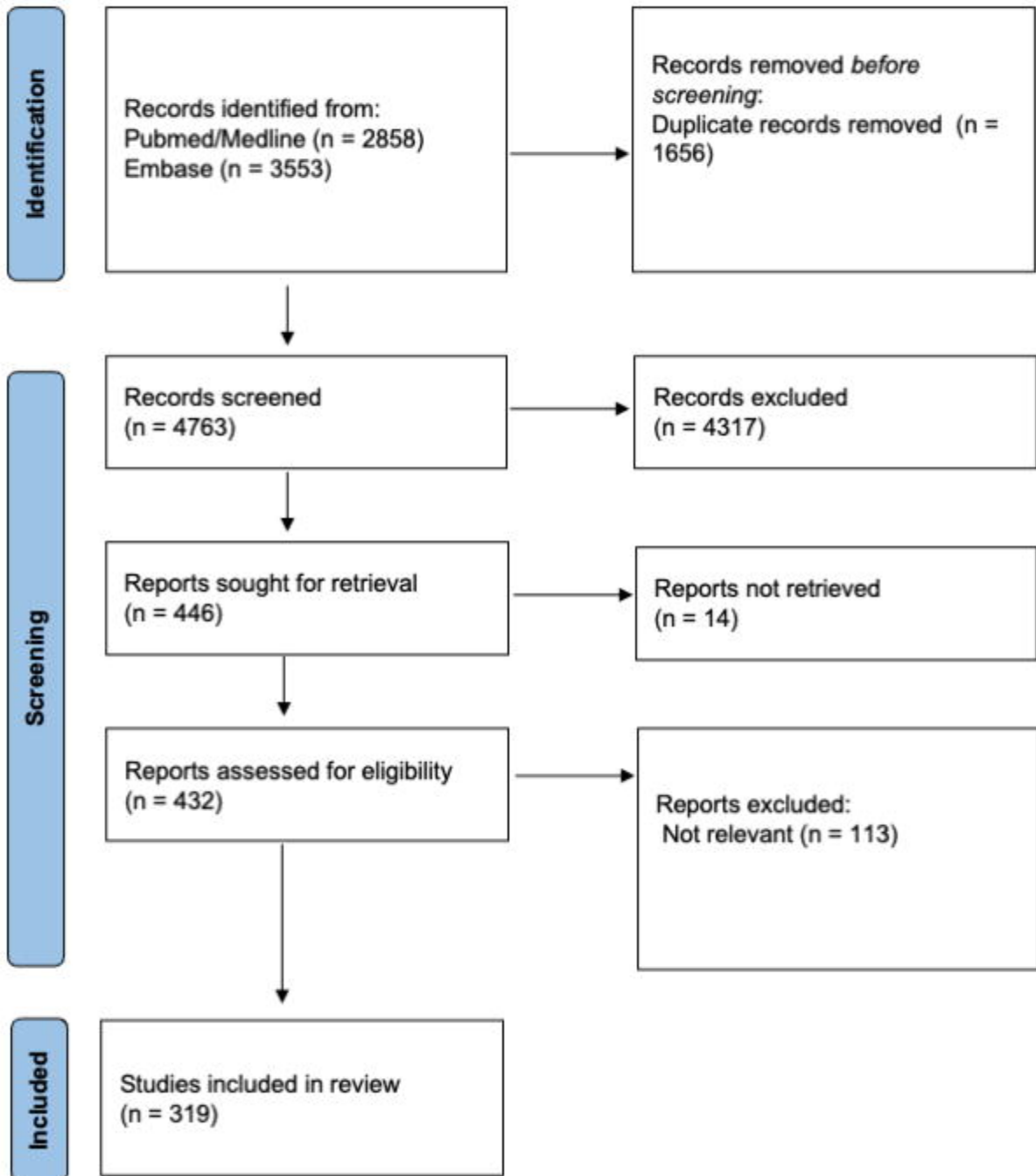

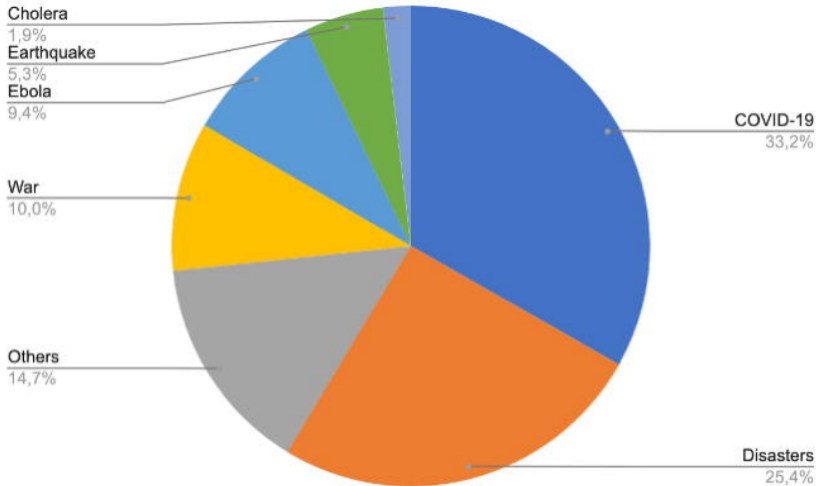

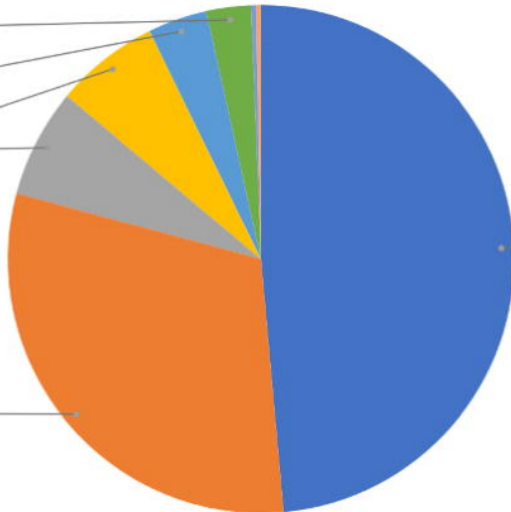
