

1 **Lessons learned from operationalizing the integration of nutrition-specific and nutrition-**
2 **sensitive interventions in rural Ethiopia**

12 Abstract

13 Background

14 Undernutrition reduction requires coordinated efforts across sectors to address its causes. A
15 multisectoral approach is important in diagnosing the problem and identifying solutions that
16 would be implemented across different sectors.

17 The study aims to explore the experience of health and agriculture extension workers in
18 integrating nutrition services provided to households with children under two years of age at
19 community level.

20 Methods

21 A qualitative study has been conducted in agrarian areas of Ethiopia in 2021 at the end of a
22 large intervention program to reduce stunting. In total, 28 key informant interviews were
23 conducted with health- and agriculture-extension workers and mothers. A framework analysis
24 approach was applied to manage and analyze data using NVivo version 12 software.

25 Results

26 Community-level joint intervention is a feasible approach to integrating nutrition services.
27 Farm gardening and cooking demonstrations were practiced jointly with extension workers and
28 households. Because of service integration, extension workers perceived an improved father's
29 role in supporting mothers in childcaring and feeding nutritious diets to children, and decreased
30 severe cases of undernutrition. Integration of health and agriculture sectors for nutrition
31 intervention was challenged by the high workload on extension workers, poor supervision and
32 leadership commitment, lack of appropriate agricultural inputs, and absence of clarity on sector-
33 specific roles. In some areas nutrition services are not owned by the health and agriculture
34 sectors, and it was overlooked.

35 Conclusion

36 Integrating existing community-level platforms are key entry points to address undernutrition
37 and promote key agriculture and health interventions in Ethiopia. Empowering extension
38 workers through training, monitoring, and supervision is part of ensuring the sustainability of
39 integration between sectors.

42 Introduction

43 Undernutrition including stunting, wasting, underweight and micronutrient deficiencies
44 plagued populations in low- and middle-income countries for decades and remains one of the
45 most pressing health problems. Young children and women of reproductive age are particularly
46 vulnerable because of their increased nutrient requirements, and, in case of women, their lower
47 social status, which limits their access to nutrient-rich foods [1]. The causes of undernutrition
48 are complex and affected by factors acting at different causal hierarchical levels [2]. The
49 political, economy, health, education, agriculture and food systems, water and sanitation, and
50 the environment are all determinants of maternal and child nutrition and health [3].
51 Undernutrition reduction requires coordinated efforts across sectors to address its underlying
52 causes [4, 5]. Addressing the problem of undernutrition needs the collaboration of multiple
53 sectors and a variety of stakeholders in governments, non-government organizations, and the
54 private sector [6]. Undernutrition reduction requires a departure from a health system-centered
55 approach of provision of nutritional services and nutrition-specific interventions only, to an
56 integrated approach that encompasses nutrition-sensitive, food systems-based approaches[7].
57 The framework of actions proposed by the UNICEF and the Lancet nutrition series recognizes
58 the needs for multiple actions that are at different levels from immediate, underlying to distal
59 [2, 8]. Interventions targeting the improvement of maternal and child nutrition and health act
60 on interlinked factors which influence each other. Nutrition-specific interventions address the
61 immediate causes of undernutrition and nutrition-sensitive interventions focus on the
62 underlying causes of good nutrition [9]. Both nutrition-sensitive and specific interventions
63 require an enabling environment, that encompasses actions addressing basic determinants of
64 undernutrition. Multiple actions to improve nutrition were undertaken over the recent years, the
65 most prominent is Scaling Up Nutrition which clearly underscores the necessity of actions

66 among all the stakeholders [10]. This approach puts nutrition at the core of each sector plan and
67 institutional effort.

68 However, systematic coordination between different sectors to achieve the objectives of
69 improved maternal and child nutrition is problematic, given the bureaucratic barriers that
70 characterize the administrative division of responsibilities among sectors. All sectors are
71 expected to be clear about what they can contribute to resolving malnutrition in a particular
72 context specific to their sector role. Agriculture, as an example of nutrition-sensitive
73 intervention, can potentially increase food availability, which would directly improve the
74 dietary accessibility leading to improved nutritional status of targeted populations. However, the
75 multiple factors that influence nutrition, the social dynamics within households that can result
76 in unexpected allocations of resources, and the many indirect ways that agriculture may impact
77 nutrition, require purposeful planning and careful consideration of how exactly program inputs
78 will lead to nutritional improvements. This complex relationships has consequently lead to
79 limited impact of nutrition intervention, because other determinants are not put in place at
80 different levels.

81 Ethiopia is one of the countries with the highest rate of undernutrition in sub-Saharan Africa.
82 The proportions of stunting, underweight and wasting among children under age of five years
83 are respectively 38%, 24% and 10% in Ethiopia [11]. Multiple efforts have been made to
84 implement the government commitment towards ending undernutrition. To reach this goal,
85 Ethiopia has demonstrated a strong policy commitment to nutrition through the development of
86 a multisectoral food and nutrition policy, which highlights the need to accelerate multi-sectoral
87 approaches [12]. Political willingness is an important factor that helps to implement effective
88 nutrition interventions [10]. However, the Ethiopian situation remains in its debuts with poorly
89 synchronized sectors of food, nutrition, agriculture, and health to prevent the problem of under-
90 nutrition. In Ethiopia, the presence of health and agriculture extension systems and frontline

91 workers at the community level is a good framework that facilitates the synergetic linkage of
92 nutrition within health and agriculture services [13] Additionally, existing multisectoral
93 nutrition coordination structure at all levels, and the willingness of international and national
94 development partners to support multisectoral nutrition interventions are favorable conditions
95 on the ground [14]. Ethiopia has implemented multiple nutrition-specific and nutrition-sensitive
96 programs such as the Ethiopian national nutrition program, and the Seqota declaration program,
97 that have required the development of structures and processes that facilitate multisectoral
98 coordination [15]. But, collaborations between the health and agriculture sectors are suboptimal
99 at community levels [16]. The multi-sectoral nutrition programs and interventions lack strong
100 coordination that brings on board all the relevant stakeholders.

101 Based on these facts, Ethiopia designed different intervention modalities whose objective is to
102 strengthen community-level multisectoral nutrition interventions. In this context, the
103 Sustainable Undernutrition Reduction program in Ethiopia (SURE) was developed and
104 implemented between 2016 and 2020 in rural regions of Ethiopia. The program utilizes the
105 potentials of the Agricultural Development Agents (DAs) and the Health Extension Workers
106 (HEWs) for the promotion of improved agricultural practices and utilization of high nutrient
107 products to promote dietary diversification among rural mothers and children. At present, there
108 is no study that has analyzed the experience and perception of the health (HEWs) and
109 agriculture extension workers (AEWs) in integrating nutrition services provision at the
110 community level in rural Ethiopia. Understanding frontline workers' practices and experience
111 is crucial for identifying appropriate measures to sustain nutrition improvements [9]. This
112 qualitative study aims at appraising the understanding, the knowledge and perception of those
113 women and men who are the most in contact with the communities in rural Ethiopia and who
114 were responsible to implement the SURE program.

115 Methods

116 Study Setting

117 The Ethiopian Ministry of Health and the Ministry of Agriculture led the implementation of the
118 SURE program whose aim was to reduce stunting by improving complementary feeding
119 practices and dietary diversity of young children through a process of improving local
120 agricultural productivity, food accessibility, food consumption diversity and nutritional status
121 of young children and women [27]. SURE, was implemented between 2016 and 2020 in four
122 agrarian regions (Oromia, Amhara, Southern Nations, Nationalities, and Peoples' Region
123 [SNNPR], and Tigray). The program package included promoting diversified agriculture,
124 promoting infant and young child feeding (IYCF) practices, empowering women's decision-
125 making related to agriculture, diversified food intake, and health, and enhancing food security
126 and water, sanitation, and hygiene practices (WASH). The SURE intervention districts were
127 selected because of the high food insecurity and stunting prevalence in four regions out of the
128 nine total regions in Ethiopia. Details of the SURE intervention program have been published
129 elsewhere [17].

130 Briefly, a total of 36 districts (Woreda as locally called) were selected and assigned to the SURE
131 intervention. Comparison control districts were selected in equal number (36 districts) in the
132 same four agrarian regional strata as for intervention districts. Districts were roughly matched
133 based on stunting prevalence tertiles (low, medium or high) and food insecurity scores. Eligible
134 households are households with at least one child under the age of 2 years. The intervention
135 started in 2016 and included 4299 households, 2146 households from 144 Kebeles (smallest
136 administrative unit) were included in the intervention group and 2153 from 144 Kebeles in the
137 control group. After baseline data collection, and all households received counselling at
138 household and community levels. Additionally, 10 % of households with children aged under

139 two years in the intervention regions (they can be enrolled or not in the larger SURE
140 intervention) were 1) provided improved seed variety and chicken through AEWs and 2) trained
141 through demonstration gardens at farmer training centers.

142 The SURE program was delivered through: 1) interpersonal contacts to provide counselling on
143 IYCF and nutrition-sensitive agriculture advice to mothers and fathers of children under 24
144 months, inclusive of pregnant women and fathers-to-be, jointly delivered by the local HEWs
145 and AEWs during routine household visits; 2) men's and women's group dialogues targeting
146 all men and all women in a given community network, facilitated also by the local HEWs and
147 AEWs, and 3) media campaign to reinforce IYCF and dietary diversity messages.

148 [Study design](#)

149 A phenomenological qualitative study design was conducted among beneficiaries (mothers)
150 and implementers (HEWs and AEWs) of the SURE program in the intervention communities.
151 One Kebele per district from the intervention group was randomly selected to contribute in the
152 qualitative study.

153 [Study period](#)

154 This qualitative study was conducted after four years of intervention. The data were collected
155 at the community level in selected districts of Amhara, Oromia, and SNNPR between January
156 and February 2021. Data collection was discontinued in Tigray because of the war.

157 [Recruitment of participants](#)

158 All SURE intervention districts and Kebeles in the three agrarian regions of Ethiopia were
159 eligible for inclusion. The recruitment of participants was done purposely to obtain maximum
160 variation of information. The HEWs and AEWs as service providers of the intervention
161 packages, and mothers who were enrolled in the SURE intervention as direct beneficiaries were

162 invited to participate in this study. The HEWs and AEWs were eligible to participate in this
163 study if they received the SURE program training in 2016 and have provided the service as per
164 their training in their respective Kebele for a minimum of two years. Mothers should be
165 residents of the Kebele, would have had a child 0-24 months old at the time the intervention
166 started, and received joint health and agriculture counseling as described in the study setting.

167 [Data collection and tools](#)

168 Data were collected using key informant interviews (KIIs) at the community level from a total
169 of 28 eligible respondents including HEWs, AEWs and mothers. Participants were asked about
170 their understanding of nutrition, quality of service provided and quality of nutrition education
171 specific to the SURE program, the challenges of implementing nutrition programs jointly, and
172 how the program could be sustained for a better nutrition service provision (Supplementary
173 material 1).

174 Participants took part in a face-to-face interview. A topic guide was developed by the research
175 team and training on how to conduct KIIs was provided. The interview began with demographic
176 questions about schooling, experience, and professional background. All the interviews were
177 conducted in a private space and were audio recorded. Data was collected in the local languages
178 (Amharic and Oromifa). Audio recordings were transcribed and translated into English. All
179 transcribed data was anonymized.

180 [Data Analysis:](#)

181 A framework analysis approach was used to manage and analyze the data. Framework approach
182 provides clear steps to follow and produces structured outputs of summarized data that can be
183 used with a variety of data sources, including interviews, focus groups, and documents [18].
184 The steps include familiarization (becoming familiar with the content of the data), Identification
185 of thematic areas (identifying a thematic framework, which is a set of predetermined themes or

186 categories that are relevant to the research question), Indexing (systematically coding the data
187 to identify content related to each theme or category), and Interpretation (identifying patterns
188 and relationships across the data, and interpreting what these patterns and relationships mean
189 in relation to the research question). Qualitative data analysis software NVIVO version 12
190 software was used in coding and constructing thematic areas from the collected data. The
191 transcripts were coded into specific themes. The themes were identified and coded based on the
192 topic guide as nutrition understanding, achievements, opportunities, and way forwards for a
193 successful implementation of nutrition-specific and nutrition-sensitive programs and
194 sustainability.

195 Ethical considerations:

196 Ethical approval was obtained from the research ethic committees both at the University
197 Hospital of Ghent, Belgium (protocol number BC-08862), and the Ethiopian Public Health
198 Institute, Ethiopia (protocol number EPHI-IRB-306-2020). The qualitative study included
199 recipients from the same cohort (participating mothers from the intervention group), in addition
200 to health extension workers from the intervention Kebeles. Written informed consents, which
201 included permission to be recorded using a digital audio recorder, were obtained from
202 participants before interviews. Further administrative permissions were granted by local
203 government bureaus in all regions.

204 Results

205 Demographic characteristics of study participants

206 From the total of twenty-eight key informants who participated in the study, 43%, 39% and
207 18% were from Oromia, Amhara and SNNPR regions, respectively. The proportion of HEWs,
208 AEWs and mothers were almost similar. Totally 58 % of the extension workers were female

209 and 73% had at least five years of work experience. Sixty-seven percent of the study participants
210 have completed college and above.

213 Major causes of undernutrition

214 The causes of undernutrition are seasonal and context-specific. The key informants perceived
215 that, in their community, undernutrition was due to a shortage of land to produce adequate food
216 to sell or to consume for a rapidly growing population. The severity of the problem increases
217 when it is coupled with poor distribution of agricultural supplies, and pest infestation that affect
218 productivity.

219 *Absence of enough farmland is the cause of undernutrition. Since the community is large in*
220 *number, farmland is not enough. on average the farmland owned by the farmers is about 0.375*
221 *up to 0.5 hectare. AEW,SNNPR.*

222 The problem of land and water scarcity were identified as the main cause of undernutrition in
223 the community in Oromia region. The small plot of land is challenged by a shortage of water
224 and agricultural inputs.

225 *The lack of adequate farming place also another problem because it is difficult to produce*
226 *enough food for family consumption using one farming place and leads to poverty. Moreover,*
227 *lack of adequate rain, lack of irrigation service, and the fertilizer supply is not as required in*
228 *our kebele, which may lead to poverty. HEW, Oromia.*

229 Access to fruits and vegetables is important to improve food security and undernutrition
230 reduction. Frequent drought and absence of irrigation facilities to farm during the dry season

231 are among the causes of undernutrition that undermine the efforts of AEWs and households to
232 improve food and nutrition interventions.

233 *Malnutrition is mainly due to insufficient production of fruits and vegetables due to drought in*
234 *this area. When the husbands and wives agree to produce in their home garden, it will vanish,*
235 *because there is no irrigation. Due to this reason our community failed to produce fruits and*
236 *vegetables and give less emphasis. HEW, Oromia.*

237 War and civil unrest affect access to- and availability of foods through destructing market
238 linkage. Instability compromises the support of HEWS and AEWs to the community. An
239 extension worker indicated that the causes of undernutrition are related to lack of hygiene and
240 sanitation, diseases and infections, inflation and war that displaced people from their residential
241 areas and hindered them from producing food.

242 *The cause of under nutrition are lack of hygiene, disease, war, and such things are the cause of*
243 *under nutrition in addition to the above, there are food security issues. For instance, there is a*
244 *lack of milk for children, they can't access enough milk. There is also limited access to eggs.*
245 *HEW, SNNPR.*

246 *Now in some places, based on market inflation, some people become incapable of buying*
247 *something, as a result, the child may develop malnutrition. For example, when children need*
248 *milk, they may fail to give it. As a child fails to get balanced food when they need and passed*
249 *that time, they may go into malnutrition. Some households are economically incapable to care*
250 *for their child, there is a household that relies on the market business for leading the family,*
251 *such a woman gave other foods to their child before six months and leave the child at home*
252 *because they can't stay home and breastfeed their child regularly. HEW, Oromia.*

254 Challenges of integrating health and agriculture interventions in Ethiopia

255 Many challenges have been reported by extension workers in the implementation of
256 intersectoral interventions. High workload, conflict, shortage of agricultural inputs, limited
257 training and poor supportive supervision and COVID-19 pandemic were the most frequently
258 reported challenges (Figure 1).

259 Intervention in the midst of the war in Ethiopia

260 Ethiopia is facing civil unrest in the last four years and the project intervention has been
261 affected. Conflict was a challenge of service delivery at community level, which resulted in
262 destruction of facilities, damages of means, and loss of income by restricting people's
263 movement and targeted attacks on workers.

264 *The current situation is overly sensitive. It is now three years since the conflict began. Every*
265 *day there are riots, there is something. So, people think it is turning to something else. At the*
266 *beginning of the SURE program, the expert was there to support them every day, and the people*
267 *were getting education and had been given training. It was good to take care of that and*
268 *practice. But now people are abandoning everything and entering politics. "Who will die today?*
269 *Who will live today?" They are living in fear. In this regard, political stability is a bit difficult.*
270 *AEW, SNNPR.*

271 Conflict and the COVID pandemic have also compromised the supportive supervision and
272 monitoring activities by restricting people's movement from regional and zonal levels to front
273 line workers.

274 *... So, this team has met frequently, and minutes have been kept on our discussion. This meeting*
275 *was previously held every week, then turns to every month. As I said earlier, recently we have*
276 *less engagement due to varied factors and we do not have minutes. We fail to gather the*
277 *participants to give different training as this contradicts the covid-19 restrictive measures.*
278 *HEW, Oromia.*

279 Shortage of agricultural inputs and material for workshop training

280 The availability of agricultural inputs for gardening and cooking demonstrations at community
281 level was a challenge and participants were not interested in bringing their own food and
282 material for demonstration. The project gives agricultural inputs to only 10% of the total
283 population, but the demand for agriculture inputs was high and the community perceived that
284 the project does not treat people equally.

285 *We are very much interested in the work (for example a demonstration of food preparation).*
286 *For this demonstration, if you asked the farmers to bring the ingredients/inputs (like egg, kale,*
287 *cereals, ...) from their home they will lose their interest. It is difficult to bring by yourself too.*
288 *The issue is the problem of access to input for the demonstration. AEW, Oromia.*

289 Workload and ownership of the program

290 Nutrition activities are not a priority agenda in all sectors equally. The ownership of nutrition
291 is not clearly defined, and extension experts assume an additional assignment is beyond their
292 regular tasks. There is a lack of awareness and commitment by AEWs to implement nutrition
293 activities at a community level. AEWs assume that tackling issues related to women's and
294 children's nutrition to be the role of HEWs.

295 *Emm... there is often a seasonal job. For example, in the health sector, they will have activities*
296 *such as the vaccination campaign, as well as in the agriculture sector, such as spring, harvest,*
297 *watershed and irrigation. We do not keep our appointment because we give priority to our main*
298 *work. Especially in health, there are increased immunization programs, increased follow up*
299 *programs. AEW, SNNPR.*

300 Integrating agriculture and health services is challenged by shortage of workforce. Food and
301 nutrition-related interventions are not a priority for the agriculture sector. The leadership does
302 not prioritize nutrition, and they always focus on campaigns that aim to achieve a sector-specific
303 activity like vaccination in the health sector and water shedding and plantation in the agriculture

304 sector. Extension workers assume that nutrition activities require additional experts assigned to
305 the job. The service was also compromised by the absence of continuous monitoring and
306 evaluation mechanisms.

307 *The main reason was being overburdened or having overlapping duties on our side. The*
308 *agricultural extension workers push these SURE program activities on us, by mentioning that it*
309 *is not their duty. We also mentioned that these SURE program duties are their responsibility.*
310 *Both sectors push the duties to each other because of work overload. Therefore, we emphasize*
311 *only a single duty expected from our major career and letting others perform the SURE duties.*
312 *We met and discussed the issues only when stakeholders from the zone came to our kebele for*
313 *supervision, otherwise, it was overlooked by both of us. No one continuously monitors the*
314 *progress as result, it will be forgotten. If this is not the case, we would perform it successfully*
315 *in collaboration with AEW. HEW, Oromia.*

316 [Absence of adequate training, supervision, and technical support](#)

317 Supportive supervision and technical support during the implementation of new program is a
318 key factor for the success of a project. The SURE program was designed in a way that
319 supervisors contribute continuously during the whole implementation period. The support
320 provided during the program implementation was limited and many extension workers
321 perceived the support and supervision provided were not adequate.

322 *Let alone frequent training, if at least the concerned bodies at zone level visit our activities and*
323 *provide the necessary feedback, it will motivate us for further improvement. It is pretty good if*
324 *those in the zone were actively involved. As said earlier there is no problem at kebele level but*
325 *at zone level, it seems an overlooked opportunity. HEW, Oromia.*

326 *When the support is provided in an interrupted way, the community perceives the*
327 *activities/supports are useless. If the support comes in an organized manner and reaches the*
328 *kebele (for the farmers) hierarchically, the farmers did not oppose it. They will curiously take*

329 *the supports and adapt to their home/household. But, if the support seems loose from its origin,*
330 *the community considers it useless. AEW, Oromia.*

331 [Lesson learned and sustainability of health and agriculture intersectoral intervention](#)

332 The SURE intervention packages depended on multi sectoral coordination at the local and
333 district levels (Figure 1). However most agricultural interventions were perceived as the
334 distribution of poultry and other agricultural materials. Although most extension workers
335 captured the intention of the target population, as being mothers, young children and those who
336 are most vulnerable households.

337 *SURE, program covered mainly hen distribution for targeted population segments. For*
338 *example, the program distributed up to 6 hens per household. Especially for the lowest quantiles*
339 *of fathers and mothers [socioeconomic], lactating mothers, and children less than 2 years of*
340 *age. SURE, also supplies seed for vegetables. Training is also given for both the professional*
341 *and community. AEW, Amhara.*

342 *In the beginning, we provided training. After we took 15 days of training at the start of the*
343 *program, we mainstreamed this to the level of community. Then, in all kebeles, chicken (for egg*
344 *production) was purchased and provided for 20 individuals per kebele. Different productive*
345 *agricultural materials like water pumps and others were given to support them in the production*
346 *of fruits and vegetables in their backyard. AEW, Oromia.*

347 Health and agriculture extension workers jointly visited households with under two years of
348 age children and provided age-appropriate IYCF counselling and advice on nutrition-sensitive
349 agriculture to improve dietary diversity. Job aids have been developed with food calendars and
350 recipe books for each region. Extension workers describe their experience of joint visit as
351 follows:

352 *we are working together on SURE program. The kebele has a man's and women's development team*
353 *[community-level volunteers who provide support to health and agriculture extension workers in*

354 mobilizing communities to deliver service]. *We and the health extension staff are going from house*
355 *to house and teaching them how to feed their families, especially pregnant mothers, and children*
356 *under two years of age, how to grow vegetables and animals on their limited land and use them at*
357 *home without taking them to market. When we teach together, we or the agriculture extension*
358 *workers through the men's development team, teach them how to produce, what to sow, how to care*
359 *for and feed their children together, how to feed nutritious food and how to feed at least six different*
360 *types of food. The health extension worker shows them cooking demonstration. For example, they*
361 *teach them what to mix, how to prepare and how often to feed. AEW, SNNPR.*

362 *We gather women twice a month in their group to provide training. We have materials and different*
363 *food items on our demonstration site, we show them how to prepare and feed soft foods like porridge*
364 *for children. We advise women to prepare food available in the home based on their capacity. For*
365 *instance, they sell eggs and buy cabbage, we advise them to avoid this habit and spend time feeding*
366 *the child. HEW, Oromia.*

367 Mothers witnessed the service received by extension workers in their community. Although,
368 asking mothers to come with food ingredients could be one factor that limits mothers from
369 attending cooking demonstration sessions.

370 *From HEW I have heard about the preparation of porridge from food items available at home like*
371 *cereals (bean, chickpea and pea), seeds (teff, wheat, oats, millet and barley) vegetables and animal*
372 *products (meat, egg, milk etc). I have also learnt about feeding the children only breast milk until*
373 *the age of six months. From the AEW, I have learnt about chicken for baby and garden for baby.*
374 *They taught us, as we must have vegetables in our garden and animal products at home. If these are*
375 *not available at home, we are expected to buy from the market and prepare porridge from these*
376 *variety of food items to feed children. Mother, Oromia.*

377 Farm demonstration gardens were established at the farmer's training centers to facilitate
378 coordination between the HEW managing the health posts and the AEWs working on the farms.
379 Farm demonstration gardens were developed and managed by AEWs. Appropriate varieties of

380 vegetables were selected according to agroecology. Harvests from the farmer's training centers
381 were used for cooking demonstrations. Cooking demonstrations were managed by HEWs at
382 health posts near the farmer's training centers. Women also donate ingredients from their homes
383 to contribute to the exercise.

384 *We give agricultural demonstrations on every occasion. Whenever we get the best performance, we*
385 *give training and demonstrations on farmer's land or on farmer's training centers to act as the best*
386 *performed farmers. We also give demonstrations as per the farmers' needs and questions. SURE,*
387 *the program recommends demonstration every month. We give porridge demonstration for both*
388 *women and men developmental army every month. Before a year this was done every month*
389 *consistently. Currently we give demonstrations every 2 months or longer. AEW, Amhara.*

390 *When they advised us, they said in recent days, even not the rural, the urban communities are*
391 *practicing home gardening with the limited land they have in the backyard. Different types of*
392 *vegetables (tomatoes, kale, potatoes...) are on your hand; you may not need to buy them from the*
393 *market, plant them. Mother, Oromia.*

394 Knowledge gained through the SURE program

395 The SURE program interventions have impact on the knowledge of community to improve
396 child caring practice, agricultural and behavioral practices in different parameters like severe
397 undernutrition workload, women empowerment, and father's support. The extension workers
398 have observed the changes in the community, mainly fathers' role in supporting mothers in
399 childcaring and the importance given to feeding nutritious diet to children instead of selling the
400 food produced. The extension workers felt that severe cases of undernourished children visiting
401 health centers have decreased.

402 *...after the implementation of the SURE program, we noticed a significant decline in the*
403 *prevalence of malnutrition. The number of children brought to our health post with malnutrition*
404 *has significantly declined. Before the implementation of this program, we found a lot of cases*

405 *and referred them. If in case we found a child with malnutrition, it is the moderate type of*
406 *malnutrition. The severe form of malnutrition is almost rare after the SURE program.*

407 *Concerning women empowerment, one of the most important changes SURE bring is, engaging*
408 *husbands in food demonstration, letting husbands start to think as they are responsible for*
409 *childcare, for their women and they also believe that women have an equal right to decide on*
410 *their asset. The surprising thing was we as our area discuss many issues related to women,*
411 *including their right, ability, responsibility and how they can be independent economically and*
412 *manage their home. For instance, if she generated income by breeding chicken, she could obtain*
413 *money on her own and incorporated it into the household after counselling and significant*
414 *improvement have been observed. HEW, Oromia.*

415 *In the past, men thought that caring for children was a women's job. But now it has completely*
416 *changed; men help their wives by caring for their children. AEW, SNNPR.*

417 [Importance of monitoring and regular supervision](#)

418 Awareness creation activities should be organized frequently for proper implementation of
419 nutrition interventions, and ideally by another person responsible for coordinating nutrition
420 activities at community level. Additionally, the importance of regular meetings and evaluation
421 for integrating services at community level was highlighted.

422 *The first is, giving awareness creation education. For this HEWs and AEWs are responsible.*
423 *But HEWS and AEWs are busy with other tasks. Therefore, there should be other responsible*
424 *body at kebele level for this task to reduce the work overload and to avoid task overlapping*
425 *among HEWs and AEWs. This may increase the effectiveness of the SURE program.*

426 *The other is having regular meetings to monitor and evaluate the progress of the program.*
427 *During this meeting, all responsible bodies should be present. The program should have a*
428 *budget for both monitoring and evaluation as well as for supplies. The porridge and the like*
429 *demonstration need raw materials. These materials should be funded by the SURE program.*
430 *AEW, Amhara.*

431 *At the start of the program there was an evaluation session every six months and sometimes*
432 *every year. Now it has totally stopped. Especially after COVID 19. There is a plan, but the*
433 *achievement is not checked. The reason is usually lack of budget. Therefore, there should be a*
434 *budget for the monitoring and evaluation. HEW, Oromia.*

435 **Discussion**

436 This study explored the experience of integrating health and agriculture sectors for improved
437 food security and nutritional status in Ethiopia. This study reported that the major cause of
438 undernutrition in the SURE program intervention areas are drought, conflict, and population
439 pressure. Furthermore, the high burden of infectious diseases and WASH problems were the
440 cause of the undernutrition. The finding is aligned with the study of Mohamed (2017) which
441 found drought, population pressure, and conflict as the major causes of food security problems
442 in Ethiopia, resulting in child undernutrition and household food insecurity [19]. Similarly
443 finding on child growth in the time of drought by Hoddinott and Kinsey (2001) has shown that
444 conflict and drought increase stunting prevalence among young children in poor households
445 [20].

446 Nutrition interventions require intensive effort from multiple sectors. The expansion of
447 governmental services from nutrition-specific to nutrition-sensitive strategies is the preferred
448 approach, as it addresses all determinants of maternal and child nutrition and health including
449 social and economic determinants [15]. Ethiopia has a national structure for multi sectoral
450 nutrition coordination anchored at the Ministry of Health and a working model at district level
451 also exists [14]. Nevertheless, according to this finding nutrition has been perceived as the work
452 of the Ministry of Health and has been framed as a treatment/preventive problem, which mainly
453 involves health sector interventions. One of the reasons to have a multisectoral nutrition policy
454 is to lift the responsibility of improving nutrition into a national concern. SURE is one of the
455 government-led programs that try to bring the health and agriculture sectors to work jointly for

456 improved dietary diversity and improved nutritional status [17, 21]. Integrating nutrition into
457 the national development agenda, ensuring all sectors have a mutual understanding of the
458 importance of undernutrition prevention, and having a mechanism that helps to ensure local
459 delivery of nutrition services, through decentralization are key components of multisectoral
460 response for undernutrition reduction. SURE, is a common umbrella that brings HEWs, AEWs
461 and women to promote dietary diversity and better nutrition in Ethiopia. But we found extension
462 workers are overloaded by different sectoral activities which can limit their joint efforts and
463 compromise the integration of nutrition-related activities. Similar to this study, frontline
464 workers in Uganda confront various pressures from the institutional and socio-political
465 environment, that limit their decisions about their daily activities [9]. Pelletier and collaborators
466 found that in sub Saharan African countries, institutional integration of nutrition in different
467 sectors was challenged by the job description of staff, the lack of sectoral alignment on
468 multisectoral nutrition objectives and integration into the planning and reporting of sector
469 activities [14]. A systematic review exploring the integration of nutrition-sensitive and specific
470 interventions in fragile environments shows a lack of interest in collaboration, workload and
471 diverting to only sectoral activities as the barriers to integrating nutrition services [22].

472 Delivering nutrition services to the local level tends to work better in countries that have
473 adequate decentralized structures. In Ethiopia, the vertical structure of the Ministry of Health
474 and Ministry of Agriculture from central to Kebele level offers an opportunity to integrate
475 nutrition services at community level. Front-line HEWs and AEWs are a critical bridge between
476 communities and service provision systems in the health and agriculture sectors. Empowering
477 extension workers, supporting them and responding to the challenges they face will be an
478 important part of ensuring the sustainability of joint activities to promote proper nutrition.
479 Therefore, appropriate training, supportive supervision and performance monitoring should be

480 in place to ensure the successful implementation of joint programs in the health and agriculture
481 sectors.

482 [Strengths and limitations](#)

483 Our study collected data from actual implementers and beneficiaries of joint intervention
484 program which can be used to scale up their experience. However, our study focused only on
485 the health and agriculture sectors and did not explore the experiences of other sectors included
486 in the Ethiopian national nutrition program.

487 [Conclusion](#)

488 Integrating existing community-level platforms are key entry points to address undernutrition
489 and promote key agriculture and health interventions in Ethiopia. Community-based joint
490 interventions are perceived as appropriate approaches to prevent severe cases of undernutrition
491 and improve the role of family members in supporting mothers. Empowering extension workers
492 through training, monitoring, and supervision, and addressing the challenges they face are part
493 of ensuring the sustainability of integration between sectors.

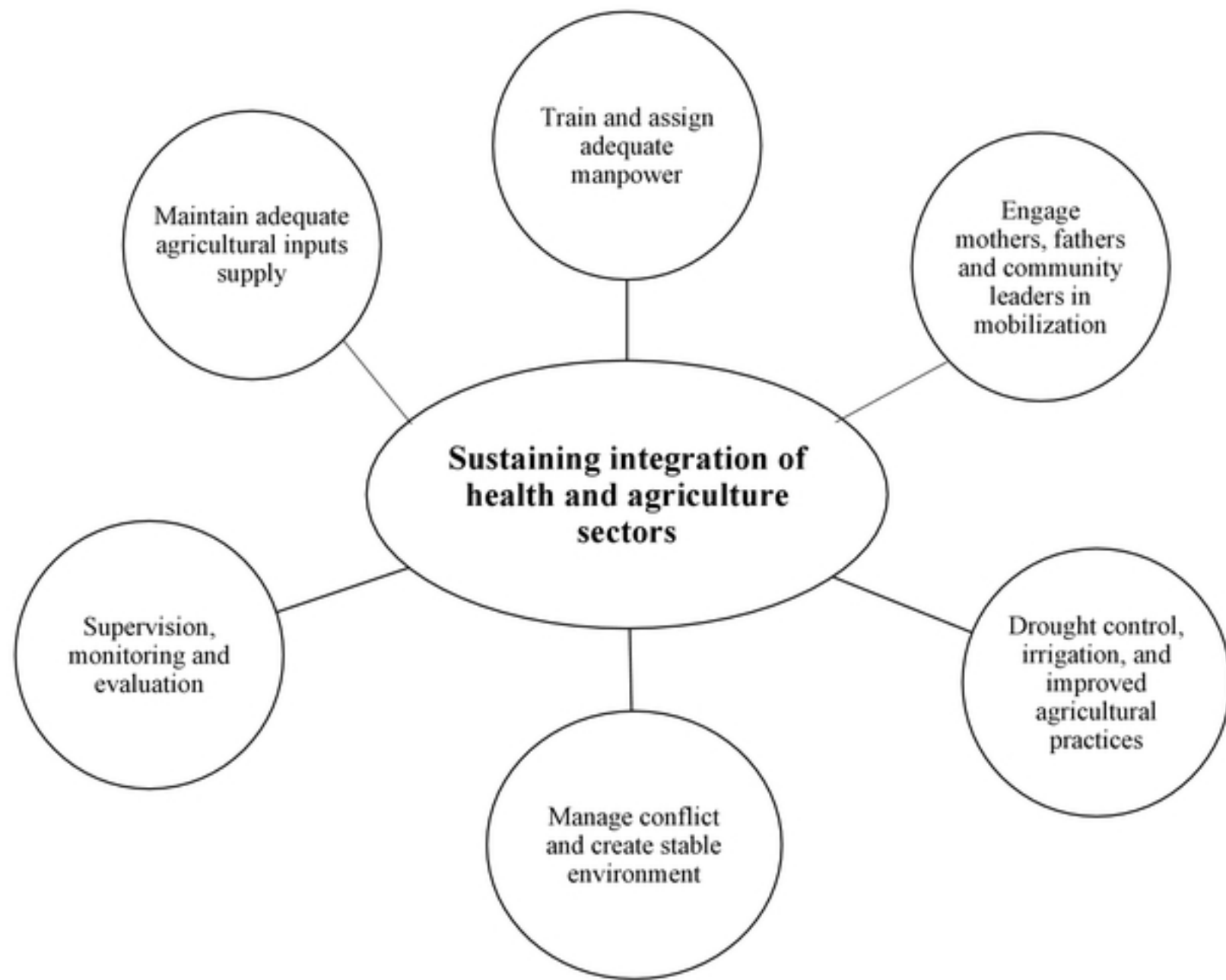
599 **Figure 1:** Sustaining the integration of agriculture and health sectors for reduction of
