Title: Prevalence and determinants of cervicovaginal, oral, and anal HPV infection in a population of transgender and gender diverse people assigned female at birth

1 Abstract 2 Introduction: HPV causes oral, cervicovaginal, and anogenital cancer, and cervical cancer 3 screening options include HPV testing of a physician-collected sample. Transgender and 4 gender diverse (TGD) people assigned female at birth (AFAB) face discrimination and stigma 5 in many healthcare settings; are believed to be a lower risk for cervical cancer by many 6 physicians; are less likely to be up to date on preventive health care services such as pelvic 7 health exams; and are more likely to have inadequate results from screening tests. Self-8 sampling options may increase access and participation in HPV testing and cancer 9 screening. 10 Methods: We recruited 137 TGD individuals AFAB for an observational study, mailing them a kit 11 to self-collect cervicovaginal, oral, and anal samples at home. We tested samples for HPV 12 genotypes 6, 11, 16, 18, 31, 33, 35, 39, 45, 51, 52, 56, 58, 59, 66, 68, 73 and 90 using a PCR 13 mass array test. 14 Results: 102 participants completed the study. Among those with valid tests, 8.8% were 15 positive for oral HPV, 30.5% were positive for cervicovaginal HPV, and 39.6% were positive 16 for anal HPV. A large fraction of anal (50.0%) and oral (71.4%) infections were concordant 17 with a cervicovaginal infection of the same type. 18 **Conclusions:** HPV infection in TGD people AFAB may be just as high, if not higher, than in 19 cisgender women. It is essential that we reduce barriers to cancer screening for TGD

- 20 populations, such as through the development of a clinically approved self-screening HPV test.

23 Introduction

24 The human papillomavirus (HPV) causes more than 24,000 cancers each year in women and people assigned female at birth (AFAB), including 12,000 cervical cancers [1]. The U.S. 25 26 Preventive Services Task Force (USPSTF) recently revised cervical cancer screening guidelines 27 to include the option of testing for high-risk HPV instead of, or in addition to, cytological (Pap) 28 screening [2]. Many physicians believe transmasculine people (those who were AFAB but who 29 identify as male or masculine [3]) and nonbinary and gender diverse people (those who identify between or beyond the male-female gender binary; note that transgender and gender diverse 30 31 may be overlapping identities) to be at a lower risk for cervical cancer than cisgender (i.e., non-32 transgender) women because of lower rates of penile-vaginal intercourse [4]. However, prior 33 studies have suggested that transmasculine populations have just as high or higher rates of

34 sexually transmitted infections and may be at equal or higher risk of HPV-associated cancers [3, 35 5]. Moreover, transgender and gender diverse (TGD) people face discrimination and stigma in 36 health care settings and daily life and consequently are less likely to seek reproductive and 37 preventive health care services, including cervical cancer screening [6–12]. Recent studies have proposed HPV self-sampling as an alternative to provider-based testing, circumventing some of 38 these known barriers to screening [13-16]. However, any clinically approved self-sampling 39 40 protocol should be designed to address the specific physical and mental discomfort that TGD 41 people may face. Ultimately, more work is needed to understand the risk of HPV-associated 42 cancers in TGD populations [17] as well as the impact and feasibility of HPV self-sampling as a 43 cervical cancer screening tool. This work is especially crucial in the context of the updated 44 USPSTF guidelines and the current politicization of TGD medical care.

45 While HPV is best known as the etiological agent of nearly every cervical cancer, it also causes 46 over 90% of anal cancers, 40% of vaginal, vulvar, and penile cancers, and more than 60% of 47 oropharyngeal and other oral cancers [1, 18, 19]. Oropharyngeal cancer is now the HPVassociated cancer with the highest incidence in the U.S., with approximately 19,000 of the 48 49 43,000 HPV-associated cancers diagnosed occurring at oropharyngeal sites (approximately 50 12,000 are cervical, 7,000 are anal, and the rest are at other genital sites) [20]. There is 51 increasing recognition that HPV must be considered a multisite (cervicovaginal, oral, anal) 52 infection to fully understand its epidemiology [21-26]. We extend this multisite perspective to 53 HPV-associated cancer risk, screening, and prevention for TGD people AFAB. Specifically, we 54 enrolled a sample of TGD AFAB people and mailed them at-home, self-sampling kits, which we tested for cervicovaginal, oral, and anal HPV. 55

56 **Methods**

57 **Ethics statement**

58 This study was approved by the University of Michigan Institutional Review Board (IRBMED: 59 HUM00166980) and Rogel Cancer Center Protocol Review Committee. Prior to beginning the 60 study, ten TGD community consultants reviewed and commented on the study protocol, 61 surveys, and sample collection instructions; each person was compensated with a \$100 gift card 62 for their time. In the main study, all participants gave written, informed consent virtually, using the SignNow platform. Participants were compensated with a \$50 gift card for full study 63 completion and were returned the results of their high-risk HPV test, with appropriate cautions 64 given the non-clinical sampling. This study included the use of a cervicovaginal swab outside of 65

- the Food and Drug Administration (FDA) approved context (i.e., used by the participant, not by a
- 67 physician, to collect a sampling for HPV testing); the FDA determined the study, including return
- of qualified research results to participants, to be a non-significant risk device study.

69 Study population

70 Eligibility criteria

To participate in the study, potential candidates had to meet all of the following criteria: (1) be between the ages of 21–65, (2) have been assigned female at birth (AFAB), (3) have a male, masculine, nonbinary, queer, or another gender diverse identity other than female or feminine, (4) not be pregnant, (5) not have had cervix removed, (6) not be menstruating on the day of the cervicovaginal swab self-collection, and (7) live in Michigan, Illinois, Indiana, Ohio, or Wisconsin. Individuals of any HPV vaccination status or prior HPV infection status were eligible.

77 Recruitment and enrollment

Recruitment methods included advertisements and listserv emails through Michigan Medicine's Comprehensive Gender Services Program, the University of Michigan Health Research posting site, social media posts, outreach to statewide LGBTQ+ groups and organizations, and word of mouth referrals. Interested participants reached out to study staff, who screened them for eligibility requirements. Potential participants were then invited to an individual virtual video call to review the consent form and details of the study.

84 Surveys

Participants completed two surveys on an online platform (Qualtrics). The demographic and behavioral survey include questions on sociodemographic characteristics; healthcare utilization; sexual behavior and history; and substance use. The self-sampling survey, which was administered after specimen collection, included questions on the acceptability, comfort, and ease-of-use of the cervicovaginal and anal self-sampling protocols, as well as preference for self- or physician-administered testing/screening.

91 Biospecimen collection and processing

Participants were mailed a study test kit that included materials and instructions for selfcollection of 3 separate biospecimens: a cervicovaginal swab, an oral rinse, and an anal swab.
Self-sampling instructions were modified to remove gendered language (e.g., "genital swab" or
"front hole swab" instead of "cervicovaginal swab" or "Evalyn Brush"). All samples were

repackaged in USPS biospecimen compliant packaging then returned via mail to the study. The
estimated time lapse between sample collection and package receival was 5 days.

Cervicovaginal swab: Participants used an Evalyn Brush (Rovers Medical Devices BV, Oss, 98 99 Netherlands) to self-collect a cervicovaginal sample [27]. Participants were provided with self-100 collection instructions that were modified from the original, with permission from Rovers Medical 101 Devices, to remove gendered language. In short, participants were instructed to use the plunger 102 on the device to inserted the brush into their vagina to the appropriate depth, rotate the brush 5 103 times, and then retract and cap the device for transport. HPV DNA on a dry-stored Evalyn Brush 104 has previously been shown to be analytically stable [28]. Upon return to the study, the protective 105 cap was removed, and the brush tip was vigorously agitated then gently mashed in a 20mL vial 106 of PreservCyt solution (Hologic, Inc.; Marlborough, MA). Since the genital mucus sample often 107 dried during transport, the brush bristles arrived firmly adhered together. Mashing ensured 108 complete separation of the plastic brush bristles, which improved elution of the cells from the 109 brush into the PreservCyt media. The tip of the brush was then removed from the barrel of the 110 device using a set of autoclaved disposable forceps provided by the manufacturer and left to 111 soak for a minimum of 5 minutes to rehydrate dried mucus that would have otherwise impeded 112 cell elution. The device barrel was discarded, but the brush tip was retained within each 113 PreservCyt vial. After resting, each vial was vortexed for 30 seconds to remove cervical cells 114 that were adhered to the brush bristles. A 10mL aliquot was pipetted into a conical tube and 115 sent to our research laboratory for genotyping, a 2mL aliquot was pipetted into a 5mL transport 116 tube and sent to Michigan Medicine Pathology for Cobas testing. Samples were stored at 0°C.

117 Anal swab: Participants were sent a Dacron flocked swab (Puritan Medical Products; Guilford, 118 ME), a 10ml conical tube with 1 mL of DNA/RNA Shield (Zymo Research; Irvine, CA) or 119 Preserv-Cyt. Sample collection instructions were based on those developed by Meites et al. 120 [29]; briefly, participants were instructed to insert the swab 2 inches into anus, twirl the swab 121 between the thumb and forefinger while pressing laterally against the anal walls, and then 122 remove the swab from the body. The swab was then placed in the corresponding conical tube. 123 Upon return to the study, the conical tube containing the Dacron flocked swab and transport media were vortexed for 15 seconds to release cells from the fibers of the swab tip. The swab 124 125 was then extracted from the tube with a pair of sanitized hemostats and discarded. The sample 126 was sent to our research laboratory for genotyping.

Oral rinse: Participants received 1 50 mL conical tube with 10 mL Scope Mouthwash (Proctor &
 Gamble; Cincinnati, OH). Participants were instructed to swish the mouth wash vigorously for 30

seconds, then spit the contents back into the original 50 mL tube. Upon return to the study,samples were transferred to our research laboratory for genotyping.

131 HPV testing

High-risk HPV testing: Cervicovaginal samples were tested by Michigan Medicine Pathology
clinical laboratories using a Cobas high-risk HPV test (Roche Molecular Systems, Inc;
Branchburg, NJ), a polymerase chain reaction (PCR)-based test that provides pooled results on
high-risk genotypes and individual results for HPV-16 and HPV-18, the highest-risk genotypes.
The results of this test were returned to participants.

PCR Mass Array HPV genotyping: Cervicovaginal, anal, and oral samples were tested for HPV genotypes 6, 11, 16, 18, 31, 33, 35, 39, 45, 51, 52, 56, 58, 59, 66, 68, 73 and 90. Sample processing and DNA extraction details are the same as in Eisenberg et al. [30], and technical details of the PCR Mass Array test are given in Walline et al. [31]. Participants whose samples contained insufficient DNA or otherwise resulted in inconclusive test results were denoted as invalid. The results of the PCR Mass Array were not returned to participants.

143 **Results**

144 Demographics, behaviors, and medical history

145 We enrolled 137 participants between August 2020 and August 2021, and 102 participants 146 completed the biospecimen collection and demographic and behavior questionnaire. The 147 demographic, behavioral, and medical history characteristics of these participants are summarized in Table 1; a table summarizing participants' numbers of recent sexual partners is 148 given in the supporting information (Table S1). While participants ranged from 21 to 59 years of 149 150 age, the majority of those who completed the study (66%) were under 30 years old. The study 151 participants were predominantly White (82%). Participants were also highly educated, with 92% reporting attending at least some college and 65% having a 2-year, 4-year, or 152 153 professional/doctorate degree. Reported annual income was distributed fairly evenly between 154 the categories ranging from less than \$10,000 to at least \$50,000. Most participants reported 155 having a single partner, either married/partnered (46%) or not (12%); about 25% of participants 156 were never married or partnered.

Approximately half (48%) of participants identified as nonbinary, genderfluid, or agender and half (49%) as transgender male, transmasculine, or male (note that people who identify as male and were AFAB may or may not include being transgender as part of their gender identity). Most

160 participants identified their sexual orientation as bisexual, pansexual, and omnisexual (43%) or 161 simply as queer (36%). The vast majorities of participants reported a history of deep kissing 162 (96%), mutual masturbation (89%), vaginal/front hole sex (98%), and oral sex (99%), while 60% 163 reported ever engaging in anal sex, and 43% having ever engaged in anilingus/rimming. When asked about partners within the last 6 months, participants overall reported similar numbers of 164 partners with a vagina and partners with a penis for vaginal, anal, or oral sex. A table of recent 165 166 (past 6 month) sexual activity by sex type and partner genitals is given in the Supporting 167 Information (Table S1).

168 About 75% of participants responded that they have transitioned or are currently transitioning 169 from living as the gender assigned at birth, 76% of whom reported ever taking hormones as a 170 part of gender-affirming medical care. Only 42% of transitioned or transitioning participants 171 reported gender-affirming surgery. The vast majority (86%) of participants reported never being 172 pregnant. Most participants indicated currently using alcohol (75%) and marijuana (54%), while 173 only 32% reported ever smoking cigarettes. More than half (57%) reported receiving at least one 174 dose of a vaccination against HPV, and most (81%) reported having ever had a cervical pap 175 smear. While none of the participants reported being uninsured, 81% reported delaying regular 176 medical checkups. Most of these (59%) were due to fear of physical discomfort or dysphoria. 177 Most participants (53%) also reported delaying care for acute medical needs, with 36% of participants reporting delaying acute treatment due to concerns for physical discomfort or 178 179 dysphoria.

180 HPV prevalence and determinants

HPV prevalence varied across oral, cervicovaginal, and anal sites and across demographic and
behavioral characteristics (Table 2). HPV was detected in 8.8% of valid tests on oral samples,
30.5% of valid tests on cervicovaginal samples, and 39.6% of valid tests on anal samples. Highrisk HPV, which includes genotypes 16, 18, 31, 33, 35, 39, 45, 51, 52, 56, 58, and 59, was
detected in 6.6% of oral, 26.8% of cervicovaginal, and 27.1% of anal samples. The genotypespecific HPV prevalence by site is given in the Supporting Information (Table S2).

Of the 44 participants with both valid cervicovaginal and anal test results, 25.0% of pairs of anal and cervicovaginal test results detected the presence of HPV of the same genotype. These concordant infections represented 34.4% of cervicovaginal infections in this group and 50.0% of anal infections. Of the 75 participants with valid results for both oral and cervicovaginal tests, 6.7% of pairs of oral and cervicovaginal tests detected the presence of the same genotype of HPV. These concordant infections represented only 12.2% of cervicovaginal infections in this

193 group but 71.4% of oral infections. The HPV genotype-specific concordance for 194 anal/cervicovaginal and oral/ cervicovaginal samples in the supporting information (Table S3).

No statistically significant associations were found between any characteristic and oral HPV 195 infection. Cervicovaginal HPV infection was statistically significantly associated with the number 196 197 of deep kissing partners with a penis in the past 6 months (PR 3.12 (95% CI: 1.56, 6.23) for 5+ 198 partners vs 0 partners), number of partners with a vagina from whom the participant received 199 oral sex (PR 3.47 (95% CI: 1.52, 7.93) for 2-4 partners vs 0 partners), a history of HPV (PR 2.68 200 (95%CI 1.47, 4.88)), and a history of other STI (PR 2.07 (95%CI 1.11, 3.85)). Anal HPV 201 infection was statistically significantly associated with sexual attraction identity (PR 1.94 (95% 202 CI: 1.06, 3.58) for identifying as homosexual vs bisexual, pansexual, or omnisexual), number of 203 deep kissing partners with a penis in the past 6 months (PR 6.00 (95% CI: 1.54, 2.34) for 5+ 204 partners vs 0 partners), and a history of other STI (PR 2.67 (95%CI 1.33, 5.36)).

205 **Discussion**

We evaluated the prevalence of cervicovaginal, oral, and anal HPV in a Midwestern TGD AFAB 206 207 population and investigated the potential association of infection with demographics, health factors, and sexual behaviors. We found HPV prevalence of 8.8% in oral samples, 30.5% in 208 209 cervicovaginal samples, and 39.6% in anal samples. In a partner study using similar protocols 210 for oral and cervicovaginal HPV detection in a general population with a similar age profile, 211 10.5% of cisgender women (and 9.0% of cisgender men) in the sample were positive for oral 212 HPV, and 20% of cisgender women were positive for cervicovaginal HPV [32] (anal swabs were 213 not collected in the partner study). This comparison suggests that the TGD AFAB population may have higher cervicovaginal HPV prevalence than but similar oral HPV prevalence to the 214 cisgender women. A separate study in a TGD AFAB population, found 16% high-risk HPV 215 216 prevalence in physician-collected cervicovaginal swabs, compared to the 26.8% high-risk HPV 217 prevalence in our study [13]. Overall, we found no evidence that TGD people AFAB are at a lower risk for HPV and HPV-related cancers, and it is therefore important that screening for 218 219 cervicovaginal HPV is accessible through affirming medical providers, or, potentially, at-home 220 self-screening.

We found a high prevalence of anal HPV among valid tests (39.6%). A meta-analysis of anal HPV prevalence in cisgender women found that cisgender women without HPV-associated cervical pathology had anal HPV prevalence ranging from 4–22%, and prevalence in those with HPV-related cervical pathology ranged from 23–36% [33]. It is concerning, however, that despite modeling our anal sample collection instructions off an established protocol [29], we had low

sample validity (that is, low detection of human control indicators) in our anal samples (47% valid). Validity was much higher among oral (89% valid) and cervicovaginal (80% valid) samples. Future work could involve instructional videos demonstrating anal (and cervicovaginal) sample collection techniques, and future work should consider whether there are particular challenges for anal sampling for TGD individuals. A follow-up study will also examine participants' experiences with the cervicovaginal and anal sample self-collection.

232 We found significant differences in HPV prevalence across several participant characteristics 233 and reported behavior. History of an STI diagnosis, likely a proxy for other behavior, was also 234 associated with HPV at both cervicovaginal (PR: 2.07, 95%CI: 1.11, 3.85) and anal (PR: 2.67, 235 95%CI: 1.33, 5.36) sites. HPV is thought to be largely transmitted through sexual activity, and 236 many previous studies have demonstrated associations in general populations [34-41]. Few 237 associations rose to the level of statistical significance, with the exception of the number of deep 238 kissing partners with a penis for both cervicovaginal and anal HPV infection and the number of 239 partners with a vagina that a participant received oral sex from for cervicovaginal HPV infection. 240 More broadly, in many sexual behavior categories, prevalence generally increased with the 241 number of recent sexual partners, even if not statistically significantly. Additionally, although the 242 effects were not statistically significant, there were indications that HPV prevalence among the 243 participants identifying as male, transgender male, or transmasculine was higher than those 244 identifying as nonbinary, genderfluid or agender. There were no significant differences in HPV 245 prevalence by transition status, use of gender affirming hormones, or gender-affirming surgery.

246 We found a high degree of cervicovaginal-anal concordance among the participants with valid 247 results for both anal and cervicovaginal tests. The high concordance of cervicovaginal-anal 248 infection highlights the need to treat HPV as a multisite infection. One limitation is that we 249 cannot tell from our data whether this correlation is the result of autoinoculation from site to site 250 or separate transmission events from the same partner to different sites. In future work, the 251 autoinoculation vs transmission explanations could be further evaluated using gene sequencing 252 and mapping of samples from participants, or by utilizing contact tracing and partner testing. We 253 found many oral infections were genotype concordant with cervicovaginal infections (71%), but 254 few cervicovaginal infections were concordant with an oral infection (12%). These results are 255 consistent with patterns of oral-cervicovaginal concordance in the National Health and Nutrition 256 Examination Survey (NHANES) [42]. Together, our results are consistent with cervicovaginal 257 infections being the source of anal and oral infections.

258 One strength of our study is the multisite design, incorporating oral, cervicovaginal, and anal 259 self-sampling and HPV testing. Additionally, because many gender minority studies in the US 260 are focused on urban, coastal populations, this Midwestern cohort helps to bring context and enhance the generalizability of gender minority studies. We also explicitly included nonbinary 261 and gender diverse participants in this study, who are often overlooked in gender minority 262 research. One limitation of our study is the small sample size, limiting statistical power, although 263 264 other comparable studies have also had limited sample sizes [13]. Additionally, lack of racial and 265 ethnic diversity in this pilot study is a strong limitation, as there may be important intersectional 266 effects for TGD people of color. Indeed, we found high HPV prevalence among the non-White 267 participants in this study. Future work should use targeted recruitment strategies to achieve better racial and ethnic representation. Finally, while the age distribution of the cohort (66% 268 269 aged <30 years) is not inherently a limitation, it should be accounted for when try to generalize 270 the results, since HPV prevalence varies by age [42].

271 Conclusion

In our multisite (cervicovaginal, oral, anal) HPV sampling study in TGD people AFAB, we found HPV oral prevalence consistent with cisgender populations but higher cervicovaginal and anal infection. Our work suggests that the risk of HPV-related cancers in TGD people AFAB may be just as high, if not higher, than in cisgender women. It is essential that we reduce barriers to cancer screening for TGD populations, such as through the development of a clinically approved self-screening HPV test.
