24 Abstract

25 Background: Childhood undernutrition is a serious public health issue that includes stunting, wasting, and underweight. In Bangladesh, many adolescent girls become mothers early. Giving 26 birth at a young age is common, adversely affecting maternal health and child undernutrition. 27 28 This study investigated the association between maternal age at first birth and undernutrition of under-five children in Bangladesh. 29 30 Methods: The study is cross-sectional and data was collected from BDHS 2017–18 survey. Mothers who were pregnant at the age of ≤ 19 years were regarded as young mothers and aged 31 >19 years were regarded as adult mothers. Children were categorized as stunting (height for age). 32 wasting (weight for height), and underweight (weight for age) based on the z-scores -2 as per 33 WHO median growth guidelines. Multivariate logistic regression was employed to assess the 34 35 association. **Results**: This study revealed that 71.5% of mothers had their first child before 19 years old. The 36 undernutrition status of the children of younger mothers and the children of adult mothers 37 differed significantly, stunted (p<0.001), wasted (p<0.001), and underweight (p<0.001)). 38 Children of mothers aged under 19 years at their 1st childbirth were 1.4 times more likely to be 39 stunted [Adjusted odds ratio (AOR): 1.4, 95% CI: 1.02- 2.46; p=0.008], 1.6 times more likely to 40 be wasted (AOR: 1.6; 95% CI: 1.09-1.78; p=0.039), 1.5 times more likely to be underweight 41 (AOR: 1.5, 95% CI: 1.15-2.07; p=0.004) compared to children of mothers who are adults. 42 43 **Conclusion**: This research will draw attention to the policymakers taking the necessary initiatives focus on the maternal age at the time of first birth, which will help reduce all forms of 44 undernutrition in under-five children. 45

47 Background

48	Undernutrition is the term that refers to a person's inability to meet their needs to maintain good
49	health (1). Adequate nutrition is helpful for growth and progress but malnutrition threatens
50	human life (2). Globally, in 2020, 45 million under-five children were wasted and 150 million
51	were stunted (3) and 47 million were underweight (4). In low and middle-income countries
52	(LMICs), childhood undernutrition which includes stunting, wasting, and underweight, is a
53	serious public health issue. In LMICs, undernutrition is a factor in about 45% of under-five
54	fatalities. (3). In South Asia; the prevalence of undernutrition is 15.7% (5); 8.2% were wasted,
55	and 27.4% were stunted (6). Bangladesh made some progress on the prevalence of stunting
56	(31%) (7), but this is still higher than the average (21.8%) for the Asian region (8). In
57	Bangladesh, the prevalence of wasting (9.8%), but this is still higher than the average for the
58	Asian region (8.9%) (8), and 21.9% are underweight in Bangladesh (7, 8).
59	Globally, around 1.8 million children die each year due to stunting and wasting, and 12% of the
60	years are adjusted for disability (9). Undernutrition in childhood is a factor that affected
61	cognitive development and causes brain damage, harming children's motor development and
62	investigative behavior (10). Undernutrition in children has been associated with atypical
63	behavior, low academic performance, and mental retardation (11).
64	Young mothers are at risk of giving birth to undernourished children (12). The age at first birth
65	refers to the percentage of mothers giving birth at certain ages. In this context, "young mother"
66	refers to becoming a mother between the ages of 10-19 years (13). Women aged 15-19 who have
67	given birth their first child are taken into account as per BDHS-17/18 (7). In LMICs, it is
68	anticipated that per year 21 million of mothers aged between fifteen to nineteen become
69	pregnant, and 12 million give birth (14). In South Asia, about one in two adolescent girls married

before the age of eighteen and one in five girls give delivery before their eighteen years (15). As
per the world bank, 37% of girls married before their eighteen years, and that impacted child
mortality and nutrition (16). In Bangladesh, sixty-six percent of women gave birth before age
twenty (7). Young mothers often suffer from abortion, ectopic pregnancy, miscarriage, maternal
infections and obstructed labor (17). Birth outcomes of adolescent mothers are born with
stillbirth, low birthweight, preterm birth, child mortality, severe neonatal conditions, birth
injuries, and retarded growth (18-21).

In developing countries, young pregnancies mostly happened in economic insolvency, with less 77 78 education, and among the rural population (22, 23). Approximately 71% of new mothers start breastfeeding, but due to labor and delivery problems, and low social support breastfeeding 79 initiation was hampered (24). Adolescent mothers are less likely to get immunized, obtain 80 regular health care, overfeed and underfeed their infants, and introduce solid early and 81 inadequate nursing to their offspring (18, 25). Deaths of live newborns are fifty percent higher 82 among babies of young mothers compared to mothers aged 20-29 years (22). The young mother 83 requires special attention as she is at risk of adverse health outcomes rather than the older (26). A 84 prospective study found that young mothers' age (≤ 19 years) was associated with infants' low 85 86 birth weight, preterm birth, stunting, and failure of completing secondary school to the child (27). In developing countries, maternal and child undernutrition is caused by several factors, 87 88 including a lack of suitable feeding habits for babies and young children (28). Even though the 89 government has taken steps to discourage young marriage, it is yet common in rural and underprivileged areas. Early marriage influences becoming a mother at a premature age. 90 91 However, as per our knowledge no studies explored the association between young maternal age 92 at their first birth and undernutrition in children in Bangladesh. We aimed to investigate maternal

age at first birth and child undernutrition in Bangladesh using nationally representative crosssectional health surveys (BDHS-17/18) data.

95 Methodology

96 Data source

Data extracted from the Bangladesh Demographic and Health Survey (BDHS)-2017/18. The 97 two-stage stratified sample design used in the BDHS survey across all administrative divisions. 98 Every division is further subdivided into zilas and every zila into upazilas. Subdivisions of the 99 100 upazila serve as the main sample units (enumeration areas, EAs), wards and mohallas in urban areas, unions and mouzas in rural areas. EAs were chosen in the initial step with probability 101 based on size. A sampling frame for the second step of household selection was created by 102 103 completing a household listing operation in each selected EAs. An average of 30 households per EA were chosen in a systematic random sample during the second sampling step. The BDHS 104 provides essential mother and child health, and nutrition information that represented at the 105 national and divisional levels (7, 29). 106

107 Samples

Child anthropometric measurements were the key outcome factors. Enumerators measured
weight, height, and length using the internationally accepted standard protocol. Each child has
measured height for age, weight for height, and weight for age to calculate Z-scores for
comparison to the age and gender-appropriate child growth guidelines of WHO (30).
After requesting permission from the DHS program, datasets were downloaded from the DHS
website. After excluding missing data, height limits and flagged cases (inconsistent, irrelevant
and not applicable response etc), absence for height and weight measurement, and deaths, finally

7,643 children were included in this study (Fig. 1). Detailed information on the survey (such as
the sampling method, the determination of the sample size, and the data collection procedure) is
described in the BDHS 2017-18 report (7).

118 This study considers the maternal age at first birth as the primary exposure variable. We divided

the ages of the mothers at their first birth into ≤ 19 and >19 years. To evaluate the link between

120 maternal age at the time of the first birth and undernutrition in children. In addition, we took into

account the mothers' age (≤ 19 years, and >19 years), the household head (mother, husband,

122 father, fathers-in-law, and others), the mothers' body mass index (BMI) [underweight, normal

weight, and overweight and obese (BMI 25->29.9 kg/m2)], the age group of the children (≤ 24

months, >24 months), the delivery by cesarean section (yes, no), the mothers' education ((yes,

125 no).

126 Statistical analysis

The statistical program Stata (version 15) was used to analyze the data. Descriptive statistics were calculated and reported in percentages and weighted percentages. The bivariate analysis used the chi-square test to assess the significant associated factors of childhood undernutrition. Finally, after adjusting potential confounders, the association between undernutrition in underfive children and the mother's age at first birth was examined using multiple logistic regression analysis.

133 Ethical consideration

134 DHS data are publicly available upon justifiable request and are in the public domain. We did

not need further ethical approval because the study protocol was accepted by both the

136 Bangladeshi Ethics Commission and ICF International (7).

137 Results

138 Socio-demographic characteristics

About 72% of mothers' age at first birth was below 19 years, 56.3% of household head was

husband, 60.5% of women were of normal weight. About 50% of mothers completed secondary

education, whereas 33.3% of fathers completed primary education. In the wealth index, we found

that the distributions of poorer (20.4%) and richer (20.3%) and rest are almost similar. About

143 35% of mothers delivered babies by C-section. 15.7% of children were under 2500g at birth, and

144 40.2% of mothers were employed at the time of data collection (Table 1).

145 Nutritional status of children

146 Stunting, wasting, and underweight were all common, with prevalence rates of 31%, 8%, and

147 22%, respectively (Figure 2). In a chi-square test, it was found that young mothers' first-born

148 children had different nutritional statuses from those of adult mothers in terms of underweight

149 (p<0.001), stunted (p<0.001), and wasted (p=0.008). The chi-square test revealed a significant

association between child undernutrition and the household head wasted (p=0.017), stunted

151 (p<0.001), underweight (p<0.001), the father's education wasted (p=0.013), stunted (p<0.001),

underweight (p<0.001), and cesarean delivery (p=0.006), wasted (p<0.001), stunted (p<0.001),

underweight (p<0.001). Antenatal care visits four times were found to be effective in preventing

stunting (p<0.001) and underweight (p<0.001) and but not significant for preventing wasting

155 (p=0.226) (Table 2).

156 Relationship between mothers' age during their first delivery and

157 children's undernutrition

158	Multiple logistic regression models are used to analyze the data, after adjusting for potential
159	confounders such as household head type, antenatal care (ANC), childbirth weight, and the
160	respondents' current employment. In the regression model, AOR =1.6, 95% CI 1.09-2.46 were
161	found to be 1.6 times more likely to be wasted, AOR =1.4, 95% CI 1.09-1.78 were found to be
162	1.4 times more likely to be stunted, and AOR =1.5, 95% CI 1.15-2.07 were found to be 1.5 times
163	more likely to be underweight of children born to mothers aged less than nineteen years
164	compared to mothers aged more than nineteen years (Table 3).

177 Discussion

This study found that 71.5% of women who gave birth for the first time were below the 19 years. 178 179 The prevalence of maternal age at first birth in Bangladesh aligns with the previous study in Bangladesh (29). In Bangladesh, marriage at a young age is forbidden. However, it still exists 180 due to religious and societal factors, peer pressure, perceptions of girls' gender roles, upholding 181 family honor and virginity, dowry, and concern about safety and security (31-33). According to 182 Bangladeshi civil law, girls must be 18 years to get married. In 2017; the Bangladeshi parliament 183 approved early marriage in certain situations (34). As a result, many young girls married before 184 their legal marriage age limit. In Bangladesh, 33% of young mother marriages before the age of 185 15, and 66% of young mother marriages before age the of 18 years (35). Sixty-eight percent of 186 girls had a child before twenty years of age (age 15-19 years) (36). Because of this, many women 187 have children before they were 19 years old. That has detrimental effects on raising and caring 188 189 for children. In USA, a study shows that experiences for young mothers on childbearing have 190 some effects on their minds, relationships, and emotions (37). This research revealed that higher risk of stunting, wasting, and underweight among under-five 191

192 children whose mothers were age of below 19 years. According to this study, having the first

child at the age before 19 years puts at an elevated risk of child undernutrition, including stunting 193 and wasting. Children of adolescent mothers are more likely to be undernourished such as 194 shorter and underweight compare to the adult mothers (38). Young pregnant mothers are 195 associated with undernutrition in children through poor maternal nutrition, less education, less 196 access to health services, poor supplementary feeding practices, and substandard housing 197 198 situations (12). A prospective study found that young maternal age (≤ 19 years) is associated with the stunting of two years aged children (27). 199 The overall prevalence of stunting, wasting, and underweight in under-five children of young 200 201 mothers is 33.7%, 9.0%, and 23.7%, respectively. Another study conducted in Bangladesh on maternal, newborn, and child health (MNCH) programs area of BRAC (a non-governmental 202 organization) found the prevalence of stunting 15.9%, wasting 14.7%, and underweight 22.4%, 203 204 respectively of the children of mother age less than nineteen years old (39). In Ghana, under-five children of young maternal age (15-19 years) are more likely to be stunted (39.0%) and wasted 205 (8.0%) (40). 206

Current study found that children of young mothers (age below 19 years) more likely to be undernutrition than children with older mothers. These children were at least 1.4 times more likely than children of adult mothers to be underweight, stunted, and wasting. In India, a study found that young pregnancies were linked to an increased risk of undernutrition. Children of young mothers were five percentage points more likely to be stunted than children of adult mothers, and they were also shorter for their age (41).

In this study, it is found that mother who gave their first birth at an age below 19 years is more accountable for the undernutrition of children. A review found that mothers who gave birth at the age of before 19 years received routine medical care and immunizations for children, frequently

overfed or underfed their children, fewer mothers breastfed their children and they introduce 216 217 solid foods in the first or second months of the infants (18). This occurs among mothers below nineteen years, who may not be able to nurture appropriately due to the lack of their maturity. 218 219 Many adolescent mothers had lack of knowledge to take responsibility for maternity and infant 220 care including prenatal care, and breastfeeding (42). 221 Maternal age at first birth of under 19 years who get pregnant too young and leave school may feel personally unhappy if they don't have a steady source of income. Pregnant girls are 222 frequently forced or under pressure to leave school, which might affect their chances for higher 223 224 education and jobs (43). Due to the early pregnancy, they might give their kids less care, breastfeeding, and nurturing than mothers who are adults, which might translate to less care, 225 226 nursing, and nurturing all around (42). Adolescent girls have been negatively impacted on their 227 couples, families, schools, and society at large by early motherhood (42). Due to malnutrition and other growth deficiencies, this is likely to have an impact on the physical and cognitive 228 development of their children (44). 229

230 Strengths and Weakness

This study analyzes nationally representative demographic and health surveys data to examine
the relationship between maternal age below 19 years and undernutrition of under-five children.
BDHS-17/18 data helps to generalize the relationship between the maternal age first birth and
undernutrition of under-five children at the national level.

We performed a cross-sectional analysis that is not appropriate for studying causal relationships but it shows that the association between the maternal age at first birth and undernutrition of under-five children. In contrast, data were collected on mothers who have given birth at the age below nineteen years using the recall procedure so that it may have some remembrance issues.

239 Conclusion and recommendations

- 240 These research results provide policymakers with vital information to implement the programs
- focusing on child undernutrition and younger maternal age at first birth ≤ 19 years. Moreover,
- young mother need to engage with the inclusive education to reduce the challenges of child
- 243 health and nutrition. A longitudinal investigation is necessary to determine the causal connection
- between the maternal age at first birth and the undernutrition of under-five children.
- Additionally, young mothers need special program during pregnancy and the postpartum period.
- 246 Moreover, a qualitative study might be helpful to understand the sociocultural factors that related
- 247 with young maternal age and child undernutrition.




Fig. 1. Sampling flow chart for the selection of the participants




Fig. 2: Percentage of undernutrition of under-five children
