Unintended events in long-distance neonatal interhospital transport in Western Australia: A

comparison of neonatal specialist and non-neonatal specialist transport teams.

Abstract

Objective: To compare unintended events in transport performed by neonatal specialist (NS)

and non-neonatal specialist (NNS) teams in Western Australia (WA).

Study design: Retrospective comparison of neonatal transports from the Kimberley and Pilbara

regions (WA) to tertiary services, King Edward Memorial (perinatal) and Perth Children's

Hospital NICU, in Perth (state capital, distance up to 2200km) between January 2018 - June

2021. NS teams travelled from the tertiary to the referring center and back. NNS travelled from

the referring to the tertiary center. Transport time, team composition, total unintended clinical,

endotracheal tube (ETT), and logistic events were compared. Categorial data are expressed as

numbers (%) and compared by chi-squared test; continuous data are expressed as median

(interquartile range) and compared by Mann-Whitney U test.

Results: During the study period, 3,709 infants were transported in WA to tertiary services for

escalation of care: 119(3.2%) from the Kimberley and Pilbara, 49 with NS and 70 with NNS

teams. NNS had shorter transport times than NS teams (508(435-609) vs 871(615-735) min;

p<0.00001). Neonatal nurses were on NS more than NNS teams (36/49(73.5%) vs 6/70(9%);

p<0.001). Total unintended clinical and ETT events were less in NS vs. NSS teams

(28/49(57%) vs. 54/70(77%); p=0.02) and (0/26(0%) vs. 7/23(30%); p=0.004). Unintended

logistic events were greater involving NS than NNS teams (31/49 (63%) vs. 33/70 (47%);

p=0.05).

Conclusion: Although NS teams had longer transport times and more unintended logistic

events, there were fewer unintended clinical and ETT events. NS teams should be considered

as the first choice to undertake neonatal transport.

Introduction

Emergency transport is a critical component of centralized neonatal care. Centralization of

preterm and low birth weight infants has been recommended worldwide for many years (1),

improving outcome survival and morbidity. (2-6). Despite best efforts to transfer high-risk

women antenatally, some infants require stabilization and transfer to a tertiary-level Neonatal

Intensive Care Unit (NICU) after birth. Infants cared for by healthcare staff inexperienced at

newborn resuscitation take longer to intubate, have more attempts to establish intravenous

access and have a higher rate of hypothermia (7).

Western Australia (WA) is the largest single retrieval area in the world (2.6 million km²), with

highly centralized neonatal intensive care and transport services located in the state capital of

Perth – Supplement 1. The tertiary centers comprise the perinatal center at King Edward

Memorial Hospital (KEMH) and the neonatal unit within the Perth Children's Hospital (PCH).

Newborn Emergency Transport Service of Western Australia (NETS WA) transfer infants from

rural WA to Perth in collaboration with the Royal Flying Doctor Service (RFDS) in fixed-wing

aircraft (turbo-propeller PC12 or jet PC24; Pilatus, Switzerland) Historically, non-neonatal

specialist (NNS) teams transported infants to Perth due to the prohibitive travel time (slower

turbo-propeller aircraft, PC12) and distance for a specialist team to transfer the infant. From

2016, following the expansion of the RFDS aeromedical fleet with jet aircraft (PC24, Pilatus,

Switzerland), it was now possible for an NS (neonatal specialist) team to transport infants to

Perth.

Survival of pediatric patients is improved with the use of specialized transport teams. (8)

Morbidity and adverse events during the interhospital transfer of older children have long been

established (9, 10). In transported pediatric patients, it has been reported that adverse events

were more common when non-pediatric specialist teams performed transfer; airway events

were the most common (11). There is insufficient evidence to support the positive effect of

specialist neonatal teams on morbidity or mortality (12). This study aims to test the hypothesis

that transports performed by neonatal specialist (NS) teams in WA have fewer unintended

events than those performed by non-neonatal specialist (NNS) teams.

Methods

All regional neonatal transports from the Kimberley and Pilbara regions of north-western

Australia to Perth between 1st January 2018 and 30th June 2021 were identified from a

prospectively collected electronic database and screened for analysis. Data were obtained from

NETS WA call conference notes, clinical observation chart and patient medical records.

Demographic data included gestational age, birth weight, sex, Apgar scores, and diagnoses.

This study was approved through the Governance, Evidence and Knowledge Outcome

oversight pathway in the Western Australia Health Department (2023-000420). Formal ethics

approval was waived.

Transport process.

Neonatal retrievals included all preterm newborns (<37 weeks' gestation) until 44 weeks

corrected gestational age and term infants (\geq 37 weeks gestational age) until \leq 28 days of age.

A neonatal transport was initiated by a phone call to the specialist transport service (NETS

WA) from a referring doctor, usually a pediatrician in a local hospital in the Kimberley or

Pilbara, requesting neonatal transport to a tertiary facility. A call conference was convened,

and clinical management was discussed. RFDS was contacted, and flights were requested. The

choice of transport team was governed primarily by the infant's location and the availability of

aeromedical resources. If aeromedical resources were in the Kimberley or Pilbara region, a

local pediatric doctor would accompany the infant with a RFDS flight nurse (NNS team). If a

NNS team accompanied the patient from the Kimberley or Pilbara, a NS team would meet them

at the airport in Perth and accompany the infant for the remainder of the journey to the tertiary

unit by road ambulance (approximately 20 Km). When NNS teams accompanied the infant, a

call was still required to NETS WA for clinical advice and logistical support. A neonatal

transport consultant had oversight of every transport. Phone calls were documented and

recorded. If the aeromedical resources were available in Perth, a NS doctor (and neonatal nurse

from 2019) would travel to the patient and transfer them back to Perth (NS team).

Key time points during the transport were recorded: time of the initial referral (call to NETS

WA), time of arrival of the NETS WA equipment to the cot side (in NNS transfer, the

equipment would be transported from the regional RFDS base (airfield) to the cot side at the

local hospital) and time of arrival in the tertiary NICU. Stabilization time was time from the

arrival of the transport team and equipment to the cot side until departure from the referring

hospital. Length of retrieval was the time taken from the team departure from the respective

base to the infant's arrival in NICU. The number of phone calls documented in the call

conference system was recorded. Calls not documented or not made through the call conference

system were not recorded or included in the data.

The principal reason for retrieval was documented. Suspected sepsis was defined based on the

clinical presentation and the referring doctor's assessment and treatment. Blood cultures and

parameters confirming the diagnosis of sepsis were not available during the transport.

Suspected congenital heart disease was defined as any suspected cardiac anomalies, including

arrhythmias, e.g., supraventricular tachycardia. Any other congenital anomalies were defined

as 'non-cardiac congenital anomalies'.

Physiology in transport

The Transport Risk Index of Physiologic Stability (TRIPS) score was calculated from clinical

observations at the three key time points described above. The score comprises four

physiological parameters (temperature, respiratory status, hemodynamic and response to

noxious stimuli), reflecting neonatal physiological status at that time point. The TRIPS score

predicts NICU mortality in the first seven days of life. A higher score indicates a more unstable

infant with a higher predicted mortality (13).

Team composition, definitions, and equipment.

Personnel were defined and recorded as follows: Medical staff accompanying the infant were

neonatologists or pediatricians. A neonatologist was a medical practitioner whose practice was

entirely in that area. A pediatrician (in this context) whose practice was mainly in pediatrics

but may include neonatal care. A junior practitioner was defined as less than five years and a

senior more than five years of experience. A neonatal nurse had more than three years'

experience in neonatal care and postgraduate qualifications in neonatal intensive care nursing.

A RFDS flight nurse/midwife (more than three years of postgraduate experience in critical or

emergency care who may have had previous pediatric or neonatal experience) was always

present on the flight (as a civil aviation requirement.) An NS team was expected to be made up

of a neonatologist and neonatal nurse; an NNS team comprised a pediatrician and RFDS flight

nurse.

The NETS WA equipment used to transport the neonatal patient was identical, and both teams

were oriented to its use. The same equipment was stored at the regional RFDS bases in the

Kimberley and Pilbara regions. Flight information was extracted from written records,

including the type of aircraft (turbo-propeller or jet), maximum cruising and pressurized cabin

altitudes.

Unintended events.

Unintended events during transport were documented contemporaneously, categorized as

clinical, logistic or equipment and compared between NS and NNS teams. Total unintended

clinical events included all events related to the endotracheal tube, hypoglycemia, hypotension,

and hypo-or hyperthermia. These events were also considered separately. Hypotension was

defined by the clinical need for fluid boluses or inotrope therapy as determined by the treating

physician. Hypothermia was defined as <36.5°C or hyperthermia >37.5°C (axillary) on arrival

in NICU. Infants undergoing therapeutic hypothermia were excluded from temperature

analysis. Hypoglycemia was defined as serum glucose <47mg/dL (<2.6mmol/l) as measured

with blood gas analysis. Logistic issues included delayed retrieval due to unavailability of

medical, aviation or ambulance assets. Equipment issues included problems with transport cot,

stretchers, and devices.

Deaths

Deaths were reported up to seven days after admission to the receiving NICU. The reason for

death was extracted from mandatory documentation and the medical notes.

Statistics

Categorical data are presented as numbers and percentages (n, %). Comparison of categorical

data is compared by Pearson's chi-squared. Continuous variables are presented as the median

and interquartile range (IQR) and compared by the Mann-Whitney U test. Comparison of the

TRIPS score variables at three different time points is by a non-parametric analysis of variance

with repeated measure (Friedman test). Statistical significance was considered < 0.05.

Results

Between 1st January 2018 and 30th June 2021, there were 3709 emergency neonatal retrievals

in Western Australia: 119 (3.2%) transports were undertaken from the Kimberley or Pilbara

regions. An NS transport team transported 49 infants, and NNS transport team, 70.

Patient characteristics

Characteristics of transported infants, reason for transfer and respiratory support on transport are described in Table 1. The NS team mainly transported infants with respiratory distress, prematurity, or a suspected congenital cardiac anomaly; NNS teams transported infants with respiratory distress or a suspected neurological or surgical disease. NS teams transported more ventilated infants than non-neonatal teams (26/49 (53%) vs. 23/70 (33%); p=0.047).

Physiology

Physiology scores (TRIPS) at referral, the arrival of the transport equipment at the cot side and

arrival in NICU for definitive care are described in Figure 1. The TRIPS score increases across

all three-time points when the infant is cared for by the NS transport team compared to the

NNS team (p<0.001)—Figure 1.

Transport characteristics

Transport characteristics, length of transport time and composition of teams is described in

Table 2. NNS teams had shorter duration of transport times and times from decision to retrieve

to arrival in NICU (508 (435 – 609) vs. 675 (615 – 735); p<0.00001 and 715 (568 – 848) vs.

871 (770 – 1030); p<0.00001) There were a greater proportion of senior medical practitioners

present with NS than NNS teams (43 (88%) vs 42 (60%); p<0.001. There were more neonatal

nurses present on NS (36/49 (73.5%) vs.6/70 (8.6%) p<0.001). NS teams were more likely to

travel by jet than turbo-propeller aircraft (58/70 (82.9%) vs. 19/49 (39%); p<0.001).

Unintended events

The total number of clinical events was less in the NS group than in the NNS group (28/49 (57%) vs. 54/70 (77%); p=0.02). There were fewer unintended events with an endotracheal tube in infants transported by NS compared to NNS teams (0/25 (0%) vs. 7/23 (30%); p=0.004). Hypoglycemia and hypo- or hyperthermia were more similar between groups. The number of

logistical events was greater in the NS teams compared to the NNS group (p=0.05). Each group had a similar number of unintended equipment events. Unintended events are described in Table 3.

There were no deaths before the transport team arrived at the referring hospital or during the transport. Four deaths occurred within seven days of the transport, all following treatment redirection. Two-term infants with severe hypoxic-ischemic encephalopathy and two extreme preterm infants with extensive intraventricular and pulmonary hemorrhage.

Discussion

Infants transported by NS and NNS transport teams in Western Australia between January 2018 and June 2021 demonstrated differences in team composition, unintended clinical events and logistics. NS teams transported more ventilated infants, had more neonatal nurses present during transport, and had fewer total unintended clinical events and unintended endotracheal tube events.

Few data exist to show improved outcomes in infants transported by specialist neonatal transport teams. Children transported by specialist pediatric services have fewer adverse events than non-specialist teams, especially unplanned airway events, cardiopulmonary arrest,

hypotension, and loss of intravenous access (14). Consequently, pediatric specialist transport

teams have demonstrated improved survival (8).

To compare neonatal transport outcomes, we selected several previously published quality

metrics; dislodgement of therapeutic devices, temperature control, hypoglycemia, and

hypothermia (15-18). In our study, NS and NNS teams were noted to have a difference in total

unintended clinical and endotracheal tube events. We speculate that the presence of neonatal

nurses as part of the transport team improved these outcomes. Neonatal nurses routinely

travelled on specialist transport flights from January 2019. Before this, flight nurses were only

present. This explains neonatal nurses' <100% presence in the specialist group. No data

describes the benefit of specialist nurses in transport medicine or neonatology in general. In

other disciplines, it has been long recorded that specialist nurses improve outcomes (19).

The physiological condition of the infants in this study was assessed using the TRIPS score

(13). TRIPS was recorded at three key time points during the retrieval. Intubated infants score

highly in the TRIPS score (13), likely to be this cohort's major contributor. The TRIPS score

increased over time in the NS compared to the NNS teams. This reflects the greater potential

physiological instability and medical needs of infants transported by specialist teams. The NS

teams transported a higher proportion of preterm infants, those who had suspected cardiac

lesions or were ventilated.

Neonatal transports from northwest WA were long journeys over many hours in all

circumstances for both NS and NSS teams (675 vs. 508 min). NNS teams travelled from the

referring hospital to receiving NICU. NS teams travelled double this distance. Transport times

were shorter but not by half the time. NS teams were more likely to travel by jet aircraft and

had more unintended logistic events than NNS. Unsurprisingly, the greater distance had more

likelihood for delays due to the multiple steps in the transport journey. The longer journey time

and more logistical problems accompany fewer unintended clinical events. Time-critical

transports, e.g., bilious vomiting (20), require urgent and expeditious transport for definitive

intervention. Patient acuity, logistics, timeliness for care and experience level of the team

should be considered for the safest possible transport.

Our study is one of only a few reports comparing NS and NNS transport teams (12, 21).

Strengths include reliable and comprehensive clinical status, processes, and logistics

documentation from a well-maintained, prospectively acquired dataset. All transports were

similar regarding equipment and consultant oversight regardless of the team composition,

allowing for a like-for-like comparison. WA's unique geographical and healthcare

circumstances allow for a quasi-randomized comparison of specialist delivery in neonatal

transport. Jet aircraft and the addition of a neonatal nurse to the NS team were introduced at

differing time points during the study period. Group differences might have been more apparent

if the specialist teams had this enhanced capability throughout the study period. Small study

numbers and retrospective analysis limit our study. Due to small patient numbers, analysis of

vulnerable populations and specific clinical outcomes, such as extremely preterm infants or

those with hypoxic-ischemic encephalopathy, are not possible.

NNS teams in the Kimberley and Pilbara regions of Western Australia have extensive

experience in providing high-quality neonatal stabilization and transport. There has long been

a necessity for providing this care in WA for neonatal patients, given the limited availability

of fast, long-range aircraft in WA and the distance to tertiary NICU. The acquisition of jet

aircraft has provided greater opportunity for specialist neonatal teams to transport sick infants

long distances in WA. Specialized neonatal nursing care appears vital in improving safety in


the transport of infants.


