## 15 Background

- 16 The home-based vaccination card (HBR) is an important health record for determining vaccination
- 17 status of children during surveys, particularly in low- and middle-income countries (LMICs).
- 18 However, there are limited evidence on the factors that influence its retention in Ghana. We
- 19 assessed the predictors of vaccination card retention in Tamale Metropolis, Ghana

## 20 Methods

- We conducted a cross-sectional study from 21<sup>st</sup> December 2022 to 10<sup>th</sup> January 2023 among children aged 0-59 months in the Tamale Metropolis. Multi-stage sampling was used to select caregivers of children aged 0-59 months for enrolment in the study. Data were collected using
- validated questionnaire through face-to-face interviews of caregivers. A vaccination card was
- retained if it was presented for physical inspection by research assistants. The factors that influence
- vaccination card retention were determined in a multivariate logistic regression analysis at p < 0.05.

# 27 **Results**

- A total of 1,566 eligible children were enrolled in this study. Vaccination card retention was
- 89.5%. Negative predictors of card retention included: being resident in the Nyohini (AOR=0.26;
- 30 95% CI=0.15-0.47) and Tamale Central (AOR= 0.52; 95% CI=0.30-0.92) sub-Metro areas, and
- children belonging to age group 24-59 months (AOR=0.40; 95% CI=0.23-0.67). On the other
- hand, paying for the vaccination card (AOR=5.20; 95% CI=2.98-9.04) was a positive predictor of
- 33 vaccination card retention.

# 34 Conclusion

- In this study, vaccination card retention among children aged 0-59 months was higher than national
- 36 estimates. Vaccination card retention was mainly influenced by place of residence, age of child
- and mode of acquisition of the card such as out-of-pocket payment. There is need to design and

#### 43 Introduction

Routine childhood vaccination is one of the most successful public health interventions, averting
four million deaths every year [1]. Aside protection against preventable diseases, vaccination
brings children and their families into contact with health systems, providing an opportunity for
delivery of other health services [1]. Routine immunization reduces vaccine-preventable disease

incidence [2], and antimicrobial use [3], resistance [4] and associated deaths [5].

- 49 In low- and middle-income countries (LMICs), home-based vaccination cards (HBRs) are the

- 54 In Ghana, vaccination data are collected during service delivery through vaccination registers and
- 55 individual HBRs. The vaccination registers are paper-based records kept in the facility and used
- 56 for estimating administrative coverages. The HBRs are kept by caregivers of children for follow
- <sup>57</sup> ups on the vaccination schedule and used as reference source for vaccination coverage surveys.
- Current available evidence revealed a national vaccination card retention rate of 78.5% [11], a decline from 2014 rate of 80% [12]. Understanding factors that influence vaccination card retention can help in the design and delivery of tailored messages to improve retention. However, studies on predictors of vaccination card retention are limited in Ghana. To fill this gap, and further understand factors for non-retention of vaccination cards among caregivers, this study assessed predictors of vaccination card retention aged 0-59 months in Tamale Metropolis, Ghana.

## 66 Materials and Methods

#### 67 Study design

- This was a community-based analytical cross-sectional study conducted from 21<sup>st</sup> December 2022
- to 10<sup>th</sup> January 2023 among children aged 0-59 months in the Tamale Metropolis. This study was

coefficient (ICC) of 1/3, assuming that 10% of eligible respondents will not be available or will

# 91 Selection of respondents

92 Multi-stage sampling was used to select respondents. In stage one, all 63 clusters were purposively

selected from the four (4) sub-Metros in Tamale. Clusters were made up of demarcated CHPS
 zones in the study area, and a list of all clusters and the communities under each cluster was

obtained from the Tamale Metro Health Directorate. In stage two, a list of all communities in each

cluster was generated and coded. Sixty-three (63) communities, one from each cluster were then

97 selected using simple random sampling. In stage three, the initial house was selected using the

- 98 central pen-spinning technique. Subsequently, houses were selected using an interval of three and
- 99 two in urban and peri-urban localities respectively. In stage four, simple random sampling was
- 100 used to select eligible children.

# 101 *Eligibility criteria*

All caregivers of children aged 0-59 months were included in this study. Caregivers of children
 above 59 months, those who had never received a vaccination card, and those who declined were
 excluded.

# 105 Data collection

106 Data were collected using validated questionnaire by the WHO for assessing routine immunization

107 coverage [15]. The questionnaire consisted of socio-demographic variables of eligible caregiver-

108 child pairs, vaccination coverage using card and caregiver recall of vaccination questions.

109 Questionnaire was deployed using the latest android version (v2021.2.4) of KoboCollect App [16]

in Samsung mobile tablets. Trained research assistants collected data through face-to-face

111 interviews with respondents. During the survey, caregivers were requested to present vaccination

112 cards to confirm retention.

# 113 **Quality assurance**

114 Research assistants were given a day's training on survey objectives, methods and how to ask

115 questions to elicit appropriate responses. Tools were pretested and modified by investigators to

enhance clarity. Biodata and vaccination record pages of eligible children were taken to confirm

117 card retention. Submitted questionnaires were checked for correctness and completeness.

# 118 **Operational definitions**

119 A vaccination card was defined as any document given by a healthcare provider stating the 120 vaccination status of an eligible child [17].

121 A caregiver is defined as an individual who provides physical and psychological care for the child.

122 Card was retained if a document was seen and verified by research assistants as proof of 123 vaccination status of eligible child.

### 125 Data analysis

Data were exported from KoboCollect into excel for cleaning before being imported in Stata Version 15.1 (Stata Corp (2017) Stata Statistical Software: Release 15. College Station, TX.) for analysis. Card retention was the outcome variable, which was determined through correct "Yes"/ "No" responses to the physical inspection of a vaccination card presented for review of research assistants by caregivers as proof of vaccination status. The exposure variables were sub-Metro, sex of child, age of child, place of delivery, sex of caregiver, age of caregiver, employment status of caregiver, and educational status of respondent, relationship of child to respondent and whether

- 133 card was paid for (out-of-pocket).
- 134 The predictors of vaccination card retention was assessed through a logistic regression model. The
- factors that showed significant association in the univariate regression analysis at p<0.05 were fitted in the multivariate regression analysis.

### 137 Ethical Approval

This study received approval from the Navrongo Health Research Center Institutional Review
Board (Approval ID: NHRCIRB495). Verbal consent was obtained from caregivers of eligible

- 140 children before enrolment in the study. Study objectives, approach and rights of respondents were
- 141 explained in detail and clarifying questions addressed by the research assistants.

#### 142 **Results**

## 143 Sample description

Though our estimated sample size was 1512, we enrolled 1577 eligible children. However, only1,566 were included in the data analysis after cleaning.

## 146 Vaccination card retention

147 Of the 1,566 sample, 89.5% presented vaccination cards as proof of vaccination status. Of the

- remaining 164, misplaced (63.4%) was the predominantly reportedly reason for non-retention,
- 149 followed by other reasons such as not knowing where it is being kept during the study or feeling
- lazy to retrieve card (28.1%), and destroyed (8.5%).

151 In a multivariate regression analysis, sub-Metro type, age of child and whether card was paid for 152 or not were significant predictors of vaccination card retention. Living in Tamale Central (AOR=

- 153 0.52; 95% CI=0.30-0.92) or Nyohini (AOR= 0.26; 95% CI=0.15-0.47) sub-Metros was negatively
- associated with card retention. Similarly, compared to children aged 0-11 months, those aged 24-
- 155 59 months had lower odds (AOR=0.40; 95% CI=0.23-0.67) of retaining their vaccination cards.
- However, caregivers who paid for the card had higher odds (AOR=5.20; 95% CI=2.98-9.04) of
- 157 retention (Table 1).

#### 165 **Discussion**

166 Our study shows a high (89.5%) vaccination card retention rate. This is similar to nationally

reported rate of 80% in 2014 [12] and 78.5% in 2022 [11]. A study in Nepal [18] reported similar

- card retention rate of 82.2%. In contrast, lower rates of retention have been reported by other 168 studies in Senegal (73.7%) [19], Uganda (66.0%) [20], Cameroon (29.9%) [21], Zimbabwe (68%)
- 169
- [22], Nigeria (63.3%, 32.6%) [23,24] and Pakistan (66.2%). 170
- Residing in Nyohini or Tamale Central sub-Metros was negatively associated with vaccination 171
- card retention. This may be partly explained by the fact that caregivers in these sub-Metros may 172
- have low awareness level on the importance of keeping the vaccination card, as this may have not 173
- been emphasized by healthcare providers who issued cards. 174
- Similarly, children aged 24-59 months had reduced odds of having their cards retained. Studies in 175
- Senegal [19], Uganda [20] and Pakistan [26] have reported similar findings that older children 176
- were less likely to retain vaccination cards. The possible reason for this is that caregivers don't 177 178 understand the importance of keeping the card after completing the vaccination schedule.
- Caregivers who paid for the vaccination card had increased odds of retaining it. The possible 179
- reason is that caregivers who pay for the vaccination cards recognize its value and are more likely 180
- to take good care of them. On the other hand, they may want to avoid paying for replacement in 181
- event of a loss. However, sale of vaccination cards is against the vaccination policy in Ghana, even 182
- in times of shortages, when health facilities print copies to support service delivery. It is expected 183
- that the cost of making copies of the vaccination card be borne by the health facilities without 184
- transfer to service users. 185

#### Strengths and limitations of the study 186

- 187 This study used a relatively large sample; therefore, the findings can be interpreted in wider context. Additionally, the study used an objective measure through physical inspection to assess 188
- card retention. However, findings of this study should be interpreted in the light of the fact that as 189
- cross-sectional study, it difficult to establish causality between exposures and vaccination card 190
- retention. Additionally, the failure of some of the caregivers to present cards for inspection does 191
- not mean that the children do not have them. 192

#### **Conclusions** 193

- 194 Our study found high vaccination card retention rate. Sub-Metro, age of child and payment for card were significantly associated with vaccination card retention. 195
- Health care providers in the Nyohini and Tamale Central sub-Metros should endeavor to intensify 196 education of caregivers on the importance vaccination cards and the need for safe keeping. 197 Additionally, caregivers of older children should be educated about the importance of keeping 198
- cards after the child has completed vaccination schedule. Given that payment for card improves 199
- 200 retention, vaccination cards should be supplied to health facilities and made readily accessible to
- caregivers to prevent out-of-pocket payment. 201
