Background: Ethiopia is one of the countries with the highest burden of neglected tropical diseases

# 1 Abstract (250-300 words)

3 (NTDs), with 16 of 20 recognised NTDs considered a public health problem, twelve of which have 4 been identified as public health priorities by the Ethiopian Federal Ministry of Health. However, until 5 recently NTDs have not received adequate attention at national and subnational levels in the 6 country. 7 Methods: This study was conducted in Damot Gale district, Wolaita Zone in (Southern Nation 8 Nationalities Peoples Region) SNNPR, Ethiopia and used a mixed methods approach to evaluate an 9 intervention integrating four common NTDs (trachoma, lymphatic filariasis, schistosomiasis and 10 podoconiosis) into Ethiopia's primary healthcare system. The intervention consisted of adapted job aids, supportive supervision, and improved supplies of medical tools to improve diagnosis, 11 12 management and reporting. 13 Results: found that the intervention was successful at improving the detection, management and 14 reporting across the four common NTD's included and had a high level of acceptance from health workers. The intervention demonstrated cost-effectiveness. 15 16 **Conclusion:** The findings highlight the need for further investment and consideration of integrating

17 and scaling up NTD interventions at the primary healthcare level in Ethiopia, demonstrating that

18 providing a package of interventions to support integration can be a cost-effective method.

# 19 Author Summary (150-200 non-technical summary of the work)

20 Building on the findings of a previous small-scale operational study and formative phase, this study 21 involved implementing an intervention to integrate the prevention, diagnosis, management and 22 reporting of four common NTDs — trachoma, lymphatic filariasis, schistosomiasis and podoconiosis 23 - into Ethiopia's primary healthcare system. The intervention consisted of providing health workers 24 with adapted job aids, supportive supervision and improved diagnostic and medical supplies to 25 facilitate NTD diagnosis, management, and reporting. It was implemented for six months in one 26 hospital, one health centre and five health posts in Damot Gale district, Ethiopia and the feasibility, 27 acceptability and cost-effectiveness were evaluated. Results indicate that the capacity of all enrolled 28 health facilities for detecting, managing, and recording target NTDs improved over time. The use of 29 intervention materials by health workers also increased over time. The intervention tools proved to 30 be highly acceptable to health workers who viewed them as helpful, relevant, and easy to use. The 31 findings highlight that providing a package of interventions to support integration can be a cost-32 effective method and that the integration and scale of NTD interventions at the primary healthcare 33 level in Ethiopia should be considered.

# 34 Introduction

Neglected tropical diseases (NTDs) are a diverse group of diseases that are mainly prevalent in tropical 35 36 areas, with over 40% of the global NTD burden concentrated in sub-Saharan Africa [1]. NTDs affect 37 more than 1.5 billion of the world's population, particularly communities with higher poverty rates, 38 and women and children [1]. In recent years, the global development community has come together 39 to tackle the burden of NTDs, agreeing on an ambitious NTD roadmap [2]. Reducing NTD morbidity 40 and mortality is formally recognised as a target for global action in SDG 3.3, which calls to 'end the 41 epidemics of [...] neglected tropical diseases' to 'ensure healthy lives and well-being for all at all ages' 42 [3]. Although a great deal has been achieved by NTD programmes during the past decade, progress 43 towards achieving NTD and universal health coverage (UHC) targets will depend on bringing NTD 44 programmes, functions and activities into the mainstream of broader health systems. In addition, 45 efforts to innovate and intensify the management of NTDs must focus on ensuring that these diseases 46 are detected and managed within primary healthcare systems [1]. The 2030 NTD global roadmap also reaffirms the importance of integrating efforts across NTDs and within national health systems in the 47 context of UHC and coordinating stakeholders in NTDs and related areas [4]. 48

49 Ethiopia is one of the countries with the highest burden of NTDs, with 16 of 20 recognised NTDs 50 considered a public health problem, twelve of which have been identified as public health priorities 51 by the Ethiopian Federal Ministry of Health [5]. However, NTDs have not received adequate attention 52 at national and subnational levels in the country until recently. The Ethiopian Third National NTD 53 Strategic Plan (2021-2025) lists the mainstreaming of NTDs into the routine healthcare delivery system 54 as a cross-cutting and strategic priority [6]. In addition, nationwide NTD mapping has been conducted, 55 control interventions for the various NTDs – including mass drug administration – have been scaled 56 up, and a post-treatment surveillance system and strong NTD research forum have been established 57 [7].

This study evaluated an intervention which integrates NTDs into primary healthcare. The intervention
focused on strengthening the detection, management, recording and reporting of four NTDs;

60 trachoma, lymphatic filariasis, schistosomiasis and podoconiosis. These NTDs were selected due to 61 being identified as public health priorities in Ethiopia [5]. Although these NTDs differ in their 62 transmission and management, there is overlap in the populations they affect, and the presentation 63 of these diseases can lead to stigma [8][9][10]. Nationwide mapping exercises conducted between 64 2013 and 2017 revealed 412 national districts and 70 districts in (Southern Nation Nationalities 65 Peoples Region) SNNPR were endemic for schistosomiasis [11]. Preventative chemotherapy, prompt 66 diagnosis and treatment of schistosomiasis, as well as access to clean water and good hygiene 67 practices, can help to reduce transmission. Ethiopia is also the most trachoma-endemic country in 68 sub-Saharan Africa, with a prevalence of active trachoma of 25.9% and blinding trachoma of 1.5% in 69 the Southern Nations Nationalities and Peoples' Region (SNNPR) in 2016 [12]. Trachoma can be 70 treated with antibiotics but in the case of repeated infection and if left untreated the disease can lead 71 to blindness. Prompt treatment of trachoma and good hygiene practices can help to reduce 72 transmission. Both lymphatic filariasis, caused by infection with filarial parasites, and podoconiosis, a 73 non-infectious disease, can lead to the abnormal enlargement of body parts, causing pain and severe 74 disability. Nationwide mapping exercises conducted in 2017 revealed 71 national-level districts and 75 24 regional-level districts were lymphatic filariasis-endemic [13]. Lymphatic filariasis preventative 76 treatments are used to prevent infections but once the disease has progressed management of 77 swelling in affected areas is the only option. As of 2021, the average prevalence of podoconiosis in 78 Ethiopia was 4% (an estimated 1.56 million cases), with the highest prevalence in SNNPR (8.3%) [14]. 79 Treatment for this disease is limited to lymphoedema management. For each of these NTDs 80 management can help to alleviate suffering and reduce stigma associated with the presentation of some of these diseases. 81

A previous small-scale operational research study was conducted in 2018 and provided the basis for this larger study, conducted between 2019 and 2021 [15]. This study comprised of two phases a formative phase and an intervention phase. The formative phase identified gaps in the integration of NTD services in the Ethiopian primary healthcare system and was used to inform the development of

a tailored, multi-component intervention. Data collected during the formative phase provided a baseline for evaluating the health system capacity component. The intervention phase piloted the intervention in selected health facilities for six months and evaluated for feasibility, acceptability, and implementation cost. This paper presents the results of this evaluation and outlines recommendations to ensure the sustainability of future NTD service integration within the Ethiopian primary healthcare system.

# 92 Methods

# 93 Study setting

94 The study was conducted in Damot Gale district, Wolaita Zone in SNNPR, Ethiopia. This district was 95 selected due to the endemicity of the four target NTDs and operational feasibility due to the proximity 96 to Malaria Consortium's sub-country office in Hawassa. Damot Gale is located 350 km south of 97 Ethiopia's capital, Addis Ababa, and 153 km southwest of Hawassa. The district is mainly rural and is 98 subdivided into 31 kebeles, with a population of approximately 183,720 as of 2017 [14][16]. Within 99 Damot Gale, Boditi primary hospital, Buge health centre and five rural health posts were selected to 100 implement the intervention. Inclusion criteria included having an adequate health workforce, access 101 to electricity, clean water and sanitation, no enrolment in other research studies and not receiving 102 support from non-governmental organisations.

## 104 Study design

105 The aim of this study was to evaluate the package of interventions developed to support the

106 integration of four common NTDs into the health system. The package of interventions included:

107 clearly outlining staff roles and responsibilities, providing clear and harmonized NTD case definitions,

- 108 providing job aids for integrated NTD detection and management, introducing sensitive diagnostic
- 109 tests for intestinal schistosomiasis, training for health workers and Health Extension Workers

- suspected targeted NTDs and social and behaviour change communication (SBCC) materials.
- 112 The intervention was evaluated using a mixed methods approach to determine the feasibility,
- acceptability and cost-effectiveness. The evaluation comprised of:
- Two observational assessments; one immediately after the health worker training, and one
- after the six-month intervention pilot. These aimed to determine the proportion change in
- 116 NTD assessments demonstrating adequate knowledge of target NTDs by health workers and
- 117 their use of the intervention materials.
- A health system capacity assessment to evaluate changes in the capacity of the study health
   facilities to detect, manage, record and report target NTDs.
- The collection and analysis of routine monitoring and evaluation (M&E) data from the study
   health facilities to identify any changes in NTD prevalence and service delivery post intervention.
- Key informant interviews (KIIs) with health workers, HEWs, health development army
- 124 members (HDAs) and community members to elicit their perceptions of the intervention's
- 125 reach, fidelity, acceptability and feasibility.
- A cost-effectiveness analysis to determine the intervention's value for money.

### 128 Data collection and analysis

Baseline data were collected during the formative phase and in April 2021 immediately after the health worker training. Endline data were collected in October 2021 six-months after the start of the intervention. Data collection procedures and data collector training were compliant with national COVID-19 prevention guidelines, with all participants wearing a facemask, maintaining physical distancing, washing hands frequently and regularly disinfecting materials. All data collectors had a first

degree or higher, experience within the Ethiopian healthcare system and spoke Amharic, English andWolaytegna.

### 136 **Observational assessments**

137 43 patients with signs and symptoms of target NTDs were enrolled and participated in the baseline 138 observation assessment in April 2021. In the endline observation assessment, conducted in October 139 2021, a total of 129 patients with signs and symptoms of target NTDs were enrolled and 140 participated. Data for the observational assessments was collected by a trained research assistant 141 observing health workers during patient consultations. To assure data quality, data collectors participated in a three-day training beforehand which included a pre-test of the observation 142 143 checklists. During each consultation the research assistant observed and recorded data using a 144 checklist developed for each facility type. The research assistant recorded the signs and symptoms 145 the patient presented with, patient history, the type of diagnosis or test (clinical examination, 146 laboratory test) received, the health worker's diagnosis, the health worker's recommendations in 147 terms of disease management (treatment, follow-up, home management), the treatment 148 prescribed, if the patient was referred, if the health worker recorded the diagnosis and the services 149 provided, and if the health worker consulted any guidelines or reference documents during the 150 consultation.

151 Baseline and endline observational assessment data were quantitatively analysed using SPSS to

determine the changes in health workers' knowledge during patient consultations, adherence to

153 intervention procedures, health worker ability to detect NTDs and the acceptability of the

154 intervention tools.

155 Health system capacity assessment

The health system capacity assessments were conducted by two trained data collectors. Structured questionnaires were used which covered the health facility profile and the following areas related to NTDs: general infrastructure, supervision, drugs and equipment, laboratory infrastructure and equipment, guidelines and job aids, health personnel, training and recording and reporting. Two

160 questionnaires were used: one for Boditi hospital and Buge health centre and one for the health posts. 161 Health posts do not have a laboratory and so questions on laboratory infrastructure and equipment 162 were omitted. The questionnaires were input into the data collection app CommCare and data were 163 collected electronically using tablets. To assure data quality, data collectors' skills were evaluated 164 during a pilot prior to data collection, data submitted in CommCare were checked daily and standard 165 operating procedures (SOPs) were developed to ensure consistency in data entry. Health system 166 capacity assessment data were exported from CommCare into Excel for analysis. The data were 167 analysed quantitatively and qualitatively based on the designed relevant six thematic areas: general 168 infrastructure, supervision, drugs and equipment, laboratory infrastructure and equipment, guidelines 169 and job aids, and training.

### 170 Routine M&E data

171 Routine NTD M&E data were retrieved from health facility records, which are captured using two 172 separate forms: one for diseases and one for service delivery, both through a DHIS2 tool. As HEWs are 173 not tasked with NTD reporting, reporting forms were prepared by the research team for HEWs to report suspected target NTDs. Results from schistosomiasis-related laboratory tests were also 174 175 recorded before and after the introduction of the intervention. Routine M&E data were analysed 176 quantitatively by inputting the collected data into Excel. The analysis was done based on data collected 177 on laboratory tests, disease reports related to target NTDs (DHIS2), service delivery reports related to target NTDs (DHIS2) and a parallel data reporting form developed by the research team. 178

179 KIIs

KIIs were conducted in October 2021 with 10 HEWs from five health posts (2 per health post), 8 health workers (4 from health centre and 4 from hospital level), 4 laboratory technicians (2 from health centre and 2 from hospital level), 2 data managers (1 from health centre and 1 from hospital level) and 5 HDA members. All participants were involved in either the detection, management or recording and reporting of NTDs at their health facility and were exposed to the intervention during implementation. KIIs were also held with male and female community members; 6 people living with

186 disability caused by a target NTD and 6 living without disability. Topic guides were designed to explore 187 participant perceptions of the reach, fidelity, acceptability and feasibility of the intervention, including 188 their knowledge of the four target NTDs and their control. Health worker KIIs took place at their 189 respective health facility and community member KIIs were held in a neutral space such as a school. 190 All KIIs were conducted by trained data collectors. To ensure data quality, all data collection 191 procedures and tools were piloted for one day, with separate pilots for each local language. KIIs were 192 conducted in the participant's preferred language (Amharic, English or Wolategna) and audio recorded 193 using a digital recorder.

194 Community-level key informants were identified and selected through convenience sampling, based 195 on their availability and willingness to participate. Health system-level informants were identified and 196 selected by the Malaria Consortium team based in Hawassa on the basis of their role and experience 197 of working on NTDs within the Ethiopian primary healthcare system.

198 A thematic analysis was conducted for data collected during KIIs [17]. Audio recordings were 199 transcribed verbatim and translated into English where applicable. For those KIIs not conducted in 200 English, data quality and translation accuracy were assured by checking a sample of the transcripts 201 and backtranslating these into the local language. Transcripts were read to generate a coding list, 202 which was then applied to all transcripts. The software MAXQDA 2020 was used to manage, code and 203 retrieve data. Potential themes were identified and data relevant to each theme were collated; these 204 were then discussed among the research team before final consolidation. Theme names were agreed 205 by the research team and each theme description was refined and substantiated with compelling 206 participant quotes.

### 207 Cost-effectiveness

A cost-effectiveness analysis was conducted to measure the resource flow or total value of resources used to improve NTD services through integration into primary healthcare. A cost-effectiveness analysis compares an intervention's costs to its outcomes. It expresses outcomes in natural health units, in this case the proportion change in terms of primary healthcare capacity in detecting and

212 managing target NTDs through the introduction of the intervention, as well as the system's capacity 213 to produce relevant, timely and accurate data with regard to disease burden. The ratio of net 214 programmatic costs vs. net programmatic effects was determined and the costs incurred per 215 disability-adjusted life year (DALY) averted with that of the current gross domestic product (GDP) per 216 capita compared.

The TreeAge Pro 2021 software was used for the cost-effectiveness analysis. The software constructs a decision analytic model with a Markov process to estimate the programmatic costs incurred and the health impacts (in terms of DALYs averted) within the project. The decision tree model follows a series of steps to construct a tree structure under uncertainty for alternative options and selects the least expected cost per effect as the best alternative among the constructed steps.

### 222 Informed consent and ethical considerations

Prior to the observation assessments and KIIs, participants were given an information sheet and consent form to read which included information on the withdrawal of consent at any point and the contact details of the study coordinator. Participants were allowed up to an hour to confirm their participation and were guided through the information sheet to assist their decision. For illiterate participants, data collectors read the information sheet and consent form aloud in the local language and confirmed their consent to participate by marking their digital fingerprint.

To ensure participant confidentiality and data authenticity, audio files and transcriptions of KIIs were kept in secure, locked cabinets, accessible by the Malaria Consortium research study team. Paper consent forms and KII topic guides were stored in opaque carriers at all times. A unique identification code was used to anonymise subject data (e.g. 1001) and subject identifiers were not used on data forms or during KIIs. Data stored in electronic formats were password protected.

This study was approved in June 2020 by the SNNPR Public Health Institute Research Ethical Committee. However, implementation of study activities was delayed due to COVID-19-related restrictions imposed by the Ethiopian government. To address these delays, an amendment

- agreement between The Task Force for Global Health and Malaria Consortium was signed for a costed
- extension of the project by nine months until December 2021.

### 239 **Results**

- 240 Observational assessment of service providers
- 43 patients with signs and symptoms of the four target NTDs were enrolled and participated in the
- baseline observation assessment. In the endline observation assessment, a total of 129 patients with
- signs and symptoms of target NTDs were enrolled and participated. The participant characteristics are
- summarised in supplementary information Table 1.

### 245 Adherence to intervention procedures

The proportion of each of the five assessment stages (outlined in table 1) was used to calculate the proportion of NTD assessments demonstrating adherence to intervention procedures by health workers at baseline compared to endline. At endline, proportion change improvement, which ranged from 20% to 53%, was shown in four out of the five assessment stages, compared to the baseline. The proportion of one assessment stage, 'appropriate application of examination procedures', showed a minor decrement (-1%) at endline compared to baseline.

# 254 Health system capacity assessment

Table 2 summarises the results of the health system capacity assessment conducted before and after the intervention pilot at Boditi primary hospital, Buge health centre and the five rural health posts. Overall, there was a marked increase in the capacity of the primary healthcare system to detect, manage and record NTDs post-intervention implementation. More attention was given to the integration of NTDs into routine services, which previously only focussed on mass drug administration (MDA).

## 263 Routine M&E data collection and analysis

264 Retrieved routine laboratory data related only to intestinal schistosomiasis as the intervention assigned point-of-care circulating cathodic antigen (CCA) diagnostic tests for this NTD at the hospital 265 and health centre level. Prior to the intervention pilot, which took place from July to September 2021, 266 267 these health facilities used microscopy for schistosomiasis detection in wet mount stool samples. In 268 Boditi hospital, before the intervention pilot, of the total 942 stool samples taken with wet mount microscopy, no schistosomiasis cases were detected, possibly due to the reduced sensitivity compared 269 270 to point-of-care CCA tests or microscopic quality issues. After introduction of the intervention, 16 tests 271 were performed using CCA test kits, three of which were positive. As a result of the intervention the 272 case detection rate increased from 0% to 18.75%. 273 In Buge health centre, before the intervention pilot, a total of 83 stool examinations were performed 274 using microscopy, with only one case positive for schistosomiasis. After the intervention pilot a total 275 of 181 CCA tests were performed, of which 65 schistosomiasis cases were detected. As a result of the 276 intervention the case detection rate increased from 1.2% to 35.91%. These results are summarised in

277 Table 3.

#### 280 **DHIS2 disease reports**

281 Prior to the intervention, target NTDs were not reported in DHIS2 reporting forms at Boditi hospital 282 or Buge health centre. However, after the intervention, 3 schistosomiasis cases and 3 trachoma cases 283 at Boditi hospital and 51 schistosomiasis cases at Buge health centre were reported. No lymphatic 284 filariasis or podoconiosis cases were recorded during the reporting period at either health facility. 285 However, this is because these diseases are not included in the DHIS2 disease reporting tool.

#### 286 **DHIS2 service delivery reports**

287 Results of NTD service delivery data, which are reported electronically through DHIS2 on a quarterly 288 basis, are presented in Table 4. At Boditi hospital, there were no reported NTD services before the 289 intervention, however lymphedema management and trichiasis surgery were initiated after the six-290 month pilot period. At Buge health centre, the lymphedema management and trichiasis surgery were 291 intensified after the intervention period, with the number of lymphedema cases increasing fivefold. 292 There were no hydrocele operations reported at Boditi hospital or Buge health centre before or after 293 the intervention.

#### 296 Health post data

297 There is no formal system for recording and reporting disease data at the health post level, therefore 298 monthly parallel reporting forms were developed as part of the intervention. For this reason no

- suspected target NTDs were recorded before the intervention period. After the provision of parallel
- 300 reporting forms and training on their use, all health posts initiated recording suspected NTD cases and
- 301 referral to the nearest health centre. The suspected cases recorded before and after the intervention
- 302 implementation are shown in Table 5.

# 305 Key informant interviews

The following results are from KIIs held with health staff and community members. Health staff included those at the health post, health centre and hospital level who were involved in either the detection, management or reporting of NTDs at their health facility and were exposed to the intervention during implementation. Community members included both those living with and without disability caused by the target NTDs.

### 311 Acceptability and usability of training materials received by health staff

Most participants received materials during the training, including guidelines on NTD detection, management and follow-up, manuals, registration books, referral forms and job aids. Materials were used regularly to assist with NTD detection and management, to advise other staff and to determine the appropriate drug dosage. Participants described the materials as clear, easy to understand, user-

For some, "it is a 344 very good thing", they should be encouraged to do so and "we need to support them to identify those 345 346 cases and bring them to health facilities". Others did not foresee any challenges and believed that as 347 people are aware of the benefits of seeking care and being educated on NTDs, they will be willing to 348 listen to and cooperate with the HDA and HEWs. Although supportive of the idea, some participants 349 mentioned the need to ensure all the necessary resources are available beforehand, such as drugs and 350 equipment. However, a few community members had negative perceptions, describing how NTDrelated problems are beyond the capacity of the HDA and HEWs and "they can't treat such problems". 351 For a community member with disability, the additional task would not have a positive impact on 352 health outcomes as drugs will still remain unaffordable for many. ## 359 Health staff perceptions of the intervention

358

The vast majority of health workers felt confident to perform NTD responsibilities during the intervention, mainly due to the training and materials received. However, a small proportion of HEWs did not feel fully confident due to the training being "too short". Most participants also believed in the intervention's approach for ensuring reliable NTD detection and noticed an improvement in patient outcomes. The main challenge spanning all four NTDs was the shortage of drugs and equipment to

- perform tasks. The impact on workload was also raised, except for schistosomiasis, which resulted in
   many health staff feeling this may affect the sustainability of the intervention.

### 374 Recommendations for NTD integration into primary healthcare

375 Health staff made several recommendations for integrating the detection, management, recording 376 and reporting of NTDs into primary healthcare. These included having health workers and community 377 leaders conduct awareness-creation activities within communities to "use every opportunity to deliver 378 messages that can bring significant change". Ensuring the necessary supplies (e.g. drugs and equipment) are available was frequently highlighted as an important factor to ensure the 379 380 sustainability of NTD services. It was suggested that drugs and services should be provided free of 381 charge as those susceptible to NTDs are often of low socioeconomic status, which may in turn encourage more healthcare-seeking. Having a dedicated focal person "who will work only on NTD-382 383 related issues at each level" to reduce the work burden on HEWs was also raised, this focal person 384 should be incentivised to boost their motivation. Other recommendations included continuous 385 support and follow-up on health workers from higher bodies and non-governmental organisations and 386 regular trainings. This should also involve kebele leaders. Review meetings to evaluate these activities, 387 including experience-sharing between different kebeles may facilitate future improvements in service 388 provision. For one health worker, cooperation within the primary healthcare system and having a well-389 structured health post-hospital linkage was critical.

### 405 **Outcome of integration**

406 The main outcome measures at baseline and endline are shown in Table 7. The main outcome 407 measures used for the effectiveness calculation included: the proportion of NTD assessments 408 demonstrating adherence to target NTD intervention procedures by health workers (primary); the 409 proportion of change in heath workers' ability to detect target NTDs over time (secondary); the 410 proportion of change in heath workers' ability to detect and mange target NTDs over time (secondary); 411 and the proportion of health workers and HEWs who can adequately detect and record target NTDs 412 at the end of the intervention period (secondary). These measures are again converted to gains in 413 years of life lived without disability (gains in YLL) based on the Global Burden of Diseases Study for 414 Ethiopia for 2017 [18].

## 417 Cost-effectiveness of service integration

Assuming the effectiveness of the intervention (gains in health workers' ability to detect NTDs) to be 34.43, the cost-effectiveness ratio of the intervention would be 21.23 (730.94/34.43). This ratio (730.94) results from dividing the total annual cost of intervention (USD 450,478) by the estimated decrease in DALYs lost (616.3) due to the increased ability of detection that came about following the integrated interventions. Based on comparison with the mean per-capita GDP prevailing at the period of project implementation (the willingness-to-pay threshold of one times the GDP per capita), the intervention can be considered cost-effective since the per capita cost of 730.94 USD is below the GDP

- 425 per capita (USD 936.34) that prevailed during the intervention period. The input parameters for the
- 426 cost-effectiveness model are outlined in Table 8. The cost-effectiveness model is shown in Figure 1.

## 431 **Discussion**

Overall, results from the study were promising. The health system capacity assessment revealed encouraging changes in the functions of the study hospital and health centers after the implementation of the intervention. Results showed that target NTD service delivery improved after

the six-month intervention pilot, particularly in lymphoedema case management for lymphatic filariasis and podoconiosis, which can be attributed to the provision of training, job aids, drugs, supplies and materials. This reflects a similar result from the recent EnDPoINT study, also conducted in Ethiopia, which highlighted the need for continuous on-the-job training and supervision to maintain quality service delivery [13].

440 The study found there is a need for improved M&E data collection and analysis to support improved 441 NTD case management. Overall, data on the target NTDs showed remarkable improvements post-442 intervention, which can be attributed to the positive impact of the intervention on service delivery. 443 For example, there was a dramatic increase in the number of schistosomiasis cases detected at 444 hospital and health centre level, from one case (with microscopy) pre-pilot intervention, to 68 cases 445 through CCA tests during the intervention implementation, demonstrating the improved sensitivity of 446 the tests. However, a significant disparity between laboratory data and data reported through DHIS2 was observed pre- and post-intervention at Buge health centre, which may be attributable to errors 447 448 in recording and reporting. Furthermore, the number of trachoma cases reported through DHIS2 449 appeared relatively low, considering the intervention areas are trachoma-endemic. Further 450 investigation for corrective action is needed to fully understand this.

Our study demonstrated increases in the reporting of suspected schistosomiasis and trachoma cases 451 452 at health posts, however further study is needed to determine the intervention's impact on the 453 reporting of suspected lymphatic filariasis. In addition, further effort is needed to advocate for the 454 integration of podoconiosis into the DHIS2 reporting platform. Given the importance of effective and 455 efficient data reporting highlighted by the study, due attention is needed at Ministry of Health level 456 to include NTD case reporting at the health post level, as this will enable the true burden of NTDs to 457 be documented and the proper referral and management of cases tracked. This was further 458 highlighted by a recent study conducted in Kenya, which also showed low-performance surveillance 459 in relation to NTDs and the need to strengthen this going forward [20]. Similarly, work done by

460 Sightsavers in Ethiopia calls for the improved use of surveillance and data integration to eliminate 461 trachoma [21].

462 The study found improvements in the primary outcome, adherence to target NTD intervention 463 procedures by health workers over time, with a 5.4 percentage point improvement between baseline 464 and endline (from 72.1% to 77.5%). This was slightly lower than expected and could have been due to 465 the influence of the pandemic on service delivery, with many health systems suffering from service 466 delivery issues during this period [22]. However, when specifically observing the ability to detect target 467 NTDs over time, a notable increase of over 10% was discovered. This could reflect the focus on diagnosis as part of the intervention and the provision of improved diagnostics, as well as job aids. 468 469 These results reflect the findings from other recent work conducted to support NTD case management 470 [23]. These results are further supported by looking at the associated actions over time, such as 471 consulting job aids (increased from 60.5% to 83.7%) and the use of the appropriate job aid for the age group (increased from 60.5% to 80.6%). 472

The qualitative findings demonstrated widespread acceptability of the intervention by health workers and HEWs at the end of the intervention period, and participants reported increases in knowledge and skills, and positive perceptions of the job aids' ease of use. Many health workers reported feeling confident managing NTDs since the training, however others said additional training would be beneficial. Health staff and community members also mentioned some persisting contextual barriers that could affect the effectiveness of the intervention. These barriers included: a lack of human resources, the availability of equipment and the affordability of treatment.

Considering 'gains in health workers' ability to detect target NTDs' as a main outcome measure, there was a 34.43% percentage point increase. The difference (as measured in total DALYs averted) amounts to a gain of 616.3 life years among beneficiaries in the catchment area of the programme, and the cost-effectiveness ratio of the intervention is 21.23 (730.94/34.43). Therefore, as the per capita cost of the intervention (USD 730.94) is less than the mean per capita GDP prevailing during the intervention period (USD 936.34), the intervention can be considered cost-effective.

486 Overall, the findings from this study highlight the need for further investment and consideration of 487 integrating and scaling up NTD interventions at the primary healthcare level in Ethiopia, and that 488 providing a package of interventions to support integration can be a cost-effective method. Routine 489 health services for morbidity management and disability prevention caused by NTDs are still lacking. 490 even though they impose a huge burden on affected individuals and their communities in terms of 491 physical and mental health, and psychosocial and economic outcomes. More must be done to improve 492 the prevention, diagnosis, treatment and management for these diseases to move towards national 493 and global goals to eliminate NTDs and achieve universal health coverage. NTDs also 494 disproportionately affect women and efforts to reduce the incidence of these diseases will also help 495 to redress gender inequalities that persist in health.

### 496 Limitations

497 The study was postponed by six months due to the COVID-19 pandemic and data collection methods 498 were adapted to respect infection prevention and control measures. Focus group discussions were 499 replaced with KIIs to limit person-to-person contact, which meant fewer participants were recruited 500 due to time limitations, resulting in a narrower range of views and opinions being captured. The 501 pandemic also hindered the full sample size being obtained in the initial assessments, however, this 502 was compensated for by over-achieving the sample size in the final assessments. The research team 503 worked hard with the district, regional and national health officials to ensure medicines and supplies 504 were allocated to the research site, however, stock-outs were occasionally experienced. When this 505 occurred, the team procured the necessary items as required. The comparison of CCA and microscopy 506 to determine schistosomiasis case positivity rate pre- and post-implementation of the intervention, 507 with the increased detection possibly due to the increased sensitivity of point-of-care CCA tests 508 compared to microscopy, opposed to other intervention factors.

# 509 Conclusion

- 510 The capacity of all enrolled health facilities for detecting, managing and recording target NTDs, 511 through the introduction of the intervention, improved over time. Similarly, the use of intervention 512 materials by health workers and HEWs increased over the intervention period. The intervention tools 513 proved to be highly acceptable to health workers and HEWs, who viewed them as helpful, relevant 514 and easy to use. Furthermore, patients and caregivers appeared to be satisfied with the new NTD 515 services offered at the different levels of the health system. The intervention was also seen to improve care-seeking behaviours over time and be cost-effective. 516 517 To strengthen the detection, management and reporting of target NTDs in Ethiopia health workers
- and HEWs should continue to receive regular training and supportive supervision. Support to ensure sustainable, robust routine data collection for NTDs must also continue. Further work is needed to evaluate the feasibility and effectiveness of this intervention using a hybrid effectivenessimplementation evaluation design. Further work is also needed to integrate podoconiosis and lymphatic filariasis into the DHIS2 reporting system to ensure the effective management and reporting of these diseases.
