38 Abstract

- 39 Background: Post-traumatic stress disorder (PTSD) and chronic pain are highly prevalent
- 40 comorbid conditions. Veterans dually burdened by PTSD and chronic pain experience more
- 41 severe outcomes compared to either disorder alone. Few studies have enrolled enough women
- 42 Veterans to test gender differences in pain outcomes [catastrophizing, intensity, interference] by
- 43 the severity of PTSD.
- 44 Aim: Examine gender differences in the association between PTSD symptoms and pain
- 45 outcomes among Veterans enrolled in a chronic pain clinical trial.
- 46 Methods. Participants were 421 men and 386 women Veterans with chronic pain who provided
- 47 complete data on PTSD symptoms and pain outcomes. We used hierarchical linear regression
- 48 models to examine gender differences in pain outcomes by PTSD symptoms.
- 49 **Results.** Adjusted multivariable models indicated that PTSD symptoms were associated with
- 50 higher levels of pain catastrophizing (0.57, 95% CI [0.51, 0.63]), pain intensity (0.30, 95% CI
- 51 [0.24, 0.37]), and pain interference (0.46, 95% CI [0.39, 0.52]). No evidence suggesting
- 52 differences in this association were found in either the crude or adjusted models (all interaction
- 53 p-values<0.05).
- 54 **Conclusion:** These findings may reflect the underlying mutual maintenance of these conditions
- 55 whereby the sensation of pain could trigger PTSD symptoms, particularly if the trauma and pain
- are associated with the same event. Clinical implications and opportunities testing relevant
- 57 treatments that may benefit both chronic pain and PTSD are discussed.

59 Background

Post-traumatic stress disorder (PTSD) and chronic pain are highly prevalent comorbid conditions 60 that affect the health and well-being of U.S Veterans (1.2). Those dually burdened by PTSD and chronic 61 62 pain may experience more severe psychiatric functional impairments and greater health care utilization 63 than those with either disorder alone (3-5). Women Veterans, the fastest growing demographic of 64 Veterans, experience disproportionally high rates of PTSD, 13%, compared to 6% of men Veterans, and 65 between 11-78% experience chronic pain, compared to 9-50% of men Veterans (6-10). Despite the 66 growing body of knowledge on comorbid PTSD and chronic pain, few studies have enrolled enough 67 women Veterans to test gender differences in pain outcomes (pain catastrophizing, interference, and intensity) in relation to PTSD symptoms. Understanding the potential gender variation in the severity of 68 chronic pain outcomes associated with PTSD symptoms has implications for developing gender-sensitive 69 70 assessment tools and treatment modalities for Veterans with PTSD and chronic pain.

Chronic pain is defined as pain lasting longer than three consecutive months and is associated 71 72 with decreased quality of life, increased medical costs, and increased substance use (11-14). In addition 73 to the higher musculoskeletal pain reported by women Veterans, they are more likely to report moderate 74 or severe chronic pain (15,16). At least one study found that women Veterans experienced greater pain 75 intensity, decreased physical functioning, and more affective distress despite reporting better self-76 perceived health than men (17). Additionally, gender role expectations and societal norms may influence how individuals perceive and communicate their pain experiences, potentially contributing to reported 77 78 disparities in clinical pain assessment, diagnosis, and offered treatment modalities (18–20). Finally, 79 previous studies have revealed higher pain catastrophizing, interference and intensity levels in Veteran 80 and civilian women compared to Veteran and civilian men (21,22).

PTSD is a mental health disorder that may develop after experiencing or witnessing a traumatic event and then subsequently developing a pattern of symptoms, including intrusion, avoidance, negative cognitions, and mood, or alterations in arousal and reactivity(23). It is associated with an increased risk of

additional mental health diagnoses, although most people who experience traumatic events do not
ultimately develop PTSD. Men Veterans report proportionally more combat-related exposures linked to
PTSD symptoms (24). However, women Veterans who served in post-9/11 combat zones, such as Iraq
and Afghanistan, report similar levels of perceived threat in the war zone as men (25,26). Women
Veterans also report a higher incidence of trauma exposures across the life course, including adverse
childhood experiences, military sexual trauma, and adult interpersonal violence, which may result in
higher rates of PTSD compared to civilian women (16,27).

Comorbid chronic pain and PTSD frequently co-occur in civilian and Veteran populations and are 91 92 thought to have a bidirectional and mutually reinforcing relationship (28,29). Chronic pain and PTSD are thought to share common underlying mechanisms. The shared vulnerability and mutual maintenance 93 theories have been used to explain the co-morbidity of these conditions. The shared vulnerability theory 94 95 posits that people with comorbid PTSD and chronic pain share common factors, such as anxiety 96 sensitivity, attentional bias, autonomic arousal, and psychobiological dysregulation, predisposing them to one or both conditions (28). The mutual maintenance model posits that in addition to shared vulnerability 97 98 factors (e.g., attentional biases, anxiety sensitivity), PTSD and chronic pain may exacerbate and reinforce 99 each other (29). This bidirectional influence may result in the experience of pain-related exacerbation of 100 PTSD symptoms by retriggering recollections of painful injuries sustained during the traumatic event. 101 Conversely, elevated PTSD symptoms may activate the body's stress response and the experience of 102 increased pain. The co-morbidity of chronic pain and PTSD has been found in treatment-seeking samples of PTSD and chronic pain patients (1,28). This mechanism has been well studied in predominantly male 103 104 Veteran (30) and civilian (31) samples, which may obscure important differences in the manifestation and 105 severity. While the findings of studies using Veteran samples support the central tenant of the mutual maintenance model, namely the mutually reinforcing and exacerbating influence of PTSD on chronic pain 106 107 outcomes, very few have had adequate numbers of men and women Veterans to identify differential

108	effects by gender (32). The current study assesses whether gender differences exist in association between				
109	PTSD symptoms and pain outcomes in a comparative sample of men and women Veterans.				
110	This manuscript reports the associations between probable PTSD symptoms and three dimensions				
111	of chronic pain outcomes: pain catastrophizing (negative thinking about one's pain), pain intensity (how				
112	strong the pain feels), and pain interference (how one experiences pain, pain interference with daily				
113	activities), in a sample of U.S. Veterans diagnosed with a chronic pain condition. Specifically, we				
114	assessed gender differences in the association between probable PTSD and chronic pain outcomes. Based				
115	on the higher prevalence of both PTSD and chronic pain among women Veterans, the study team				
116	hypothesized that gender differences would be present across strata of probable PTSD and chronic pain				
117	outcomes. This study extends previous research on the associations between PTSD and chronic pain due				
118	to the unique gender composition of our data, which includes approximately equal numbers of men and				
119	women Veterans with chronic pain.

138 Of the participants (n=1945) who met eligibility criteria, 1,737 completed the baseline survey,

and 811 were randomized to one of the intervention arms. Due to an a priori study aim to examine gender

140 differences, women were oversampled and comprised 48% of participants.

141 Measures

142 **Predictors**

143 *PTSD symptoms* were assessed using the PTSD Checklist for *Diagnostic and Statistical Manual of*

144 *Mental Disorders-Fifth Edition* (PCL-5) (34). The PCL-5 is a 20-item self-report measure that assesses

the presence and severity of PTSD symptoms over the past month (range, 0-80). Respondents are asked to

rate how bothered they have been by each of the 20 items on a five-point Likert scale. Response options

147 for all items are: "Not at all" (0), "A little bit" (1), "Moderately" (2), "Quite a bit" (3), or "Extremely" (4).

148 Items are summed with scores of 31 or higher, indicating probable PTSD and a need for additional

149 clinical assessment or PTSD treatment (35). PCL-5 scores were standardized and parameterized as

150 continuous in the analysis.

151 Outcomes

152 Pain Catastrophizing was assessed using the Pain Catastrophizing Scale (PCS) (36). The PCS is a 13-

item self-report instrument that asks respondents to reflect on past painful experiences and indicate their

- thoughts and feelings in response to pain (range, 0-52). Response options for all items are: "Not at all"
- (0), "To a slight degree" (1), "To a moderate degree" (2), "To a great degree" (3), or "All the time" (4).

Items are summed with scores of 30 or higher, representing a clinically significant level of pain 156 157 catastrophizing (36). PCS scores were standardized and parameterized as continuous in analysis. 158 Pain intensity and interference. The Brief Pain Inventory (BPI) subscales were used to assess participant 159 experiences of pain intensity (range, 0-10) and interference (range, 0-10) during the past week (37,38). 160 Pain interference was assessed by seven items asking the extent to which pain interferes with general activity, mood, walking ability, normal work, relations with other persons, sleep, and enjoyment of life on 161 162 an 11-point numeric rating scale from "Does not interfere" (0) to "Completely interferes" (10). Pain intensity was assessed by four items asking participants to rate their worst, least, average, and current pain 163 164 severity for the past 1 month on an 11-point numeric rating scale from "No pain" (0) to "Pain as bad as you can imagine" (10). BPI subscale scores were standardized and parameterized as continuous in 165

analysis (39).

Gender was identified by self-report on the study screening questionnaire. Answer options included: man,
woman, another gender, and decline to answer. Participants who identified as either "another gender" or
"decline to answer" were then re-coded for analysis using their administrative birth-sex as reported in
EHR.

172 Sociodemographic variables included self-identified racial identity ("White," "African American or

173 Black," "American Indian/Alaskan Native," "Asian," Native Hawaiian/Pacific Islander," and

174 "Multiracial"); ethnicity ("Hispanic or Latino" and "Not Hispanic or Latino"), highest level of

educational attainment ("High school or less," "Some college," "Bachelor's degree," and "Master's

degree or beyond"), and age. The patient facility where participants were recruited (Minneapolis,

177 Durham, or Greater Los Angeles VA Medical Centers) was also included in adjusted models.

178 Analysis

179	First, we conducted descriptive analyses summarizing distributions of all variables overall and
180	stratified by gender identity (Table 1). Crude and sociodemographic adjusted linear regression models
181	were used to quantify the association between PTSD symptoms and each pain outcome (pain
182	catastrophizing, intensity, and interference). We fit two sets of models (crude and adjusted) models to
183	assess the association between PTSD symptoms and each pain outcome. We additionally assessed effect
184	measure modification by gender (whether the association between PTSD symptoms and each pain
185	outcome differed by gender identity) by adding an interaction term to each model. Due to differences in
186	the scale range of all outcomes, all estimates were standardized to represent the number of standard
187	deviations of change in each pain outcome associated with a one standard deviation change in the
188	exposure variable, PTSD symptoms. Statistical significance was assessed at alpha level p<0.05. All
189	statistical analyses were conducted using Stata 17 (College Station, TX).
190	Results

191 <u>Participant Characteristics</u>

A total of 807 participants provided complete data on PTSD, pain catastrophizing, pain intensity, and pain interference on the baseline survey (n=807/811). Women in our sample were more likely to be employed, have four-year or more advanced degrees, be a member of a racially minoritized group, and be younger compared to men. Mean and standard deviations of scores for all outcome variables are also shown in Table 1. Women reported statistically significant higher mean scores for all pain outcomes and

197 PTSD symptoms compared to men.

Table 2 shows the standardized estimates, 95% confidence intervals (CI), and results from the

200 regression models examining the association between PTSD symptoms and pain outcomes

201 (catastrophizing, intensity, and interference). Results are shown for both the crude and the model adjusted

202 for sociodemographic characteristics. Results from the adjusted models indicated that PTSD symptoms

were associated with higher levels of pain catastrophizing (0.57, 95% CI [0.51, 0.63]), pain intensity

(0.30, 95% CI [0.24, 0.37]), and pain interference (0.46, 95% CI [0.39, 0.52]). No evidence suggesting 204

differences in this association were found in either the crude or adjusted models (all interaction p-205

206 values<0.05).

Discussion

This study investigated whether the associations between PTSD symptoms and pain 211 212 catastrophizing, intensity, and interference differed in an approximately equal sample of women and men 213 Veterans. While our bivariate results indicated higher average PTSD symptom scores, pain catastrophizing, pain intensity, and pain interference in women Veterans, the multivariable results did not 214 215 provide evidence of gender differences in this association. Our results revealed that higher PTSD symptoms had the strongest effect on elevated pain catastrophizing symptoms, followed by pain 216 217 interference and intensity in both men and women Veterans. Co-morbidity between PTSD and chronic pain has been well documented in civilian (40) and 218 Veteran samples (4,41). Previous studies assessing the association between PTSD symptoms and pain 219 220 outcomes in cut-points among Veteran (predominantly men >80%) samples have observed overall higher 221 levels of pain catastrophizing, interference, and intensity (4,5,31,42). The inequity in the gender 222 distribution in these studies left unanswered questions regarding gender differences, given gendered 223 variability in the timing and type of trauma exposure(s) that resulted in PTSD symptoms (26,27). While

224 our results support previous findings, showing robust statistical associations between PTSD symptoms

and pain catastrophizing, interference, and intensity, we did not find evidence of gender differences in thisassociation in our gender balanced sample (4,5,41,43).

227 The present study provides a unique contribution to the existing literature due to the size and 228 approximately equal proportions of men and women Veterans that allowed tests of heterogeneity of 229 effects in this association by gender. The ability to investigate gender differences regarding pain and 230 PTSD in previous Veteran samples has been hampered by poor recruitment and retention of women in 231 VA clinical trials, which typically average only 3-22% women (32,44). The lack of gender differences, may reflect the underlying mechanism of the mutual maintenance model whereby the sensation of pain 232 233 could trigger PTSD symptoms (intrusions, avoidance, arousal), particularly if the trauma and pain are associated with the same event and this mechanism operates similarly in men and women (28,45). In the 234 case of pain catastrophizing, this may reflect the tendency to magnify the threat value of pain, thereby 235 236 increasing feelings of helplessness and difficulty inhibiting pain-related thoughts (46). Alternatively, the 237 lack of gender differences in these associations may be in part due to the restriction that all Veterans in the current analysis needed to meet inclusion criteria for entry into the LAMP clinical trial, which may 238 239 make them more similar compared to the overall Veteran patient population. Eligibility criteria for this 240 clinical trial screened out those with recent diagnosis of a mental disorder (e.g., depression, suicidality), 241 which may have resulted in a clinical sample that is less psychiatrically severe compared to a typical sample of Veterans seeking chronic pain care. These restrictions may obscure gender differences present 242 in more psychiatrically severe patients with comorbid chronic pain conditions. 243

Elevated levels of pain catastrophizing, intensity, and interference in people with probable PTSD, highlight the need for interdisciplinary care modalities to target both PTSD and chronic pain symptoms. There have been mixed results regarding the efficacy of cognitive-based therapies in reducing comorbid PTSD and pain, with interventions generally demonstrating greater reduction in PTSD symptoms with little change in pain interference and intensity (41,47–49). Mindfulness-based therapies have demonstrated reductions in both PTSD and chronic pain outcomes, indicating their promise as an

effective treatment for people with comorbid PTSD and chronic pain (50–54). Finally, Veterans with
comorbid chronic pain and PTSD may specifically benefit from integrated and trauma-informed treatment
modalities that recognize the mutually reinforcing relationship between PTSD and pain (55). As the VA
continues to develop and test multimodal care for Veterans with comorbid trauma and pain conditions,
careful attention will be required to evaluate gender-sensitive treatment options (e.g. integrated into
women's clinic, online options) to ensure women Veterans feel comfortable accessing the required care to
address these highly co-prevalent conditions (56,57).

This study contributes to the literature by assessing associations between probable PTSD and pain 257 258 outcomes as well as findings related to gender differences in a Veteran population with highly prevalent PTSD and comorbid chronic pain. Some limitations must be considered when interpreting our results. 259 First, our sample may differ from civilian samples in important ways. For example, compared to civilian 260 261 samples, Veterans with chronic pain have higher average levels of PTSD symptoms (8). Additionally, we 262 were unable to account for gender differences in the onset of trauma across the life-course (e.g., Adverse 263 Childhood Experience, sexual assault, service-related exposures), where the timing, frequency, and 264 severity may relate to the onset of chronic pain symptoms. Finally, this analysis was conducted on a sample of participants who volunteered to participate in a mindfulness study for chronic pain. Therefore, 265 266 findings may not generalize to the broader population of Veterans with chronic pain. Despite these 267 limitations, our study has several strengths, including completeness of data, including survey and electronic health record data from a large, diverse, and balanced sample of Veterans with chronic pain. 268 269 Finally, this uniquely large and gender-balanced study cohort of Veterans allowed for analyses into 270 potential gender differences in pain outcomes by the presence of probable PTSD.

271 Conclusion

This study found that PTSD symptoms were associated with elevated levels of pain
catastrophizing, pain intensity, and pain interference in women and men Veterans. We did not find any
statistically significant gender differences in the associations between PTSD symptoms and pain

- 275 outcomes. The unique gender composition of this sample created an opportunity to test these differences,
- addressing a limitation present in other Veteran samples. Our results contribute to research in Veterans
- aimed at understanding shared underlying mechanisms of this co-morbidity and testing relevant
- treatments that may concurrently benefit both chronic pain and PTSD.
