## ABSTRACT

Post Traumatic Osteoarthritis (PTOA) of the knee is osteoarthritis (OA) occurring specifically after a significant acute injury to the joint. Approximately 50% of people with significant knee joint injuries, such as anterior cruciate ligament (ACL) rupture, develop symptomatic radiographic OA within 10 years. Although impacts of the disease are well-described, there is little known about the genetic risk of developing OA after a knee injury relative to idiopathic OA. There is an unmet clinical need to understand the aetiology of PTOA, which will help us to understand, predict and prevent PTOA.

In this Analysis Plan, we describe our methodological approach to performing a Genome Wide Association Study (GWAS) meta-analysis, developed by the Genetics of Osteoarthritis consortium (GO)-PTOA working group. We aim to determine if genetic variants associate with PTOA following a knee joint injury and understand whether these variants are similar to or different from those associated with idiopathic knee OA (iOA).

Summary statistics from six international cohorts and biobanks will be included in the meta-analysis. We have harmonized an approach to identify cases of acute knee injury, knee PTOA cases as well as controls. Our three main objectives are to identify genetic variation associated with:

- 1) knee PTOA independent of knee iOA
- 2) knee PTOA compared with knee injured controls without OA
- 3) knee PTOA compared with controls over 40 years of age without injury or OA

Although not part of our primary analysis, we also plan to identify genetic variation associated with the onset of knee PTOA in a time-to-event analysis in the future.

Where resources allow, sensitivity analyses for all aims will be carried out, adjusting for body mass index (BMI). For case-control analyses, either a logistic regression or linear mixed model (LMM) will be used. For later time-to-event analysis, a matched case-control Cox Proportion Hazards (PH) regression model will be applied. Cohorts will share their summary statistics with the central analysis site conducting the single meta-analysis for each GWAS, which is likely to be carried out in either METAL or GWAMA.

Findings from this work will potentially improve our understanding of PTOA pathogenesis and aetiology. Better understanding of genetic determinants could contribute to more accurate prognostic modelling and precision medicine in the future.

## 1.0 Objective of GO-PTOA

The objective of GO-PTOA is to identify genome-wide significant signals associated with post-traumatic osteoarthritis (PTOA) of the knee.

## 2.0 Purpose of this document

This plan has been written to reflect our approach to our planned work, supported by meetings of the GO-PTOA working group. In this document we cover the following:

- Background to the work we will carry out and its relevance
- Our main research questions and objectives
- The overarching principles in our methodological approach, including methods for case ascertainment and eligibility criteria
- The statistical approach and meta-analysis
- Publication plans
- Management of results including publicly available deposit of summary statistics and scripts post-publication

## 3.0 Background to work

Post-traumatic osteoarthritis (PTOA) of the knee is the osteoarthritis (OA) that follows clinically significant acute knee injury in a proportion of people. It is thought to affect around 50% of people experiencing a knee injury, such as anterior cruciate ligament (ACL) injury or acute traumatic meniscal tear. It comprises about 12% of all people with knee OA, but causes particular impact as it affects people earlier in their life course. The polygenic risks of knee OA as a whole are now well known. However, very little is understood about the genetic risk of developing OA after a knee injury. This is important for our understanding of OA as a whole and for translational research in OA (where pre-clinical modelling relies heavily on post-traumatic models, assuming that this disease is one and the same).

In summary, there is an unmet clinical need to understand, predict and prevent PTOA. A better understanding of the aetiology of PTOA, including genetic risk of PTOA is likely to give insight into its pathogenesis and that of OA. Understanding genetic determinants may contribute to more accurate prognostic modelling and to precision medicine in this area. Beyond this, determining the similarities and differences between non-traumatic 'idiopathic' OA (iOA) and PTOA are vital for the field as a whole, particularly for successful translational research and progress towards better tests and treatments for people living with or at risk of this condition.

## 4.0 Research questions

Our main question is to determine whether there is genetic variation associated with the development of PTOA after a knee joint injury.

**Our overall hypothesis** is that there is genetic variation associated with the development of PTOA after a knee joint injury (PTOA). We want to definitively answer whether these variants are the same as, or different from idiopathic knee OA (iOA) genetic variants.

**Our aims** are to carry out several linked GWAS meta-analyses to answer this question.

We will aim to show whether the genetic architecture of PTOA is the same as, or different to iOA.

## 5.0 Overarching principles in methodological approach

Our aim is to include as many GO cohorts/biobanks/collections (henceforth referred to as ‘cohorts’) to participate in the analysis as possible, in order to increase numbers of international cohorts and participants, and therefore our power and generalisability in answering our research questions.

We will do this by accepting some loss of precision in case ascertainment and allow increased heterogeneity in our methods of defining cases, whilst using a prior approach in UK Biobank as a starting guide as to how we might conduct a meta-analysis at scale.

Given the high frequency and impact of PTOA of the knee, that these cases can be identified from electronic data and also to increase homogeneity in analyses, our study will be exclusively in the knee.

The analysis will be carried out in two stages. Firstly, the consortium will work with each participating cohort to develop an approach to identify PTOA cases and appropriate controls so that each cohort can run their own individual GWAS studies (pre-defined case-control, and where possible also time-to-event) according to the principles laid out in this document. Secondly, each cohort will share the genome-wide summary statistics for their analyses with a single coordinating ‘central analysis site’, who will then carry out a single meta-analysis for each GWAS according to a pre-defined plan.

We will aim for **definition of PTOA knee cases** in one or both of the following ways:

1. Evidence of at least one clinically significant knee injury in a participant\*, which is likely due to acute trauma to an internal joint structure (at/within the knee joint) rather than elsewhere AND a subsequent OA code which is likely of the same knee (or of either knee if side is not known)
2. Evidence of a specific diagnosis of PTOA of the knee

\*When considering evidence for a clinically significant knee injury:

- This can be a range of knee injuries, but ideally without evidence of more extensive trauma (see Eligibility criteria, Appendix 1 & 2)
- A recall of a ‘history of knee injury’ by a patient that is not specific to a particular clinically assessed structural knee injury is not sufficient, without additional supporting evidence
- A clinician diagnosed injury of a relevant structure, supported by appropriate imaging evidence of an injury, and/or supported by a single diagnostic code or combination of diagnostic codes, such as on ICD-10 is sufficient

**Participation in GO-PTOA requires cohorts:**



- To be able to identify group i) listed below AND at least one of groups ii-iv), but ideally as many groups as possible
- To have the ability to undertake these analyses\* and supply the summary statistics by the agreed date in 2023

\*typically this is anticipated to be local analysis, or with support from other participants' teams e.g. Masters students within GO-PTOA, where this has been arranged in advance

The following groups shown in Figure 1 are mutually exclusive for the purpose of GWAS case-control analyses:

- Post-traumatic knee OA cases (as defined above) 'PTOA'
- Non traumatic/'idiopathic' knee OA (knee OA with no evidence of prior knee injury, however this is defined) 'iOA'
- Knee injured, no knee OA (after as much follow up as is possible) 'Knee injured controls'
- Injury free, OA free controls (age/sex matched where possible to cases of injury for the relevant analyses) 'Injury free, OA free controls'

### Figure 1: GWAS case control analysis groups

A summary 'knee injured group', which is the combination of i) and iii) is relevant for some analyses: these are all those who have been knee injured, irrespective of their OA outcome 'ALL Knee injured'. For inclusions and exclusions for each group/analysis, see Appendix 5.

#### 5.1. Case ascertainment and eligibility criteria: guiding principles

Methods for case ascertainment should be broadly informed by/based on prior work in UK Biobank (UKB) by some of this group and the discussions of the GO-PTOA working group at their first three meetings (see eligibility criteria and code lists, Appendix 1 and 2, meeting minutes).

Each cohort should consider the inclusion/exclusion criteria below and carefully document their approach and inclusion strategy, for example, by describing what types of injury are likely to have been included. However, the general guidance will be to allow different approaches and that, where these are felt likely to potentially represent substantially different groups, sensitivity analyses will be carried out. For example, if some inclusion approaches are more likely to be associated with associated fractures/more extensive trauma, analyses could capture susceptibility to bone fracture etc.

Where core/shared Eligibility criteria by participating cohorts can be retrospectively defined, these will be captured, or else summarised per cohort at reporting.

### 5.1.1. Inclusions: Knee injured

Considering the above and Inclusion Criteria from UKB analyses (Appendix 1A), a simplified/subset of inclusion criteria for definition of acute knee injury and for subsequent/related definition of PTOA of the knee will be outlined by each cohort.

Inclusion criteria will be considered, adapted and code lists or definitions refined and reported by each cohort for each of the 2-4 groups for this purpose (we will report at cohort level, as approaches will necessarily vary).

Cross-mapping (new or existing) from ICD-10 to other coding systems such as ICD-9 may be carried out to support this work. The need for this should be identified as soon as possible.

### 5.1.2. Exclusions (all groups)

Considering the Exclusion criteria for the UKB study (Appendix 2), adaptation of these can be defined by the cohort.

Where possible for the time-to-event analysis, these should be relative to the injury event, as described in Appendix 2A.

As a minimum, for all analyses, these should include as a minimum the ‘ever’ exclusions in this list of inflammatory arthritis, multiple site trauma, congenital bone disease, etc. as listed in Appendix 2B (these are a subgroup of Appendix 2A, items 6-12).

*These exclusion criteria should be applied to all 4 groups.*

For exclusions for group (i) PTOA cases only, where the presence of both injury codes and OA codes are used to define PTOA cases, it is important that in addition those with knee OA occurring before the injury, i.e. exclusion criterion 1, are excluded.

### 5.1.3. Knee OA outcomes

Knee OA codes: Codes/diagnoses compatible with ‘definite, probable or possible knee OA or total knee replacement/revision consistent with knee OA’ including codes consistent with post-traumatic OA knee (see Appendix 3A).

- Exclusions are if OA is of lower limb but not of the knee e.g. hip, ankle, or OA which is definitely not of lower limb. (Knee, hip and ankle location codes can be used where relevant, to improve specificity).
- Timing of OA outcome (where relevant) should be the earliest documented knee OA code.
- OA diagnosis should be 6 months or more after the knee injury.

## 5.2. Time dependent vs time independent analyses

Cohorts will fall in to two main groups in terms of case ascertainment for group (i) ‘PTOA’ in terms of whether they can define the exposure, injury and the outcome OA separately. Participating cohorts need to be clear which they belong to (it is also possible for a cohort to

contribute both types of cases to the analyses, in which case the two groups should be mutually exclusive):

*Where the knee injury is defined/timed and followed with a subsequent timed OA code/diagnosis or lack of OA code. In these cases:*

- The knee injury (defined as supported by Appendix 1A) should be between the ages of **16** (or 18 if lack of consent for this) **and 50 inclusive**
- An upper limit for the observation period of 20 years after the knee injury should be applied for cases of subsequent OA, or censoring to that date (or at death or last record if sooner)
- OA outcomes can include PTOA knee codes (see 5.1.4)
- Pre-existing OA prior to the injury or conditions which suggest this should be excluded (as supported by Appendix 2A)
- Knee OA diagnosis in the 6 months after injury ascertainment should be excluded (as likely pre-existing OA, see 5.1.4)
- These cohorts can contribute time-specific content to a time-to-event analysis if they are able to, as well as identifying so-called ‘time to event’ cases to contribute to the case-control analyses.

*Where there is no time stamp/specific record of the knee injury:*

The main example here is where there are combined ‘PTOA knee code cases’ (for example, as found in Appendix 1B) where there is no available prior information on what the knee injury was. In these circumstances, inclusions and exclusions may be simplified by the cohort (as cannot be relative to the timing of an injury).

Specifically:

- Age at time of injury may not be considered (any age at code is acceptable)
- Time between injury and OA cannot be considered (just clinical judgement that this is PTOA)
- Non time dependent exclusions (Appendix 2B) should still be applied

*Where cohorts are providing both types of cases from the same cohort:*

Only PTOA knee code cases that have not been identified in the time to event analyses should be supplied i.e., these two groups should be mutually exclusive.

Where a cohort has both methods of identifying PTOA cases, for primary analyses 2 and 3 (section 5.4), ‘time to event’ methods should be prioritised and only additional cases from PTOA knee codes not already identified should be combined with those identified in time-to-event analyses.

### **5.3. Other variables and baseline characteristic reporting**

Age at time of injury and sex are relevant covariates in the time-to-event analysis (i.e. they influence the outcome, the development of PTOA). As such, wherever possible, they should be used as covariates in time-to event analyses. Covariates therefore include:

- Age at time of injury
- Or, Age at time of inclusion (diagnosis/last follow up – see analysis section)

- Sex
- Global ancestry group (if different ancestral groups are included)
- First X genetic principal components (as defined by cohort)
- Any other cohort specific covariates, felt to be important by cohort, such as Genotyping chip

For all analyses, the following summary information should be supplied for the purposes of reporting on baseline characteristics (Table 1) for each cohort and for each study in the meta-analysis:

- Current age (median, IQR)
- Age at time of injury if known (median, IQR)
- Sex distribution (n/% female)
- BMI (at time of injury or other time point (report when in Appendix 5 tables) (median, IQR)
- Global ancestry group (if different ancestral groups are included)

#### **5.4. Power considerations and sample sizes**

Power calculations using UKB data indicated that for a full meta-analysis, a total sample size between 6,000 and 9,500 injury cases would be required to detect variants in a time to event GWAS with moderate hazard ratios (HR 1.2-1.25; assumed MAF = 0.3) and with power of 80%, at genome-wide significance.

To compare PTOA and iOA associations in a full GWAS meta-analysis, odds ratios of >1.2 could be detected at genome-wide significance with sample size of 2,750 PTOA cases (assuming an excess of iOA cases), though greater case numbers are preferable as they allow detection of smaller effect sizes.

Based on completed feasibility assessments within GO-PTOA participating cohorts (April 2022-February 2023), it is very likely that these sample numbers will be exceeded.

There will be no minimum sample size of PTOA cases in a participating cohort/collection to take part (though some cases will be necessary). However, those with smaller sample sizes may be combined (where genotypic data can be shared/accessible – noting this would not be typical or anticipated for the majority) or may be subject to sensitivity analysis, given that their inclusion may introduce a disproportionate amount of heterogeneity.

#### **5.5. Analysis approach**

One or more of these defined GWAS will be performed by the participating cohorts themselves, depending on their dataset and ability to carry out these analyses, prioritising as listed below. Meta-analysis of summary statistics from all contributing cohorts for that particular analysis will then be carried out by the Central Analysis Site for GO-PTOA.

The group's Analysis Lead will oversee the delivery of the meta-analysis at the Central Analysis Site. Regular meetings will be arranged to support those contributing data to the analysis with project management by the coordinating Imperial College team. A practical document for the primary analysis is included as Appendix 5, in support of this plan.

### Primary GWAS models\*:

The following analyses have been prioritised by the group, in this order. See Appendix 5 for inclusion/exclusion criteria for all case and control groups.

- A case-control GWAS of all PTOA cases vs. iOA
- A case-control GWAS of all PTOA cases vs. knee injured controls (no OA) without considering time to event/censor
- A time-to-event GWAS of all knee injured cases with available time information, looking at the subsequent event of presence of OA/PTOA, to 20 years of follow up or censor)\*

### Secondary GWAS models :

There will be 3 additional analyses, where cohorts have capacity:

- A case-control GWAS of PTOA vs. Injury free, OA free controls
- A case-control GWAS ALL Knee injured, no OA vs Injury free, OA free controls (to interpret any findings in (4) this will be necessary)
- A case-control GWAS of iOA vs. Injury free, OA free controls (to support post GWAS analyses)

\*to allow as many participants as possible to take part in the first primary analyses and maximise our power and achievability of our first analyses, case-control GWAS by participating cohorts (first, then second, fourth and fifth in the order listed here) have been prioritised for sequential analysis and submission, over the time to event analysis. The time to event analysis will be performed after these are case control analyses are complete, by those cohorts able to do this, informed by these first analyses.

Post GWAS analyses will be carried out in certain cohorts (nominated after combined meta-analysis, informed by the results from primary and secondary GWAS analyses above. A separate detailed post GWAS analysis plan will be written which will support these specific analyses. These are linked analyses and it is intended that these will include:

- **The predictive effects of polygenic risk scores (PRS) for iOA knee or total (any joint) OA on PTOA** will be assessed by creating and adding them as covariates in the time-to-event analysis in 1. (Exact methods to be confirmed but wherever possible, there will be cross-replication e.g. using iOA scores from one cohort in PTOA analyses of another cohort, to ensure generalizability of the scores.) This is likely not to be in the largest or smallest sample populations and would aim to include PRS from non-White populations.
- **Testing the coheritability between PTOA and iOA of the knee.** We will seek to quantify the shared and non-shared genetic risk for iOA and PTOA. Variance will be partitioned and quantified into that shared between PTOA and iOA, and that which is not co-heritable, by genome-wide LD score regression analysis applied to genome-wide summary statistics for PTOA knee (log hazard ratios or log odds-ratios) and iOA knee (log odds-ratios). We will test for heterogeneity, finding out if any effects seen are greater/lesser in PTOA.

## 5.6. Statistical approach

Our approach will use two main methods:

- For the time-to-event analysis, a matched case-control Cox Proportional Hazards (PH) regression model will be applied, implemented in SPACox (a module in R), GATE or similar. Scripts and methods will be shared with cohorts where this is being applied.
- For case-control analyses, either logistic regression or LMM will be used, at the discretion of the cohort, depending on what is most appropriate considering their population structure and size. Their selected method, software used and imputation methods should be reported by the cohort on the relevant tab on the Google sheet.

As per 5.3, covariates for both analyses will include genetic principal components (PCs), genotyping batch (where relevant), age at the time of injury (where available), sex and any cohort specific covariates (cohorts may determine the number of genetic PCs needed, with the aim of explaining approximately 80% of the variance as a benchmark, to make this as comparable as possible and report the numbers of these. The minor allele frequency will be  $\geq 0.01$ ).

Where used as an additional covariate in the post GWAS analyses, PRS for iOA (knee, any site) will be generated in cases that are independent to the time-to-event analysis.

## 5.7. Analysis by each participating cohort

Chip and method of imputation, number of genetic PCs, prior sample and SNP QC approach as well as inclusion/exclusion approaches will need to be summarised by each cohort.

Summary statistics for each GWAS carried out should include total sample size, chromosome, SNP position, HWE, allele1, allele2 (noting which is minor allele), frequency of allele 1 in cases, frequency of allele 1 in controls, beta/odds ratios (either log odds ratios/log hazard ratios relative to allele 1, depending on analysis), standard error (95% CIs), *P*-value (an example output .csv file will be provided to support their upload).

It is anticipated that PLINK will be used for GWAS analyses. R will be used for all other analyses. The output files may differ and file type should be notified to the coordinating site.

## 5.8. Meta-analysis approach

In all cases, the summary statistics from each of up to 6 GWAS analyses listed in 5.4 will be shared with the Central Analysis Site. The analysis team will use a fixed-effect variance weighted meta-analysis for each of the 6 analyses to produce 6 sets of meta-analysed summary statistics. (We will assume the same allelic effects over all studies but will test for heterogeneity between effects).

Analysis is likely to be carried out in METAL or GWAMA (this will be reviewed by the central analysis team, depending on the datasets), to enable checking for strand alignment. GWAMA may be preferable for additional trans-ethnic meta-analysis. Forest plots and relevant tests (I<sup>2</sup>) will be used to assess for heterogeneity.

Genome-wide significance threshold will be corrected for multiple testing.



## 5.9. Sensitivity analyses

To check if the methods for case ascertainment influence the results, we will report effect sizes across different types of methods of identification and carry out predefined sensitivity analyses.

These will include one or more of:

- omitting sample size outliers, i.e. very large or very small cohorts, to check how these affect results
- omitting certain ancestry groups (or if sample numbers for these subgroups allow, running specific meta-analyses within these)
- only considering variants found in at least 2 cohorts with the same direction of effect
- sensitivity analyses including BMI as a covariate
- sensitivity analyses excluding individuals/cohorts where there is a) a PTOA case with no prior knee injury information, i.e. PTOA case codes only and b) insufficient follow up of knee injured comparators

For details on sensitivity analyses, please see Appendix 5.

## 6.0. Post-meta-analysis activities

Fine mapping will be carried out for each independent signal, including all variants within 1Mb of the index variant, to extract potentially associated variants. Manhattan plots and Locus Zoom plots will be prepared. Approaches such as SuSiE will be used to generate a credible set. Ancestry specific and trans-ethnic fine mapping may be used, depending on the constituent cohorts.

We will tabulate hits with genome wide significance and search across open access databases including Open Targets Genetics Portal to identify candidate genes and other phenotypes associated with variants, reporting our findings.

We will aim to carry out independent replication of any findings in other replication cohorts not taking part in the GO-PTOA primary analysis.

## 7.0. Access, review and storage of results

### 7.1. During the GO-PTOA primary analysis

Summary statistics from each cohort in the agreed output format will be uploaded to a user-restricted Box account, supported by the Central Analysis Site. Genome-wide summary statistics for each meta-analysis generated during this study will be held in a central repository at the Central Analysis Site during the analysis. This will be a password protected secure private Github, with vetted access only to those who are members of the GO consortium (who have signed or agreed to abide by the principles of the GO memorandum of understanding) and who are approved by the GO consortium PTOA sub-project leaders (FW, analysis group lead). Summary statistics for cohorts will be made accessible to these approved members of the group to allow their combined analysis at consortium level, with transfer via SFTP between analysis servers where necessary.

The analysis and its results will be reviewed by the GO-PTOA group at each group meeting.

## **7.2. After publication of GO-PTOA primary analysis**

Following completion of analyses, summary statistics will be uploaded to a repository, at the time of publication.

Individual summary statistics will be uploaded locally as per cohort guidelines/requirements. Following publication, they will be uploaded to MSK Knowledge Portal as per GO consortium procedures, to allow open access <https://msk.hugeamp.org>. Final summary statistics for the meta-analyses will also be uploaded to the GWAS Catalog <https://www.ebi.ac.uk/gwas/>.

Summary statistics dropping out cohorts will be reviewed and may be necessary for upload for some local repositories.

It is intended that the analysis approaches, software/scripts and summary statistics will all be archived and publicly accessible when agreed by all group members, by public Github page, at the time of/following publication.

## **8.0. Publication**

The results of this analysis will be published in a peer reviewed open access journal. Publication/authorship policy will be in line with GO collaboration agreement and ICJME guidance, agreed by the group and represent the contributions of the cohorts, analysts, as well as analysis lead and group lead. Near final drafts will be circulated to the GO steering committee and other scientific committees of relevant cohorts at least 3 weeks before manuscript submission.

## **9.0. Coordination**

Please see the consortium's memorandum of understanding (January 2023) for guidance on consortium participation and overarching principles. The upload of summary statistics for this working group will be as listed in 7.1 and not to the Helmholtz servers; this analysis plan therefore intentionally supplements information in this document and deviates from it in this specific regard.

The coordination and leadership of this work is supported by UKRI (UK) Future Leaders Fellowship (MR/S016538/1 and MR/S016538/2) to Watt, Imperial College London, UK. The work is supported by the GO consortium, led by Zeggini (Germany). The analysis lead is McDonald (Birmingham, USA). Any funder(s) of the study were not involved in the study design; collection, analysis, and interpretation of data; writing of the report; or decision to submit the paper for publication.

Examples lacking sufficient evidence of clinically significant injury to an internal structure include MCL sprains (as opposed to rupture); presence of synovial plica; patello-femoral subluxation (as opposed to dislocation); quadriceps and patellar tendon injuries. Examples lacking sufficient evidence for acute trauma e.g. contusion, superficial wound, knee sprain.

## Appendix 1B: Known ‘Case-code PTOA’ codes for consideration in non-time dependent analyses

To be included, cases should achieve a code sufficient for osteoarthritis, location (i.e. knee) and linked prior trauma (post-traumatic OA code), from a single code<sup>1</sup> or in combination (e.g. knee location code can be separate). The identified examples are given below:

## Appendix 2: Exclusion criteria for knee PTOA cases

### Appendix 2A: Suggested Exclusion criteria for time-dependent analyses<sup>2</sup>

#### Exclusion criteria

The presence of any of the following, diagnosed at **any time PRIOR** to the date of the knee injury<sup>#</sup>:

1. Osteoarthritis (or non-specified arthropathy which could be osteoarthritis<sup>a</sup>) of either knee, hip or ankle
2. Partial or total knee arthroplasty of either knee, hip or ankle
3. Clinically significant injuries to the hip including hip and pelvic fracture.

The presence of any of the following, diagnosed **6 months or more PRIOR** to the date of the knee injury<sup>#</sup>:

4. Chronic instability or recurrent patellofemoral dislocation of the knee without evidence of a prior acute knee injury of known timing
5. Acquired structural abnormalities of the knee, without evidence of a prior acute knee injury of known timing (e.g. degenerative meniscus included cystic change, chondrocalcinosis) or which are not attributable to an acute knee injury that meets the inclusion criteria<sup>b</sup>.

The presence of any of the following **at ANY TIME** (prior, during or after the date of knee injury<sup>#</sup> and up until the first date of osteoarthritis or equivalent):

6. Inflammatory arthritis<sup>c</sup> or associated connective tissue disorder (e.g. rheumatoid arthritis, psoriatic arthritis, juvenile idiopathic arthritis, enteropathic arthritis, inflammatory spondyloarthropathy, Lupus or Sjogren's syndrome; generalised or lower limb gout, CPPD, reactive arthritis or septic arthritis); neuropathic arthritis or inherited collagen vascular disease affecting joints.
7. Clinically significant congenital structural abnormality of the knee, or clinically significant congenital or acquired structural abnormality of the hip or ankle (e.g. discoid meniscus, absence of anterior cruciate ligament, congenital dislocation of hip, protrusio acetabuli)
8. Septic arthritis or osteomyelitis of the knee
9. Individuals with non-normal weight bearing (e.g. wheelchair user, those with spina bifida or cerebral palsy, lower limb amputations)

Evidence of more extensive musculoskeletal trauma **within the 'injury window'** for the acute knee injury<sup>#</sup>:

10. Open or closed fractures of the lower limb which are not likely to be intra-articular in origin (e.g. proximal or mid femoral fractures, proximal or distal tibial fractures, distal fibular fractures).

## Appendix 2B: Suggested modified Exclusion criteria (for non-time-dependent analyses)<sup>3</sup>

Evidence of any of the following:

1. Inflammatory arthritis<sup>C</sup> or associated connective tissue disorder (e.g. rheumatoid arthritis, psoriatic arthritis, juvenile idiopathic arthritis, enteropathic arthritis, inflammatory spondyloarthropathy, Lupus or Sjogren's syndrome; generalised or lower limb gout, CPPD, reactive arthritis or septic arthritis); neuropathic arthritis or inherited collagen vascular disease affecting joints.
2. Clinically significant congenital structural abnormality of the knee (e.g. discoid meniscus, absence of anterior cruciate ligament)
3. Septic arthritis or osteomyelitis of the knee
4. Non-normal weight bearing (e.g. wheelchair user, those with spina bifida or cerebral palsy, lower limb amputations)
5. Open or closed fractures of the lower limb which are not likely to be intra-articular in origin (e.g. proximal or mid femoral fractures, proximal or distal tibial fractures, distal fibular fractures).
6. Clinically significant neurovascular or nerve palsies of the lower limb likely caused by lower limb trauma e.g. peroneal nerve, sciatic nerve or femoral nerve palsies.
7. Multisite musculoskeletal trauma, outside of the knee.

Please note these are exclusions 6-12 of the full exclusion criteria listed in Appendix 2A.

In addition, for (i) 'time to event' PTOA cases (where the presence of both injury codes and OA codes are used to define PTOA cases for case control analyses): it is important that those with knee OA occurring before the injury, i.e. exclusion criterion 1 from Appendix 2A, are excluded. That is:

1. Osteoarthritis (or non-specified arthropathy which could be osteoarthritis) of either knee, hip or ankle

## Appendix 3: Definitions of knee OA

### Appendix 3A: Knee OA outcomes after injury<sup>4</sup>

Outcomes selected include categories 1 and 2 using the OA classification in Table below. In some cases, category 2 codes do require a knee specific code (which in all cases makes them a 1) to sufficiently increase their specificity (primarily arthroplasty codes).

For time-dependent analyses, earliest available OA codes should always be used, i.e. revision arthroplasty codes would be superseded by an earlier first arthroplasty code; arthroplasty codes would be superseded by an earlier non arthroplasty OA code. Revision codes suggesting there has been prior surgery have been specifically highlighted as an earlier code would be expected, although they can act as OA outcome codes where no others exist\*.

^Column 'Knee/hip code' – where blank is no action and 'yes' indicates that code requires a knee code to ensure sufficient specificity (relating to arthroplasty codes).

\*Column 'Look for earlier code as knee revision surgery' - where blank is no action and 1 notes revision code, i.e. where there should be an earlier OA outcome code as this is repeated surgery

See associated adjudication of **OA outcome code** lists<sup>4</sup> eg ICD10.

Please note that PTOA knee codes should be included in these lists for time dependent analyses.

### Appendix 3B: Definition of idiopathic knee OA comparator group<sup>5</sup>

Idiopathic knee OA codes (KIOA) need higher specificity than those listed in 3A as OA outcomes.

These codes are a subset of ALLKOA, i.e. all the ‘category 1’ knee OA outcome code lists e.g. ICD10.

KIOA include cases of definite or probable knee OA, without prior knee trauma or ever history of PTOA

- All category 1 codes from the outcome code list given below (ALLKOA)
- Removing all secondary and ‘case code PTOA’ (CCPTOA), as listed in Appendix 1B.

## Appendix 5: GO-PTOA Primary Analysis including detailed methods for prioritised case-control analyses

### 1.0. Objective of GO-PTOA

The objective of GO-PTOA is to identify genome-wide significant signals associated with post-traumatic osteoarthritis (PTOA) of the knee.

### 2.0. Research questions

Our main question is to determine whether there is genetic variation associated with the development of knee PTOA.

Our overall hypothesis is that there is genetic variation associated with the development of knee PTOA. We want to definitively answer whether these variants are the same or different from idiopathic knee OA (iOA) genetic variants. Under this overarching hypothesis, we will execute the following aims:

#### 2.1. Aims

##### **Aim 1: Identify genetic variation associated with knee PTOA independent of knee iOA.**

To achieve this aim, each cohort will perform a case-control GWAS of knee PTOA vs. knee iOA cases (without knee injury history).

##### **Aim 2: Identify genetic variation significantly predictive of the onset of knee PTOA.**

Each cohort with available data will perform a time-to-event GWAS of all knee injured cases with available time information, looking at the subsequent event of presence of knee OA/PTOA, to 20 years of follow up or censor.

##### **Aim 3: Identify genetic variation associated with the onset of knee PTOA compared with knee injured controls without OA.**

Each cohort with available data will perform a case-control GWAS of knee PTOA cases vs. knee injured controls (no OA with adequate follow up).

##### **Aim 4: Identify genetic variation associated with knee PTOA compared with controls over 40 years of age without injury or OA.**

Each cohort with available data will perform:

- A)** case-control GWAS of knee PTOA cases versus Injury free, OA free controls;
- B)** case-control GWAS of knee injured versus injury free, OA free controls; and
- C)** case-control GWAS of knee iOA vs. Injury free, OA free controls

Results from these three models will be compared to identify genetic variants likely to be associated with knee PTOA rather than knee injury risk or knee iOA.

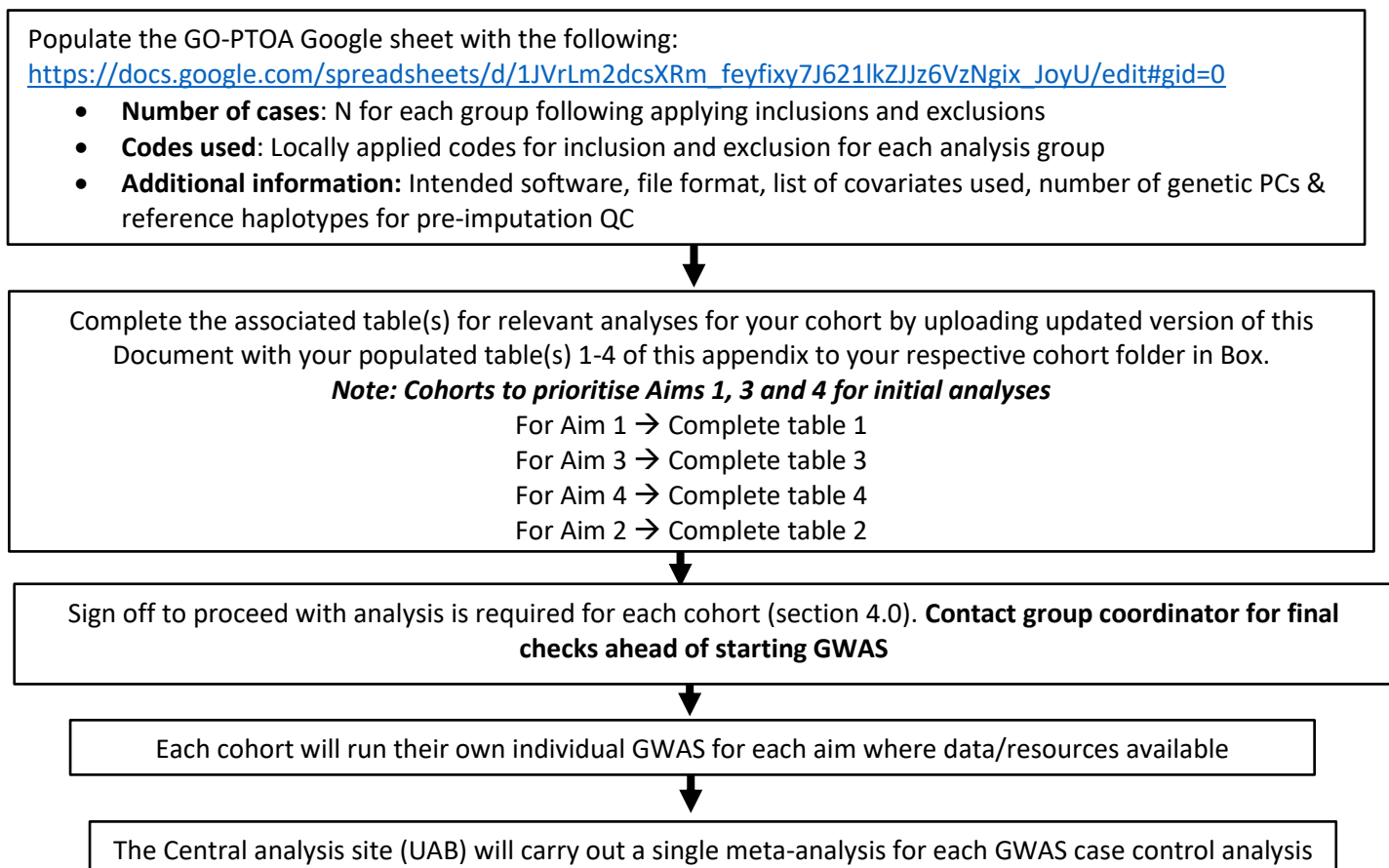
**Figure 1:** Summary of coding groups demonstrating redundancy of use in Aims to facilitate preparation of phenotype files. Additional details regarding each group are provided in section 3.0.

**Criteria for Aim 1 knee PTOA cases:**

**Inclusions:**

- Evidence of at least one clinically significant knee injury in a participant which is likely due to acute trauma to an internal joint structure (at/within the knee joint) rather than elsewhere (Appendix 1A) AND a subsequent OA code which is likely of the same knee (or of either knee if side is not known) at least 6 months after injury (Appendix 3A). (When considering evidence for a clinically significant knee injury, this can be a range of knee injuries, but ideally without evidence of more extensive trauma, see Eligibility criteria, Appendix 1 & 2)
- Injury occurring between the ages of **16** (or 18 if lack of consent for this) **and 50 inclusive**

**AND/OR**

- Evidence of a specific diagnosis by PTOA code (see Appendix 1B), where not identified already using the inclusion approach above (Appendix 1A).

**Exclusions:**

- Where there is time information, consider applying exclusions as per Appendix 2A if feasible

NB Pre-existing OA prior to the injury, or conditions which suggest this, should always be excluded

- OA code within 6 months or less after first injury code, where this is available
- For all cases (including where identified by specific PTOA code diagnosis), simplified exclusions, defined by cohort, supported by Appendix 2B, should be applied

Where resources allow and this is possible, for each Aim please also run your model adjusting for BMI.

The group recognise that BMI could be on the causal pathway for osteoarthritis following injury and, its inclusion could lead to collider bias. The timing of collection of BMI may vary between cohorts. However, the group also feel that the effects of BMI are important to consider and likely to be a reviewer comment. As such we plan to investigate its effects on our findings in this planned sensitivity analysis. If its inclusion affects our findings, we will attempt to understand why and report this.

##### **Aim 1: Identify genetic variation associated with knee PTOA independent of knee iOA.**

To achieve this aim, each cohort will perform a case-control GWAS of knee PTOA vs. knee iOA cases. *For the BMI sensitivity analyses, also perform analyses adjusting for BMI at time of OA diagnosis in study.*

Cohorts should upload their BMI-conditioned GWAS for Aim 1 to folder **'Aim1\_ALLPTOA\_vs\_KIOA'** on Box. Cohorts should name this file **'Aim1\_ALLPTOA\_vs\_KIOA\_BMI'**.

##### **Aim 2: Identify genetic variation significantly predictive of the onset of knee PTOA.**

Each cohort with available data will perform a time-to-event GWAS of all knee injured cases with available time information, looking at the subsequent event of presence of knee OA/PTOA, to 20 years of follow up or censor.

*For the BMI sensitivity analyses, please include all available BMIs for the subject during the 20 years of follow up.*

- C) case-control GWAS of knee iOA vs. Injury free, OA free controls

Results from the three models will be compared to identify genetic variants likely to be associated with knee PTOA rather than knee injury risk or knee iOA.

## **7.0. Overarching principles of analysis execution and sharing of summary statistics**

Each case-control analysis will be carried out in two stages, local analysis then upload and meta-analysis by the central site.

- 1) Each cohort will run their own individual GWAS for each aim where data and resources are available.
- 2) For the larger cohorts (especially when there is a case control imbalance) and resources permit, we recommend case-control GWAS analyses be performed using BOLT-LMM or SAIGE. For smaller cohorts, case-control analyses should be performed using tool team is most familiar with e.g. PLINK2, REGENIE This should be recorded in Google sheet

- 3) Recommended covariates to be used in case-control GWAS models: age, sex and local PCs for ancestry as appropriate. For BMI sensitivity analyses, either BMI at time of injury or BMI at PTOA/ OA diagnosis will also be used as a covariate.
- 4) Each cohort will share the genome-wide summary statistics for their analyses with the central analysis site, the University of Alabama at Birmingham (UAB), by uploading data to Box directory for their cohort/ study and Aim.
- 5) The Central analysis site (UAB) will carry out a single meta-analysis for each GWAS case control analysis.

## 8.0. Autosomal Analysis

### Genome-wide array data

Additional QC will be prudent following this, for example: Generate and visualize PCs, check for duplicates, differential missingness, inspection of intensity clusters for significant variants after case-control association analysis.

### Pre-imputation QC

Pre-imputation QC can be assessed using BioDataCatalyst imputation server and selecting quality control only under 'Mode' which will generate a QC report for your review prior to initiating imputation. However, we recommend additional pre-imputation QC excluding AT/GC variants as well as those deviating from Hardy Weinburg equilibrium  $P < 1E-4$ . This QC should be performed prior to uploading to the imputation server which has its own QC pipeline where each variant is checked and excluded if:

1. contains invalid alleles
2. duplicates
3. indels
4. monomorphic sites
5. allele mismatch between reference panel and uploaded data
6. SNP call rate <90%

### Post-imputation QC

We are working with Build 38. These are the coordinates for the pseudo autosomal (PAR1 and PAR2) and non-pseudo autosomal (nonPAR) regions on X chromosome.

Chr X region	Coordinates in bp (b38)
PAR1	chr X1 (< 2781479)
nonPAR	chr X2 (2781479 - 155701383)
PAR2	chr X3 (> 155701383)

Split the X-chromosome directly typed data into 2 datasets:

- (1) PAR1 and PAR2**
- (2) nonPAR**

We will QC these separately, as detailed below and then we combine at the end of this section. Example: In plink the data Xchr data can be extracted and separated into nonPAR and PAR12 by the following (here your genome-wide dataset = data.bed/bim/fam). Note that there may be no variants in the PAR12 region in your dataset.

```
plinkv1.9 --bfile data --chr 23 --split-x b38 no-fail --make-bed --out chrX
```

#### **(1) PAR1 and PAR2**

Please QC exactly as you did for the autosomes. Example: In plink this can be achieved by the following (chrX data was produced as above) we use an exclusion threshold of HWE  $p < 1 \times 10^{-4}$ , 1% MAF and 98% call rate.

```
plinkv1.9 --bfile chrX --chr 25 --hwe 0.0001 --make-bed --geno 0.98 --maf 0.01  
--out QCedPAR12_data
```

#### **(2) nonPAR**

Please split your cohort into males and females for the QC:

- In the female dataset perform your Hardy-Weinberg p-value filters and create a variant inclusions list (inclusions1)

Example: In plink this can be achieved by the following (chrX data was produced as above) for an exclusion threshold of HWE  $p < 1 \times 10^{-4}$

```
plinkv1.9 --bfile chrX --filter-females --chr 23 --hwe 0.0001 --make-bed --out female_nonPAR_data
```

```
cut -f 2 female_nonPAR_data.bim > Inclusions1
```

- In the male dataset prepare a list of variants that contain individuals that are heterozygous haploids prepare an exclusions list for these (Inclusions2)

Example: In plink this can be achieved by the following:

```
plinkv1.9 --bfile chrX --filter-males --chr 23 --from-bp 2699520 --to-bp 154931044 --make-bed --out male_nonPAR_data
```

If you have no male\_nonPAR\_data.hh file produced then you have no heterozygous haploids in your data and there are no exclusions to prepare. But if you do...

```
cut -f 3 male_nonPAR_data.hh | sort -u > Exclusions1
```

```
plinkv1.9 --bfile male_nonPAR_data --exclude Exclusions1 --make-bed --out male_nonPAR_data2
```

```
cut -f 2 male_nonPAR_data2.bim > Inclusions2
```

Include only variants that pass both QC in males and females (Inclusion3).

Example: to get the intersect from both lists you can use the following:

```
comm -1 -2 <(sort Inclusions1) <(sort Inclusions2) > Inclusions3
```

Extract these variants from the chrX file and include your usual call rate and MAF filters.

Example: In plink this can be achieved by the following, here with a 1% MAF and 98% call rate threshold:

```
plinkv1.9 --bfile chrX --extract Inclusions3 --geno 0.98 --maf 0.01 --make-bed --out QCednonPAR_data
```

### **(3) Combine the QCed PAR1, PAR2, nonPAR into a single file and code chrX as 23**

Males and females should be in the same file and the Xchr should be coded as 23 regardless if the variants are in the nonPAR or PAR region. This is because the imputation server need everything as 23 or X. example: In plink this can be achieved by the following, with the QCed data prepared and files name as above.

```
plinkv1.9 --bfile QCednonPAR_data --bmerge QCedPAR12_data --make-bed --out QCedXchr_data
```

```
plinkv1.9 --bfile QCedXchr_data --merge-x no-fail --make-bed --out QCedXchr_data
```

Quality control for HRC or older reference panels requires comparison of alleles and frequencies to reference panel. Details are here:

For TOPMed imputation, comparison to the TOPMed reference panel is performed within the imputation pre-QC. Details are here:

You will then need to prepare vcf files for upload as detailed in the link above.

### **Imputation**

Please make a note of the number of directly types variants as we will ask that you include this information in your data upload. Example: imputation with HRC haplotypes on the

Michigan server for a European cohort.

Reference panel: TOPMed r2 (hg38)  
Array Build: GRCH38/hg38  
Rsq filter: off  
Phasing: Eagle v2.4 (phased output)  
Population:: EUR  
Mode: Quality Control & Imputation

### Post imputation QC: for the imputed variants

We are stringent regarding the variants we include for chrX analysis. To summarise the process:

- Split chrX into nonPAR and PAR1+2
- For the nonPAR, we exclude the following:
  - Genotypes with genotype probability <0.9
  - Variants with call rate <99%
  - Variants with  $\geq 1$  heterozygote haploid genotype in males
  - Variants with Hardy-Weinberg  $p < 0.0001$  in females

### PAR1+2

For the PAR1 and 2 regions we extract the variants located in these regions but filter out variants with an estimated imputation accuracy (R-square) < 0.3. This data is ready to use for association analysis using the same protocol you applied for the autosomal analysis.

Example: Where the imputed vcf from HRC imputation server is named chrX.dose.vcf.gx.

```
tabix -f -p vcf chrX.dose.vcf.gz
```

```
bcftools view -r X:1-2699519,X:154931045-15527056 '-e INFO/R2<0.3' -Oz -o chrX.PAR12.filteredR2less0.3.vcf.gz
```

```
chrX.dose.vcf.gz tabix -f -p vcf
```

```
chrX.PAR12.filteredR2less0.3.vcf.gz
```

### nonPAR

For the nonPAR regions we apply very stringent QC, we extract all variants in the region with  $R2 \geq 0.3$  and then we will apply additional QC. Example:

```
bcftools view -r X:2699520-154931044 '-e INFO/R2<0.3' -Oz -o chrX.nonPAR.filteredR2less0.3.vcf.gz chrX.dose.vcf.gz
```

```
tabix -f -p vcf chrX.nonPAR.filteredR2less0.3.vcf.gz
```

To ensure that the fam file matches the vcf you may have to prepare double identified for Plink. Example: where the fam file produced as the end of step 2 above (\*) is called QCedXchr\_data-updated-chr23.fam

```
cat QCedXchr_data-updated-chr23.fam | awk '{print $1"_"$1,$2"_"$2,$3,$4,$5,$6;}' > chrX.dose.fam
```

Exclude any genotypes that do not have a high genotype probability. Convert the genotype

probabilities into hard calls using a genotype probability threshold of 0.9. Example: Note that we switch to plink v2.0 for this step.

```
plinkv2 --vcf chrX.nonPAR.filteredR2less0.3.vcf.gz dosage=GP --double-id  
-- import-dosage-certainty 0.9 --keep-females --make-bed --out  
female_chrX.nonPAR_GP0.9 --psam chrX.dose.fam
```

```
plinkv2 --vcf chrX.nonPAR.filteredR2less0.3.vcf.gz dosage=GP --double-id  
-- import-dosage-certainty 0.9 --keep-males --make-bed --out  
male_chrX.nonPAR_GP0.9 --psam chrX.dose.fam
```

Apply a call rate threshold of 99% and HWE  $p < 1 \times 10^{-4}$  for the females. Example:

```
plinkv1.9 --bfile female_chrX.nonPAR_GP0.9 --geno 0.01 --hwe 0.0001 --make-  
bed  
--out female_chrX.nonPAR_GP0.9_geno0.01_pHWE1e-4
```

Apply a call rate threshold of 99% for the males. Example:

```
plinkv1.9 --bfile male_chrX.nonPAR_GP0.9 --geno 0.01 --make-bed --out  
male_chrX.nonPAR_GP0.9_geno0.01
```

If you do not have a .hh file produced then skip the next 2 example steps and for the males use the mail bim file produced in the step above for the inclusions.

If you have a .hh file produced then there are variants with incorrect genotypes (heterozygous haploids) so we will exclude all of these variants. Example:

```
cat male_chrX.nonPAR_GP0.9_geno0.01.hh | cut -f 3 | sort -u >  
male_chrX.nonPAR_GP0.9_geno0.01.hhexclusions
```

Exclude the variants with heterozygous haploids. Examples:

```
plinkv1.9 --bfile male_chrX.nonPAR_GP0.9_geno0.01 --exclude  
male_chrX.nonPAR_GP0.9_geno0.01.hhexclusions --make-bed --out  
male_chrX.nonPAR_GP0.9_geno0.01_hhout
```

Produce an inclusions list for the variants that pass QC in males and females. Example: to get the intersect from both bim files you can use the following:

```
comm -1 -2 <(cut -f 2 male_chrX.nonPAR_GP0.9_geno0.01_hhout.bim | sort)  
<(cut -f 2 female_chrX.nonPAR_GP0.9_geno0.01_pHWE1e-4.bim | sort) >  
nonPARQCedinclusions.txt
```

Prepare sex specific datasets for association analysis

```
plinkv1.9 --bfile male_chrX.nonPAR_GP0.9_geno0.01 --extract  
nonPARQCedinclusions.txt --make-bed --out male_chrXnonPAR_QCed
```

```
plinkv1.9 --bfile female_chrX.nonPAR_GP0.9_geno0.01_pHWE1e-4 --extract  
nonPARQCedinclusions.txt --make-bed --out female_chrXnonPAR_QCed
```

Because we have set some genotypes to missing it is good practice to make sure that you do not have differentially missing genotypes between your cases and controls for each phenotype.

Example for phenotype 1, which is included in column 6 of the fam file:

```
plinkv1.9 --bfile female_chrXnonPAR_QCed  
--test-missing --out female_chrXnonPAR_QCed_diffMiss_pheno1
```

Exclude variants with  $P < 1 \times 10^{-4}$

```
cat female_chrXnonPAR_QCed_diffMiss_pheno1.missing | awk '{if($5 < 0.0001)  
print  
$2;}' > female_chrXnonPAR_QCed_diffMiss_pheno1
```

These variants should be excluded from your association analysis. Example:

```
plink --bfile female_chrXnonPAR_QCed --exclude  
female_chrXnonPAR_QCed_diffMiss_pheno1 --make-bed --out final_file_pheno1
```

This means that if you have >1 phenotype the variants excluded may be different for each phenotype.

Using plinkv2.0 with --export you can also prepare these genotypes as vcf, bgen or Oxford format to facilitate your association analysis requirements.

### **X- chromosome association analysis**

The X chromosome will be analysed as 3 separate datasets:

- PAR1+2
  - Analyse as you did for the autosomal analysis and follow the autosomal analysis plan for file naming and uploading.
- nonPAR males only
- nonPAR females only
  - Analyse as you did for the autosomal analysis but follow the file naming and uploading instructions below

Please note that centrally, we will:

- Investigate if we need to correct for genomic control
- Apply quality control
- Meta-analyse the male and female data centrally using Z-scores
