In many states, the first vital person conducting this assessment is a nurse. In this project, 17 nursing intake forms from Massachusetts jails were analyzed for the offer of 15 different screening and 18 preventative services (e.g., HIV testing). Then, Health Services Administrators (HSAs) at the jails were 19 asked to review and comment on the assessment. The average agreement rate between the project 20 team members and HSAs was 73%. Twelve of the 14 jails had guestions about history of HIV or HCV on the nursing intake form. Only 5 facilities discussed PrEP. There is potential to standardize the nursing 21 22 intake form and therefore medical intake process. This must be done with key stakeholder groups, in 23 particular nurses, to best understand the logistics of the complex medical intake process. 24 Keywords: HIV, hepatitis C virus, screening, jail healthcare 25 26

28 Introduction

29	As the source of healthcare for over one million adults in the United States every year, the
30	systems of healthcare delivery in jails should be routinely evaluated for areas of improvement (Carson,
31	2022). Nurses and nurse-administrations are integral to and at the center of these healthcare systems.
32	People who are detained and incarcerated in criminal-legal settings face barriers to quality
33	healthcare and have higher rates of infectious diseases, mental illness, and cardiovascular disease (Ahalt
34	et al., 2013; Camplain et al., 2021; Dumont, 2013; Dumont et al., 2012; Freudenberg & Heller, 2016;
35	Johnson et al., 2013; Massoglia et al., 2014). In order to facilitate continuity of care and offer
36	preventative care, there is a medical intake process in most carceral settings where the person who is
37	being detained interacts with a nurse or other member of the jail staff to review medical history, active
38	medical treatments, and screen for psychiatric illness (Anno, 2001; Maner et al., 2022; Ndeffo-Mbah et
39	al., 2018). This information is collected using a questionnaire, or medical intake form. Medical intake
40	forms are completed almost universally across U.S. jails, prisons, and detention centers, although there
41	is variability about who asks the questions and what questions are asked (Carda-Auten et al., 2022;
42	Maner et al., 2022). Beyond asking about medical history, the CDC Infectious Diseases Corrections 2022
43	guidelines recommend that medical intake form should include offering services, including evaluation
44	for HIV, hepatitis, tuberculosis, gonorrhea, chlamydia, and syphilis (CDC, 2022b). The same guidelines
45	also advise that vaccines and PrEP should be offered (CDC, 2022b).
46	In Massachusetts, the initial medical intake screening is always completed by a nurse, so this
47	document is henceforth referred to as the nursing intake form for the purpose of this study. The same
48	study team published an evaluation of 2018 nursing intake forms in Massachusetts and found
49	heterogeneity in the infectious diseases questions asked during nursing intake (Wurcel et al., 2021).
50	About 85% of jails asked about a history of HIV, but only 50% offered HIV testing (Wurcel et al., 2021).
51	Half of the jails asked about previous HCV infection, and only 2 offered testing (Wurcel et al., 2021).

52	Since the study team's 2018 evaluation, the COVID19 pandemic brought increased attention to the
53	process of COVID19 screening for people entering jail as well as offering COVID19 vaccination.
54	Prison and jail scholars interested in learning more about medical intake process have requested
55	jail medical intake forms via the Freedom of Information Act (FOIA) (Yaremko, 2020). There is an
56	increase in research reports analyzing the jail medical intake forms as a marker of healthcare. However,
57	the accuracy of these content analyses has not been reviewed by the most critical jail employees: nurses
58	and nurse-administrators.
59	Objective
60	The goal of this evaluation was to perform a content analysis on Massachusetts nursing intake forms
61	from 2022. To complete the summative content analysis, researchers collected nursing intake forms and
62	then had health services administrators (HSAs) from every jail support or refute the researchers'
63	interpretation of data on the nursing intake forms, allowing researchers to revise findings if indicated.
64	Methods
65	Setting: Massachusetts has 14 counties and 15 jails. All the Massachusetts jails have
66	accreditation from the American Correctional Association, the National Commission on Correctional
67	Health Care, or both. The jails either have healthcare provided by the county, a for-profit medical
68	organization, or a hybrid model. One county jail was excluded from this analysis due it is extremely small
69	size and unique healthcare delivery system.
70	Design : This is a descriptive qualitative study design with summative content analysis.
71	Sample: The research team collected nursing intake forms from a convenience sample of
72	fourteen jails in Massachusetts. HSAs are typically nurse-administrators who oversee the healthcare
73	provided at jails. The nursing checklists were requested via email twice, and we followed up with one
74	phone call.

75	Research team checklist development: The project team modified the previous evaluation
76	research checklist on nursing intake from 2018 (Wurcel et al., 2021) to evaluate the nursing intake forms
77	again in 2022 (Supplement 1). The modifications included surveying for the presence of questions on the
78	intake form that addressed LGBTQIA+ status, offering COVID19 vaccination/history of vaccination,
79	history of COVID19 infection, Sickle Cell disease, and offering STD testing. These modifications stemmed
80	from an interest in taking a more holistic, updated view of infections and chronic diseases that affect
81	infections that should be screened at intake. In particular, since the 2018 study, there have been
82	initiatives in healthcare and jail settings to ask about LGBTQA+ status (Bacak et al., 2018). Similar to
83	previous projects, tuberculosis screening was not included in the assessment. The project team made
84	this decision because tuberculosis screening in Massachusetts is universally implemented across jails in
85	line with 2006 CDC recommendations and national accreditation requirements (CDC, 2006; NCCHC,

96 the evaluation. If the HSA disagreed, they were asked to explain in a free text box why they disagreed

98 **Expert review incorporation:** The research team recorded the responses given by the HSAs. If an 99 HSA stated a topic was addressed, the research team would consider that topic as addressed during 100 nursing intake. If an HSA stated a topic was not addressed, the research team would consider that topic 101 as not addressed during intake. The research team would also record that that topic was changed from 102 yes to no or no to yes after expert review by the HSA. The research team also collected the HSA's free 103 text reasons for why they disagreed with the research team's content analysis findings.

104 *Ethics statement:* The collection of nursing intake forms was exempt as non-human subjects' 105 research. The nursing intake forms collected for analysis were blank, so they contained no identifying 106 information. The survey of the HSAs was granted as exempt from consent by the Tufts University Health 107 Sciences Institutional Review Board (IRB).

108 Results

109 All 14 Massachusetts jails sent their nursing intake forms and responses to the surveys. The jails 110 were anonymized as Jails A-N. Of note, two jails only completed page one of the survey (five questions). 111 All other jails completed 15/15 questions. The results of the initial content analysis are displayed in 112 Figure 1. Twelve of the 14 jails had questions about history of HIV or HCV on the nursing intake form. The least commonly covered topic was offering PrEP, with only five facilities discussing PrEP during 113 114 nursing intake. The average agreement rate between the team members and HSAs was 73%. Free text 115 responses fell into six broad categories: (1) topic is covered elsewhere during nursing intake 116 (unspecified); (2) topic is covered elsewhere during nursing intake (specified); (3) topic is addressed by a 117 broader question during nursing intake; (4) test is mandated for everyone, so not asked during nursing 118 intake; (5) topic is addressed, but verbally; and (6) topic has been added since documents were shared 119 with project team. These results can be found in Table 1. The most common reason for changing a 120 response was that the topic is covered during an unspecified part of the nursing intake, with 12 121 responses falling into this category.

122 Discussion

123	Although the nursing intake form may seem like a straightforward, accessible method for
124	researchers, policy experts, and advocates to analyze the healthcare topics discussed during medical
125	intake at jails, this study showed that the nursing intake form did not consistently reflect healthcare
126	delivery. There are several reasons why this finding is an important addition to the literature. First,
127	researchers, public health experts, and litigators may use nursing intake forms to evaluate the care
128	provided at jails. Based on our analysis, the nursing intake forms do not capture all the types of
129	healthcare services provided. Second, a goal of nursing intakes forms is to operationalize best practices
130	so that the clinical evaluation can be equitable. Several jails reported that the infectious disease testing
131	and vaccination was offered, just not at the time of nursing intake or on a separate form from the
132	nursing intake form. The fragmentation of infectious diseases testing and vaccination into different
133	systems and clinical interactions creates opportunities for heterogeneity in who gets offered or is able to
134	access care. Third, despite being in a small state, there were differences in how jails incorporated
135	infectious diseases testing and vaccination into the nursing intake form in Massachusetts. These
136	differences could be exponentially greater in larger states.

137 The Guidelines for the Management of an Adequate Delivery System published by the National 138 Commission of Correctional Health Care describes the medical intake process as the most important 139 standard for correctional facilities to meet (Anno, 2001). The nursing intake form in Massachusetts is the 140 first step in a multi-layered process of acute and chronic healthcare including organizing emergency 141 triage; coordinating continuity of care; assessing current health status including mental and dental 142 health; and offering a variety of optional preventative services (e.g., screenings and vaccination) (Anno, 143 2001). The rate of deaths due to alcohol in United States jails doubled between 2001-2018 (Carson 144 2021), and two-thirds of people who are incarcerated meet standards for substance use 145 disorder/dependence (Bronson, 2017). The mental and physical status of a person who is newly

146	incarcerated may be impaired because of acute intoxication or withdrawal, leading to incorrect answers
147	or answers to questions that may not represent their true wishes. Information about medical care does
148	not pass easily from the jail to community or back (Butler, 2014). All of these factors complicate the
149	process of working towards continuity of care for infectious diseases and providing the highest level of
150	evidence-based interventions.
151	The creation of a universal infectious diseases intake form for jails that represents best practices
152	is a feasible next step to encourage uniform application of best public health practices. Despite several
153	obstacles, tuberculosis screening has been implemented across the U.S. in jails and prisons, with
154	incredible impact in reduction of tuberculosis transmission both in the carceral setting and in the
155	community (CDC, 2022a; Puisis et al., 1996; Saunders et al., 2001; Stewart et al., 2022). The creation of a
156	universal infectious diseases medical intake form will require getting feedback from key stakeholders
157	across the criminal-legal spectrum on the best time to ask questions, the way to ask questions, and the
158	potential downstream consequences, such as increased medical costs, that need to be considered.
159	As the first people who meet and triage people who are incarcerated, nurses best understand
160	the challenges of accessing accurate health information at intake into a carceral facility. Nurse-
161	administrators understand the procedures for standardizing healthcare practices and assessing their
162	efficacy. People who are incarcerated understand the lived experience of being detained and can
163	provide expert first-hand feedback on the intake process, including what services they think they should
164	be offered and what questions should be asked of and answered for them. As evidenced by this current
165	review, there are lapses in questions asked and services offered during the intake process. The key to
166	improving any care given during intake to a carceral facility is asking nurses and nurse-administrators on
167	how to best do it.

168 Limitations of this report include focusing on a single state and getting feedback from only one 169 person working at the jails. Due to the substantial differences that exist between state-run jails, a similar

170	analysis in a different state may yield different findings. Some states do not have intake forms asked by
171	nurses, which may require investigators in other states to modify their assessment of the medical intake
172	forms. This study was only conducted in jails, and the medical intake process in prisons may be different.
173	It should be noted that two jails only completed five questions of our 15-question electronic survey. We
174	believe this was because the survey was three pages long, with five questions per page, and
175	respondents may have not seen the arrow at the bottom of the screen directing them to the rest of the
176	survey. The survey questions sent to each facility were in a different order, so the 10 questions that
177	were not answered were different for each facility. Therefore, the study team believes the missing
178	questions did not greatly impact study results, as they only limited responses per question by one or two
179	at most.
180	Despite these limitations, this work adds to the growing body of literature analyzing jail medical
181	intake forms with goal of improving jail healthcare. It also highlights the shortcomings of these analyses.
182	This work also calls for and outlines the potential process for standardizing the medical intake process,
183	particularly by incorporating a consistent infectious diseases intake form, which would need to be
184	developed with nursing feedback, which could help reduce disparity and promote best public health
185	practices.


