2 Navigating vaccination choices: The intersecting dynamics of institutional trust, belonging and
3 message perception among Congolese migrants in the UK (A reflexive thematic analysis)

36 **Abstract**

37

38 **Background**

39 The COVID-19 pandemic has disproportionately impacted intersectionally marginalised migrants,
40 revealing systemic disparities in health outcomes and vaccine uptake. An in-depth understanding of
41 the underlying social and structural factors influencing health behaviours is necessary to develop
42 tailored interventions for migrants but has been seldom explored. Therefore, this qualitative study
43 aimed to explore the contextual factors shaping COVID-19 vaccination decision-making among
44 Congolese migrants in the UK.

45

46 **Methods**

47 A community-based participatory research study was designed and led by a community-academic
48 partnership in London, UK (2021-2022). Peer-led, semi-structured interviews were conducted in
49 Lingala with 32 adult Congolese migrants and explored beliefs, perceptions and lived experiences of
50 migration, healthcare and vaccination and the pandemic. Reflexive thematic analysis generated two
51 themes and a model conceptualising the vaccination decision-making process was developed.
52 Participants and community partners were financially compensated, and the study received ethical
53 approval from the University of London ethics committee (REC: 2021.0128).

54

55 **Findings**

56 Participants highlighted the incompatibility of lockdown restrictions with their communal culture, which
57 intensified feelings of exclusion and alienation. Concerns about COVID-19 vaccination were attributed
58 to safety and effectiveness, partly informed by experiences and legacies of discrimination and

59 exploitation of Black Africans. Inequality in the pandemic response and COVID-19 outcomes
60 heightened participants' sense that their views and needs were being overlooked and government
61 sources and information were perceived as coercive. Drawing on this data, our model depicts the
62 interplay between institutional trust, belonging, and message perception which shaped participants'
63 vaccination decisions and led to (non-)engagement with COVID-19 vaccination.

64

65 **Conclusion**

66 This research enhances understanding of how social and contextual factors may influence migrants'
67 engagement with health interventions. It underscores the necessity of partnering with migrant
68 communities to understand their needs in context and co-design tailored interventions and inclusive
69 messaging strategies which foster trust and belonging. Implementing systemic changes to address
70 structural inequalities will be crucial to create an environment that supports engagement with health-
71 protective behaviours and enhances health outcomes among migrant communities.

79 Introduction

80

81 Migrants suffered disproportionately during the COVID-19 pandemic, facing heightened health risks
82 (1-4), poorer health outcomes (1, 5-8) and lower vaccine uptake rates (9-15), compared to non-
83 migrant communities. There is an urgent need to critically examine the structural factors underpinning
84 these inequitable outcomes, to guide the design of inclusive interventions and policies which can
85 advance health and vaccine equity. While trust has emerged as a key factor shaping vaccination
86 decisions, especially among marginalised groups (16, 17), the intricate dynamics of trust within
87 specific migrant communities, and the underlying structural and social determinants, remain relatively
88 unexplored (18, 19) or oversimplified (19, 20). To bridge this knowledge gap, this participatory
89 research study will explore the influence of context, lived experiences and notions of belonging on
90 migrants' vaccination behaviour.

91

92 Trust can be understood as the confidence individuals have in their interactions with others,
93 institutions, and societal systems (21), and is influenced by their beliefs, values and lived experiences.
94 Several theoretical concepts can help us to understand how migrants conceptualise trust and feel
95 connected to the world around them. Social identity theory (22, 23) and belonging (24) provide two
96 means of understanding the range of processes, including perceptions, attitudes and behaviours, that
97 can contribute to identity. The latter concept offers a more nuanced framework and proposes that
98 belonging (a sense of being 'at home' (25), feeling safe and connected) is formed through diverse
99 attachments and memberships that, when denied, lead to exclusion and marginalisation. One of the
100 ways this exclusion manifests is through othering, a process of exclusion rooted in power dynamics
101 (26, 27), and which is notably used as a political tool to evade responsibility for migrants and the
102 globally displaced. In Australia, research with black African migrants and refugees living in
103 Queensland highlighted the detrimental effects of othering practices and marginalisation on their
104 sense of belonging to Australian society (28). Similarly, the emphasis on race and ethnicity as
105 COVID-19 risk factors in the UK led to increased stigmatisation and alienation of individuals of Black
106 African, Caribbean and South Asian descent during the pandemic (29). Crenshaw's intersectionality
107 theory (30, 31) provides a lens through which to understand the layered exclusion faced by migrants,
108 by considering their overlapping social categorisations or identities (for example, based on migrant

109 status, ethnicity, class and gender) and the interconnected systems of oppression, domination, or
110 discrimination they create (31). Applying these concepts to our research may facilitate a more
111 nuanced understanding of the context in which migrants' health and vaccination decisions are made,
112 providing us with the insight to develop more responsive and tailored interventions.

113

114 Research in this area to date has been relatively siloed, focusing on migrants' constructions of
115 belonging and identity, experiences of discrimination and marginalisation, or their health outcomes,
116 but not causally linking these factors. Moreover, the overly simplistic explanation for behaviour based
117 on "cultural differences" has been criticised for perpetuating and legitimising inequality relations (32).
118 However, recent studies have begun to consider the wider context shaping migrants' health decision-
119 making. A study among Black African and Caribbean communities in the UK, for example, found that
120 the uncertainty of the pandemic, combined with contemporary and historical mistrust and a lack of
121 identity-aligned messaging, contributed to belief in conspiracy theories and low engagement with
122 COVID-19 health-protective behaviours (18, 29). A study in Japan found that the social integration of
123 migrants positively correlated with their COVID-19 vaccine acceptance, underscoring the importance
124 of inclusion and community engagement (33). Building on this recent work and the different
125 understandings of these concepts, this study aims to explore the contextual factors shaping migrants'
126 COVID-19 vaccination decision-making through an in-depth study with Congolese migrants in the UK.
127 This approach moves beyond the limitations of the traditional 'information deficit model' (34),
128 providing a comprehensive understanding of how migrants' unique contexts, worldviews and
129 intersecting identities shape their attitudes towards and engagement with science (35), and paving the
130 way for more tailored, culturally-embedded and inclusive interventions to address their unique needs.

131

132 **History of the Democratic Republic of the Congo and Congolese migration to the UK**

133

134 The Democratic Republic of Congo (DRC) has a complex history, with the Congolese people subject
135 to exploitation, cultural repression, and systematic oppression under Belgian colonial rule from the
136 late 19th to mid-20th Century. This era promoted harmful racial hierarchies and ideas of superiority of
137 Europeans over Africans, while the economic exploitation of Congo's natural resources perpetuated a
138 narrative of exploitation which continues to shape Congolese beliefs and values (36). The country's

139 struggle for independence from Belgian colonial rule is said to have fostered a sense of nationalism
140 and pride among Congolese people (36). However, this period also exacerbated ethnic tensions
141 between the country's more than 200 different ethnic groups, potentially creating a complex picture of
142 identity (36).

143

144 In recent decades, Congolese migration to the UK has been spurred by political instability, armed
145 conflicts, economic challenges, and human rights abuses in the DRC. Consequently, a significant
146 proportion of Congolese migrants in the UK arrived as refugees and asylum seekers, and they were
147 the fourth most common nationality resettled in the UK between 2010 and 2021 (1774 people).

148 Despite their complex history, relatively little is written about the Congolese diaspora in the UK. A
149 2006 report by the International Organization for Migration highlighted specific challenges, including
150 language barriers, cultural adjustments, discrimination, difficulties accessing key services (housing,
151 healthcare, employment), and challenging asylum processes (37). These have led to prolonged
152 periods of uncertainty, impacting their ability to integrate into UK society (37). The reported reliance of
153 these communities on the support of Congolese community organisations and non-governmental
154 organisations (37) gives further indication of the detrimental effects of these challenges on their sense
155 of belonging and inclusion within UK society, potentially shaping their willingness and ability to
156 engage with the wider system.

157

158 **Methods**

159

160 *Study design*

161

162 A community-based participatory research (CBPR) study was conducted with Congolese migrants in
163 London, UK in 2021-2022, led by a community-academic partnership ('coalition', see below). This
164 study originated from Congolese migrant community members identifying unmet needs and concerns
165 around COVID-19 vaccination within their community, coupled with the academic partner's interest in
166 exploring existing evidence gaps related to vaccination beliefs and behaviours among migrant
167 populations (38-40). Within this CBPR study (reported elsewhere (41, 42)), qualitative, semi-
168 structured in-depth interviews were conducted with Congolese migrants to explore their beliefs,

169 perceptions and lived experiences of migration and healthcare in the UK, the COVID-19 pandemic,
170 and routine and COVID-19 vaccination. The coalition co-designed and pilot-tested the topic guide and
171 jointly decided on the data collection approaches and all aspects of the study design. The Standards
172 for Reporting Qualitative Research were followed (43).

173

174 *Setting and population*

175

176 The study was set in Hackney, a diverse borough of London, UK, where over 89 languages are
177 spoken and around 40% of the population come from Black and Minority Ethnic Groups, as defined by
178 the UK Office for National Statistics (44). Hackney was the 11th most deprived local authority in
179 England based on the Indices of Deprivation 2015 (45). It is thought to host one of the UK's larger
180 populations of Congolese migrants (41, 46). A single nationality migrant group was involved for an in-
181 depth, culturally situated understanding of the research topic, although it was recognised the sample
182 differed across a variety of other criteria. The target population was Congolese adult migrants living in
183 or around Hackney (specific inclusion/exclusion criteria are shown in Table 1).

187 *Community-Academic Coalition*

188

189 The all-female coalition included an academic researcher with a background in community health
190 research and lived experience of migration, three Congolese founders of a local community
191 organisation in Hackney, with lived experience of migration and strong links with the local Congolese
192 and Hackney communities, and an experienced community outreach coordinator from Hackney's

193 voluntary and community support sector agency. The coalition met regularly to allocate roles and
194 responsibilities and plan the study (described elsewhere (41)). As the three Congolese members of
195 the coalition expressed an interest in conducting the interviews but had no prior research experience,
196 the academic researcher (AFC) trained them in qualitative interview techniques and study design and
197 the outreach coordinator (CH) provided training in facilitation skills two months prior to starting the
198 study. The team had ample time to learn and practice their skills through role-play and pilot testing the
199 topic guides.

200

201 *Participant selection and recruitment*

202

203 The study aimed to recruit approximately 30 adult migrants who met the specified inclusion criteria
204 (see Table 1). Participants were recruited (14/01/22-18/03/22) by the Congolese members of the
205 coalition (LML, LMK, SN) using co-designed flyers, word-of-mouth, and snowball sampling
206 techniques. They received a participant information sheet explaining the study and their rights, which
207 was also explained to them verbally, at least one week in advance of the interview, and had the
208 opportunity to ask questions before deciding whether to participate.

209

210 *Ethics and informed consent*

211

212 The study was approved by the St George's University of London Research Ethics Committee (REC
213 reference 2021.0128). All participants provided written informed consent prior to participating.

214

215 *Data collection*

216

217 Semi-structured in-depth interviews were conducted in January-March 2022 and were done face-to-
218 face in private meeting rooms by four members of the coalition (AFC, LML, LMK, SN). CH provided
219 logistical and project management support. Interviews were conducted in Lingala, French or English
220 (LML, LMK, SN are tri-lingual, and AFC used a professional telephone interpreter as required; most
221 interviews were done in Lingala) and lasted 15 – 50 minutes. Interviews explored experiences, beliefs
222 and knowledge of vaccination (including COVID-19, routine, selective and catch-up vaccinations),

223 health-seeking behaviour, experiences of the NHS, preferred health information sources, and
224 suggestions for improving health services. Topic guides were developed iteratively over the course of
225 the study. Interviews were audio-recorded by Dictaphone and transcribed and translated verbatim by
226 a professional translator. Transcripts were checked for accuracy and pseudonymised, and audio
227 recordings were destroyed after transcription. Handwritten field notes were incorporated into final
228 transcripts. Sociodemographic data were collected at the time of interviews from participants using a
229 standardised form. Additional data and insights about the local, socio-cultural, and historical context,
230 and Congolese culture, customs, and preferences were collected using optional poster walls which
231 participants were invited to contribute to anonymously outside of interviews. Optional post-interview
232 feedback forms were also collected. Participants received a £20 gift card for taking part and were
233 reimbursed for travel costs and provided with childcare when required. Specific decisions were also
234 made to encourage attendance and create a more welcoming and informal environment for
235 participants, with the guidance of the Congolese coalition members. For example, interviews were
236 held at a local community centre close to the local market, timed to coincide with market days, and
237 organised as part of 'community days' celebrating Congolese culture, during which information was
238 shared about local support services.

239

240 *Data analysis and theoretical framework*

241

242 A six-stage reflexive thematic analysis (47, 48) was followed to explore patterns and subjective
243 experiences across the dataset. A moderate constructivist theoretical framework (49) was used,
244 recognising the roles of the researchers and participants in the co-construction of meaning (50).
245 Theoretical flexibility meant the analysis could be informed by critical and social justice approaches
246 concerned with 'giving voice' to the participants and their lived experiences and locating these within
247 wider political, historical, and sociocultural discourses. Transcripts were uploaded into NVivo12
248 software for qualitative analysis. The first author (AFC) completed stages 1-3, using a mixture of
249 semantic and latent coding, and then discussed initial themes with the coalition (LML, LMK, SN, CH),
250 TV and FK in a process of critical engagement to deepen the analysis, develop and refine themes
251 (stages 4-5). During this stage, important patterns in the data relating to belongingness and identity
252 were noted, which framed the onward analysis. Finally, a model was developed to theorise the links

253 within and across the dataset and showcase how individuals' lived experiences may lead to
254 engagement with specific health behaviours. AFC had regular conversations with co-authors
255 (particularly TV and FK) throughout the analytic process and kept reflexivity notes. These were crucial
256 to the development of the final themes and model and ensured subjectivity was acknowledged.
257 Several iterations of theme names and definitions were reviewed to ensure their clarity, scope, and
258 fidelity to the overall storyline. Consequently, the four initial candidate themes were refined into the
259 two final themes presented below.

260

261

262 **Findings (analysis and interpretation)**

263

264 Thirty-two participants were included in the study (descriptive characteristics are shown in Table 2), of
265 whom most were female (24, 75%) and refugees or asylum seekers (19, 60%). The inclusion criteria
266 were expanded during the study to include two (6%) participants who were born in Angola but
267 identified as Congolese, recognising the geo-political limitations of the original criteria. Participants
268 had a mean age of 52.6 years (standard deviation, SD, 11 years) and had lived in the UK for mean
269 14.3 years (SD 7.5 years). Most spoke Lingala (28, 88%) or French (20, 63%); few spoke English (10,
270 31%) and 15 (47%) considered themselves to have limited English proficiency (unable to read or
271 write). All (100%) were registered with a GP.

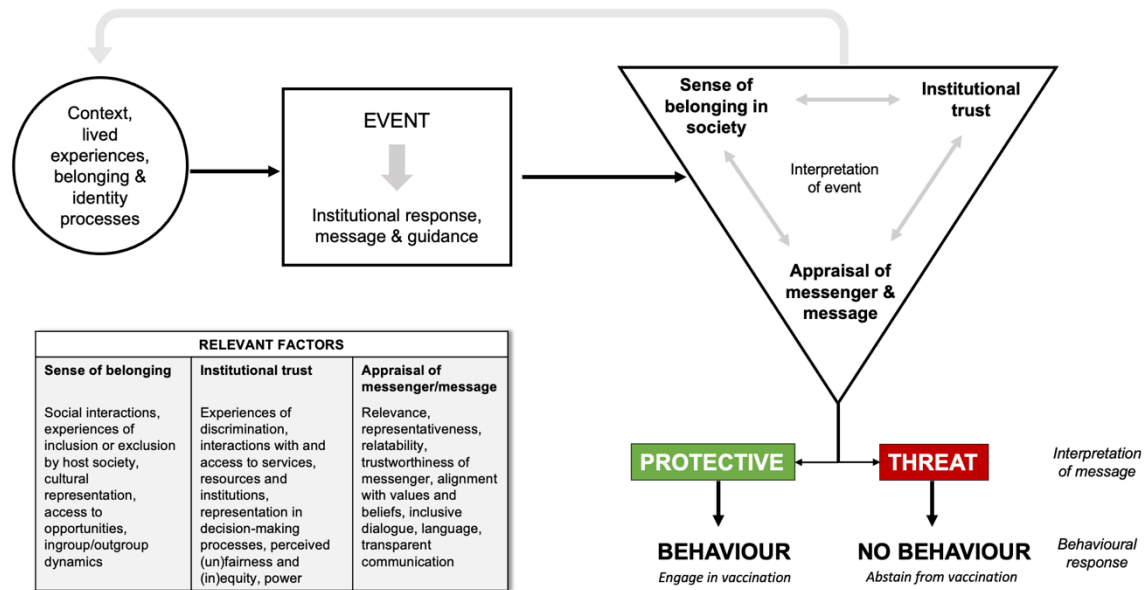
276 The analysis generated two themes, which informed the model depicted in Figure 1. The model aims

277 to theorise the engagement or non-engagement with health-protective behaviours, in this case

278 COVID-19 vaccination, of Congolese migrants by considering the influence of context and lived

279 experiences on their health decision-making.

 283 behaviours/vaccination in Congolese migrants in the UK. The “EVENT” represents the COVID-19
 284 pandemic. Institutional trust reflects confidence in authorities, sense of belonging represents
 285 connectedness to wider society and in-groups, and perception of messenger/message relates to
 286 trustworthiness and relevance of information based on their worldview.

287
 288 **Theme 1: Belonging and identity in the wider context of lived experiences of migration**

289
 290 This theme first explores the intersecting social categories, systems and power structures shaping our
 291 participants’ sense of belonging (24). Next, it considers the impact of the COVID-19 pandemic on
 292 participants and explores how the policy response challenged notions of belonging and identity and
 293 elevated participants’ alienation and mistrust towards Government and wider social systems.
 294
 295 Participants’ narratives presented a layered picture of belonging. Community, respect for elders,
 296 and being connected to their religious faith emerged as important aspects of their social identities.
 297 The significance of faith was noted and reflected in their use of biblical references to articulate their
 298 beliefs. Participants’ cultural identities were strengthened through attachments to Congolese culture
 299 and ways of life, including social gatherings, gospel music, creative expression, and local community

300 ties. These attachments fostered feelings of safety and inclusion within their in-group, offering a
301 refuge of shared experiences and values. However, participants also shared their perceptions of not
302 being embraced by, or belonging to, British society. These perceptions were informed by experiences
303 of exclusion and othering, rooted in language barriers, citizenship status (or labelling/othering based
304 on legal status), discriminatory practices, and the challenges of navigating the system as a migrant.
305 This was particularly evident when it came to navigating the healthcare system, where they
306 highlighted examples of receiving sub-standard care and having their eligibility questioned. Some
307 participants said they had sought alternative treatment or withdrew from seeking further care because
308 of this, while others expressed a sense of injustice, particularly given their contributions through
309 taxation. These shared experiences may have fostered a sense of comradery and internal belonging
310 (with their in-group or 'insiders') while deepening their sense of alienation from wider society (their
311 perceived out-group or 'outsiders').

312 *"In my case, because I work a lot with the community, yes, some people are*
313 *asylum seekers and there's a discrimination when they turn up to a GP to register.*
314 *They ask them for so many documents, your passport, proof of address and when*
315 *they don't have that it's just putting them off." P5*

316 ***

317 *"If we go again [to] the GP in this country, when you try to phone them, maybe*
318 *have to take you two hours, three hours, before to pick up the phone. And then*
319 *when they pick up the phone in reception, okay, they give you now appointment.*
320 *Appointment may be two weeks or three weeks before to see you. I don't know.*
321 *[...] Is embarrassing. For now, the GP, I think, is a joker. [...] When they come to*
322 *see you after that, they give you a paracetamol. What's going on? We work in this*
323 *country. We pay the tax... Why the thing must go like that? Why?" P11*

324
325 Participants described varying responses to their experiences of exclusion. Some responded through
326 self-protective mechanisms such as withdrawal, while others adapted and formed new attachments
327 and memberships which secured their inclusion, and potentially increased their sense of belonging in

328 society or connectedness to wider society (the out-group) (Figure 1). Furthermore, beliefs and
329 perceptions regarding belonging and identity were dynamic and appeared to evolve over time and
330 across generations. One participant shared that when they first arrived in the UK, they had been told,
331 “this country is English country, to understand and to be free you need to learn [English]” (P26). It is
332 unclear who their interaction was with, but their further comments suggested they now conformed to
333 this mindset:

334 *“Not Congo, I'm not living in Congo at the moment, now I'm in here in England. I*
335 *need to follow the instruction from here. I need to follow the news from here to get*
336 *better life. So that better life we need to share with people who doesn't understand*
337 *something like this. They don't like to understand because many African they not*
338 *respect the law. Yes, many African they don't want to respect the law. I don't know*
339 *why.” P26*

340
341 Reflecting on the pandemic, participants highlighted the incompatibility of restrictions with their
342 communal culture and explained that lockdowns and social distancing measures had impacted their
343 ability to be together, which had led to sadness, loneliness, and uncertainty, as well as the perception
344 of ‘being watched’. The loss of loved ones to COVID-19 further compounded their distress. Drawing
345 on the framework of social identity theory (22, 51), the enforced separation during the pandemic may
346 have disrupted participants’ collective and self-identities and sense of belonging at a more profound
347 level by compounding their experiences of marginalisation.

348 *“Yes, it's a big problem because now we cannot meet each other and then most*
349 *people, they lost their relatives. And then it divided people, that's what I can say*
350 *because we Africans need to be together, but because of Covid we cannot be*
351 *together. No party, no group, no church. We like to go to the church to pray, to*
352 *meet with people but we don't do it anymore. [...] They were not allowed to come*
353 *because the government is watching them.” P21*

354 ***

355 *“No, you know, Congolese people we are different, I am telling the truth. Some*
356 *people care, and other don’t. If you are telling them to respect social distancing,*
357 *they will tell you that we are community people. We are different.” P18*

358

359 During this period of uncertainty, participants drew on familiar belief systems, such as their Catholic
360 faith. Several participants collectively identified with the need for ‘proof’ when faced with uncertainty;
361 the absence of which may have heightened their sense of vulnerability.

362 *P18: “Congolese people are like Thomas who wanted to put his finger in Jesus*
363 *wound before he would believe that Jesus has been resurrected.*

364 *I: You mean Congolese people need proof?*

365 *P18: Yes, they need proof...”*

366

367 Some participants highlighted the impact of the pandemic on their spiritual journey and relationship
368 with God, referring to the Ignatian concept of discernment of spirits – judging good from evil – guiding
369 their worldview and decision-making process. Navigating the crisis of the pandemic without regular
370 access to spiritual guidance may have intensified participants’ perceived need for spiritual
371 discernment. This is reflected in how they conceptualised the pandemic and their (or others’)
372 engagement with government messages and guidance. Some placed their faith above governmental
373 matters, while others saw non-compliance with health guidance as a form of defiance against divine
374 orders.

375 *I: In your view, how has the government managed the Covid-19 pandemic?*

376 *P20: I don’t have an opinion about the government because I am more engage(d)*
377 *in serving God than the government business.*

378

379 *I: Why do you think those people they don’t want to listen to the government or the*
380 *advice?*

381 *P26: Is [because] they're bad spirited [...] It's like God give us intelligence and*
382 *such, what does God give to the nurse, to the doctor, is like a good spirit to help*
383 *us [...] So if you don't listen to the people who want to save your life, it's like you*
384 *are abusing the order from the heaven. Sometimes, it's like when we are praying,*
385 *we pray for those people.*

386

387 **Theme 2: Evaluating and interpreting health information**

388 This theme considers how participants interpreted and evaluated health information: (a) interpreting
389 the message, and (b) evaluating the messenger: representativeness and trust.

390

391 **A) Interpreting the message**

392

393 Nearly all participants perceived vaccines in general as protective (“Vaccines are good to protect
394 against diseases”) and routine (“We take vaccines from birth”) but expressed mistrust of COVID-19
395 vaccines specifically. They largely attributed this mistrust to rumours, including misinformation, and
396 muddled messaging about COVID-19 that were spread through social media, social networks (friends
397 and family), and government messaging.

398 *“Yes, people know that vaccines protect, but based on the information they are*
399 *reading on media on TV, it's putting people off.” P5*

400

401 Many participants experienced dilemmas while evaluating health information and deciding on a
402 course of action, due to the presence of widespread rumours, misinformation, fear, and suspicion
403 about the COVID-19 vaccine. They expressed uncertainty about whether to get vaccinated, driven by
404 a perception that the vaccine may pose risks to black people. These concerns were further
405 compounded by worries about fairness and the potential for discrimination. A crucial factor influencing
406 their decision-making process appeared to be their personal biography as refugees, having come to
407 the country for protection. This unique background added an additional layer of complexity to their risk
408 assessment and decision-making. Many participants acknowledged the prevailing confusion and

409 misconceptions within African and Congolese communities regarding the safety and effectiveness of
410 the vaccine.

411 *“It was not easy for me [to get the vaccine] because there was so many rumours*
412 *and I was questioned myself if do I have to take it or not. We came in this country*
413 *to seek protection. I just realised that white people are receiving their*
414 *vaccinations, its means that not only they want to kill only black people. All of us*
415 *are standing in the same queue to receive the same vaccine. It means that all of*
416 *us are going to die? There has been lot confusion about negative rumours*
417 *concerning covid-19 vaccine. African in general and especially Congolese people*
418 *has wrong judgement about the vaccine. We are not doctors but we [are]*
419 *searching about vaccines. It was not easy to take vaccines because of negative*
420 *rumours and publicity saying that if you receive the vaccine you are not going to*
421 *live for the next 3 months. Another person placed his phone on his arm to show*
422 *how the phone was stuck after receiving his jab. How come a mobile phone can*
423 *stick on somebody’s arm?” – P4*

424
425 Participants shared concerns and rumours (38, 52-54) reported by other migrant and ethnically
426 minoritised groups about the origins and consequences of COVID-19 vaccines/vaccination, including
427 that they were designed by people or systems (scientists, the NHS, the government, Bill Gates) to
428 cause harm, kill, reduce, or spy on the global population, and black and African populations
429 specifically; or that they had demonic or apocalyptic associations. They also expressed concerns
430 about safety and side effects, which originated from the aforementioned conspiracy theories, public
431 information (e.g. clotting risks associated with the AstraZeneca COVID-19 vaccine), knowledge of
432 their own risk factors, and personal experience of side effects. Some participants believed that the
433 evidence of adverse events and the frequent changes in government guidance and
434 recommendations, such as the need for additional doses and boosters, indicated that the vaccine was
435 not safe or ready when it was first rolled out. They contrasted this with the flu vaccine, which they
436 considered to be safer:

437 *“People are not really reluctant to have flu vaccines because they are convinced*
438 *that it has been experimented in people for many years and it’s safe for them to*
439 *take it, but this one [COVID-19 vaccine], there are a lot of things that have been*
440 *said.” – P5*

441
442 Changes in guidance and perceived lack of transparency by the government were off-putting to many
443 participants and appeared to erode trust in the messenger. The lack of clarity and certainty in
444 messages resulted in confusion and led some participants to question if something more sinister was
445 being hidden behind the vaccine. Some also considered the vaccine’s inability to prevent infection as
446 a scientific failure. Participants questioned the clarity, relevance, and representativeness of messages
447 and gave examples of ways the messages didn’t reflect their reality or circumstances; for example,
448 two participants dependent on shift work said they had wished they had known more about the
449 vaccine’s side effects before getting vaccinated, so they could better plan their schedules.

450 *“I was not sure about the research carried of the vaccine as researchers*
451 *themselves had doublespeak [and] were not sure about their own work. I was*
452 *scared and reluctant about the vaccines because I was confused with the*
453 *information from research. The vaccine prevents you not to catch illness but it*
454 *doesn’t means that you may not be infected. There was a lot of confusion, and*
455 *this was the reason I was not ready to be vaccinated. I was not sure because*
456 *scientists were not clear in their language.” -P6*

457
458 Participants indicated that in the absence of clear information or proof about the consequences of
459 vaccination, they needed to seek out answers independently, as part of their risk evaluation and
460 decision-making process. This centred on whether a course of action (e.g. vaccination) could be
461 deemed ‘protective’ or a ‘threat’. Events which heightened the perception of vaccination as a threat
462 were more prevalent and included vaccine scares reported by the media and relatively rare instances
463 of vaccine-derived poliomyelitis (notably, DRC is one of few countries with recurring vaccine-derived
464 polio outbreaks), which participants recalled from polio vaccination campaigns during their childhood.
465 For example:

466 *“Some children have become disabled after receiving polio vaccine. [...] [They are*
467 *afraid] because the side effects of vaccine have caused to their children to*
468 *become disabled, and they don’t want again to take the risk.” –P2*

469
470 Many participants said they had developed hypertrophic or keloid scars from vaccination in childhood,
471 which had made them associate vaccination with pain and fear. They also alluded to historical racist
472 and unethical medical practices against African people and expressed concerns that they were still
473 being used as ‘guinea pigs’ into the present day, referencing racist remarks by French doctors about
474 testing coronavirus vaccines in Africa (55).

475
476 The principles of heuristics (mental shortcuts to making quick decisions) can help to explain decision-
477 making processes under uncertainty (56). Facing an overwhelming amount of contradictory and
478 changing information, our participants may have experienced indecision and defaulted to believing in
479 or following information that confirmed their worldview (confirmation bias), or that which was most
480 readily available to them (such as misinformation and rumours). This may help to explain why
481 individuals experiencing alienation and social exclusion may have been less likely to engage with
482 COVID-19 vaccination (Figure 1).

483

484 **B) Evaluating the messenger: representativeness and trust**

485

486 *The source of the messenger* delivering the message was critical in determining whether it was
487 trusted and followed by participants. Messages delivered by ‘outsiders’, including the Government,
488 were generally perceived as misleading, unreliable, and coercive. Messages delivered by ‘insiders’,
489 such as members of participants’ own communities, were considered more representative, relatable,
490 relevant, and trustworthy. Participants were more trusting of local community members who were
491 known to them and represented their communities rather than somebody who might not know their
492 community’s histories.

493

494 Participants generally expressed mistrust towards the Government and felt they were being
495 “pressured”, “forced”, and “pushed” by the Government to receive COVID-19 vaccines. Vaccine
496 reminders were perceived on a negative spectrum, ranging from an annoyance to an indication of
497 something more sinister that should be resisted (“It means that there is unknown information behind
498 this.” P4). One participant remarked, “I would do it voluntarily, but not by force.” (P16), adding that the
499 constant reminders had deterred them and heightened their suspicions of what might be hidden
500 behind the vaccine. Comparisons were again drawn with the flu vaccine, which was felt to be
501 uncontentious:

502 *“People have never been forced to receive flu vaccine. If you don’t want to take*
503 *your flu jab, the GP will not force you to take the jab, but this (referring to the covid*
504 *vaccine) has become an obligation.” P4*

505 Although we did not explore vaccine mandates with all participants, those we spoke to felt they
506 imposed excessive control over people’s lives. One participant (P24) said they would “definitely” leave
507 their job if their employer introduced mandatory COVID-19 vaccination. It was also apparent that
508 some participants felt their views and concerns were being ignored and overlooked, and mandates
509 were a way for the Government to avoid addressing or considering wider and more peripheral
510 viewpoints and being used as a form of oppression and control.

511 *“The people in the power, the government, must listen to the voice of all the*
512 *people antivax. After three months, you must take the vaccine [booster]. It’s no*
513 *good like that. And then COVID pass is no good. Before you get to the restaurant,*
514 *you go to the events like that, you must to show something like that. It’s not work*
515 *like that. The people now limits. Life, now, is finished.” P11*

516
517 One participant explained why mandates and reminders were so triggering and proposed ways of
518 communicating that might be more effective and less likely to elicit an emotional response or feeling
519 of being coerced among members of their community. Community members wanted reassurance,
520 and for their concerns and reservations to be addressed, rather than perceived as unjustified.

521 *“Basically, to force someone is like he thinks you give him poison. When you force*
522 *someone... like me, I like vegetables, but she doesn't like, he doesn't like*
523 *vegetables. Why can you force him? You need to help him to understand that*
524 *vegetable is not poison. [...] So, when you force someone, it will get [him] thinking*
525 *more things [like]: ‘they kill me’, ‘they give me poison’, ‘they want to...’ He will think*
526 *[that] because no he doesn't like [it]. But if you help, you advise, you make him*
527 *understand, like [with a] baby: ‘don't do that’, ‘don't touch’, ‘this is a fire’, ‘don't eat*
528 *this, it's a poison’, until you will see him calm down [and] say ‘Really, this thing is*
529 *good, let me go and get it.’” – P26*

530

531 For many participants, the Government represented the orchestrator of their reduced freedoms and
532 the supplier of said ‘poison’. As alluded to above though, some participants described having positive
533 interpersonal relationships with their local social network, including GPs, managers, and neighbours,
534 which were influential on changing their views and behaviour. For example, a few participants who
535 had been initially hesitant about COVID-19 vaccination changed their mind after having a
536 conversation with a trusted source or seeing a friend get vaccinated:

537 *“Yes, I spoke with my GP when the news came out that people were having blood*
538 *clots and I was so scared, I cancelled my appointment two or three times. [...] My*
539 *GP advised me and said don't worry. [...] That's when I was convinced to go and*
540 *get the second one because I seek medical advice.” P5*

541

542 *“After I have seen too, some people around me, they got the vaccination and they*
543 *advise me. I say, okay, I need to go get [it]. [...] My wife too, got the vaccination. I*
544 *send her to go get the vaccination after I got my one.” P29*

545

546 Certain members of the community also took on the role of encouraging others to get vaccinated. This
547 included individuals who had initially been ambivalent or cautious but had since had a positive
548 vaccination experience. Unlike the official messaging deployed, these unofficial community role

549 models used approaches that were perceived as being more representative, relevant, and resonated
550 with the community and their values. One participant described how they encouraged their community
551 “not by force”, and appealed to values of community, care, protection, and safety:

552 *“We keep advising them not by force, but patiently to tell them respectfully, to*
553 *explain to them it's like this, it's important, it's for saving life, saving our kids,*
554 *saving everything in our community. Something like this.” P26*

555
556 Others directly addressed the specific concerns and causes of mistrust that people raised, and which
557 they could relate to, such as hidden Government motives or malintent stemming from histories of
558 repression, and sought to debunk them:

559 *“Some for them, it's a scare. But I advised them, I said to them, it's nothing.*
560 *Because look at it. People is thinking wrong. They say maybe it's a poison. I have*
561 *advised them. I said, no. Look at me. In England, it's not like Africa. Because the*
562 *government for England is work for their people. Is work for their community. It*
563 *can't kill anyone, everyone in the same [boat] about the vaccine.” P29*

564

565 **Linkage to model**

566 Figure 1 provides an explanation for how participants' context, lived experiences and sense of
567 belonging shaped their interpretation of information and their behavioural response to COVID-19
568 vaccination. The triangle depicts the interplay between institutional trust, belonging, and the appraisal
569 of messages and the messenger. Our data suggest these factors vary between individuals and can
570 change over time (shown by the grey arrow). When these factors align positively, individuals adopt
571 health-protective behaviours (perceiving them to be protective), like vaccination. Conversely, if
572 individuals feel alienated, mistrust institutions, and messages and messengers do not reflect their
573 values or needs, they may reject the information (perceiving it to be a threat) and not adopt the
574 desired health-protective behaviour.

575

576 **Discussion**

577 This study explored how the lived experiences of Congolese migrants in the UK shaped their sense of
578 belonging, trust in institutions, message perception, and ultimately their vaccination decision-making
579 during the COVID-19 pandemic. Participants described how experiences of discrimination, exclusion
580 from healthcare, and pandemic-related restrictions heightened their feelings of alienation from British
581 society. Awareness of medical exploitation of Black Africans and vaccine-related fears and scares
582 contributed to concerns about the safety and effectiveness of the COVID-19 vaccine. Additionally,
583 perceptions of government corruption in the DRC, and a lack of clear, relatable or representative
584 messages from UK officials, reinforced mistrust of authorities. The conceptual model depicts the
585 interplay of these factors in shaping participants' vaccination decisions, leading to (non-)engagement
586 with COVID-19 vaccination, while also providing a framework for understanding broader health-
587 related decision-making. These findings emphasise the profound impact of personal experiences and
588 worldviews on vaccination decisions, particularly among intersectionally marginalised populations,
589 and underscore the importance of addressing structural inequalities to strengthen vaccination uptake.
590

591 Our findings build on recent research, such as Vandrevalla et al. (2022), which highlighted how the
592 crisis of the pandemic, combined with historical and contemporary mistrust, provided a context for
593 alternative conspiracy narratives to thrive in UK black communities (18). Our study findings lend
594 support to this interpretation, while further underscoring the pivotal role of context and lived
595 experience in shaping migrants' belonging and identity processes and levels of institutional trust, and
596 subsequently, how health messages are received and acted upon. Bury's notion of biographical
597 disruption (57) may also help us to understand the impact of the pandemic on our participants' sense
598 of belonging and their decision-making. Biographical disruption aims to describe the influence of a
599 significant, sudden event on the course of a person's life, which Bury argued occurs in three ways: 1)
600 disruption of 'taken for granted' assumptions and behaviours, creating heightened awareness of our
601 bodily state, 2) disruption of explanatory frameworks, leading us to re-think our biography and
602 question our sense of self and future trajectory, and 3) disruption of the way we deploy our resources,
603 physically (time and effort) and socially (activities we pursue; financially) (57, 58). We found that the
604 pandemic heightened participants' awareness of their actions, prioritising behaviours vital for their
605 safety or security. It prompted them to ask questions about their biography, such as why this was
606 happening to them, and what had caused it; and it changed the way they acted and behaved.

607 Applying this lens may deepen our understanding of our participants' responses to the pandemic and
608 their COVID-19 vaccination choices and support the design of more personalised vaccination and
609 health interventions. Moreover, these insights may help define responses to help individuals cope with
610 enduring life changes beyond the pandemic.

611

612 Several qualitative studies exploring beliefs about COVID-19 vaccination and other vaccinations have
613 identified concerns about safety and effectiveness and fear of side effects (38, 52-54, 59). These
614 were also reported in our study; however, we also noted novel factors specific to our population which
615 might help to explain how these concerns originated. Many participants in our study associated
616 vaccines with pain partly because of the keloid scarring they had developed after receiving childhood
617 immunisations, particularly BCG. Extensive literature suggest that keloids form more readily in dark
618 compared to light skin, cause pain and distress, and can form at vaccination sites (60). This may help
619 explain why fear of pain and side effects were frequently mentioned as a barrier to COVID-19
620 vaccination in this population, and perhaps also why participants expressed wanting to know in
621 advance more about what to expect from getting vaccinated. Many of our participants experienced
622 mass immunisation campaigns as children in the DRC, where the emphasis may have been on 'jabs
623 in arms' as opposed to informing recipients or providing aftercare. Our findings highlight how the
624 medical experiences of black and racialised people are overlooked in the medical literature and in
625 informing medical practice. Greater consideration must be given to how specific medical practices can
626 shape collective beliefs about vaccines and the medical institution over generations, especially among
627 groups who already share beliefs that they have been historically exploited by medical authorities,
628 with clear communication of risks and implementation of alternative measures where possible. Our
629 participants also had relatively specific knowledge and views about vaccination, drawn from personal
630 and group experiences. For example, participants highlighted cases of vaccine-derived polio,
631 including paralysis, and international examples of vaccination scares. Being a migrant population with
632 close links to a country with history of mass vaccination campaigns and circulating vaccine-derived
633 poliovirus strains, these references should perhaps not be unexpected, and may help contextualise
634 participants' fears. These examples highlight the importance of understanding population
635 demographics and migration patterns and considering the influence of past experiences, histories,
636 and context on values and behaviour when designing and implementing public health interventions,

637 particularly for migrant populations. They also underscore the role of governments in promoting public
638 trust and confidence, and of demonstrating their competence through proactive, transparent, and
639 comprehensive communication with populations (61).

640

641 Participants' mistrust of Government and authority appear to stem from historical and more recent
642 experiences of injustice and oppression. Depending on the timing and context of their migration
643 (noting that around 60% of participants were asylum seekers and refugees), experiences of violence
644 and war in Congo and marginalisation and discrimination as newcomers in UK society will have likely
645 shaped their worldview. Their perception of vaccine reminders and recommendations as coercive is
646 an important finding and suggests vaccine mandates or other enforcement-based public health
647 measures (which are a recommended strategy for achieving high vaccine uptake (62)) would not be
648 suitable to implement in this population (nor populations with similar experiences, beliefs, and value
649 systems), as they would likely further undermine trust. It also highlights the importance of considering
650 the cultural relevance of interventions during their design (prior to roll-out) and involving members of
651 represented groups in tailoring their design to ensure they are appropriate and acceptable for the
652 intended audience(s). These findings align with other recent work, for example, a US study of the
653 effect of COVID-19 vaccine mandates on vaccine attitudes and behaviours concluded that mandates
654 are unlikely to change vaccination behaviour overall and may deter considerable percentages of
655 people from engaging in activities where vaccines are mandated (63). A second US study reported
656 that more Black respondents found hypothetical vaccine mandates for adults unacceptable compared
657 to non-Black respondents (64). Our findings also corroborate and build on the hypothesis of
658 Tankwanchi and colleagues (2021) who suggested, in their rapid review of literature reporting on
659 vaccine hesitancy in migrant communities, that experiences of xenophobia, marginalisation, and
660 discrimination in host countries diminish migrants' trust in the health system and may exacerbate
661 vaccine hesitancy along a pathway of social exclusion (65). Recent literature exploring reasons for
662 vaccine hesitancy among diverse groups has proposed that aligning pro-vaccination messages with
663 the moral values and intuitions that people endorse may be more effective than vaccination
664 mandates. Of note, a UK study (66) found that individuals who more strongly endorsed the moral
665 foundation of liberty, which prizes freedom, choice, and individual rights (67), tended to be more
666 vaccine hesitant. Members of the Collaboration on Social Science and Immunisation (Australia) also

667 recently proposed that less coercive, trust-promoting measures should be prioritised over mandates,
668 along with efforts to understand and address context-specific factors (68). Future research could
669 involve exploring how migrants' unique contexts give rise to the endorsement of specific moral values.
670 These insights could shed further light on the processes underlying vaccination behaviour, aiding the
671 development of vaccination messages that integrate both context and value systems. This could be
672 relevant to designing strategies to improve uptake of catch-up vaccinations in adolescent and adult
673 migrants, which is an increasingly important policy area requiring further planning (69), as well as
674 other health promotion strategies, and in future public health crises. Overall, the findings of this study
675 provide new insights into the importance of inequalities in understanding responses to public health
676 crises, reinforcing the argument for increased research on this topic and for integrating the reduction
677 of systematic inequalities as a fundamental component within disaster planning (70).

678

679 A key recommendation from this study is for policymakers and practitioners to work closely with
680 communities to understand their needs in context, recognising that public health interventions go
681 beyond health and interact with and influence notions of belonging in communities. Policymakers
682 need to be aware of this and of the potential risks if public health interventions aren't carefully
683 designed. In parallel, governments should shoulder the responsibility for building trust and fostering
684 social cohesion as proactive measures. This should include implementing measures which share
685 power, promote social justice, are anti-racist and reparatory, build and maintain trust, and are situated
686 within frameworks of wider social processes.

687

688 **Strengths and limitations**

689 Aligning with other initiatives aiming to address health inequalities (71-75), a strength of this study
690 was its participatory, power-sharing approach, which provided members of Congolese community-
691 based organisation with training and funding to lead a study exploring a public health issue of
692 importance to their community. Having trusted members of the target population lead and conduct the
693 study may have also contributed to the openness of participants and the rich data generated. Our
694 theoretical and conceptual approach allowed us to explore our objectives through the language of our
695 participants and locate their lived experiences within wider political, historical, and sociocultural
696 discourses. Subsequently, our model may help improve understanding of migrants' health decision-

697 making processes and lead to the development of tailored public health interventions which better
698 consider their personal histories, cultural identities and lived experiences.

699 A limitation is the study's focus on a specific Congolese community in London, meaning that the
700 specific historical and contemporary influences that informed their beliefs and behaviours may not be
701 generalisable to other marginalised communities in different contexts. Our study also did not
702 disaggregate by ethnicity; therefore, our participants may represent diverse Congolese ethnic groups
703 whose unique histories are not adequately reflected here. Nonetheless, our overarching finding that
704 health perceptions and behaviours are rooted in long-standing societal issues will be relevant for
705 many intersectionally marginalised migrant populations, and has immediate implications for
706 practitioners, policymakers and academics working to address health inequalities and design tailored
707 public health interventions. Being an exploratory study, this research did not set out to explore notions
708 of belonging and identity; rather, these themes were generated through immersion in the data and the
709 inductively developed analysis. Future research may now build on and test our findings and
710 theoretical approach more purposively. We discuss other strengths and limitations of our work in our
711 accompanying intervention co-design paper (76).

712 **Conclusions**

713 This study highlights the need to work closely with migrant communities to co-design culturally
714 appropriate interventions that build trust and promote inclusion. Fostering this sense of ownership and
715 trust may secure improved health outcomes among migrant populations. Governments must at the
716 same time recognise the need to address structural inequalities and upstream factors to strengthen
717 public health and immunisation programmes and reduce population health disparities.

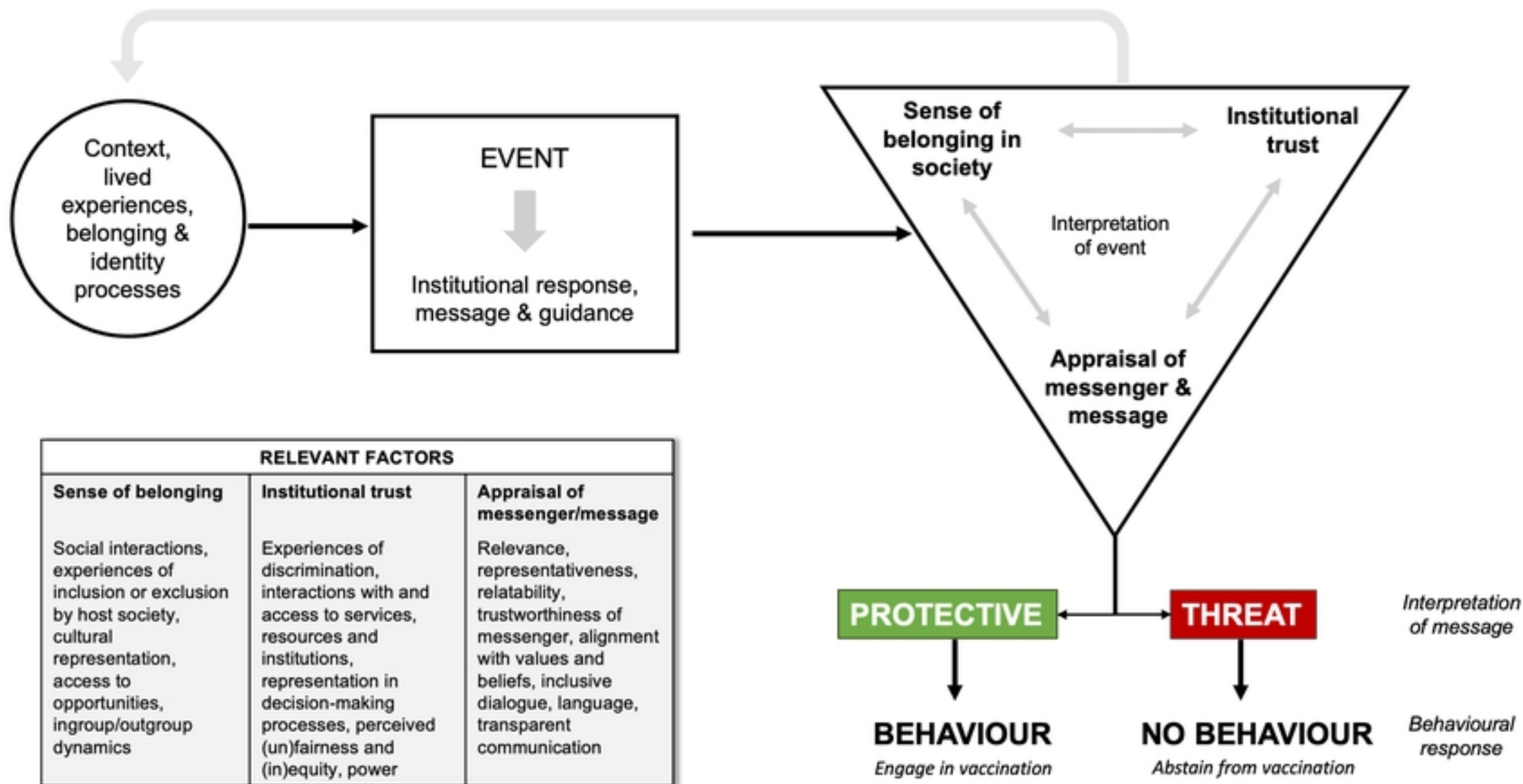
