47	Question: How does physician maldistribution, indicated by the physician uneven
48	distribution (PUD) index, impact resident physicians' clinical competence based on
49	performance in the General Medicine In-Training Examination (GM-ITE) in Japan?
50	Findings: In this nationwide cross-sectional study, resident physicians affiliated with
51	hospitals in regions with a lower PUD index (indicating insufficient medical
52	professional supply relative to healthcare demands) had significantly higher scores on
53	the GM-ITE than those in regions with a higher PUD index.
54	Meaning: Training resident physicians in areas short of physicians does not adversely
55	affect their education; rather, it can enhance medical education and address the
56	physician maldistribution issue.

60	Importance: This study highlights the association between physicians' maldistribution						
61	and core clinical competency of resident physicians and emphasizes the global						
62	significance of addressing healthcare access disparities.						
63	Objective: To investigate the relationship between a prefectural program with and						
64	without physician maldistribution and core clinical competency, measured using the						
65	General Medicine In-Training Examination (GM-ITE).						
66	Design: Cross-sectional study.						
67	Setting: Data from the GM-ITE survey were collected in January 2023.						
68	Participants: Resident physicians in their first and second postgraduate year (PYG-1						
69	and PGY-2) who were employed at Japanese hospitals that required the GM-ITE or						
70	resident physicians who voluntarily participated in the GM-ITE.						
71	Exposure: Physician uneven distribution (PUD) index is a policy index developed and						
72	adopted in Japan. It serves as an indicator of regional disparities among physicians						
73	within the country. A low PUD index indicates that there is an insufficient medical						
74	supply relative to the medical demand in that region.						
75	Main Outcomes and Measures: The GM-ITE scores of resident physicians.						
76	<b>Results:</b> The high PUD index group included 2,143 participants and the low PUD index						
77	group included 1,580 participants. After adjusting for relevant confounders,						
78	multivariable linear regression analyses revealed that the low PUD index group had a						
79	significantly higher GM-ITE score compared to the high PUD index group (adjusted						
80	coefficient: 1.14; 95% confidence interval: 0.62–1.65; p<0.001).						

### 81 Conclusions and Relevance: Resident physicians in regions with low PUD indices had

- 82 significantly higher GM-ITE scores. These findings underscore the significance of
- 83 addressing physician maldistribution to enhance the clinical competency of resident
- 84 physicians and emphasize the potential benefits of reducing regional healthcare
- 85 disparities, particularly in terms of medical education and training. These insights have
- 86 broader relevance for healthcare policies and medical training programs worldwide,
- 87 highlighting the need to consider physician distribution as a critical factor in improving
- 88 healthcare access and quality.

89	INTRODUCTION							
90	Japan is currently experiencing a severe crisis in local healthcare delivery due to the							
91	uneven distribution of physicians, which is exacerbating the critical situation in							
92	community hospitals in rural areas. <sup>1,2</sup> The insufficient number of physicians in rural							
93	areas due to urbanization remains a serious problem. <sup>3-5</sup> The issue of physician							
94	maldistribution is not unique to Japan; it is a global concern affecting China, India,							
95	England, Canada, the United States, Australia, and European nations. <sup>6-11</sup>							
96	In 2019, the Ministry of Health, Labour and Welfare (MHLW) initiated an							
97	intervention policy aimed at rectifying geographical disparities in physician distribution							
98	at the prefectural level. <sup>1,12-14</sup> This policy introduced the physician uneven distribution							
99	(PUD) index. The PUD index was designed to gauge the extent of physician							
100	maldistribution by considering both medical supply and demand at the prefectural level							
101	(Supplement 1). A lower PUD index indicates a higher level of uneven distribution of							
102	physicians across prefectures.							
103	In Japan, training physicians to produce proficient clinical practitioners							
104	involves 6 years of medical school followed by 2 years of clinical training as resident							
105	physicians. <sup>15-17</sup> Resident physicians are required to undergo supervised training and							
106	rotate through seven specialties (internal medicine, surgery, pediatrics, obstetrics and							
107	gynecology, psychiatry, emergency medicine, and community-based medicine). During							
108	this 2-year clinical training period, resident physicians are mandated to acquire core							
109	clinical competency that enables them to effectively manage common medical							
110	conditions in general practice, irrespective of their future specialization. <sup>18</sup> This clinical							
111	training system is currently undergoing a policy review, addressing concerns regarding							

112	recruitment capacity and other aspects, with a view to mitigate physician
113	maldistribution in various regions and enhance the quality of clinical training.
114	The MHLW has conducted a questionnaire regarding clinical training in areas
115	characterized by an uneven distribution of physicians. <sup>19</sup> According to the report,
116	resident physicians who received clinical training in areas with a relatively low number
117	of physicians reported a higher level of satisfaction. <sup>19</sup> Of the 2,684 resident physicians
118	who received their clinical training in areas with a relatively high number of physicians,
119	74.2% expressed satisfaction, though 79.6% of the 1,703 resident physicians who
120	received their clinical training in areas with a relatively low number of physicians
121	reported satisfaction with their clinical training. <sup>19</sup> A questionnaire assessing self-
122	perceived competencies related to clinical training revealed no significant differences
123	between prefectures with a relatively high number of physicians and those with a low
124	number of physicians in terms of professionalism (69.4% vs. 69.4%), medical
125	knowledge and problem-solving skills (69.9% vs. 67.2%), medical skills and patient
126	care (71.6% vs. 70.1%), or quality and safety of care (68.2% vs. 68.0%). <sup>19</sup>
127	However, to the best of our knowledge, no objective and quantitative
128	assessment of clinical training and proficiency in core clinical competencies within
129	regions affected by physician maldistribution has been conducted in Japan. <sup>19,20</sup> The
130	primary objective of this study was therefore to evaluate the relationship between areas
131	with a relatively high number of physicians and areas with a relatively low number of
132	physicians in each prefectural program and the achievement of core clinical
133	competencies, measured using resident physicians' General Medicine In-Training
134	Examination (GM-ITE) scores. <sup>21</sup>

**METHODS** 

136

137	Study design, setting, and participants
138	A nationwide cross-sectional survey was conducted on 9,011 postgraduate resident
139	physicians (approximately 50% of the total number of resident physicians in Japan)
140	from 662 hospitals who had taken the GM-ITE between January 17–30, 2023. The
141	participants in this study included resident physicians in their first and second
142	postgraduate years (PYG-1 and PGY-2, respectively) in Japanese hospitals in which the
143	GM-ITE was included in the residency program as well as those who voluntarily
144	participated in the GM-ITE. We included the participants of the GM-ITE 2022.
145	Participants who refused the use of their data for research were excluded.
146	
147	Main outcome
148	The main outcome of this study was the total GM-ITE scores of resident physicians. In
149	2011, the nonprofit Japan Institute for Advancement of Medical Education Program
150	(JAMEP) developed the GM-ITE as an in-training examination of clinical knowledge
151	using a methodology similar to that of the US Residency Internal Medicine In-Training
152	Examination. <sup>21-23</sup> The GM-ITE provides resident physicians and program directors with
153	an objective, reliable, and valid assessment of core clinical competency, including
154	clinical knowledge. <sup>21-24</sup> Designed by a committee of experienced attending physicians
155	organized by the JAMEP, the 2-hour GM-ITE includes 80 multiple-choice questions in
156	several domains <sup>24,25</sup> and is scored from 0 to 80, with higher scores indicating better
157	performance and knowledge of clinical medicine.
158	An assessment of the validity of the GM-ITE revealed a strong positive
159	correlation between GM-ITE scores and scores on the Professional and Linguistic

160	Assessments Board test, Part 1 (PLAB 1), which was designed to assess the depth of
161	medical knowledge and levels of medical and communication skills. <sup>26</sup> In validity testing,
162	the discrimination index indicates how well the item differentiates between students
163	with high and low aptitude (whether high-aptitude learners performed better, worse, or
164	the same as that of low-aptitude learners). <sup>27</sup> The GM-ITE exhibited equivalent or
165	superior discriminative power compared to the PLAB 1 examination. <sup>26</sup>
166	

### 167 Exposure and covariates

168 The exposure in this analysis was the PUD index (updated on August 9, 2023). This 169 index is a policy index developed and adopted in Japan. It serves as an indicator of 170 regional disparities among physicians within the country. A low PUD index indicates 171 that there is an insufficient medical supply relative to the medical demand in that region. 172 Resident physicians were categorized into three groups based on the score ranges of 173 their residency program, as follows: the high PUD index group (PUD index: 353.9-174 266.9), moderate PUD index group (PUD index: 266.5-230.5), and low PUD index group (PUD index: 228.0-182.5).<sup>19</sup> The resident physicians were also categorized based 175 176 on their duty hours per week: <60 hours, 60–79 hours, and  $\geq$ 80 hours. The duty hour 177 category was defined with a lower limit indicating no or minimal overtime and an upper 178 limit of 80 hours per week, in accordance with the new resident physician duty hour 179 limit set by the MHLW. The questionnaire administered in this study included questions 180 regarding the participants' demographic information, such as hospital type (community 181 hospital or university hospital), gender, postgraduate year (PGY-1 or PGY-2), 182 participation in the general medicine rotation, and the duration of the participant's 183 internal medicine rotation. The number of night shifts per month, average number of

- assigned inpatients, and self-study time per day were also reported by the resident
- 185 physicians.

### 187 Statistical analysis

- 188 The participant demographics and characteristics, as well as the GM-ITE scores, were
- 189 compared among the three PUD index groups. Multivariate linear regression analysis
- 190 was used to evaluate the association between the PUD index grade and the GM-ITE
- 191 score. The results were adjusted for covariates, including hospital type, gender, PGY,
- 192 rotation in the general medicine department, internal medicine rotation duration,
- 193 number of night shift duties per month, average number of assigned inpatients, self-
- study time, and duty hours per week. All statistical analyses were conducted using
- 195 Statistical Analysis System version 9.4 for Windows (SAS Institute Inc., Cary, NC,
- 196 USA), with the level of significance set at p < 0.05. All statistical tests were two-tailed.
- 197 This study was approved by the Ethical Review Committee of the Japan
- 198 Organization for Advancing Medical Education (approval no. 23–9). All participants
- 199 provided informed consent prior to their participation in the study in accordance with
- 200 the Declaration of Helsinki.

### RESULTS

### 203 **Demographics**

A total of 5,762 resident physicians from 608 hospitals, including 3,922 (68.1%) men,
participated in this study (Table 1). The minority of resident physicians (n=979; 17.0%)
were from university hospitals. The high PUD index group included 2,143 participants,

207 the moderate PUD index group included 2,039 participants, and the low PUD index

208 group included 1,580 participants.

- 209 Overall, the mean GM-ITE score was  $45.45 \pm 8.23$  points. The mean scores of
- 210 the high, moderate, and low PUD index groups were  $44.70 \pm 8.25$  points,  $45.69 \pm 8.25$
- 211 points, and  $46.16 \pm 8.09$  points, respectively. The GM-ITE score distribution is shown
- in terms of the PUD index in Figure 1.
- 213 Approximately half (54.4%) of the participants did not undergo a general
- 214 medicine rotation; 26.8% underwent an internal medicine rotation that lasted 0–5
- 215 months, while 61.6% underwent an internal medicine rotation that lasted 6–10 months.
- 216 The reported hours per week were <60 hours in 51.0% of participants, 60–79 hours in

217 35.5% of participants, and  $\geq$ 80 hours in 13.5% of participants.

218

### 219 Univariate linear regression analysis

- As shown in Table 2, in univariate linear regression analysis, a low PUD index was
- associated with a higher GM-ITE score when compared to a high PUD index (adjusted
- 222 coefficient: 1.46; 95% confidence interval: 0.93–1.99; p<.001). A moderate PUD index
- 223 was also associated with a higher GM-ITE score (adjusted coefficient: 0.98; 95%
- 224 confidence interval: 0.49-1.48; p<.001) when compared to a high PUD index.

225

### 226 Multivariate linear regression analysis

- 227 In multivariate linear regression analysis, a low PUD index was identified as an
- independent predictor of a higher GM-ITE score when compared to a high PUD index
- 229 (adjusted coefficient: 1.14; 95% confidence interval: 0.62–1.65; p<.001) (Table 3). A
- 230 moderate PUD index was also identified as an independent predictor of a higher GM-

ITE score (adjusted coefficient: 0.91; 95% confidence interval: 0.43-1.39; p<.001) when</li>
compared to a high PUD index.

233	Participation in a residency program at a university hospital was identified as an
234	independent predictor of a lower GM-ITE score when compared to participation at a
235	community hospital (adjusted coefficient: -4.05; 95% confidence interval: -4.633.48;
236	p<.001). A PGY-2 status was an independent predictor of a higher GM-ITE score
237	(adjusted coefficient: 0.74; 95% confidence interval: 0.27-1.20; p=.002). Having 31-60
238	(adjusted coefficient: 2.70; 95% confidence interval: 1.15-4.26; p<.001), 61-90
239	(adjusted coefficient: 3.27; 95% confidence interval: 1.64-4.91; p<.001), or $\ge$ 91
240	(adjusted coefficient: 4.28; 95% confidence interval: 2.38-6.17; p<.001) minutes of
241	study time per week was also indicative of higher GM-ITE scores compared to 0 self-
242	study time. Working 60–79 hours per week was predictive of a higher GM-ITE score
243	(adjusted coefficient: 1.27; 95% confidence interval: 0.81-1.72; p<.001) compared to
244	shorter working hours (<60 hours). The other factors significantly associated with GM-
245	ITE scores were gender (women), participation in a general medicine rotation, internal
246	medicine rotation duration, number of night shifts, and number of assigned patients.
247	
248	DISCUSSION
249	Resident physicians from training programs in regions with a low and moderate PUD
250	index (areas facing physician shortages due to regional maldistribution) achieved
251	significantly higher GM-ITE scores than those in programs with a high PUD index. To
252	the best of our knowledge, this is the first study to quantitatively evaluate the

253 relationship between the distribution of physicians and the core clinical competency of

the resident physicians using nationwide data.

255 Physician maldistribution is a global problem that hinders patients' ability to access healthcare services.<sup>28</sup> Physicians are geographically maldistributed, with too few 256 physicians in rural areas.<sup>29,30</sup> In Japan, there is a well-documented issue of physician 257 258 shortages and regional maldistribution, where approximately 90% of physicians are clustered in urban areas.<sup>31</sup> As an example of countermeasures, changing the medical 259 education system so that it selects, trains, and retains physicians who are more likely to 260 practice in rural areas can remedy problems of rural geographic maldistribution.<sup>29</sup> 261 262 Resident physicians who train in areas with a high PUD index may have a 263 more passive attitude towards clinical training than resident physicians who train in low 264 PUD index areas. This could be attributed to the possibility that clinical experiences in 265 areas with a high PUD index might not offer as diverse or challenging opportunities as 266 those in areas with a lower PUD index. In high PUD index areas, opportunities for the 267 supervising physician to allow resident physicians to make independent judgments may 268 be limited, leading to an observational training style. Furthermore, the higher patient 269 load or complexity in these high PUD index areas could potentially overshadow the emphasis on hands-on experience, prioritizing efficiency over educational value.<sup>32</sup> 270 271 Areas with high numbers of supervising physicians and nurses involved with 272 resident physicians have disadvantages. When resident physicians interact with several 273 different senior physicians and nurses, it takes time to establish relationships and build 274 trust, which may lead to inefficient learning and reduced effectiveness. A lower number 275 of supervising physicians in low PUD areas, including medical resident physicians, is associated with higher GM-ITE scores.<sup>33</sup> 276

277 Resident physicians in Japan require at least 60–65 duty hours per week
278 during their clinical training to acquire a certain level of clinical knowledge.<sup>21</sup> However,

clinical knowledge does not proportionately increase with increases in duty hours. The
optimal number of duty hours that maximizes the development of resident physicians'
competencies must be determined. In Japanese areas with a low PUD index, resident
physicians face moderately longer working hours than resident physicians in areas with
a high PUD index, which may contribute to skill development.

284 Resident physicians from areas with a low PUD index dedicated more time to 285 self-study than those in areas with a high PUD index. Self-study time was strongly 286 correlated with GM-ITE scores, suggesting that self-directed learning is crucial for 287 enhancing competency, irrespective of the region (rural or urban). The positive 288 relationship between longer self-study time and higher GM-ITE scores in this study is consistent with the results of a previous report.<sup>34</sup> William Osler noted that, "To study the 289 290 phenomena of disease without books is to sail an uncharted sea, while to study books without patients is not to go to sea at all."<sup>35</sup> Hence, it becomes imperative to ensure the 291 292 optimal equilibrium between the two elements within the constraints of limited time. In 293 Japan, physicians' work-style reforms, including the establishment of working hour 294 limits for physicians and resident physicians, are scheduled to be implemented in April  $2024.^{36}$  Resident physicians working <60 hours per week reported less self-study time 295 than those working 60–65 hours per week.<sup>21</sup> Therefore, innovative self-study tools that 296 297 efficiently demonstrate educational concepts in a limited time are needed. 298 Physician maldistribution remains a significant challenge in the global 299 healthcare context. The findings of the current study underscore the importance of

300 policy-driven interventions in addressing these disparities. The correlation between the

301 PUD index and resident physicians' clinical competence suggests that the quality of

302 medical training and patient care is intricately linked to the equitable distribution of

303	healthcare resources.	The impact	of physician	distribution	on clinical	competence	may

- 304 have implications beyond Japan, suggesting a need for international collaborative
- 305 efforts to address this issue.

### 307 Limitations

308 This study is not without limitations. First, the potential for selection bias cannot be 309 ruled out. As the GM-ITE is voluntary for training hospitals, only half of the resident 310 physicians in Japan participated in this study. Second, a bias may exist between data 311 from community and university hospitals. Similar to previous studies regarding the 312 GM-ITE, resident physicians from university hospitals had lower GM-ITE scores in this study.<sup>37</sup> The low PUD index group had a lower proportion of university hospitals, which 313 314 may be a confounding factor. Third, the resident physicians' baseline clinical skills were 315 not assessed. The participants had various medical school experiences, which may have 316 impacted the study results. Fourth, this investigation did not evaluate the actual number 317 of supervising physicians in each hospital or their years of clinical experience. These 318 factors may have affected the GM-ITE scores. Fifth, the current study relied heavily on 319 the GM-ITE scores as a primary measure of clinical competence. Although the GM-ITE 320 is a validated tool, it predominantly assesses theoretical knowledge rather than practical 321 skills. Sixth, although the regions were categorized based on the PUD index, intra-322 regional disparities may exist. Different areas within a single region may have varying 323 physician densities, which may lead to heterogeneity in the clinical exposure and 324 training of residents within the same PUD category. Seventh, while the GM-ITE 325 assesses medical interviewing for communication skills, it does not sufficiently evaluate

326 crucial aspects such as interpersonal literacy and interprofessional communication

327 essential for effective leadership in contemporary medicine.

## 329 CONCLUSIONS

- 330 In prefectures with a shortage of physicians, resident physicians enrolled in training
- 331 programs can attain favorable core clinical competency scores. This highlights the close
- 332 relationship between efforts to address physician maldistribution and the enhancement
- 333 of clinical competency among resident physicians in Japan. Regions with a relatively
- insufficient distribution of physicians, as indicated by a lower PUD index, have higher
- 335 clinical proficiency, measured as the GM-ITE scores. As the healthcare landscape
- evolves, the assurance of equitable physician distribution has emerged as a central tenet
- 337 of robust healthcare systems. The findings of this study have global implications.
