# First assessment of a cost questionnaire for its agreement with administrative databases in females with stress urinary incontinence in Switzerland: a validation study

# 2 Abstract

3 Introduction: Economic research in the field of pelvic floor rehabilitation is lacking in transparency of methodology and consideration of indirect costs. Service use guestionnaires 4 collect cost data with the broad approach needed for the societal perspective of health 5 6 economic studies. Nevertheless, these questionnaires are seldom validated. Therefore, this 7 study aimed to evaluate the accuracy of a questionnaire to assess healthcare costs of 8 females with stress urinary incontinence (SUI) in Switzerland. 9 Methods: A guestionnaire was developed to measure direct medical, direct non-medical and 10 indirect costs in females with stress urinary incontinence living in the larger Bern area in Switzerland. Participants were recruited out of a prior study sample, where they had already 11 12 completed the cost questionnaire. Administrative databases' cost data were obtained for the 13 investigation period. The agreement between the reported direct medical costs of the questionnaire with those from the providers' billings was assessed using Pearson correlation 14 coefficient (r), intraclass correlation coefficient (ICC) for agreement, Lin's concordance 15 16 correlation coefficient (LINCCC) and limits of agreement (LOA). 17 **Results:** Fourteen participants were eligible for this study. Agreement between the two 18 methods presented a Pearson's r of 0.64 [95%CI 0.16 to 1.00], ICC of 0.79 [95% CI 0.33 to 19 0.93] and LINCCC 0.75 [95% CI 0.19 to 0.86]. LOA results showed no evidence for 20 systematically under- or overreporting. 21 **Conclusions:** The developed questionnaire seemed to be an acceptable representative for 22 direct medical costs in females with stress urinary incontinence in Switzerland. However, 23 direct non-medical and indirect costs were not compared to an external criterion. 24 25

# 28 Introduction

29 In Switzerland, per capita healthcare expenditures rise steadily from year to year. In 2020, 30 healthcare costs amounted 11.8% of the gross domestic product (1). In times of increasing health expenditures, it is indispensable to perform economic evaluations to ensure cost-31 32 effective resource allocation in healthcare organizations. The estimation of costs is an essential aspect when conducting health economic analyses. 33 34 Thus, valid tools are required to obtain useful cost data. Self-reported questionnaires are one 35 alternative to gain resource utilization data (2). The societal perspective is recommended for 36 health economic analyses, since costs shifting between sectors might be detected (3). 37 Hence, not only direct medical costs are taken into account, but all arising expenses

38 concerning the macroeconomic situation (4). In contrast to health insurance administrative

data, self-reported questionnaires allow this broad capture of health related costs (5). Apart

40 from direct medical costs, direct non-medical costs such as travel expenses, costs resulting

41 from paid or unpaid informal care or indirect costs such as absenteeism, presenteeism or

42 early retirement are considered (6). Economic estimations based on self-reported

43 questionnaires are, unlike medical records, not limited by lacking cooperation of

44 administrative staff or restrictions due to privacy and security concerns. Although

45 administrative databases only allow insight into direct medical costs, they are a rich source of

46 accurate data. While retrospective patient reported questionnaires may be affected by recall

47 bias, administrative data does not suffer from such influences (5). However, administrative

data may be inaccessible in a time- and cost-efficient manner and inappropriate due to their
limited perspective (2).

Therefore, within the scope of a cost of illness (COI) study, a questionnaire to measure health related costs in females with stress urinary incontinence (SUI) was developed. Urinary incontinence is a common problem among females, causing almost ten billion Euros of direct and indirect costs in Europe per year (7). Stress urinary incontinence is the most common type of this condition with a mean prevalence of 35% in Europe (8). In the field of pelvic floor

medicine, transparency in the costing methodology and consideration of a broad perspective
of costs are lacking globally as well as in Switzerland (7). Thus, the aforementioned
questionnaire should be eligible for further health economic evaluations in urinary
incontinence. Therefore, it ought to be published on "Database of Instruments for Resource
Use Measurement (DIRUM)"; an open-access database of resource-use questionnaires for
use by health economists (9).

# 61 Methods

The aim of this study was to evaluate the questionnaire's accuracy of assessing health related costs in females with stress urinary incontinence living in the larger area around Bern in Switzerland. Since there is no standardized method for validating health economic questionnaires, health insurance administrative data was used as the comparative value as seen in previous papers (5,6,10,11).

# 67 Questionnaire development

68 The questionnaire was developed for a previous COI analysis in patients with stress urinary 69 incontinence. However, validity of the data gathered by this tool was never evaluated. The 70 "Health status, comorbidities and cost-of-illness in females with stress urinary incontinence 71 living in the Canton of Bern" (12) was embedded in a randomized controlled trial investigating 72 the effects of two pelvic floor muscle training protocols (13). The first version of the 73 instrument was developed based on a questionnaire that has already been used in a study 74 from the Universities of Ghent and Antwerp (Belgium), which evaluated health status and 75 costs of obesity in adult females in Flanders (14). Face validity of the adapted cost 76 questionnaire was operationalized by comprehensibility and completeness of its items and 77 assessed by six experts in the field of pelvic floor rehabilitation. Additionally, the 78 questionnaire was confirmed for comprehensibility by two pilot-test subjects. To review 79 criterion validity in a first point, these two test subjects filled out the cost questionnaire 80 retrospectively for the last four months and provided the health insurance bills for the same 81 period of observation. The comparison with the survey data did not raise any major

sconcerns, or the need for further modifications (12).

83 The present cost questionnaire under investigation assessed participants' characteristics, health status and health related costs retrospectively over four months. This included all 84 85 direct medical costs such as medical and therapeutic treatment costs, raises for dental 86 services, complementary medicine, and medications. Consumed service units and price units 87 were asked separately. In addition, direct non-medical costs (e.g., incontinence aids) and 88 indirect costs (e.g., productivity loss such as work absenteeism and presenteeism) were assessed. "Filter questions" were used as guiding assistance for costs reporting (6). The 89 questionnaire in full version can be found under "additional files". 90

#### 91 Setting

The previous COI study of Koenig et al. (12) used a prevalence based, bottom-up approach. 92 93 According to a prevalence based approach guidelines, guestions of the survey targeted not 94 only expenditures due to SUI but the entirety of healthcare expenditure (15). Out of 96 95 participants in the original randomized controlled trial (RCT), 37 adult female participants volunteered in the COI study and completed the cost questionnaire in an individual four-96 97 month time horizon between 2016 and 2017. Each participant returned her questionnaire during a post-intervention measurement for the RCT. The answers were then checked by the 98 responsible examiner for completeness and missing data were completed immediately in the 99 100 presence of the participants. Based on unit prices, Koenig et al. (12) estimated the total 101 healthcare costs of the investigated four months.

The Swiss healthcare system is highly decentralized. Compulsory health insurance is offered
by competing insurers with minimal annual deductibles of 300 Swiss Francs (CHF) for
insured adults. Insured persons may increase deductibles up to 2'500 CHF. Insured persons
also pay 10% coinsurance of these services with an annual limit of 700 CHF for adults (16).
Residents are free to take out a supplementary insurance. In contrast to the compulsory
health insurance, coverage of services may differ between insurance providers.
Supplementary insurances might include, for example, complementary medicine, dental

109 treatment, or health prevention services. There are different methods of charging the fee:

service providers can either invoice the insurances directly or they can bill patients, which

settle up the account and claim reimbursement from the insurer (16).

#### 112 Study participants and procedure

113 Each participant received written information about the study design and procedures and

signed the informed consent form between October 2019 and February 2020. With

volunteer's power of attorney, one of the authors (CM) was allowed insight into personal

health insurances billing data of the investigated four-month period between 2016 and 2017.

117 The inclusion criteria for the previous randomized controlled trial were: age range 18 to 60

118 years, body mass index (BMI) between 18 to 30 kg/m<sup>2</sup>, nulliparous or at least 12 months

postpartum with a negative pregnancy test, ability to read and understand the German

120 language and to run on a treadmill. Exclusion criteria were: acute urinary tract or vaginal

121 infections, urogenital surgery, predominant overactive bladder and urogenital prolapse over

122 grade one pelvic organ prolapse quantification system (POP-Q). These criteria met the

123 International Consultation on Incontinence's recommendation for diagnosis of SUI (17).

# 124 Statistical analysis

125 Characteristics of the sample were compared to the original cohort of the RCT with a 126 Student's *t*-test for independent samples. As a reference for the degree of incontinence, the 127 Oxford Grading Scale was used. This scale is a classification system of the pelvic floor 128 muscle strength where zero represents no palpable contraction and the maximum score of 129 five signifies strong contraction (18). Median and interquartile range (IQR) of observed 130 muscle strength values were calculated for the original and the current samples.

For comparability with other studies (19), descriptive parametric statistics were used to analyze the cost data, despite the probability of a skewed distribution. The items "medical care" and "physiotherapy" fell into the scope of compulsory health insurance. The items "dental care", "complementary treatment" and "medication" were categorized as services within supplementary insurance. To measure criterion validity, the differences between

reported costs and health insurance billings were calculated and compared with "0" 136 137 difference using a one-sample t-test. For a first visual impression of the relationship between the datasets, a scatterplot was performed. Cost data is usually skewed due to, for example, 138 139 medical complications. Therefore, data was log transformed for approximate normality to conduct calculations of correlation (20,21). 140 As a preliminary test, consistency of variables was indicated by Pearson's correlation 141 142 coefficient (r). Agreement was measured using intraclass correlation coefficient (ICC). Since 143 the variables were continuous and reported in the same units, ICC was appropriate (22). ICC 144 two-way, mixed model formula for agreement was applied. As a reference value for small sample sizes, Lin's concordance correlation coefficient (LINCCC) was added (23). 145 Pearson's r, ICC and LINCCC are measurements of correlation ranging from 1 (perfect 146 agreement) to -1 (perfect inverse agreement) (23,24). The following levels for interpreting 147 accuracy were applied: "poor" = < 0.40, "fair to good" = 0.40 to 0.74, "excellent" = 0.75 to 148 1.00 (25). Standard error of measurement (SEM) was calculated (26). Systematic bias was 149 assessed using limits of agreement (LOA) and were presented in a Bland Altman plot (6). 150 151 The visual result was supported by the calculation of linear regression of the difference between the costs over mean value of the costs. The procedure was doublechecked by two 152 of the authors independently. 153

All data analyses were performed using SPSS (IBM Corp. Released 2017. IBM SPSS
Statistics for Windows, Version 25.0. Armonk, NY: IBM Corp.) and with a macro written in
Excel for the calculation of LINCCC. Significance was set at 5% level of error.

# 157 **Results**

158 Out of the 37 participants of the COI study, 14 persons volunteered in the present agreement 159 study. The participants were insured in eight different healthcare insurance companies,

160 which all provided detailed billing data after written request from the participants.

161

- 162 Table 1 shows the characteristics of the participants such as age, BMI, number of vaginal
- births as well as sectio and scores on the Oxford Grading Scale. The present sample differed
- in none of these variables significantly from the original RCT population (p > 0.05).

166 In table 2, data was compiled by subgroups. Mean values and standard deviations (SD) for

reported costs and billings were opposed for the items "medical care" and "physiotherapy"

168 indicating compulsory services, and "dental care", "complementary treatment" and

169 "medication" representing supplementary services.

173 well as expenditures of compulsory and supplementary services separately. Total sum of

174 reported costs during the four-months period was CHF 18'038.85 and CHF 17'113. 85 for

billings. Overall correlation between the reported costs and the billing sums yielded in a



- 180 Systematic errors of overall data are presented in the Bland Altman Plot in Figure 1. Linear
- regression from cost difference over mean costs yielded a beta regression coefficient of
- 182 -0.17 (p = 0.564).

# 188 Discussion

# 189 Assessment of validity

- 190 This study aimed to validate a questionnaire assessing costs in females with stress urinary
- incontinence living in the larger area around Bern in Switzerland. Although analysis of
- 192 correlation is known as a reliability process, it is also used as a method to determine criterion
- validity between the measurement instrument and the gold standard (22). As a gold
- standard, health insurance billing was used in this study.
- 195 Students' *t*-test for independent samples showed no significant difference in demographic
- data of the 14 participants enrolled in the current study to the original cohort of 96 females.
- 197 Since the participants of the RCT were diagnosed according to the criteria of the

International Consultation on Incontinence, the current sample was representative forfemales with stress urinary incontinence.

200 Healthcare expenditures analyzed by the items "medical care", "physiotherapy", "dental 201 care", "complementary treatment" and "medications" showed large standard deviations in 202 both reported and administrative data. Since each of those items represented different 203 medical services, this variability seemed to have occurred naturally. For example, a 204 respondent could accrue a ticket for a simple laboratory service of about CHF 20 in the 205 category of medical care as well as a surgical procedure of CHF 1'500. Despite the observed 206 variability, when comparing mean values of reported costs and billing data, subgroups 207 appeared similar. This was particularly relevant for the items "medical care" and 208 "physiotherapy". Participants seemed to estimate costs for these services accurately and 209 consistently with insurance billings. The differences of datasets get larger, when it comes to 210 the costs of dental care and complementary treatments. Reported dentist costs were three 211 times higher than insurances recorded billings. Since Swiss residents are free to take out a 212 supplementary insurance of their needs, different services might be covered or not. If 213 participants had a supplementary dental health insurance, dentists' costs would be covered 214 by the insurance. If not, residents would most likely settle the bill out of pocket without submitting the invoice to the insurance. Consequently, companies might be incompletely 215 216 informed and reflect the true costs insufficiently. Thus, the patient reported questionnaire 217 could be more accurate than the so-called gold standard itself. Concerning complementary 218 treatments, billings were higher than reported costs. Since overestimation of billing data is 219 unlikely (5), underestimation of patient reported cost must be assumed. Pinto et al. (5) observed this behavior of underreporting regarding doctor visits. Recall bias side lined, 220 221 difference of reported costs may also be a result of the "reverse telescoping" effect. 222 Telescoping occurs, when participants unconsciously lengthen their period of investigation 223 and report events erroneously into the recall time. In contrast, treatments within the time 224 frame may be "reverse telescoped" out of the recall period (27). True costs might even be 225 higher than insurance' billings revealed. Depending on the coverage of services, participants

226 may or may not have submitted the invoices to the companies. Therefore, unsubmitted 227 billings must be assumed, which would lead to a simultaneous underestimation of insurances 228 expenditures for complementary treatments. In the case of medications, insurance 229 companies' information is generally restricted to prescribed drugs. Whereas the patient 230 reported cost questionnaire captured all types of medication, including out of pocket 231 utilizations. Overall sums of reported costs and billings were similar but with large standard 232 deviations. Subsequently, the data range had a similar impact on each arm of the distribution and averaged itself out. Correspondingly similar values of reported costs were found after 233 234 dividing the costs into categories of compulsory and supplementary services. Differences 235 between the data sets were nonsignificant in all the three calculations. Therefore, Pearson's r correlation coefficient was calculated. In contrast to ICC agreement, Pearson's r does not 236 237 take systematic error into account (22). Whereas ICC measures the degree to which one variable can be equated to another variable, Pearson's r assesses the linearity of the 238 relationship between the two variables. Lin's concordance correlation coefficient is known for 239 240 its robustness even with small sample sizes (23,24). It evaluates the degree to which pairs 241 fall on the 45° line when plotted (28). In this present study, variability between the degree of 242 correlation between the three methods occurred. Given the small number of samples, 243 Pearson's r and ICC may have yielded unstable calculations. Hence, ICC reflected a higher 244 correlation than Pearson's r despite the more restrictive formula (22). Point estimations of 245 correlation for overall data were "fair/ good" to "excellent" according to the levels of accuracy 246 with a Pearson's r of 0.54 [95% CI 0.16 to 1.00], ICC of 0.79 [95% CI 0.33 to 0.93] and 247 LINCCC of 0.75 [95% CI 0.19 to 0.86]. Nevertheless, the large confidence intervals indicated 248 an ambiguous result. As expected, due to the descriptive values, correlations of 249 supplementary services were lower than compulsory services with point estimations rated 250 "fair to good" for supplementary services respectively, "fair to good" and "excellent" for 251 compulsory services.

The Bland Altman plot (figure 1) depicts the mean value of the pairs against differences
between the pairs. Each dot on the plot represents data from one participant. There are six

dots each above and below the mean visible. The limits of agreement are wide and thus 254 255 consistent with the large confidence intervals of the correlations. Out of 14 dots, 13 are 256 located within the limits of agreement and one is situated exteriorly. There is a trend 257 noticeable, where the more the mean increases, the larger the differences become. This 258 finding suggests that participants who have less health service consumption were able to 259 estimate their costs better than those with much healthcare consumption. The calculation of 260 the linear regression confirmed the first impression of no evident systematic bias. Beta coefficient was -0.17 (p = 0.564), indicating that there was no proportional bias involved. 261 262 Indeed, the plot shows that the deviations of the mean were evenly balanced between under-263 and overreporting of study participants. In the systematic review of Leggett et al. (2), a tendency of underreporting was noticed. The 15 included self-reported questionnaires 264 265 seemed to capture the number of hospitalizations and emergency room visits accurately, whereas participants tended to underestimate the number of visits to a general practitioner 266 (GP). 267

268 Pinto et al. (5) developed a questionnaire to capture healthcare use and costs in patients 269 with osteoarthritis in New Zealand. This study included 50 participants. The reported costs of 270 the three-month investigation period were compared to administrative data. GP services, 271 hospital services and medication use were collated. According to the authors, correlations 272 were acceptable concerning GP services and hospitalizations (LINCCC >0.4) but exhibited 273 poor agreement for medication (LINCCC < 0.4). These results were in line with findings of 274 the current included females with SUI. Depending on the cost categories, concordance between survey and administrative data corresponded well and the questionnaire seemed to 275 give an appropriate reflection of direct medical costs. Nonetheless, administrative databases 276 277 were limited as gold standard, since they captured a more restricted perspective of costs 278 than the patient reported questionnaires.

This study attempted an important step for standardized economic research in the field of pelvic floor medicine and rehabilitation. Further research is needed to evaluate and

strengthen the results of this present study on a greater sample size. Since the cost
questionnaire is only available on paper, a digital version is required. For this future version,
a feasibility study will be needed.

#### 284 Limitations

285 In their systematic review, Leggett et al. (2) showed that few studies have aimed to measure the accuracy of healthcare service use and cost data questionnaires. Thus, no unambiguous 286 method is known (29) and limitations need to be declared. The first obstacle for assessing 287 288 accuracy of such questionnaire is the lack of an appropriate "gold standard" (29). Insurance 289 companies do not cover all types of healthcare costs and are therefore not informed about the totality of expenses. Due to the decentralized Swiss healthcare system, there is no single 290 291 omniscient administrative database. Survey data were thus compared to a deficient criterion. 292 Secondly, since there is no appropriate comparator for a broad perspective of costs, the cost 293 questionnaire was assessed for a subset of questions only. Hence, declaration of validity 294 was only possible for the part of direct medical costs. Direct non-medical and indirect costs 295 were neglected. Thirdly, sample size of the present study was low (n = 14). Due to the fact, 296 that the study population was originally participating in an RCT and was committed to the following COI analysis, only few people agreed with another observation. Consequently, the 297 298 low number of participants may have generated unstable calculations. An unambiguous 299 result would have been achieved by a greater cohort.

#### 300 Conclusion

The developed questionnaire for measuring costs in females with stress urinary incontinence in Switzerland seemed to capture direct medical costs sufficiently. Overall correlation of patient reported data and health insurance billings yielded in a Pearson's *r* of 0.64 [95% CI 0.16 to 1], ICC of 0.79 [95% CI 0.33 to 0.93] and LINCCC of 0.75 [95% CI 0.19 to 0.86]. Compulsory services such as medical care and physiotherapy corresponded better with administrative database than supplementary services such as expenses for dentist,

- 307 complementary treatment, and medication. No proportional bias of under- or overreporting
- 308 occurred.
