12	Abstract:
13	background: The incidence rate of fear of falling in chronic stroke is high, which seriously
14	affects the quality of life and rehabilitation effect of patients. Early identification of its risk factors
15	will help clinical screening of high-risk patients and prevent their further development. There is
16	currently no systematic evaluation of risk factors for fear of falling falls in chronic stroke.
17	Objective: we systematically reviewed the literature on risk factors for fear of fall in chronic
18	patients with stroke. Method: We systematically searched PubMed, Embase, cochrane, Web of
19	Science and the China National Knowledge Infrastructure(CNKI), the china biomedical literature
20	database(CBM), the China Science and Technology Periodicals Database(VIP), Wangfang data for
21	relevant literature until May 2023.Review Manager V.5.3 merged the OR value and 95% CI of the

23	individual studies.Cochran's Q and the I ² tests were used to assess heterogeneity between the
24	studies. Results: A total of 6 studies were included for the final analysis, with 965 chronic stroke
25	patients. The risk factors for fear of falling in chronic patients with stroke were impaired balance
26	ability (OR=3.05; 95% CI 1.60 to 5.80), history of falls (OR=2.12; 95% CI 1.40 to 3.20) and
27	anxiety (OR=2.29; 95% CI 1.43 to 3.67), depression (OR=1.80; 95% CI 1.22 to 2.67), poor lower
28	limb motor function (OR=1.14; 95% CI 1.00 to 1.29), physically inactiveness (OR=2.04; 95% CI
29	1.01 to 4.12). Married (OR=0.61; 95% CI: 0.435-0.875) is a protective factor. Conclusion:Our
30	study shows that impaired balance ability, history of falls might be a greater risk for fear of
31	falling. Future studies are recommended to determine other risk factors specific to patients with
32	chronic stroke.

34	Stroke remains the second largest cause of death globally and the main cause of disability in
35	adults(1). In China, stroke is the main cause of death, and As our population grows and ages, the
36	number of deaths will steadily increase(2). There are many complications after brain stroke, and
37	falls are a common complication(3). Some scholars have found that people with a history of stroke
38	have an increased risk of falls (4), which may be related to hemiplegia(5), balance loss(6), sensory
39	disturbances(7), fatigue(8), depression and anxiety(9), and cognitive dysfunction(10) caused by
40	stroke.Fear of falling (FOF) refers to the decrease in self-efficacy or confidence that occurs to
41	avoid falling while performing an activity(11). Studies have shown that patients with stroke have a
42	higher risk of developing the fear of falling(12), which may be related to an increased risk of
43	falling after stroke(13). The incidence of fear of falling after stroke has been reported to be
44	approximately 32 to 66 percent(14-16). Fear of falling is associated with adverse consequences

45 such as limited activity, increased incidence of falls, decreased quality of life, and increased hospitalization and case fatality rates(17, 18). Moreover, FOF was also significantly associated 46 47 with anxiety and depression(16). Therefore, it is very important to screen stroke people with high risk of fear of falling as early as possible and provide targeted intervention measures, so it is 48 49 necessary to explore the risk factors of FOF in stroke. However, the fear of falling is a dynamically 50 changing psychological problem, and risk factors vary from stage to stage. Previous studies have 51 always considered acute stroke and chronic stroke as a whole, so this study only conducts a 52 meta-analysis of risk factors for fear of falling in patients with chronic stroke, in order to provide a 53 reference for clinical staff to identify people at high risk of FoF as early as possible and prevent 54 their further development. 1. Materials and methods 55 56 **1.1 Search Policy** 57 Using subject words combined with free words, we searched the CNKI, Wanfang, VIP, CBM, PubMed, EMbase, The Cochrane Library, and web of science databases. The search period 58 59 is until May 30, 2023.search terms include: "stroke", "strokes", "cerebrovascular accident *", "CVA", "cerebrovascular apoplexy", "brain vascular accident *", "cerebrovascular stroke *," 60 61 apoplexy "," cerebral stroke, "acute stroke," acute cerebrovascular accident "," cerebral infarction "," cerebral hemorrhage "," brain ischemia, "Accidental Falls", "Falls", "Falling", "Accidental 62 Fall*", "Slip and Fall", "Fall and Slip", "Accident Prevention "," Home Accidents "," Fear "," 63 fear* "," Panic "," worry "," afraid". Taking the PubMed database as an example, the retrieval 64 65 formula is as follows: (((stroke[MeSH Terms]) OR ("stroke"[Title/Abstract] OR "strokes"[Title/Abstract] OR 66

76 **1.2 Inclusion and exclusion criteria**

Inclusion criteria (1) Study subjects: stroke patients who meet the diagnostic criteria, patients with disease time \geq 3 months or convalescent period; (2) exposure factors: risk factors for fear of falling in patients with chronic stroke were reported, and the OR or RR value was extracted directly from the included studies; (3) fear of falling: use of validated screening tools; (4) Case-control studies, cohort studies, and cross-sectional studies.

Exclusion criteria: (1) the data in the literature cannot be converted and applied; (2) repeated
publications; (3) Conference papers, case reports; (4) low-quality literature.

84 **1.3 Literature screening and data extraction**

Endnote X9 software was used to remove duplicates.Browsing the title and abstract, preliminary screening of literature according to inclusion and exclusion criteria, further review of literature that may meet the inclusion criteria, discussion or consultation with a third person in case of disagreement.Two review authors conducted literature extraction independently based on

searches, reviewed and selected according to predefined criteria. The extracted data includes: first
 author, year of publication, Country, type of study, sample size, course of illness, screening tools

- 91 for fear of falling, influencing factors.
- 92 **1.4 Quality assessment**

93 Two researchers independently evaluated the literature, and if there was a disagreement, a third investigator was invited to participate. The methodologic quality assessment of case-control 94 95 studies and cohort studies was assessed by the Newcastle Ottawa Scale (NOS) for the study 96 population, comparability and outcome evaluation. The scale's total score was kept as 9 points, 97 where 0 to 3 were divided into low-quality research, 4 to 6 were divided into medium-quality 98 research and 7-9 were divided into high-quality research. In addition, the risk of bias in a 99 cross-sectional study was assessed using the instrument Agency for Healthcare Research and 100 Quality (AHRQ). The total score is 11 points, 0~3 is low quality, 4~7 is medium quality, and 8~11 101 is high quality.

102 **1.5 Statistical analysis**

we conducted a meta-analysis by the RevMan V.5.3 software to pool the *OR/RR* value with 95% CI.Statistical heterogeneity between studies was quantified by the I² statistics and formally tested by Cochran's Q statistic. If P \geq 0.1, I² \leq 50%, indicating homogeneity between studies, a fixed-effect model was used; Conversely, there was heterogeneity, and random-effects models were used or results pooled were abandoned.Sensitivity analysis: different effect models were used to pool effect sizes separately to see if there was a difference in the results.

109 2 Results

110 **2.1 Literature selection**

111	Initially,1297 records were searched from the eight databases and other resources (figure 1).
112	After the exclusion of duplicates, the remaining 669 records were screened. After analysing the
113	title and abstract, ultimately, 43 publications were selected for the full-text assessment. Finally, six
114	full-text studies were included in this meta-analysis.

116	2.2 Basic characteristics and quality evaluation of the included literature
117	Six studies were included in the meta-analysis. They are from four countries: China (n=2),
118	Sweden (n=2), Canada (n=1), India (n=1); Among these studies, two were cross-sectional, three
119	were case-control and one were prospective cohort studies. the included literature scored as 5-8; 4
120	high-quality studies and 2 of moderate quality. A summary of literature characteristics used in the
121	analysis is shown in table 1.

- 131 **2.3 Results of the meta-analysis**
- 132 **2.3.1 Age**

Two studies reported the relationship between age and fear of falling, with heterogeneity testing (I2=82%, p=0.02), with great heterogeneity among the studies, so a random effects model was used for the analysis. The results showed no statistical significance:OR=1.13;95%

136 CI:0.85-1.52(Figure 2).

138 **2.3.2 History of falls**

139	Three studies reported the relationship between history of falls and fear of falling, with
140	heterogeneity testing (I2=0%, p=0.93), and there was no heterogeneity among the studies, so a
141	fixed-effects model was used for the analysis. The results showed that history of falls (OR=2.12;
142	95% CI:1.40-3.20) was a risk factor for fear of falls in chronic stroke(Figure 3).

144	2.3.3 Balance ability
145	Two studies reported a correlation between balance ability and fear of falling, with
146	heterogeneity tests (I ² =0%, p=0.35), and there was no heterogeneity among the studies, so a
147	fixed-effects model was used for the analysis. The results showed that balance ability(OR=3.05;
148	95% CI:1.60-5.80) was a risk factor for fear of falls in chronic stroke(Figure 4).

150	2.3.4 Mobility
151	Two studies reported a correlation between mobility and fear of falling, with heterogeneity
152	testing ($I^2=87\%$, p=0.0005), the high heterogeneity between studies may be related to the different
153	assessment tools used by the two studies in assessing Mobility, one study using The Functional
154	Ambulation Category and the other using the "Stand up-GO" timing test. The results showed no
155	statistical significance(OR=2.75;95%CI:0.29-25.63)(Figure 5).

157	2.3.5 Other Factors
158	The following influencing factors were only mentioned in a single study, and meta-analysis
159	could not be conducted, so descriptive analysis was used, in which anxiety (OR=2.29;95%CI:
160	1.43-3.67), depression (OR=1.80;95%CI:1.22-2.67), poor motor function of lower extremity
161	(OR=1.14;95% CI:1.00-1.29), physical inactivity (OR=2.04;95%CI:1.01-4.12) was a risk factor
162	for fall fear in patients with chronic stroke. Have a spouse (OR=0.61;95%CI:0.435-0.875) is a

- 163 protective factor. Zhang Qin et al(19) have found that anxiety and depression are risk factors for
- 164 fear of falling, and the marital status of a spouse is the protective factor.

165 2.4 Sensitivity analysis

- 166 These four risk factors, including age, fall history, balance ability and mobility, were not
- significantly different after switching models, suggesting that the results have high reliability.
- 168 Results of the sensitivity analysis are shown in Table Table 2.

170 **2.5 Publication bias**

- 171 The number of studies included in the outcome index was less than 10, so no funnel plot was
- 172 made to verify publication bias.
- 173 **3 Discussion**
- 174 **3.1 General Factors**
- 175 Two of the studies included in this paper reported the relationship between gender and fear of
- 176 falling, but the results of the two studies were completely opposite, so a meta-analysis was not
- 177 conducted.Both studies found no statistically significant relationship between gender and fear of
- 178 falling. This is inconsistent with the findings of Suna Park et al(24), who reported that women have

179 a higher risk of FOF when walking outdoors compared to men.Laren A et al(25) also found that 180 women are 2.25 times more likely to experience fear of falling than men in acute stroke patients.In 181 the elderly population, female gender has been proven to be an important influencing factor for 182 falling fear(26-29). A study(30) found that after stroke, the level of physical activity decreases and 183 women are more prone to FOF. There is no significant difference in the level of physical activity between men and women among stroke survivors, but the walking speed of men is correlated with 184 185 the level of physical activity, and the balance ability of women is correlated with the level of 186 physical activity.FoF is positively correlated with walking speed in stroke patients(15) and 187 negatively correlated with balance ability, which may be the reason why women are more prone to 188 FOF than men. However, persson et al found that men are more likely to fall than women(31), and 189 men who are more likely to fall are less likely to have a fear of falling than women, which is a 190 question worth considering. Further research is needed on the relationship between gender and fear 191 of falls in chronic stroke patients, and the current number of studies is limited and the results 192 obtained are not entirely consistent. This study found no statistical significance between age and 193 fear of falling, but Guan et al(13) found that age may be an important factor affecting the 194 development of fear of falling in patients with chronic stroke. Yuan Lanlan et al(32) also found 195 that age >70 years old is a risk factor for fear of falling, First of all, the elderly will show slow 196 movement, lower limb muscle strength, blurred vision, cognitive function decline, etc. Secondly, 197 the ability to acquire and understand disease-related knowledge is poor, which may lead to a higher degree of fear of falling in the elderly. However, the number of studies included in this 198 199 paper is limited, and the results may be unstable, so more studies are needed to verify the 200 relationship between age and FOF in chronic stroke patients.

201 3.2 Disease-related factors

202 Yadav et al(23) found that lower limb motor function is an important influencing factor of 203 fall fear.For every 1-unit increase in the lower limb Fugl-Meyer score, the risk of FOF increased by 1.36 times. This is consistent with the findings of Suna Park et al(24), who reported that lower 204 205 limb strength is the most important influencing factor for FOF. Therefore, improving lower limb motor function may reduce the risk of fear of falling.Furkan et al also found that there was a 206 207 significant negative correlation between FOF and upper limb Fugl-Meyer score and upper limb 208 functional arm motor ability score (r=-0.888,r=-0.926)(33). It can be found that stroke people with 209 poor motor function are more likely to face the fear of falling, and it is hoped that more studies 210 will be conducted to explore whether motor function is a risk factor for the fear of falling in 211 chronic stroke. This study found that balance ability is one of the risk factors for fear of falling in 212 chronic stroke. This is consistent with the study results of Semra Oguz et al(34), which showed 213 that patients with poor balance have higher fear of falling. Many studies have confirmed the negative correlation between fear of falling and balance ability(13, 27, 35, 36). This study found 214 215 that the history of falls is an important risk factor for the occurrence of fear of falling in chronic 216 stroke, and the risk of falling fear in patients with a history of falling is 2.4 times that of patients 217 without a history of falls [20]. It has been reported that fear of falling is also a risk factor for 218 falling(37, 38). What can be known is that fear of falling and falling affect each other, forming a 219 vicious circle. Identifying patients with high fear of falling and developing intervention measures 220 can also reduce the occurrence of falls. A Thai study found that the prevalence of FoF in patients 221 with a history of falling was 8.21%, and that in subjects without a history of falling was 222 7.80%(27). It can be seen that a history of falling is not the only predictor of fear of falling, and a

high proportion of FOF will also occur in people without a history of falling(39). In addition, Netha Hussain et al(22) proposed that the risk of falling fear due to physical inactivity prior to stroke was 2.6 times that of active patients. This is consistent with the research report of Hanna et al(40), which reported that the longer the sitting time of stroke patients per day, the more likely the fall fear will occur.

228 **3.3 Psychological factors**

229 This study found that anxiety and depression are risk factors for fear of falling. Guan Q et 230 al(13) found that depression is a risk factor related to fear of falling after chronic stroke. Schmid et 231 al(41) also found that the fear of falling after stroke was negatively correlated with anxiety and 232 depression scores. In the elderly population, anxiety and depression have been confirmed by a number of studies to be related to the fear of falling(42-45), while in the group of chronic stroke, 233 234 firstly, because of the limited number of studies on the relationship between the two. Secondly, the presentation of results between studies is not the same, resulting in some data cannot be extracted 235 236 and analyzed. All these make it impossible to combine the effect size of these two risk factors in 237 this study, so the results of this study need to be further verified by more studies.

238 **3.4 Fear of fall assessment tool**

Through reading the literature, it is found that The self-made questionnaire is most commonly used to screen the prevalence of fall fear, and the Fall Efficacy Scale International and the Short Falls Efficacy Scale International are used to evaluate the severity of fall fear. Because there are many versions of the current definition of the fear of falling, there are many different scales to measure the fear of falling. The use of different assessment scales may vary the results of the studies and may increase heterogeneity across studies. More and more clinical workers

- gradually began to pay attention to the psychological problems of patients, and the psychological problem of falling fear will get more attention. Therefore, it is hoped that more scholars will
- 247 develop a standard scale specifically for evaluating stroke fear of falling in the future.

3.5 Limitations and recommendations

- Recognizing the dangers of fear of falling and early identification of high-risk patients with fear of falling through identified risk factors can help clinical staff develop targeted interventions
- to reduce the occurrence of adverse outcomes during hospitalization, reduce the length and cost of
- 252 patient stay, and improve the quality of care.

253 Limitations of this study: (1) The number of studies included was limited, and only Chinese 254 and English literature were included, so there was a certain selection bias; (2) Due to the small 255 number of literatures included, some influencing factors still need further verification; (3) Most of 256 the included studies are case-control studies and cross-sectional studies, and the causal 257 relationship is not strong enough, so more cohort studies need to be included in the future to verify the conclusions. To sum up, this study is limited by the number and quality of included studies, 258 259 and the conclusions of this study need to be verified by more large sample size, multi-center, 260 high-quality and prospective studies.

261 4 Summary

Fear of falling can have many adverse effects on patients, such as limited activities, reduced participation in activities, increased anxiety, depression and even reduced quality of life, and increased the risk of disability and relapse. A prospective study found that a higher fear of falling may be associated with an increased rate of disability(46), so it is necessary to identify the risk factors for fall fear in patients with chronic stroke early to improve the prognosis of patients.By

267	combining the effect size of published literature, this study found that impaired balance ability and
268	a history of falling are risk factors for fear of falling in chronic stroke, which can provide
269	reference for clinical staff to formulate corresponding intervention measures to reduce the
270	occurrence of fall fear.
