28 **Abstract**

29 **Background**

30 Religious leaders have been involved in risk communication campaigns for many years across
31 West Africa such as their involvement in the HIV/AIDS pandemic response. Little is known
32 about religious leaders' perceptions of their role in communicating Ebola risks during the 2014-
33 2016 outbreak in Sierra Leone and the strategies they adopted to communicate these risks.

34 **Methods**

35 In this qualitative study 10 semi-structured interviews were conducted with religious leaders in
36 Freetown, Sierra Leone, to better understand their perceptions of their roles communicating risk
37 during the outbreak. Five Christian and five Islamic leaders were recruited from multiple national
38 religious organisations including male and female leaders. The data was analysed using
39 thematic analysis.

40 **Results**

41 Three themes were developed from the data which illustrate the different strategies religious
42 leaders used when establishing public confidence in their role communicating risk and the
43 messages they communicated during the outbreak. The religious leaders describe how they
44 established themselves as non-political actors in the outbreak response, they provided support
45 to their communities and used collaboration as a means to effectively communicate risk. The
46 religious leaders adapted pre-existing roles and established new ones in order to build
47 confidence among their communities. They flexibly and pragmatically utilised scriptural texts
48 within these strategies to communicate risk and to establish confidence in their messages.

49 **Conclusions**

50 Religious leaders were pragmatic in their approach to risk communication, leveraging political
51 distrust and collaborating with other actors to strengthen their position. Interreligious unity as
52 well as scripturally supported messaging helped establish confidence in the public health
53 emergency response.

54 Author Summary

55 Religious leaders are both positively and negatively associated with the promotion of protective
56 behaviours during outbreaks. During the 2014-2016 Ebola outbreak, thousands of religious
57 leaders were engaged to communicate Ebola risks and protective Ebola messages across
58 Sierra Leone. Working with public health professionals they developed Ebola specific messages
59 by selecting specific passages from scripture to support medical messages. These messages
60 were positively associated with safe burial behaviours during the outbreak in Sierra Leone.

61
62 In this study, semi structured interviews were conducted with religious leaders involved in risk
63 communication campaigns during the outbreak. Our results highlight that religious leaders were
64 pragmatic in their approach to risk communication, leveraging political distrust and collaborating
65 with other actors to strengthen their position. Interreligious unity as well as scripturally supported
66 messaging helped establish confidence in the public health emergency response. In their role
67 communicating risk religious leaders prioritised building confidence by advocating for
68 community supported Ebola-measures and by establishing themselves as non-political actors in
69 the outbreak response.

70 Public health messages developed by religious leaders in line with scriptural texts can be used
71 as part of risk communication campaigns to improve their public acceptability.

73 Introduction

74 Across the world, religious leaders are trusted figures in their communities and as such, can be
75 positive agents of health behaviour change with involvement in public health interventions (1-4).
76 For instance, hearing messages from religious leaders (pastors or other ministerial staff) that
77 were supportive of same-sex relationships was associated with an increased willingness to use
78 HIV prevention strategies (e.g. pre-exposure prophylaxis) among Black Americans in the United
79 States (5). In Ghana, an intervention in which national and local religious leaders spread HIV
80 public health messages on mass media was associated with reduced HIV-related stigma (6).

81
82 Religious leaders have also been associated with hindering public health efforts (7). In the early
83 2000s in Northern Nigeria, religious leaders propagated misinformation that the oral polio
84 vaccine contained the HIV-virus and antifertility agents. This misinformation contributed to the
85 suspension of the polio vaccine campaigns in the region (8). During the HIV/AIDS epidemic,
86 some religious groups in Nigeria and Burkina Faso opted to promote abstinence over condom
87 use (9, 10), while others actively encouraged condom use to reduce the spread of infection (11).
88 The mixed messages also reflect the influence religious leaders had; they have been both
89 positively and negatively linked to the HIV/AIDS epidemic (6, 9, 10, 12, 13). Religious leaders
90 also have the power to influence vaccine uptake. During a measles outbreak in a Somali
91 community in Minnesota, the engagement of religious leaders helped to increase vaccination
92 rates (14).

93
94 The Ebola epidemic that affected West Africa between 2014-2016 posed a unique religious
95 challenge: religious and cultural practices (such as washing a dead body before burial) were

96 strongly associated with Ebola transmission (15, 16). Religious leaders had traditionally
97 promoted various forms of physical contact with corpses including washing of the deceased as
98 part of long-standing funeral and burial rituals (Hewlett 2003).

99

100 In order to influence health-behaviours during epidemics and pandemics, risk communication
101 campaigns must appreciate the complex interactions that exist between individuals, their peer-
102 groups and wider communities within a society as described by the socio-ecological model (17,
103 18). Therefore, a key intervention to improve the uptake of safe burials was to engage religious
104 leaders to promote safe Ebola burials. In collaboration with public health professionals, religious
105 leaders developed scripturally-based messages that were delivered nationwide in places of
106 worship and local community events as well as through radio and television programmes (19,
107 20). Public health messages promoted by religious leaders were positively associated with
108 willingness to engage in safe burial behaviours during the Ebola outbreak in Sierra Leone (21).

109

110 In times of crisis, people will turn to those they trust as a source of information (22). Religious
111 leaders are trusted figures in Sierra Leonean society (23). They were recognized as influential
112 spokespersons for protective health behaviours as part of risk communication campaigns during
113 the Ebola outbreak (24). The COVID-19 pandemic further demonstrated the important role of
114 trusted actors in the public health response, including religious leaders (25). The rampant
115 misinformation surrounding the COVID-19 vaccines made the uptake of protective behaviours
116 challenging in some areas (26, 27). In Romania for example, the strong standing of religion
117 combined with negative attitudes towards vaccines held by some influential religious leaders is
118 thought to have contributed to low vaccination coverage (3). In Israel, on the other hand (a
119 population with very high vaccination coverage) religious leaders were key in community

120 engagement around COVID-19 vaccination (28). Religious leaders were also involved in the
121 COVID-19 response in Sierra Leone including promoting the uptake of vaccinations (29).

123 Our aim with this study was to understand and contextualise the strategies religious leaders
124 adopted to build confidence and communicate risk during the Ebola outbreak in Sierra Leone.

125 **Methods**

126 **Setting**

127 Religion plays an important role in the lives of Sierra Leoneans. The majority of Sierra Leoneans
128 affiliate with either Islam (77%) or Christianity (22%) (30). Countrywide, religious leaders are
129 involved in various public health campaigns through faith-based organisations such as the
130 Islamic Action Group (ISLAG) and the Christian Action Group (CHRISTAG). Both these
131 organisations were formed in 1987 with support from the Ministry of Health and UNICEF to
132 undertake social mobilisation activities to promote childhood immunisation. The Action Groups
133 have since been involved in education, water and sanitation, family planning and HIV/AIDS
134 prevention. During the civil war in Sierra Leone (1991-2002) ISLAG and CHRISTAG were
135 brought together to form the Inter-Religious Council of Sierra Leone (IRCSL), an umbrella body
136 responsible for coordination and advocacy on matters involving religious leaders (1). The IRCSL
137 helped coordinate and support dialogue between both parties involved in the conflict and helped
138 facilitate peace negotiations (31, 32). Inter-religious collaboration in Sierra Leone has been
139 described as “a framework of everyday life in Sierra Leone”, capturing the fundamental nature of
140 the collaboration across the country (31, 33). The IRCSL remains actively involved in a wide

141 range of religious, health and development projects, collaborating with government, other faith-
142 based organisations and civil society.

143 The Religious Leaders' Taskforce on Ebola was established in July 2014, two months after the
144 first Ebola case was confirmed in Sierra Leone, to enhance the role of faith-based organisations
145 in the response (20). Religious leaders were identified as key figures in community engagement
146 and risk communication efforts. In collaboration with public health professionals, religious
147 leaders developed faith-based messages that were delivered nationwide in places of worship
148 and local community events as well as through radio and television programmes (19, 20).
149 Religious leaders built trust by engaging the public in dialogue around accurate measures of
150 Ebola prevention. They worked to address people's concerns and worked to dispel Ebola
151 misinformation in collaboration with public health professionals (20). Messages covered key
152 aspects of Ebola risk communication, drawing upon scriptural texts to promote safe Ebola
153 practices including avoidance of deceased family members and promoting the update of Ebola
154 burial teams (21).

155 This study was carried out in Freetown, the capital of Sierra Leone where around 1 million of the
156 country's 8 million people live. The country ranks among the poorest countries on Earth, with
157 one of the highest maternal mortality rates and had a population with a life expectancy of 60
158 years in 2021 (34). Freetown was one of the worst affected areas during the outbreak with high
159 numbers of positive cases and deaths (35). Participants in this study lived and worked in
160 Freetown at the time of interview. This study was conducted in collaboration with FOCUS1000
161 (a local NGO) who were one of the organisations involved in the coordination of community
162 engagement and risk communication programmes during the outbreak.

163 Study design & participant identification

164 This study is based on semi-structured interviews with religious leaders that were involved in
165 risk communication campaigns across Sierra Leone during the Ebola outbreak 2014-2016. Ten
166 interviews were conducted with religious leaders in Freetown between March 5th to March 20th,
167 2019. All ten of those invited to interview, attended. Religious leaders were recruited using a
168 combination of purposive and convenience sampling, using the predefined criteria that all
169 participants must have been involved in risk communication activities during the outbreak.
170 FOCUS1000 assisted in recruiting the initial Christian and Islamic interviewees through their
171 local contact networks. Recruitment was conducted with the help of a local Imam who was also
172 interviewed in the study. The sample was predominantly male (n=7) with five Christian and five
173 Islamic leaders included. Five of the leaders were pastors and four were Imams, and the final
174 interviewee was one of the leaders of the National Islamic Council. All the religious leaders held
175 multiple positions across religious organisations in the country, including leadership positions
176 with ISLAG, CHRISTAG and IRC SL. Basic characteristics of the participants in the study are
177 described in Table 1 with their specific roles within faith-based organisations omitted to protect
178 the identity of participants.

179 Initial analysis was driven by the WHO guidelines for Risk Communication in Emergencies
180 which provided a framework for analysing risk communication in emergency settings (WHO
181 2018). The interview guide was largely informed by this framework and a literature search on
182 risk communication strategies during emergencies. Questions were designed in a chronological
183 fashion asking questions related to experiences before, during and after the outbreak. The
184 interview started with open ended questions regarding the participant's religious background
185 and previous risk communication experience, continuing to questions regarding Ebola
186 knowledge and then more targeted questions regarding experiences conducting risk
187 communication campaigns during Ebola including barriers and facilitators to this process.
188 Finally, open-ended questions were posed regarding reflections on the experience and thoughts

189 going forward. Two pilot interviews were conducted leading to a few minor adjustments to
190 question-wording and ordering before finalising the guide for the remaining interviews.

192 Data collection and analysis

193 All the interviews were conducted in person, in English. The native language of the interviewees
194 was Krio, but all interviewees were fluent and comfortable giving the interview in English. Eight
195 of the ten interviews were conducted in the headquarters of FOCUS1000 (a local NGO) one
196 took place in a local religious school and one in a pastors' home. PL was in Freetown for one
197 month in 2019 to carry out the interviews with religious leaders as part of a master's thesis in
198 Global Health. Noone else was present during the interviews which took place at a time chosen
199 by the participants and were conducted both during and after office hours. Interviews lasted
200 between 26 and 83 minutes (Table 1). PL established a relationship with the interviewees via
201 FOCUS1000 and all interviewees were made aware that the research was a part of a masters'
202 dissertation. Repeat interviews were not conducted and interviews were not returned to
203 participants for comment due to the length of time that elapsed between analysis and
204 conducting of interviews. Brief field notes were made after each interview to summarise any
205 thoughts the lead author relating to questions and responses.

206 Interviews were transcribed verbatim and analysed in Dedoose, version 8.3.4. Thematic
207 analysis was used to analyse the data, with initial open coding of three of the transcripts using
208 both in vivo codes and codes derived by the lead author (PL). This coding framework was then
209 applied across the remaining 7 interviews. When all transcripts had been coded, several
210 emerging codes were retrospectively applied across the interviews and those first transcripts

211 were revised again to check for consistency in the coding process. The codes were grouped in
212 categories leading to the formation of sub-themes and the final themes. During the course of the
213 analysis, authors discussed and provided feedback on the codes and the emerging themes. In
214 comparing and contrasting the religious leaders' responses to one another, the analysis became
215 more latent allowing for a deeper understanding of their opinions on their work during the
216 outbreak.

217 Ethical considerations

218 The Sierra Leone Research and Scientific Review Committee granted ethical approval for this
219 study in March 2019. All interviewees provided informed consent to participate by signing an
220 informed consent form.

224 **Results**

225 Three primary themes were identified from the data representing the strategies religious leaders
 226 used to enhance public confidence in their role as risk communicators and the messages they
 227 communicated: providing community support, collaboration, and establishing themselves as
 228 non-political figures. The religious leaders discuss these three themes as strategies they flexibly
 229 used to build confidence in their role communicating risk during the outbreak.

230 The religious leaders adapted pre-existing roles and established new ones in order to build this
 231 confidence during the outbreak. Scripture is ingrained in most aspects of religious leaders'
 232 communication with the public and they flexibly made use of religious texts when establishing
 233 confidence in their Ebola messages across these themes. Themes are categorised and
 234 summarised in table 2. They are further discussed and illustrated with quotes below.

235 **Establishing religious leaders as non-political actors**

236 Early in the Ebola outbreak political conspiracies and distrust in political figures were
237 commonplace in Sierra Leone. Rumours circulated among local populations that the
238 government was intentionally spreading the virus along with a general perception of corruption
239 and that the virus was a government ruse to generate international aid (Anderson 2015,
240 Wilkinson 2015). Against this backdrop religious leaders said that they established public
241 confidence as Ebola risk communicators by separating themselves from politicians and political
242 organisations.

243 “...[the public] *don't know whether to believe the health workers or whether to believe the*
244 *politicians, so they were confused. So this made us [Religious leaders] to be relevant in the*
245 *message dissemination because they are seeing us as neutral people.” (Interview 1 - Muslim)*

246 “...*you will discover that the religious leader will get more results than that politician*
247 *because they [politicians] are coming from the angle of distrust.” (Interview 4 - Christian)*

248 The religious leaders describe how their separation from political affiliations provided them with
249 a unique platform to approach their risk communication efforts.

250 “*Some of them [the public] were saying it is good because they lack trust in the politician,*
251 *but since you people [religious leaders] are here, we believe you. We will go by what you say.”*
252 (Interview 4 - Christian)

253 People within communities recognised the religious leaders when they communicated Ebola
254 messages because, unlike the politicians, they were frequently seen and embedded within
255 communities.

256 *“...so that's the big tool that we have that the politicians don't have, even those in power.*
257 *Because maybe he [Politician] is in this house [house belonging to a member of the public]. The*
258 *people that are there, he doesn't know them. A religious person doesn't do that. I go there first*
259 *thing in the morning saying “Good morning how is the old man, the old lady, are they okay?”*
260 *Maybe there is a problem that I need to sort out, to come to their aid.” (Interview 2 - Muslim)*

261 One religious leader speculated that the reason political figures are not trusted like the religious
262 leaders is because of the financial gain involved in their roles. The religious leaders define their
263 work as vocational and their lack of apparent wealth as a reason to garner public confidence.

264 *“When the minister [political leader] talks, he is lying. But when I appear on TV...they*
265 *[the public] know when I say something it is going to work, it is going to benefit them. Because*
266 *they [the public] don't pay me for this work...I don't have a new bicycle, but I'm dedicated to*
267 *doing this job” (Interview 2 - Muslim)*

268 **Establishing confidence and providing community support in the** 269 **context of an Ebola outbreak**

270 Religious leaders have long provided emotional and spiritual support for many Sierra Leoneans,
271 and they adapted this role to suit the unique needs of their communities during the Ebola
272 outbreak (Featherstone 2015, Hewlett). As a result of the direct and indirect effects of Ebola
273 many Sierra Leoneans found themselves in challenging situations. The religious leaders
274 described themselves as figures of hope for their communities in many of these circumstances,
275 providing a listening ear and spiritual meaning to the situations the public faced.

276 *“...we give them the words of hope, in the messages, give them courage that they will*
277 *not die, they will come out. Let them just listen to what the doctor say. Follow the instructions....*
278 *Sometimes they call me 2, 3 am in the morning; “reverend I am giving up, the pain I am feeling*

279 *so much pain, even to hold the cup for me to drink I cannot, the pain". I said "This is not for you.*
280 *You will surely come over this".*" (Interview 8 - Christian)

281 This *hope* the religious leaders describe is contextualised in terms of the individual's spirituality
282 and the essence of placing faith in a higher power beyond the outbreak. The religious leaders
283 describe how they would stand outside the homes of those who were quarantined and talk to
284 them, providing a sense of hope that they will recover from Ebola.

285 The suffering community members were facing during the outbreak was contextualised by the
286 religious leaders who compared Ebola to the infectious diseases discussed in the Bible
287 (leprosy) and the Qur'an (the *Tha'oon Amwas*). This facilitated public understanding of the Ebola
288 measures religious leaders were communicating while also providing a means to spiritually
289 interpret the outbreak.

290 *"There's nothing in Islam called Ebola. But there are similar things, like the tha'oon*
291 *[infectious disease discussed in the Qur'an]"* (Interview 2 - Muslim)

292 *"In the bible lepers were set apart...because they thought it was a contagious disease"*
293 (Interview 9 - Christian)

294 The religious leaders further report building confidence in their messages by advocating for the
295 needs of their communities. Many Sierra Leoneans were frustrated by the specific restrictions
296 placed upon them during the outbreak, for instance, restrictions on traditional burial practices
297 which were imposed by the government to reduce the spread of Ebola (Jalloh 2020). These
298 restrictions did not consider the spiritual and cultural needs of the public. Religious leaders
299 worked with (medical) authorities to design safe and dignified burials, including incorporating
300 more women into burial teams in response to concerns that deceased women were being
301 buried by men.

302 *“The burial team was full of male. So at that time, the women, they rose up and they said*
303 *uh no! We need women in the burial teams. We went to the government and we said this is the*
304 *concern of our peopleThe government agreed.”* (Interview 4 - Christian)

305 The religious leaders described this advocacy as a tool to provide their communities with what
306 they needed at a time of crisis and in doing so built trust in their role as communicators.

307 *“[the public] want to appeal to you, to appeal to the government in the area of*
308 *burial...even though they are talking about safe burial, we want to add dignity into it. It is our*
309 *culture, we need to give our funeral rights to our loved ones when they die.”* (Interview 8 -
310 Christian)

311 **Collaboration built public confidence in religious leaders**

312 During the Ebola outbreak Christian and Islamic leaders worked together to develop and
313 communicate Ebola messages across Sierra Leone in a coordinated manner. The religious
314 leaders described how this interreligious collaboration was beneficial for the risk communication
315 campaigns as it emphasised, for the public, the importance of putting aside religious differences
316 to focus on the outbreak.

317 *“At first, they [the public] were thinking that because of our different beliefs it would be*
318 *difficult for us [Muslims & Christians] to come together, you know, but we were able to make the*
319 *people know that, no, in fact, it is the source of our strength to come together... Some of us*
320 *were able to say look, when Ebola is coming it is not looking for a Christian, it's not looking for a*
321 *Muslim, it's not looking for your tribe, it's not looking for your colour, it is just looking for an*
322 *individual that it can suppress, kill, destroy.”* (Interview 4 - Christian)

323 There was a positive public reaction to seeing Islamic and Christian leaders entering towns and
324 villages together according to the religious leaders. They describe the positive effect of seeing
325 religious leaders standing side-by-side in Mosques and Churches communicating in unison.

326 *“We do everything in common. Sometimes we even go into churches, when it is required*
327 *to go to the church, we go to the church when it is required to come to the mosque, we do that*
328 *also. Sometimes you can see some Christians in the mosque, sometimes you can see some*
329 *Muslim in the church. Just for the people to get the message.”* (Interview 1 - Christian)

330 This interreligious collaboration was described from a more pragmatic perspective by a number
331 of the religious leaders. They acknowledged the confusion that different, often conflicting
332 messages from multiple sources caused during the outbreak. They considered religious leaders
333 of different doctrines speaking with one unified voice as much clearer and more inherently
334 understandable to their audiences.

335 *“...you know initially, at first, the misinformation was so much...the information was*
336 *coming in every direction....everyone was confused.”* (Interview 6 - Christian)

337 *“...we said that we are going to speak with one voice. We don’t want to speak with*
338 *conflicting messages. So that at least when you go to the south, I go to the north and he goes to*
339 *the east, we make sure that the message that you are giving the people is the same message.*
340 *Don’t say any different thing. So, we all speak with one voice. Yes, no conflicting message.”*
341 (Interview 7 - Christian)

342 There was acknowledgement from the religious leaders that they contributed to the public’s
343 confusion early in the outbreak. The subsequent unified approach to risk communication was
344 described as important to prevent false information being spread by religious leaders.

345 “...messages came that people should wash with water and salt, then the Ebola will not
346 affect you, oh yeah...a prophet from Nigeria, you know, they gave a portion [of the bible]... it
347 went like a wildfire. Even Muslims were washing, they were bathing with that stuff” (Interview 4 -
348 Christian)

349 Collaboration was also described by the religious leaders in terms of their interactions with other
350 sectors of the Ebola response and the beneficial impact this had on their work overall. When
351 communicating their messages, the religious leaders often entered communities as part of a
352 larger team which included medical experts and other non-religious people. The religious
353 leaders' presence beside these medical teams made their messaging more acceptable to the
354 public.

355 “When it comes to the technical parts of the disease, we call on the technical people.
356 Because when we are going [into communities] sometimes we go with some health officers, we
357 involve the DHMT [District Health Medical Team]... We will call them to come on board and they
358 explain to the people. But because we are around, they [public] will accept them [medical team
359 messages].” (Interview 4 - Christian)

360 The religious leaders would also engage village chiefs, community leaders and traditional
361 healers upon entering towns and villages as a means to support their communication
362 campaigns. These local leaders would help to disseminate messages through the communities
363 using megaphones and going house to house to spread the messages. The religious leaders
364 also described their approach to collaboration in pragmatic terms. Although they may not have
365 agreed with external parties such as the traditional healers, they were willing to put this aside for
366 the greater good. They described these actions in terms of how best to communicate their
367 messages.

368 *“We also saw it necessary to work with the traditional healers because the practice of*
369 *the traditional healers very contradicts the belief of the Christian and the Muslim. But because it*
370 *was a national emergency the thing [Ebola] was killing our people, we had to say no, let’s ignore*
371 *some of this...fundamental right...and then address the issue that is killing people.” (Interview 4*
372 *- Christian)*

373 Discussion

374 Three primary strategies were described in the data which religious leaders used to build
375 confidence in their role communicating risk and the messages they communicated; establishing
376 themselves as non-political actors in the outbreak, providing community support and using
377 collaboration to build confidence in their communicated messages. They established new
378 strategies as well as building upon pre-existing religious roles in Sierra Leonean society to
379 achieve this. Religious leaders pragmatically utilised scripture to communicate risk and also to
380 establish confidence in their messages.

381 Trust in institutions and governments is considered a key component of an effective outbreak
382 response (36). Our findings suggest that religious leaders built confidence in their messages by
383 distancing themselves from politicians, who were not widely trusted (37, 38). With effect it
384 seems, as public health messages promoted by religious leaders have also been positively
385 associated with willingness to engage in safe burial behaviours during the Ebola outbreak in
386 Sierra Leone (21). Instead of associating with political leaders, the religious leaders sought
387 different trust alliances – for instance through inter-religious collaborations.

388 While Sierra Leone is unique with its high levels of interreligious tolerance, the power of
389 communicating with a unified message holds lessons for other emergency settings. Even
390 though the leaders in this study did not discuss the ideological conflicts which can exist between

391 the two religions (39), our findings highlight the importance of finding a middle ground to help
392 bolster a collaborating position. This is also shown through the religious leaders' collaboration
393 with traditional healers, for which doctrinal differences were put aside to fight their common
394 enemy. The religious leaders seem to appreciate the positive impact that seeing others
395 cooperate can have on an individual's willingness to cooperate (36, 40).

396 A number of the religious leaders in our study referred to themselves as *non-political* and
397 *neutral* when describing their role in Sierra Leonean society. While they pragmatically separated
398 themselves from political affiliations to assist in their risk communication strategies, evidence
399 suggests that religion and politics are closely intertwined and difficult to separate from one
400 another in Sierra Leone (23, 33). The religious leaders in our study do not reflect upon this when
401 referring to their role as *non-political* and *neutral*. Similarly, they do not reflect upon some of
402 their religious doctrines which are in conflict with basic public health messages such as
403 contraception and birth control which have been linked both positively and negatively to
404 religious involvement (9-11, 13). While religious leaders were associated with uptake of positive
405 health behaviours during the Ebola outbreak in Sierra Leone the influence these roles garner
406 may well carry over to other less favourable impacts on public health and political influence
407 which needs to be considered when looking towards ongoing and future outbreaks.

408 Religious leaders were embedded in communities and could appreciate the specific needs of
409 the individual community members while also distributing messaging through wider
410 communication campaigns. The socio-ecological framework highlights the importance of
411 intrapersonal and interpersonal relationships when trying to affect behaviour change (17, 41).
412 The top-down approach to communication seen early in the outbreak was not as effective in
413 part because it did not account for the socio-cultural realities of many Sierra Leoneans. For
414 example, burial teams were not always dignified making accepting them challenging for many,
415 and avoidance of caregiving for sick family members was not always an option (1, 42).

416 The influence of socio-ecological factors on the uptake of protective health-behaviours was
417 similarly demonstrated during the COVID-19 pandemic. Adherence to mask wearing guidance
418 and compliance with self-isolation were positively associated with household income, age,
419 personal attitudes, educational attainment and gender (43, 44). The COVID-19 pandemic has
420 demonstrated the important role of trusted actors in the public health response, including
421 religious leaders (45). The importance of building public confidence and trust in the messenger
422 is key to effective risk communication as has been established previously using the socio-
423 ecological model (36, 46, 47).

424 Religious leaders describe their scriptural texts as an integral part of risk communication
425 campaigns. From contextualising the outbreak for those who are sick and fearful, to developing
426 the risk communication messages around scripture, the religious texts were ingrained across
427 their actions. Producing messages in support of public health messages adapted to suit the
428 needs of a population can help acceptability and efficacy of public health programmes (48, 49).
429 A willingness to engage with the medical professionals and build Ebola specific messages from
430 scripture may be a practical and beneficial application of the findings of this study.

431 **Strengths and limitations**

432 The religious leaders in this study are a diverse cohort of participants with male and female,
433 Christian and Islamic leaders represented. The study sample is limited to the perspective of
434 religious leaders, most of whom held powerful positions in religious and faith-based
435 organisations in Sierra Leone. As such, their opinions may not be entirely representative of all
436 religious leaders in Freetown and indeed those in more rural parts of the country. Nonetheless,
437 the perspective of these leaders may give a more overarching viewpoint of religious leader
438 involvement in the outbreak.

439

440 While the sample was limited to 10 religious leaders, the power could be considered robust
441 since the aim of the study was well-focused, the sample of participants was unique and the
442 participation rate was 100% (50). The study was also informed by theory and the participants
443 provided in depth and reflective responses.

444

445 A few potential sources of bias should be mentioned. Interviews were carried out by PL who is a
446 caucasian male, which may have introduced a response bias. Arguably the religious leaders
447 may have provided more candid responses to a Sierra Leonean interviewer. On the other hand,
448 they may have provided the most honest answers to someone they perceive as outside the
449 local healthcare system particularly when criticising the outbreak response efforts. Harvey's
450 "elite interviews" also helped to inform PL on how to approach the interviews in terms of building
451 trust and engaging these religious leaders who are considered high standing community figures
452 (51). Participants were all interviewed in Freetown. The experience of the outbreak may have
453 been significantly different for those living in remote and rural areas and may differ between
454 regions, therefore findings are limited to Freetown. Eight out of 10 of the interviews were
455 conducted in FOCUS1000 headquarters, potentially leading to a response bias. This effect was
456 somewhat mitigated by reiterating that PL was not affiliated with FOCUS1000 and all
457 interviewees' responses would remain entirely confidential. Finally, an unavoidable source of
458 bias in this study was that the qualitative interviews were conducted more than three years after
459 the outbreak, which might have led to omission of details and possible recency bias in terms of
460 some of the later successes seen in the outbreak.

461 Conclusion

462 Religious leaders saw themselves as key actors in risk communication campaigns during the
463 Ebola outbreak in Sierra Leone. They responded to the needs of their communities and the
464 rapidly changing context of the outbreak to communicate risk. In this study religious leaders
465 highlighted the key role that inter-religious collaboration and collaboration with medical experts
466 had in their role communicating risk and applied their scriptural texts to suit the needs of the
467 outbreak response. They were pragmatic in their approach to risk communication and engaged
468 with multiple different facets of the outbreak response to strengthen their position. Religious
469 leaders are embedded across Sierra Leonean society within small communities through to
470 nationwide organisations. It is these broad ranging networks that allow religious leaders to
471 effectively approach risk communication strategies at multiple levels while accounting for the
472 socio-ecological realities of the individual.
