9 ABSTRACT

10 Introduction. South Sudan established an HIV program for the South Sudan People's Defense 11 Force (SSPDF) in 2006, recognizing the potential national security threat posed by HIV's impact 12 in post-conflict settings. By 2018, the SSPDF program's scope had expanded to include three 13 VMMC clinics and four ART service delivery facilities. This qualitative study examined participant feedback on two existing HIV services, ART and VMMC, with the goal of 14 identifying and prioritizing barriers and improving program performance. We used focus group 15 16 discussions to gather information from male and female participants chosen at random across the 17 four main project sites. 18 19 Methods. We conducted a cross-sectional qualitative study from March to April 2022 involving 20 177 people (108 men and 69 women) within fifteen focus group discussions. We collected data 21 on enablers and barriers to HIV service uptake and utilization using a thematic framework 22 approach. 23 24 **Results.** Perceived high-quality HIV services in a secure environment, organizational support 25 systems, peer-led mobilization, and transportation facilitation were all identified as HIV service 26 delivery enablers. HIV service delivery was hampered by knowledge gaps, poverty and food 27 insecurity, access issues, a lack of treatment support groups, transportation challenges, social 28 cultural barriers (stigma and discrimination), and the need for permission from commanders. 29 30 **Conclusions.** The findings show some overlap in client needs for VMMC and ART services. To 31 increase ART retention and overall HIV service demand, the program will focus on improving 32 the quality of HIV services and tailored client support, as well as addressing barriers resulting 33 from structural and social cultural challenges to increase ART retention and overall HIV service 34 demand.

35 INTRODUCTION

36 In 2011, the Republic of South Sudan proudly became the world's newest nation and 37 Africa's 55th country. Since then, development efforts in South Sudan have slowed because of 38 recurring internal conflict, insecurity, and the COVID-19 pandemic (1), leading to poverty, food 39 insecurity, deficits in education and health systems, internally displaced people, and other post-40 conflict effects (2-7). Ethnic conflicts in 2013 and 2016 have led to armed groups targeting 41 civilians, destabilized new establishments, and displaced people (2-5, 8). The economic crisis 42 and disruption in farming led to famine in many parts of the country. Additionally, reduced 43 harvest, cattle theft, poaching, and flooding left more than 8 million people food insecure in 2019 44 (3, 4). Gender-based violence against women has been fueled by this ongoing instability, 45 violence, and displacement. More than 4 million people remained displaced in 2022, which directly affects livelihood, education, social protection, and access to health services (6). 46 47 Although recent developments aim to strengthen the health system, preventable/treatable 48 communicable diseases such as HIV pose as a major threat and a leading cause of death in South 49 Sudan. (7, 9-12). As South Sudan recovers from years of conflict, this fragile setting impacts the 50 communities, the health system's infrastructure, and their capacity for prevention, surveillance, 51 and treatment, signifying an imperative leap toward peace (12). 52 The South Sudan National Strategic Plan for HIV/AIDS (2021-2023) (13) prioritized 53 increased access to quality HIV care, treatment, treatment as prevention, and TB/HIV 54 collaboration. South Sudan's HIV epidemic is classified as low and generalized with a 55 prevalence rate of 1.9 among adults aged 15-49 (14); however, pockets of HIV are concentrated 56 among key and vulnerable populations, where the prevalence is 5% or higher (15). Although globally and regionally new HIV infections are decreasing and treatment is increasing (16), in 57

58 South Sudan there are an unknown number of people living with HIV (PLHIV) who are virally

59 suppressed and only an estimated 35% of people living with HIV know their status (14). The 60 Ministry of Health (MoH) and related bodies have the national mandate of overseeing health care 61 delivery in South Sudan. The unique HIV threats faced by the military, on the other hand, 62 necessitate a contextualized forces policy to fill gaps left by the national program. 63 In 2006 South Sudan established an HIV program for the South Sudan People's Defense 64 Force (SSPDF), recognizing the potential national security threat from HIV's impact. The HIV 65 Secretariat oversees the program, which is tasked with planning, developing, and implementing 66 quality HIV prevention, care, treatment, support, and impact mitigation services for military 67 personnel, their families, and host communities. The military HIV program addresses institution-68 specific issues such as military personnel culture, access, deployment patterns, and the general 69 work environment. The program has evolved from a narrow focus at Juba Military Hospital 70 (JMH) in the capital city to a more expansive HIV care and treatment program, opening clinics 71 in Wau Military Hospital (WMH) and Malual Chaat Military Hospital (MCH) in 2018 and 2021, 72 respectively. Voluntary medical male circumcision (VMMC) services were introduced in JMH in 73 2018 and expanded to WMH and MCH in 2021. Despite these achievements, there is still a 74 significant unmet need for HIV services among the military population (15).

Although ART and male circumcision are proven to be effective in reducing HIV-related morbidity, mortality, and transmission, addressing barriers impacting client access, program uptake, and coverage is critical to improve services, activities, stigma, and inequity (17). Used as part of combined prevention, the effectiveness of male circumcision in reducing sexual transmission of HIV from HIV-positive women to HIV-negative men has been shown in randomized control trials conducted in Kenya (18), South Africa (19), and Uganda (20) and

82	consequently widely accepted since 2007 (21). Due to these achievements, the Joint United
83	Nations Programme on HIV/AIDS (UNAIDS) investment framework (22) recognized male
84	circumcision as one of the "basic program activities" with proven effectiveness in HIV
85	prevention in generalized epidemics with a low prevalence of male circumcision. Additionally,
86	investments in HIV response increase access to ART, with the goal of eliminating HIV as a
87	global public health threat by 2030 (23). This strategy uses an array of biomedical, behavioral,
88	and structural approaches (e.g., sexually transmitted disease control, voluntary counseling and
89	testing, harm reduction, mother-to-child transmission prevention, blood safety, infection control
90	in health care, structural interventions, and HIV-treatment programs and medical male
91	circumcision) to achieve maximum impact.
92	Factors such as marginalization and stigmatization continue to pose as challenges and
93	barriers especially among vulnerable populations. Access to HIV services may be hampered or
94	mitigated by a variety of factors that occur at the individual, health provider, or health system
95	level(24). Findings from studies conducted in Kenya (25), Uganda (26, 27), and Malawi (28)
96	showed that the barriers and facilitators to care linkage are multifactorial. Major barriers include
97	a lack of social networks, economic vulnerability, and fear of the consequences of stigma.
98	Overcrowded clinics, unwelcoming staff, and unintegrated facilities resulted in linkage failure at
99	the program level. Socioeconomic support from networks of health providers, family members,
100	and friends was a key facilitator of linkage to HIV services.
101	This paper takes a novel approach to complement other efforts to understand the barriers
102	and enablers to HIV service delivery in South Sudan's post conflict military settings. The
103	qualitative study examined participant feedback on two existing HIV services, ART and VMMC,
104	to identify and prioritize barriers and to improve program performance. For example ART

105	initiation and retention in treatment numbers at 12, 24, and 60 months, and client circumcised
106	and adverse events reported for VMMC. Prior to this study, the South Sudan military HIV
107	program had been implemented for military personnel, their families, and host communities
108	without factoring in client perspectives about service delivery. RTI International/SSPDF, with
109	support from the Department of Defense HIV/AIDS Prevention Program (DHAPP), aims to
110	make HIV and VMMC services available and accessible to the wider military population at
111	substantial HIV risk within the project catchment areas. However, there is limited information on
112	beneficiary population perspectives about HIV services in those locations. Understanding the
113	perspectives and preferences of HIV service beneficiaries, especially ART and eligible VMMC
114	clients, is essential to designing programs that meet clients' needs. Additionally, few studies
115	have described how they have used data to improve program performance.
116	These are not new programs; ART services have been available in the South Sudan
117	military since 2008, and VMMC services have been available since 2018. Because effective HIV
118	prevention and treatment services are now available, RTI plans to use the study findings to
119	expand tailored socio-behavioral change services by developing a comprehensive demand
120	creation plan to address military and host community acceptance of, and generate demand for,
121	these public health interventions to increase ART retention and overall HIV service demand. The
122	implementation of the demand creation plan will be based on our experience designing and
123	implementing socio-behavioral change programs to promote uptake of health products and
124	services, including ART and VMMC services, but will also draw on best practice tools
125	developed by PEPFAR and UNAIDS. Before implementing and adjusting activities to respond to

- 127 plan to define and understand local military community needs. Importantly, the demand creation
- 128 plan will be updated on a regular basis to ensure that its components remain relevant and useful.

129 METHODS

130 Setting. In March 1-April 131 30, 2022, we conducted 15 mixed-132 gender focus group discussions 133 (FGDs) to identify barriers and 134 enablers to accessing routine ART 135 and VMMC services provided at 136 three of four project sites where 137 clients present voluntarily for free 138 HIV services: JMH, WMH, and

Definition of Terms Used: Enablers, Barriers, and Treatment Supporters

- **Enablers**, as used in this study, are strategies, activities, and approaches aimed at improving accessibility, acceptability, uptake, equity, quality, effectiveness, and efficiency of HIV interventions. Enablers operate at all levels of society—at individual, community, institutional, societal, and national, regional, and global levels.
- Barriers, as used in this study, are impediments to HIV service uptake, including structural, sociocultural exclusion and marginalization, stigma, and inequity. If left unaddressed, these barriers will undermine the provision of HIV services, especially for priority populations such as the military.
- A treatment supporter is any person (including a family or PLHIV support group member) who is willing to help play a vital role in guiding and motivating HIV patients during their care and treatment; they are accepted by the patient and routinely engage with the health services (29).

139 MCH.

Participant recruitment. The FGD study gathered qualitative data from five FGD
 groups at each of the three program sites. Three VMMC-focused groups included circumcised
 males, non circumcised males, and female relatives of soldiers. Two ART-focused groups

•

143 included ART-stable and ART-unstable clients.

For each focus group session, we invited seven to nine potential participants targeting specific ages and genders to ensure representation, as guided by site-specific program data. RTI screened potential participants; those who met the study criteria and agreed to participate were assigned to the appropriate FGD sessions. We confirmed ART adherence status through client records at the facilities; we assessed male circumcision status through self-reporting. We obtained verbal informed consent, which was documented in the participant log and basic

150 demographic data from all participants. Approval for the study was obtained by RTI's

151 Institutional Review Board.

152	Data collection. We conducted the FGDs in English; a trained moderator translated them
153	into local languages (Dinka and Juba Arabic) as needed. The moderator used a semistructured
154	questionnaire to facilitate the discussions with open-ended and probing questions. A notetaker
155	recorded responses in real time, using audio-recordings to provide partially transcribed notes and
156	translate all notes into English; audio-recordings allowed us to review for quality assurance. We
157	provided each participant refreshments and travel cost reimbursement of about \$20USD.

- 158 **Data collection instruments.** Standardized interview questions were developed for each
- 159 type of respondent. Sample interview questions are shown below.

Sample Interview Questions

- How would you describe our services?
- Based on your experience with our services, would you return for services?
- What are three important feature that you think we are missing?
- In your opinion, what important services currently provided at the ART clinic would you like to see continue?
- What are your biggest challenges in attending services at SSPDF facilities?
- Do you have a clear understanding of how to navigate or find different service points around this health facility?
- Do you think clients would like to be connected to peer support network? This would be a network of people taking ARVs like themselves to support and encourage them to ensure their treatment is not interrupted.

Data analysis. We used an inductive analytic approach to identify and describe the

161 barriers and enablers of HIV service delivery in the DHAPP program. Two researchers reviewed

- 162 the FDG notes and audio-recordings to identify key themes related to the topic. They grouped the
- 163 themes and examined the narratives of FGD sessions per location. A senior researcher
- 164 independently reviewed the transcripts to assess consistency and accuracy of themes identified.
- 165 Areas of inconsistency were discussed with the moderator, noting definitions and context. The

166 researchers discussed the findings and wrote summary notes and placed themes into analysis

- 167 tables. Final results were written to reflect all themes identified.
- 168 Using qualitative data for program improvement. Program leadership used the FGD 169 data to identify program successes, needs for program improvements, and solutions. 170 Additionally, leadership validated the outcomes with other available data sources such as routine 171 program site visits, standard project listening sessions with SSPDF, and in-depth reviews with 172 the implementation team. Integrating military perspectives into decision-making at all stages of 173 programming planning and implementation is a key element of effectively using these data 174 sources. 175 We examined FGD-identified barriers using a two-factor model to prioritize which 176 barriers to address first. First, "Is this barrier within our control to solve?"; in other words, does 177 the solution fit into the project scope, is there sufficient funding, is this reasonable to address 178 within the period of the project? Second, "To what extent does this impact clients receiving 179 services?" We used multiple data points to determine client impact, including the extent to which 180 focus group participants discussed this issue, if multiple sites were impacted, and if this was an
- 181 issue for both ART and VMMC.

182 **RESULTS**

183 All 177 clients recruited at the three sites were eligible, and all consented to participate,184 as shown in Table 1.

187 We describe the specific ART and VMMC enablers and barriers below, in addition to
188 participant perspectives based on their interaction with the program.

189 Enablers

190 Staffing (ART and VMMC). Overwhelmingly, both ART-stable and Interruption in Treatment (IIT) participants from all three sites expressed gratitude for the welcoming nature of 191 192 the ART providers. JMH clients in particular were more likely to comment on the welcoming 193 nature of its staff; JMH has been in operation the longest. Participants particularly valued their 194 providers' openness, honesty, and level of confidentiality when offering HIV services. A current 195 JMH ART client noted, "Doctors have a good approach to clients and offer words that calm my 196 *heart.* Seeing that I have no help from my children which is a challenge." 197 VMMC participants pointed out that the staff at the VMMC clinics treat all their clients 198 with dignity and respect. They ensure that clients feel welcome and receive health education 199 while addressing language difficulties as needed and supporting clients to utilize all the available 200 services. When asked about their experience and whether they would return for additional 201 services or recommend them to others, Bor (MCH) participants responded: "Yes, I will come 202 back because services are good and to bring other people because I know this place", "Yes, 203 environment is good, doctors are polite and quality circumcision service.", and "Yes, I am likely 204 to recommend these services for it is because of good quality, free of services, and free 205 transport."

206 **Peer/social support (ART).** ART participants frequently mentioned receiving emotional 207 or material support from a support group, family member, friend, or a community health worker. 208 Participants cited supporters' traits such as trustworthiness, availability, and good 209 communication as factors beneficial to a successful partnership. Some peer supporters helped 210 participants by teaching them how to navigate the health system and encouraging them to keep 211 track of their pill count and clinic appointment dates. A participant at WMH shared her 212 experience with a community health worker: "A lady took my phone number, and then checked 213 on me - I am happy. Usually when I don't show up, they call to ask me why I have not come for 214 *medication. Which is good.*" In these settings where facility staff numbers are inadequate. 215 community health workers are critical in addressing patient challenges including psychosocial 216 and adherence issues. 217 ART participants in MCH and WMH mentioned the need for treatment supporters. One 218 participant noted that the "Support group can help me when I am frustrated or missed an 219 appointment." Another client highlighted the psychosocial support: "The group will check and 220 encourage each other to relieve thoughts and stress." Other clients also emphasized the 221 importance of treatment supporters in treatment adherence "...can help me through talking to me 222 and in taking medicine." Several participants echoed the idea of peer supporters providing life 223 skills, hope, and a positive outlook on life to clients. Such interventions increase clients' 224 individual and social motivation, resulting in the expansion of support networks and the 225 promotion of optimism and positive living. Another participant reiterated the type of support 226 they received from a health worker: "There was a [health provider], he had a vehicle. He would 227 call and if you are very sick, he would come looking to check on you and bring your medication."

228 Such community outreach clearly contributes to enhanced HIV service delivery quality and 229 uptake and by extension the dignity and quality of life of the clients.

230 **Organizational support (ART).** The program provides mobile phone–based reminders 231 of scheduled HIV appointments for clients. Other support available for clients includes 232 multimonth dispensing, community tracing, and relinkage of clients who experience interruption 233 in treatment. Most participants appreciated receiving reminder and follow-up calls for their 234 appointment or picking up their antiretroviral (ARV) refill medication. Tracking and following 235 up of IIT clients and counseling are critical approaches that clients agree are necessary for 236 patients to continue with their treatment. A client added: "They contact you by phone to ask you 237 why you have not come. They also send someone to look for you at your residence in case you 238 don't show up."

239

Client transport facilitation (VMMC). Participants shared that the provision of 240 transport to and from the facility saved them money.

241 **Safety (VMMC).** Participants expressed surprise that they felt safe within the clinic. 242 even sitting together with other clients from the diverse ethnic and political backgrounds that had 243 been in conflict. Because of the 2016 civil war in the MCH area, participants noted their fear of 244 leaving the safety of their UN compounds to come to the clinic. One woman had never left the 245 UN compound, noting that the facilitator convinced her to come to the FGD; she was amazed 246 that she could walk freely through town. A participant commented that the VMMC clinic was 247 "*peace building*" between two tribes through their accessing services together. Despite the 248 prevailing ethnic tensions after the 2016 conflict, participants reported that they felt no 249 discrimination or fear of being attacked or harmed during the whole process.

Peer-led mobilization (VMMC) as a component of the VMMC intervention including community mobilization was valued by clients. One participant in Wau stated: "*I mobilized more than 15 clients for circumcision to come to this clinic because the services are good, and I will continue to do so.*"

254 Barriers

Barriers, as used in this study, are impediments to HIV service uptake, including
structural, sociocultural exclusion and marginalization, stigma, and inequity. If left unaddressed,
these barriers will undermine the provision of HIV services, especially for priority populations
such as the military.

259 Funding for transport (ART). Many participants agreed that addressing the 260 transportation challenge would improve access and minimize client dropout. A client said: "If 261 there was a way for easing the transport challenge, patients would be helped to reach their drug 262 pick up location. This is because if you don't have money for transport, you will not come to pick 263 *your medication.*" This was particularly noted in Juba. 264 Food insecurity (ART). Most participants believed that providing food to PLHIV would 265 improve treatment numbers. They shared that lack of food is a barrier to consistently taking 266 medication. One client stated: "One day I took my drugs when there was no food and I felt dizzy, 267 so I stopped taking the drugs" and added "I stop taking my drugs every time I do not have food." 268 The practice of delaying ART medication because of lack of food was a recurrent theme in some 269 groups. According to the participants, taking ARV drugs with juice was requested in multiple

270 groups to help the pills go down more easily.

Female participants were more vocal about this problem. They highlighted the lack of employment opportunities and suggested being given business loans which would empower them to set up businesses to address the food insecurity problem in the long term.

Stigma and discrimination (ART). Nearly all participants discussed perceived
community stigma as a barrier with extreme community-level stigma noted at MCH; comments
on this topic were lengthy. Participants described how stigma undermines one's identity and
capacity to cope with the disease. Multiple participants reported hiding their medications for fear
of household members discovering they were HIV positive. Facilitators commented that the
WMH and MCH sessions for IIT participants were emotionally touching; all participants' stories
were difficult to hear. Women spoke up more than men and told their truth.

281 One participant had delayed HIV testing because of fear, and thus, treatment was 282 delayed. Fear of discrimination and of potential rejection within his immediate family and 283 community prevented his disclosure to even his close family. He said: "This disease is top secret, 284 and no one must know at all apart from doctors." In MCH, a participant reported that he may not 285 want to keep or take his medications at home for fear of being discovered by family. "I fear 286 taking medication when other people are present in the house." Learning that one is on ART 287 medication may create hostility from family members who hold negative attitudes and beliefs 288 about HIV, potentially leading to disruption in family harmony.

Stigma/social cultural attitudes (VMMC). All VMMC participants agreed that they
 knew about VMMC, but some specifically emphasized the sociocultural barriers to adopting the
 practice.

One participant noted: "*I know well about medical circumcision but…Dinka Bor culture*does not allow male circumcision, despite it being practiced in town." Another participant stated

that: "I'm married and for me to get circumcised, my wife must agree before I do it and will not
be circumcised if my wife refuses."

One participant reflected the reason for his hesitation: "*Male circumcision should be* agreed to by our female counterparts to avoid divorce. A wife of my friend divorced after his circumcision." Another expressed fear and stigma: "*I'm aware about the service and its* importance, but I'm not ready to be circumcised, fearing community abuse. In my community circumcision is not allowed and if one does it, you and your children will be abused until your death."

302 Knowledge gaps (ART and VMMC). Confusing VMMC with traditional circumcision, 303 some participants only know the traditional circumcision that is conducted by traditional healers 304 within the villages under poor hygienic conditions. So, they confuse VMMC with that approach, 305 leading to some men and women expressing unfounded fear of incompetent providers and 306 potential adverse events such as bleeding, swelling (keloids), and pain after medical 307 circumcision. Participants on ART emphasized the lack of routine counseling to address 308 knowledge gaps about the ART's side effects. Some participants even inquired about the 309 availability of injectable ART and single-dose medication for children in South Sudan.

310 Limited access (ART and VMMC). Some participants highlighted lack of access to 311 VMMC services within their localities. Available services are few and are located within military 312 garrisons, which for some may be far from where military and host communities reside. This 313 usually impacts access because of high costs or limited transport options.

For ART services, IIT participants indicate the long distance to the clinics, and other access issues, prevented them from seeking regular treatment. This was true for participants newly on treatment who cannot benefit from community refills.

326 **DISCUSSION**

As a nascent post-conflict country, South Sudan's myriad infrastructure, human resource, and structural challenges plague public service delivery, especially health services. Findings from our focus groups identified enablers and barriers to HIV service delivery, allowing our team to prioritize strategies to improve program performance.

331 Enablers of HIV service delivery include the perceived high quality of services,

332 satisfaction with the providers and services, and availability of transport. This feedback shows

that participants hold positive relationships with their providers; the human touch is critical for

driving client demand for services and creating a friendly facility. Because some of these clients

lack peer support, they are less likely to engage in HIV care, and thus program facility staff

become a valuable resource for client engagement and adherence to care. Staff at the facility can

assist clients in making sense of confusing health information, provide psychosocial support,

influence their treatment-related behaviors, navigate the health care system, and improve

339 relationships with peers in their communities.

340 Maintaining free-of-cost HIV services, clean workspace, staff cooperation, privacy and 341 confidentiality, and facilitating client transport, safety, and security, were stated as perceived 342 indicators of the quality of HIV services offered at the three facilities. Thus, improving demand 343 for HIV services may require addressing these factors. A welcoming environment, good 344 communication, and respect for patients should be implemented in all the project facilities to 345 promote these outlined socially acceptable practices. There is also need for integration of 346 services at all sites to provide opportunities to deliver interventions across the spectrum of needs 347 of HIV-infected military men and women and the affected communities. We also noted the 348 willingness with which the potential clients from different ethnic groups/tribes agreed to be 349 booked, meet at scheduled central meeting points, and be transported together at zero cost to the

350 VMMC site as a novel approach to promote peace. There is no reported case of discrimination 351 against any client based on their tribe, ethnicity, religion, or political affiliation as they navigate 352 the program health facilities.

We prioritized barriers by grouping them into four categories according to results shown in Table 3. Facilitator feedback noted the emotional strain participants expressed and difficulty they felt while conducting these FDGs; these topics are all critical for this extremely needy and vulnerable population. Although the team wished to address all issues highlighted, we prioritized them to enable positive changes moving forward.

358 1-Top priority factors that affect both ART and VMMC services and are within control
of the program include knowledge gaps and service access issues.

360 **Knowledge gaps**. HIV/AIDS knowledge is low in South Sudan because of low literacy 361 rates (34.5%) among both men and women, particularly among those in the military (15). 362 Traditional print and broadcast media that could be used to increase HIV awareness, such as 363 radio, television, and new online media, are not accessible to a large portion of the population, 364 both rural and urban. Furthermore, at the national and community levels, South Sudan lacks 365 strong and diverse HIV champions to drive the HIV awareness and a mobilization agenda. 366 Therefore, the program will ensure that clients have social connections or "buddies" who are 367 involved in providing accurate and reliable HIV treatment information to clients in their health 368 journeys and to hold them accountable.

Access barriers to ART services have been reduced in key regional settings by
 establishing facilities in military-rich areas, with a plan to further decentralize services to address
 unequal access to ART in the surrounding areas. Some respondents reported that affordability
 barriers are significantly higher for clients in more remote settings. This finding is consistent

373 with South Sudan's current HIV service delivery policy emphasis on strengthening community374 ART service delivery.

2-High priority factors affect only ART services; these include **support groups**.

Support groups. Although the program allows stable PLHIV to meet once a month to

377 share treatment experiences and support one another, it lacks self-formed support groups in

378 larger communities to follow up on and address their unique individual ART challenges.

Although the military program has more than doubled its ART enrollment from 1,172 in 2019 to

380 2,597 in 2022, low treatment retention rates, which are currently less than 50% for the program,

threaten to undo the program's gains in ART enrollment over the last 8 years. Attrition is often

382 seen as the result of inadequate patient preparation, which causes treatment interruptions, and a

383 lack of strong community-level support for new PLHIV. In 2020, the MOH and its partners

384 developed guidelines and protocols while keeping structural constraints of patients and the health

385 system in mind. This protocol gives the client the ability to collaborate with health providers,

institutions, and others to improve their own care. Improved adherence, increased motivation and

387 confidence, and mutual support, as observed by Sabin (30), result in higher levels of physical,

388 psychological, and social well-being and improved health outcomes (30).

389 **3-Medium priority** factors affect VMMC only; these include transport and permission
 390 from commanders.

391 Transport. Similar to Ancia (31) findings, some participants were grateful for the free 392 transport provided to the clinic for VMMC because otherwise they would need to walk long 393 distances from their homes to the service point, since transportation is unavailable or too 394 expensive (31). ART participants do not have access to transport, although the program provides 395 community refills for stable clients.

396	Permission from commanders. The military is a hierarchical institution in which
397	subordinates need permission from their commanders to seek treatment on or off the military
398	base for extended periods of time. For a service like VMMC, where clients need about 3-4 weeks
399	to fully recover, military leaders must be convinced that VMMC is critical for their troops.
400	Potential clients have been denied leave to attend such services in some cases where
401	commanders do not understand their roles and have not been sensitized about their troops' rights,
402	including the right to life and health, and other human rights. The program continues to hold
403	regular commander training sessions to ensure that new commanders are familiar with the HIV
404	program, their roles in HIV service uptake and utilization, and that they remain accountable for
405	the overall health of their troops.
406	4-Low priority factors are beyond the remit of the program; these include safety,
407	poverty/food insecurity, and stigma/sociocultural issues.
408	Safety. Since the conflicts in 2013 and 2016, approximately 1.96 million South Sudanese
409	have been internally displaced, with the majority residing in UN-managed civilian sites. Food
410	insecurity continues to affect large segments of the South Sudanese population because of the
411	economic downturn, civil insecurity, the lingering effects of floods, and the prolonged conflict.
412	Poverty is widespread, and most people rely on subsistence agriculture and humanitarian
413	aid. The additional burden of managing a chronic illness in a resource-scarce environment makes
414	PLHIV even more vulnerable and in need of support.
415	Stigma. Myths and misconception are powerful drivers of stigma (16) toward PLHIV in
416	South Sudan. This leads to discrimination expressed by loss of jobs, intimate partner violence,
417	expulsion from homes, and denial of basic health and other services such as leasing house. RTI
418	has been able to provide HIV services in the four project facilities that are not perceived as

419 "stigmatizing" by clients and may serve as a "beacon of hope" for less stigmatizing attitudes and
420 behaviors in the communities they serve. This was accomplished by collaborating closely with
421 PLHIV clients around project facilities to help create an environment that provides patients with
422 HIV with timely, appropriate, and humane HIV care services.

423 Sociocultural issues, especially gender roles and relationships, play a significant role in 424 the transmission of HIV and perspectives on its prevention and treatment. Participants discussed 425 the impact of HIV on their lives, their role in HIV prevention, and obstacles to accessing HIV 426 services. A comprehensive, multidisciplinary, systemic approach that includes community-wide 427 education and empowerment and modifying legal and social structures that contribute to the 428 spread of HIV is suggested as a necessary addition to the current national response. Only by 429 forging strong partnerships between the different actors in health, education, women and youth 430 groups, and political, religious, and opinion leaders will the impact of HIV be reduced in South 431 Sudan.

432 We will use the lessons learned to design interventions that are appropriate and 433 acceptable to the beneficiary population; delivered by providers with relevant personal and 434 community experience; and tailored to address sociocultural influences such as stigma and 435 discrimination. The military leadership and RTI are committed to data analysis and use for real-436 time program course-correction, while engaging meaningfully with the beneficiaries. By 437 continuously triangulating available information, we will improve service delivery and program 438 content to reflect local realities. Maintaining close partnership with and education of military 439 leadership is central to ownership and sustainability of the program.

440 CONCLUSIONS/NEXT STEPS

441	This study sought to ensure that HIV ART and VMMC programming in South Sudan is
442	based on evidence; the program will adapt to local circumstances and target military community
443	needs while promoting program effectiveness. We created a tiered system to prioritize client
444	needs based on the barriers/enablers we identified from two HIV services (VMMC and ART)
445	and those issues within project control. Our findings highlight some overlap in the needs of
446	clients VMMC and ART services, enabling us to target both services to increase demand for HIV
447	services. South Sudan's fragile post-conflict context is noteworthy and influences the needs of
448	the HIV service delivery clients.
449	As next steps, we plan to use the FGD feedback to prioritize demand-creation
450	interventions to address the factors above to increase ART and VMMC service uptake with
451	several next steps:
452	• Creating a comprehensive HIV awareness model that addresses knowledge gaps and
453	emphasizes service delivery point availability in the short term.
454	• Collaborating with the military program team to identify and nurture PLHIV support
455	groups in each of the three ART program locations.
456	• In the long term, exploring ways to sustainably increase access to ART and VMMC
457	service locations. The program will also reach out to military leadership to identify
458	command channels for troops who want to undergo VMMC to obtain permission
459	promptly.
460	• Continuing to reach out to relevant government officials, partners, and stakeholders
461	who may have solutions to the issues of safety, poverty, and sociocultural issues.

462 LIMITATIONS

463 This study has several limitations that should be considered in future program 464 improvement studies. Since the participants in this study were not chosen at random, the findings 465 may not be applicable to all beneficiaries/patients served by the facilities. Recordings of the 466 focus groups were not transcribed or translated because of programmatic costs. Translations 467 were carried out during the sessions, with notes taken in English. Some participants in the ART-468 unstable focus groups revealed serious health conditions, with some requiring hospitalization 469 during or immediately following the sessions. This could have limited their ability to participate 470 effectively in the discussions. Because of the nature of group dynamics, "group think" may occur 471 in focus group settings, resulting in themes that would not have emerged as frequently if 472 interviews were conducted individually. Some discussion points may have been "lost in 473 translation" because of language barriers in some study locations, because sessions required real-474 time translation, response, and note-taking. Despite these limitations, the study findings suggest 475 several practical and programmatic implications that can help the SSPDF program improve 476 service delivery.
