Abstract

Background. Medical students' rate of depression, suicidal ideation, anxiety, and burnout 25 26 have been shown to be higher than those of the same-age general population. However, longitudinal studies spanning the whole course of medical school are scarce and present 27 28 contradictory findings. This study aims to analyze the longitudinal evolution of mental health 29 and burnout from the first to the last year of medical school using a wide range of indicators. 30 Moreover, biopsychosocial covariates that can influence this evolution are explored. 31 Method. In an open cohort study design, 3066 annual questionnaires were filled in by 32 1595 different students from the first to the sixth year of the Lausanne Medical School 33 (Switzerland). Depression symptoms, suicidal ideation, anxiety symptoms, stress, and burnout 34 were measured along with biopsychosocial covariates. The longitudinal evolution of mental 35 health and burnout and the impact of covariates were modelled with linear mixed models. **Results**. Comparison to a same-aged general population sample shows that medical 36 37 students reported significantly more depression symptoms and anxiety symptoms. Medical 38 students' mental health improved during the course of the studies in terms of depression 39 symptoms, suicidal ideation, and stress, although suicidal ideation increased again in the last 40 year and anxiety symptoms remained stable. Conversely, the results regarding burnout 41 globally showed a significant worsening from beginning to end of medical school. The 42 covariates most strongly related to better mental health and less burnout were less emotion-43 focused coping, more social support, and more satisfaction with health. 44 Conclusion. Both improvement of mental health and worsening of burnout were observed 45 during the course of medical school. This underlines that the beginning and the end of 46 medical school bring specific challenges with the first years' stressors negatively impacting 47 mental health and the last year's difficulties negatively impacting burnout. 48 Keywords: Mental health; Burnout; Medical students; Longitudinal study

49 Introduction

Medical students have been shown to present more depression [1], anxiety [2], and burnout [3] than same-aged general population individuals. Meta-analyses have indeed reported a pooled prevalence of 28.0% of the medical students for depression [1,4], 11.1% for suicidal ideation [1], 33.8% for anxiety [2], and 44.2% for burnout [5]. Moreover, a study has shown that before actually starting medical school, medical students present less depression and less burnout than same-aged general population; suggesting that the course of the medical school itself may trigger mental health issues and burnout [6].

57 Despite the wealth of literature on the subject, longitudinal studies analyzing the evolution 58 of mental health and burnout from beginning to end of medical school are still scarce and 59 present inconsistent findings. For depression symptoms, a meta-analysis estimated a median 60 increase of 13.5% each curriculum year [1], but another meta-analysis reported a gradual 61 decrease until the last year of medical school [4]. For anxiety, both increase and decrease 62 trends have been reported [7] and for suicidal ideation and burnout, longitudinal studies are 63 too scarce to provide a reliable understanding of their evolution during medical school [1,8]. 64 Consequently, the patterns of evolution of mental health and burnout during medical school 65 are still unknown.

Medical students' mental health issues and burnout have been attributed to different factors. Entering medical school represent a significant source of stress as it often marks a transition of moving away from home towards a new social environment with new ways of studying that demands an important adjustment from students [4]. Then, academic factors of stress are numerous such as the volume of information to learn, time constraints, examinations, competition, ethical challenges, and exposure to human suffering [9]. On the

other hand, protective factors have been identified as well: a systematic review reports that the
 factors most often related to less mental health issues and burnout in medical students are low

74 neuroticism, less emotion-focused coping strategies, more physical activity, lower study-

related stress, and higher satisfaction with studies [10].

The present study aims to add to the existing literature by analyzing the temporal evolution 76 77 of mental health and burnout throughout the course of medical school [1,8]. The few studies 78 using prospective data focused mostly on the first year of medical school or on the two first 79 vears [1,8]. Yet, it seems essential to understand the temporal evolution of medical students' 80 mental health and burnout throughout the entire medical school curriculum in order to identify 81 the curriculum years that are most challenging. Moreover, there is a need for more studies analyzing conjointly a wide range of biopsychosocial covariates of medical students' mental 82 83 health and burnout in order to identify the most influential protective and aggravating factors. 84 The objectives of the present study are thus to (1) compare the mental health and coping 85 strategies of medical students to same-age general population, (2) describe the evolution of 86 mental health and burnout from beginning to end of medical school using a wide range of 87 indicators (depression symptoms, suicidal ideation, anxiety symptoms, stress, emotional 88 exhaustion, cynicism, and academic efficacy), and (3) identify biopsychosocial covariates 89 influencing the evolutions of medical students' mental health and burnout.

90 Method

91 Design and data collection

This is a longitudinal analysis of data from the ETMED-L project [11] collected with an open cohort study design. An online questionnaire investigating mental health and interpersonal competence was sent to all medical students (curriculum years 1 to 6) matriculated at the University of Lausanne (Switzerland), except for the students who are at the university as part of an academic exchange. It took approximately one hour to fully complete the online questionnaire and the students received 50CHF (~50USD) for each completed questionnaire. The present study used the data of the three first waves of the

99 ETMED-L project collected during the months of March 2021, November 2021, and

100 November 2022.

101 To compare the mental health of medical students to same-aged general population

- 102 individuals, data collected as part of the CoLaus|PsyCoLaus were retrieved. Initiated in 2003,
- 103 CoLaus|PsyCoLaus is a population-based cohort study that follows a representative sample of
- 104 the residents of Lausanne (Switzerland). The study has been designed to investigates
- 105 psychiatric disorders and cardiovascular risk factors as well as their association using
- 106 structured interviews and questionnaires [12]. For the present study, the data of the offspring
- 107 of the participants of CoLaus|PsyCoLaus collected from the 26th of March 2008 to the 16th of
- 108 November 2022 were used.
- 109 The Research Ethics Committee of the Canton de Vaud approved both the ETMED-L
- 110 (project number 2020-02474) and CoLaus|PsyCoLaus (project number PB_2018-00038,
- 111 reference 239/09) projects. All participants gave written informed consent.

112 Measures

113 Mental health and burnout

114 The instruments used in the ETMED-L project are detailed in its published protocol [11]. 115 For the present paper, four measures of *mental health* were used. *Depression symptoms* were 116 assessed with the Center for Epidemiological Studies-Depression [CES-D; 13] with the 117 validated cut-offs scores of 16 for males, 20 for females, and 19 overall [14]. Suicidal 118 ideation was measured with two questions of the Beck Depression Inventory [BDI; 15]. Anxiety symptoms were assessed with the State-Trait Anxiety Inventory [STAI; 16] and stress 119 120 was measured with a single generic item ("Globally, how would you evaluate your current 121 stress level on a scale from 1 'none' to 10 'extreme'?"). For burnout, the Maslach Burnout 122 Inventory Student-Survey [MBI-SS; 17] was used to measure its three dimensions: Emotional 123 Exhaustion, Cynicism, and Academic Efficacy (reversed dimension). Except for the single

124 item measuring stress, all instruments are well established and have a French validated125 version that has been used in the present study.

126 **Biopsychosocial covariates**

127 Four *sociological covariates* were analyzed: identifying as male (gender identity 128 recoded into 1=male and 2=female or non-binary), paid job (hours per week), parents' 129 education (number of parents with college or university degree), having a partner (1=yes, 130 0=no), and social support. Social support was measured as the average score of two questions: 131 "If necessary, in your opinion, to what extent can someone provide you with practical help, 132 this means concrete help or useful advice, if 0 means "not at all" and 10 "a great deal"?" for 133 practical support and "To what extent can someone be available in case of need and show understanding, by talking with you for example, if 0 means "not at all" and 10 "a great deal"?" 134 135 for emotional support. 136 Regarding *psychological covariates*, having consulted a psychotherapist during the 137 past year (1=yes, 0=no) and coping strategies were assessed. Coping strategies were measured 138 with the French version of the coping section of the Euronet questionnaire [18,19]. 139 Confirmatory factor analysis [20] supported three factors including the dimensions of 140 emotion-focused, help-seeking, and problem-focused coping strategies. 141 Finally, three *biological covariates* were included: Body Mass Index (BMI; weight in 142 kilograms divided by height in meters squared),), physical activity (number of hours per 143 week), and satisfaction with health ("Are you satisfied with your health?" rated on a scale

144 from 1=very unsatisfied to 5=very satisfied).

145 Statistical analysis

Medical students were compared to same-age general population individuals using linear
regression with sample (medical students vs general population) as independent variable,
being male as a control variable, and depression symptoms, anxiety symptoms, and coping

strategies (the only indicators measured similarly in both the ETMED-L and

150 CoLaus|PsyCoLaus projects) separately as dependent variables. Cohen's *d* was computed for 151 effect size estimation with *d*s of 0.2, 0.5, and 0.8 respectively considered as small, medium, 152 and large effect sizes [21]. For a more clinically relevant appreciation of the results, a test of 153 proportion was additionally used to compare the two samples in terms of risk of clinical 154 depression according to the CES-D cutoff. Note that for all these comparison analyses,

155 medical students' data at first participation were used.

156 To model the longitudinal evolution of mental health and burnout during the course of the medical school, Linear Mixed Models (LMMs) were fitted to account for the clustering in the 157 158 data due to the repeated measures for each medical students, considering the student specific 159 effects as random intercepts. Due to funding constraints, the students could not be followed 160 during the entire six-year of medical school. However, LMMs provides a powerful framework 161 for modeling the longitudinal evolution of mental health and burnout across the entire six-year 162 duration of medical school, even when the medical students have been assessed at a maximum 163 of three time points. This approach indeed effectively accounts for limited and unevenly 164 spaced data points, facilitating robust insights into trajectories over the entire course of 165 medical school. Note that different temporal variance-covariance structure such as 166 autoregressive process of order 1 and autoregressive moving average process were compared 167 versus unstructured parameterization using likelihood ratio test, then only the most plausible 168 structure was estimated and presented using Restricted Maximum Likelihood (REML). 169 REML method was used to produce unbiased estimates of variance and covariance 170 parameters [22,23]. The linear and non-linear evolution of mental health and burnout were 171 then tested by including the time as linear, quadratic, and cubic. The best model was chosen 172 and presented using likelihood ratio tests. The biopsychosocial covariates described in the 173 Measure section were included in all LMMs. Standardized β are presented for effect sizes

174 estimation. Standardized βs between 0.10–0.29 are considered as small, between 0.30–0.49 as
175 medium, and 0.50 or greater as large effect sizes [21].

Missing data at the item level were replaced by mean scores if less than 20% of the items
were missing. If 20% or if more items were missing, the total score was considered missing.
Missing data at the score level were then handled with full information maximum likelihood
in the LMMs. Stata version 17 [24] and R version 4.2.2 [25] were used for the analyses and p
values <.05 were considered significant.

181 **Results**

182 Samples

183 The eligible students who agreed to participate were 906, 1059, and 1101 for each data 184 collection wave, resulting in a total of 3066 questionnaires (see participation flow chart in 185 Supplementary information). From those, 74 questionnaires were excluded because students 186 gave a wrong answer to at least one of the two attention questions placed in the questionnaire (e.g., "In order to check your attention, please answer 'Slightly agree' to this question.") and 6 187 188 questionnaires were excluded due to technical issues. Thus, each data collection wave 189 included respectively 886, 1034, and 1066 answered questionnaire, which represent 49.41%, 190 49.33%, and 54.92% of each wave's eligible students. Then, 168 students who repeated a year 191 had to be excluded to have only linear curriculum trajectories. The final sample thus included 192 2601 questionnaires form 1595 different students with 909 students who participated in only 193 one wave, 366 who participated in two waves, and 320 who participated in three waves of 194 data collection.

The same-age CoLaus|PsyCoLaus offspring comparison group, included 91 participants
who completed at least one of the questionnaires of interest and gave consent for the reuse of

197 their individual data. They were between 18 and 35 years old with a mean age of 22.99 (SD =

198 4.31) and 60.92% were women.

Descriptive statistics

- 200 The medical student sample descriptive is displayed in Table 1. Medical students were
- between 17 and 49 years old with a mean age of 21.78 (SD = 3.14) and most of them self-
- 202 identified as females (67.90%), which corresponds to the gender proportions generally
- 203 observed in the Lausanne Medical School. Observed means and standard deviation of medical
- students' mental health and burnout for each curriculum year are detailed in Table 2.

Comparison to same-age general population 210

211	Results of linear regressions testing the difference between medical students and same-age
212	general population individuals with respect to depression symptoms, anxiety symptoms, and
213	coping strategies are displayed in Table 3. Results indicated that medical students presented
214	significatively more depression symptoms and anxiety symptoms than the same-age general
215	population. A test of proportion further showed that the proportion of individuals who were
216	likely to be affected with clinical depression according to the CES-D cutoffs were
217	significantly higher in the medical student sample (46.88%) than in the same-age general
218	population sample (21.69%), $Z = 4.49$, $p < .001$. Regarding coping, medical students reported
219	using significantly less help-seeking strategies than same-age general population but did not
220	differ in terms of emotion-focused nor problem-focused coping strategies. Cohen's ds show
221	that the difference in depression symptoms was of medium effect size and that it was small
222	for anxiety symptoms and help-seeking coping strategies.

Longitudinal evolution of mental health and burnout 231

232 Results of the LMMs modelling the longitudinal evolution of mental health during medical 233 school are displayed in Table 4. They showed a significant linear decrease of depression 234 symptoms and stress from the first to the sixth year of medical school. For suicidal ideation, 235 the quadratic function of curriculum years was significant, indicating that evolution was 236 convex (U shape), with a decrease in suicidal ideation until the third year of medical school 237 followed by an increase until the end of the curriculum. No significant change over 238 curriculum years was found for anxiety symptoms. 239 The results for burnout's longitudinal evolution during medical school are displayed in 240 Table 5. They show that academic efficacy (reversed dimension of burnout) significantly 241 decreased linearly from the first to the last year of medical school. For cynicism, we observed 242 a slow increase in the two first years of medical school followed by a gradually steeper 243 increase in the last years (i.e., a significant convex course following a sort of J shape). Finally, 244 a curvilinear evolution was observed (~ shape) for the emotional exhaustion dimension with 245 an increase in emotional exhaustion until the second year of medical school, followed by a 246 decrease until the fifth year, and finally another increase until the sixth year.

Influence of biopsychosocial covariates 255

256 The results for the covariates' influence are displayed in Tables 4 and 5. The 257 biopsychosocial factors that were significantly related to all outcome variables were gender 258 identification, social support, having consulted a psychotherapist during the last year, 259 emotion-focused coping, and satisfaction with health. Social support and satisfaction with 260 health were consistently related to *less* mental health issues and burnout, whereas having 261 consulted a psychotherapist during the last year and emotion-focused coping were 262 consistently related to *more* mental issues and burnout. For gender, identifying as male was 263 significantly associated with less depression symptoms, anxiety symptoms, stress, and 264 emotional exhaustion, but it was related to more suicidal ideation, more cynicism, and less 265 academic efficacy (reversed dimension of burnout).

266 Other covariates were related to fewer mental health or burnout variables. Help-seeking 267 coping was associated to less mental health issues (on all mental health variables), but 268 unrelated to burnout. Physical activity was related to less depression symptoms, stress, and 269 emotional exhaustion. Higher parent education was related to less stress, but more cynicism. 270 Having a partner was related to less stress and emotional exhaustion. And finally, problem-271 focused coping was related to more academic efficacy. Having a paid job and BMI were the 272 only tested covariates that showed no significant influence.

273 According to effect size indicators, the strongest predictors of students' mental health and 274 burnout were emotion-focused coping (average absolute $\beta = .33$), followed by satisfaction 275 with health (average absolute $\beta = .14$) and social support (average absolute $\beta = .11$). The 276 effect sizes are considered medium for emotion-focused coping and small for all other 277 significant covariates. Overall, the models tested explained between 52% (for suicidal 278 ideation) and 73% (for anxiety symptoms) of the outcome variables' total variance (fixed 279 effect plus random structure; "Conditional R²").

280 **Discussion**

281 The results of the present study show that medical students' mental health gradually 282 improves in terms of depression symptoms, suicidal ideation, and stress, although suicidal 283 ideation increases again during the last year of medical school and anxiety symptoms remain 284 stable throughout the curriculum. For burnout, it is another picture: it worsens with medical 285 students experiencing gradually more cynicism and less academic efficacy, whereas we 286 observe a worsening of emotional exhaustion until the end of the second year, followed by an 287 improvement, and then another surge during the last year. 288 Our results are in line with past findings regarding the comparison between medical

289 students and general population in terms of mental health [1,2]. This study indeed indicates 290 that medical students report significantly more depression symptoms and anxiety symptoms 291 compared to same-age general population individuals. In fact, according to the CES-D 292 cutoffs, twice as much medical students are at risk of clinical depression compared to same-293 age general population individuals. Moreover, a specificity/sensitivity check of the CES-D 294 cutoffs using data collected as part of the CoLaus|PsyCoLaus project showed that one third of 295 the individuals who scored above the CES-D cutoffs presented a clinical depression 296 diagnosed with the Diagnostic Interview for Genetic Studies (a clinical interview assessing 297 major mood and psychotic disorders [27]). Based on these analyses, it can be assumed that 298 around 15% of our participating medical students and up to 20% of the first-year students 299 presented a clinical depression.

Like other studies in the field [4], our results confirm that students present high mental health issues in the first two years of medical school. On the bright side, medical students' mental health mostly improved along the curriculum years. Nevertheless, the present study indicates that the students presented a surge in suicidal ideation and burnout in the last year of medical school. Given that few longitudinal studies span over the whole medical curriculum,

305 the difficulties met in the last year of medical school has seldomly been described in the past. 306 The stressors faced at the end of medical school are manifestly different from the ones 307 medical students face in the first years of their studies. Indeed, the beginning of medical 308 school is characterized by difficulties that might be faced by any new university students, 309 such as change of social environment, adaptation to a new learning style, high study 310 workload, strong competition, and stressful examinations. The impact of these stressors is 311 likely to lessen along the curriculum years as students adapt to what has become their new 312 lifestyle and progress along their curriculum. However, the end of medical school can bring new types of stressors that might be more specific to medical students. Indeed, through 313 314 clerkships, medical students are gradually exposed to their potential future practice. They 315 experience the relationship with patients, but also with co-workers and their hierarchy and 316 might face difficult situations where they are confronted with the complexity, feeling of 317 powerlessness, and lack of control that can characterize medical practice. As they enter 318 clinical practice, the students face their shortcomings and the need to lean on their elders, yet 319 asking for help is a coping mechanism they employ to a limited degree compared to the 320 general population, as our results show. Moreover, the perspective of the transition to the 321 upcoming internship phase can be an important preoccupation for medical students. The end 322 of studies, anticipated as the long-awaited start of professional practice also corresponds to 323 the start of postgraduate training. This period of transition brings forth both choices to make 324 and challenges to overcome. The results of the present study indicate that these stressors faced 325 at the end of medical school impact mental health and burnout differently than the ones faced 326 in the beginning of medical school. In the past decade, there has been a debate on whether 327 burnout and mental health indicators such as depression and anxiety are the same or different 328 constructs [28]. This study indicates that mental health indicators and burnout are related but 329 distinct. Indeed, it shows that mental health is more impacted by the generic stressors of the

beginning of medical training, whereas burnout is more impacted by the specific stressors of the end of medical school, which might be characterized by occupational problematics. On the other hand, suicidal ideation and the emotional exhaustion dimension of burnout were influenced by both the stressors of the beginning and the end of medical school, which is in line with previous findings showing that suicidal ideation correlates with both depression and burnout [29] and that emotional exhaustion is the burnout dimension most strongly correlated to depression [30].

337 This study further shows that the most influential protective factors against medical 338 students' mental health issues and burnout are less emotion-focused coping, more social 339 support, and more satisfaction with health. These covariates were already known to contribute 340 to medical students' mental health and burnout [10] and can be the target of specific student 341 support services. For instance, increasing the use of help-seeking coping strategies has the 342 potential to bring at the same time more adapted coping strategies and more social support. 343 Our results show relatively low help-seeking coping strategies among the medical students 344 compared to same-age general population and past studies report on medical students' 345 reluctance to seek help for mental health issues or burnout because they felt a pressure to be 346 seen as a competent, feared stigmatization, and had insufficient knowledge of existing support 347 services [31]. In our university, numerous extra-curricular activities are proposed by different 348 associations to bring students together and thus increase their social support resources. Also, 349 accessible on campus psychiatric consultations are available to medical students.

350 Strengths and limitations

The present study's strength lies in its longitudinal design covering the sixth years of Medical School as well as a large sample. Additionally, the wide array of mental health and burnout validated indicators as well as the large coverage of biopsychosocial potential covariates ensures a more comprehensive picture of the topic. Nevertheless, some limitation

355 needs to be acknowledged. First, a yearly measurement might fail to capture short-term 356 changes in mental health and burnout. Second, the results for stress are to be interpreted with 357 caution given that it was measured with a single item that has not been validated. Third, each 358 student participated to a maximum of three time points and most of them participated only in 359 one or two time points. Further studies with less incomplete data across time points are 360 warranted to confirm the accuracy of the full trajectories' estimation, ascertain the precision 361 of parameter estimates, and avoid false-negative results. Finally, the study was run in one 362 single Swiss university, which limits the generalizability of the findings. It also made it 363 impossible to evaluate the impact of university-specific factors such as the pedagogical 364 approach or the study program. Replication in other universities and countries is needed to 365 corroborate this study's results and explore university-related covariates of medical students' 366 mental health and burnout.

367 **Conclusion**

368 This paper presents one of the rare longitudinal studies of mental health and burnout 369 spanning from the first to the last year of medical school. Results indicate that the beginning 370 and the end of medical school bring specific stressors that impact differently medical 371 students' mental health and burnout. Specifically, medical students face more mental health 372 issues in the beginning of their studies that lessen along their curriculum but experience more 373 burnout issues in the last year of medical school. Mental health issues and burnout not only 374 negatively impacts students' life, but might also affect the students' future medical practice as 375 they can hinder their professionalism [9,32]. Many medical schools have implemented 376 protectionist measures to alleviate the mental burden of medical students. The present study 377 indicates coping strategies, social support, and satisfaction with health as the most influential 378 covariates that should be primarily targeted by interventions aiming to lessen medical 379 students' mental health issues and burnout.
