

1 Exploring perceptions of and attitudes towards tanning with school children,
2 parents/carers and educators in Wales: A mixed methods study protocol for the
3 SunChat study.

10 **Abstract**

12 **Background**

13 Skin cancer comprises half of all cancers in England and Wales. Most skin cancers can be
14 prevented with safer sun exposure. As over exposure as a child can greatly increase future skin
15 cancer risk, early and accessible sun safe education and promotion of sun safe behaviours is
16 critical. Scientists agree there is no such thing as a ‘safe tan’, yet the public, including children, often
17 have positive perceptions of tanned skin. To protect against future skin cancer, it is important to
18 understand and address these misconceptions. The Curriculum for Wales with its area for Health and
19 Well-being, and autonomy for schools in designing curriculum content, presents an ideal way to
20 facilitate this exploration.

21 **Aims**

- 22 • Gather data regarding perceptions towards tanning to explore the perceived effects of a tan
23 on health.
- 24 • Inform the development and testing of a pilot toolkit for integration within the Curriculum for
25 Wales to encourage positive health behaviours and attitudes of school children towards
26 tanning and sun exposure.

27 **Methods**

28 SunChat is a mixed methods exploratory study comprising three work streams:

- 29 1. Workshops with school children to understand their perceptions on tanning.
- 30 2. An online multiple-choice survey with parents/carers to understand perceptions, attitudes and
31 behaviours towards tanning both for themselves and their children.
- 32 3. An informal focus group with primary school educators to explore challenges in engaging with
33 the school community around the Health and Well-being Area in the Curriculum for Wales.

35 **Discussion**

36 To date, there has been no work in Wales exploring children's, parents/carers', and educators'
37 perceptions of tanning and how healthier attitudes can be encouraged. This study will engage with
38 children, parents/carers, and primary school educators to scope current tanning perceptions and the
39 perceived effects tanning has on health, to feed into future toolkit and curriculum development for
40 health in schools in Wales and beyond.

42 Introduction

43 Background

44 Skin cancer, including melanoma, and non-melanoma (keratinocyte) also known as basal cell cancer
45 (BCC) and squamous cell cancer (SCC), now comprises half of all cancers in England and Wales [1]. Yet
46 86% of melanomas, 50-90% of BCCs and 50-70% of cutaneous SCCs can be prevented early on with safer
47 sun habits [2]. The age-standardised incidence of keratinocyte cancer in Wales has increased by 7.1%
48 between 2016 and 2019 – and the rate is the highest of all the UK nations [3]. Over exposure to the sun
49 as a child can greatly increase future skin cancer risk, and with childhood being a critical time for
50 forming, promoting and embedding lifelong health behaviours such as sun safety, establishing positive
51 attitudes and behaviours to sun exposure during childhood has important long-term implications for
52 attitudes and behaviours throughout life [4].

53 Sun safe behaviours also need to address sun tanning as scientists agree that there is no such thing as a
54 ‘safe tan’. However, the general public [5], university students [6], parents [7], and children [8] generally
55 have positive perceptions of tanned skin. In Wales, a population-based online survey reported that
56 43.6% of respondents agreed with the statement that ‘having a suntan makes me feel healthier’ and this
57 increased to 62.8% in the youngest age-group (<25 years). In the same survey, 44.5% of participants
58 agreed with the statement that ‘having a tan makes me look more attractive’ [5]. These findings were
59 also echoed in a 2017 omnibus survey reporting that 1 in 45 adults had used sunbeds in Wales and that
60 42% did so ‘to look better’ and 25% did so ‘to feel healthier’ [2]. With the World Health Organisation
61 classifying exposure to sunbeds as carcinogenic to humans [9], and the use of sunbeds linked with the
62 desire for a tan, work is urgently needed to understand and address the misconceptions of the
63 perceived health benefits of tanning.

64 To date, there has been no work in Wales exploring children and their parents'/carers' perceptions of
65 tanning and how healthier attitudes can be encouraged and adopted from a young age. The Curriculum
66 for Wales [10] with its designated area of learning and experience for Health and Well-being, and
67 autonomy offered for schools in designing curriculum content, presents an ideal way to facilitate further
68 exploration of attitudes to tanning. One of the overarching purposes of the Curriculum for Wales
69 includes the vision that all children and young people will become healthy, confident individuals able to
70 know how to find information and support to keep safe and well. Progress on this vision is currently
71 made via health education in child-led 'Healthy Schools' clubs and is embedded throughout
72 curricular/non-curricular activities. Focusing on understanding how different health dimensions, e.g.,
73 physical, mental, emotional, and social well-being play a role in children's lives, the Health and Well-
74 being curriculum area also supports children to incorporate healthy attitudes and behaviours, which
75 includes improving education and behaviours around sun safety and challenging current perceptions
76 around tanning.

77 To address some of these challenges and opportunities in Wales, we have designed the SunChat study, a
78 mixed methods exploratory study, funded by Swansea University's Morgan Advanced Studies Institute
79 (MASI).

80 **Study Aims**

- 81 • Gather data from primary school-aged children, parents/carers and primary school educators
82 regarding perceptions of tanning and explore the perceived effects on health.

- 83 • Inform the development and testing of an educational toolkit for integration within the
84 Curriculum for Wales to encourage positive health behaviours and attitudes of school children
85 towards tanning and sun exposure.

86 **Study Objectives**

- 87 • To explore challenges that primary school educators face in engaging with the school
88 community around the Health and Well-being Area of Learning and Experience in the
89 Curriculum for Wales, specifically about healthy attitudes to tanning.
- 90 • To gather viewpoints on best ways of engaging with school-aged children (5-8 years of age) and
91 their parents/carers about health, specifically in relation to sun tanning and sun exposure.
- 92 • To understand perceptions, attitudes and behaviours of parents/carers of primary school
93 children in Wales regarding tanning, both for themselves and their children.
- 94 • To understand perceptions, attitudes and behaviours of school-aged children (5-8 years of age)
95 in primary schools in Wales.
- 96 • Consolidate evidence to support the development of an educational toolkit for integration
97 within the Curriculum for Wales.

99 **Methods**

100 SunChat is a mixed-methods exploratory study comprising 3 work streams:

- 101 1. Qualitative workshops (n=3) with groups of 5-10 children aged 5 to 8 years of age in Healthy
102 School Clubs, to understand their perceptions of tanning and the perceived effects on health.
- 103 2. Online survey with parents/carers of primary school children to understand perceptions,
104 attitudes and behaviours regarding tanning, both for themselves and their children.

105 3. A qualitative informal focus group with primary school educators to explore tanning
106 perceptions/behaviours and challenges in engaging with the school community around the
107 Health and Well-being Area of Learning and Experience in the Curriculum for Wales.
108 Using existing networks and school partners, we will invite three primary schools in South Wales with a
109 Healthy Schools Club to participate in the study as a case study school. Consent will be sought from each
110 of the school's headteacher, and each school will be invited to participate in all three work streams.
111 We received ethical approval to conduct the study from Swansea University's Medical School Research
112 Sub-Committee (Ref 2022-0089). Study team members who will be directly involved with data
113 collection in schools have up-to-date Disclosure and Barring Service (DBS) and valid safeguarding
114 training allowing them to work with children.
115 As each work stream is distinct, we elaborate on methods, consent procedures, data collection and
116 analysis separately below.

117

118 **1. Workshops with Children**

119 The objective of the workshops is to understand perceptions, attitudes and behaviours towards tanning
120 and the perceived effects on health of school-aged children (5-8 years of age) in primary schools in
121 Wales.

122 **Workshop informed consent and ethical considerations**

123 Two researchers (one facilitator and one observer) will conduct the workshops with children in each
124 case study school's Healthy Schools Club at a time convenient to the school. These clubs typically consist
125 of 8-10 children across different year groups with an interest in health and well-being. The headteacher
126 of each school will first send out an information sheet and consent form to each parent/carer of a

127 Healthy Schools Club child. Parents will be given 7 days to opt their child out. If a parent/carer does not
128 give consent, that child will not be invited to participate in the workshop [11]. Workshops will be
129 conducted in a different room to children's regular classrooms, so that children who do not have
130 parental/carer consent to participate, will not feel excluded.

131 For those whose parents' consent, child-friendly information and consent sheets will be handed out
132 before the workshop commences. We will approach the workshops from a children's right perspective
133 [12], talking to children as empowered participants able to make decisions about taking part via
134 ongoing, negotiated assent [11]. We will talk children through the informed consent process in an
135 understandable and appropriate way and verbally confirm that they will be audio-recorded prior to
136 beginning the workshop activities. Children will be informed of all the necessary workshop details and
137 requirements so that they understand what will happen and that there are no right or wrong answers as
138 everyone's knowledge and behaviour is different. School breaks will be adhered to and factored into the
139 workshop planning. Additionally, children will be told they can have comfort and concentration breaks
140 whenever needed. Once the child has consented to take part researchers will continuously check that
141 children are comfortable through reading their body language. If any children look uncomfortable, they
142 will be asked, using appropriate child-friendly language, if they are fine to continue and reminded that
143 they can withdraw from the study at any time without giving an explanation.

144 **Workshop design**

145 Research design and materials for the purpose of collecting data with children is fundamental. Children's
146 ways of expressing their views and opinions are diverse, and creative/artistic activities facilitate the
147 communication with children that expand on spoken language [13]. We have designed 3 activities that
148 comprise colouring, role-play, drawing, collage techniques, videos and posters to enhance children's
149 voices. Each activity aims to encourage meaningful conversations with children and to ensure our
150 research aims and objectives are met. In each workshop, we will conduct the following activities:

151 **Activity 1** is designed to provide an insight into how children perceive sun tanning. We will present
152 children with an outline shape of a child on paper that will be referred to as ‘a little friend’. Children will
153 be given ‘skin-colour’ crayons that encompass all skin colour shades inclusively and we will ask
154 participants to colour their ‘little friend’ in. We will then read a short script to children and will invite
155 them to think of this ‘little friend’ after playing outdoors or going on holiday. Children will be given a
156 new blank ‘little friend’ to colour in now that the ‘friend’ has just returned from holidays or being
157 outdoors. The researchers will assist children if needed, engaging them in conversations and prompting
158 them to explore children’s perceptions to identify if the skin-colour of the ‘little friend’ has changed
159 after being outdoors or on holidays, and why. Other prompt questions will explore their thoughts about
160 perceived beauty standards associated with being tanned and if the children relate this to healthy
161 habits. The prompt questions below will be used during the activity:

162 *-How our little friend looks before playing on the beach, the park..., on a summer day?*

163 *-And how they look after, when they are back home, indoors?*

164 *-Is there any difference? Do they look the same?*

165 *-Why did you choose this colour (same or different)?*

166 *-Is your little friend tanned?*

167 *-Do they look pretty? (Show them the first figure; and then the second figure) Depending on answers,*
168 *why do they look pretty?*

169 *-Who looks healthier? (Show them the first figure; and then the second figure) Depending on answers,*
170 *why do they look healthier?*

171 *-Does your little friend (dis-)like to be tanned? Do you know why?*

172 *-Is there anything you (dis-)like about tanning? What? Why?*

173

174 Researchers will use inclusive language that embraces ethnic diversity to discuss skin colour after

175 tanning. All questions that researchers will ask associated with perceived beauty standards will solely be
176 oriented to being ‘tanned’ or ‘untanned’.

177 **Activity 2** will gather data to understand what healthy habits children already know about how to stay
178 safe in the sun. In this activity we will use different materials laid out centrally on a classroom table for
179 children to access easily and will invite them to draw a picture of themselves doing their favourite
180 activities in the sun on their own or with their family, friends or pets. Children can also choose images
181 and cut-outs from magazines with a range of items or clothing related to sun safety to glue on their
182 drawing (collage). The researcher will also assist children to set the scene, prompting them with
183 questions such as “What do they love doing in the sun?” and “What do they need to enjoy the sun
184 safely?”.

185 Children will then be invited to watch a short video with a story about sun safety, and they will be given
186 time to consider if they would like to add something to their drawings after watching the video to
187 protect themselves, friends, pets, and their families from the sun.

188 **Activity 3** is designed to meet the overall aim of encouraging healthy behaviours and to promote sun
189 safety. In this activity, children will be helping other children to promote sun safety and healthy habits
190 and learn why it is healthier not to tan on purpose. We will invite children to work in groups to draw,
191 use images and cut-outs or write down things that are healthy/safe and things are unhealthy/unsafe to
192 do in the sun to be placed on a large poster. We will guide children in a conversation within the group
193 related to healthy and unhealthy habits; sun safety and unsafe behaviours and will let them decide what
194 goes in one of two columns on the poster under the headings “YES” (healthy/safe) or “NO”
195 (unhealthy/unsafe), based on discussions which will take place during Activity 2.

196 Researchers will again assist children and facilitate discussions with them around healthy/unhealthy
197 habits and bring in points raised in Activity 2. During the activity, researchers will encourage children to

198 think about their own sun safety and healthy behaviours and what they believe is a healthy approach to
199 sun safety.

200 **Workshop data collection, management and analysis**

201 All workshop data will be audio recorded for later transcription by a secure third-party transcription
202 service. Any names mentioned in the audio recordings will be redacted from the final anonymised
203 transcripts. The observer will record detailed observation field notes regarding children's perceptions to
204 tanning and the relation to health benefits and interactions amongst participants. Pictures of resources
205 developed in the activities with children will be taken and subsequently anonymised before used in the
206 data analysis.

207 Data collected on paper and completed workshop resources will be kept in a locked filing cabinet with
208 restricted access to approved members of the research team only. Electronic data and scanned copies
209 will be held securely on Swansea University servers which are subject to physical, electronic, and
210 managerial procedures to safeguard and secure the information collected.

211 We will explore differences between perceptions, attitudes and reported behaviours towards tanning to
212 identify whether there are any differences between knowledge and healthy practices from each of the
213 activities. We will use NVivo12, an online qualitative data analysis software package to analyse
214 workshop transcripts and children's outputs using thematic analysis following the recommended 6 step
215 process: familiarisation; coding; generating themes; reviewing themes; defining and naming themes and
216 writing up [14]. We will analyse the resources and pictures children create during the workshop using
217 content analysis. [15].

218 Archiving will be conducted following Swansea Trials Unit Standard Operating Procedures (SOPs). All
219 data will be held in archive for a period of 5 years following the completion of the project.

220

221 **2. Online parent/carer survey**

222 The objective of the online survey is to help understand current perceptions, attitudes and behaviours
223 of parents/carers of primary school children in Wales regarding tanning, both for themselves and their
224 children.

225 **Survey informed consent and ethical considerations**

226 Parent/carers who access the survey will be introduced to the survey in a short introduction text and
227 directed to an online participant information sheet with full details about the survey and data protection
228 which they are able to download and read in their own time. If the parent/carer is happy to continue,
229 they will progress through the survey using the clear online navigation buttons. Due to the low-risk
230 nature of participation, consent for survey completion will be assumed if the parent/carer completes the
231 survey and the response is submitted. Respondents will be instructed that they do not have to complete
232 the survey and can close out the survey at any time if they wish to withdraw and their answers will not
233 be recorded. There will be an estimated time for completion provided within the survey introduction
234 text along with contact details of key researchers on the study for any questions or to raise concerns.

235 **Survey design**

236 We will scope the current literature and collate various questions about beliefs and perceptions of
237 tanning from similar surveys available from published sun safety research [17-19] and adapt/include
238 them in an online survey to be designed using the Swansea University approved JISC platform for online
239 surveys.

240 We will collect basic demographic data such as location, job role and gender of survey respondents.
241 Respondents will also be asked the age of their eldest child in primary school and their child's year

242 group, and asked to indicate their self-assessed skin colour using the Fitzpatrick skin colour scale [20].

243 The survey will include Likert scale type questions (strongly agree to strongly disagree) related to how

244 healthy and/or attractive they feel a tan looks on themselves and their child along with how

245 positively/negatively they feel their child thinks about tanning. We will ask about habits that the

246 respondents and their child have when outside in the sun.

247 Survey advertisements will be created and ethically approved to help disseminate the survey links and

248 QR codes which can be scanned using an eligible smartphone for direct access to the survey. All survey

249 materials including the information sheets, advertisements and the survey itself will be available in both

250 English and Welsh.

251 The survey links and QR codes will be distributed using several pathways in an attempt to reach as wide

252 a variety of parents/carers as possible including a mix of genders, ethnicities, ages, number of children

253 and professions as long as they have at least one child of primary school age. Firstly, we will distribute

254 the survey to our case study schools to disseminate to parents of their enrolled pupils. We will then look

255 to promote the survey publicly using other methods of circulation such as promotion on social media

256 and University email lists. Survey advertisements will also be uploaded to public websites including

257 Swansea University webpages and via social media, including making use of the paid advertisement

258 feature to reach a wider, specific audience. We will ask current contacts in Health and Care Research

259 Wales and the charity, Tenovus Cancer Care, to promote the survey link on their social media pages.

260 Finally, we will post the link on relevant parent and carer online forums. We will record all survey

261 promotion activities on a designated bespoke survey launch plan designed for the study.

262 Eligibility will be self-reported by the parent/carers using a screening question asking if the respondent

263 has at least one child of primary school age. Anyone who responds “no” to this question will not be able

264 to continue. Parents who have multiple children of primary school age will be asked to consider their

265 responses thinking about their eldest child. Although we will aim to capture respondents from Wales,
266 public dissemination of the link will mean that anyone able to click on the link will be able to complete
267 the survey, so the respondent will be asked to select their location from a pre-defined list.

268 We will aim to receive as many survey responses as possible and will not enforce an upper limit on the
269 number of survey responses we will accept.

270 **Survey data collection, management and analysis**

271 Survey data will be entered directly onto the JISC Online Survey platform by respondents and will be
272 held centrally throughout active data collection. JISC is a highly secure survey platform which is a GDPR
273 compliant, online survey tool designed for academic research, education, and public sector
274 organisations, certified to ISO 27001. JISC also provides daily back-ups for all data collected within
275 online surveys. All user accounts on JISC Online Surveys are password protected and unique to the
276 individual.

277 We will analyse data in an accepted statistical software package using simple statistics, such as
278 measures of distribution means, cross tabulations, and tests of association such as t-tests for continuous
279 variable and Pearson's chi square for categorical variables. We will analyse free text responses using
280 thematic analysis in NVivo following the recommended 6 step process: familiarisation; coding;
281 generating themes; reviewing themes; defining and naming themes and writing up [14]. Two
282 researchers who have qualitative analysis experience will conduct the thematic analysis.

283 Survey data will be archived following Swansea Trials Unit SOPs. All data will be held in archive for a
284 period of 5 years following the completion of the project.

285

286 **3. Primary school educator focus group**

287 The objective of the focus group is to explore the challenges that primary educators face in engaging
288 with the school community around the Health and Well-being Area of Learning and Experience in the
289 Curriculum for Wales, specifically about healthy attitudes to tanning, and to gather viewpoints on best
290 ways of engaging with school-aged children (5-8 years of age) and their parents/carers about health,
291 specifically in relation to sun tanning and sun exposure.

292 **Focus group informed consent and ethical considerations**

293 Head teachers from our case study schools will share information about the focus group to their school
294 educators who will be invited to submit an expression of interest to take part. Researchers will follow up
295 with potential participants to provide information about the consent process and to receive written
296 consent from participants. Focus groups will be conducted at a suitable time to maximise availability
297 options for participants, with consideration of school schedules and hours. Participants will be given the
298 opportunity to ask any questions before beginning the focus group and reminded that they will be audio
299 recorded for transcription purposes. Researchers will also remind all participating members how long
300 the discussion is likely to take, that they are not obliged to answer any questions they do not wish to,
301 and that participation is optional so they may withdraw at any time without giving an explanation.
302 Facilitators will also offer comfort breaks if or when they are needed.

303 **Focus group design**

304 The focus group will be conducted online using video conferencing software. We will create a semi-
305 structured topic guide with discussion points on opinions about providing tanning education for primary
306 school children and what the current awareness is about tanning in their schools. We will also cover
307 opinions about how to best promote the message of safer sun exposure and tanning and if there would
308 be any limitations or challenges delivering this awareness in primary school children. Researchers will

309 conduct the focus group in line with focus group facilitation guidance, which will be given to participants
310 before commencing any discussions to ensure that everyone has an opportunity to contribute equally
311 and there is no overtalking. Two focus group facilitators will be present to guide and encourage
312 discussions and to ensure that participants feel comfortable sharing their opinions and current practices
313 in their schools. We will offer consented participants the choice of conducting the focus group in English
314 or Welsh.

315 **Focus group data collection, management and analysis**

316 We will audio record the focus group with participant consent and will have the recordings transcribed
317 by a secure third-party transcription service, without identifying participants. The transcripts will be
318 checked and confirmed as accurate prior to analysis. Identifying data, including informed consent forms
319 and audio recordings, will be held electronically in a secure folder with restricted access on Swansea
320 University servers which are subject to physical, electronic, and managerial procedures to safeguard and
321 secure the information collected.

322 We will analyse the data to identify key themes around tanning, and challenges around the Health and
323 Well-being Area of Learning and Experience for primary school educators. Again, we will use NVivo to
324 handle qualitative analysis and will perform thematic analysis following the recommended 6 step
325 process: familiarisation; coding; generating themes; reviewing themes; defining and naming themes and
326 writing up [14].

327 As with all data collected, archiving will be conducted following Swansea Trials Unit SOPs. All data will be
328 held in archive for a period of 5 years following the completion of the project.

329

330 **Impact and dissemination**

331 To enable dissemination of study results in an accessible way which can be understood by children, a

332 collaborative infographic poster will be designed to showcase schools' and children's involvement in the
333 workshops. Children will be informed that the poster will be used publicly and that they will not be
334 identified from any poster content. Survey results will also be collated into a lay-person friendly format,
335 highlighting key findings. Results from this collaborative study will also be used to inform development
336 and testing of an educational toolkit to encourage children's healthy behaviours towards tanning and
337 sun exposure as part of future work. Further findings from all workstreams will be written up for
338 publications in suitable journals.

339 We will design a SunChat webpage hosted on a Swansea University website to promote real-time study
340 news and provide public updates of the study progress. Video logs (vlogs) will also be created and
341 uploaded online to provide lay-friendly updates and public insights into study activities over the study
342 lifetime.

343

344 **Patient and Public Involvement**

345 Parent/carer involvement in all aspects of the study design will be considered crucial for aligning with
346 study aims in an appropriate way, the success of data collection and maximising the resulting impact of
347 the study and when looking towards informing and developing the educational toolkit. We will be
348 guided by the UK standards for public involvement [21] and endeavour to meet the standards at every
349 opportunity presented while collaborating with public representatives.

350

351 Drafts of the study online survey will be reviewed by a parent representative who has child(ren) of a
352 primary school age for appropriateness/relevance of survey questions, length of time to complete and
353 layout/design choices. Our representative will also help to test the final survey against criteria such as
354 user acceptance, screen testing and confirming the survey works as expected. Training which is

355 determined as necessary to conduct any study tasks which may fall outside of the current skills of our
356 representative will be provided by members of the project team, including but not limited to
357 introductory project meetings, ongoing support with project team requests and protocol training. All
358 feedback will be considered and incorporated where feasible into the survey, and updates will be made
359 to the final version using parent/carer feedback. Our parent/carer representative will also aid in
360 circulating the survey link to their peers, their children's school and social media and provide invaluable
361 advice about how to best reach out to parents/carers with our survey. Our parent/carer representative
362 will be appropriately reimbursed according to current recommendations for public involvement
363 payments for their time and any expenses incurred as part of their involvement. Finally, we will look to
364 include our representative in study dissemination activities, such as forwarding on publications and lay
365 friendly study outputs to their social groups and seeking advice for key findings they determine as
366 important to highlight in results summaries.

367

368 **Discussion**

369 With skin cancer an issue in Wales and beyond, rising rates will not only continue to effect health and
370 well-being but will overburden NHS dermatology services and care for other skin conditions, affecting
371 future use of services for today's children. As suggested by an Australian study [22], the implementation
372 of public health prevention programmes show relevant health and economic cost benefits to reduce
373 skin cancer burden. Developing and embedding positive health-related behaviours including healthy
374 attitudes to tanning should begin in childhood, and these years give the ideal opportunity for children to
375 develop prevention strategies [23]. One study [4] suggests that prevention strategies and healthy
376 behaviours implemented during teenage years may be too late and not as effective due to tanning being
377 considered 'attractive' by adolescents, so recommend that it is more beneficial to encourage healthier
378 behaviours during the formative years of life.

379 **Study strengths**

380 This study addresses the community impact of a public health issue with ongoing education strengths in
381 Wales, specifically, by building on the innovative and holistic education process proposed in the
382 Curriculum for Wales with statutory focus on Health and Well-being. As part of the study data collection,
383 we take the known problem of skin cancer and address it in a novel way by engaging directly with
384 children through creative activities identified as best practice in facilitating and prioritising their
385 participation [24]. Also, creative and artistic approaches are known as young children's preferred ways
386 of communicating their views, thoughts and opinions [25]. As academics that do research with school-
387 aged children, it is our responsibility to explore children's perceptions in ways that facilitate their open
388 communication, and ensuring their voices are heard. Workshops at schools which will include activities
389 that use child-friendly methodologies and appropriate language for collecting information and ensure
390 that children's perceptions to tanning are listened and analysed, and then addressed e.g., through
391 developing curriculum toolkits aligned to children's views.

392 As well as ensuring we can explore the perceptions of tanning and encourage conversations towards
393 healthy attitudes with children, school educators, and families, this study will also create opportunities
394 for continued inter-disciplinary collaboration between health and education academics. The study has
395 the potential to lead into further research where we would look to evaluate our toolkit and future
396 curriculum development for schools on questioning perceptions of tanning and the effects on young
397 children's health and well-being, aligned to the views of children themselves. Taking responsibility for
398 health-related behaviours including attitudes to tanning should begin in childhood, and hence is the
399 ideal opportunity for children to develop prevention strategies.

400 **Study limitations**

401 Due to time and budget constraints, we are limited to inviting case study schools in the Swansea area in
402 South Wales. Further representation is needed from more primary schools in Wales from varying
403 locations and demographical backgrounds to provide a clearer picture of the situation around tanning
404 beliefs in children and their parents/carers/educators. Researchers on the study team will incorporate
405 this requirement into the design of a potential larger-scale study in the future to include participants
406 from across the UK to ensure that future participants better represent those from demographically
407 diverse populations. However, the online survey for this study can be distributed widely to all parents in
408 Wales using many types of avenues for dissemination and we therefore hope to receive responses from
409 a diverse range of parents/carers.

410 We hope that by sharing this protocol, we can help raise awareness of the importance of challenging
411 and changing the prevailing assumption that having a tan is desirable and support schools in
412 empowering and educating children to become healthy and informed adults.
