KEY POINTS

Question: Is accelerated epigenetic aging associated with exposure to racialized, economic, and environmental injustice?

Findings: In the US cross-sectional *My Body My Story (MBMS; n = 263)* and *Multi-Ethnic Atherosclerosis Study (MESA, Exam 5; n = 1264)*), epigenetic accelerated aging was associated with Jim Crow birth state for MBMS Black non-Hispanic participants (by 0.14 standard deviations, 95% confidence interval 0.00, 0.27) and similarly with low parental education (MBMS: Black and white non-Hispanic participants) and adult impoverishment (MESA: Black and white non-Hispanic participants).

Meaning: Epigenetic accelerated aging may be a biological pathway for embodying racialized and economic injustice.

ABSTRACT

Importance. Epigenetic accelerated aging is associated with exposure to social and economic adversity and may increase risk of premature morbidity and mortality. However, no studies have included measures of structural racism and few have compared estimates within or across the 1st and 2nd generation of epigenetic clocks (the latter additionally trained on phenotypic data).

Objective. To determine if accelerated epigenetic aging is associated with exposures to diverse measures of racialized, economic, and environmental injustice measured at different levels and time periods.

Design. Cross-sectional *My Body My Story Study* (MBMS; US, 2008-2010) and Exam 5 *Multi-Ethnic Atherosclerosis Study* (MESA; US, 2010-2012). MBMS DNA extraction: 2021; linkage of structural measures to MBMS and MESA: 2022.

Setting: MBMS recruited a random sample of US-born Black non-Hispanic (BNH) and white non-Hispanic (WNH) participants from 4 community health centers in Boston, MA. The MESA Exam 5 epigenetic component included 975 randomly selected US-born BNH, WNH, and Hispanic participants from four field sites: Baltimore, MD; Forsyth County, NC; New York City, NY; St. Paul, MN.

Participants: US-born persons (MBMS: 224 BNH, 69 WNH; MESA: 229 BNH, 555 WNH, 191 Hispanic).

Main outcome and measures. 10 epigenetic clocks (six 1^{st} generation; four 2^{nd} generation), computed using DNA methylation data (DNAm) from blood spots (MBMS; N = 293) and purified monocytes (MESA; N = 975).

Results. Among Black non-Hispanic MBMS participants, epigenetic age acceleration was associated with being born in a Jim Crow state by 0.14 standard deviations (95% confidence

interval [CI] 0.00, 0.27) and with birth state conservatism (0.06, 95% CI 0.00, 0.05), pooling across all clocks, as was low parental education for both Black non-Hispanic and white non-Hispanic MBMS participants (respectively: 0.24, 95% CI 0.08, 0.39, and 0.27, 95% CI 0.03, 0.51. Adult impoverishment was positively associated with the pooled 2nd generation clocks among the MESA participants (Black non-Hispanic: 0.06, 95% CI 0.01, 0.12; white non-Hispanic: 0.05, 95% CI 0.01, 0.08; Hispanic: 0.07, 95% CI 0.01, 0.14).

Conclusions and Relevance. Epigenetic accelerated aging may be one of the biological mechanisms linking exposure to racialized and economic injustice to well-documented inequities in premature morbidity and mortality.

Identifying biological pathways by which societal injustice becomes embodied and expressed as population health inequities – that is, unjust, avoidable, and in principle preventable differences in health status across societal groups¹ – is important, given implications for exposing accountability and preventing future harm.^{1,2} One set of potential pathways recently amenable to investigation in epidemiologic studies involves epigenetics, referring to diverse biological mechanisms that regulate gene expression and are heritable across cell generations.^{3,4} In 1940, the biologist Conrad Waddington (1906-1975) coined the term "epigenetics," as part of his novel work investigating phenotypic development as a temporal path dependent process shaped by exposures affecting gene regulation and expression, canalization, and chance.⁵ Since then, epigenetic research has expanded to investigate, for example, such outcomes as morbidity, responsiveness to treatment, aging, and mortality.^{3,4,6}

Of particular interest is the epigenetic mechanism of DNA methylation (DNAm), which entails the addition of a methyl group to cytosine, which chiefly occurs at cytosine-guanine dinucleotide (CpG) sites.^{3,4,6} Methylation at CpG-rich promoters tends to repress transcription, thereby reducing expression of the associated genes; methylation at other sites may have differential effects.^{3,4,6} DNAm is both dynamic and can be transmitted mitotically across cell generations.^{6,7} The discovery of age-related temporal patterning of DNAm led to creation, in 2013, of the first epigenetic "clocks" to estimate the biological age of an individual or a biological specimen,⁷⁻¹⁰ Comprising specified sets of DNAm sites, these epigenetic clocks "tick" in all cells and their descendants and yield estimates of "DNAm age" (or "epigenetic age"),^{7,8} The 1st generation clocks used algorithms trained solely on chronological age; 2nd generation clocks have additionally been trained using phenotypic data on health outcomes and exposures (e.g., cigarette smoking) and have also examined the "pace of aging" within individuals (**eTable**

1).^{7,8,11,12} Beyond estimating biological age, epigenetic clocks also enable the quantification of "epigenetic accelerated aging," in essence DNAm age exceeding chronological age.⁷⁻¹²

Recent epidemiologic studies, summarized in several reviews, have reported that epigenetic accelerated aging is associated with not only increased risk of cardiometabolic disease, cancer, and earlier age at death but also well-known racialized and economic health inequities in these outcomes.¹¹⁻¹⁴ Most of these epigenetic clock studies have focused on socioeconomic position, measured at the individual-level, with recent evidence (especially for 2nd generation clocks^{11,15,16}) showing stronger associations with early life as compared to adult deprivation.¹¹⁻¹⁶ Several studies have documented associations with neighborhood poverty,^{11-14,17} air pollution,^{11-14,18} and adult self-reported experiences of racial discrimination^{19,20}; none have included measures of structural racism or residential segregation.²¹

Guided by the ecosocial theory of disease distribution and its conceptualization of pathways of embodiment of societal injustice in relation to levels, lifecourse, and historical generation,² we offer a novel analysis of associations between epigenetic accelerated aging among US Black non-Hispanic, white non-Hispanic, and Hispanic adults and exposure to Jim Crow birthplace (i.e., born in a US state in which white supremacy, before the passage of the 1964 and 1965 US Civil Rights Acts, was upheld by both state law and terror^{2,22-25}) and current racialized economic segregation,²⁵⁻²⁷ along with exposure to self-reported experiences of racial discrimination, lifecourse socioeconomic position, and concurrent air pollution.

METHODS

Study Populations. We used data from two pre-existing US studies to conduct our analyses, and added new exposure data to both datasets. As pre-specified in our study protocol, the *My Body My Story* (MBMS) study^{28,29} comprised our "discovery" data (Boston, MA, 2008-

2010), and a sub-set of the *Multi-Ethnic Study of Atherosclerosis* (MESA)^{30,31} served as a secondary data set (4 US cities, 2010-2012), one likely with different biases given differences in study design, older age range, and geographic heterogeneity.³²

MBMS was designed by several current team members to investigate how racial discrimination and other social exposures affect risk of cardiovascular disease.^{28,29} As previously reported, the study recruited 1005 participants randomly selected from the patient rosters of four Boston community health centers between 2008 and 2010 who met study eligibility criteria: working age adults between age 35 and 64 years, born in the US, and self-identified as being either Black non-Hispanic or white non-Hispanic.^{28,29} Among the 1005 MBMS participants, 85% provided a finger prick blood sample on to filter paper (409 Black non-Hispanic; 466 white non-Hispanic), and within each racialized group, we determined that those who did vs. did not provide a blood spot did not differ by income level or self-reported experiences of racial discrimination. Participants' blood spots were stored at -20°C and not analyzed until the present investigation.

MESA, a longitudinal cohort, obtained DNAm from a randomly selected subset of 1264 Exam 5 participants (2010-2012) drawn from the Baltimore, MD, Forsyth County, NC, New York City, NY and St. Paul, MN recruitment sites; they were age 55 to 94, and 582 were non-Hispanic white, 270 were non-Hispanic Black, 404 were Hispanic, and 10 were non-Hispanic of other race/ethnicities.^{30,31} At baseline (2000-2002), MESA recruited 6184 participants free of cardiovascular disease (CVD) ages 45 to 84 who self-identified as being white, African American, Hispanic, and Chinese, and were recruited from university-affiliated field centers in 6 US communities (the 4 named above plus Chicago, IL and Los Angeles, CA). MESA data for Exams 1-5 included social metrics analogous to those in MBMS.^{30,31} Per all MBMS participants

being US-born, we focus on the 975 US-born MESA participants (229 Black non-Hispanic, 555 white non-Hispanic, 191 Hispanic).

Epigenetic data. We extracted DNA from the MBMS blood spots in 2021, using the QIAamp DNA Investigator Kit for FTA and Guthrie cards, with samples randomized across 96 well plates, and measured DNAm using Illumina Infinium MethylationEPIC Beadchip; protocol details are provided in our preliminary study using the MBMS blood spots to demonstrate the feasibility and validity of analyzing specimens with as little as 40 ng DNA.³³ Among the 875 MBMS blood spot specimens, 472 were judged suitable for DNA extraction; exclusions were due to an initial blood spot protocol problem affecting only the first community health center, whose members were predominantly white non-Hispanic. We then removed specimens from: (a) 50 participants with less than 40 ng DNA;³³ (b) 96 participants with poor quality DNA extraction (as determined by high numbers of undetected probes on the EPIC BeadChip); and (c) 35 participants whose self-reported cis-gender identity did not match their chromosomal sex as predicted by *meffil* (an algorithm which relies on staining intensities for the X and Y chromosomes³⁴); these latter specimens also displayed very little correlation between chronological age and epigenetic age. Thus, in total 293 MBMS participants (224 Black non-Hispanic and 69 white non-Hispanic) and 857,774 sites passed QC. Functional normalization included BeadArray as a fixed effect. Blood cell composition was estimated using a deconvolution algorithm,³⁵ implemented in *meffil*, based on the "blood gse35069 complete" cell type reference.

DNAm for the MESA participants was measured in purified primary monocytes obtained from blood drawn in the morning after a 12-hour fast, using rigorous quality-controlled medRxiv preprint doi: https://doi.org/10.1101/2023.12.13.23299930; this version posted December 14, 2023. protocols.³⁶ As described in detail in prior publications, epigenome-wide methylation was quantified using the llumina HumanMethylation450 BeadChip.³⁶

We constructed the epigenetic clocks for all participants using code provided by the developers if available, or else using the formula in the original paper; values for GrimAge were calculated by uploading data to the GrimAge website (**eTable 1**). Among the 10 epigenetic clocks we computed, six were 1st generation (Horvath; Hannum; Zhang Age; epiTOC; MiAge; DNAmTL) and four were 2nd generation (Zhang Mortality; PhenoAge; Dunedin; Grim Age), with shared CpG sites more evident among the 1st generation clocks (**eTables 1-3**). To address underlying genetic variability, we computed both surrogate variables and genetic principal components (PCs) (**eTextbox 1**) and included only the former in our models, as genetic PCs were available only for MESA and their inclusion did not alter results (**eFigure 1**).

Exposure data. We conceptualized and operationalized the MBMS and MESA social metric exposure data in relation to type and level of exposure and time period of exposure (at time of birth, childhood, and adult) and stratified analyses by racialized groups, given their likely differences in exposure to and impacts of racialized injustice. Measures of exposure to racial injustice *at time of birth* included (with the latter two newly added): (a) born in a Jim Crow state^{22,25,37}; (b) city of birth Index of Concentration at the Extremes (ICE) for racialized segregation²⁵⁻²⁷ (available for MBMS only); and (c) state of birth US state policy liberalism index, drawing on 148 policies enacted over 8 decades, including civil rights legislation.³⁸ Validated adult measures of self-reported exposure to racial discrimination included, for MBMS, the Experiences of Discrimination scale,^{25,39} and, for MESA, the Major Discrimination Scale, restricted to unfair treatment attributed to race/ethnicity.^{25,39} Metrics for socioeconomic position prior to adulthood comprised self-reported highest level of educational attainment for the

participants and for their parents.^{28,29,32} Additional self-report adult socioeconomic data at the individual and household levels pertained to: household income; household income per capita; household income to poverty ratio; employment status (and, if employed, occupational class (available in MBMS only); and housing tenure.^{28,29,32} Based on participants' residential address at the time of the survey, we newly generated census tract level data for both the MBMS and MESA participants, using the American Community Survey 5-year estimates for 2008-2012⁴⁰; these metrics included: composition by racialized group and the ICE for income, racialized, and racialized economic segregation, and housing tenure.²⁵⁻²⁷ Air pollution data for both MBMS and MESA were based on participants' residential address at time of survey (details provided in **Table 1**). Missingness of the exposure data was typically under 5% for most variables (**Table 1**) and correlations among continuous variables from MBMS and MESA are respectively provided in **eFigures 2-3**.

Covariates. Additional covariates comprised self-reported data for: age; gender; and household size and number of children under age 18 (used to determine the household income to poverty ratio⁴¹).

Statistical methods. Epigenetic clocks were regressed jointly on participants' age, exposures to adversity (see Table 1), sex/gender, BMI, smoking, cell type proportions in their blood sample, and surrogate variables (see eTextbox 1). We fit separate models for each exposure-clock combination. Models were standardized to account for clocks' scale differences. We employed crossed random-effects models⁴² with random intercepts by participant and random age slopes by clock to estimate average exposure effects assuming a common latent "epigenetic aging" construct observable across clocks. for missing data (**eTextbox 2**). We employed Bonferroni and False Discovery Rate correction for multiple comparisons testing (**eTextbox 2**).

RESULTS

Table 1 summarizes the distribution of the exposure data and covariates for the US-born MBMS study population (N = 293) and the US-born MESA study population (N = 975) with DNAm data, overall and stratified by racialized group (MBMS and MESA: Black non-Hispanic and white non-Hispanic; MESA only: Hispanic). MBMS participants on average were younger than MESA participants (means of 49.0 vs. 69.6 years) and more likely to self-identify as being women (62.8% vs. 51.4%). As expected, the Black non-Hispanic participants in both MBMS and MESA had the highest exposure to racial injustice at different levels and different points over the lifecourse (Table 1). They were most likely to be born in a Jim Crow state and/or a state with a low (least liberal) state policy liberalism index. As adults, they were also most likely to selfreport exposure to racial discrimination in three or more domains and reside in segregated census tracts with high extreme concentrations of, respectively, Black, and low-income Black, non-Hispanic households. By contrast, the US-born white non-Hispanic MBMS and MESA participants were most likely to live in census tracts with high extreme concentrations of, respectively, white, and high-income white, non-Hispanic households (Table 1). Educational attainment was lower for participants' parents compared to the participants, and in both groups was lowest for the Black non-Hispanic and Hispanic participants (Table 1). Similar patterns occurred for self-reported adult household income, poverty level, occupational class (if employed), and housing tenure, and also for the ICE metrics for income segregation and housing tenure. The MBMS and MESA DNAm raw age estimate and epigenetic accelerated aging

estimates (detrended for chronological age) in relation to each specified exposure, stratified by racialized group (and, for MESA, by also stratified by nativity), and the cell type proportions, are presented for all 10 clocks in **eTable 4**.

In **Figures 1 through 4** we present standardized effect estimates for each clock, and also the pooled clock data, controlling for age, sex/gender, cell-type proportions, surrogate variables, smoking and BMI; in **eFigures 4-9**, we remove smoking and BMI.

Our primary findings for MBMS were that we detected consistent patterns of epigenetic accelerated aging (with estimates whose 95% confidence intervals (CI) excluded 0), pooling across all clocks, for three social exposures: (a) Jim Crow birthplace and birth state conservatism for Black non-Hispanic participants only (0.14, 95% CI 0.00, 0.27 and 0.06, 95% CI 0.00, 0.12, respectively), and (b) low parental education, for both Black non-Hispanic and white non-Hispanic participants (respectively: 0.24, 95% CI 0.08, 0.39, and 0.27, 95% CI 0.03, 0.51); these latter estimates were similar or higher for the pooled 2nd generation clocks for the Black non-Hispanic participants (0.25, 95% CI 0.06, 0.43), and the white non-Hispanic participants (0.38, 95% CI 0.09, 0.66).

Second, among the US-born MESA participants (most analogous to, albeit on average older than, the solely US-born MBMS participants), pooling across all clocks, we observed consistent patterns of accelerated epigenetic aging for the social exposures only for the white non-Hispanic participants for higher adult impoverishment (as measured by the negative log of adult household income ratio to the poverty line): 0.03, 95% CI 0.00, 0.05, and also birth state conservatism (0.03, 95% CI 0.00, 0.06). Adult impoverishment was also associated with epigenetic accelerated aging for the pooled 2nd generation clocks for all three racialized groups

(Black non-Hispanic: 0.06, 95% CI 0.01, 0.12; white non-Hispanic: 0.05, 95% CI 0.01, 0.08; Hispanic: 0.07, 95% CI 0.01, 0.14).

Correction for multiple comparisons testing (both Bonferroni and the less conservative False Discovery Rate) increased the p-values. Other social and environmental exposures did not exhibit consistent associations with epigenetic accelerated aging across clocks, among either MBMS or MESA participants. Additional analyses showed the expected associations of epigenetic accelerated aging with chronological age, BMI, and smoking (**eTable 5**) and also little difference in associations for exposures if analyses excluded smoking and BMI (**eFigures 4-9**).

DISCUSSION

Our study offers intriguing novel evidence that exposure to Jim Crow at time of birth may be associated with epigenetic accelerated aging (pooling across all clocks) among US-born Black non-Hispanic working age adults, for whom being born in a Jim Crow state translated to age acceleration by 0.14 standard deviations (95% CI 0.00, 0.27) in MBMS, with evidence also of associations with birth state conservatism. It also adds to extant evidence that epigenetic accelerated aging, among working age or older adults, is associated with low parental education and adult impoverishment.¹¹⁻¹⁶

Several study limitations merit consideration. First, despite having sample sizes on par with or larger than the handful of other epigenetic clock studies with data on exposure to racial injustice,²¹ our analytic sample sizes were relatively small, especially compared to much larger studies with more statistical power (with primarily European or US white populations) that have analyzed epigenetic clocks in relation to economic and pollution exposures,^{12-14,18,43} hence our focus on consistency of point estimates rather than statistical significance. Second, MBMS

utilized frozen blood spots, a source validated for DNAm analyses,⁴⁴ but MESA used DNAm obtained from purified monocytes. Additionally, as reported in our prior study demonstrating we could obtain results meeting rigorous quality control protocols using as little as 40ng of extracted DNA, albeit with decreasing statistical power with decreasing total weight of DNA.³³ Third, for both MBMS and MESA, we used only DNAm from blood; yet, while DNAm patterns can vary by tissue, studies using DNAm measured in blood, including longitudinal analyses, have found robust associations between epigenetic accelerated aging and diverse health outcomes.¹¹⁻¹³ Fourth, our observational study was not designed to yield causal effect estimates; generating data on associations with novel exposures, however, is a necessary first step. Foci for our next studies include EWAS analyses and investigating whether specific DNAm sites or epigenetic clocks mediate associations between the study exposures and selected health outcomes.

Study strengths include, first, conducting parallel analyses across two similar but not identical study populations, enhancing robustness of hypothesis testing, given likely different biases as described above.³² Under the assumption that the different clocks (variously trained on age, mortality, or phenotype data) reflect a latent construct of epigenetic aging, we computed standardized effect estimates to aid comparison of associations, singly and pooled. We also modeled age in our analysis using methods consistent with our prior work on identifying the correct way to model age in analyses of accelerated epigenetic aging.²¹

Supporting our view that the Jim Crow birthplace and parental education exposures provide suggestive signals of association, new research, using 2nd generation clocks, has reported epigenetic accelerated aging to be associated with the economic shock of the 1930s US Depression⁴⁵ and parents' educational attainment.^{16,46,47} Inconsistencies in the MBMS and MESA results for Jim Crow place of birth merit further investigation and plausibly may reflect It is made available under a CC-BY-NC-ND 4.0 International license .

geographic variability in Jim Crow exposures, Jim Crow migration patterns, and exposure to racism in non-Jim Crow states.^{22-25,37,48} Other inconsistencies in the MBMS and MESA results may reflect differences in age of participants, cell types used for DNA extraction, and measurement on different Illumina beadchips (450K vs. EPIC). Suggesting that adult exposures may also matter is evidence linking epigenetic accelerated aging to adult economic deprivation and exposure to air pollution,^{11-16,18,46,47,49} with adults' methylome shown to change in response to acute short-term exposures to air pollutants.⁵⁰

Together, our findings, in conjunction with extant literature, support strengthening research to test the hypothesis that epigenetic accelerated aging may be one of the biological mechanisms underlying the well-documented elevated risk of premature morbidity and mortality, including for noncommunicable diseases, among social groups subjected to, vs. protected from, racialized and economic injustice.^{2,11-16} Future studies may benefit from inclusion of historically-informed measures of structural racialized and economic injustice contingent on the time period and geographic location where people are born, live, work, and bear and birth their children.

DECLARATION STATEMENTS

1) Ethics approval

The study protocol, involving use of both the MBMS and MESA data, was approved by the Harvard T.H. Chan School of Public Health Office of Human Research Administration (Protocol # IRB19-0524; June 10, 2019).

The original MBMS study protocol, implemented in accordance with the Helsinki Declaration of 1975, as revised in 2000, was approved by the Harvard School of Public Health Office of Human Research Administration (protocol #11950–127, which covered 3 of the 4 health centers through reciprocal IRB agreements), and was also separately approved by the fourth community health center's Institutional Review Board. All participants provided written informed consent.

Legend: For interpretation, the effects of the 1st generation age-estimator clocks can be viewed as how many additional years of aging (in units of standard deviations) are associated with the exposures – either in comparison to the reference category for categorical variables, or according to a 1-unit standard deviation increase in the exposure for the continuous measures. For reference, in the MBMS population, age had a standard deviation of 7.92, so a pooled effect estimate of 0.10 on the age-estimator clocks is comparable to an increase in aging of 0.79 years. Other clocks (as described in Supplemental Table 1) predict age-related measures such as mortality risk, mitotic divisions of stem cells, phenotypic outcomes, and telomere length, and therefore cannot be interpreted in units of additional years of aging. To ensure that the common effects of adverse exposures across clocks would be in the same direction, we: (a) reversed the direction of the DNAmTL clock (multiplied by negative one) because telomere length decreases with age, and (b) reversed the ICE measures compared to their conventional definitions, so that higher values represented more adverse exposures. All models controlled for the specified covariates (age, sex/gender, cell-type proportions, smoking, BMI, and surrogate variables). Because only 2 of the MBMS white non-Hispanic participants were born in a Jim Crow state (see Table 1), we do not report results for this group, given small numbers.

eTextbox 1. Construction of surrogate variables and genetic principal component (PC) variables.

Surrogate variables: We adjusted for batch effects using surrogate variables (SVs) (the first 5 for MBMS and the first 10 for MESA, calculated using the R package sva [1]). We used SVs to adjust for batch because stratifying the dataset meant that measured batch variables had small cell frequencies, which in turn caused uncertainty in the regression model and resulted in deflation of test statistics. We chose to use 5 SVs for MBMS and 10 for MESA as these encompassed the majority of association between SVs and batch variables, as well as DNA input level for MBMS; and their inclusion returned EWAS lambda values to approximately 1.

Genetic principal component (PC) variables: MESA used the Affymetrix Genome-Wide Human SNP Array 6.0 to genotype 8402 participants; this overlaps with 933 out of 975 of the US-born participants with DNAm data. Genetic principal components were generated by MESA: 23,428 flagged SNPs and 6,849 SNPs in long range LD were removed before principal components were computed per chromosome, and then combined across chromosomes to give the final PC values. eTextbox 2. Methods for multiple imputation and multiple comparisons.

1) Multiple imputation

Multiple imputation was carried out in all models to account for missing exposures and covariates. The extent of missing data on each of the variables is listed in Table 1. The imputation models included the epigenetic clock values, age, racialized group, each exposure interacted with racialized groups, BMI, smoking, sex/gender, the cell type variables, and the surrogate variables (5 for MBMS and 10 for MESA). All analytic variables were included in the imputation models andiInteractions were included to reduce the potential for bias. The default, predictive mean matching, was used as the imputation method for each missing variable and 40 imputations were carried out per model. Multiple imputations were performed using the mice package in R.

2) Multiple comparisons

The number of multiple comparisons varied and depended on four aspects of each set of analyses: (1) the set of variables considered (e.g., for early life or for adult life exposures), (2) which population group was the focus (MBMS or MESA), (3) the number of racialized groups at issue, and (4) whether the analyses focused on the epigenetic clocks individually or the pooled estimates. As a result, depending on the specific analysis at issue, the number of multiple comparisons ranged between 12 and 290. We list the N of multiple comparisons for each set of analyses below; further details (e.g., specific variables included) can be provided upon request.

The average additional % variance explained by incorporating the genetic PCs was 0.06%, and the maximum was 1.75%. Decreases in variance explained can be explained by the SVs being determined by an iterative (stochastic) algorithm, and use of the genetic PCs had no discernable impact on the effect estimates, as compared to models using the SVs.

The main analyses include smoking and BMI as they were hypothesized to be significantly explanatory with respect to the variation observed in the epigenetic clocks. However, it is possible that adult-age characteristics like smoking and BMI may be causally downstream of early life exposures and/or effect modifiers of contemporaneous adult life exposures. Therefore, both analyses including them (in the main figures) and analyses without them (eFigures S4-S9) are presented. Because only 2 of the MBMS white non-Hispanic participants were born in a Jim Crow state (see Table 1), we do not report results for this group, given small numbers.
