39 Abstract

There has been a growing concern about the financial sustainability of community-40 based health insurance (CBHI) schemes in developing countries recently. However, 41 little empirical studies have been conducted to identify potential contributors including 42 ex-ante and ex-post moral hazards. We respond to this concern by investigating the 43 44 effects of being insured on household lifestyle -Preventive Care- and the timing of treatment seeking behavior in the context of Ethiopia's CBHI scheme. Using three 45 rounds of household panel data and a fixed-effects household model, we do not find a 46 47 significant impact on preventive care activities. However, we find that participation in CBHI increases delay in treatment-seeking behavior for malaria, tetanus, and 48 tuberculosis symptoms. This behavior is costly for the insurer. Therefore, it is essential 49 to identify the primary causes of delays in seeking medical services and implement 50 appropriate interventions aimed at encouraging insured individuals to seek early 51 medical attention when signs of diseases emerge. 52 53

54 Introduction

High costs of care in developing countries are recognized as a leading cause of poor health 55 care utilization, poor health outcomes and a key factor in precipitating poverty. According 56 to (1), 800 million people worldwide spend at least 10 percent of their household budget on 57 health care expenses. For nearly 100 million people, that spending is enough to drive them 58 59 into extreme poverty and force them to survive on just \$1.90 or less a day. With the aim of ensuring all people can access the health services they need without facing financial 60 hardships, CBHI schemes have been introduced since the second half of the 19th century in 61 62 the developing world (2,3). CBHI scheme is typically used to reduce inequalities in health 63 care utilization by reducing the cost of care. This scheme are established on the basis of existing principles of social solidarity, operate at the community level and allow 64 65 community involvement in scheme management (4). Typically, membership fees are low and substantial portion of healthcare costs are, therefore, subsidized by the government. 66 The scheme differs from social health insurances, which is primarily for employed 67 individuals, and publicly funded health insurance programs, which are essentially free at 68 point of use and tax funded. 69

71 Extensive studies evaluating CBHI have been conducted in different countries, mainly examining the impact on health care utilization and out-of-pocket spending (5-12). 72 While CBHI seems promising in terms of enhancing health care utilization, concerns have 73 been raised about its sustainability as a health financing system (13-15). In the context of 74 Tanzania, (16) identified the presence of large claims, leading to the suggestion that 75 policymakers should confront a tradeoff between reducing the health benefit package or 76 increasing revenues to facilitate the nationwide expansion of the existing insurance scheme. 77 78 This concern resonates with findings from (14), who observed excess claim costs and negative net income within Ethiopian CBHI in specific districts. A similar concern has 79 been expressed by the relevant government officials regarding Ethiopian CBHI (17). Large 80 claims in CBHI may stem from various factors, including ex-ante and ex-post moral 81 hazard problems (18). Ex-post moral hazard refers to the situation where beneficiaries 82 might become excessive healthcare consumers once they are insured, especially those who 83 84 enroll with severe existing health conditions, driven by a perceived lack of financial

barriers to seeking care. They may be more likely to seek medical care, driving up claim
costs. On the other hand, ex-ante moral hazard may manifest as a lack of preventive
practices or unhealthy behaviors among beneficiaries, leading to a higher likelihood of
future health issues and, subsequently, large claims.

While there is limited empirical evidence on whether adverse behavior by beneficiaries 90 contributes to rising healthcare costs in CBHI schemes, studies based on different insurance 91 schemes provide mixed insights. In developed countries, (19–22) suggests that insurance 92 can drive unhealthy lifestyles among policyholders, given that the health consequences of 93 their behavior are shared between insurers and policyholders. Conversely, studies like 94 (18,23–25) report increased utilization of preventive care with no evidence of risky health 95 96 behaviors among the insured individuals. One perspective on this phenomenon, as discussed in (18), is that while insurance covers the financial aspect of healthcare access. 97 risk-averse individuals might still experience utility losses due to ill health. Consequently, 98 99 this factor could potentially mitigate the incentives for insured individuals to reduce their preventive efforts. 100

In the context of low-income settings, (26–28) have made initial attempts to understand
behavioral responses to insurance schemes. (27) examined the impact of a CBHI scheme in
Burkina Faso on the probability of individuals seeking care when sick while, (26,28)
focused on the effects of insurance on preventive activities, such as use of malaria bed
nets.

In this paper we examine the effects of Ethiopian CBHI on behavioral response by 108 assessing preventive care activities, such as hand-washing before meals and water treatment 109 before drinking. Additionally, we analyze the timing of care-seeking behavior in 110 hypothetical cases of Malaria, Tetanus, and Tuberculosis symptoms. Our main departure 111 from the literature is while previous studies, such as (12,27,29,30), have primarily focused 112 on the treatment methods chosen by beneficiaries, our study looks at when households 113 decide to seek care upon the onset of disease symptoms. This approach is particularly 114 115 relevant for policymakers, as delayed care- seeking behavior among beneficiaries can have cost implications for the insurer and potentially impact the financial sustainability of the 116 CBHI scheme. 117

In Ethiopia, CBHI has been implemented since 2011 to cover people operating in the 119 informal sector (rural and urban). The scheme provides financial protection for low-income 120 families to foster healthcare utilization thereby to improve their health status. Initially, four 121 regions out of nine administrative regions were covered by the program. Within these four 122 regions 13 districts were selected to gauge the response of households and later expanded to 123 cover other districts. Since this pilot stage, by June 2022, 879 districts located in six 124 regions and two city administrations (Addis Ababa and Dire Dawa) have joined the scheme 125 and it has enrolled more than 40% of the population in the country. As part of the Health 126 127 Sector Transformation Plan, it is also planned to cover 80% of districts and to enroll 80% of the households at national level (Data from EHIS 2022). 128

Using three rounds of household panel data and applying a household fixed-effect approach, we did not find a significant effect on preventive care behaviors. However, participation in CBHI appears to be associated with increased delays in accessing modern

healthcare.

This paper is organized in six sections: section 2 describes Community-Based health 135 insurance, section 3 presents data, section 4 empirical approach, section 5 provides results 136 and discussions, and section 6 concludes. 137

Community-based health insurance in Ethiopia 139

Geographically, Ethiopia is divided into twelve regions and two administrative cities. Within the 140 public health system, the provision of healthcare infrastructure increased between 2000 and 2015 in 141 all parts of the country (8). Following the expansion of healthcare infrastructure, a key motivation 142 143 was to enhance the accessibility of healthcare services with the assumption that improved accessibility would encourage greater utilization of care. However, despite these efforts, a significant 144 hurdle persisted – individuals were required to cover healthcare expenses out-of-pocket. This 145 financial barrier had a notable impact on healthcare utilization, resulting in continued low rates of 146 utilization. For instance, in the years 2009, 2010, and 2011, outpatient attendance per capita, 147 148 defined as the total outpatient attendance over the total population, stood at rates of 0.29, 0.3, and 0.29, respectively (31). 149

150

151 In response to this, the CBHI scheme was introduced in June 2011, specifically targeting those engaged in the informal sector both in rural and urban areas. The overall goal of the scheme is to 152 153 achieve universal health coverage by ensuring low-cost access to health services, especially for those who cannot afford to use them. Initially, the scheme was piloted in thirteen woredas (hereafter 154 districts) selected from four main regions (Tigray, Amhara, Oromia, and SNNP). The complete 155 156 set of district selection criteria included (1) Willingness of district authorities to implement the schemes (2) Commitment of districts to support schemes, (3) Geographical accessibility of health 157 centers (4) Quality of health centers, (5) The implementation of cost recovery, local revenue 158 159 retention, and public pharmacy policies in health centers (8). Village level implementation of the scheme is decided by a majority vote of the residing households while households' enrolment in 160 161 the scheme is voluntary. To curtail the problem of adverse selection, registration is accepted at the household level. Therefore, all household members must present their family insurance card 162 163 to access the benefit packages at health care points.

164

165 Premium is a fixed rate, unlike other types of insurance that tend to be progressive based on income. This is decided by the federal government in collaboration with local governments and other 166 167 stakeholders. At the beginning, the annual cost of premiums for households was low, ranging from 126 to 180 Ethiopian Birr (ETB), but from 2020 the premium increased to 350 (\$10) for urban 168 169 households and 240 ETB (\$7) for households living in rural areas. This cost amount to 0.5 to 1% of household monthly income (32), but it might vary slightly across regions depending on 170 171 household characteristics (8). For instance, for a core household with a parent and all children 172 under 18, the monthly premium for the first year is 10.50 ETB in SNNP, 11 ETB in Tigray, and 173 15 ETB in Oromia. Households pay a one-time registration fee and premiums to the village office, which then transfers the funds to the CBHI scheme (32). The scheme also targets and 174 175 provides fee waivers to the poorest households in the pilot districts. However, only few of eligible 176 households have actually joined the scheme with fee waiver benefits, not more than 10% of the population in the district. 177

178

CBHI benefit package includes inpatient and outpatient domestic treatment, but it does not 179 180 cover non-medical costs such as transportation to a facility. The program offers treatment options in urban public hospitals, but patients must follow referral procedures. Under CBHI, there is no co-181 182 payment and no limit on the number of services provided. However, treatments obtained from 183 private health facilities (except for services that are not available at public facilities) or abroad and 184 treatments which have largely cosmetic value are not covered under the scheme.

In Table 1 we show enrollment, drop-out and new membership rate in CBHI for each region 186 187 and for various years. The overall enrollment rate was 41% in 2012 but increased to 48% in 2013. 18% of households enrolled in 2012 dropped out and 25% of uninsured households in 2012 became 188 insured in 2013. Enrollment, drop- out and membership renewal varies across regions where pilot 189 190 districts reside. Scheme uptake seems to be higher in the Amhara region with greater enrollment rates, lower dropout rates and the second highest new membership rate. The lowest enrollment 191 incidence is recorded in SNNP region in both years. Tigray regions show the highest new 192 membership rate at the same time experienced highest dropout rate. 193

Data 197

In this paper, we used three rounds of household panel data from rural Ethiopia, which was 198 collected as part of the research project on Poverty Dynamics, Health Shocks and 199 200 Coping Strategies in Ethiopia. This was a collaboration project of the International Institute of Social Studies (ISS) of Erasmus University Rotterdam, the Ethiopian 201 Economics Association (EAA) and the Organization for Social Science Research in 202 Eastern and Southern Africa (OSSREA). 203

204

The first round of surveys was collected between March and April in 2011, a few months 205 before the launch of the CBHI program. The subsequent rounds were collected again 206 between March and April in 2012 and between March and April in 2013 after the launch of 207 the CBHI. The data collection involved 8 teams, each comprising 4 enumerators and 1 208 supervisor. Each team was assigned to collect data from 2 districts. 209

210

The surveys cover 16 districts located in four main regional states of Ethiopia, namely 211 Tigray, Amhara, Oromia and SNNP. Twelve of these districts operate CBHI program, 212 213 while one district in each region did not start offering CBHI. The survey includes a 214 information about individuals, households and community level questions. When collecting the data, 6 villages from each district were selected randomly and 17 households from each 215 village were randomly selected from lists kept by the village administrations. The first 216 round of the survey thus included 1,632 households which were tracked longitudinally. In 217 the second survey round (in 2012) it was possible to resurvey 1,599 households, leading to 218 219 a 2% attrition. The third survey round contain 1,583 of the households, with an overall 3% attrition from the original sample. 220

221

222 Given that enrollment is accepted at a household rather than the individual level, we are interested in household level lifestyle and timing of treatment seeking measures. Our 223 outcome variables are the following. First, we construct a binary indicator variable that 224 takes a value one if individuals in a household wash hands before and after meals and zero 225

otherwise. Second, another binary indicator variable that takes a value one for households 226 that treat water before drinking (filters, boils or apply other methods to make it safe) and 227 zero otherwise. 228

229

230 In the data we have information about what households would do if symptoms of disease, specifically malaria, tetanus, and tuberculosis, were detected in an adult member of the 231 household. More than 95% of the households stated that they would take them to modern 232 healthcare providers. There is a follow-up question asking when they would take them to 233 their choice of modern care. The answer to this question for Malaria, Tetanus and 234 Tuberculosis (TB) is categorically 1 if they would take them immediately, 2 if they 235 would take them the next day if symptoms persist, 3 if they would take them after two 236 days if symptoms persist, 4 if they would take them to care between three days and a week, 5 if 237 they would take them to care after a week if symptoms persist, and 6 if they would take 238 them to care after more than a week if symptoms persist. Each stage indicates households 239 behavioral response to waiting time for each illness episode, allowing us to investigate the 240 effects of CBHI on whether the insured tends to receive immediate or delayed treatment. 241 These outcomes are based on clinical health need vignettes, where each household responded 242 243 to hypothetical scenario questions. For more details, refer to Appendix.

244

Generally, the literature assessing the association between health insurance and lifestyle 245 246 mainly focuses on individual behavior in relation to diet, smoking, alcohol drinking and exercise, (18,20,22,33). Unfortunately, we do not have this information to extend our 247 analysis in this direction. However, we believe these outcomes would only be marginally 248 relevant for our purposes as we expect lower prevalence of smoking or alcohol 249 consumption and little physical activity due to limited infrastructure in the rural areas 250 where our data were collected. 251

252

In our study, the selection of washing hands and treat water or not as key outcomes 253 stems from a clear perspective. While CBHI is traditionally expected to promote health-254 conscious behaviors, we recognize that in certain contexts, it might lead to riskier behavior 255 256 due to the financial security it provides. This paradoxical effect may also extend to the timing of healthcare-seeking behavior for illness symptoms. Specifically, while having 257 CBH expected to encourage immediate care-seeking, can, in fact, lead individuals to 258 perceive minor symptoms as less urgent and delay care. Particularly, the reduction in 259 financial barriers can lead some to feel less urgency in seeking care for what they consider 260 minor symptoms. Additionally, the insured may incur additional costs when visiting a 261 healthcare facility, including transportation, lost work time, accommodation, meals, and 262 incidentals. Even though the medical costs are covered, some may perceive their symptoms 263 as not worth the related expense, leading to delayed care. 264

Ethics Statement 266

Ethics approval for the study was obtained from the Ethics Committee at the International 267 Institute of Social Studies, Erasmus University Rotterdam (reference: iss0001946). 268 Committee is chaired by the Deputy Rector for Research Affairs (then, Professor Mohamed 269 270 Salih).

The data collection involved sequential rounds of household recruitment, starting on March 1, 275 2011, and concluding on April 30, 2011, with subsequent rounds conducted at one-year 276 intervals and two-year intervals at the same time window. Participants (household heads) 277 provided verbal informed consent for their participation in the study. The verbal consent process 278 involved a detailed explanation of the study purpose, procedures, and potential benefits. 279 Participants verbally expressed their willingness to participate, and this process was documented 280 by the interviewer's team. 281

Empirical approach 284

To examine the impact of CBHI on household lifestyles and timing of healthcare seeking, 285 we implement a household fixed-effect model, exploiting the longitudinal nature of our 286 data. We specify our fixed effects model as follows: 287

Where Y_{ht} represents the household-level outcomes at time t, which includes handwashing 290 before meals, water treatment before drinking, and the timing of care-seeking for illness 291 symptoms (Malaria, Tetanus, and TB). CBHI is a binary outcome that distinguishes the 292 insured and uninsured households. Hence, β is our parameter of interest, which capture 293 the effect of being insured by CBHI. We include a vector X_{jht} of covariates that might 294 potentially influence both the outcomes and CBHI enrollment. The controls included 295 are indicator for male household head, household size, number of under 6 years old 296 children, number of male youth (6-15 years), number of female youth (6-15 years), number 297 298 of working age women (16-64 years), number of elderly (over 64 years old), time to nearest 299 health center, time to nearest hospital, time to all-weather road, households with improved water and modern light sources. We also include education level of the head of 300 household, education level of the spouse, marital status of the head of household, his/her 301 main religion, household consumption per capita, and the region of residence of the household. 302 δ_h and δ_l represent household and time fixed effects, respectively. The household fixed effect 303 allows us to control for any observed or unobserved time invariant characteristics that affect the 304 305 outcomes and enrollment decisions. And by including time fixed effect, we take into account general changes in lifestyle over the years. nht denotes the idiosyncratic error 306 307 term.

To account for potential correlation across households within the same geographic area, we 309

- cluster standard errors at the village level (34,35). 310
- Results 311

312

Baseline characteristics of the insured and insured households 313

314 Table 2 reports the 2011 baseline characteristics of insured and uninsured households in both pilot and non-pilot woredas. In our sample, both groups are comparable in terms of 315 household composition, but insured households are, on average, farther from health centers, 316 hospitals, and all- weather roads. Access to improved water, and modern light sources is 317 slightly better among the insured. 318

319

The insured households have better-educated heads and spouses. The heads are more 320

married, less divorced, and widowed compared to uninsured household heads. In terms of religious denomination, most of the heads of the insured are Orthodox Christians, while Muslims are relatively dominant among the uninsured. On average, per capita consumption is higher for insured households. The majority of the insured group in our sample originates from Amhara, which is Ethiopia's second most populous region. In contrast, a higher proportion of uninsured households are located in the SNNP region.

Trends in lifestyle measures and healthcare seeking behavior 342

In Table 3 we show the average level of each outcome by treatment status (insured versus 343 uninsured households - pilot and non-pilot) and survey year. The statistics prior to CBHI 344 implementation is based on enrollment status in post CBHI intervention period (2012, 345 and 2013). Washing hands before meals shows a slight increase in insured households 346 347 over the years, while this trend decreased in 2013 among uninsured households. When it comes to water treatment, the trend is more V-shaped among the insured but reverses 348 among the uninsured. Among the insured, the preferred waiting time for treatment of 349 Malaria, Tetanus, and TB appears to have been dropped immediately after CBHI launch, 350 but then increased in 2013. While for the uninsured, with the exception of tetanus, the trend 351 is consistently downward. 352

Baseline estimates 355

In Table, 4 we present the effects of CBHI on household lifestyle indicators. We offer 356 these estimates in two distinct ways: First, by comparing insured households with 357 358 uninsured households in the pilot districts. Second, by combining uninsured households from both pilot and non-pilot districts as the control group. This approach allows us to 359 assess how the effects vary depending on the composition of the control households, 360 providing insights into the sensitivity and generalizability of the findings. 361

362

Our estimate shows that participation in the CBHI scheme does not affect behavior related 363 to hygiene and water treatment before drinking regardless of the location of control 364 households. However, in terms of waiting time, we find a delay of approximately 0.18 to 365 0.27 points in the average treatment seeking timing outcome for Malaria symptoms in 366 insured households compared to uninsured households. Given the scale of the dependent 367 variable where higher levels indicate longer delays, this suggests that having CBHI is 368 369 associated with a modest increase in delaying the timing of treatment. This result is statistically significant irrespective of the composition of control households, but the point 370 estimates slightly decreases when this composition is both from the pilot and non-pilot 371 districts. There is also a significant but relatively weak effect on preferred waiting time 372 for Tetanus treatment. In this case, CBHI participation results in 0.19 point increases in 373 waiting time for tetanus treatment when comparing the insured versus the uninsured in the 374 375 pilot districts only. This marginal effect disappears when we consider the uninsured households from both pilot and non-pilot districts. Finally, participation in CBHI also 376 increase relatively substantial delay (0.45 - 0.42 points more in the average treatment 377

timing) in treatment timing if a TB illness symptoms are seen in adult member of the 378

Dichotomizing timing of treatment seeking behavior

We assess the sensitivity of our baseline estimates by converting treatment seeking 387 outcome variables into binary indicators, measuring the effect on extensive margin. 388 Specifically, we create an outcome that takes a value of one if a household would seek care 389 immediately or the next day and zero otherwise for each illness symptoms (malaria, tetanus, 390 and tuberculosis). Similar to the baseline, we assess the impact in a setting where the 391 control groups are initially the uninsured in pilot districts and where the controls consist of 392 uninsured households in pilot and non-pilot districts. 393

394

Table 5 shows that our findings are robust, with the exception of tetanus. In particular, we 395 find a reduction in immediate or next-day medical care seeking behavior among insureds 396 compared to uninsured in pilot districts or uninsured in both pilot and non-pilot districts. In 397 fact, the effect on tetanus is also robust, since initially the effect on tetanus symptoms was 398 399 weaker. In overall, the estimates confirms that, as compared to those who are uninsured, the incidence of seeking immediate medical care for insured individuals are less by 7-10 400 percentage points for malaria and by 7-7.4 percentage points for tuberculosis. 401

Fixed effect Ordered logit estimator

409 Our baseline findings, obtained through a linear fixed effect estimator, are based on the 410 assumption of equidistant intervals between the six categories of the timing of treatment-411 seeking outcome. We explore the sensitivity of our results to this assumption by 412 employing a fixed effect ordered logit model with blow-up and cluster estimator. Unlike 413 the linear model, the ordered logit estimator only assumes the ordered nature of response 414 options and does not presuppose equal intervals between them (26). We adopt feologit user 415 written command contributed by (36).

416

The results in Table 6 is generally in agreement with the baseline finding. Particularly, insured households exhibit 1.36 to 1.61 times higher odds of falling into a higher wait time category for malaria symptom treatment and 1.70 to 1.77 times higher odds for tuberculosis treatment compared to uninsured households, with all other model variables held constant. Similar to the baseline, this estimator shows a weak effect in the case of tetanus symptoms. Overall, this estimator appears to sustain the baseline finding that enrollment in CBHI is associated with delay in treatment.

430 **Discussion**

431 Overall, while we don't find changes in preventive care activities, CBHI appears to increase delay in seeking care for illness symptoms. Delayed use of primary health care use 432 could increase the risk of developing worse health conditions and may substantially 433 increase health care costs. It could also create considerable challenges for the financial 434 sustainability of insurance schemes (14,37,38). Since the Ethiopian CBHI is primarily 435 intended for rural residents who are largely poor, an immediate visit for symptoms of 436 illness would be costly to them. This is because, in rural areas, mainly health posts are 437 available, but these facilities engaged in provision of preventive and promotion health 438 services, and they do not provide curative care. In order to get medical care, they need 439 440 to travel to the urban areas where health centers and hospitals are established. Visiting these facilities involves transportation infrastructure and subsistence costs that are not 441 covered by CBHI scheme. 442

The existing evidence also indicates that one of the reasons for low utilization of modern 444 care in rural Ethiopia is transportation barriers (39,40). In addition, seeking immediate care 445 for rural people would result in disruption of productive activity and loss of income while 446 off farming. This opportunity cost might weigh more than the benefit from the household's 447 perspective (41). This rationale aligns with evidence from rural China, where factors such 448 as involvement in farming, longer distances to the hospital, and awareness were 449 significantly associated with higher odds of delaying care for TB (42). Knowledge is 450 likewise reported as the key factor in delaying TB treatment in Ethiopian context 451 (43,44) and for malaria higher waiting time at the health facility was associated with 452 increased delay in treatment (45). However, our finding may contrast (46) which reveals 453 the reverse, highlighting delayed treatment-seeking for actual TB symptoms among 454 individuals without health insurance. 455

457 In the context of preventive care, our findings aligns with studies by (24,47–49), which also report insignificant impacts of other health insurance schemes. However, the broader 458 literature paints a varied picture, with the majority of studies showing significant effects 459 460 that depend on the scope of insurance coverage and the country of study. For instance, (28) reported significant increase in unhealthy practices related to the use of malaria 461 462 protective materials among members of the Ghanaian National Health Insurance Scheme, although this finding contradicts the results of a randomized experiment (26). In a similar 463 insurance context, (20) suggested that participation in China's Rural Cooperative Medical 464 Scheme encourages risky behaviors, such as smoking, heavy drinking, low physical 465 activity, consumption of high-calorie food, and being overweight. Studies in countries with 466 advanced insurance programs, (21,22,50), have shown increases in unhealthy individual 467 behaviors, such as heavy smoking, weight gain and lack of exercise in relation to private 468 insurance and Medicare. In contrast, (18,23,33) indicates that participation in insurance 469 programs can improve preventive care activities. This disparity is likely due to variations in 470 outcomes, research methodologies, and contextual factors. 471

472

In (19) a distinction is made between various sources of insurance to identify which ones lead to increased risky behavior. The findings indicate that public health insurance may contribute to higher inefficiencies in terms of exacerbating unhealthy behavior when compared to private insurance. This suggests that, as observed in the Ethiopian context, public health insurance schemes may face challenges in effectively controlling unhealthy practices such as delay in care seeking among insurance beneficiaries and in developing efficient insurance programs.

The results of this work shed new light on the understanding of the impact of CBHI scheme 481 482 beyond its primary objectives of promoting healthcare utilization and reducing the burden of out-of-pocket health expenditure. While many CBHI schemes in developing country aim 483 to counteract adverse selection, little attention has been paid to possible adverse behavioral 484 485 responses from members. The evidence in this study implies the need to identify and solve major causes of delay in seeking medical services among health insurance members. This 486 is important step to promote early use of services and, consequently, maintain financial 487 sustainability of the Ethiopian CBHI scheme. 488

Conclusion 493

494 There is an increasing number of studies highlighting concern about the financial sustainability of CBHI schemes in developing countries. We partially respond to such 495 concern by examining the potential contribution of lifestyle and delayed care seeking 496 497 behavior in the context of Ethiopian CBHI. We find that CBHI increased waiting time for treatment for malaria, tetanus and tuberculosis symptoms. The key important 498 implication for the insurer is that this delayed treatment would incur higher costs than 499 immediate treatment. If there are many such insured households delaying treatment, 500 perhaps the CBHI could collapse due to a large claim for reimbursement of care costs. 501

502

The expansion of CBHI in conjunction with supply-side investments such as improving the 503 accessibility of healthcare could mitigate such behavioral responses from members. Also, 504 improving the quality of care and increasing the staff could potentially reduce waiting times 505 at the health center, which could partially reduce the opportunity cost of seeking immediate 506 507 care.

508

Due to data limitation, we could not further explore behavioral responses in terms of other 509 510 indicators such as physical exercise, smoking, and alcohol consumption and potential underlying mechanisms for the reported results. There is, therefore, ample scope for future 511 research in this area, including our limitations. CBHI is often considered a better 512 513 alternative to out-of-pocket expenditure on the path towards achieving universal health coverage. Therefore, finding out other dimensions of factors that contribute to 514 counteracting CBHI in developing country is very important. 515

A 25 year old male has got a small cut in his leg when working on the field three days ago. 663 The wound has become red and from time to time he feels a throbbing pain in his leg, but 664 he can still walk around and do some work. 665

667 A 35-year-old female has been coughing for three weeks now. She feels more tired than usual but can still do some housework. Her relatives think she looks thinner than a few 668 weeks ago. 669
