Real-world smartphone data can trace 1 the behavioural impact of epilepsy: A 2 **Case study** 3

41 Abstract

42	Neurobehavioural comorbidities have a detrimental effect on the quality of life of people with
43	epilepsy, yet tracking their impact is challenging as behaviour may vary with seizures and anti-
44	seizure medication side effects. Smartphones have the potential to monitor day-to-day
45	neurobehavioural patterns objectively. We present the case of a man in his late twenties with
46	refractory focal epilepsy in whom we ascertained the effects of ASMs withdrawal and a focal-to-
47	bilateral tonic-clonic convulsion on his touchscreen interactions. Using a dedicated app, we
48	recorded over 185 days, the timestamps of 718,357 interactions. We divided the various
49	smartphone behaviours according to the next-interval dynamics of the interactions by using a
50	joint interval distribution (JID). We analysed JIDs during two ASM load transitions: before versus
51	during tapering and restarting medication versus tapering. Cluster-based permutation testing
52	revealed significant differences, with accelerated next-interval dynamics during tapering and a
53	reversal upon medication restart. We also compared the JID of the fbTCS day to the average of
54	the three days before, showing markedly slower next-interval dynamics on the day of the
55	convulsion. This suggests that smartphone interactions' temporal dynamics may help monitor
56	neurobehavioural comorbidities in epilepsy.

58 Introduction

59 Neurobehavioural comorbidities have a detrimental effect on the quality of life in people with 60 epilepsy.^{1,2} Their impact on day-to-day behaviour is, however, difficult to monitor as the burden 61 may fluctuate over time due to medication changes or seizure occurrence. The usual approach 62 to quantifying these impairments is to use standardised tests and questionnaires in a hospital-63 based setting, thus only providing a snapshot in time.

64 Smartphones have the potential to monitor day-to-day neurobehavioral patterns objectively.

65 Recent work demonstrated its value in various neurological conditions, including Parkinson's

disease and multiple sclerosis.^{3,4} We demonstrated that smartphone touchscreen interactions

show increased behavioural ageing in people with epilepsy.⁵ Interestingly, we found a 10-year

68 gap between the smartphone-based estimated age and the chronological age, which parallels

69 findings in MRI studies.⁶ We postulated that, apart from neurodegeneration, drug-induced

70 central nervous system side effects and the occurrence of seizures contribute to accelerated

71 behavioural ageing in epilepsy.

We present a single case study of a man in his late twenties in whom we examined the effect of anti-seizure medication changes and seizures on smartphone touchscreen interactions. He participated in a prospective cohort study relating smartphone interactions to self-reported seizures for six months (NCT04617418). During the study, he was admitted to an epilepsy monitoring unit (EMU), for a five-day pre-surgical evaluation. He had refractory right temporal lobe epilepsy with weekly focal impaired awareness seizures and yearly focal to bilateral tonicclonic convulsions. No aetiology was identified despite having had several MRI scans.

In this case, we leverage the ground truth information on seizures provided by the video-EEG
recordings and the anti-seizure medication (ASM) withdrawal linked to the admission.

81 Materials & methods

The Leiden-Den Haag-Delft Medical Ethics Committee approved the study, and the subject consented to participate. He installed the TapCounter app (QuantActions, Lausanne) on his smartphone, which recorded the timestamps of all touchscreen interactions and kept a seizure diary for six months. The data from the app was automatically transferred to a cloud-based server (taps.ai, QuantActions, Lausanne).

87 The subject participated in the study from May to November 2021. Seven hundred eighteen 88 thousand three hundred fifty-seven touchscreen interactions were recorded over 185 89 consecutive days, with a median of 3,311 daily interactions (interquartile range (IQR) 2,531 to 90 4,766 interactions). He used lamotrigine and perampanel, which were reduced before 91 admission and completely withdrawn during admission (figure 1a). He reported a total of 14 92 focal impaired awareness seizures outside the admission period. The five-day video-EEG 93 recording documented nine focal aware seizures (FAS) with autonomic onset on the first day, 94 four on the second day, one electrographic seizure whilst asleep on each of the first two nights, 95 and one focal to bilateral tonic-clonic convulsion originating from the temporal lobe soon after wake-up on the fourth day. 96 97 We downloaded the data from the online data collection manager (taps.ai, QuantActions,

98 Lausanne). We applied a previously validated sleep and rise time detection algorithm to

99 separate the touchscreen interactions per study day.⁷ We then calculated joint-interval

100 distributions (JID) for the inter-touch intervals (ITI) from each day (figure 1b). We created a 2D

space by relating each ITI (at time k) against its subsequent interval (at time k + 1). We operated

102 2D kernel density estimation (Gaussian kernel with a bandwidth of 0.1) over the log₁₀-

103 transformed 2D space. We subsequently discretised the continuous output of the kernel density

104 estimation using 50 bins per dimension from ~30 milliseconds to 100 seconds, thus obtaining a

105 50 by 50 matrix of 2D bins.⁸

To evaluate the impact of ASM tapering on touchscreen interactions, we categorised the data
into three distinct periods: days before the ASM tapering (n=82), the tapering period itself (12
days), and days after ASM tapering (n=91). We evaluated the contrasts between the daily JIDs
from the pre-tapering period vs. the tapering period, and the daily JIDs from the tapering period
vs. the post-tapering period.

111 We employed a permutation-based clustering approach to identify clusters of 2D bins with

112 significant differences in touchscreen interactions and to account for multiple testing

113 associated with many individual t-tests (2500 t-statistics) when comparing JIDs bin-wise.⁹

114 Specifically, we performed 1000 random label permutations for each comparison (pre-tapering

vs. tapering and tapering vs. post-tapering). At each iteration, we did a t-test for all 2D bins within

the JIDs and identified clusters in the 2D space of t-statistics. We defined clusters as contiguous

sets of 2D bins, where each bin has a t-statistic corresponding to a p-value of 0.001 or lower.

118 This method provided us with a reference distribution of maximal cluster sizes under the null

119 hypothesis that both groups are indistinguishable. This allowed us to assess the statistical

120 significance of cluster sizes observed in our original data. We considered a cluster size above

121 the 95th percentile of the reference distribution as statistically significant.

122 To assess the effect of seizures on touchscreen interactions, we compared the day of the

123 convulsion during EMU admission (day 4) with the three days before. We first isolated the

touchscreen interactions on the day of the convulsion and computed a JID for that day. Notably,

this convulsion-related JID contains mostly post-ictal data, as the convulsion occurred shortly

126 after awakening. We then computed the average JID from the three days before the convulsion

and contrasted this distribution with that from the convulsion day to estimate the difference perbin in both JIDs.

129 Results

130 The cluster-based permutation test showed significant differences in the probability

131 distributions of interactions for comparing ASM load conditions. These differences were

- expressed by an increased probability of fast next-interval dynamics following tapering, which
- reversed after restarting the medication (figure 2a).
- 134 The probability distributions of the interactions showed marked contrasts between the days with
- and without focal to bilateral tonic-clonic convulsion, expressing an increased probability of

136 slow next-interval dynamics on the day of the convulsion compared to the three preceding days

137 (figure 2b).

138 Discussion

139 We found marked behavioural changes following an focal to bilateral tonic-clonic convulsion

and in response to ASM changes. These changes were recorded with a regular smartphone with

141 a negligible additional burden to the user. Touchscreen interactions show an increased

142 probability of slow next-interval dynamics following a convulsionand increasing ASM load. In

143 contrast, tapering showed the opposite (i.e. an increased likelihood of fast next-interval

144 dynamics). The pattern is similar to what is seen with increasing chronological age.^{5,10}

ASMs users commonly report cognitive side effects¹¹, and they are a robust predictor of reduced

146 quality of life.¹ Information on these effects is helpful during the titration of ASMs, but an

147 adequate, unobtrusive tracking method is lacking. Seizures may also aggravate cognitive

148 impairments or mood disorders,¹² but are similarly challenging to monitor as self-reported

149 seizure diaries are often inaccurate.¹³

This case suggests smartphones may address the need to track medication and seizure-related
behavioural changes. It also underscores the complexity of the fluctuations in subject status
that cannot be captured by cross-sectional assessments such as questionnaires or self-reports.
The neurobehavioural substrates are still largely unexplored, but there is some evidence that
touchscreen interactions correlate with conventional assessments of reaction time¹⁴ and

reliably estimate biological age.⁵ Interestingly, epileptiform discharges coincide with distinct

156 profiles, suggesting that even subtle changes can be monitored.⁸

157 We propose that the increased behavioural ageing in epilepsy is partly explained by ASM exposure and seizure occurrence. ASMs may cause a broad spectrum of cognitive changes, 158 including impaired executive function, attention and reaction time.^{15,16} Our finding of significant 159 160 behavioural changes following ASM load adjustment is important because the cognitive and 161 behavioural side effects of the ASMs prescribed to the case (lamotrigine and perampanel) are 162 relatively unknown but relevant.^{17,18} A more pronounced change in smartphone behaviour could 163 be expected with ASMs associated with adverse cognitive effects or with polyteraphy.¹⁵ Notably, 164 the net accelerating ASM effect was significant. However, the period also included the day of the 165 convulsive event, which showed a reverse effect on smartphone behaviour (i.e. a deceleration of 166 interactions).

We grouped touchscreen interactions into daily interaction profiles, as hourly profiles wouldyield variable amounts of data due to intermittent phone use. While the interaction profile of the

day with focal to bilateral tonic-clonic convulsion included a pre- and post-ictal phase, it

predominantly reflects the post-ictal phase as the seizure occurred soon after wake-up. The
post-ictal state can manifest in a variety of ways, including altered consciousness and cognitive

dysfunction.¹⁹ Cognitive impairments may last for hours or even days after a focal to bilateral

tonic-clonic convulsion. Our case's loss of rapid touchscreen interactions may well reflect thesepost-ictal signs.

We only examined the effects of the convulsion without evaluating the days with focal seizures.
We anticipated that the cognitive impact of focal seizures, particularly those with retained
awareness, is considerably less. Many seizures recorded and a sufficiently long seizure-free
period are necessary to evaluate their effect on smartphone behaviour. We selected a single
case to demonstrate the impact of medication withdrawal and the recorded convulsion. Cohort

- 180 studies are needed to establish our findings' generalisability and ascertain the potential of
- 181 touchscreen profiles in epilepsy care.
