25 Abstract

- Background: Long COVID (LC) is a complex and multisystemic condition marked by a diverse range of symptoms,
 vet its associated risk factors remain poorly defined.
- 28 Methods: Leveraging data from the 2022 Behavioral Risk Factor Surveillance System (BRFSS) and National Health
- 29 Interview Survey (NHIS), both representative of the United States population, this study aimed to identify
- 30 demographic characteristics associated with LC. The sample was restricted to individuals aged 18 years and older
- 31 who reported a positive COVID-19 test or doctor's diagnosis. We performed a descriptive analysis comparing
- 32 characteristics between participants with and without LC. Furthermore, we developed multivariate logistic
- regression models on demographic covariates that would have been valid at the time of the COVID-19 infection.
- Results: Among the 124,313 individuals in BRFSS and 10,131 in the NHIS reporting either a positive test or
- doctor's diagnosis for COVID-19 (Table), 26,783 (21.5%) in BRFSS and 1,797 (17.1%) in NHIS reported LC.
- 36 In the multivariate logistic regression model, we found middle age, female gender, Hispanic ethnicity, lack of a
- 37 college degree, and residence in non-metropolitan areas associated with higher risk of LC. Notably, the initial
- 38 severity of acute COVID-19 was strongly associated with LC risk. In contrast, significantly lower ORs were
- 39 reported for Non-Hispanic Asian and Black Americans compared to Non-Hispanic White.
- 40 Conclusions: In the United States, there is marked variation in the risk of LC by demographic factors and initial
- 41 infection severity. Further research is needed to understand the underlying cause of these observations.

43 Introduction

Long COVID (LC) is a multisystemic condition characterized by a diverse range of symptoms,¹ and the risk factors
associated with LC are not well defined. The most recent versions of the Behavioral Risk Factor Surveillance
System (BRFSS) survey and National Health Interview Survey (NHIS) have sampling and survey designs suitable to
determine the patient demographic characteristics associated with LC.²

49 Methods

50 The study data are from the 2022 BRFSS and NHIS, which included individuals ≥ 18 years living in the United

51 States. We restricted the sample to people who reported either a positive test or a doctor's diagnosis of COVID-19.

52 An affirmative or negative response to this question defined LC or non-LC, respectively: "Did you have any

53 symptoms lasting 3 months or longer that you did not have before having coronavirus or COVID-19?". The

54 COVID-19 severity question is exclusive to the NHIS data, while other characteristics included in the study are

55 consistent. We used chi-squared tests to compare characteristics between participants with and without LC. We

56 developed multivariate logistic regression models on demographic covariates that would have been valid at the time

57 of the COVID-19 infection (Table). We reported odds ratios (OR) to identify risk factors associated with LC. All

analyses were performed using R, version 4.1.2 (R Foundation for Statistical Computing).

60 Results

61 Among the 124,313 individuals in BRFSS and 10,131 in the NHIS reporting either a positive test or doctor's

62 diagnosis for COVID-19 (Table), 26,783 (21.5%) in BRFSS and 1,797 (17.1%) in NHIS reported LC. The

63 sociodemographic characteristics of those reporting LC were largely consistent across both surveys (Table and

64 Figure). Those with more severe acute COVID-19 presentations had the highest OR. In addition, older adults,

65 females, people who identified as Hispanic, those without a college degree, and those living in non-metropolitan

areas had higher risks of being affected by LC. Of note, the oldest adults (aged \geq 65 years) had risks that were only

- 67 slightly higher than those of the youngest adults (aged 18-24 years). Non-Hispanic Black and Asian people had
- 68 lower risks than White people, with Asian people having the lowest risk.

70 Discussion

71 This study identified demographic characteristics associated with LC. We identified the initial severity of the 72 infection as strongly associated with LC, which may point to prevention and early intervention with therapeutics as 73 an important approach. The reason for the variation in the risks associated with demographic factors, such as sex, 74 race and ethnicity, education, and geography, is unclear and could be related to exposures, treatments, and reporting. 75 There is a need for further studies to illuminate the underlying mechanisms of these differences. Although this study 76 is based on self-reported data, this is currently the only way to diagnose LC, and we restricted the sample to those 77 who reported either a positive test or doctor's diagnosis for COVID-19. A strength of this study is the consistency in 78 these national surveys. Other studies have reported female sex, older age, and previous hospitalization or ICU admission in association with higher risk for LC.3-5 However, previous studies did not have the advantage of national 79 80 representation from a single country that experienced a substantial pandemic toll. Limitations of our study include 81 the lack of medical record information, though that information would be incomplete for many people. In 82 conclusion, in the United States, there is marked variation in the risk of LC by demographic factors and initial

83 infection severity. Further research is needed to understand the underlying cause of these observations.
