40 Abstract

41 Introduction

42 Home-based records (HBR) are widely used for recording health information including child

43 immunizations. We studied levels and inequalities in HBR ownership in low- and middle-

44 income countries (LMICs) using data from national surveys conducted since 2010.

45 Methods

46 465,060 children aged 6-35 months from 82 LMICs were classified into four categories: HBR

47 seen by the interviewer; never had an HBR; had an HBR that was lost; and reportedly have an

48 HBR that was not seen by the interviewer. Inequalities according to age, sex, household

49 wealth, maternal education, antenatal care and institutional delivery were studied, as were

50 associations between HBR ownership and vaccine coverage. Pooled analyses were carried out

51 using country weights based on child populations.

52 Results

An HBR was seen for 67.8% of the children, 9.2% no longer had an HBR, 12.8% reportedly had

54 an HBR that was not seen and 10.2% had never received one. The lowest percentages of HBRs

seen were in Kiribati (22.1%), the Democratic Republic of Congo (24.5%), Central African

56 Republic (24.7%), Chad (27.9%), and Mauritania (35.5%). The proportions of HBRs seen

57 declined with age and were inversely associated with household wealth and maternal

58 schooling. Antenatal care and institutional delivery were positively associated with ownership.

59 There were no differences between boys and girls. When an HBR was seen, higher

- 60 immunization coverage and lower vaccine coverage rates were observed, but the direction of
- 61 this association remains unclear.

62 Interpretation

63 HBR coverage levels were remarkably low in many LMICs, particularly among children from the

64 poorest families and those whose mothers had low schooling. Contact with antenatal and

65 delivery care was associated with higher HBR coverage. Interventions are urgently needed to

66 ensure that all children are issued HBRs, and to promote proper storage of such cards by

67 families.

74 Introduction

75	Home-based records (HBR) are personal health documents used to record the history of health
76	services received by an individual.(1) The most frequently used HBRs are child vaccination
77	cards issued by health services at the time of the first vaccination - often in the hospital or
78	facility where the child was born – and usually kept in paper format by the child's caregivers.
79	The use of HBRs that include vaccination status is widespread – being implemented in at least
80	163 countries as of 2018(1) - but HBRs vary greatly in design and regarding the information
81	documented, which includes growth curves and clinic visits in several countries. This article
82	refers to HBRs as documents that record vaccines received by children, with or without
83	additional health data.
84	HBRs are important tools for several reasons.(1) HBRs serve as a documentation tool that
85	allows parents and health services to track the immunization status of a child, and to support
86	compliance with vaccination schedules. They will facilitate continuity of care by providing a
87	reliable source of information for healthcare providers, thus allowing providers to quickly
88	determine which vaccines a child has already received and when they are due for the next
89	vaccine. For families with limited access to services, such as those living in remote areas, HBRs
90	may help schedule the travel necessary to obtain vaccines. HBRs are also important for
91	monitoring immunization coverage through household surveys.
92	Although evidence of the effectiveness of HBRs in increasing vaccination coverage is scant,(2)
93	there are studies suggesting improved timeliness and reduced missed opportunities for
94	vaccination. (3, 4) In fact, a World Health Organization (WHO) committee produced a positive
95	appraisal of HBRs, noting that these contribute to the right to access to information and
96	support global efforts for people-centred care.(1) Furthermore, in early 2023, WHO published
97	updated guidance to strengthen the use of HBRs as a tool improve care seeking behaviours,
98	maternal and child home care practices, infant and child feeding, men's involvement and
99	support in the household, and communication between health workers and women, parents

100	and caregivers.(5) HBRs are also important for vaccination status ascertainment in surveys - as
101	in their absence the information may be affected by recall bias. This has an important impact
102	on estimates of immunization coverage, as the low availability of HBRs has been highlighted as
103	a key challenge for vaccination coverage surveys.(6) (7, 8)
104	A 2015 analysis found that the proportions of children for whom HBRs were available for
105	inspection was under 50% in 24 of 67 of low and middle-income countries (LMICs) studied.(9)
106	Low HBR coverage in many LMICs highlights the need for investigating which children are most
107	likely to lack such records.
108	Substantial inequalities in child immunization coverage have been widely documented in
109	LMICs. (5, 10-13) Well-established determinants of coverage include maternal education,
110	household wealth and geographical location, whereas inequalities according to the child's sex
111	are not so evident.(10-12, 14) Ethnic group affiliation(15, 16) and religion(16) are also
112	determinants of vaccine coverage in some, but not all countries. To our knowledge, the
113	association between ownership of HBRs and immunization outcomes has not been
114	systematically studied using survey data.
115	In contrast to the ample literature on immunization coverage inequalities, we were unable to
116	identify any single-country or multicountry analyses on disparities in HBR ownership. The
117	factors affecting HBR ownership in LMICs are likely the same as those affecting immunization
118	coverage. In addition to the above-described characteristics of the household and the child,
119	coverage is driven by health systems-related factors that include HBR and vaccine supply,
120	distribution logistics and facility readiness, as well as staff availability and training. (5, 17, 18)
121	Uptake is also influenced by factors such as vaccine hesitancy(19, 20) and political
122	instability.(21)
123	Analyses of HBR coverage have so far focused on the proportion of children who, during a
124	household survey, have an HBR in the home that was shown to the interviewer. However,

125	there are other possibilities. Children for whom an HBR was not available for examination may
126	have never had such a card; have once had an HBR but no longer have one; or reportedly still
127	have an HBR, but the interviewer could not see it. This distinction is important because such
128	results may provide insights on how to expand the use of HBRs and improve measurement of
129	vaccine coverage. Lastly, there are also countries where vaccination records are kept in health
130	facilities and are not available for inspection during a household survey.
131	In this article, we use nationally representative surveys with information on vaccination carried
132	out between 2010 and 2021 to describe the distribution of children according to the four
133	categories of HBR ownership listed above. We also show how these proportions vary by
134	country, child's age and sex, and selected sociodemographic and healthcare characteristics. In
135	addition, we explore whether HBR status is associated with survey-based measures of vaccine
136	coverage and drop-out between DPT1 and DPT3. Our aim is to better understand the spectrum
137	of HBR status to inform how to improve their ownership, which could translate in increased
138	demand for immunization, better timeliness of vaccination, and - at the health systems level -
139	improved monitoring and measurement of vaccination status.

141 Materials and Methods

142 The International Centre for Equity in Health database includes all publicly available datasets 143 from nationally representative Demographic and Health Surveys (DHS) and Multiple Indicator 144 Cluster Surveys (MICS). (22, 23) Over 450 surveys from 125 countries were screened to select 145 the most recent survey from each country carried out since 2010. Of these, 82 with 146 information on ownership of HBRs and on immunization history (47 DHS and 35 MICS) were identified and are part of this study. Eleven other countries where vaccine records were only 147 148 kept in health facilities were excluded (Ethiopia, Kazakhstan, Kyrgyzstan, Moldova, Mongolia, 149 North Macedonia, Serbia, Tonga, Turkmenistan, Ukraine and Vietnam). - 151 Types/dHs.cfm) and MICS (http://mics.unicef.org/). DHS and MICS are highly comparable in
- terms of sampling and indicators. (24, 25)
- 153
- 154 Our study sample included children 6-35 months as most surveys did not collect immunization
- 155 information on older children. Those aged under six months were excluded because they may
- 156 not yet have been issued an HBR. Four categories of HBR status were analysed: 1) HBR seen by
- 157 the survey interviewer ("HBR seen"); 2) HBR reportedly existed but was not produced for
- inspection ("has HBR, but not seen", also referred to as "misplaced HBR"); 3) HBR available at
- 159 some point but had been lost ("no longer has an HBR"); and 4) HBR never issued to the child
- 160 ("never had an HBR").

162 We investigated associations of HBR ownership with the following variables:

163

164 •	Age (6-11,	12-23 and 24-35	i months) and sex	of the child.

165	•	Household wealth quintile, derived from household asset indices provided in the DHS
166		and MICS datasets. These were obtained using principal component analyses of
167		household assets and characteristics of the building, presence of electricity, water
168		supply and sanitary facilities, among other variables associated with wealth. Because
169		relevant assets may vary in urban and rural households, principal component analyses
170		are initially carried out separately for each area and later combined into a single score
171		using a scaling procedure to make area scores comparable. (26)
170		

Maternal schooling in three categories, as reported by the survey respondent: none
 (no formal schooling); primary (any primary schooling, including completed primary
 education); secondary or higher (any secondary education, including completed
 secondary schooling and partial or full higher education).

176	• Area of residence coded as urban or rural according to country-specific delimitations.
177	• Four or more antenatal care visits to any provider during the pregnancy. For both DHS
178	and MICS, this information is available for the lastborn child only, who account for
179	76.7% of our study sample.
180	• Institutional delivery, defined as delivery in a health facility of any level. DHS collects
181	this information only for lastborn children, whereas MICS provides information on all
182	under-fives. Data are available for 87.8% of the study sample.
183	Analyses of the association between HBR ownership and vaccine coverage were done with
184	BCG (one dose), poliomyelitis (three doses, either oral or injectable), diphtheria-pertussis-
185	tetanus (DPT) (one and three doses of any DPT-containing vaccine), and measles (one dose of
186	any measles-containing vaccine or MCV). Full immunization coverage was defined as receiving
187	at least one dose of each BCG and MCV, and three doses of each DPT and polio. The DPT
188	dropout ratio was defined as the percentage of children who failed to receive a third dose
189	among those who received the first dose. The same approach was used to calculate the DPT1
190	to MCV dropout ratio, even though having received DPT1 is not a prerequisite for receiving
191	MCV.
192	The association analyses with vaccine coverage were restricted to children 12-23 months; in
193	countries where MCV is recommended at ages 15 or 18 months, the analyses included children
194	aged 15-26 or 18-29 months, respectively. The information on vaccines was collected from
195	HBRs or, if not available for inspection, from the caregiver's recall. Children without any
196	information on vaccination status were considered as unvaccinated.
197	The units of analyses were all children aged 6-35 months from the 82 countries with data.
198	Analyses of each survey dataset accounted for the multi-stage survey design and sampling
199	weights. The pooled analyses included multinomial regression with HBR as a four-category
200	outcome including fixed effects for country, and were weighted by the populations of children

- aged 12-23 months in each country as of 2017 (median year of all surveys), according to the
- 202 World Bank.(27)
- 203 Analyses were stratified by World Health Organization regions: African Region (AFR), Region of
- 204 the Americas (AMR), South-East Asian Region (SEAR), European Region (EUR), Eastern
- 205 Mediterranean Region (EMR) and Western Pacific Region (WPR) and by country income (low,
- 206 lower-middle or upper-middle income) using the most recent World Bank classification.
- 207 The analyses were carried out with Stata (StataCorp. 2019. Stata Statistical Software: Release
- 208 17. College Station, TX: StataCorp LLC) and R (R Core Team, 2020, version 4.1.0. R Foundation
- 209 for Statistical Computing, Vienna, Austria).
- 210 Ethical clearance was the responsibility of the institutions that administered the surveys and all
- analyses relied on anonymized databases.
- 212 Results
- 213 We studied 465,060 children aged 6-35 months; 20% were aged between 6 and 11 months
- 214 (93,411 children), 40.0% (185,351) between 12 and 23 months and 40.1% (186,298) between
- 215 24 and 35 months. We included 82 countries representing 82% of all low income, 62% of all
- lower-middle income, and 45% of all upper-middle income countries as of 2017.
- 217 Supplementary Table 1 lists all study surveys. Information on HBR, sex, age, wealth quintiles
- and area of residence was available for all children. Maternal education, antenatal care and
- 219 institutional delivery were not available for 36, 108,481 and 56,767 children. Vaccine coverage
- analyses were restricted to 185,729 children aged 12-23 months.
- 221 Across world regions, EUR countries presented the highest median value for children whose
- 222 HBR was seen at the survey interview (89.6%), while the WPR countries presented the lowest
- median (59.0%). The lowest values were in Kiribati (22.1%) and in four AFR countries

- 224 (Democratic Republic of Congo (24.5%), Central African Republic (24.7%), Chad (27.9%), and
- 225 Mauritania (35.5%)).
- EUR presented the lowest national median values in the "has HBR, but not seen" group (6.2%),
- no longer having an HBR (0.9%), and never having had an HBR (1.0%). Median values for no
- 228 longer having an HBR varied from 0.9% in EUR to 9.6% in WPR, whereas the medians for never
- having an HBR ranged from 1.0% and 1.1% in EUR and AMR, respectively, to 9.7% in WPR.
- 230 Table 1 shows HBR ownership status according to the six WHO regions.

Figure 1 presents the HBR ownership status by country for three age ranges (6-11, 12-23, 24-


235 35 months). There was a moderate decline with age in the percentage of children with HBR

seen. In countries with a high prevalence of HBRs seen – at the top of the figure - most

237 children without an HBR had one, but it was no seen by the interviewer. In countries with a

238 low prevalence of HBRs seen – at the bottom of the figure - most children without an HBR had

239 never been issued one.

242 Figure 1 - Percentage of children according to HBR status by country


243 Countries ordered according to the % of children aged 12-23 months with HBR seen

246	Figure 2 summarizes the results from the pooled analyses of the 82 countries across inequality
247	dimensions (see Supplementary Table 2 for more detailed results, including 95% confidence
248	intervals). After weighting by national child population, 67.8% of the children aged 6-35
249	months had an HBR seen by the interviewer, 9.2% no longer had an HBR, 12.8% reportedly had
250	an HBR that was not seen and 10.2% had never received one.
251	Figure 2 also shows inequalities in HBR ownership. The prevalence of HBRs seen dropped
252	rapidly with the age of the child, with increasing proportions of children who no longer had an
253	HBR or children who had an HBR that was not seen. These cross-sectional results suggest that
254	0.7% of HBRs are lost or misplaced with each increasing month of age (P<0.0001), but the
255	proportion of children who never had an HBR did not vary with age (P=0.191). There were
256	virtually no differences between boys and girls.
257	In terms of household wealth, the percentages of children with HBRs seen increased
258	monotonically from 62.4% in the poorest quintile to 70.1% in the wealthiest quintile.
259	Conversely, 3.7% of the wealthiest children never had an HBR compared to 17.1% among the
260	poorest. This gradient is even more evident in terms of maternal education. While HBRs were
261	seen for 73.4% of children born to women with at least secondary education, this proportion
262	was down to 55.7% when the mother had no formal schooling. Among the latter group, 23.0%
263	never had an HBR, compared to 4.3% among the former.
264	The percentages of children with HBRs seen by the interviewer were very similar for rural and
265	urban residents, but the percentage of rural children who never had an HBR (12.4%) was twice
266	as high as that of urban children (6.3%), and conversely more urban than rural children
267	reportedly had an HBR that was not seen.
268	We also investigated the overlap between HBR ownership and healthcare utilization. Higher

269 proportions of children with HBRs seen were observed when their mothers attended antenatal

- 270 care four or more times than those with fewer or no visits (73.2% and 63.1%, respectively), a
- 271 group in which about one-fourth of the children never had or no longer have an HBR. Similarly,
- 272 HBRs seen were more common among children delivered in a health facility than those born at
- home (74.1% and 51.2%, respectively). Among children born outside an institution, 35.4%
- 274 never had an HBR, compared to only 4.6% for institutional births.




276 Figure 2 – HBR ownership by characteristics of the child and household.

278	Coverage of basic vaccines and drop-out ratios according to HBR ownership are presented in
279	Figure 3. Analyses are restricted to children aged 12-23 months. These results must be
280	interpreted with caution for the reasons laid out below in the Discussion. We found similar
281	patterns for BCG and DPT1, as well as for DPT3 and Polio3, particularly for the two extreme
282	categories - HBR seen and never had an HBR.
283	When an HBR was seen, coverage of DPT1 and BCG were 97.2% and 97.5%, respectively.
284	Among children who never had an HBR, coverage levels by recall were 28.7% and 33.0%,
285	respectively. Similarly, DPT3 and Polio3 coverage were 90.5% and 89.7% among children with
286	HBR seen, and 15.0% and 22.2% among those who never had an HBR.
287	MCV coverage among children with an HBR seen (80.3%) was lower than that for any other
288	vaccines, including DPT3 and Polio3, suggesting drop-out between the third doses and MCV
289	which is usually administered later. Results on dropout ratios are shown below. For children
290	who never had an HBR, MCV coverage estimated by recall was 26.3%, similar to that for BCG
291	and DPT1. For children who ever had an HBR (a combination of three categories), coverage
292	was 95.5% for BCG, 94.2% for DPT1, 83.8% for DPT3, 79.1% for Ppolio3 and 78.7% for MCV.
293	Results for full vaccination reflect what was observed for each vaccine separately. Children for
294	whom an HBR was seen had much higher coverage (75.5%) than those who never had an HBR
295	(6.1%), whereas a smaller coverage gap was observed for those who no longer had an HBR
296	(27.0%) compared to those who reportedly had an HBR which was not seen (37.4%). Among
297	children who did not receive DPT1 (often referred to as zero-dose children), 71.3% (95% Cl
298	69.8%-72.8%) had never had an HBR.
299	The dropout ratio between the first and third dose of DPT for children who never had an HBR
300	was 47.6%; this information was based on recall of vaccinations. Among children whose HBR

301 was seen, the dropout ratio was only 6.9%. For children who no longer had an HBR and those

302 who reportedly had an HBR that was not seen, dropout ratios were 31.9% and 24.7%,

- 303 respectively. We also investigated the proportions of children who failed to receive MCV
- among those who had received DPT1. Dropout was 24.5% for children who never had an HBR
- but was lower ranging from 15.1% to 17.9% in the other three HBR categories.
- 306 Supplementary Table 3 provides the full results alongside their corresponding 95% confidence
- intervals. Supplementary Figure 1 provides the results for each of the 82 countries included.

313 Discussion

314 We report on HBR ownership for children from 82 countries using data from national surveys

315 carried out since 2010. Prior to our analyses, the largest multicountry publication on HBR

- ownership included 67 countries with surveys from 1993 to 2013. (9) We also report on within-
- 317 country inequalities in HBR ownership by pooling results across all countries.
- 318 We found that many children did not have HBRs seen, but also that a significant proportion
- reported never having received one. The weighted prevalence of HBRs seen by the survey

320	interviewer was 67.8%, whereas 10.2% had never received an HBR, and the remaining children
321	had received one that was either lost or unavailable. We also found substantial variability by
322	country and world regions, with median prevalence of HBRs seen ranging from about 90% in
323	LMICs from Europe to under 60% in the Western Pacific region. Our results are consistent with
324	those reported for 67 LMICs up to 2013, according to which HBRs were seen for over 80% of
325	children in 23 countries and fewer than 50% in 24 countries.(9) According to the Global Health
326	Observatory, current prevalence of HBRs seen across all countries with data ranged from 13%
327	in Somalia to 100% in Belarus, Belgium, DPR Korea, and Turkmenistan.(5) Regarding world
328	regions, this prevalence was lowest in the Western Pacific region (median of 42%), followed by
329	the African region (66%). The highest prevalence was found in the European region (90%).
330	The availability of HBRs for inspection is dependent on several prerequisites.(18) First, HBRs
331	must be available at national level, and then in the health facility. Next, the caregiver must
332	receive it from a health worker usually during or before the first immunization encounter and
333	bringing the record back to the facility when every new vaccine is administered. The record
334	must be properly stored and looked after while in the household. For measurement purposes,
335	during the household survey, the interviewer must request and wait to inspect the HBR to
336	transcribe it. The home-based record must also be readable, and the interviewer must
337	correctly transcribe vaccine dates or vaccination check marks. The increasing complexity of
338	immunization schedules, the diverse range of home-based records (HBRs) in circulation, and
339	the varying quality of their completion are making it increasingly challenging to record, read,
340	and transcribe information from HBRs. (28-30)
341	Stockouts of HBRs have been documented to occur in many countries.(18). These stockouts
342	can be attributed to various factors, including frequent changes to immunization schedules
343	necessitating updates to HBRs, unclear responsibilities regarding printing and distribution, and
344	rising costs associated with more advanced HBR designs, among other reasons.

345 In addition to stockouts, proper storage of the HBRs at home is an important issue. We found 346 that for 9.2% of the children the HBR had been received but later lost, and for a larger 347 proportion (12.8%) the HBR was reportedly still with the family but could not be produced. The 348 loss of HBRs has been well documented; (31) this limits their potential to serve as a tool for 349 continuity of care, particularly when individuals visit multiple health facilities. Lost and 350 misplaced HBRs may preclude children from being immunized during visits to health centres, 351 as suggested by studies from Ethiopia and Bangladesh.(32) 352 A framework was developed to guide the design and implementation of HBRs, as well as their 353 distribution and the engagement of caregivers and users.(33) In particular, one cannot assume 354 that failure to see an HBR in a survey solely reflects practices related to the caregiver. A survey 355 from Kinshasa reported that lower proportions of HBRs were seen as field work advanced 356 although the proportion of caregivers reporting ownership was maintained, which may be 357 attributed to interviewer fatigue and inconsistent supervision. (34) Similarly, when comparing 358 multiple-indicator health surveys with immunization-specific ones in close time proximity, the 359 latter tend to report higher proportions of HBRs seen. (35) Unfortunately, the survey 360 questionnaires and paradata used in the present analyses do not allow a more detailed 361 examination of the reasons for reportedly having an HBR that could not be presented during 362 the interview. 363 Analyses of inequalities help identify children without HBRs, thus contributing to public 364 policies. Although children of different ages within the 6-35 months range have received HBRs 365 to similar extents, the percentages of HBRs seen declined 0.7% per month of age. Sex of the 366 child was not associated with ownership. Rural children were more likely than urban children 367 to have ever had an HBR, but more likely to have lost or misplaced it, resulting in similar 368 proportions of HBRs seen in both groups. As is the case for disparities in vaccine coverage, (12, 369 14) household wealth and maternal education are strongly associated with HBR prevalence; 370 these differentials are particularly driven by never having received an HBR.

371	Just as immunization levels are strongly related to coverage of other essential primary health
372	care interventions,(36) we found that HBR prevalence overlaps with antenatal and delivery
373	care – particularly with the latter. The likely explanation is that some vaccines – most often
374	BCG – are applied shortly after birth to children delivered in institutions. Over 95% of such
375	children have ever received an HBR, compared to 74.6% of those born at home. Even though
376	almost all children born in a facility received an HBR, 4.6% of them still failed to receive one.
377	Stock-outs may be a potential reason for missing these children.(18) On the basis of the
378	overlap between immunization coverage with indicators of multiple deprivation in terms of
379	education, nutrition and sanitation(37), it is also likely that lack of HBRs will be frequent in
380	such populations.
381	As expected, coverage with basic vaccines was highest among children whose HBRs were seen
382	by surveyors and lowest among those who never had an HBR, a finding that has been
383	previously reported.(35) Vaccine coverage - as ascertained through caregiver recall in children
384	with lost or misplaced HBRs - was in between the two extreme categories of HBRs seen and
385	never having had an HBR. Dropout ratios from DPT1 to DPT3 were as high as 50% for children
386	who never received an HBR, compared to less than 10% among those whose HBRs were seen.
387	DPT1-MCV dropout rates were more similar among the four HBR categories, ranging from
388	15.1% in the misplaced group and 24.5% among children who never had an HBR. These
389	findings should not be interpreted as providing unidirectional evidence that HBR ownership
390	will help increase coverage. Given that HBRs are provided at the time of the first vaccination –
391	usually BCG shortly after birth – receiving an HBR and being vaccinated occur simultaneously.
392	Low reported vaccine coverage among children who never received an HBR may reflect health
393	systems failure in delivering immunization or alternatively caregivers forgetting past
394	vaccinated received by their child. A review of the agreement between recall and documented
395	vaccination showed that it varied significantly among settings and types of vaccines, with
396	vaccines requiring multiple visits being the least reliable.(38) In settings with low HBR

397	coverage, survey estimates of immunization rates should be regarded with caution.(8, 35)
398	Our analyses have limitations. Although over 80% of all low-income countries were included,
399	standardized surveys were available for less than half of all upper-middle income countries.
400	Eleven countries in which immunization HBRs are kept in health facilities were excluded from
401	the analyses. Also, we are not able to explore HBR quality and accuracy of transcription when
402	an HBR was seen. Another limitation is the lack of precision in separating reportedly lost HBRs
403	from HBRs that were misplaced – that is, those that were still in possession of the family but
404	were not seen by the surveyors. Both categories show similar associations with vaccine
405	coverage and with sociodemographic and health services characteristics, which may be due to
406	the fact that the two categories are indeed similar, or alternatively that surveys are unable to
407	discriminate among misplaced and lost HBRs. A final limitation is that recall bias most likely
408	affects data on coverage for children whose HBRs were not inspected.
409	Conclusions
410	HBRs are important tools for several reasons.(1) They serve as a documentation tool that
411	facilitates continuity of care and allows parents and health services to track the immunization
412	status of a child, and to support compliance with vaccination schedules. HBRs allow healthcare
413	providers to quickly determine which vaccines a child has already received and when they are

414 due for the next vaccine, which has become even more important now as the IA2030 calls for a

415 life-course approach to vaccination. (39) HBRs are also important for monitoring immunization

416 coverage thought household surveys.

417 In the future, digitization of personal health records(40) may minimize the proportions of lost

418 and misplaced HBRs, but such strategies will only be successful where internet access is

419 equitable and widespread.

420 Our analyses identified countries and population subgroups for which low HBR coverage is

421 likely leading to inaccurate and possibly biased estimates of immunization rates, and worse,

- 422 likely affecting the likelihood of completing vaccination schedules. Regular monitoring of HBR
- 423 ownership is essential for tracking trends and detecting subgroups of children needing special
- 424 attention.
